We claim the ornamental design for a multi-functional lens, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi-functional lens showing the new design;

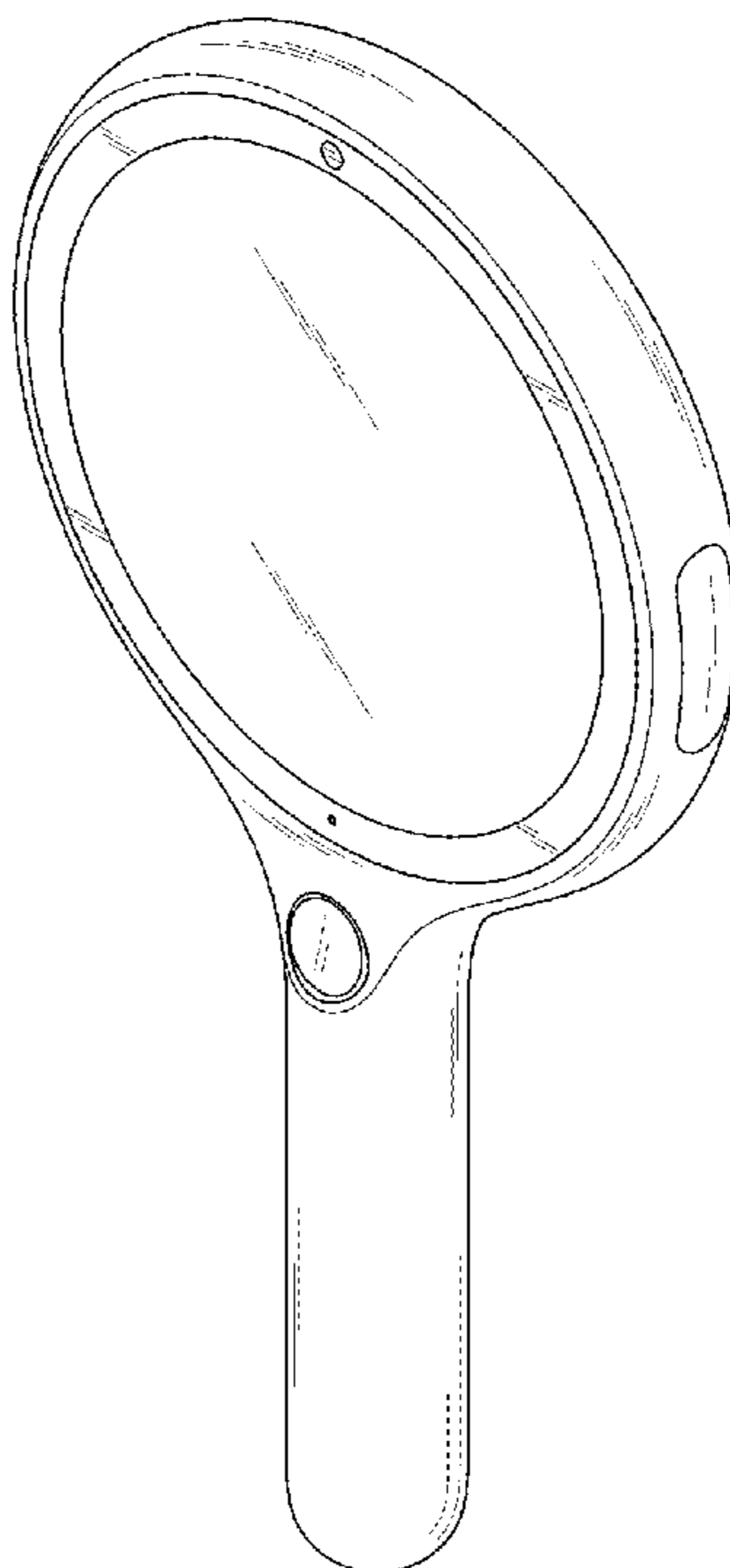

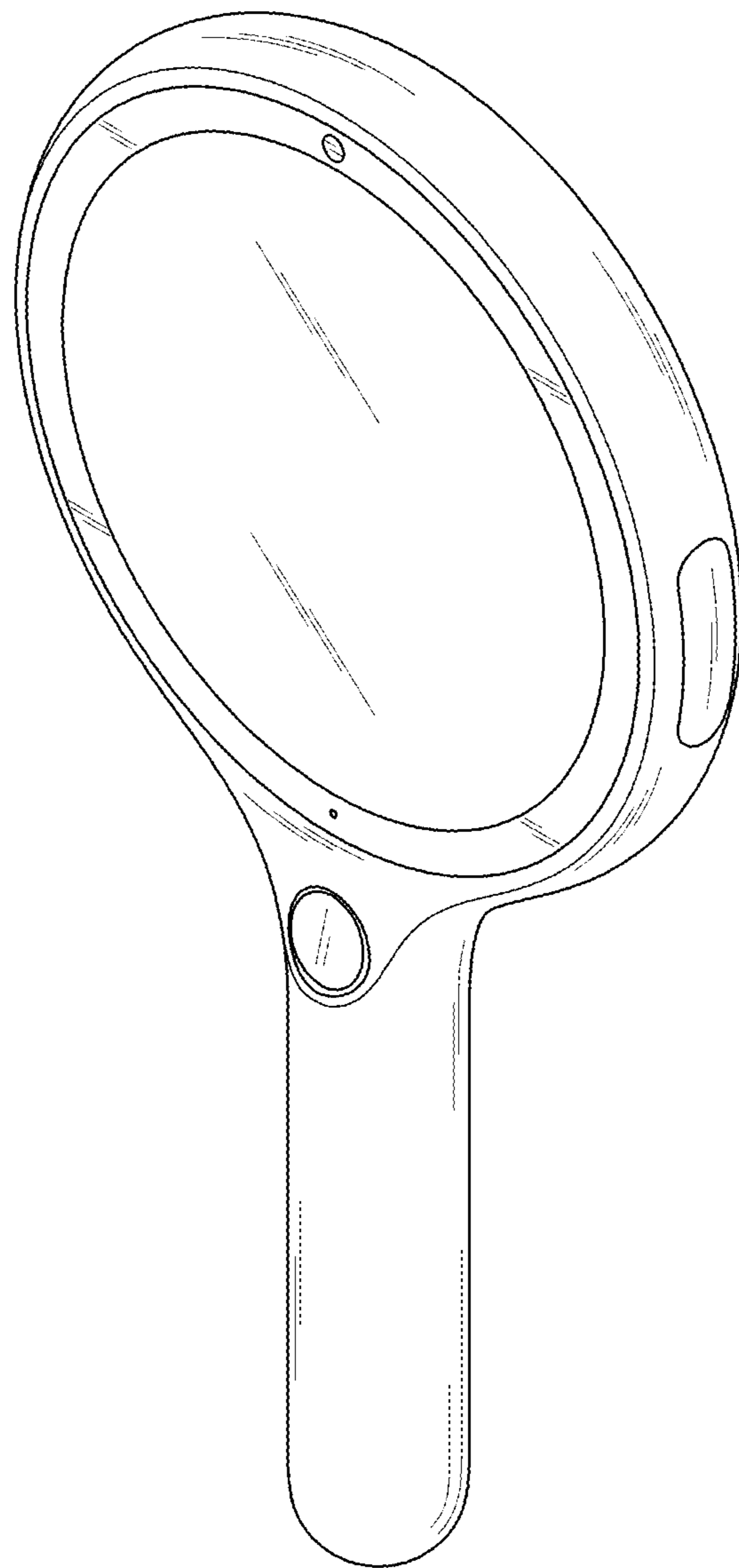

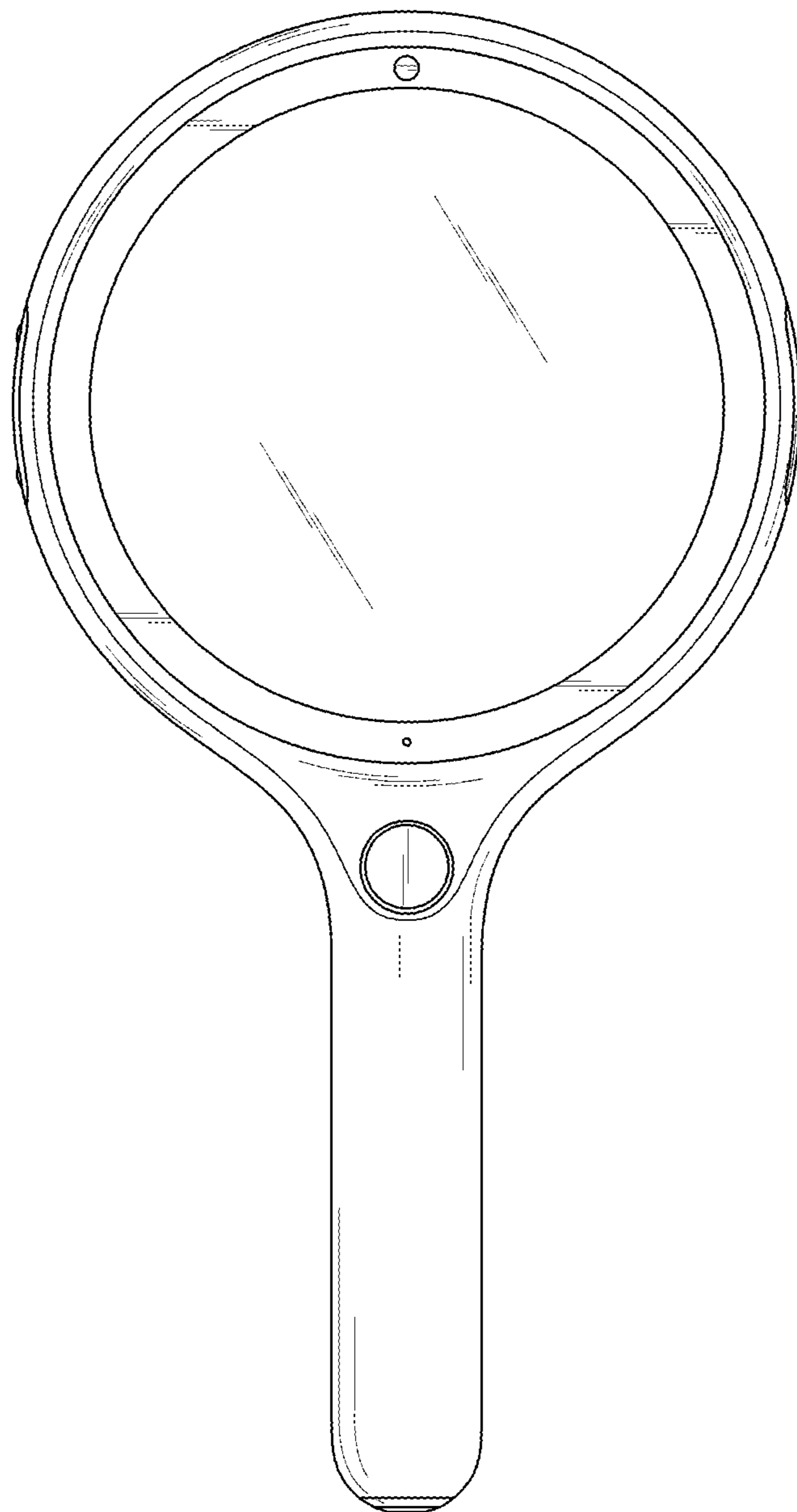

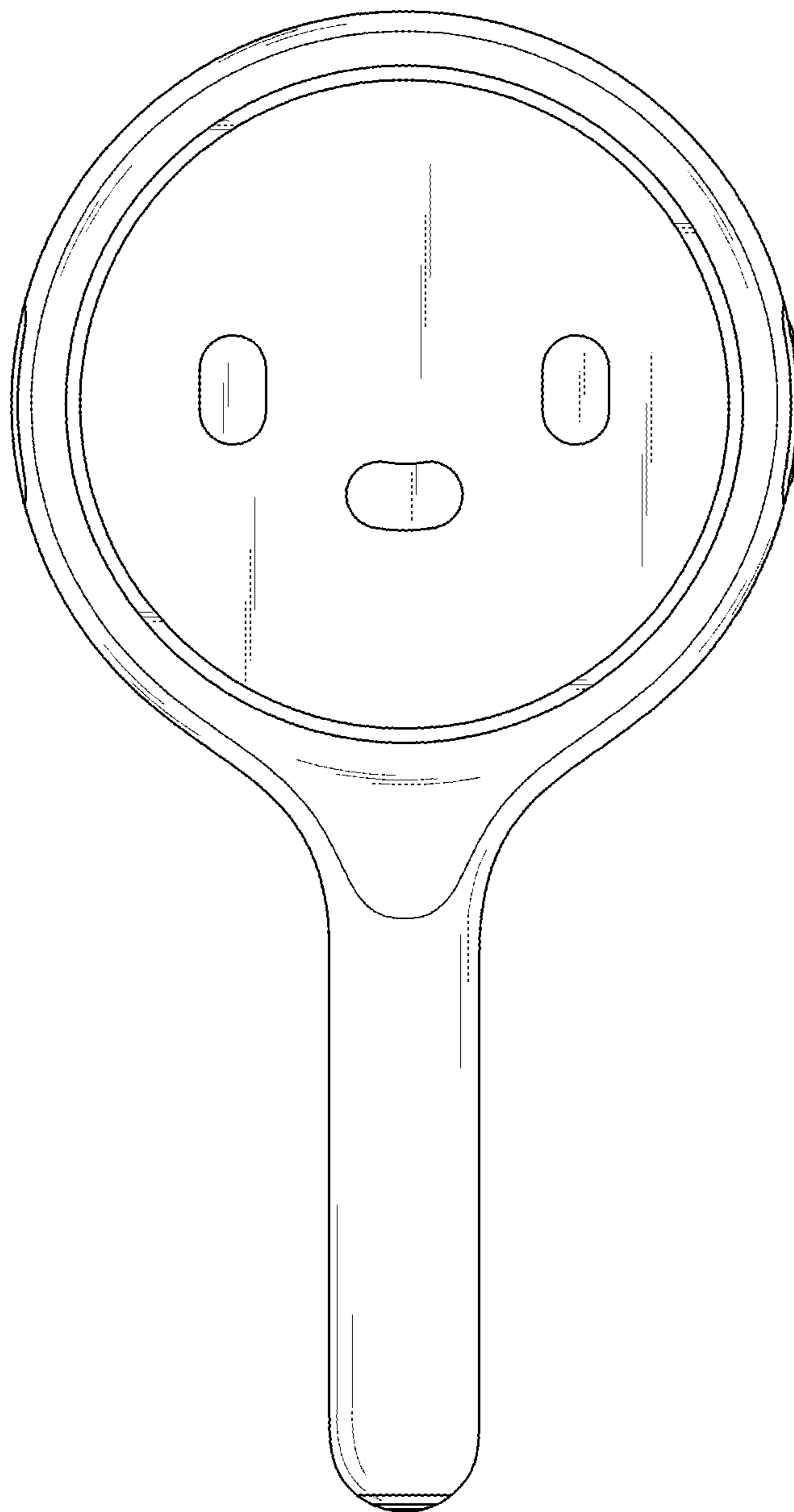

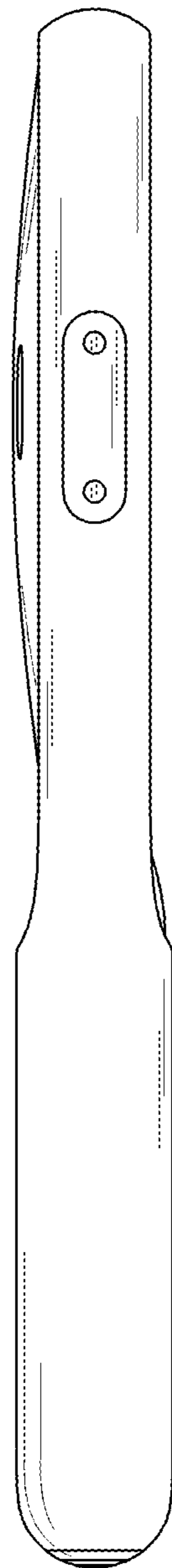

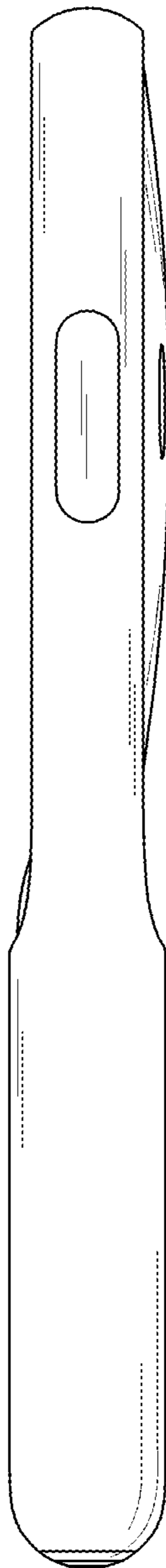

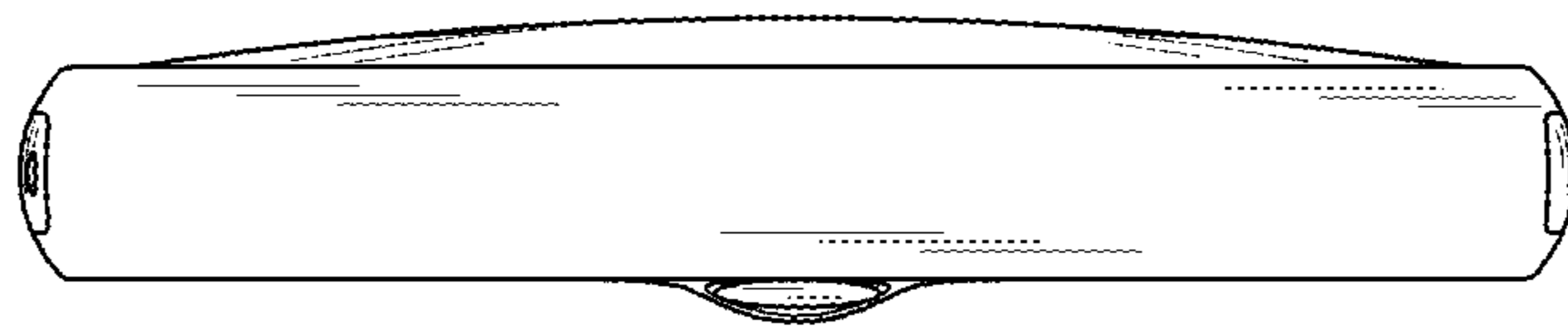
