The ornamental design for a writing board, as shown and described.

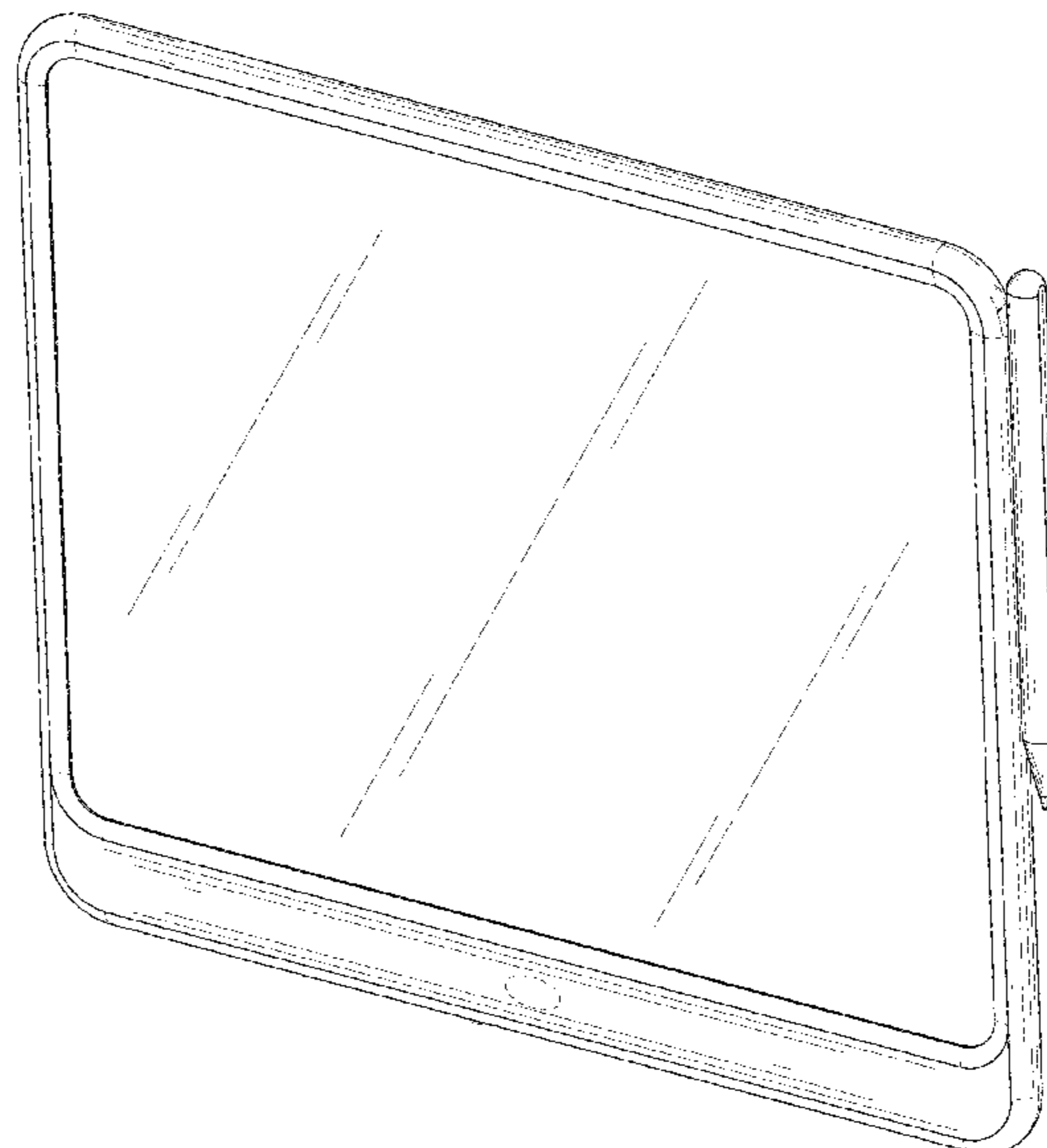
DESCRIPTION

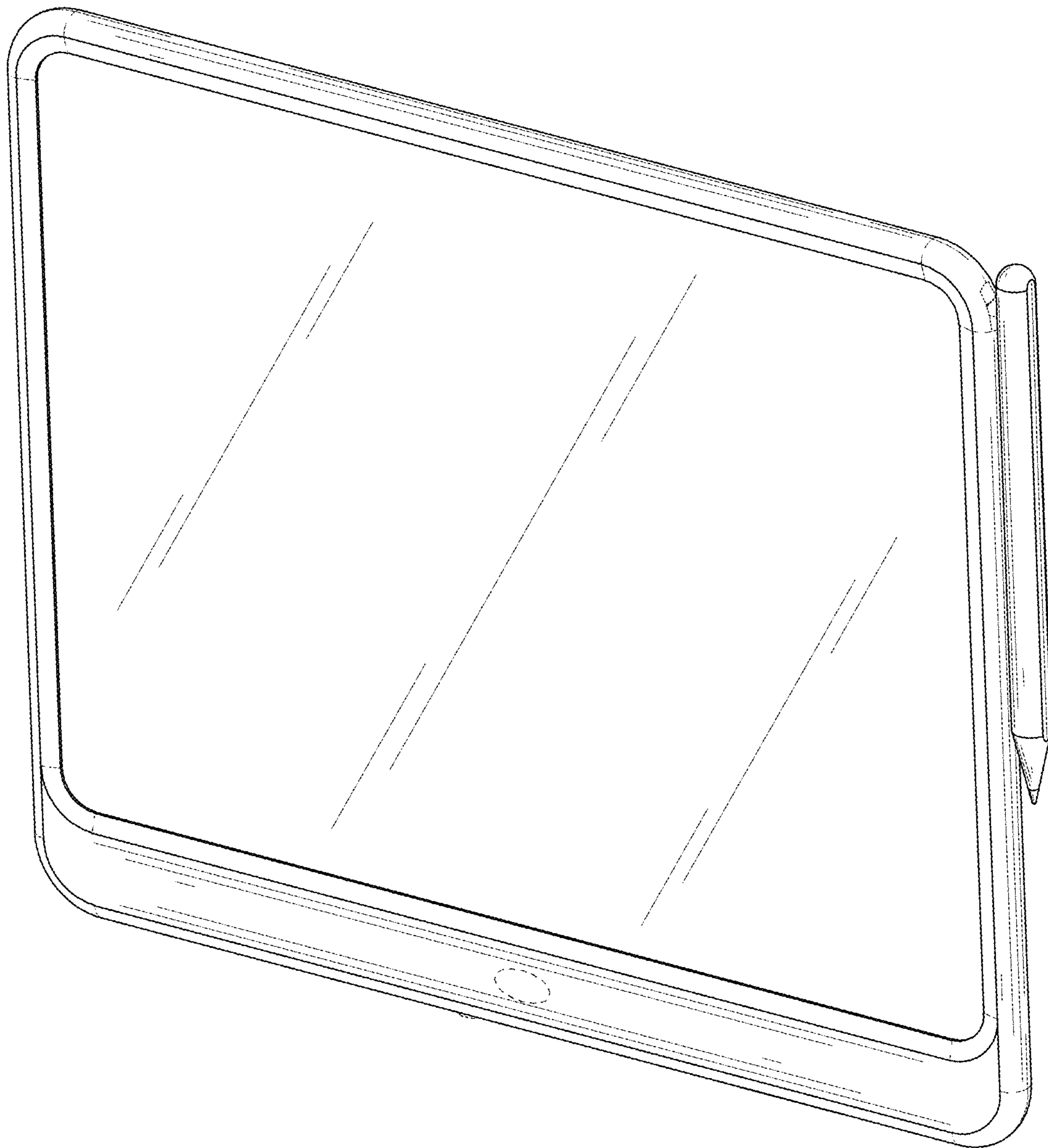

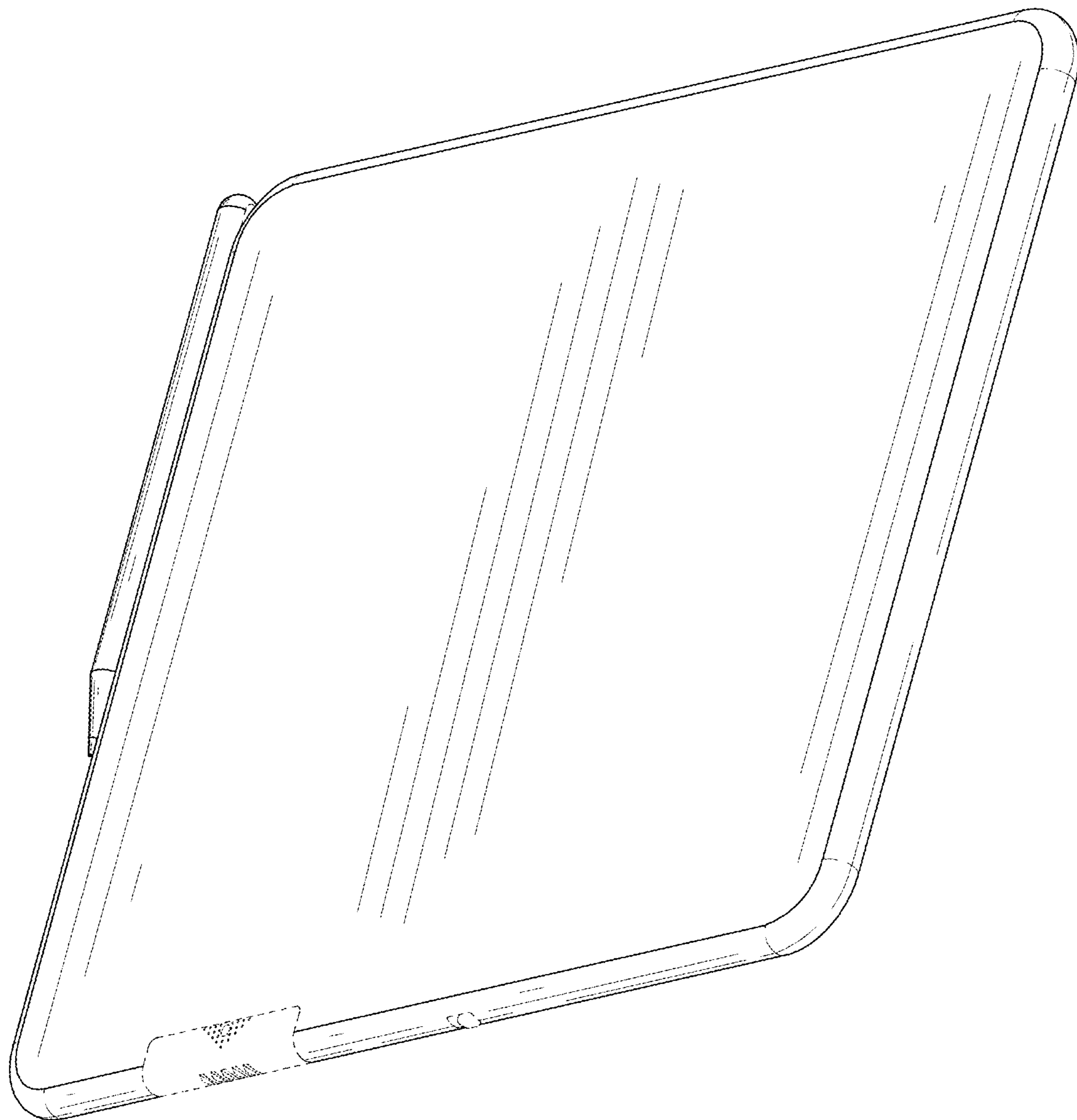

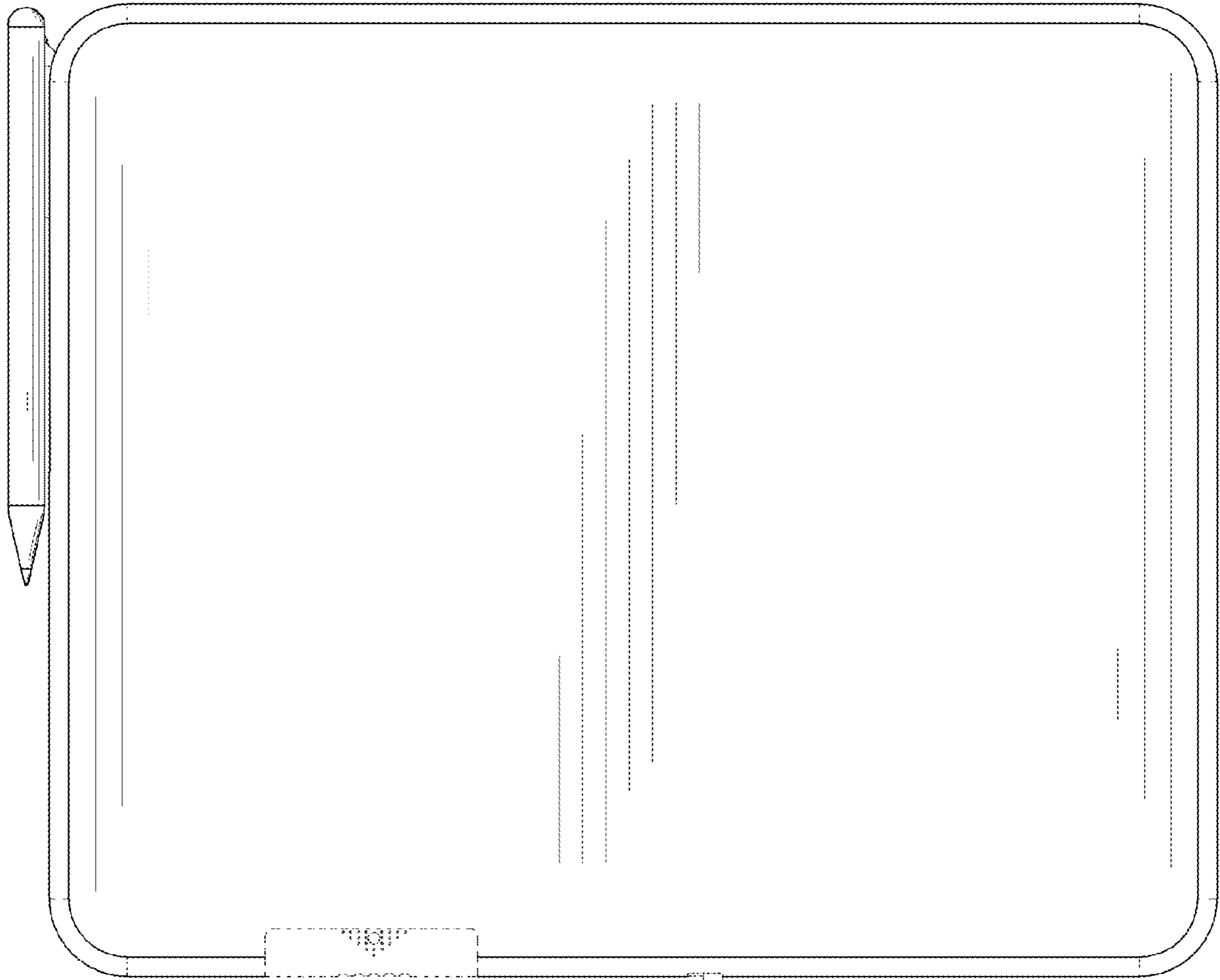

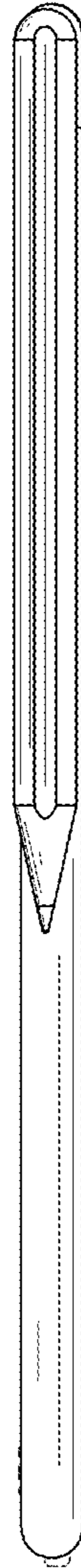

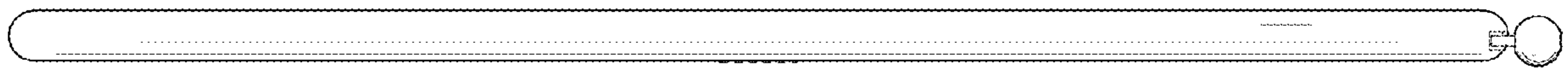

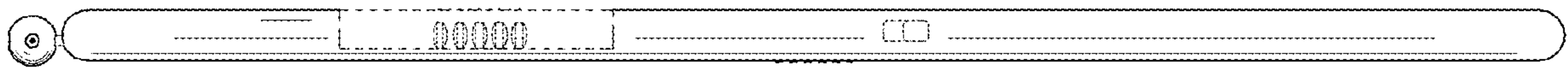
