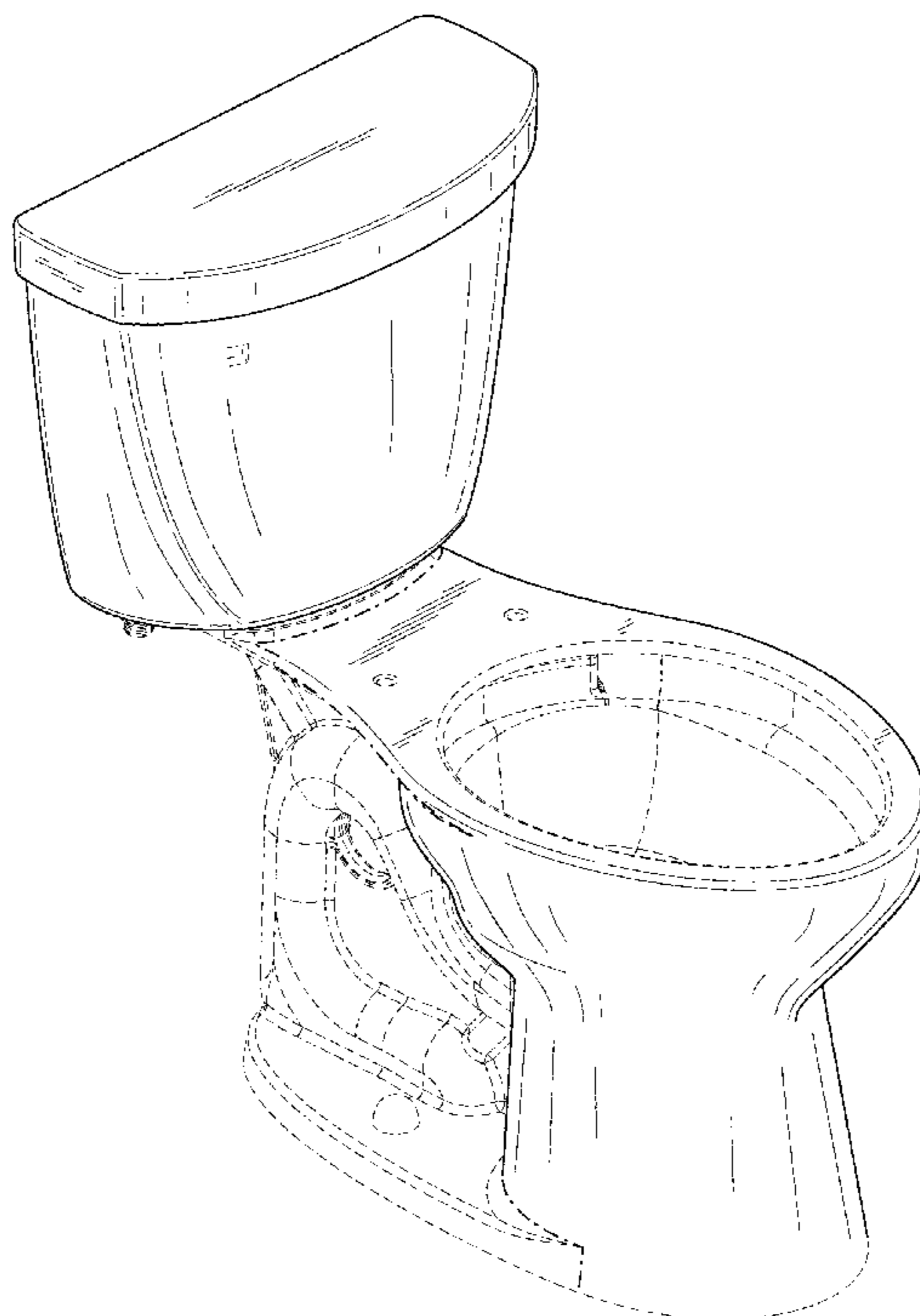
I claim the ornamental design for a toilet, as shown and

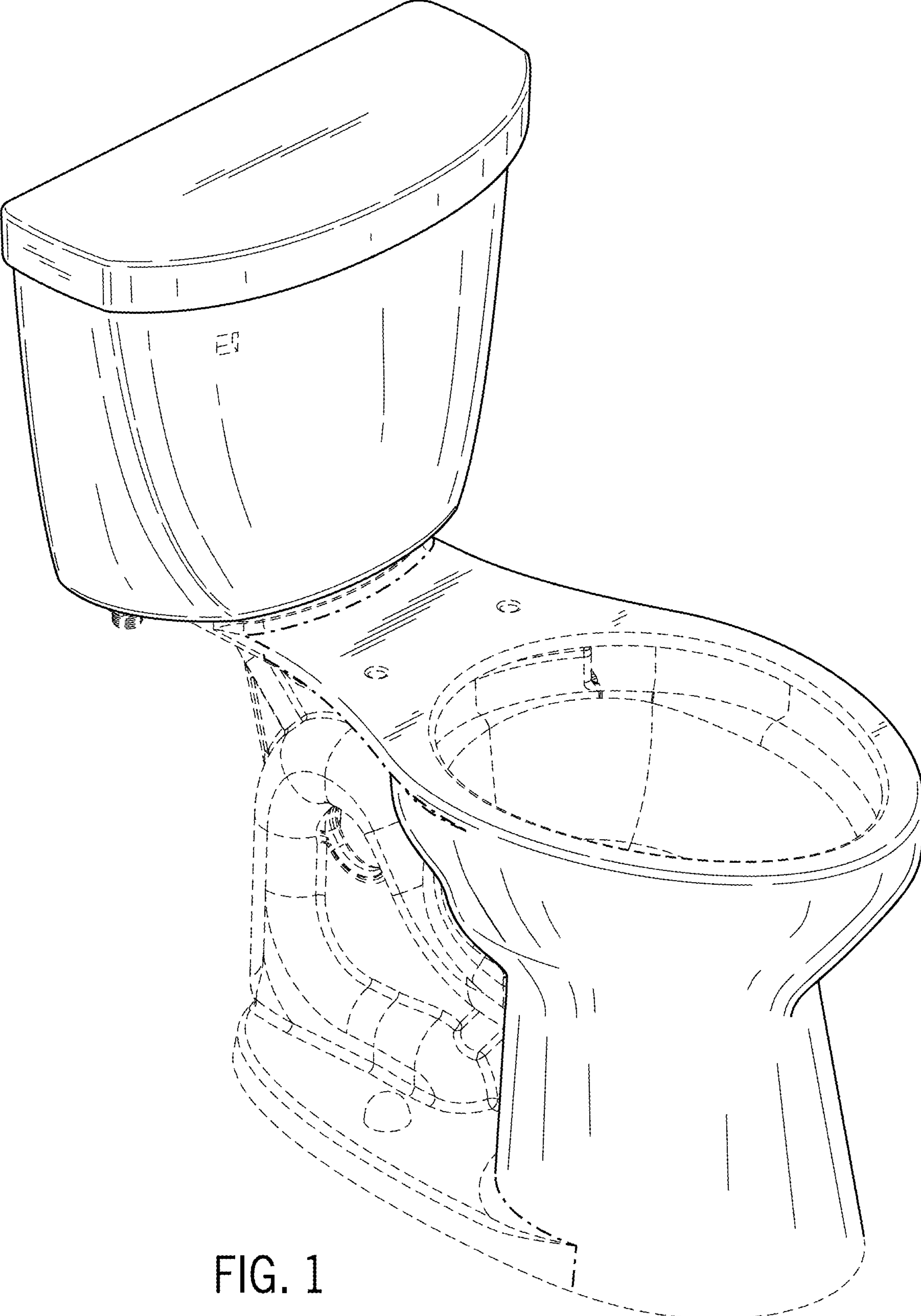

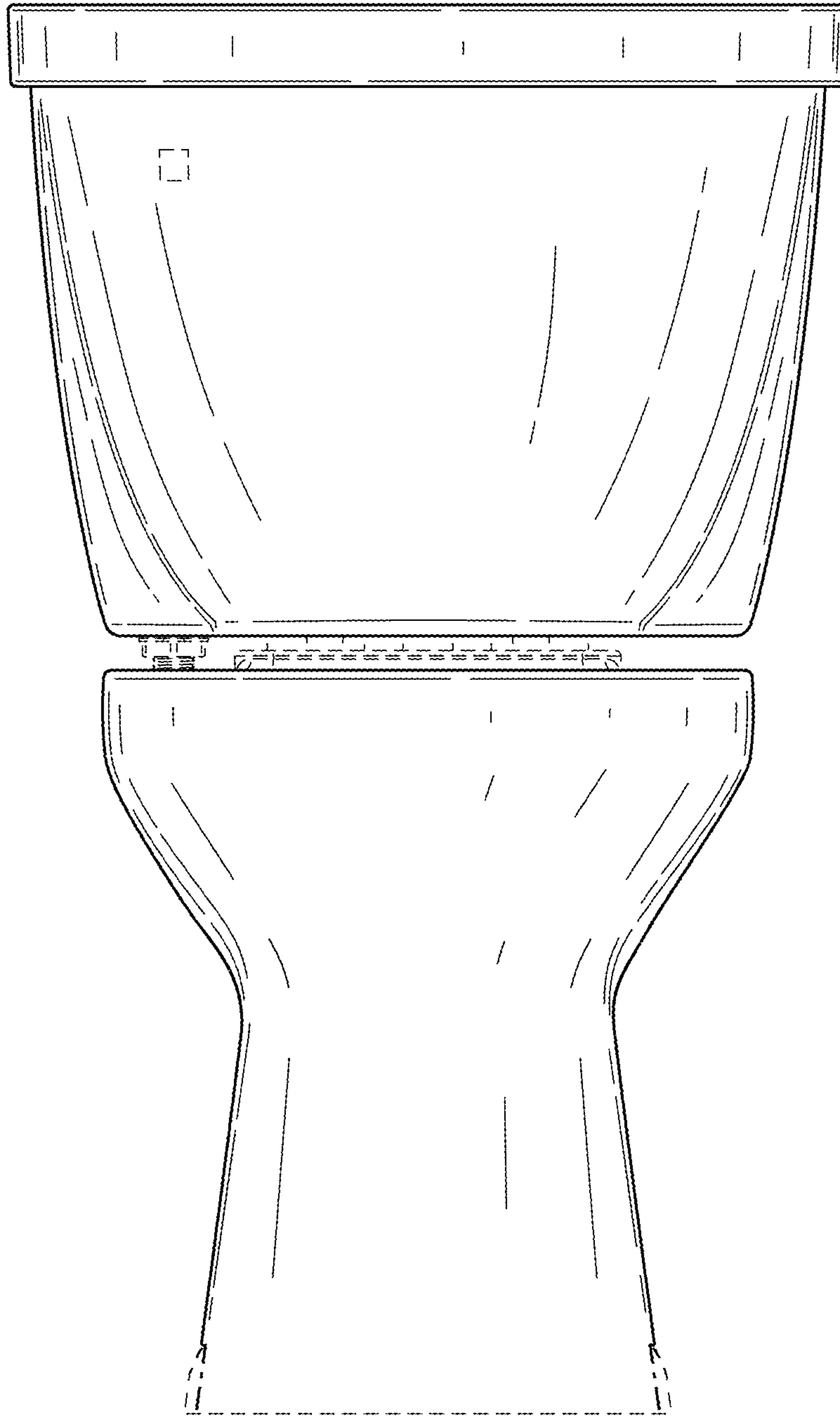

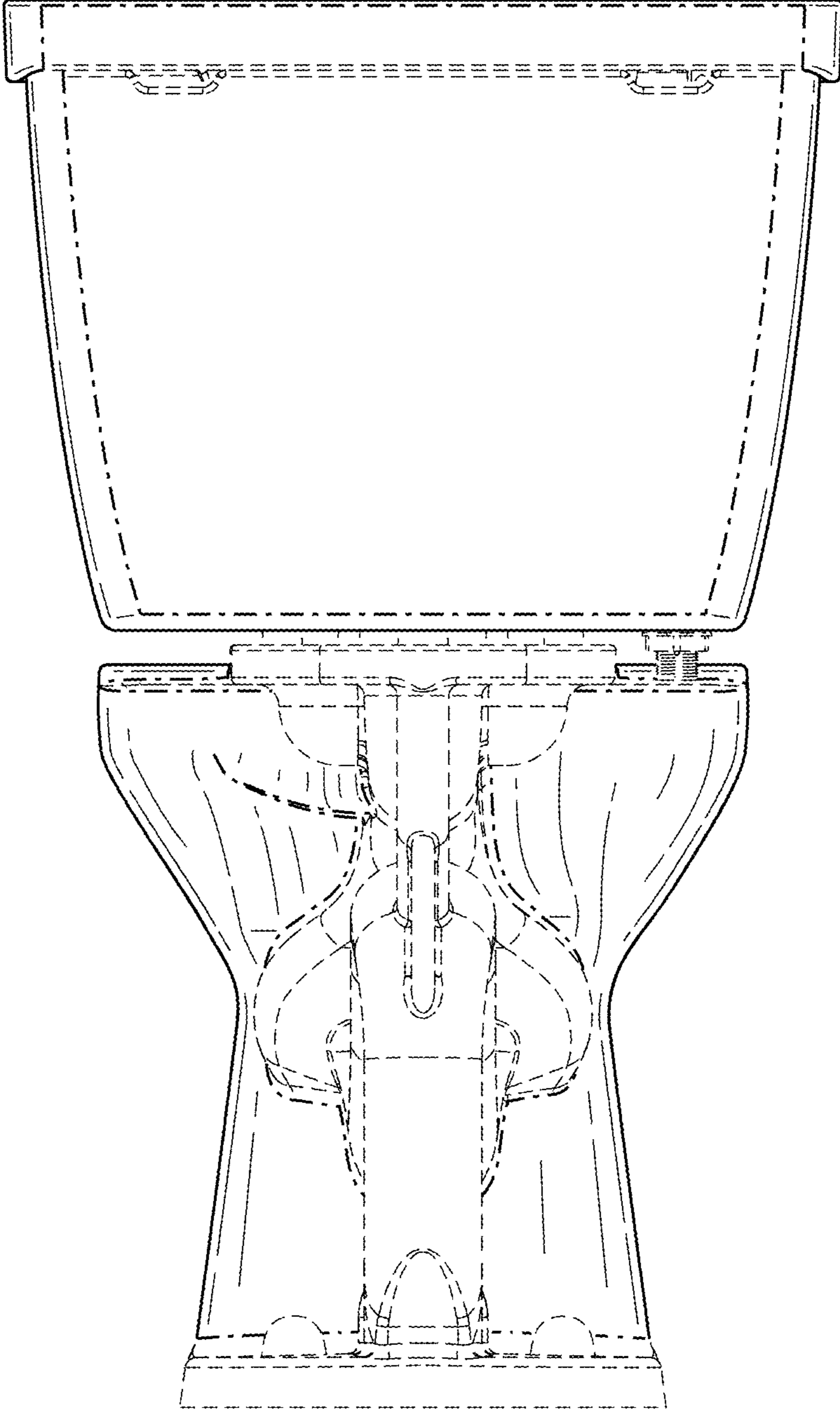

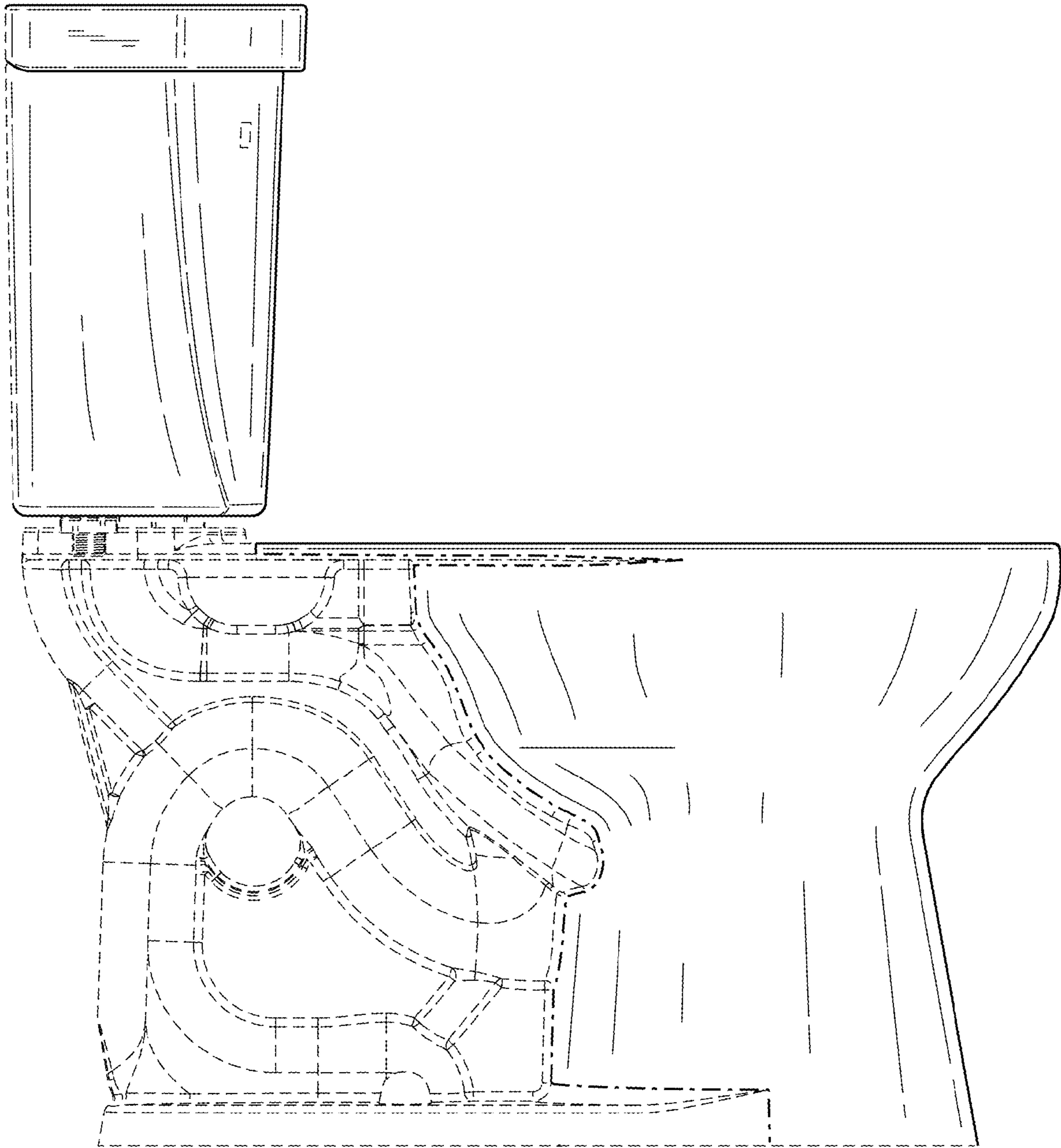

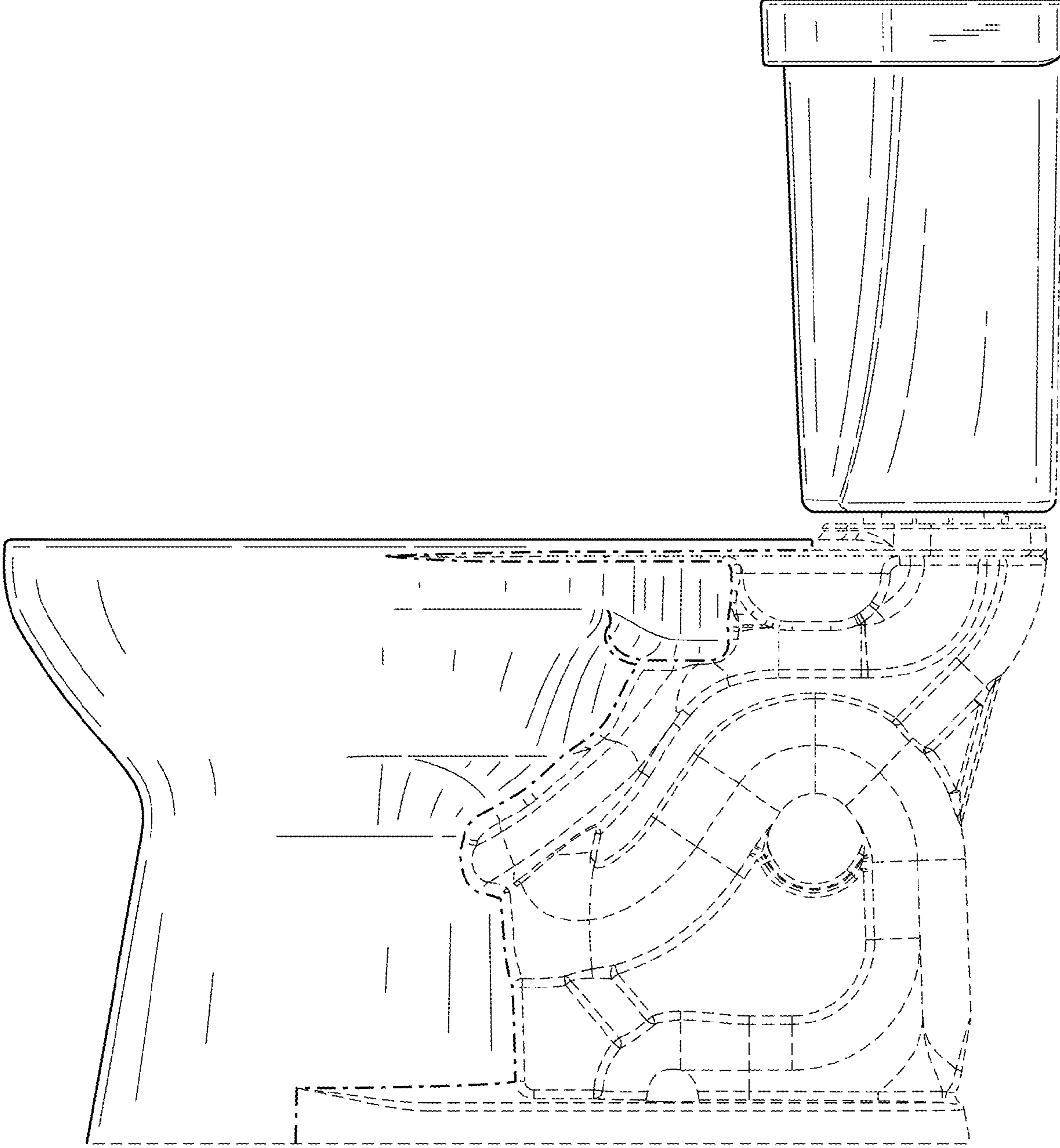

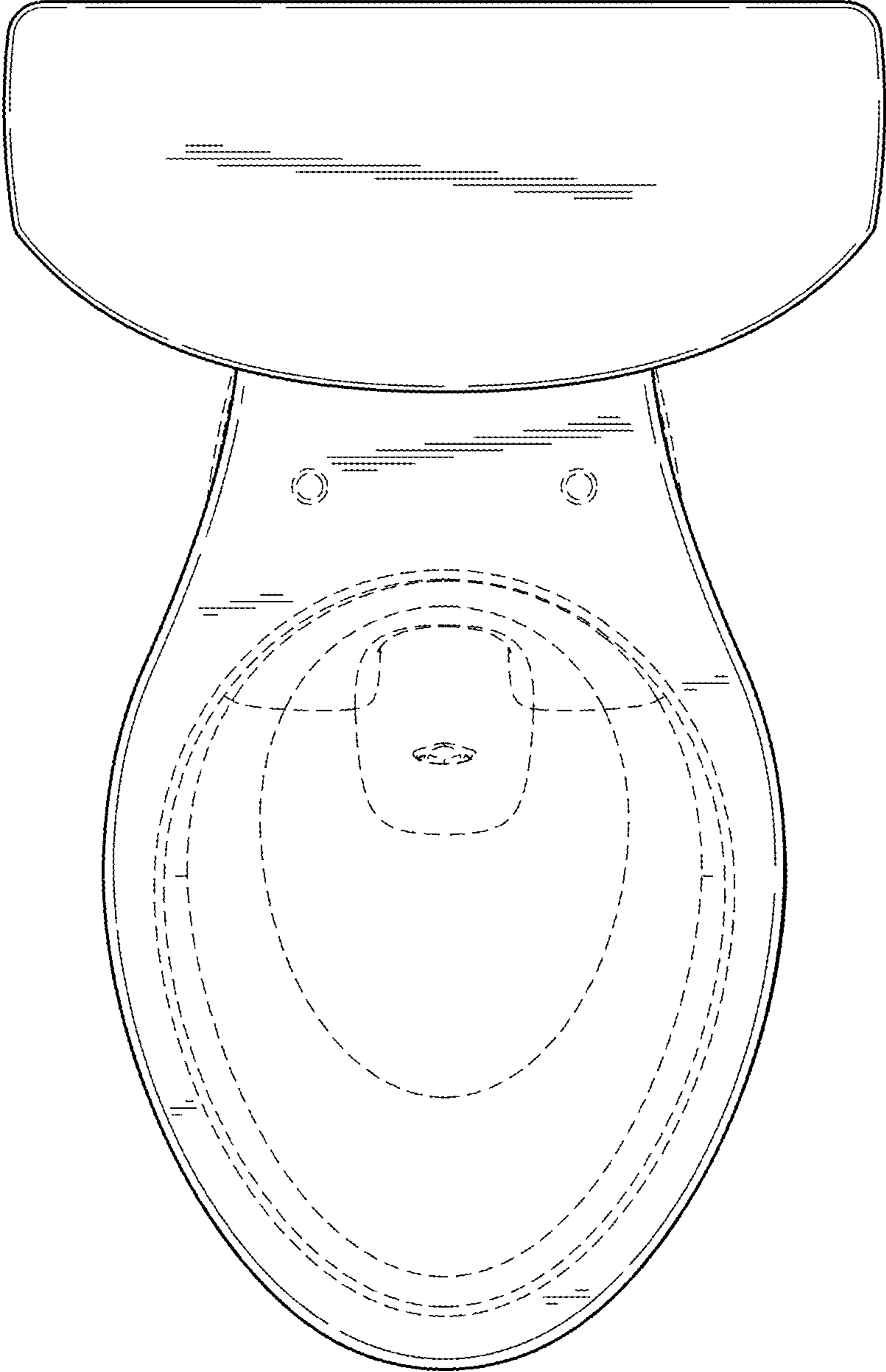

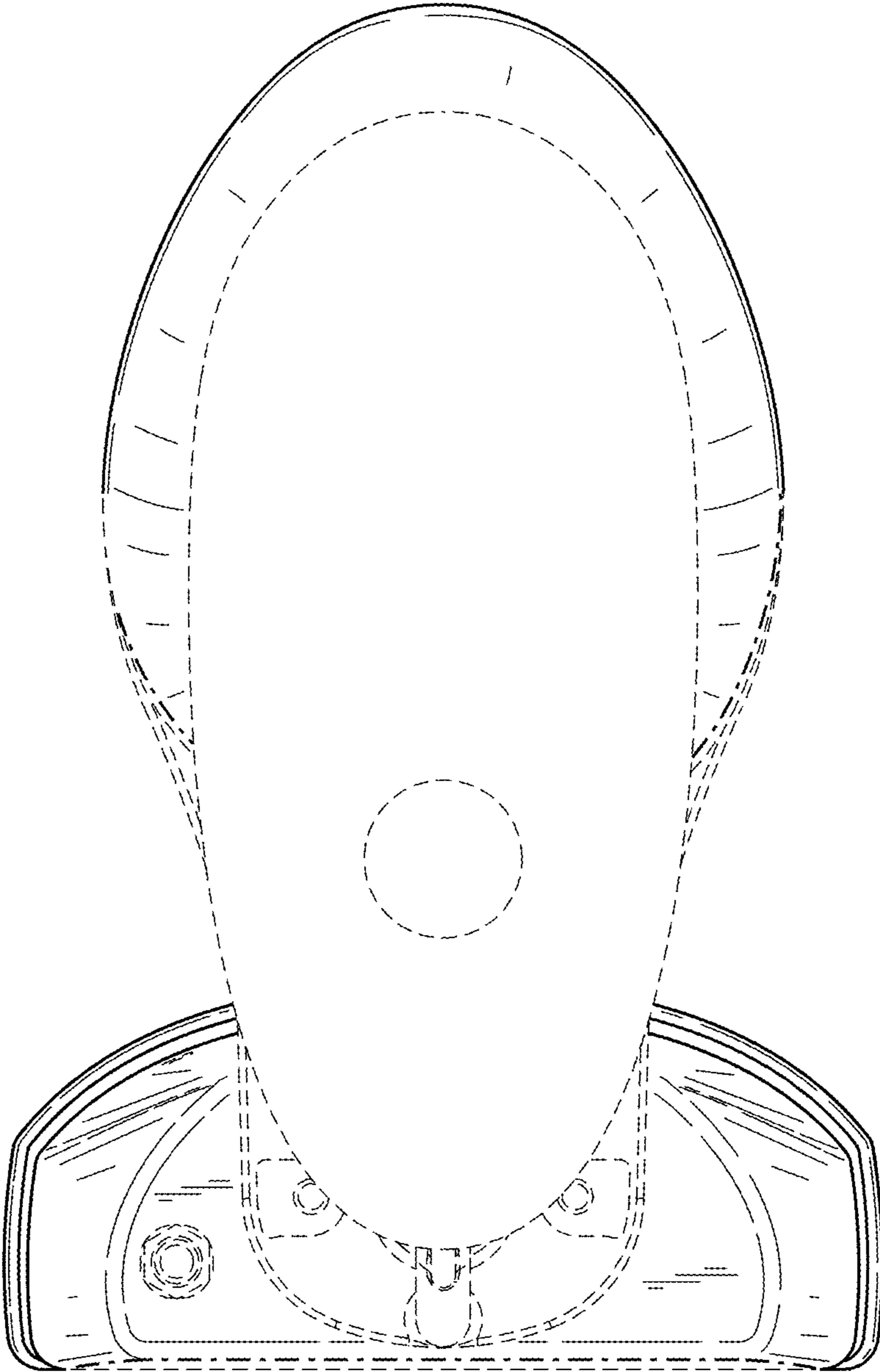
