The ornamental design for a humidifier, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right-side perspective view of a humidifier showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a right-side view thereof;  
FIG. 7 is a left-side view thereof; and,  
FIG. 8 is a rear, top and left-side perspective view thereof.  
The broken lines shown in the drawings depict portions of the humidifier that form no part of the claimed design.

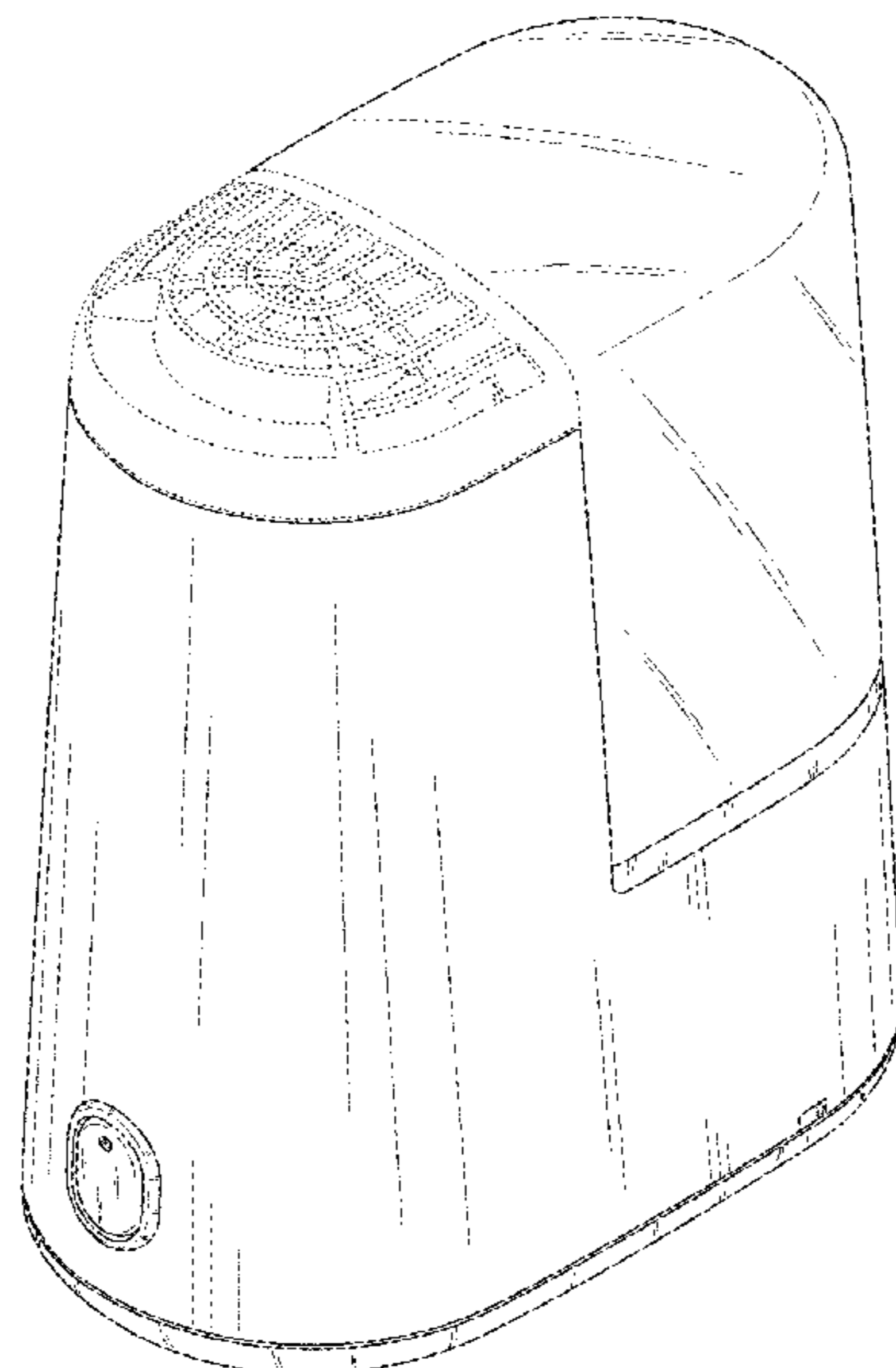

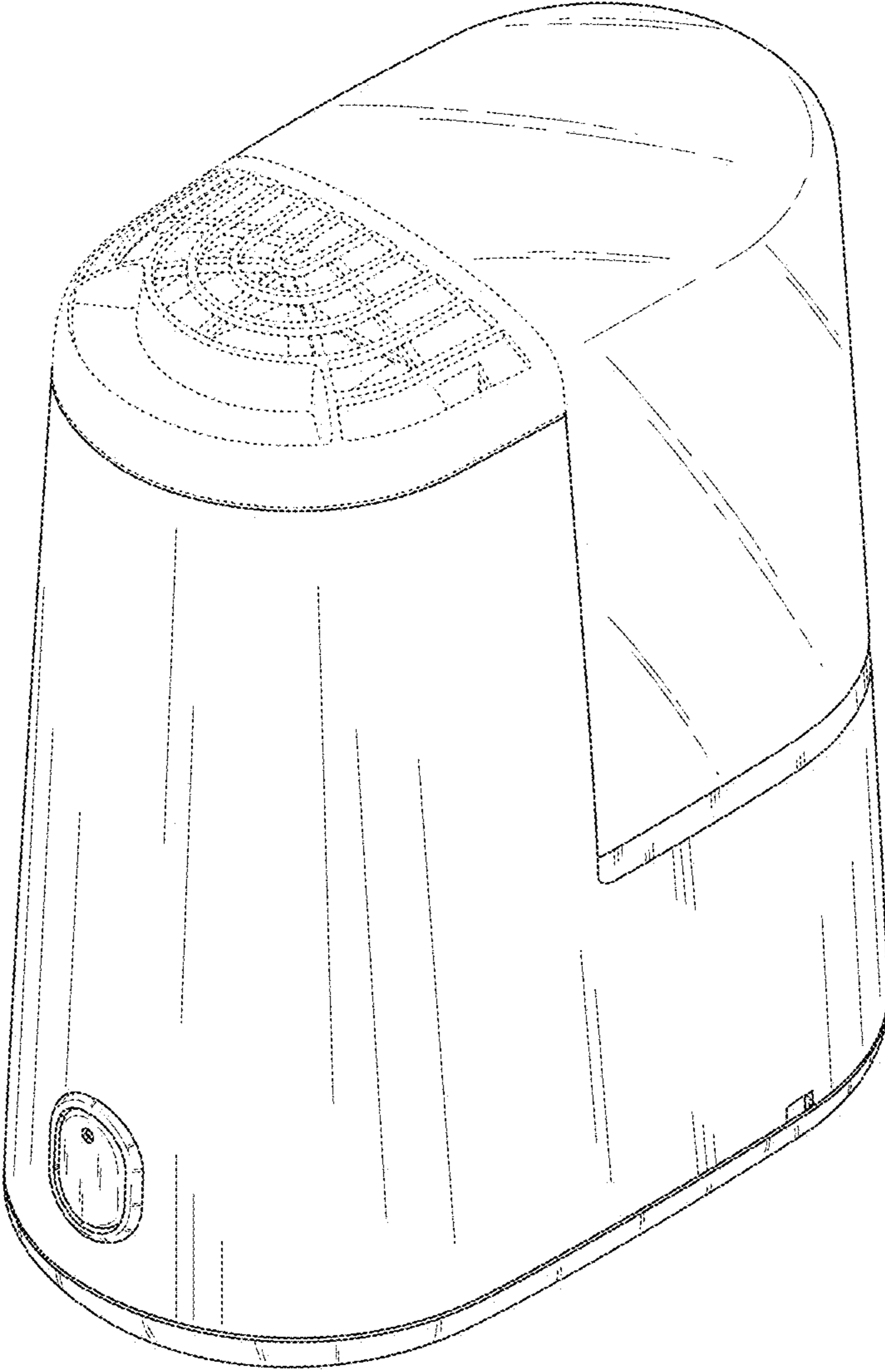

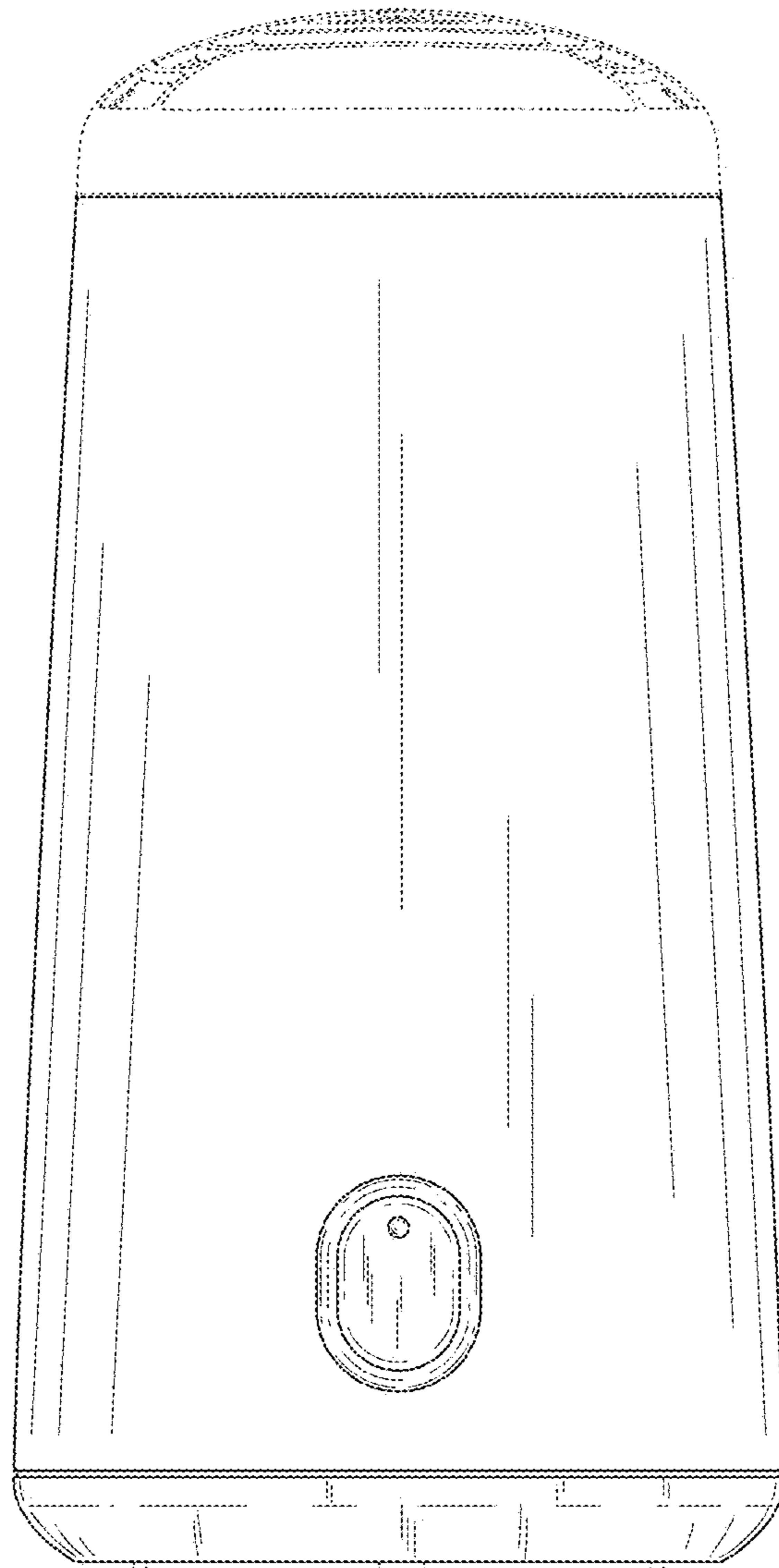

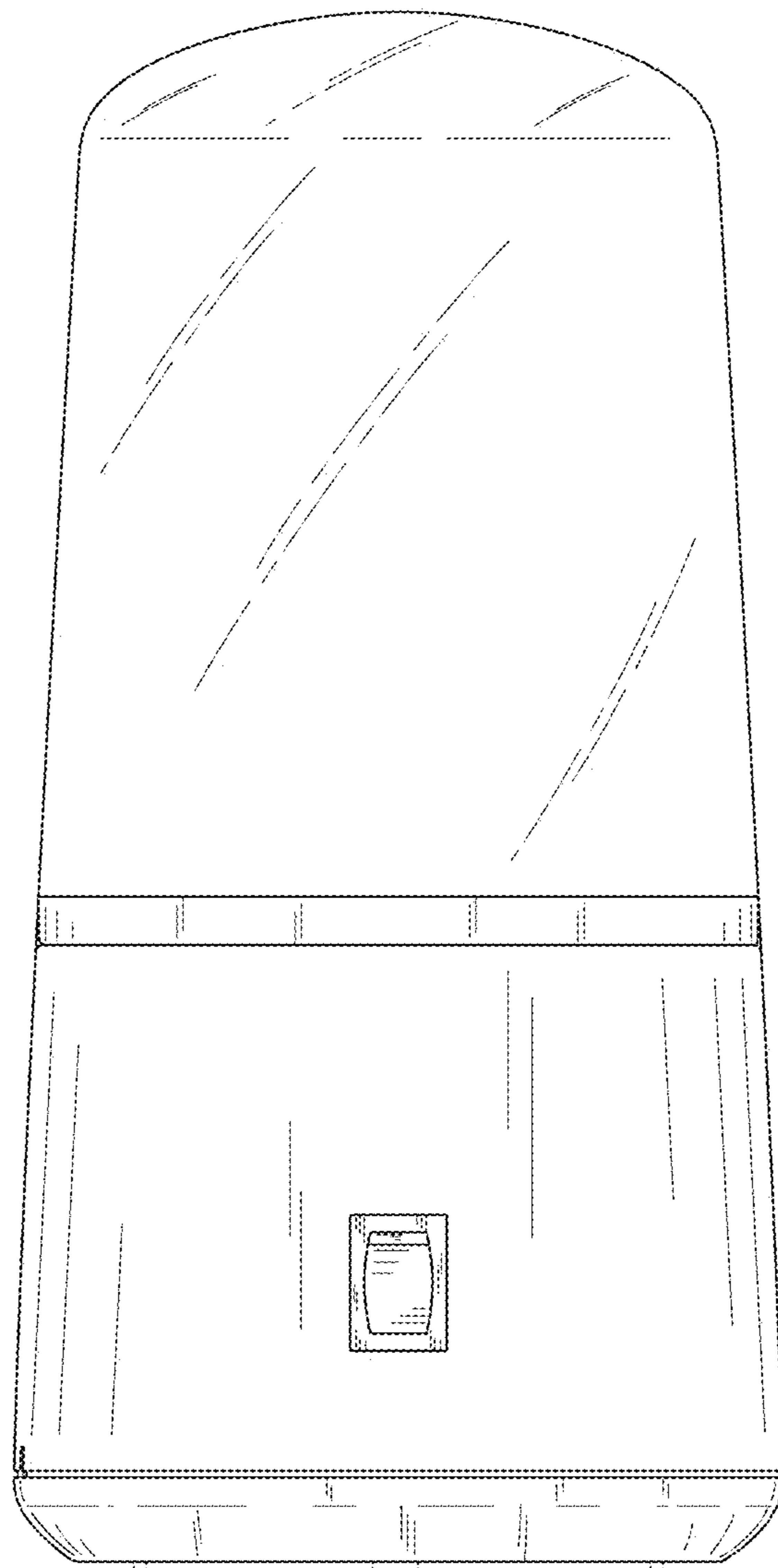

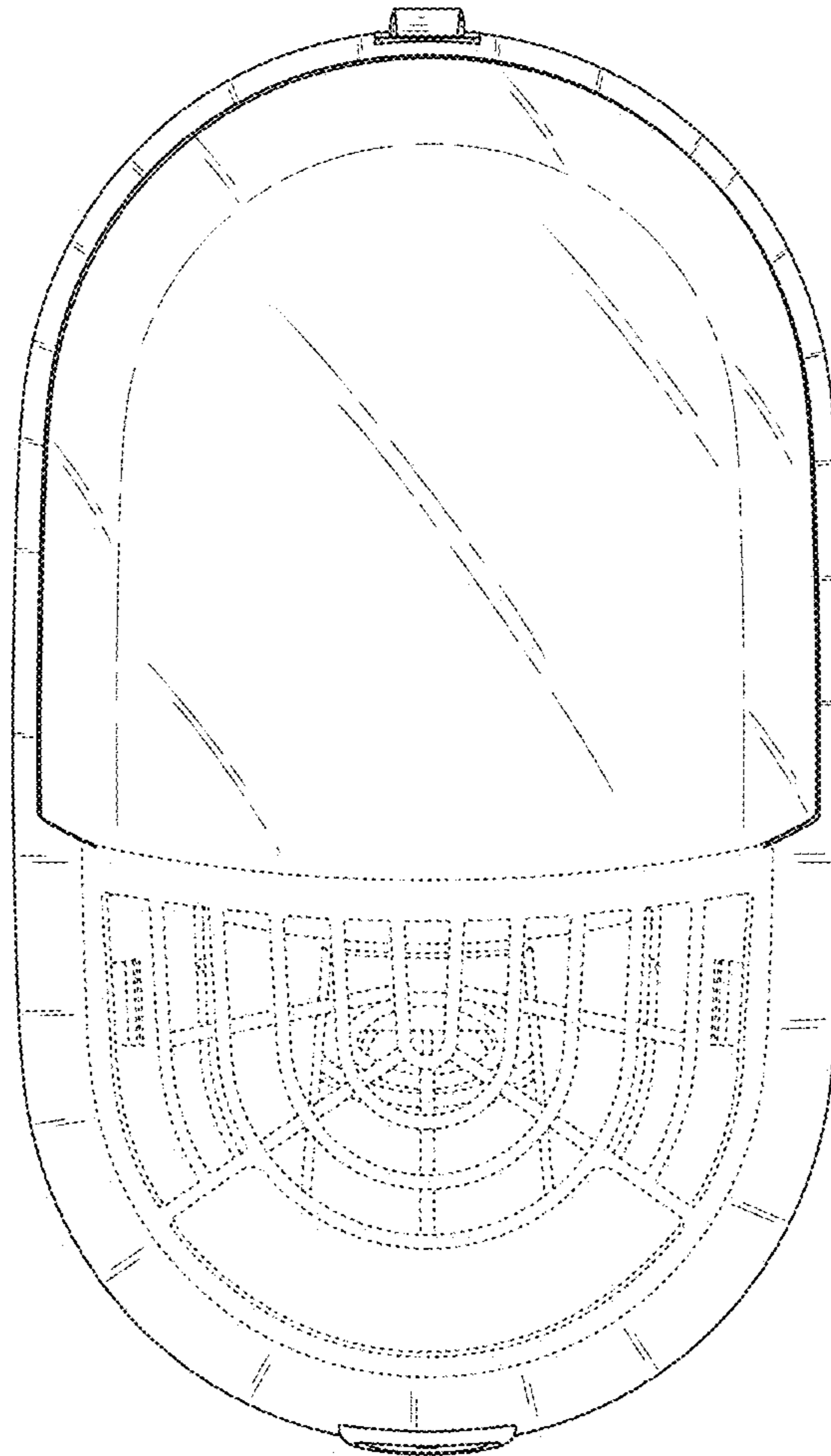

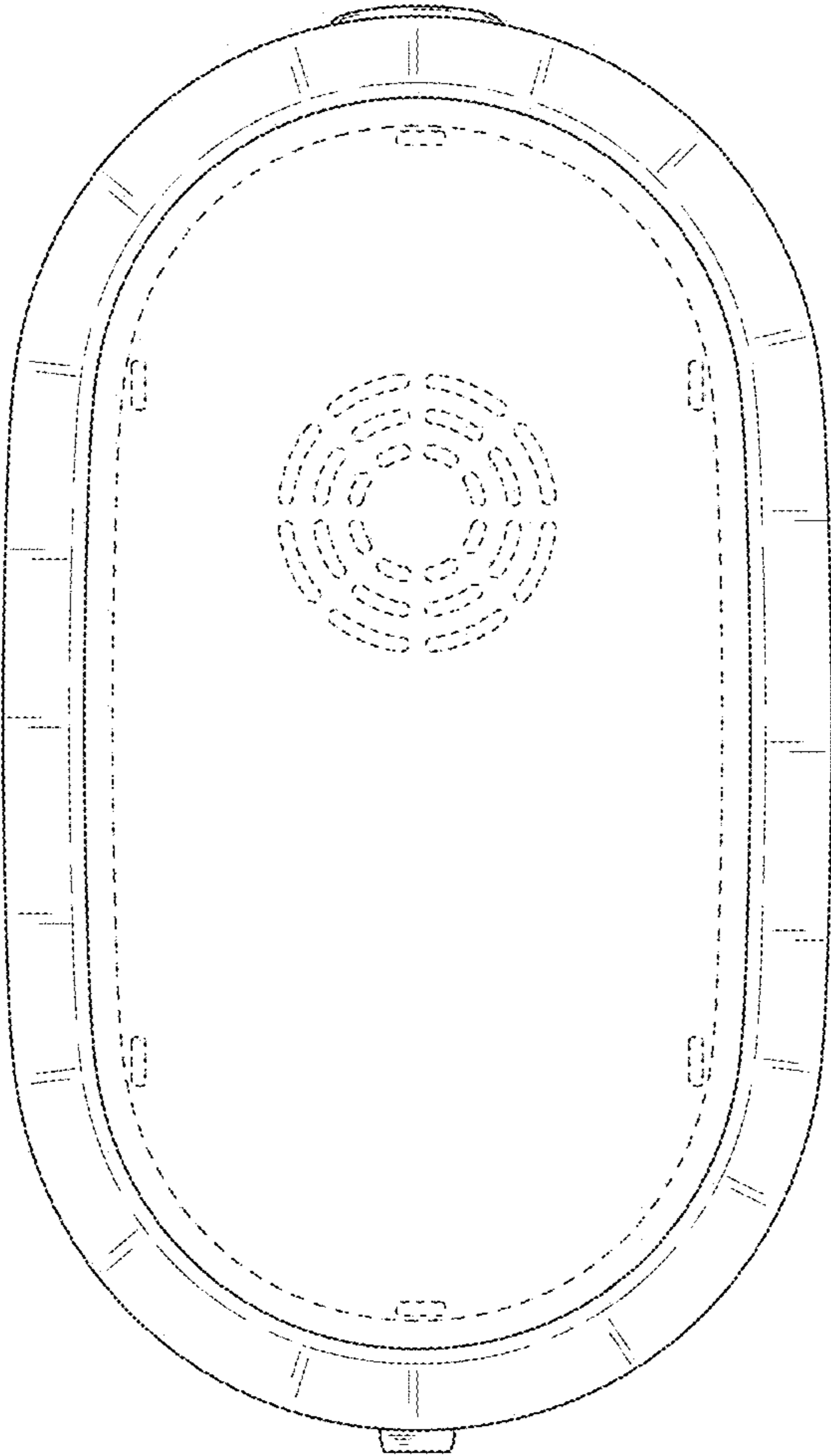

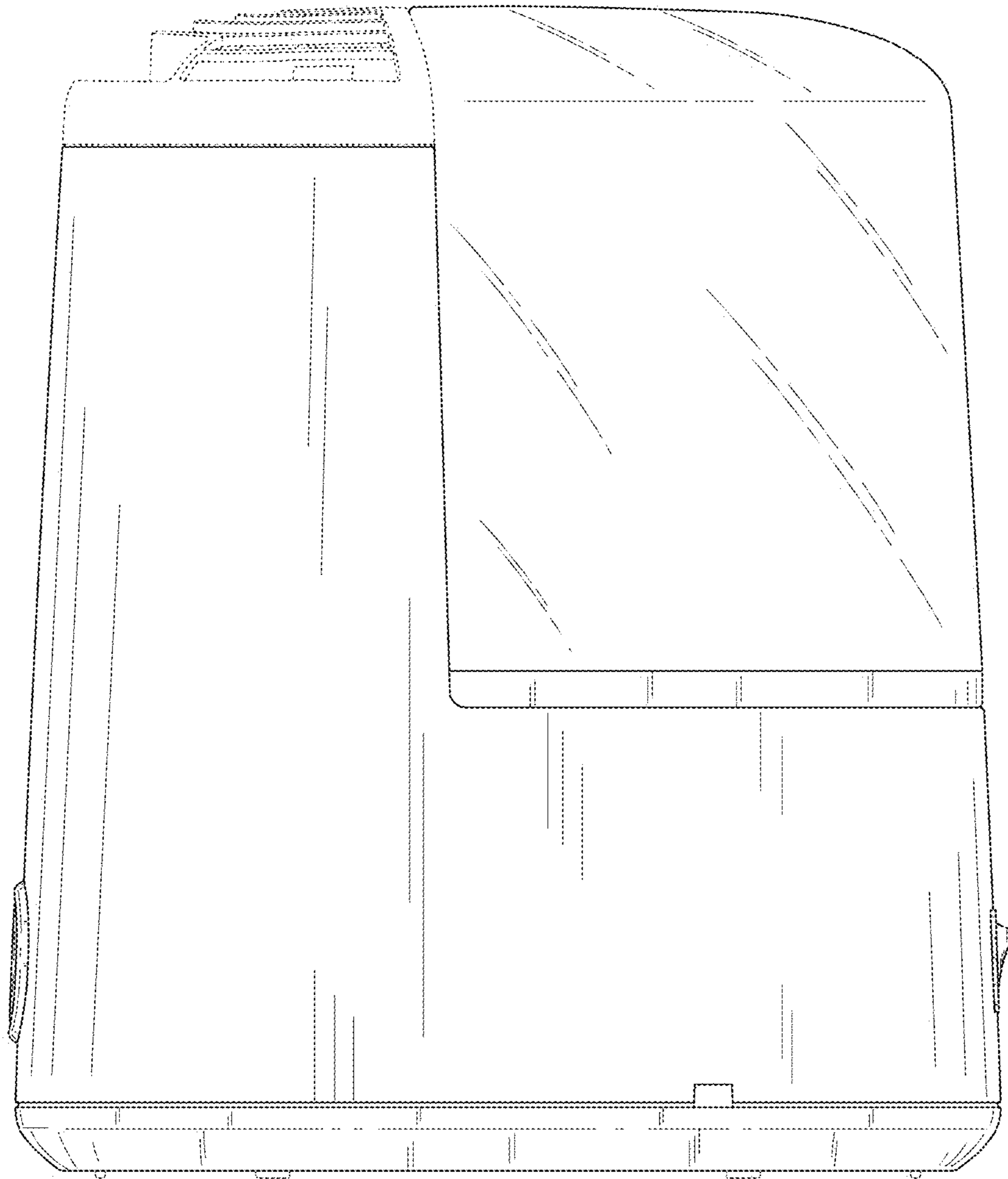

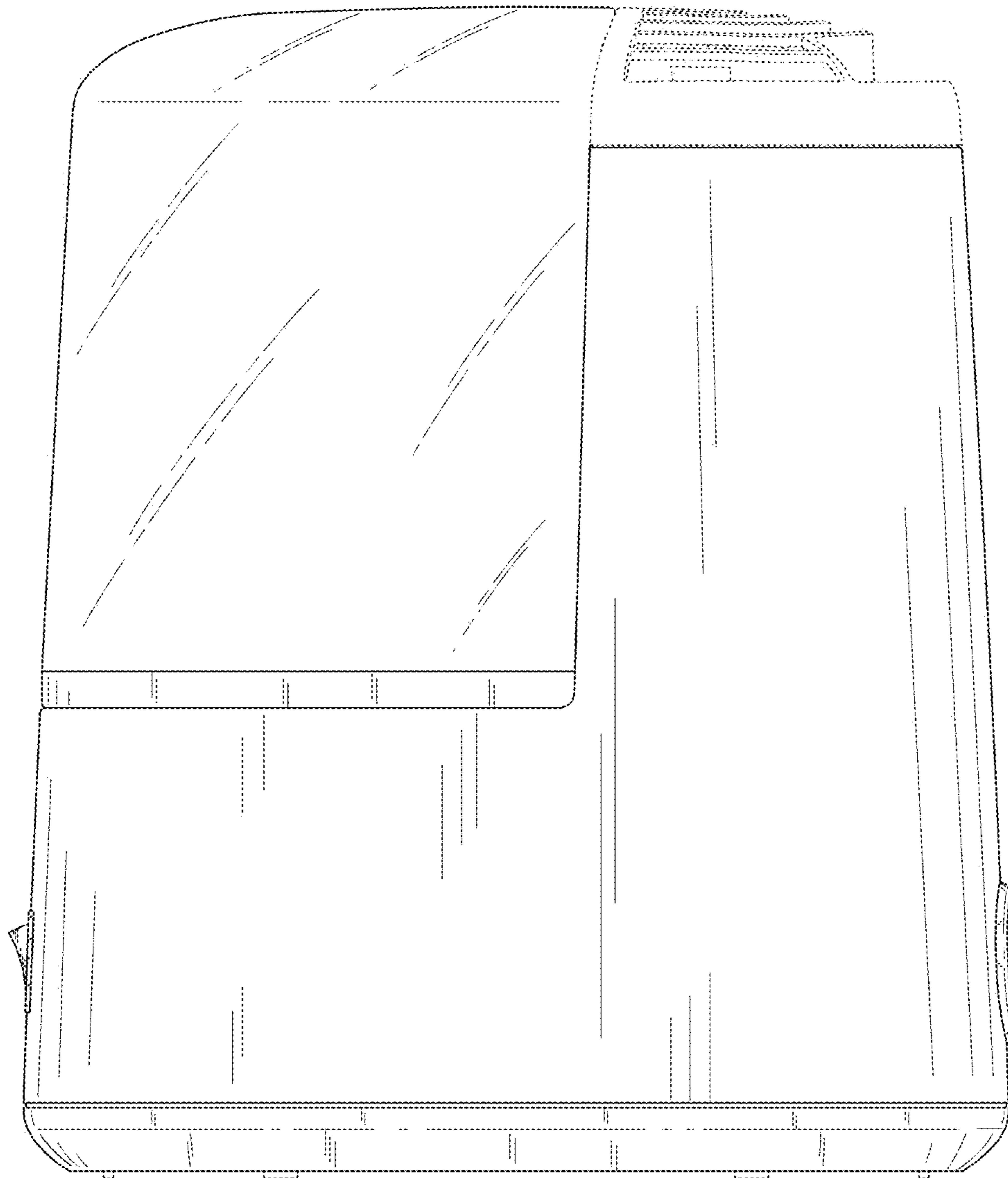
