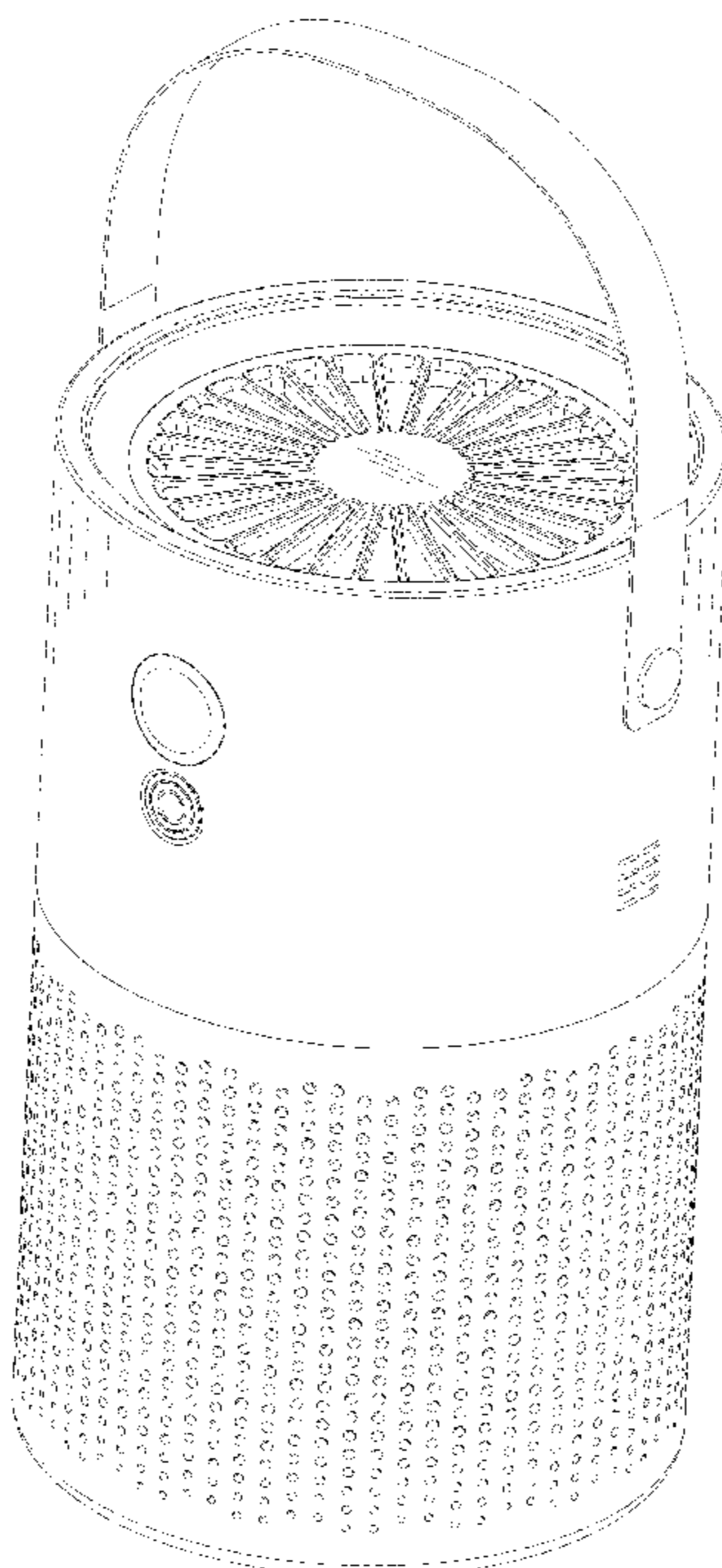
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, top perspective view of the desktop air purifier showing my new design;

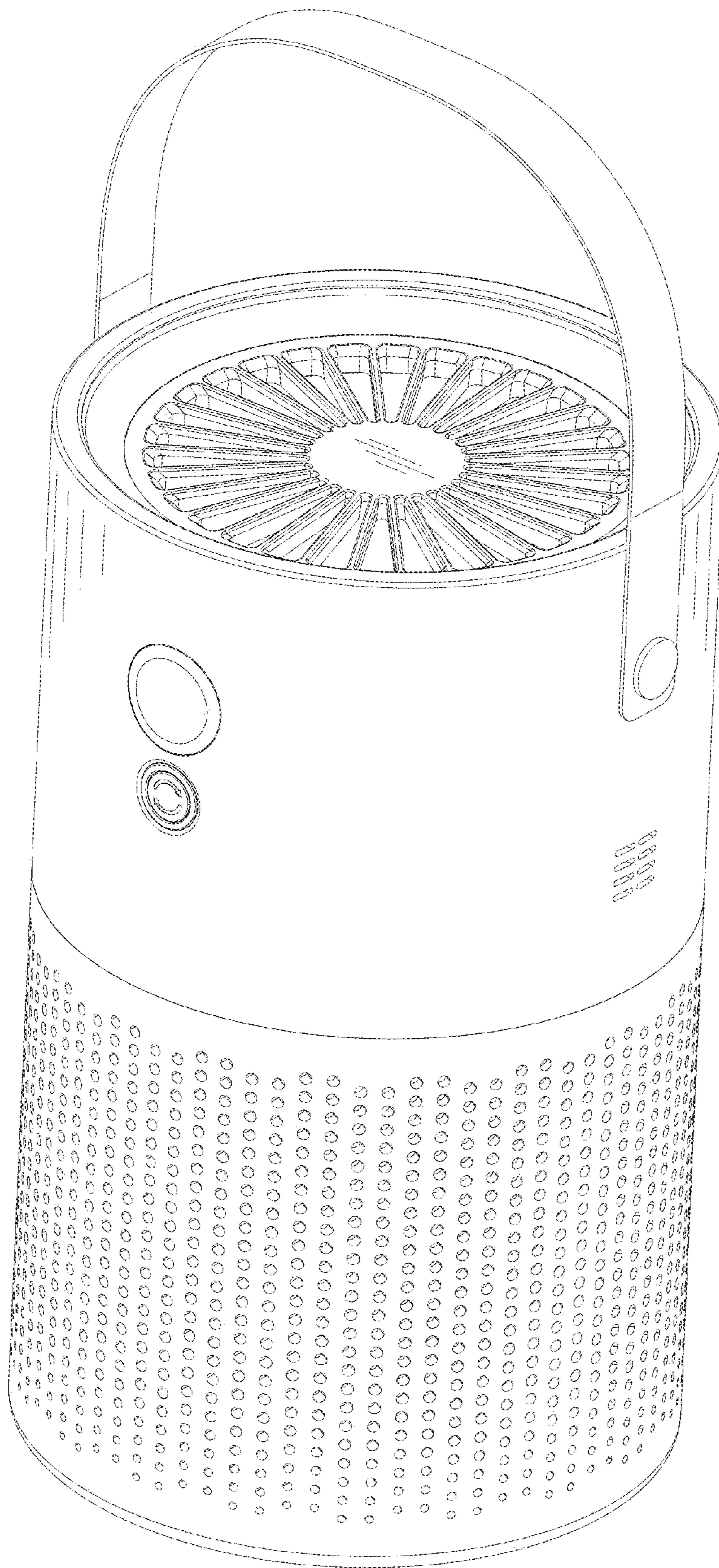

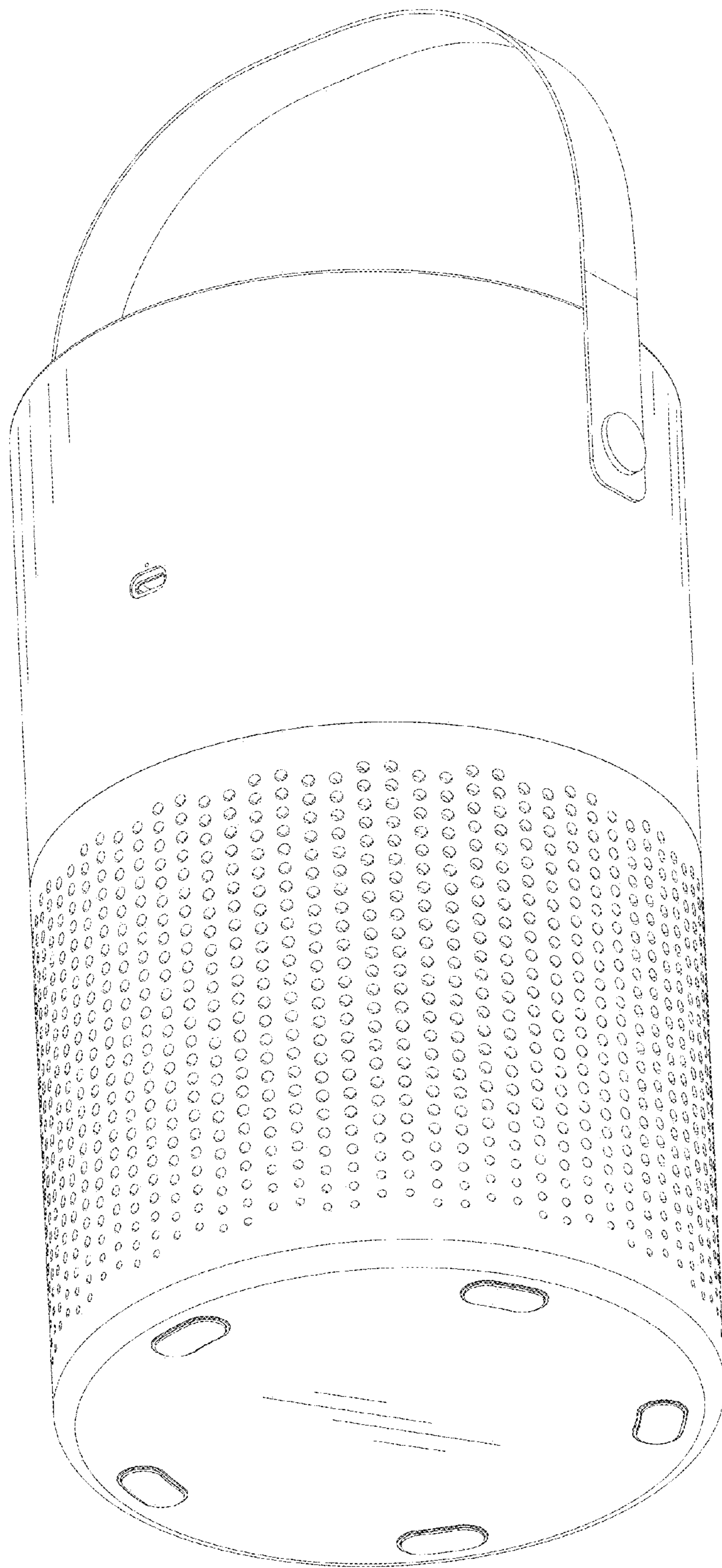

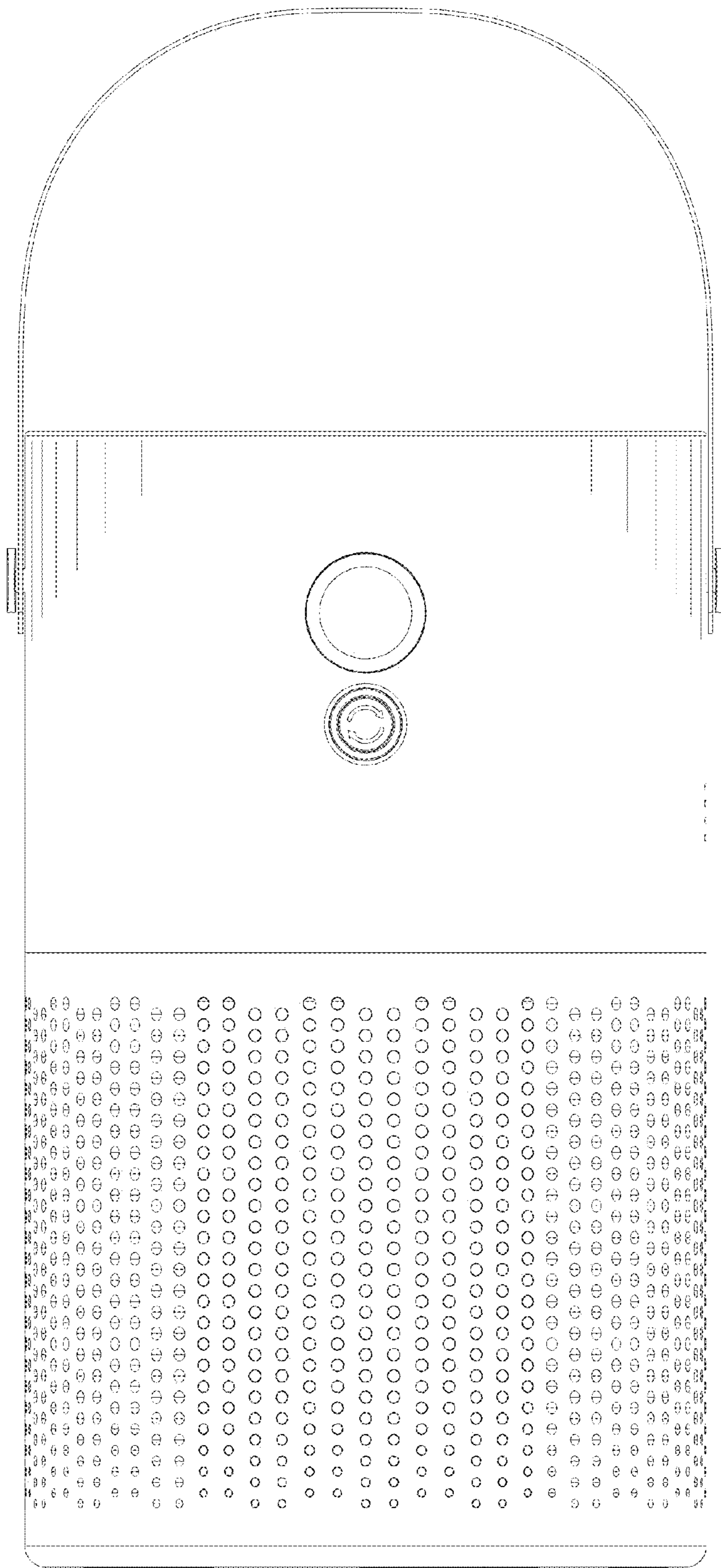

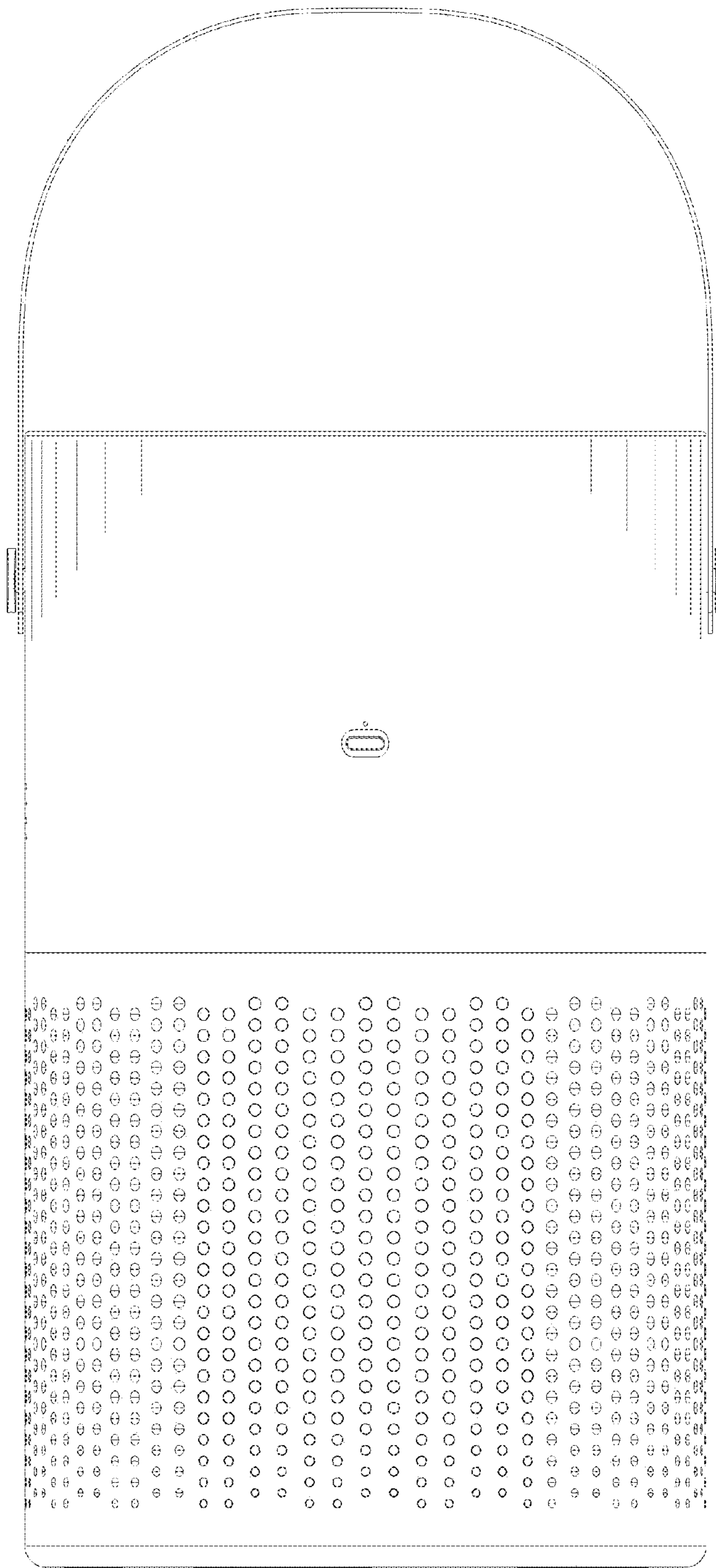

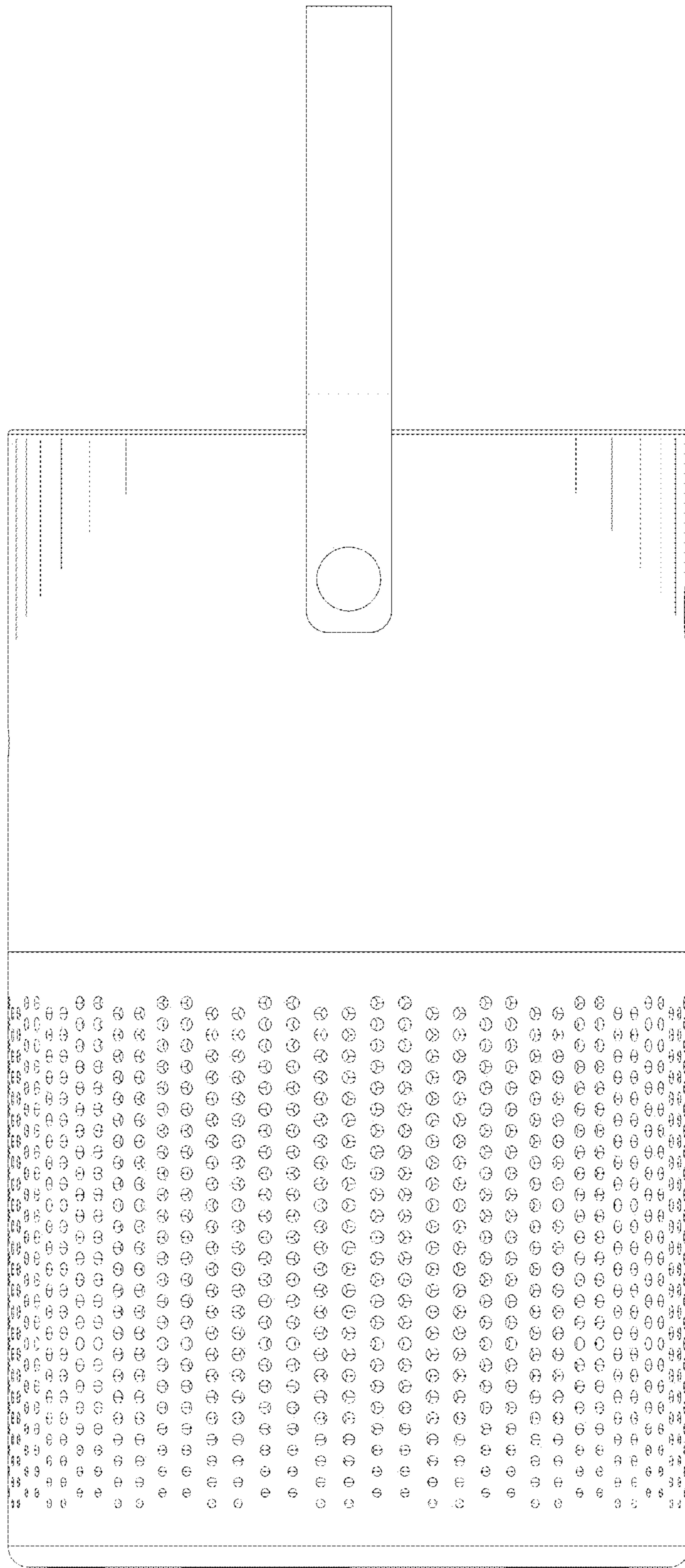

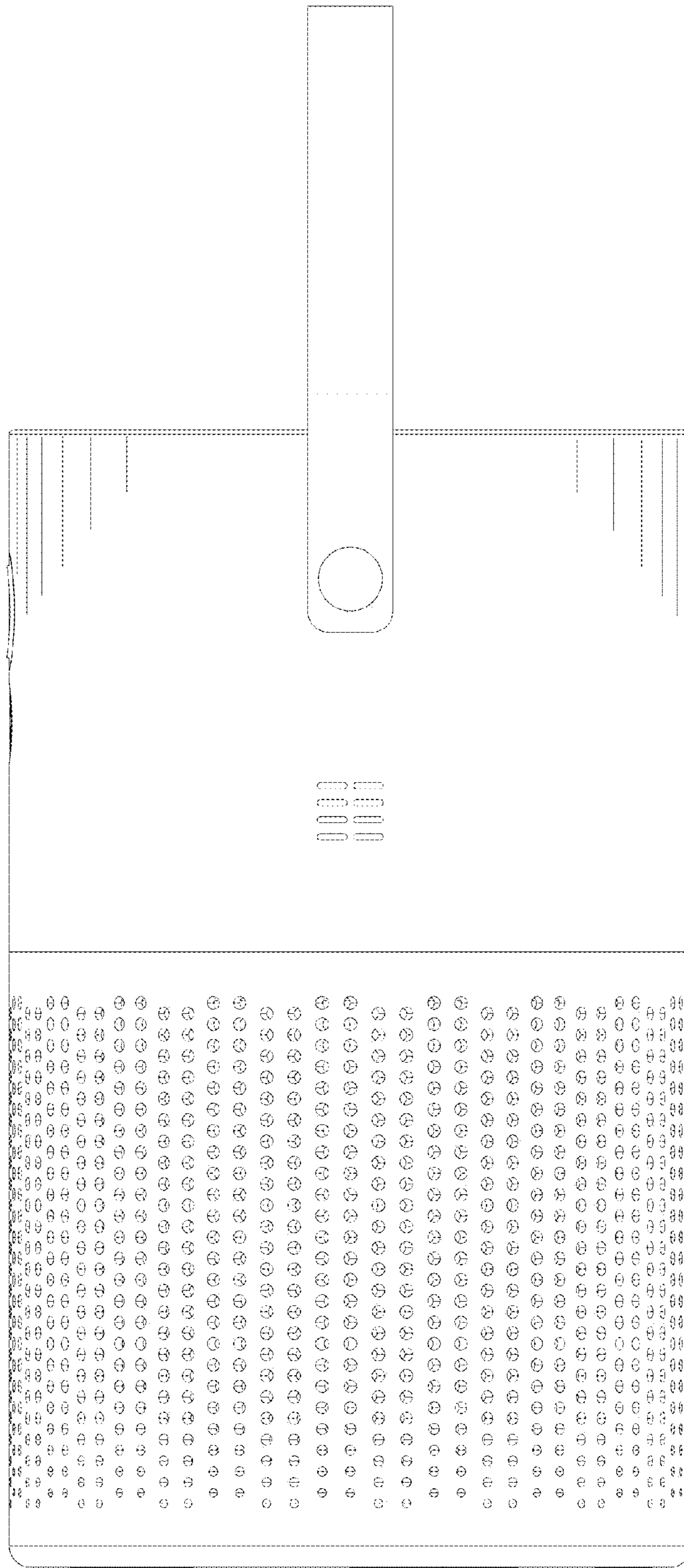

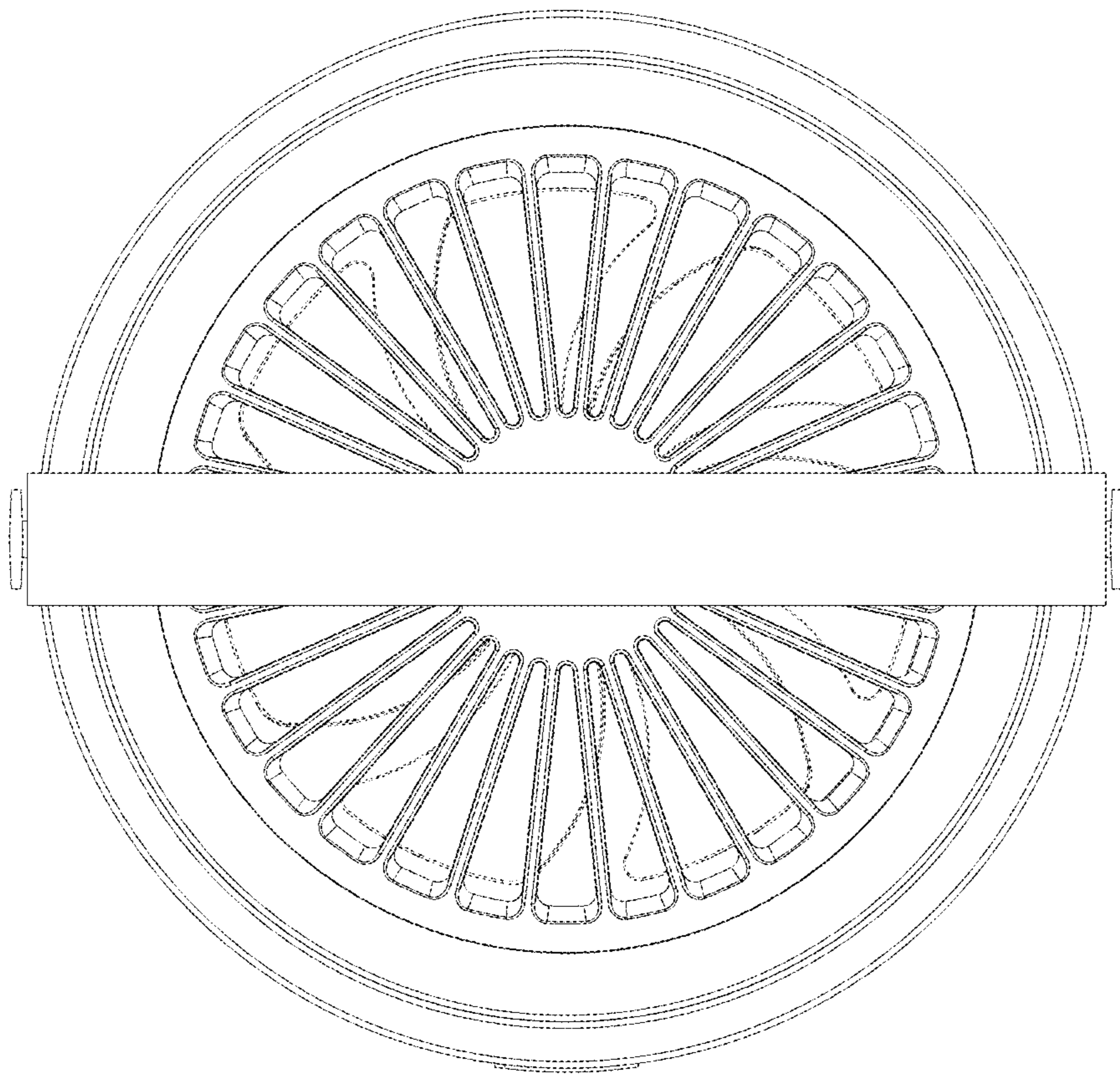

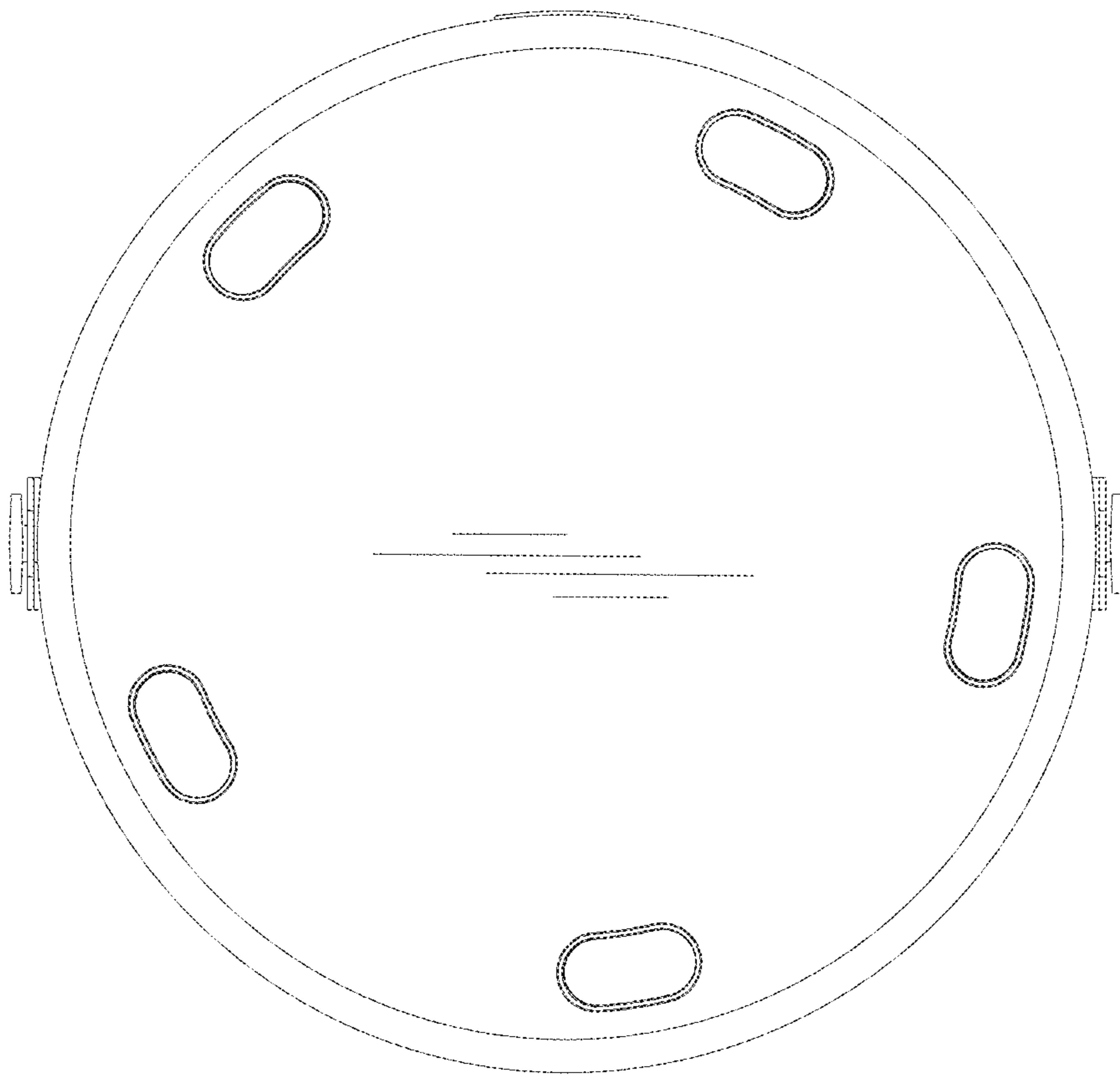
