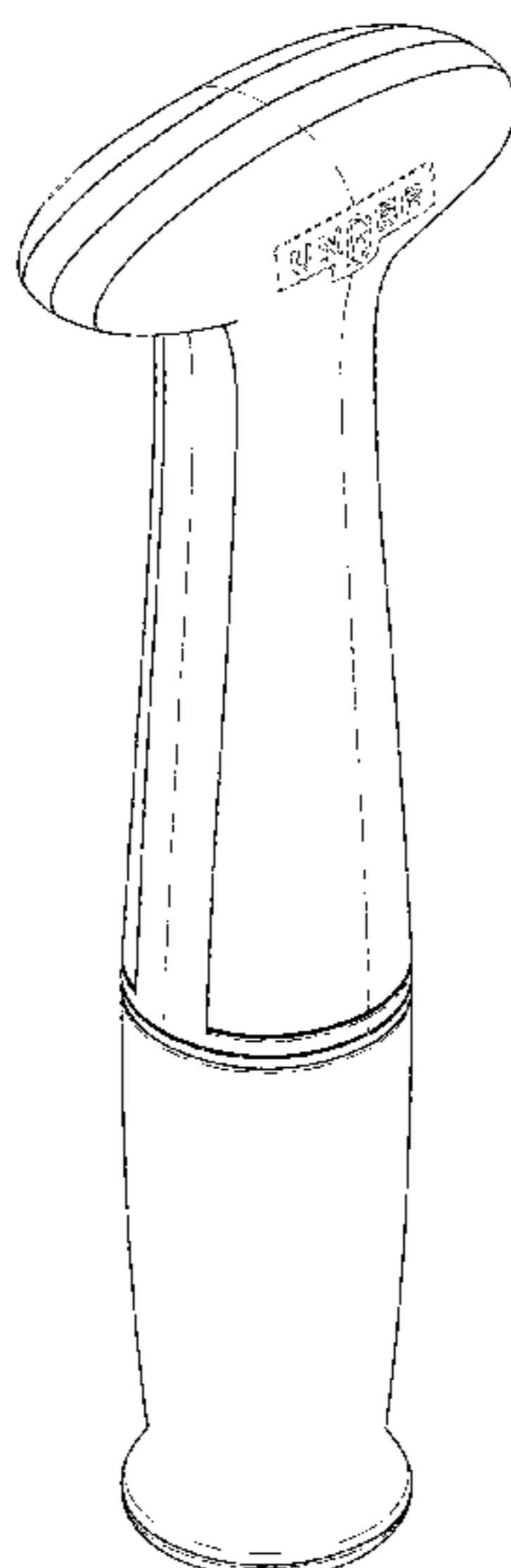
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top perspective view of a top grip according to the present disclosure;
FIG. 2 is a front, bottom perspective view of the top grip of FIG. 1;
FIG. 3 is a first side view of the top grip of FIG. 1;
FIG. 4 is a front view of the top grip of FIG. 1, the rear view being identical thereto;
FIG. 5 is a second side view of the top grip of FIG. 1;
FIG. 6 is a top view of the top grip of FIG. 1; and,
FIG. 7 is a bottom view of the top grip of FIG. 1.

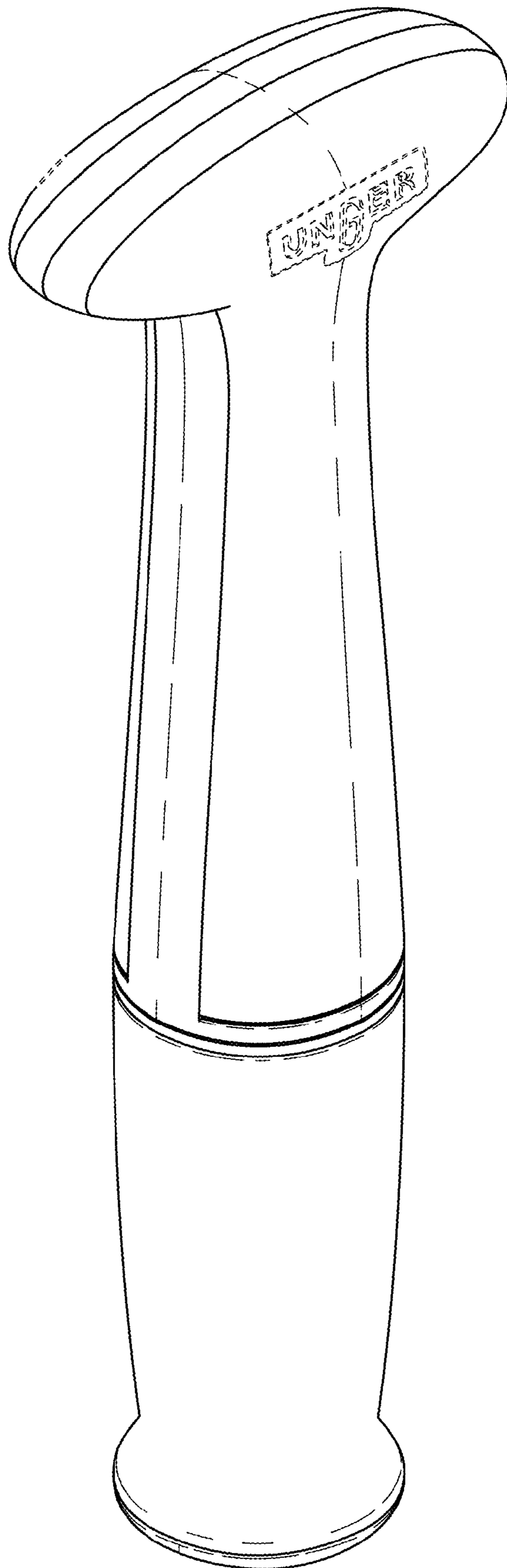

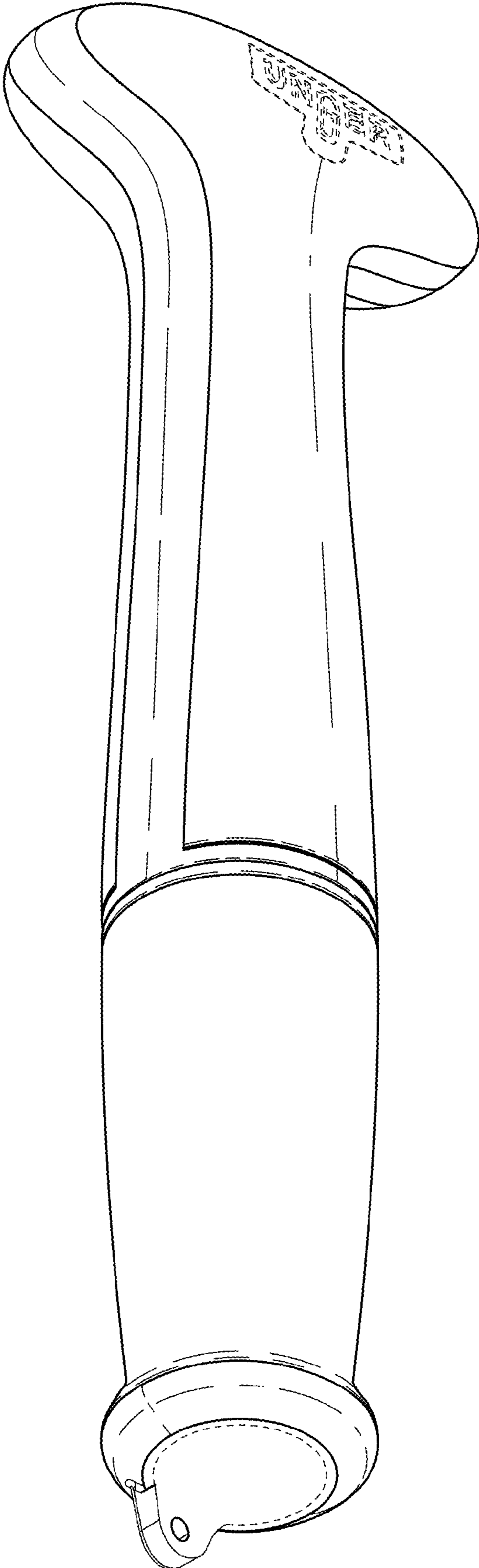

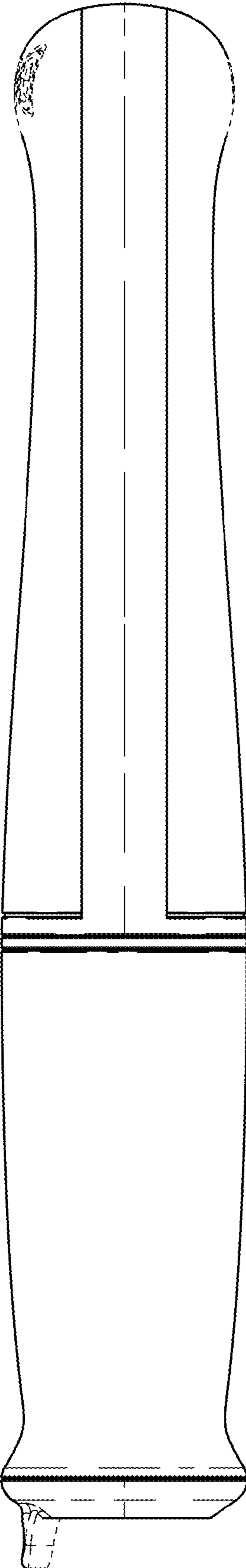

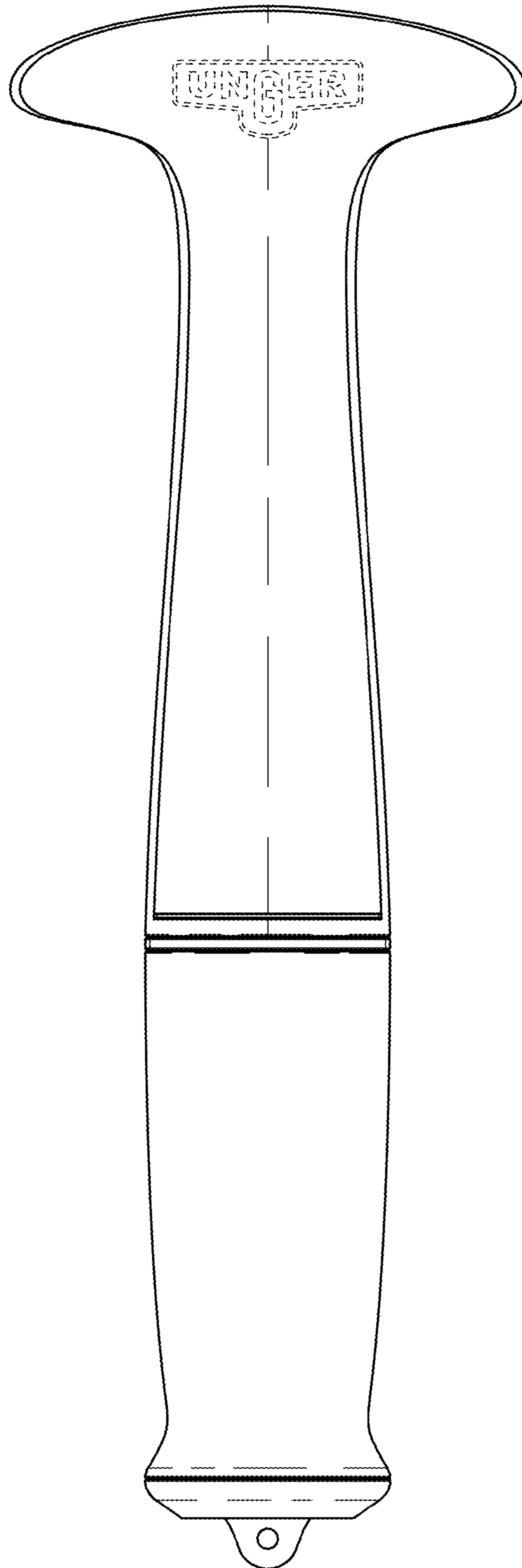

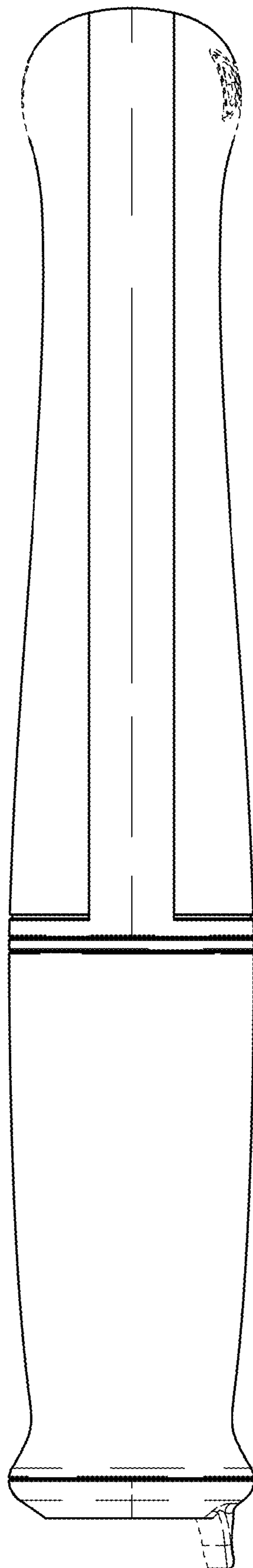

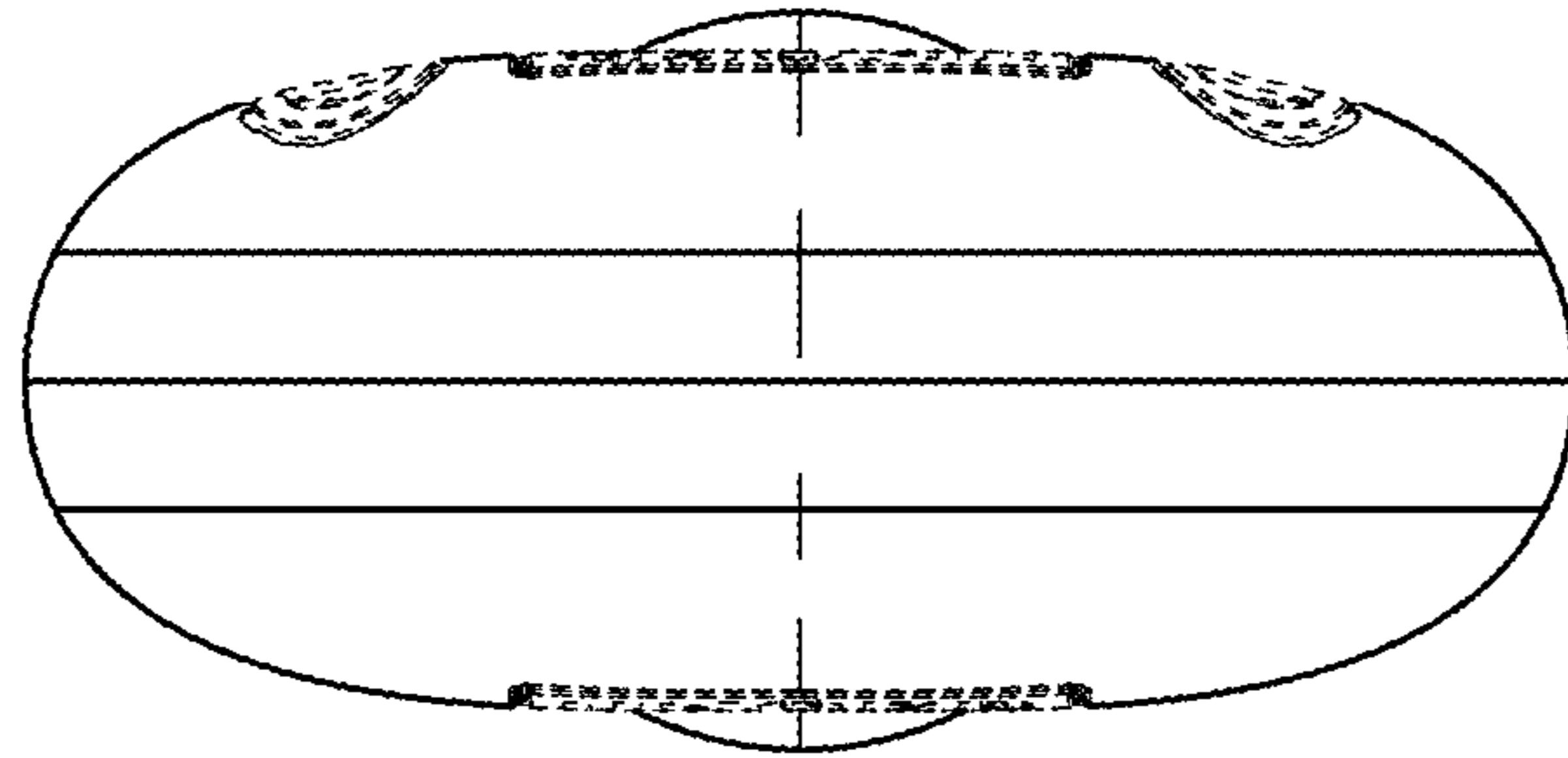

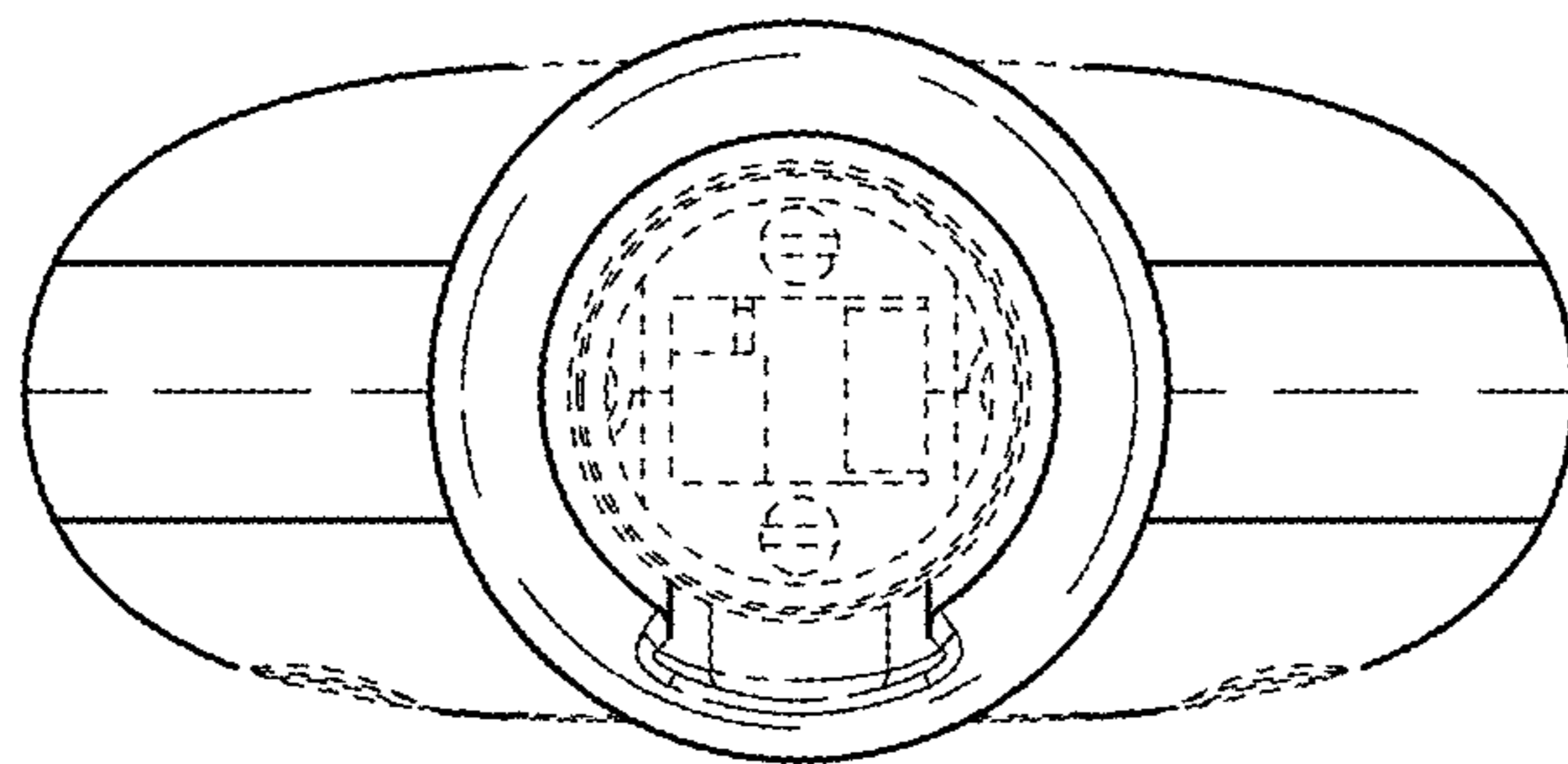
