The ornamental design for an insert for footwear, as shown and described.

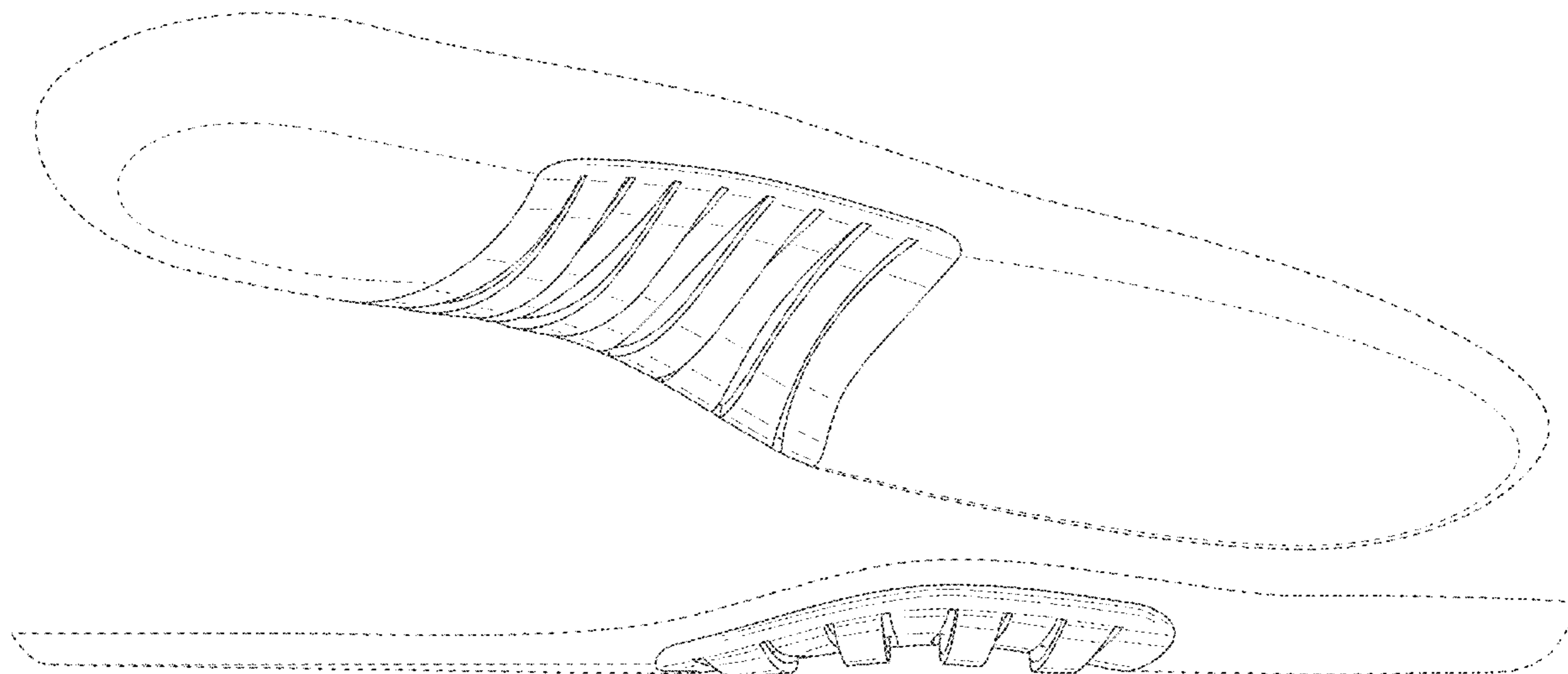
DESCRIPTION

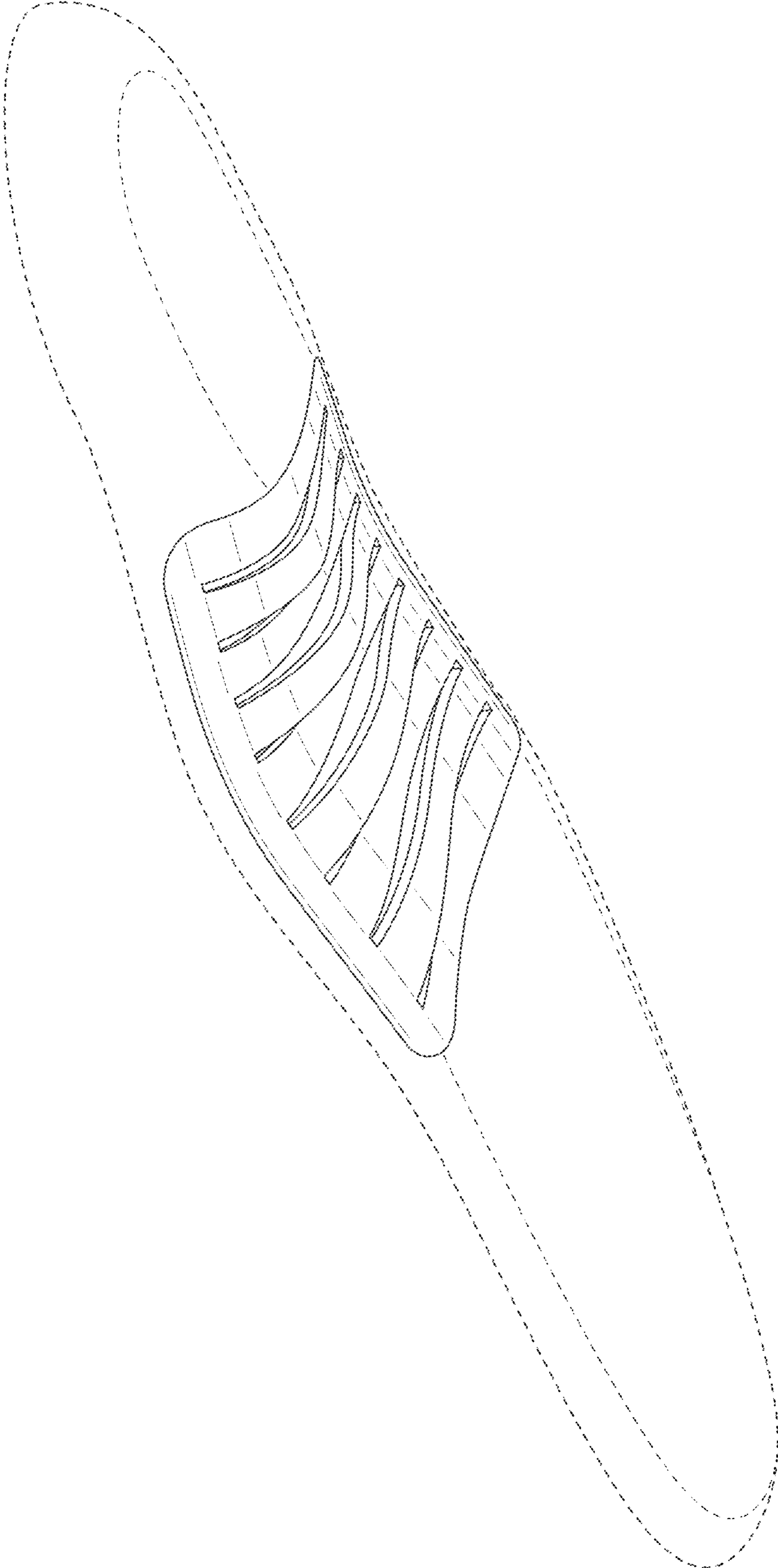

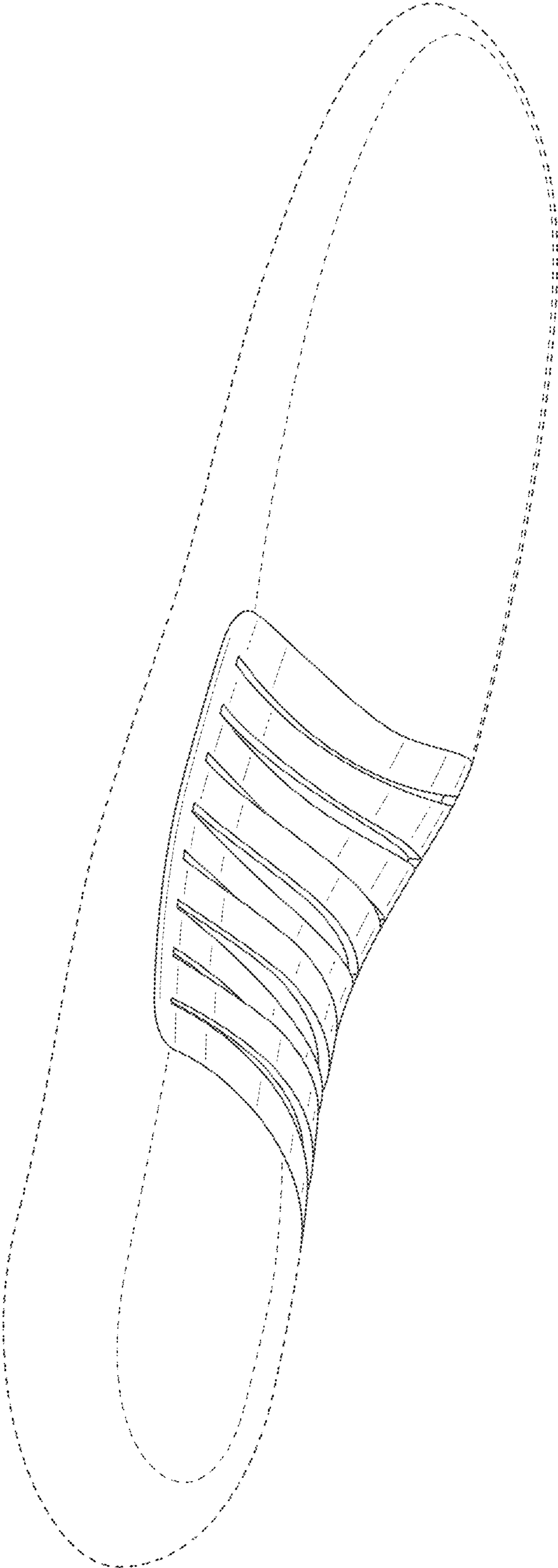

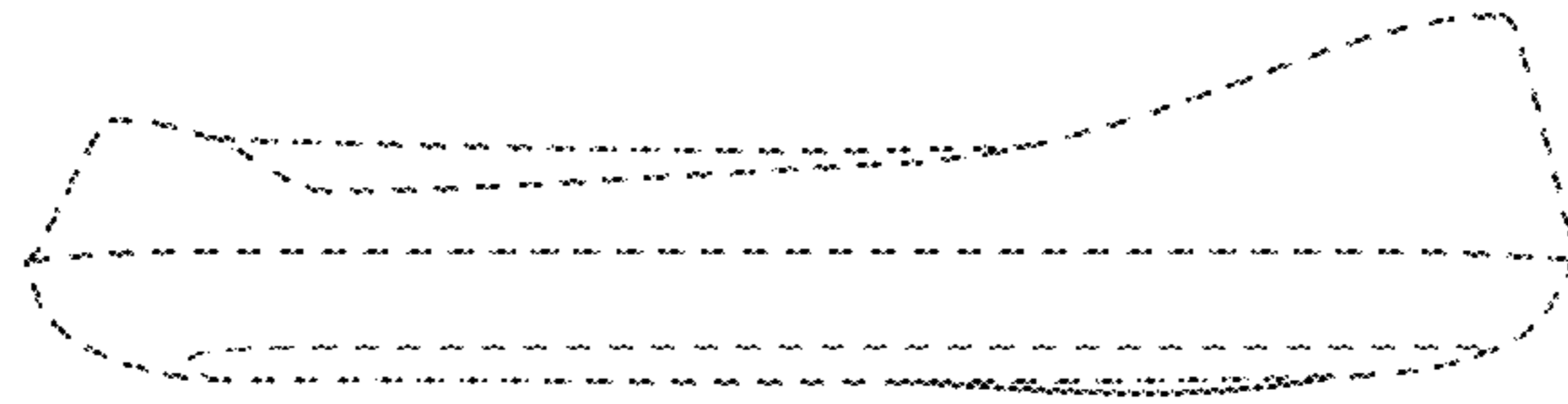

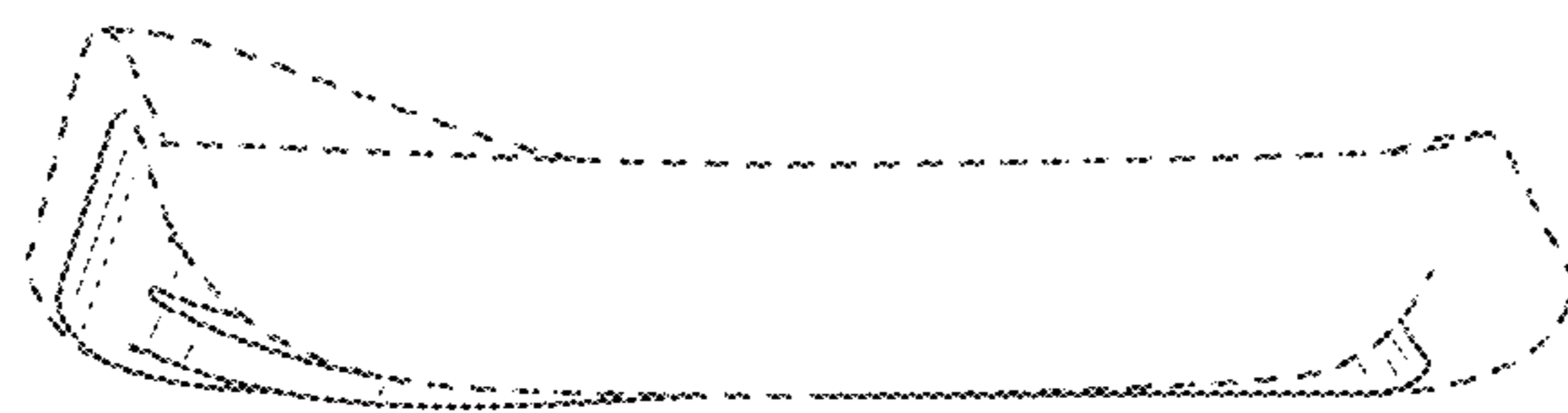

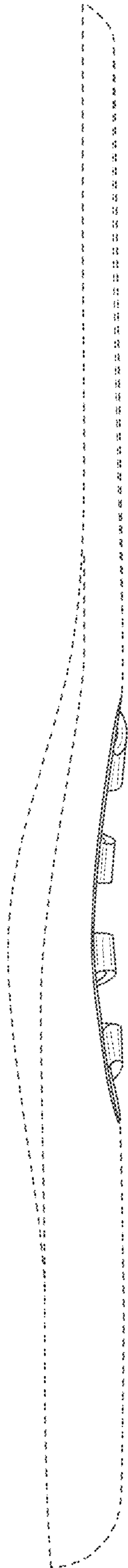

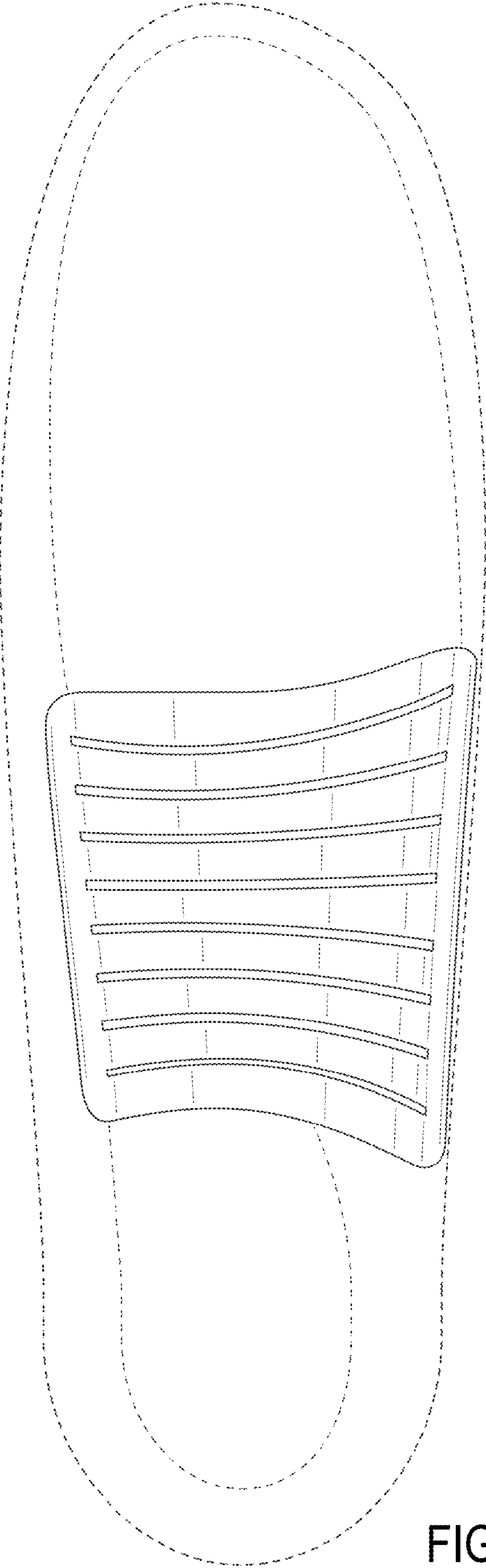
