DESCRIPTION

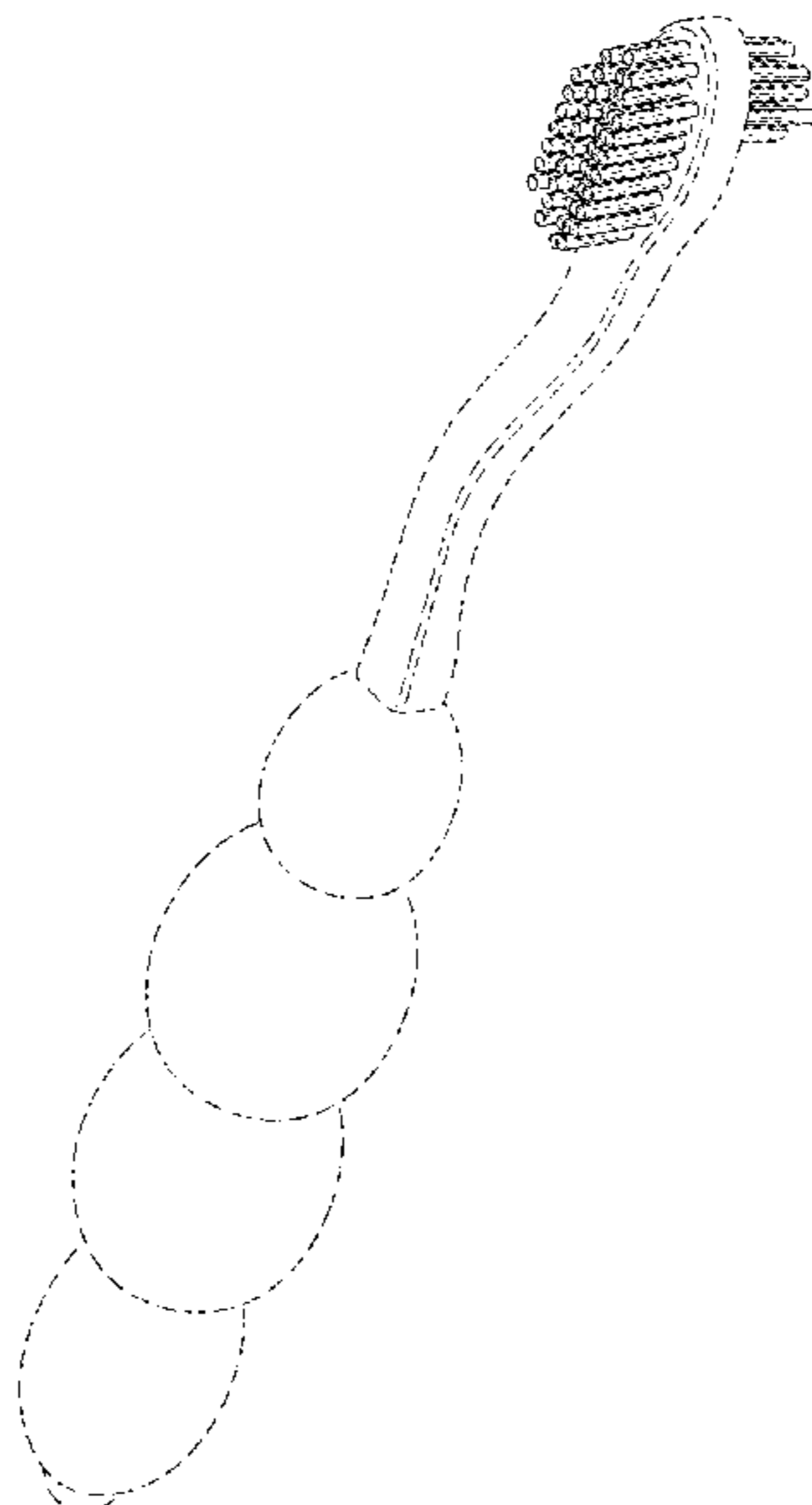
FIG. 1 is a perspective view illustrating our design for a set of bristles for an oral care implement.

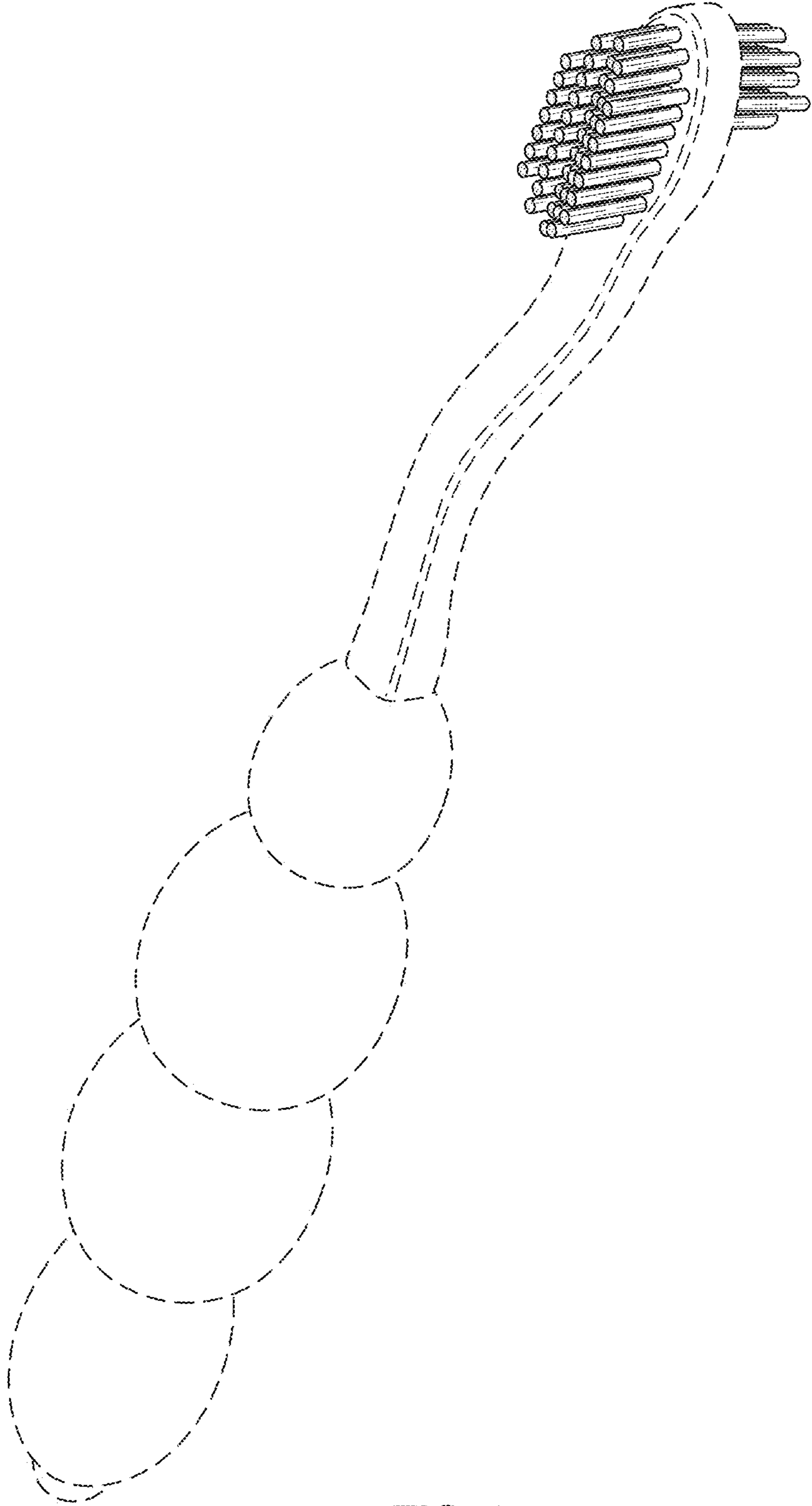

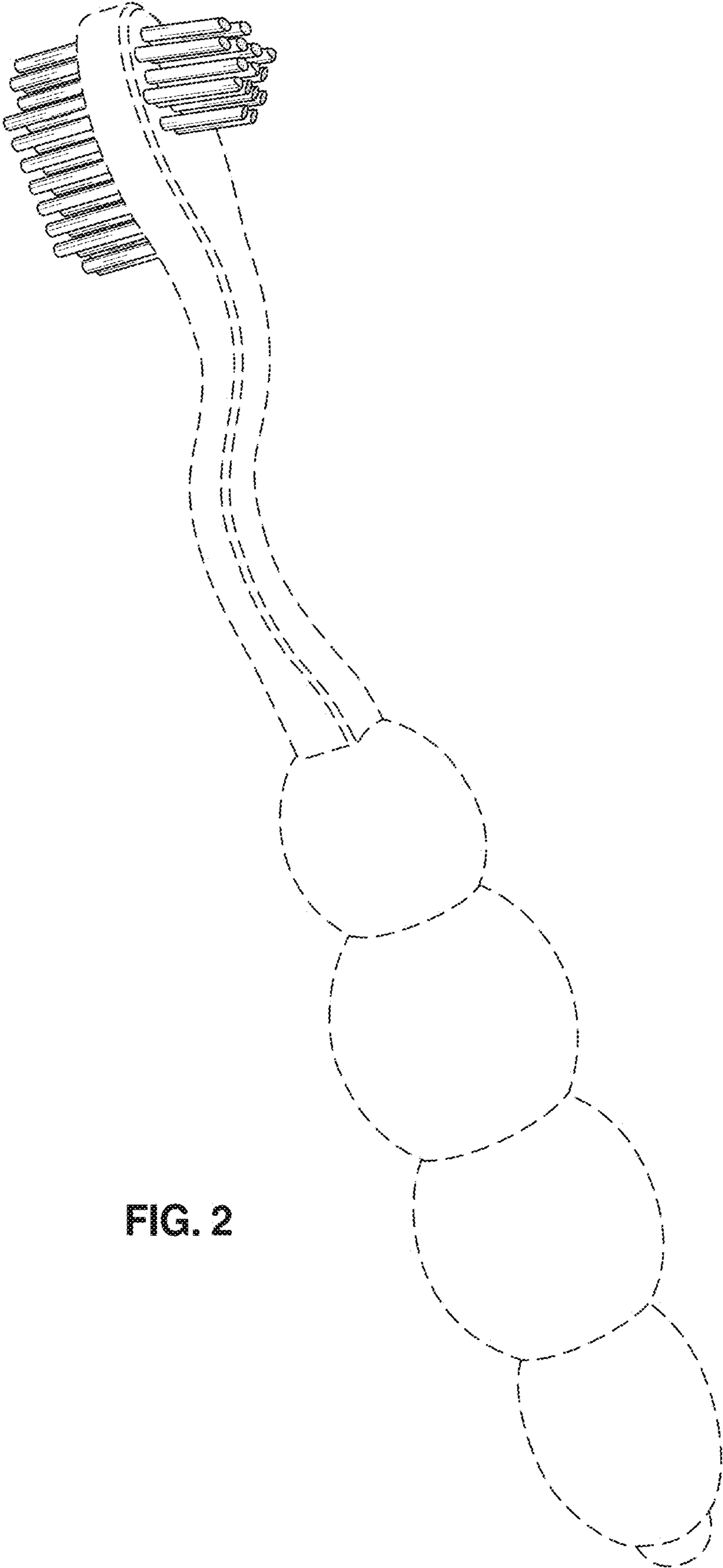

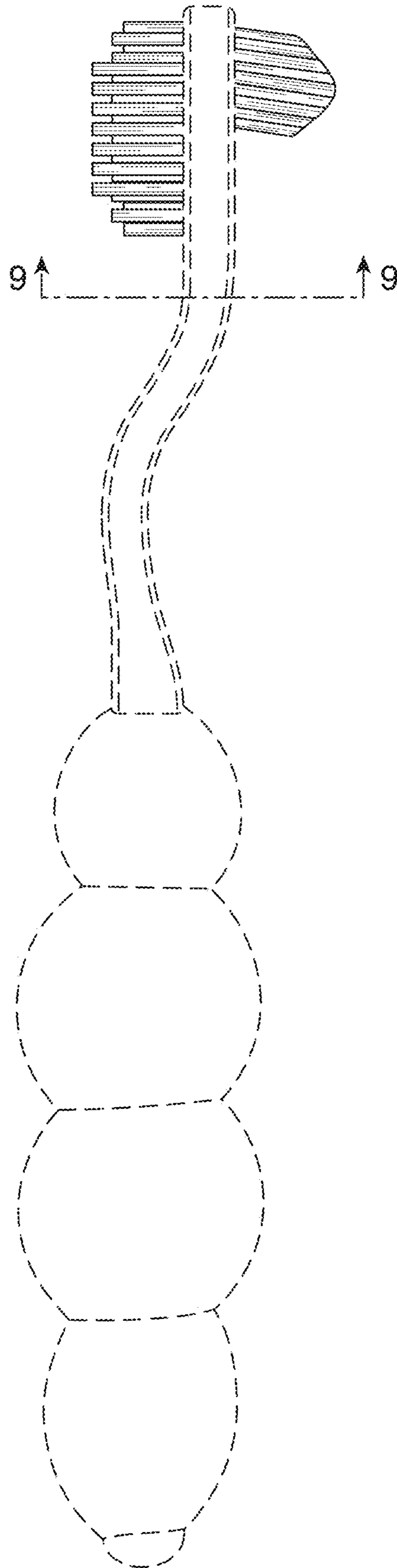
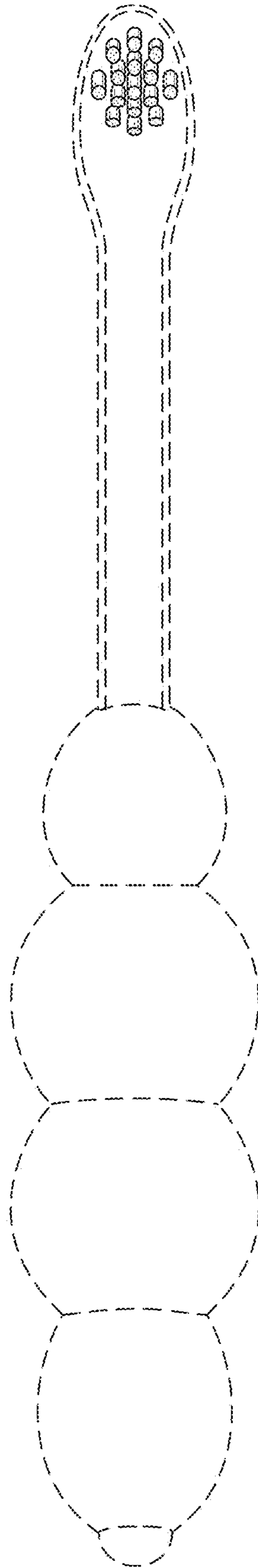

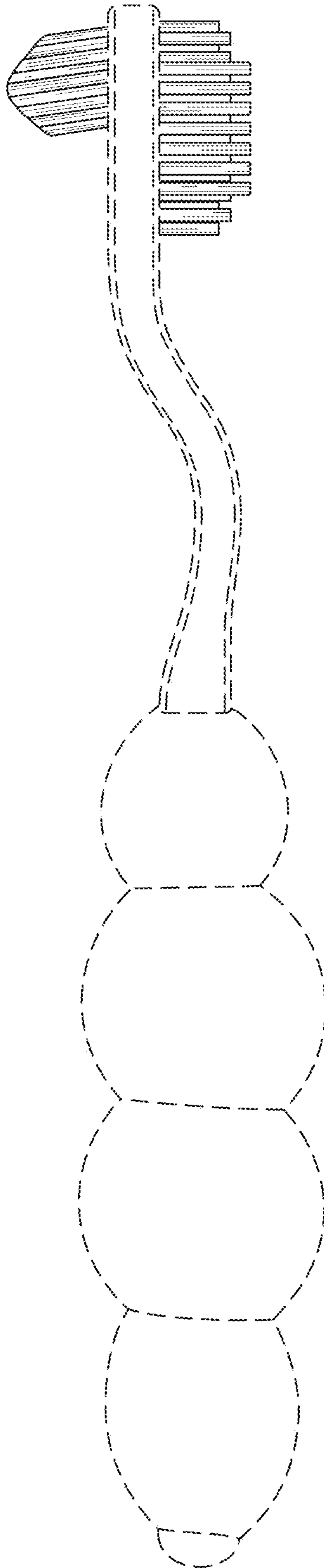

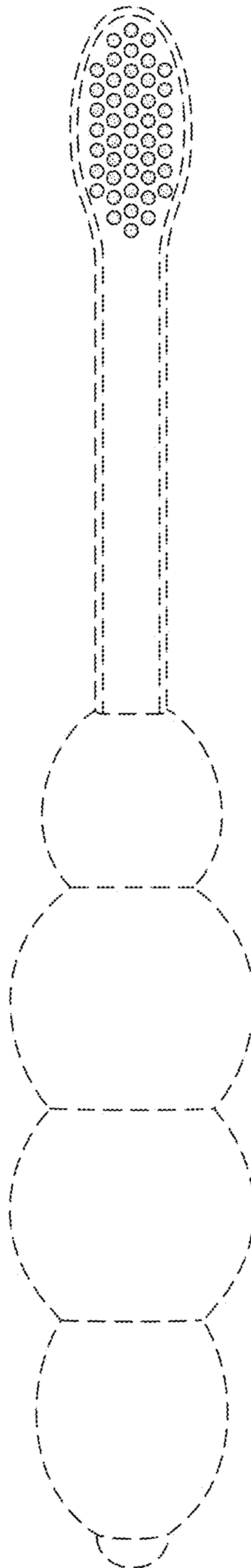

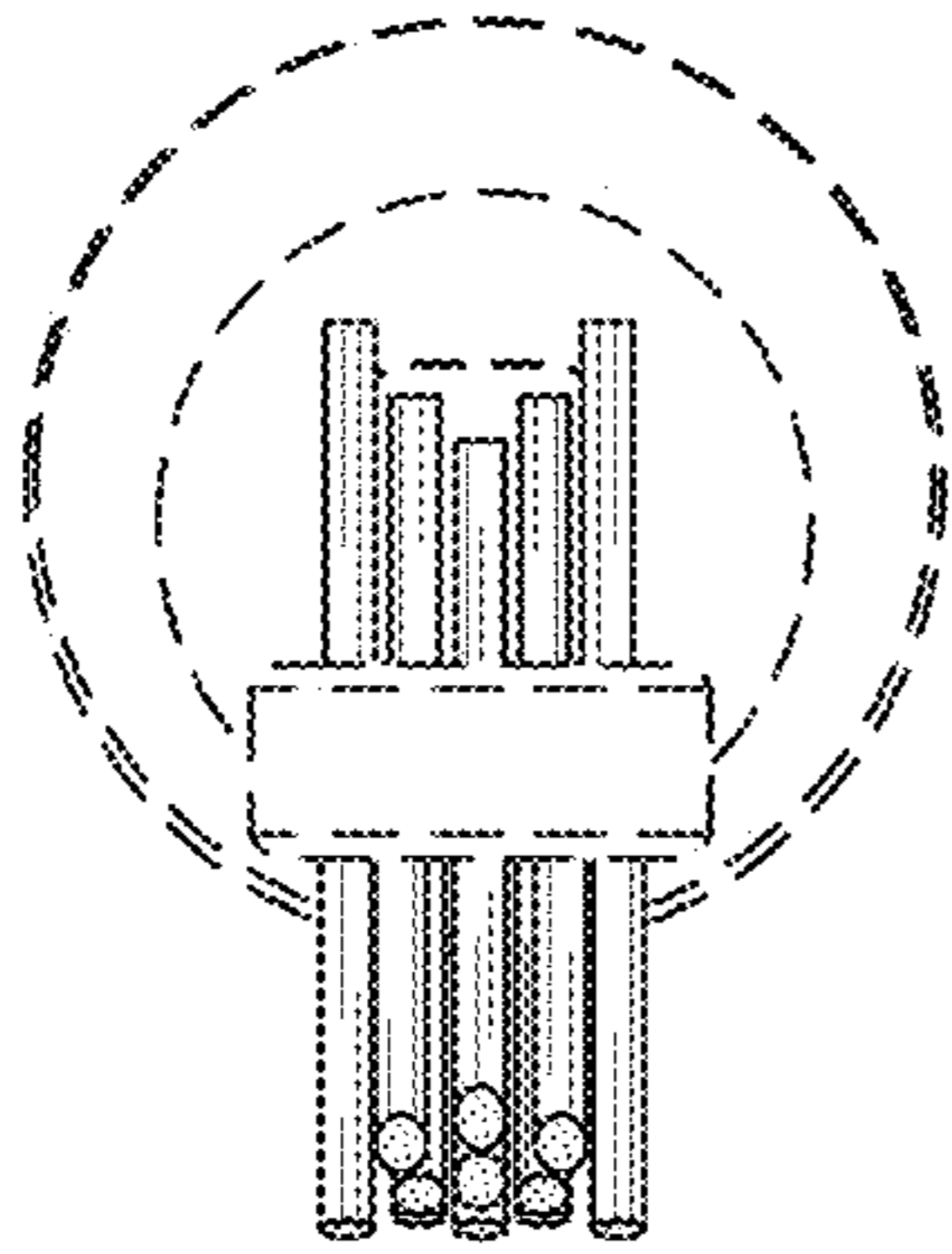

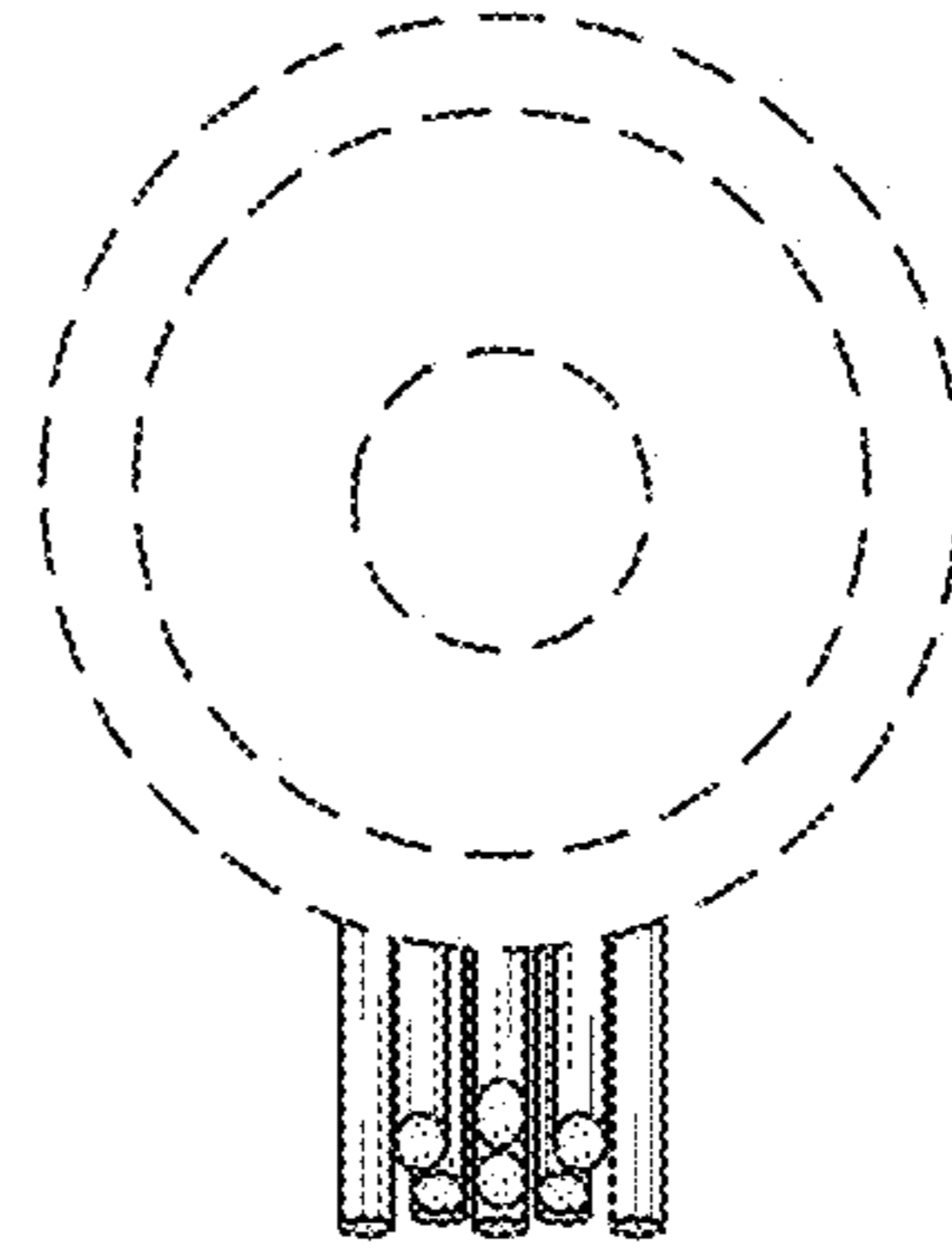

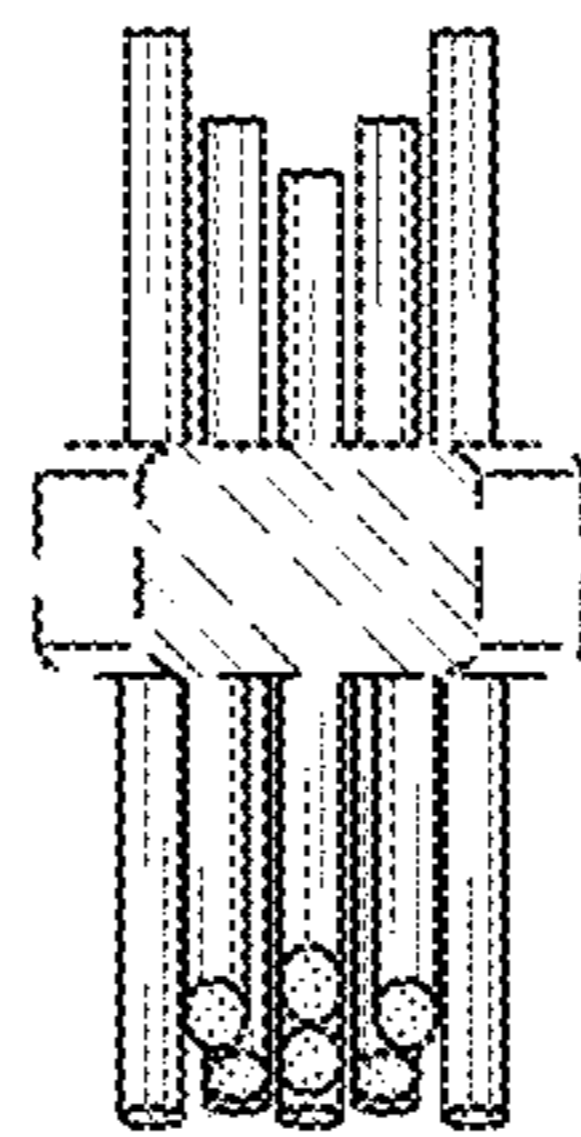
