(57) **CLAIM**

The ornamental design for an insulated mug, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an insulated mug according to the design herein.

FIG. 2 is a front view of the insulated mug shown in FIG. 1.

FIG. 3 is a rear view of the insulated mug shown in FIG. 1.

FIG. 4 is a left side view of the insulated mug shown in FIG. 1.

FIG. 5 is a right side view of the insulated mug shown in FIG. 1.

FIG. 6 is a top view of the insulated mug shown in FIG. 1.

FIG. 7 is a bottom view of the insulated mug shown in FIG. 1.

FIG. 8 is a perspective view of a second embodiment of an insulated mug according to the design herein.

FIG. 9 is a front view of the insulated mug shown in FIG. 8.

FIG. 10 is a rear view of the insulated mug shown in FIG. 8.

FIG. 11 is a left side view of the insulated mug shown in FIG. 8.

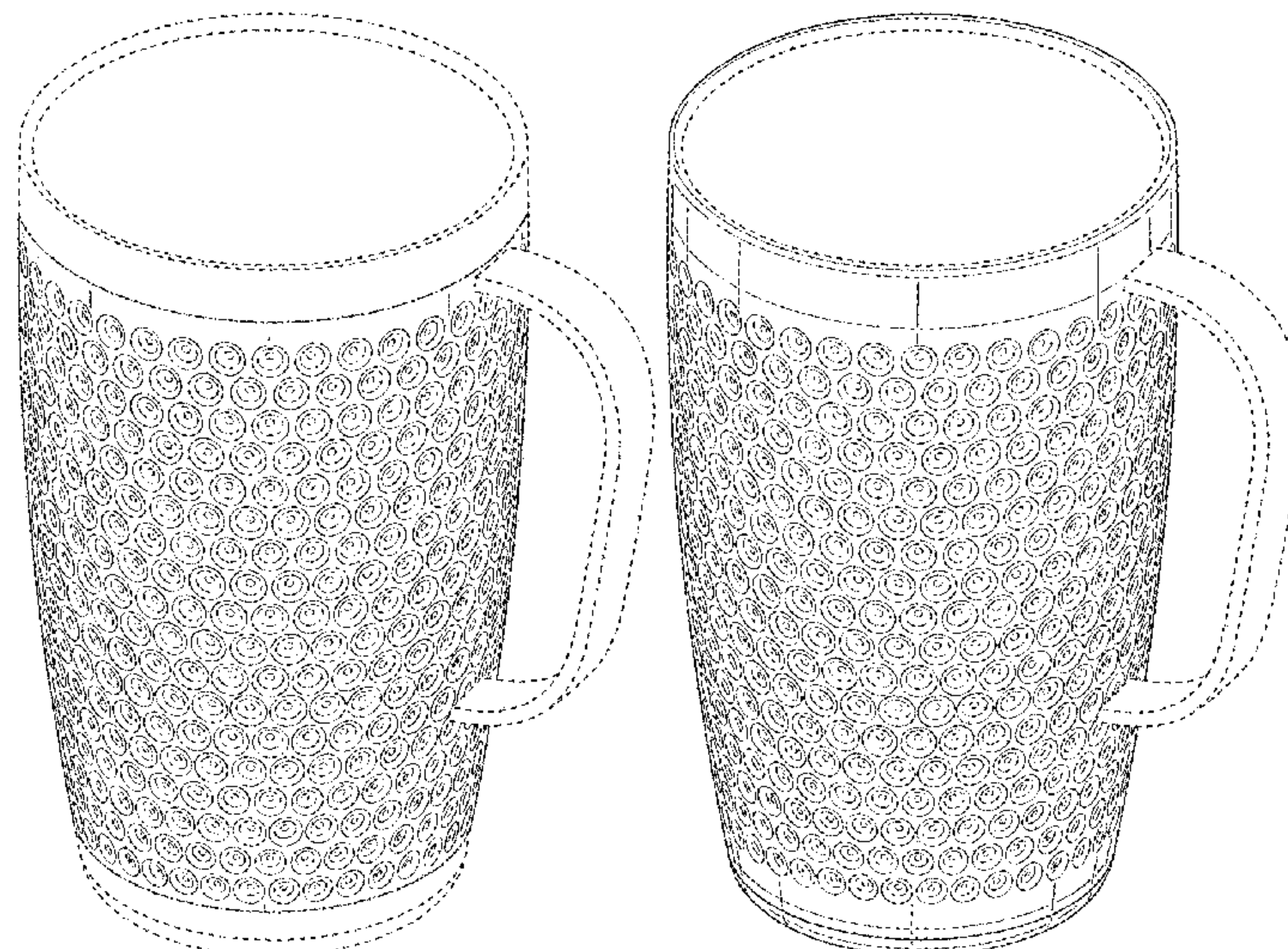
FIG. 12 is a right side view of the insulated mug shown in FIG. 8.

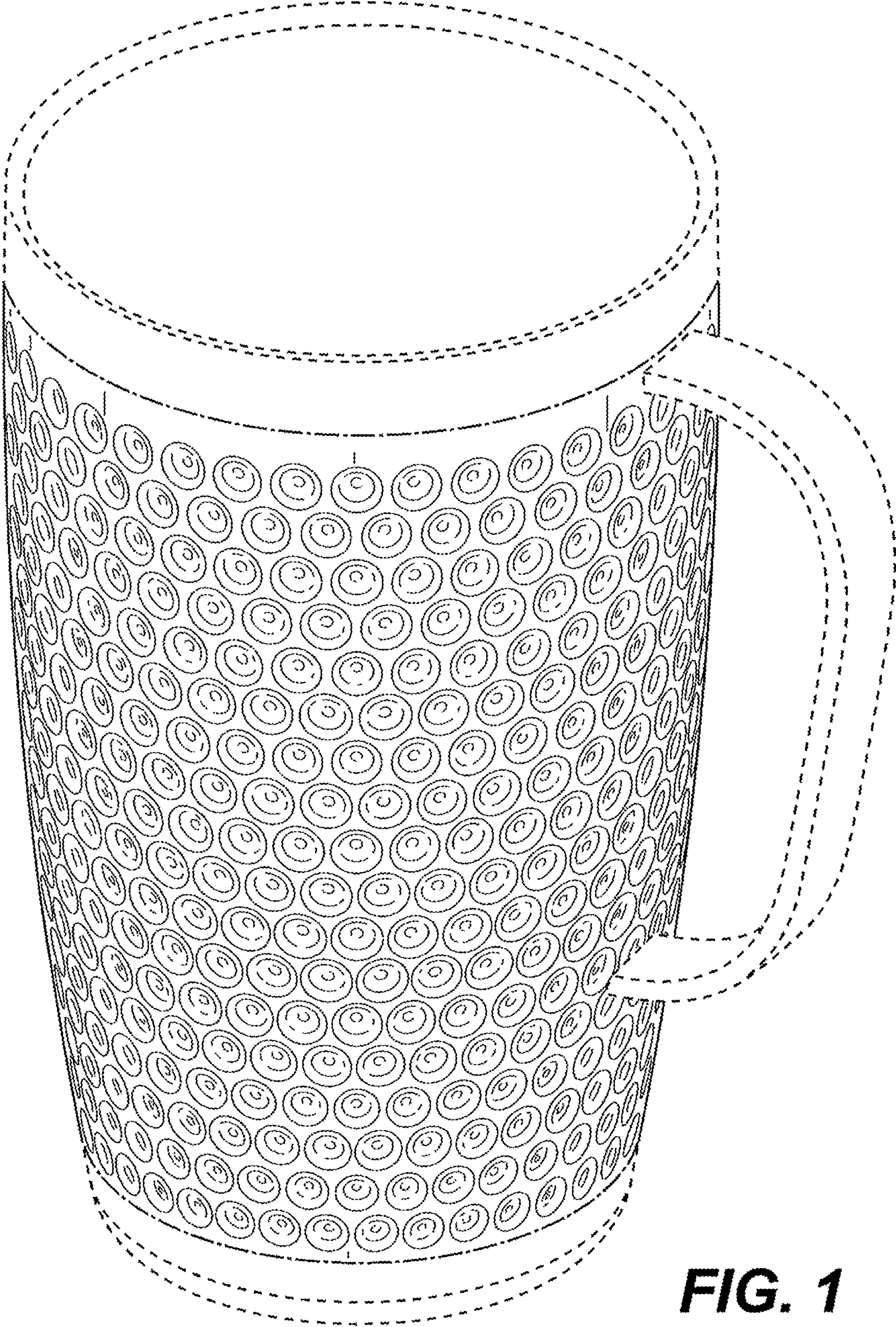

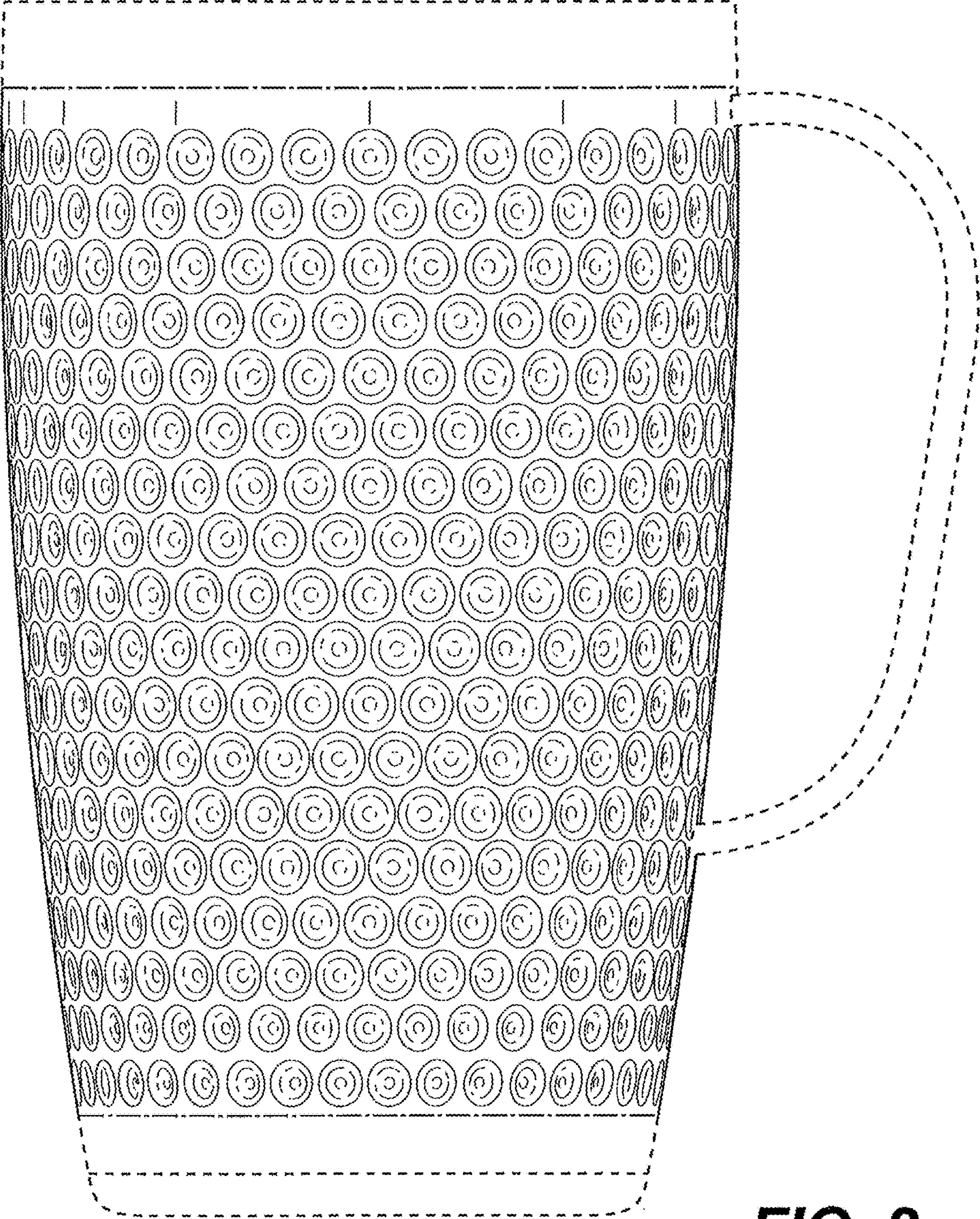

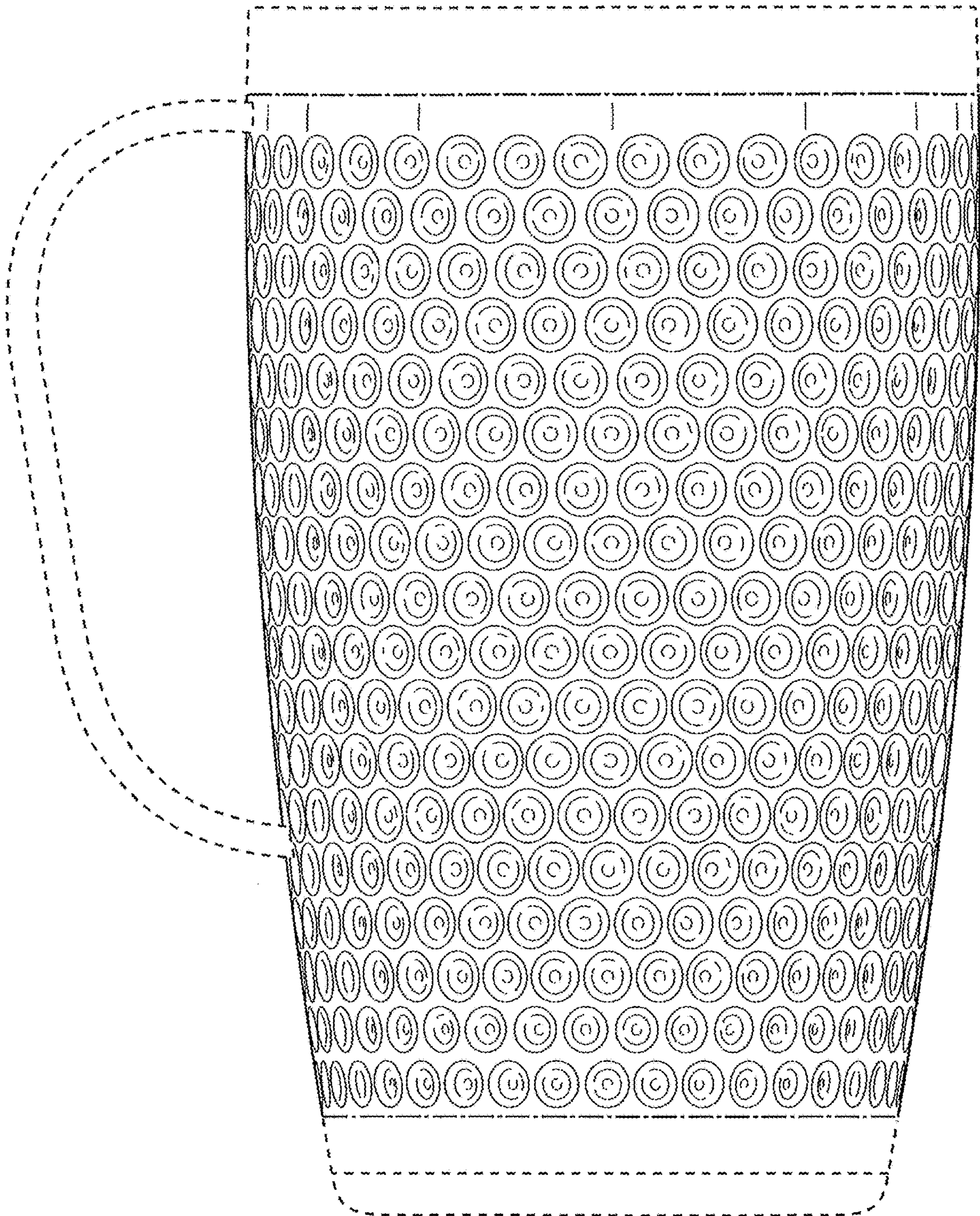

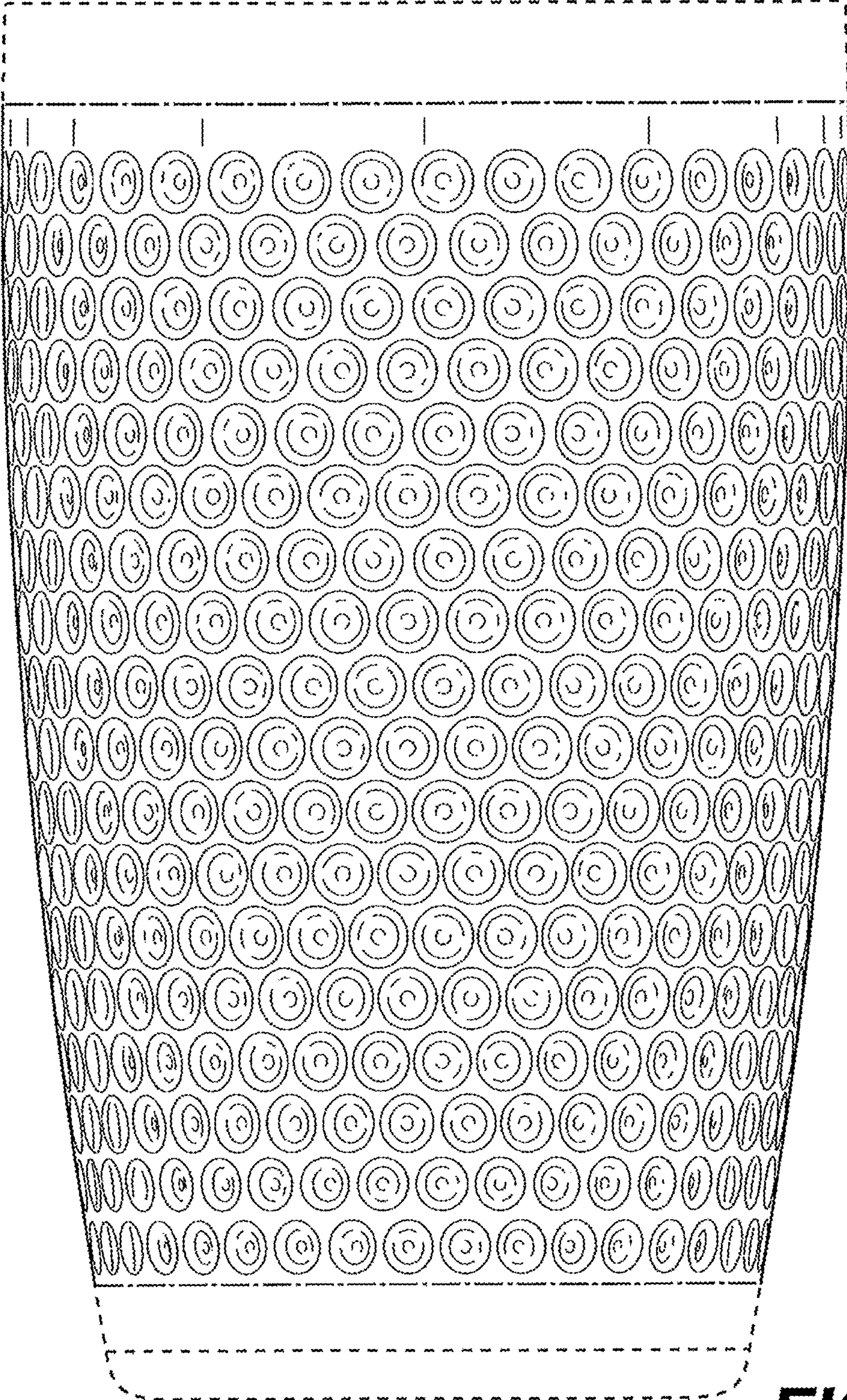

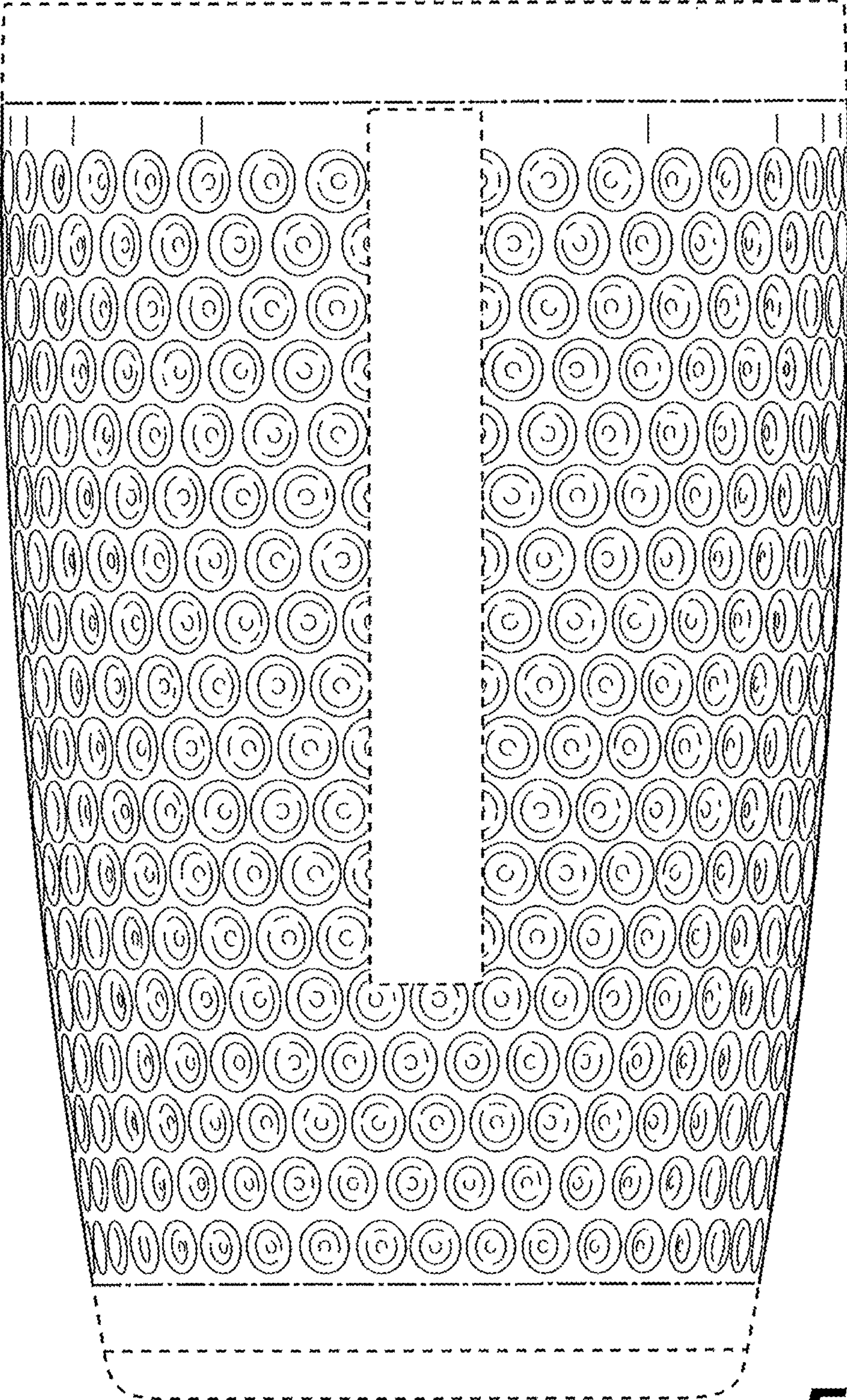

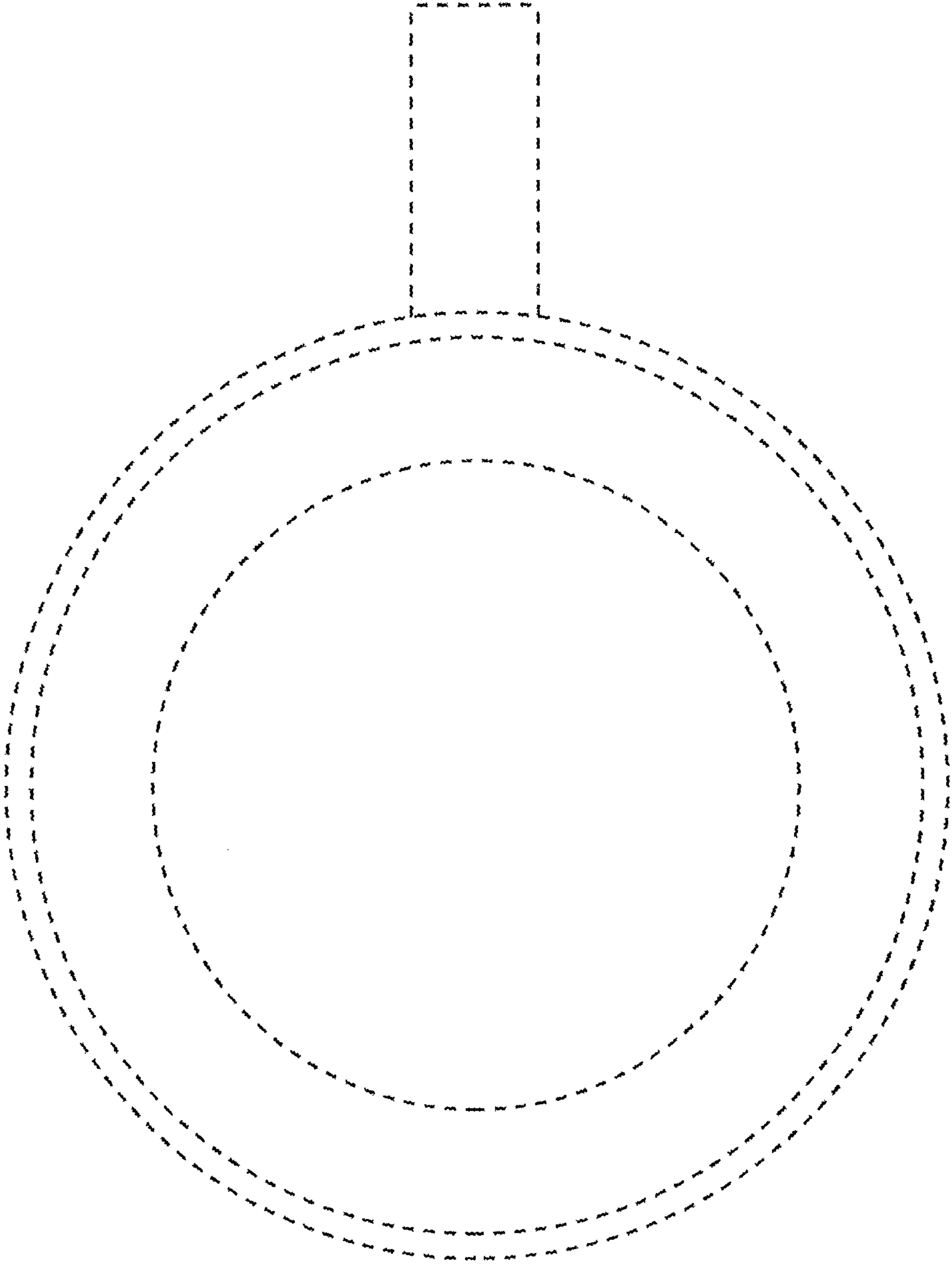

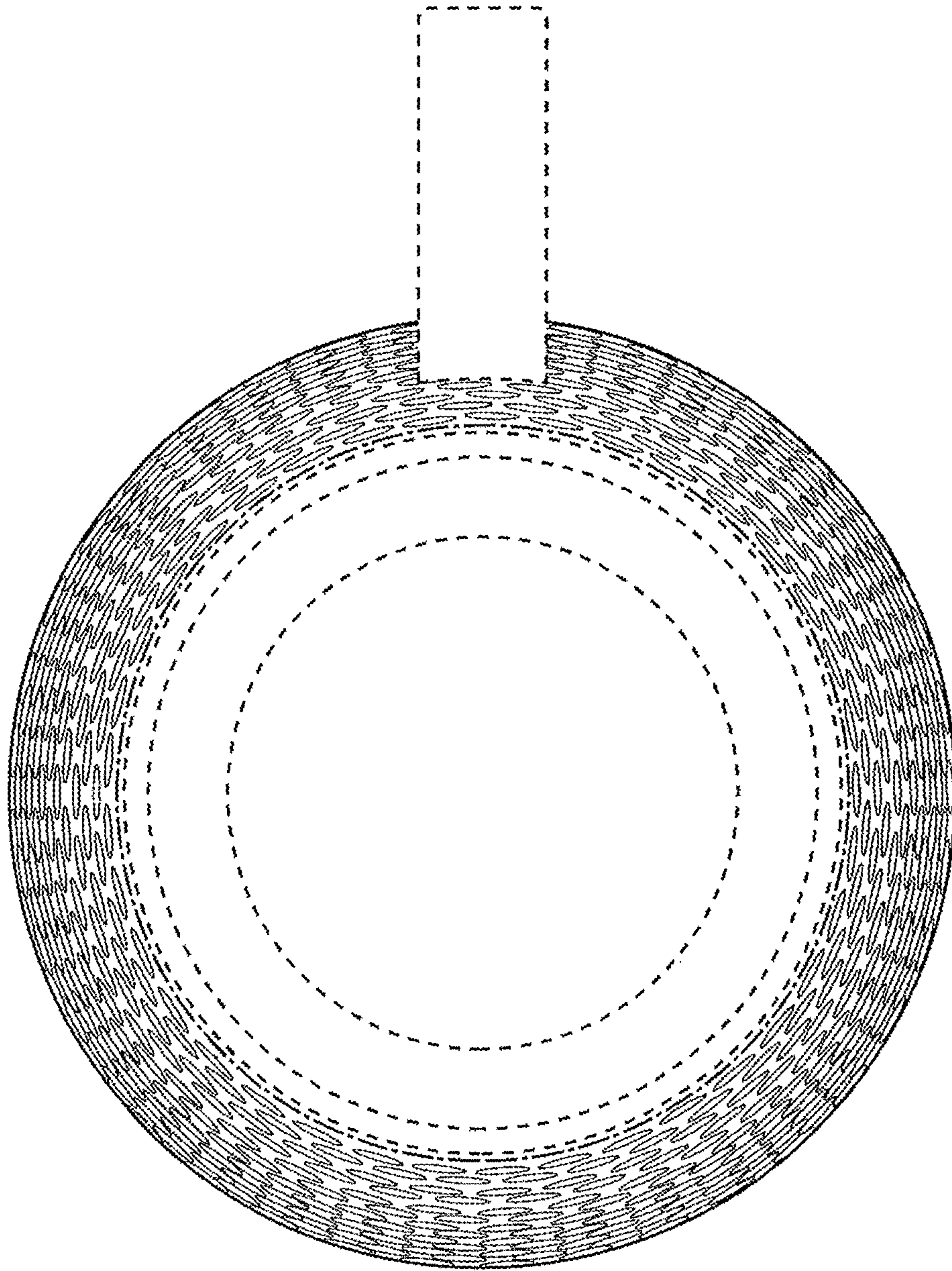

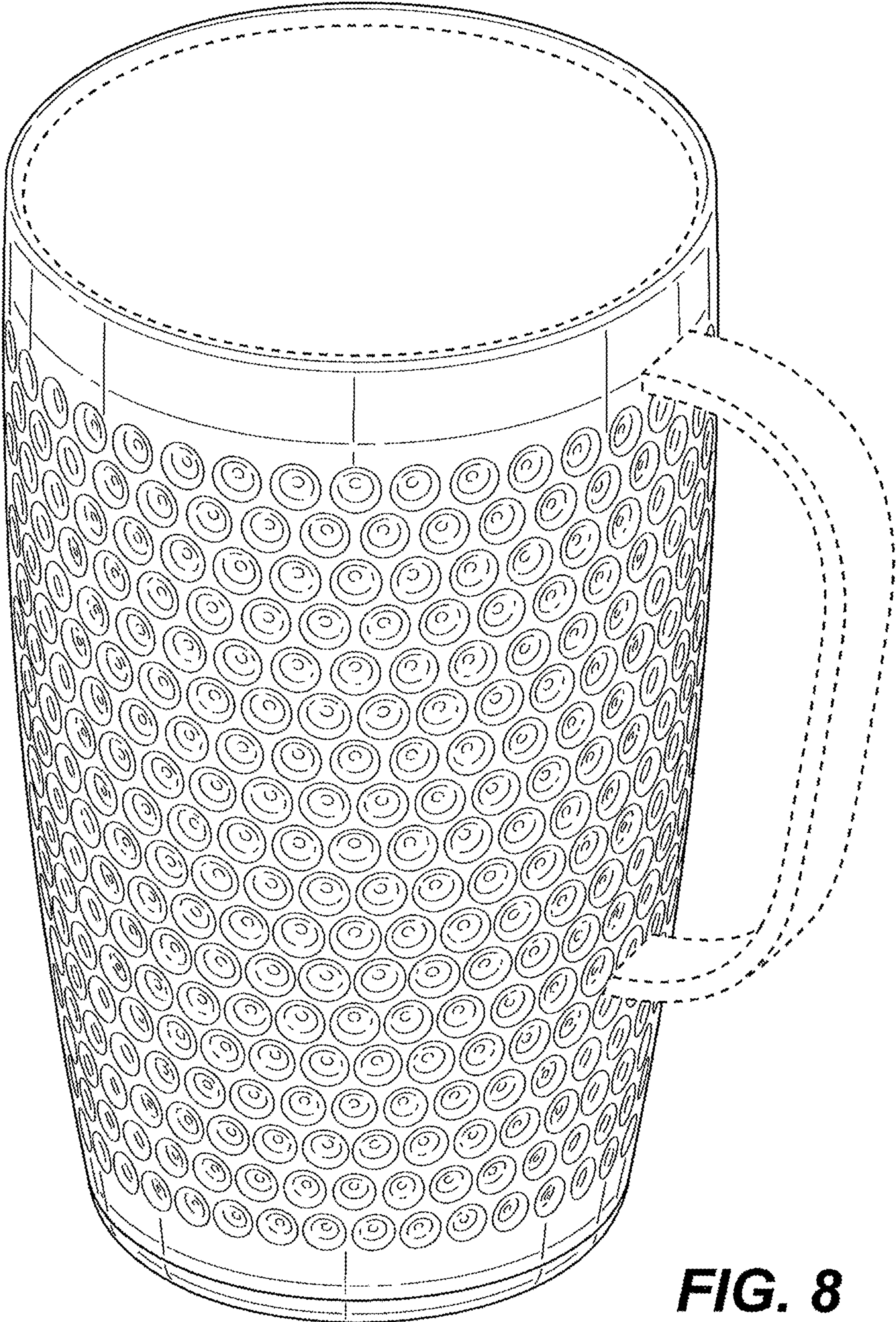

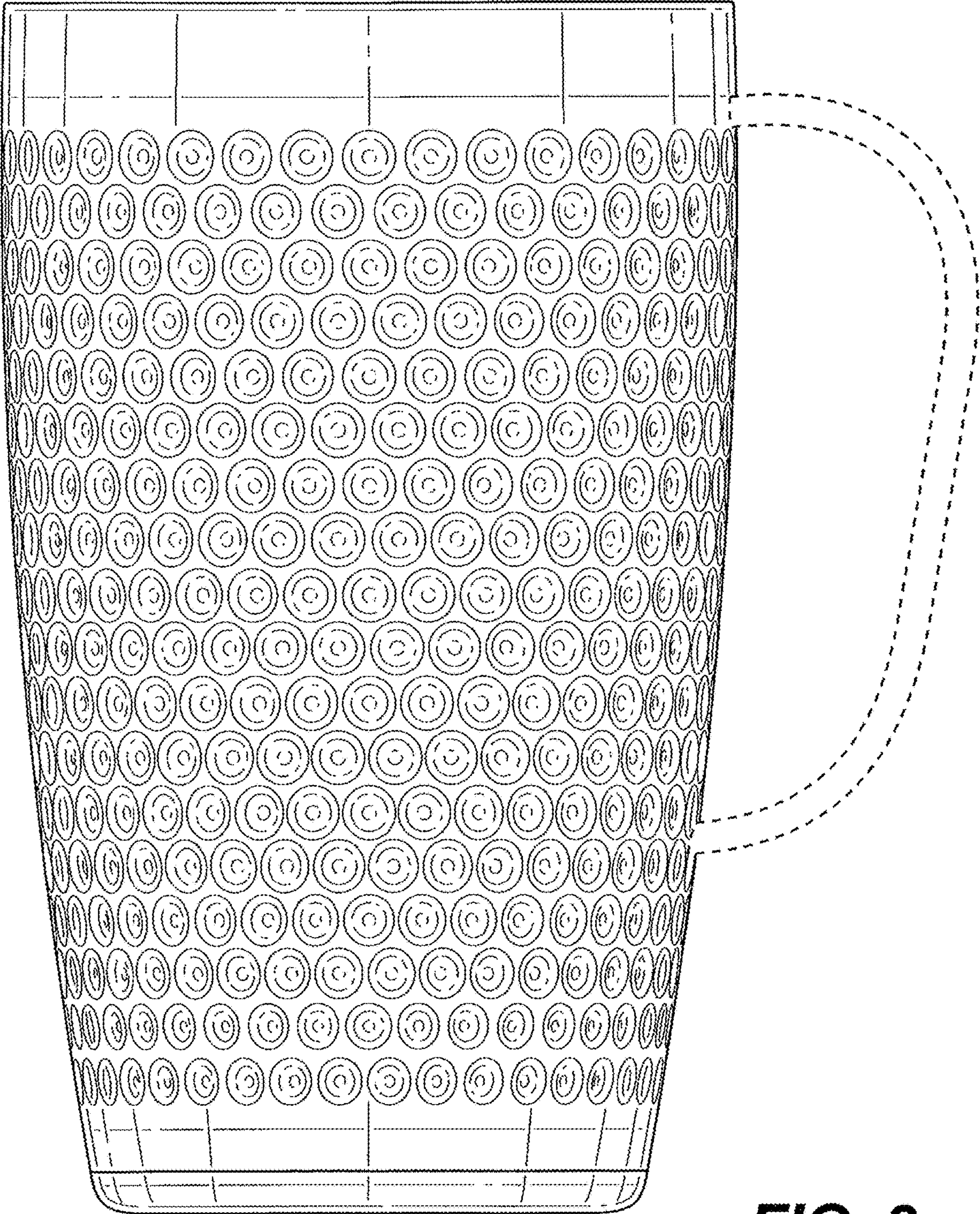

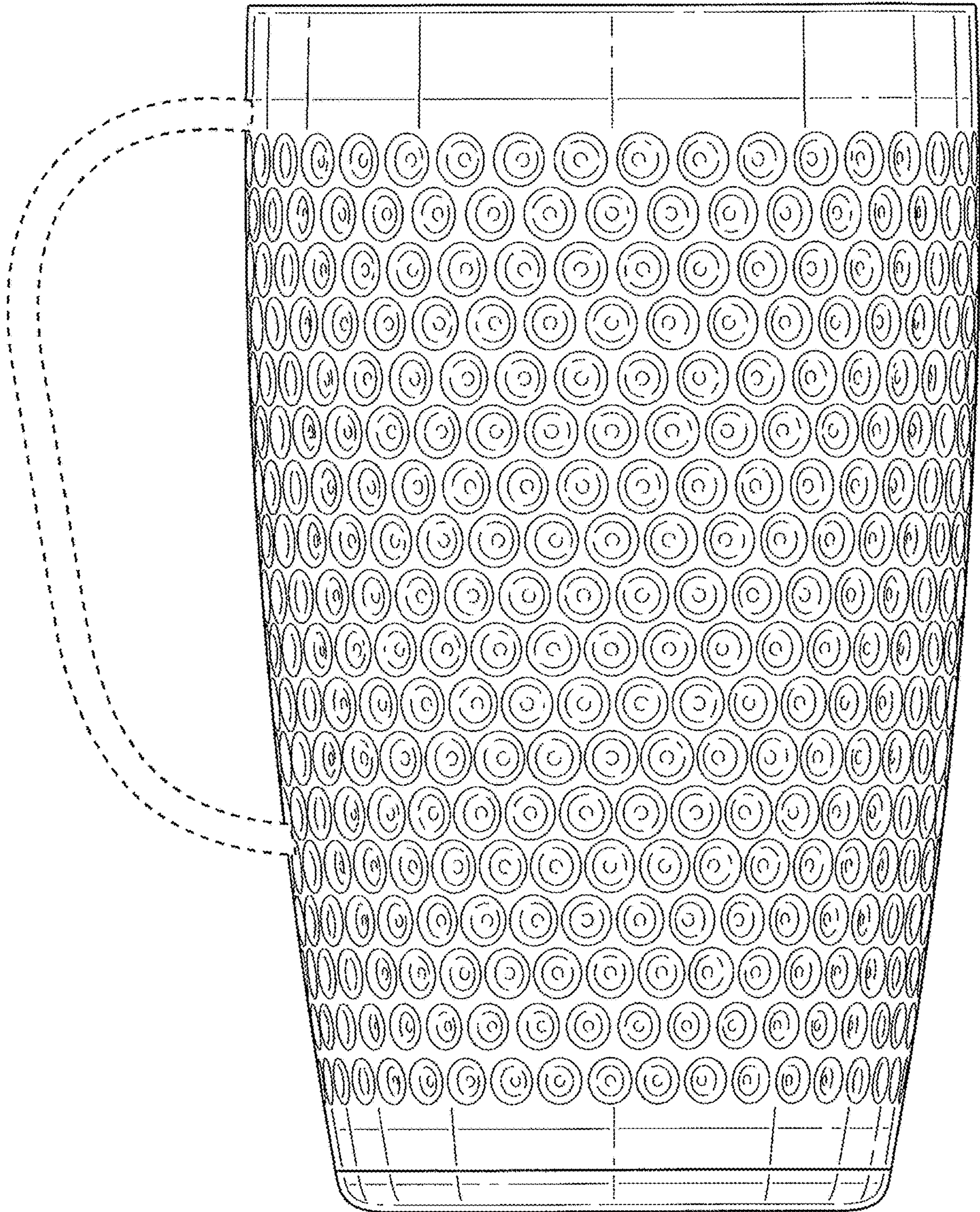

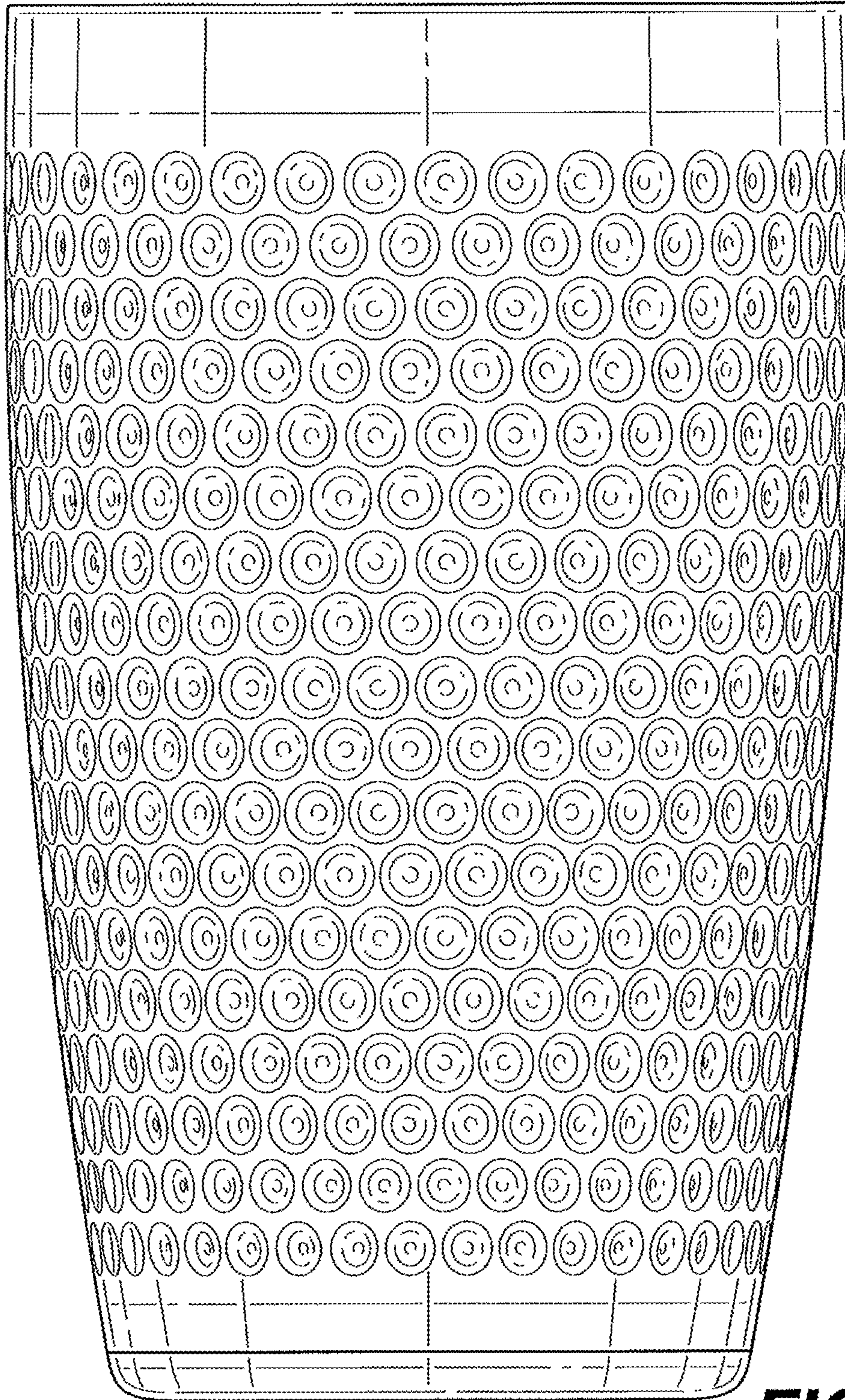

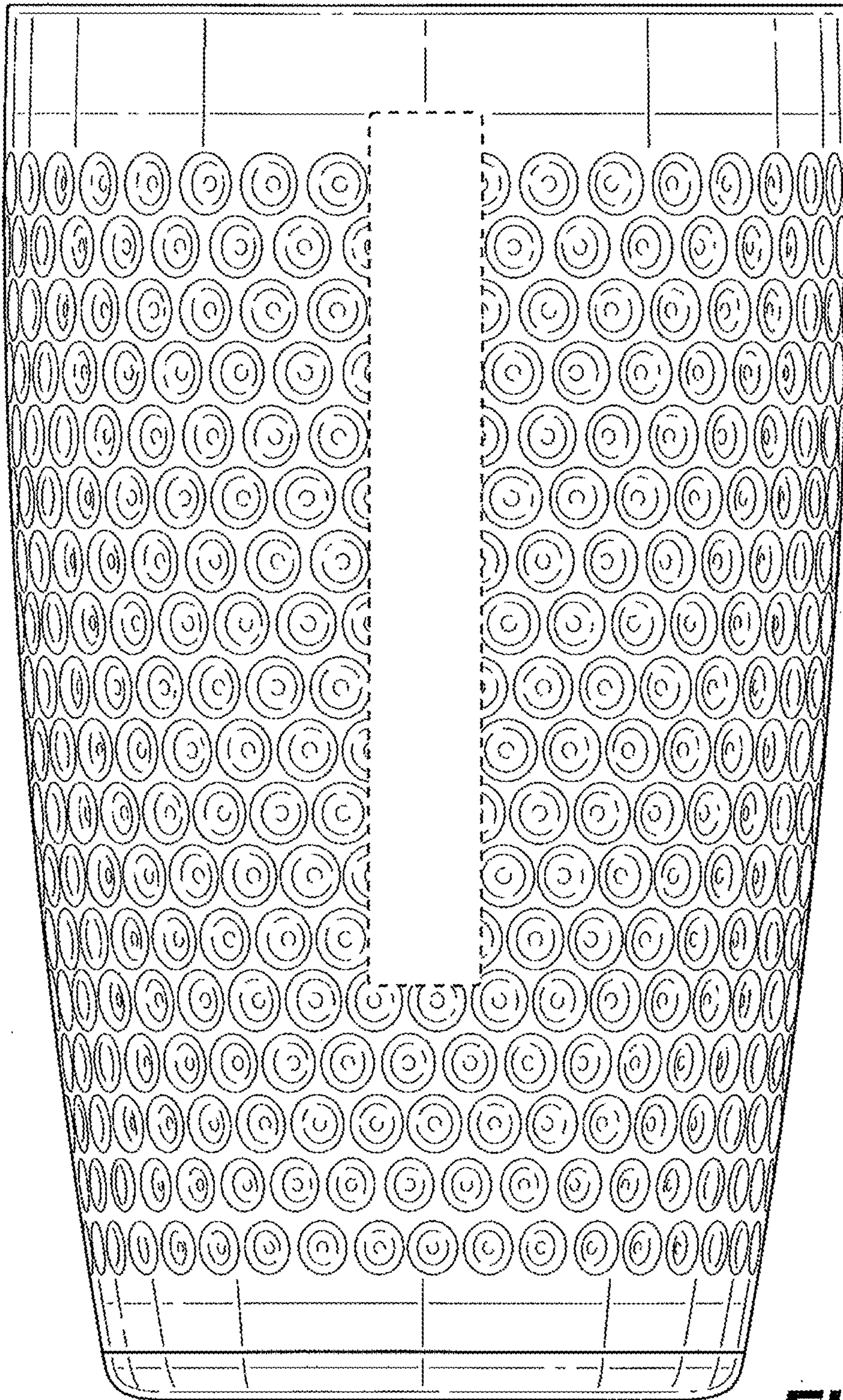

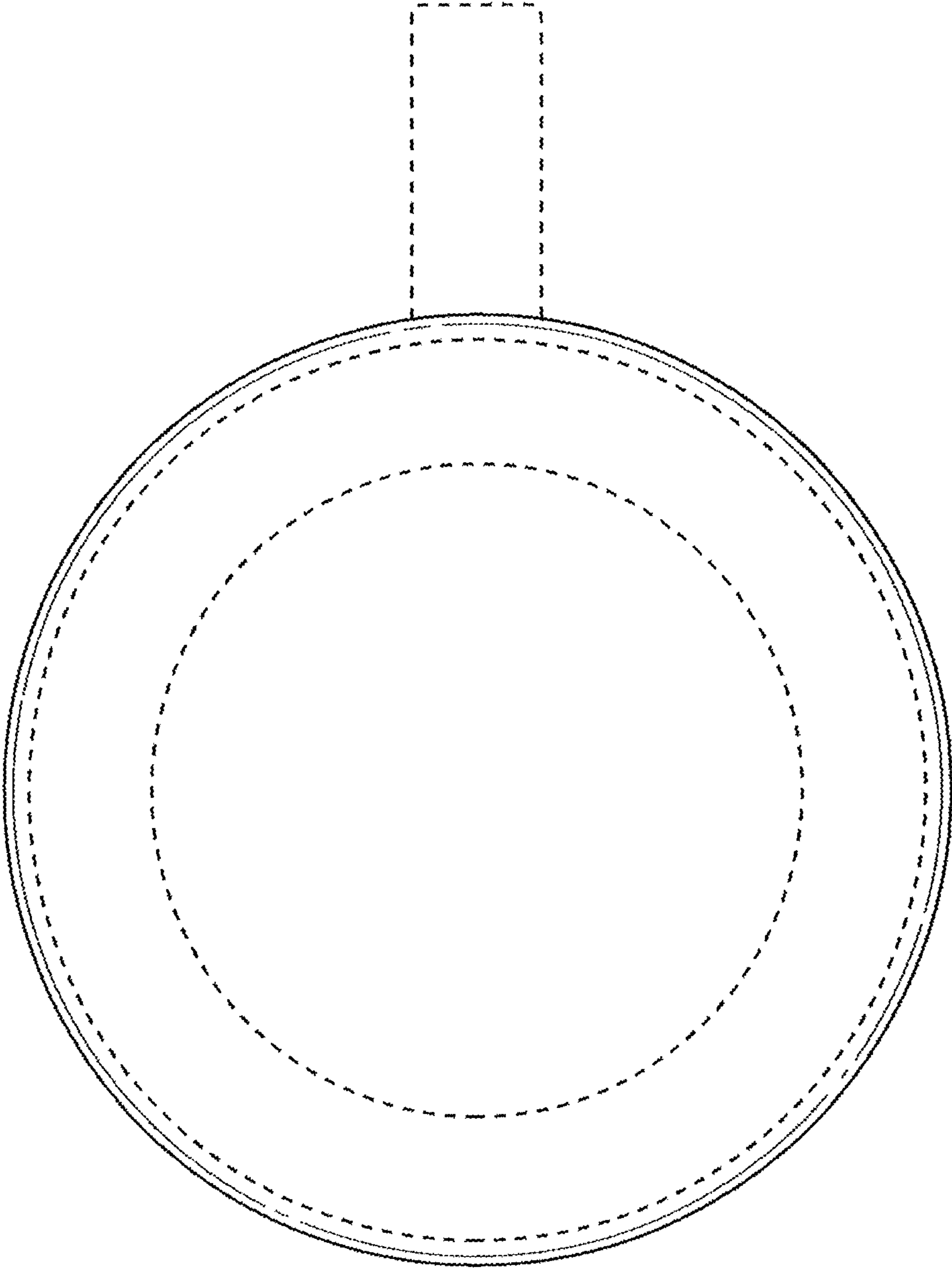

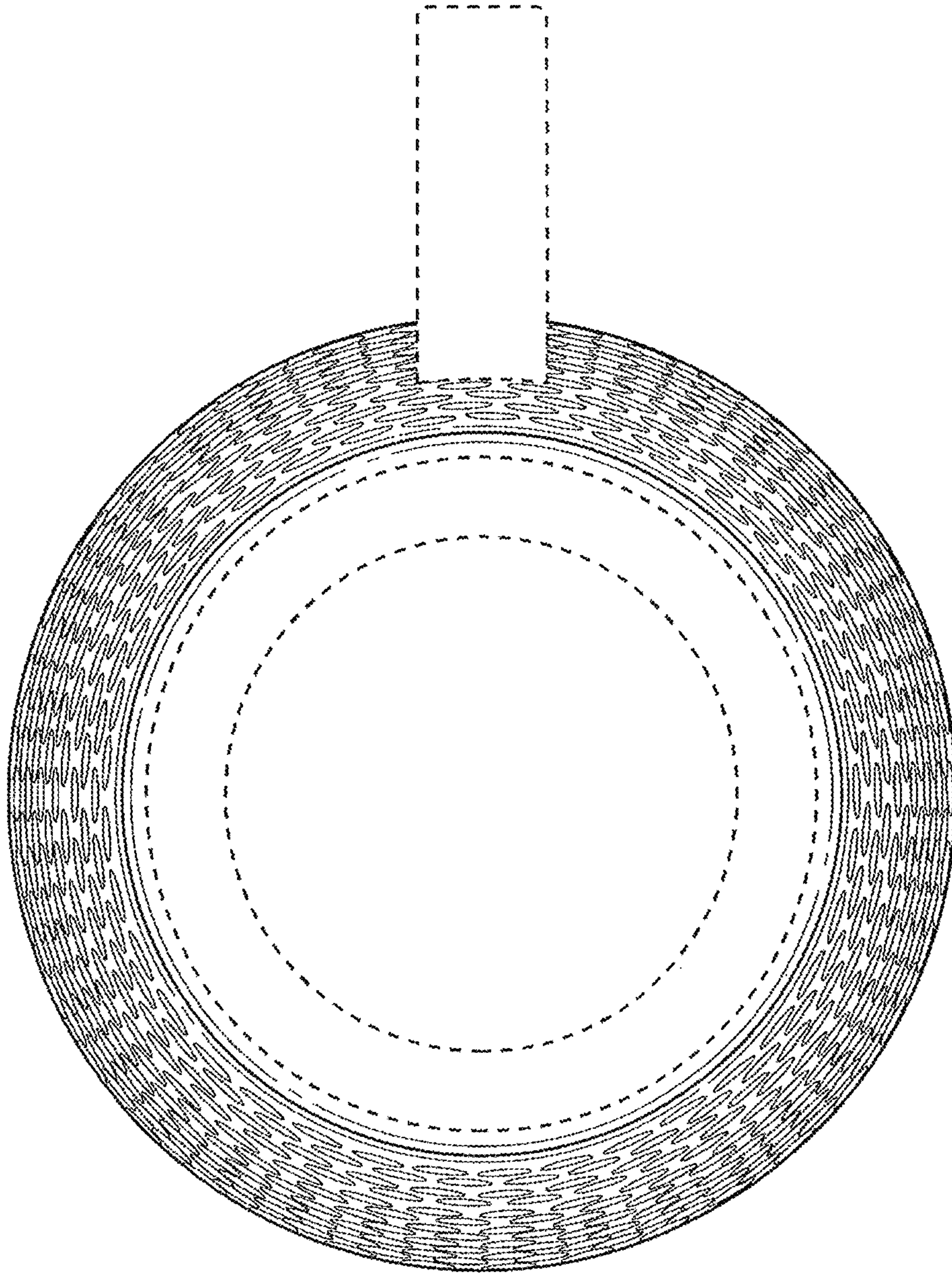
