The ornamental design for a coupling assembly for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 7 is a bottom/rear/left perspective view of the coupling assembly for a vehicle.

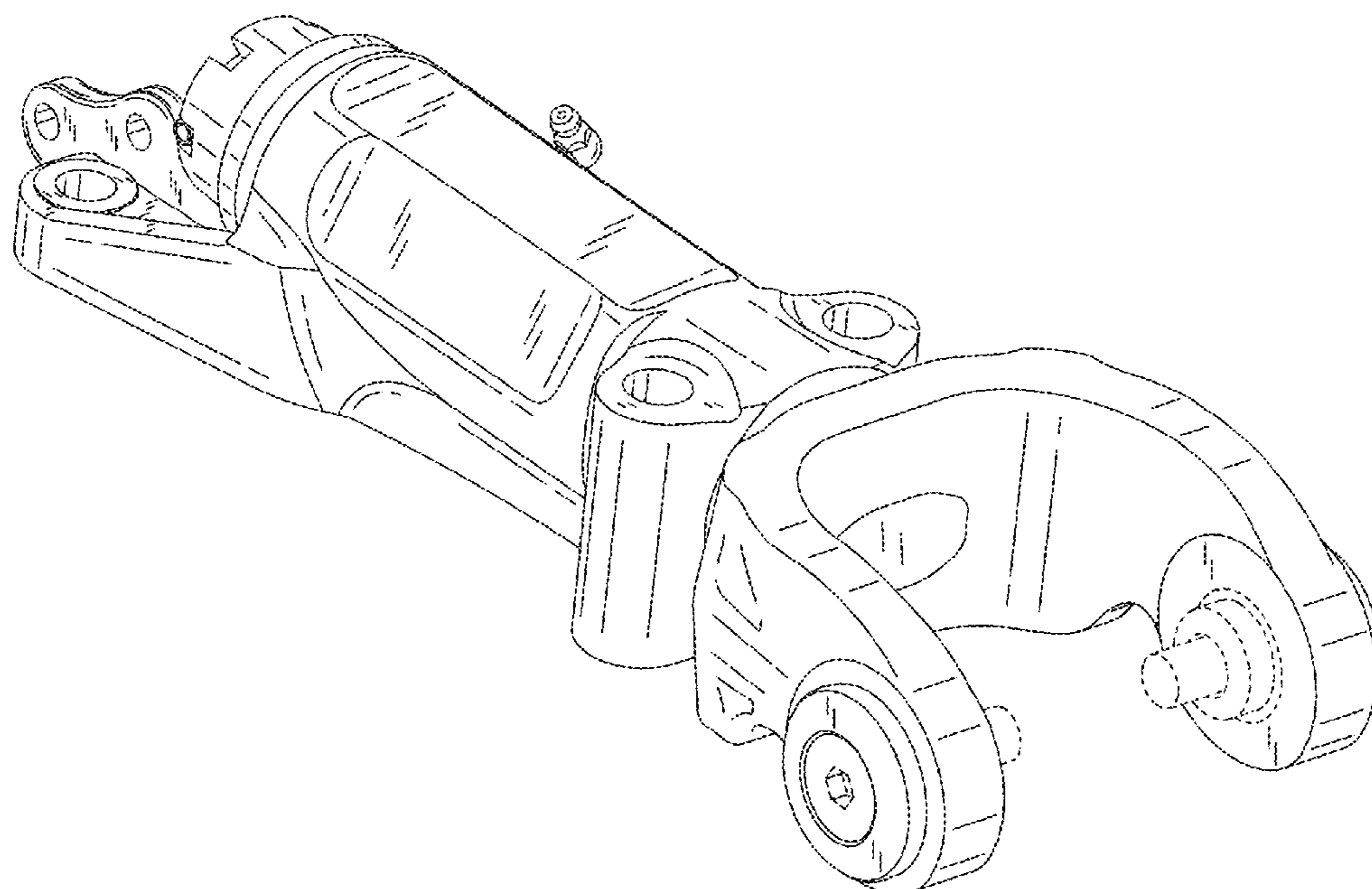
FIG. 8 is a bottom plan view of the coupling assembly for a vehicle.

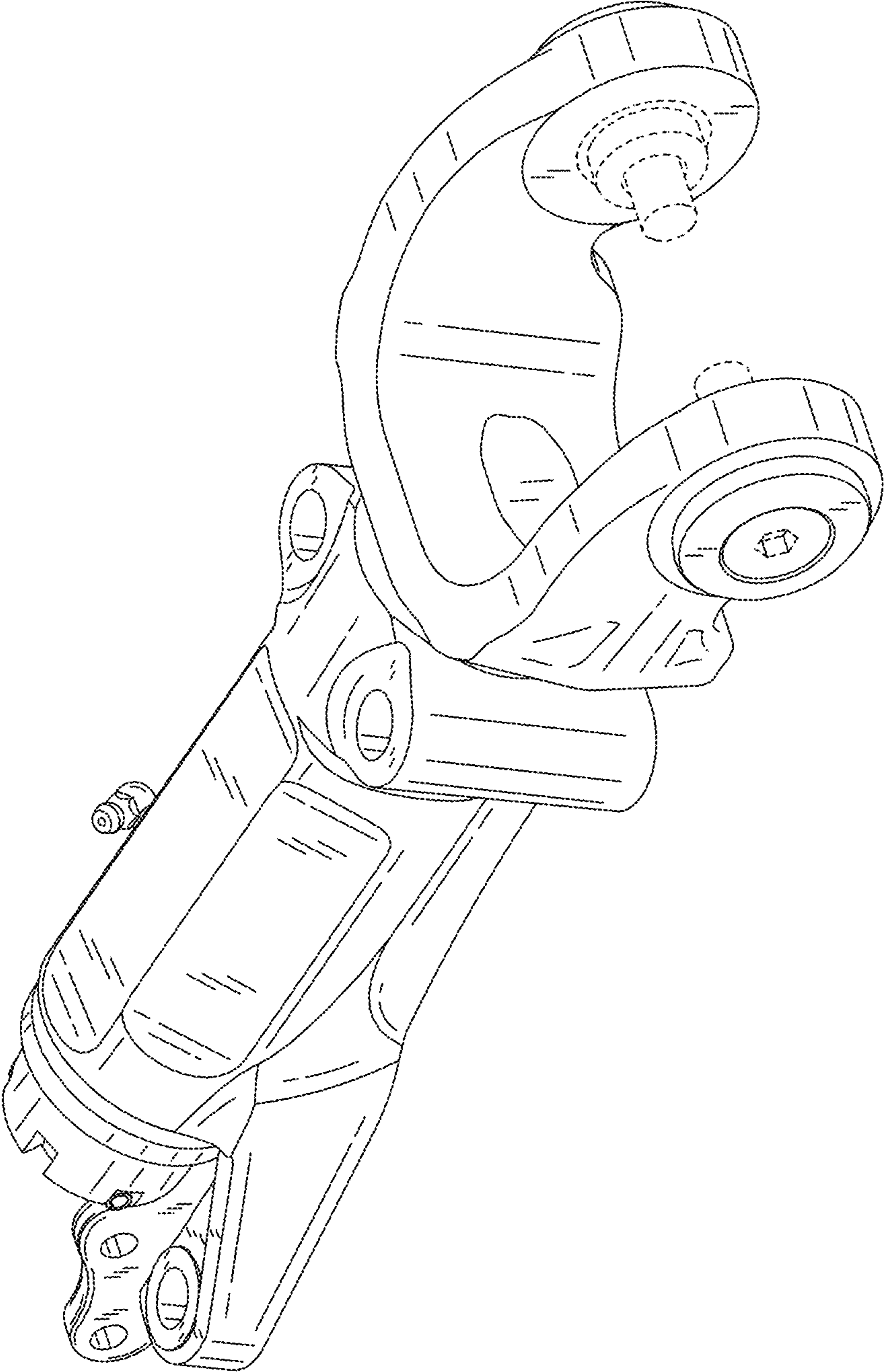

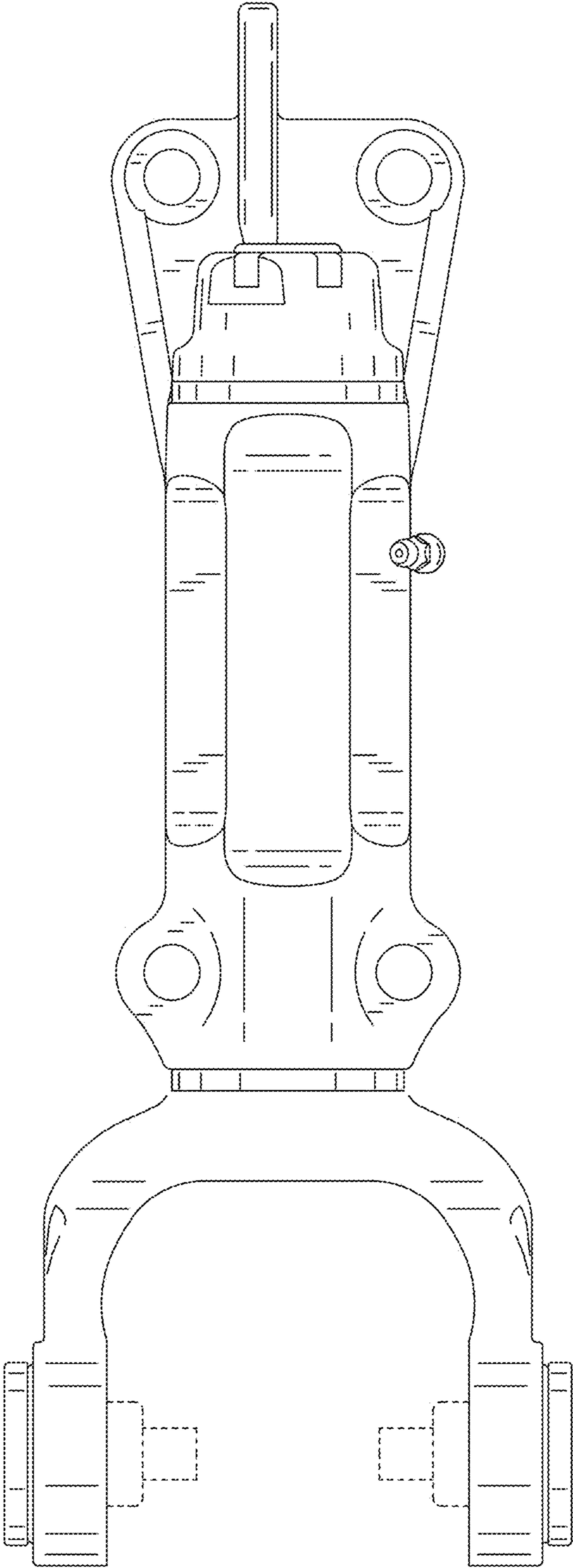

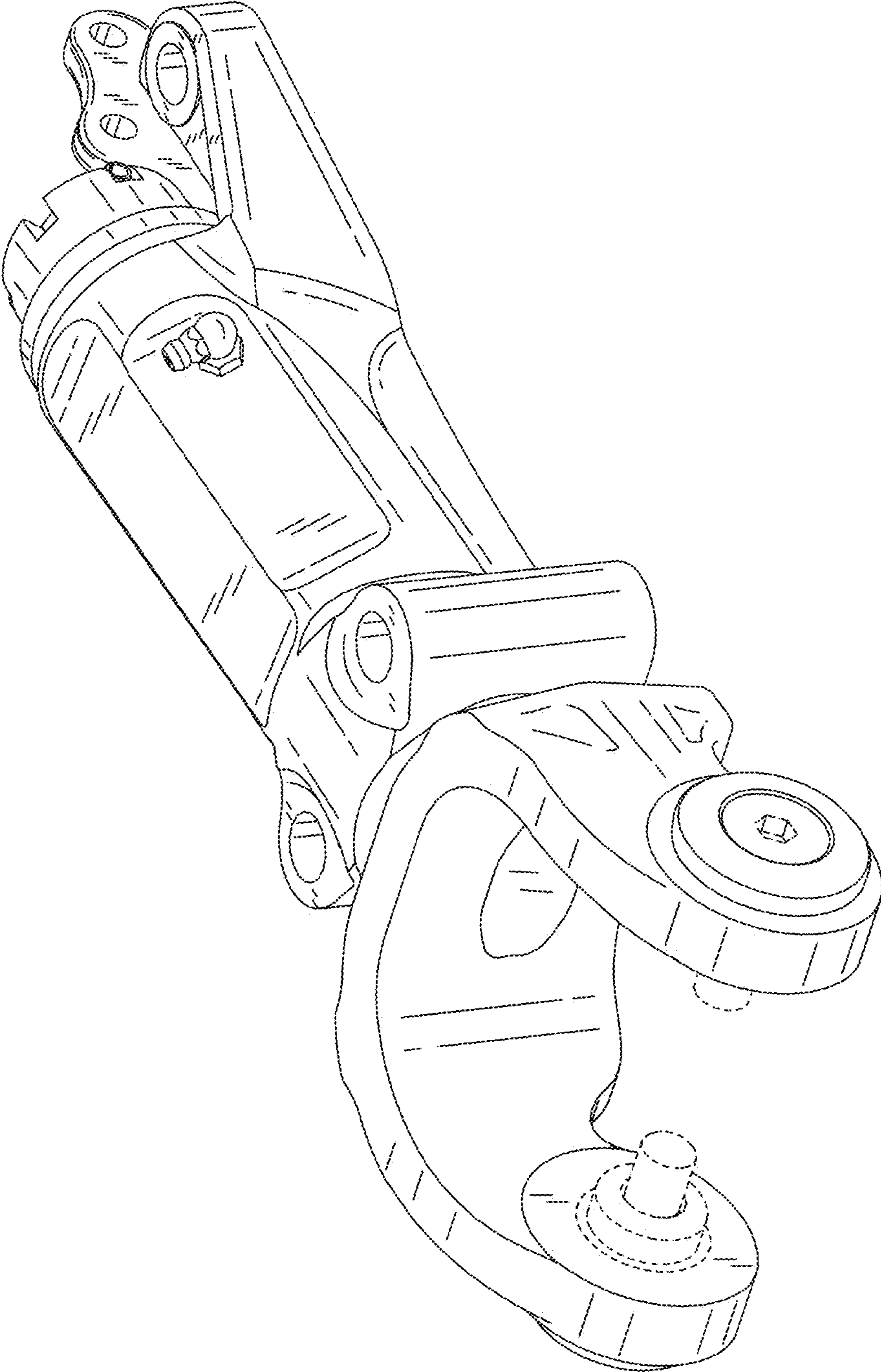

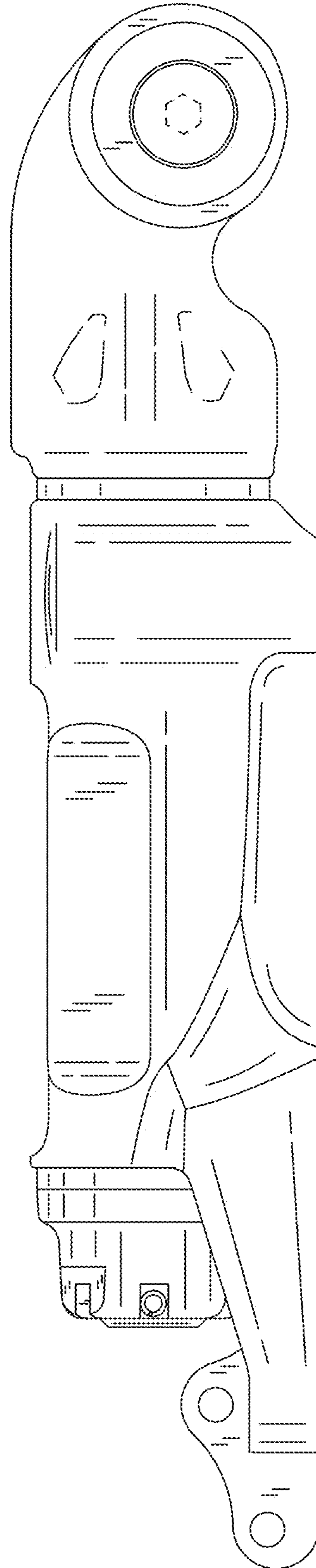

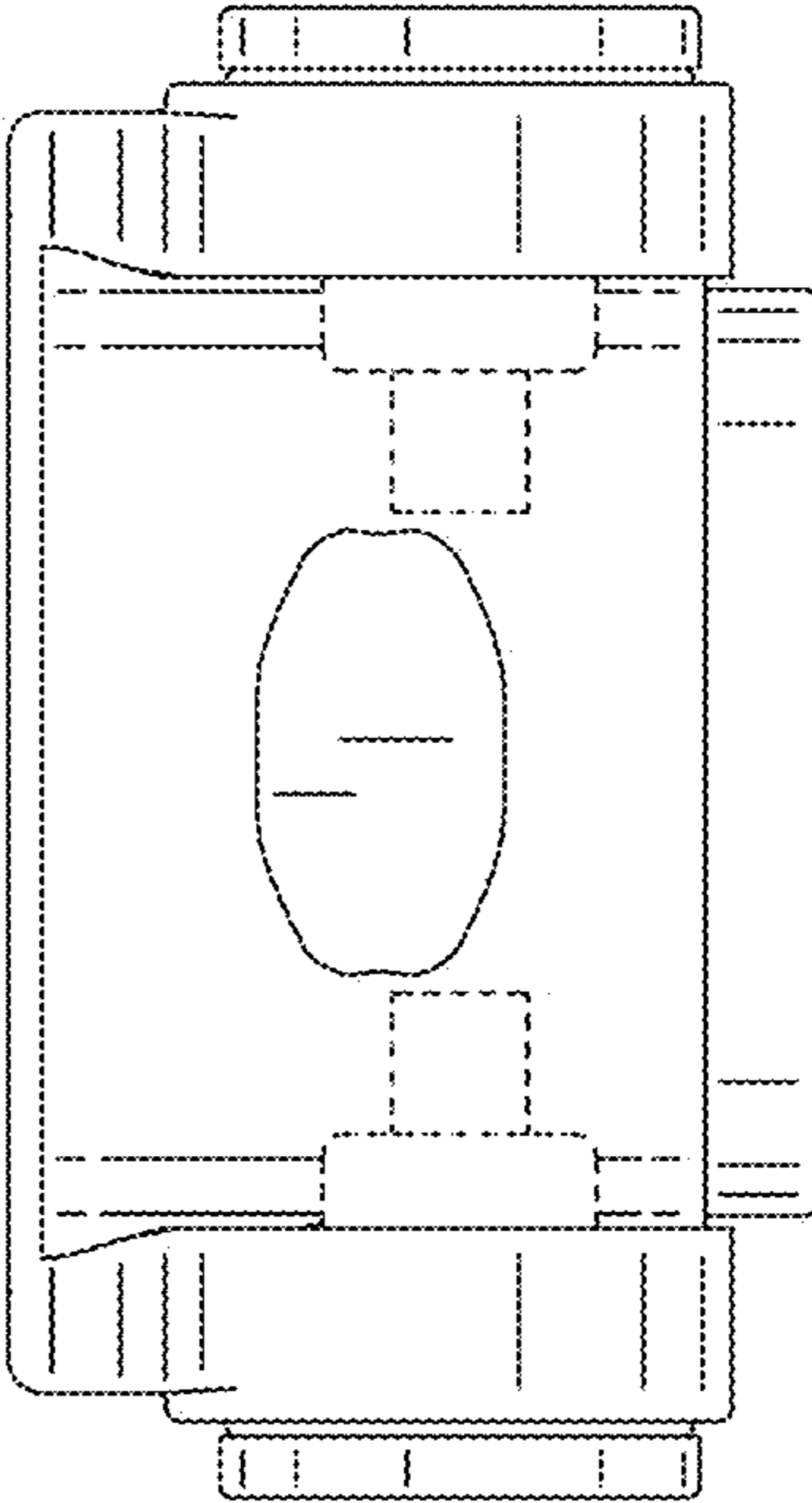

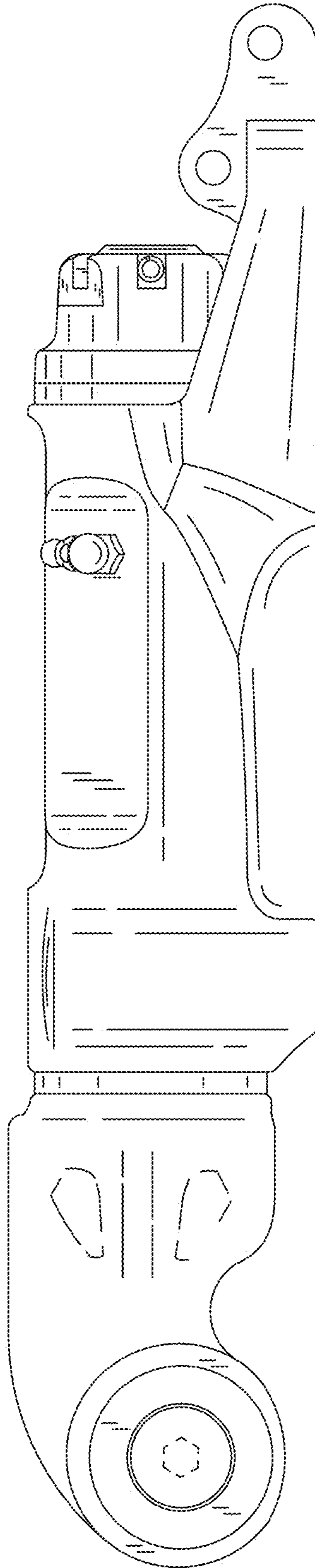

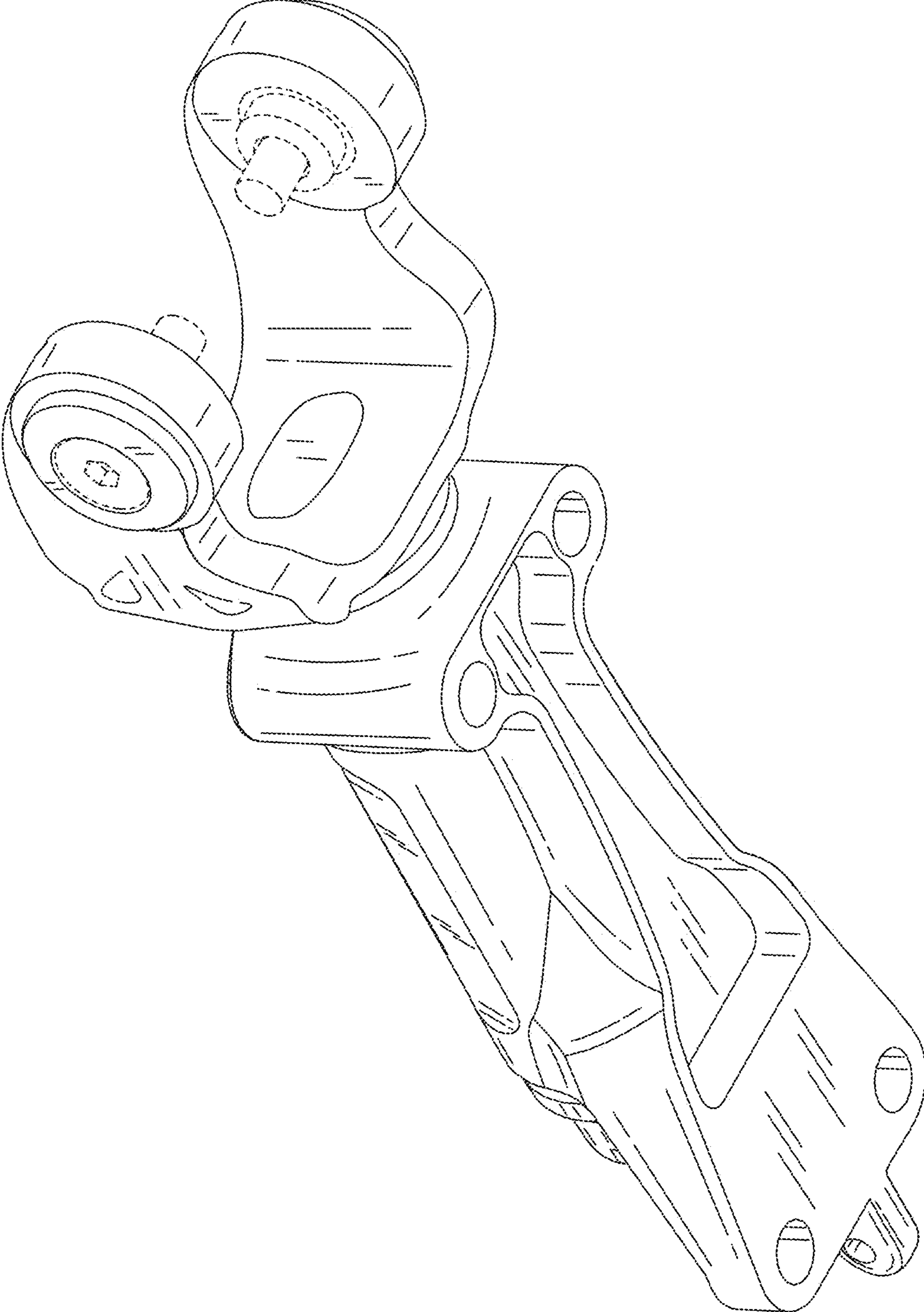

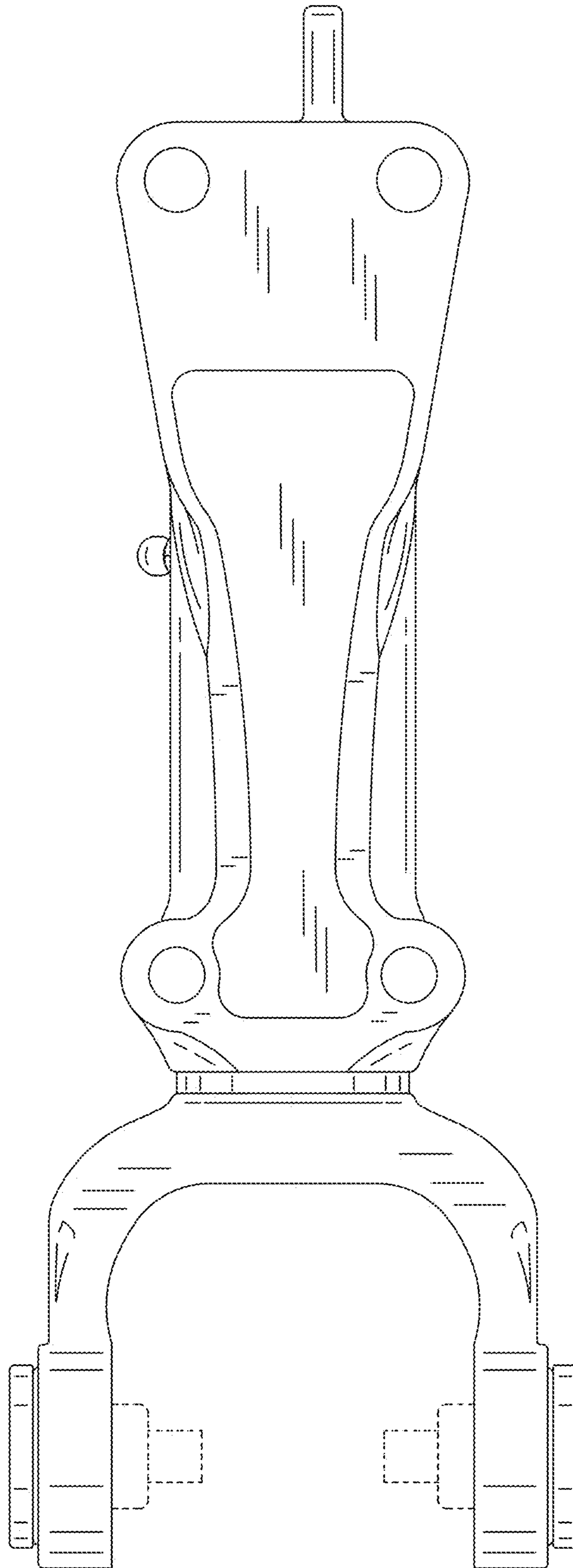

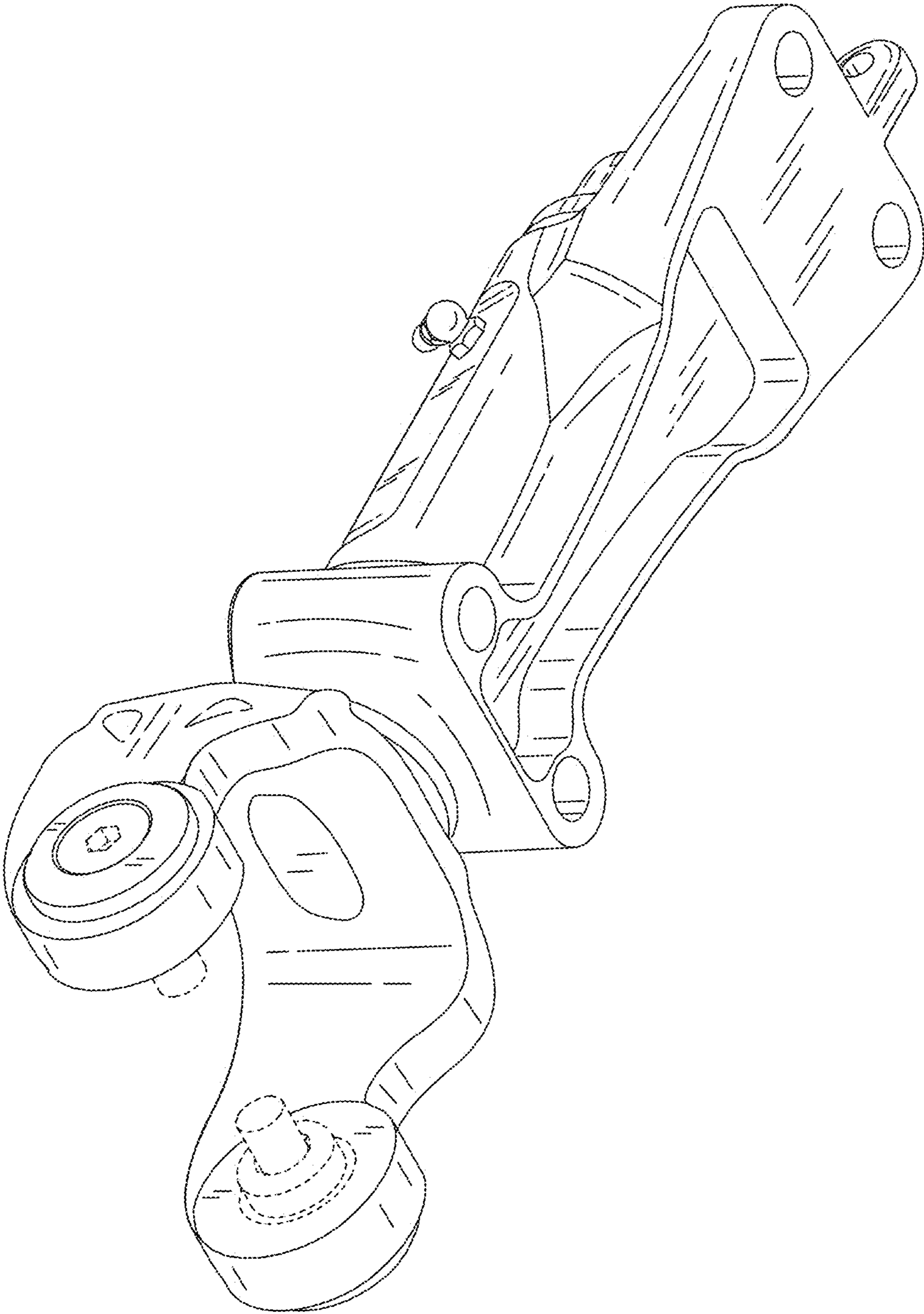

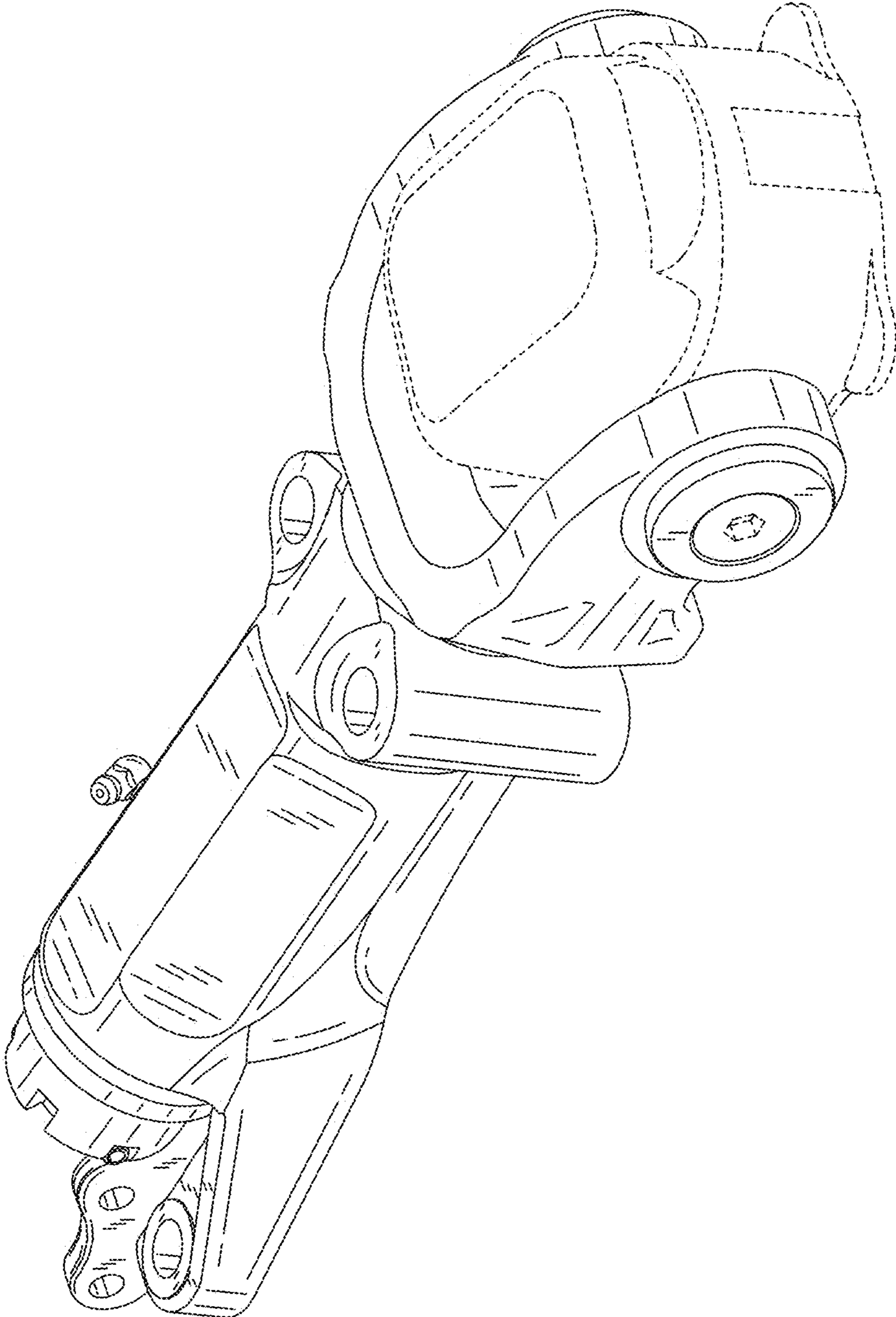
