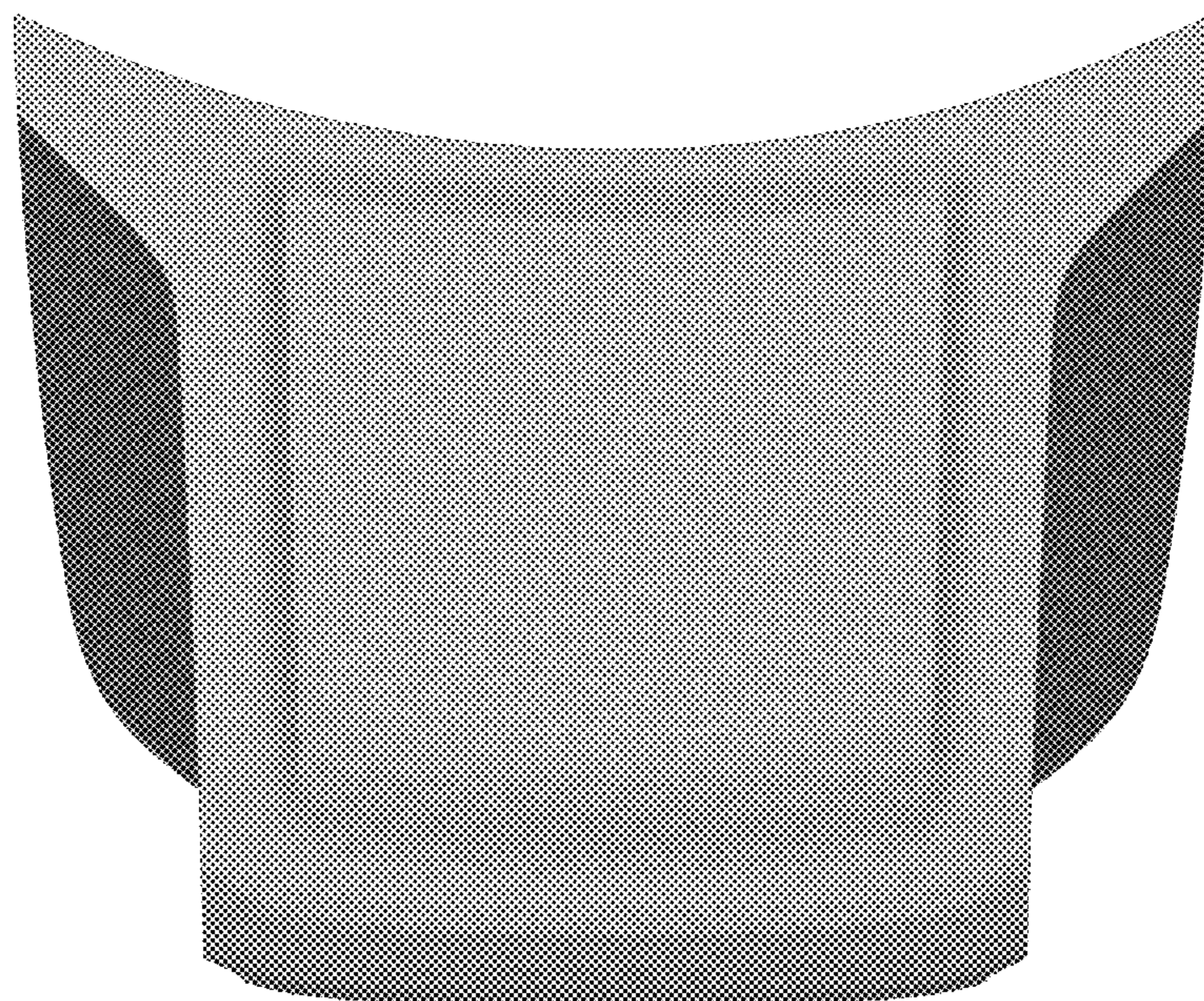
The ornamental design for a vehicle hood, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a vehicle hood showing my new design;
FIG. 2 is a front and left side perspective view thereof;
FIG. 3 is a top, rear and right side perspective view thereof;
FIG. 4 is a rear and right side perspective view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof; and,

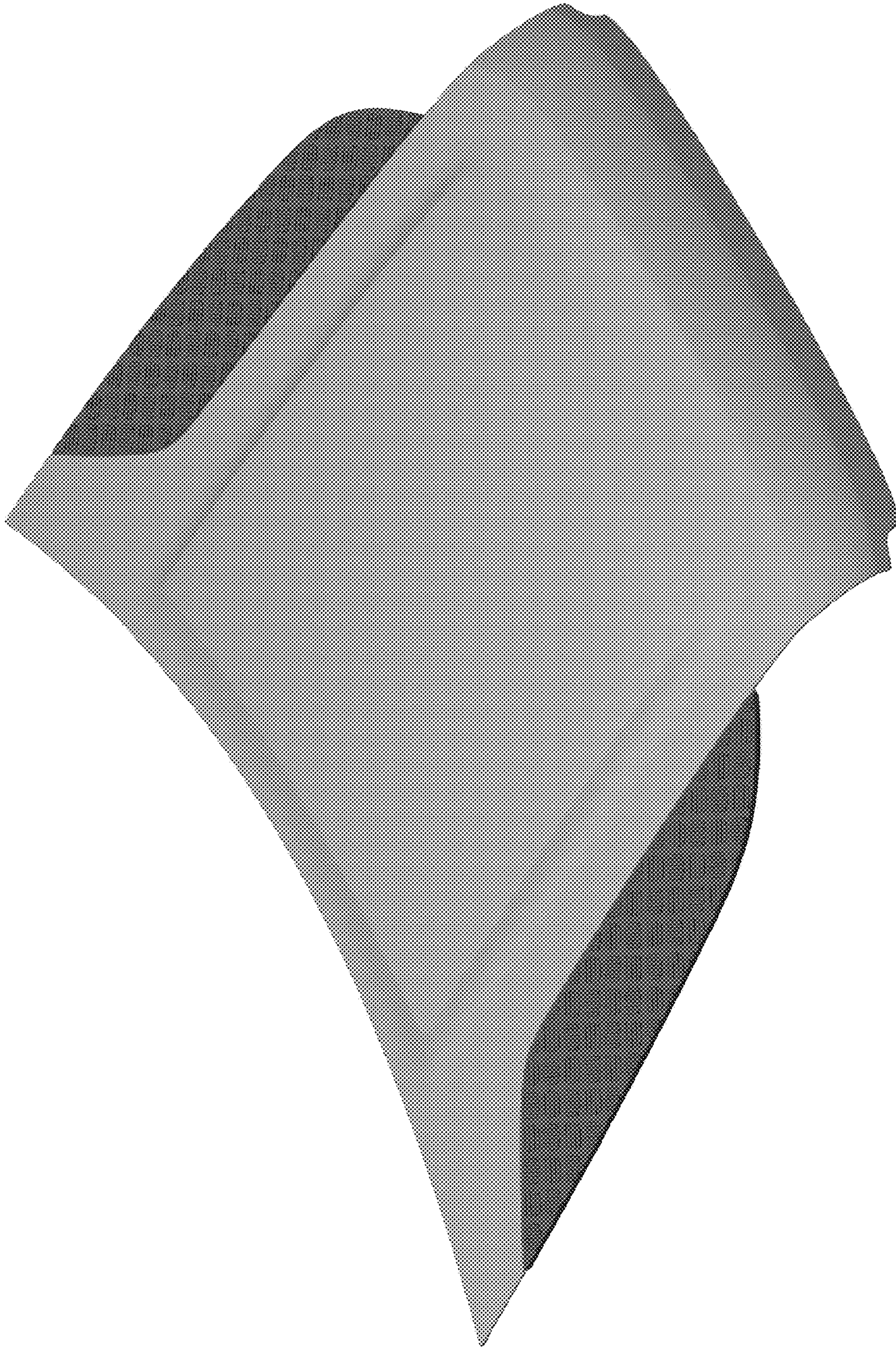

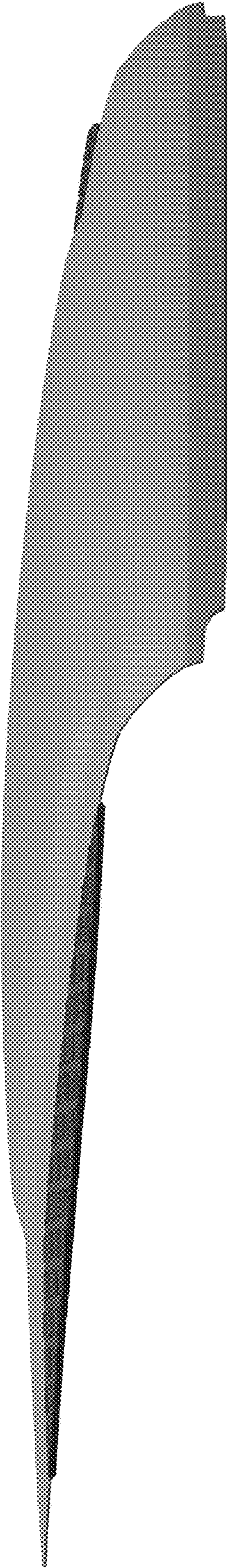

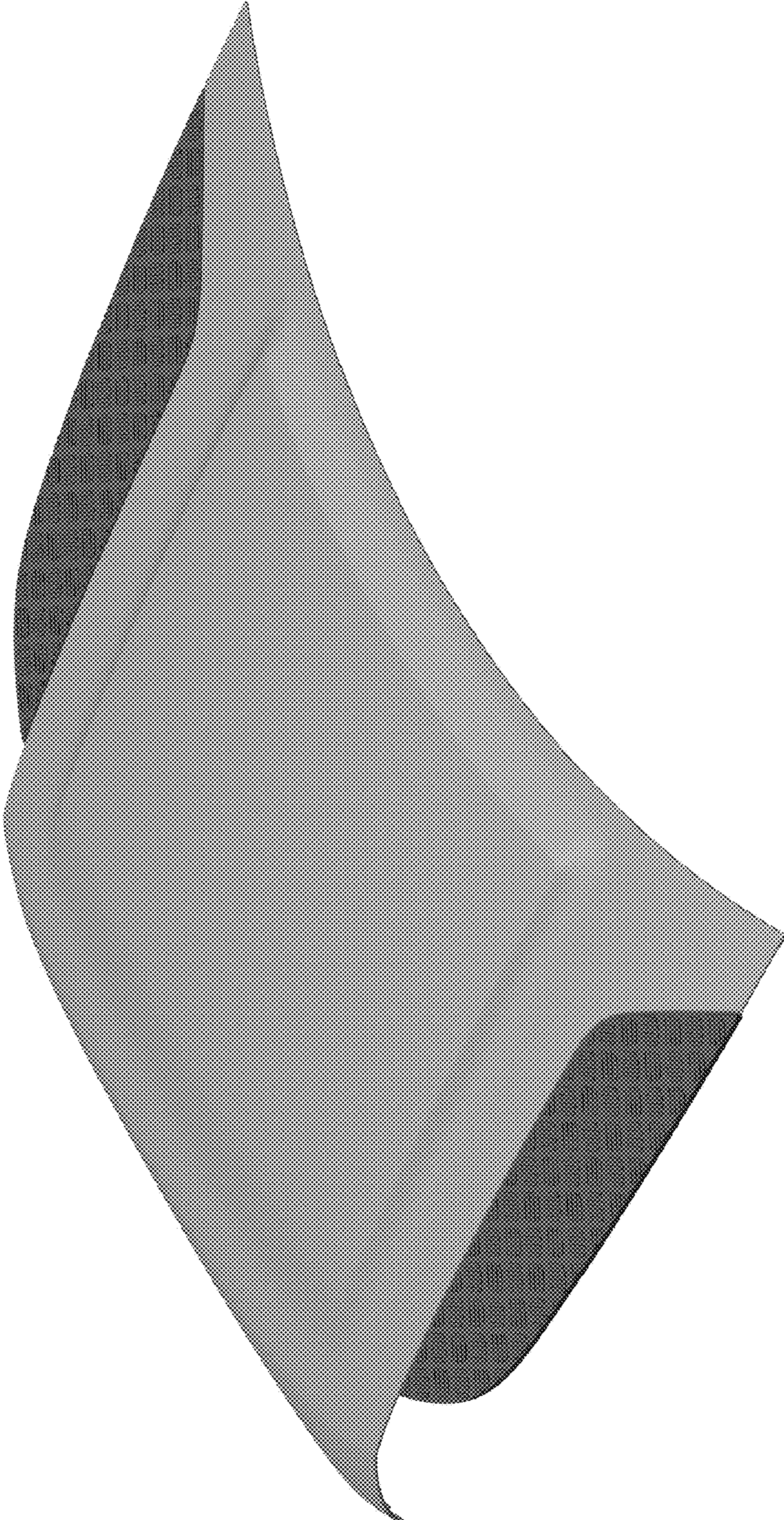

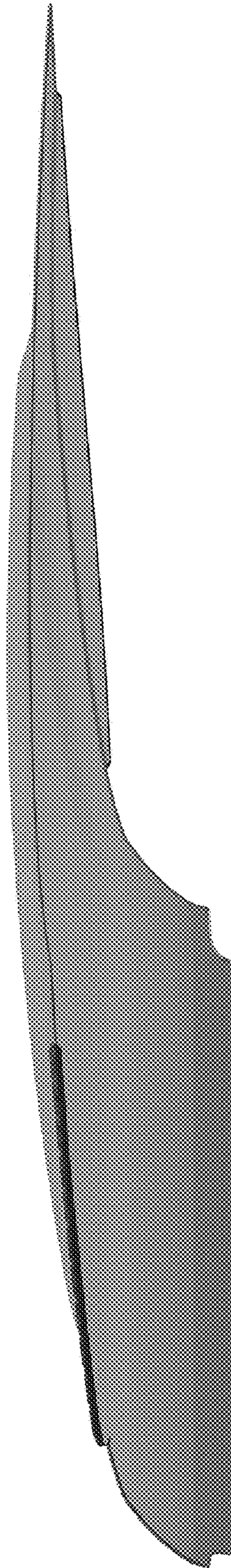

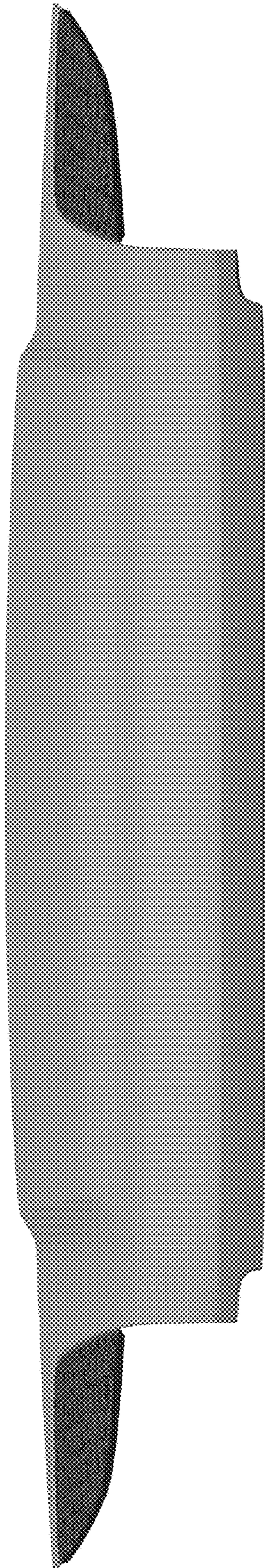

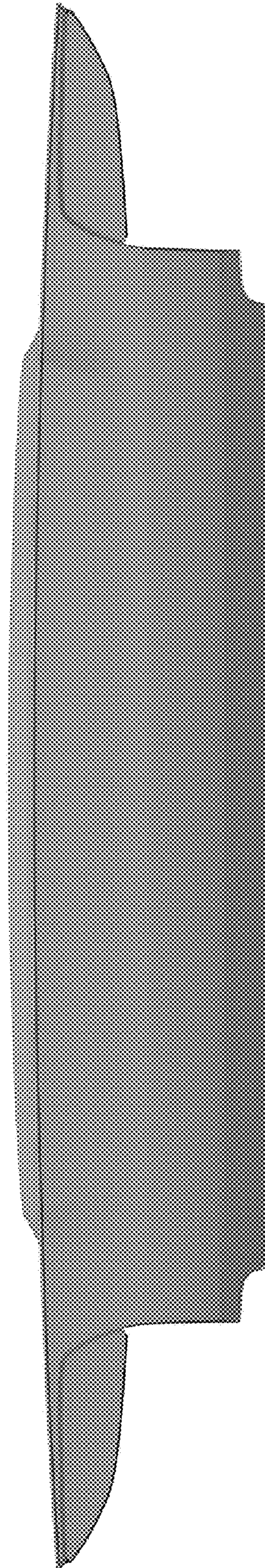

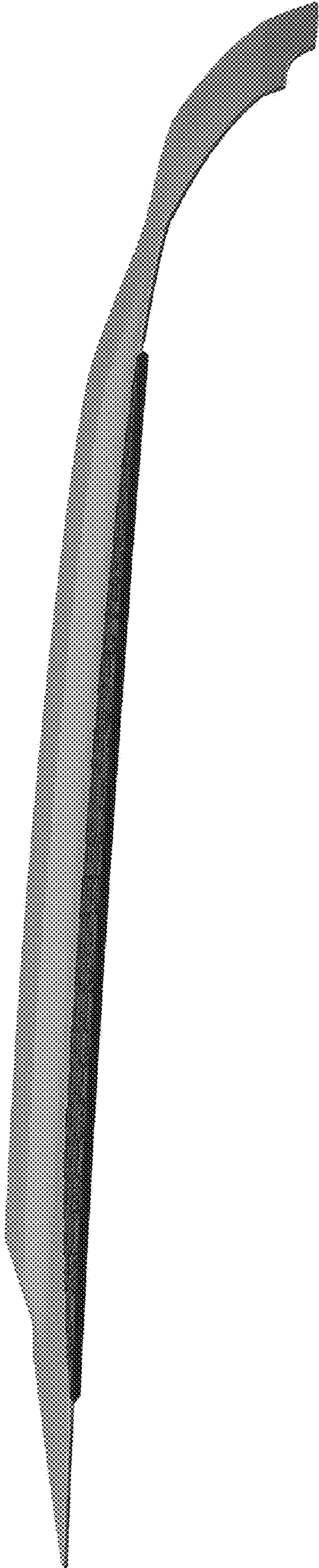

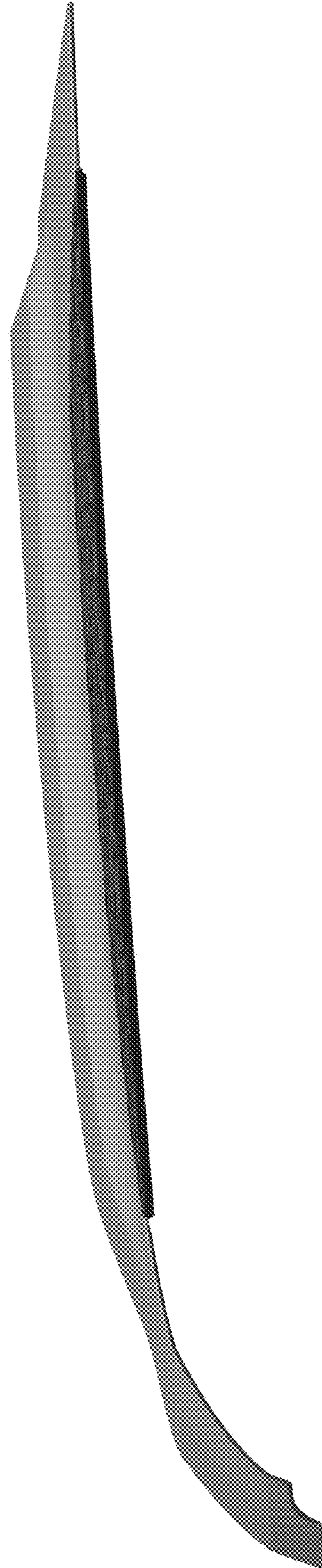

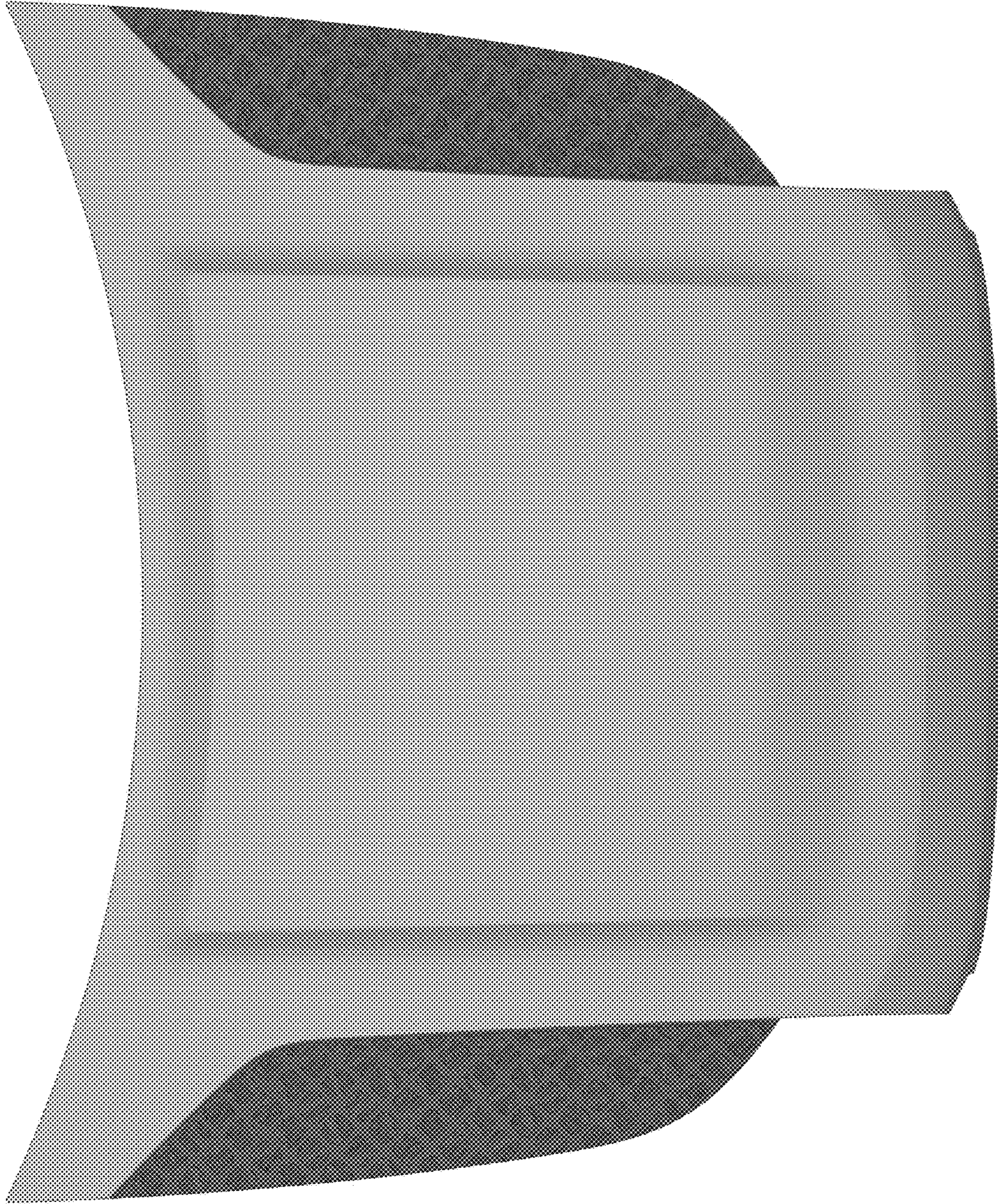

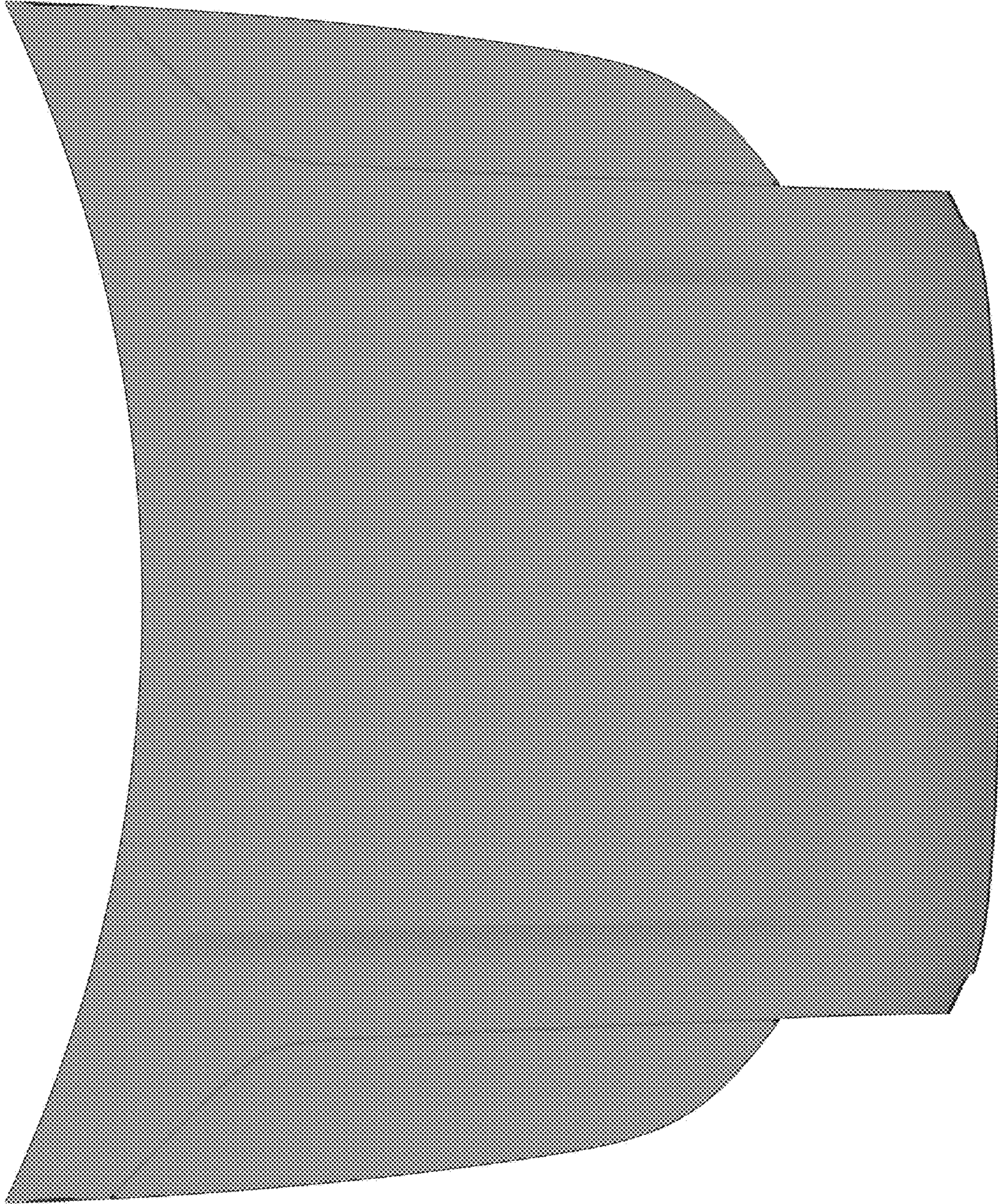
