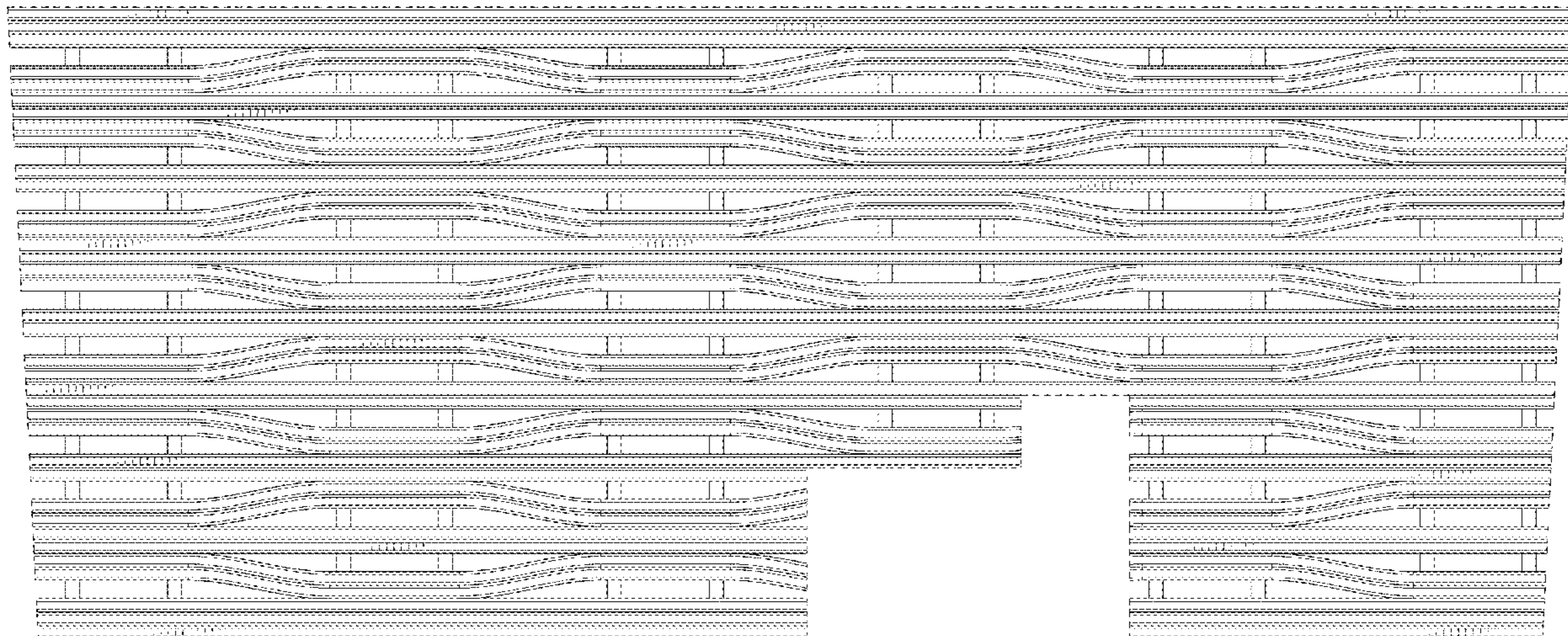

FIG. 6 is a rear view of the golf cart floor mat thereof;
FIG. 7 is a top view of a golf cart floor mat according to a second embodiment of my new design;
FIG. 8 is a bottom view of a golf cart floor mat thereof;
FIG. 9 is a left side view of the golf cart floor mat thereof;
FIG. 10 is a right side view of the golf cart floor mat thereof;
FIG. 11 is a front view of the golf cart floor mat thereof; and,
FIG. 12 is a rear view of the golf cart floor mat thereof.
The broken lines along the outer edge of the golf cart floor mat in FIGS. 1 and 7 depict the bounds of the claim and form no part thereof. The broken lines in FIGS. 2-6 and 8-12 depict portions of the golf cart floor mat that form no part of the claimed design. Portions of the golf cart floor mat in FIGS. 7-12 have been cross hatched to indicate color.

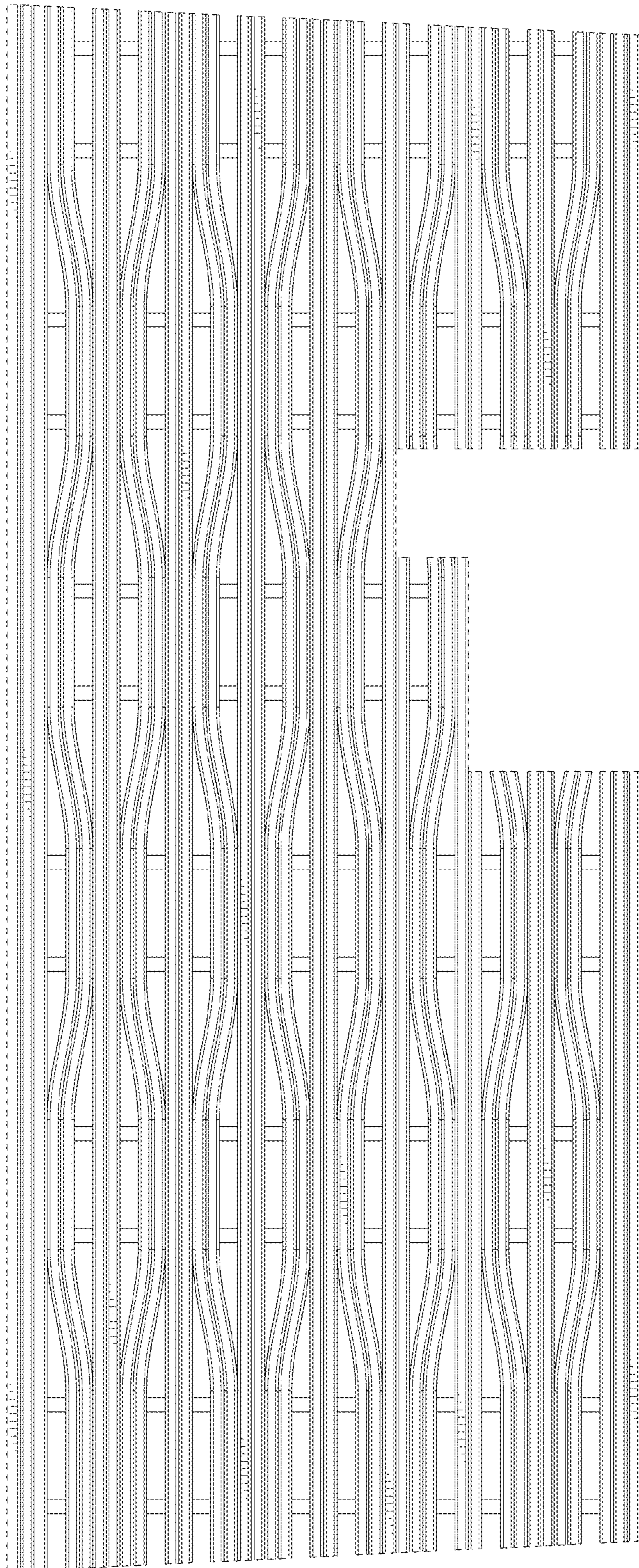

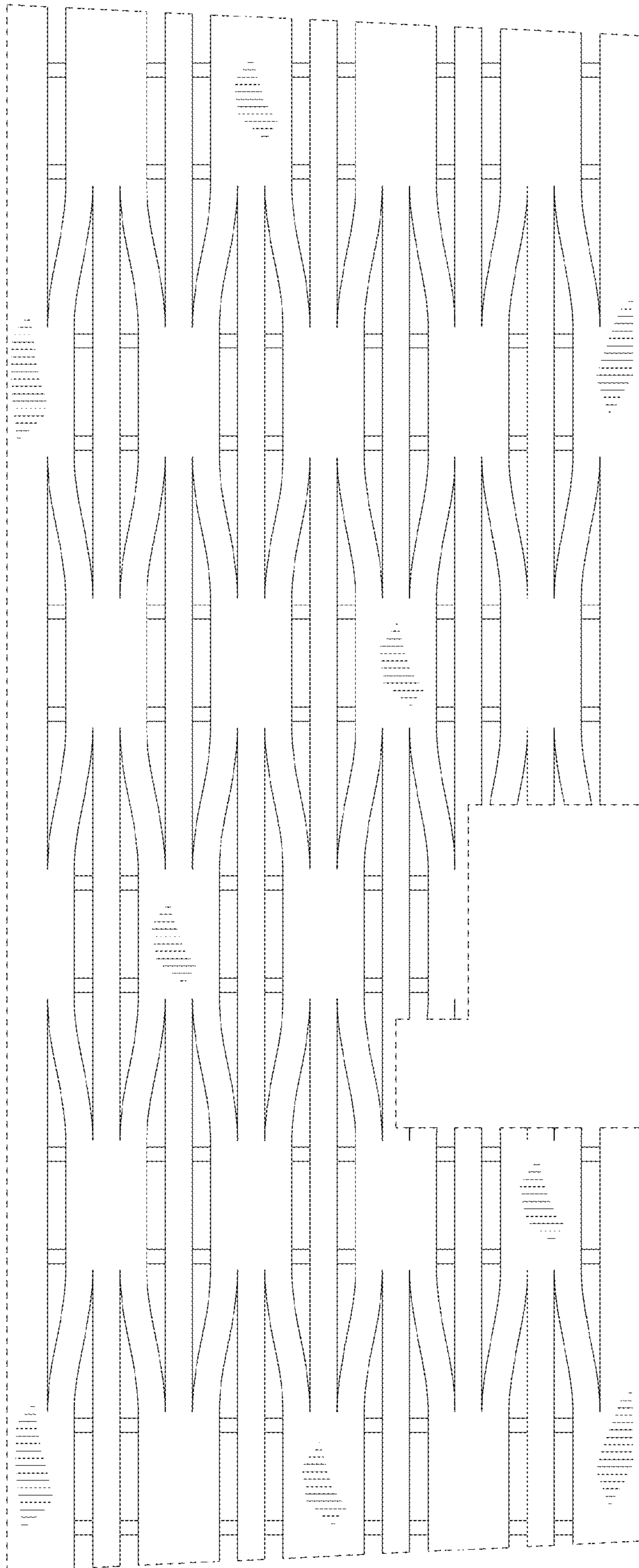

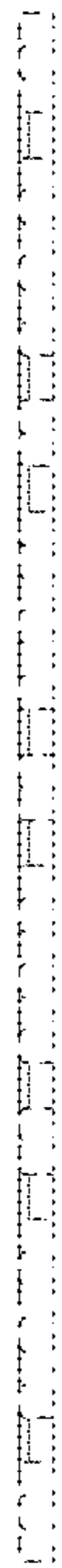

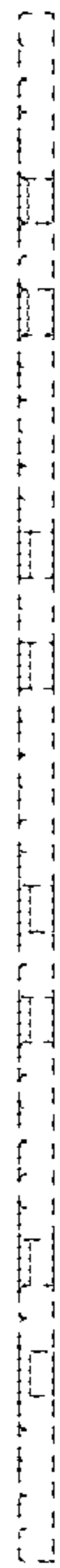

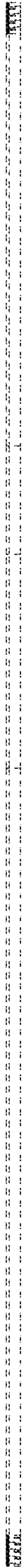

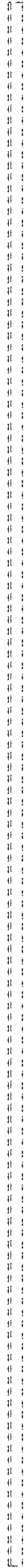

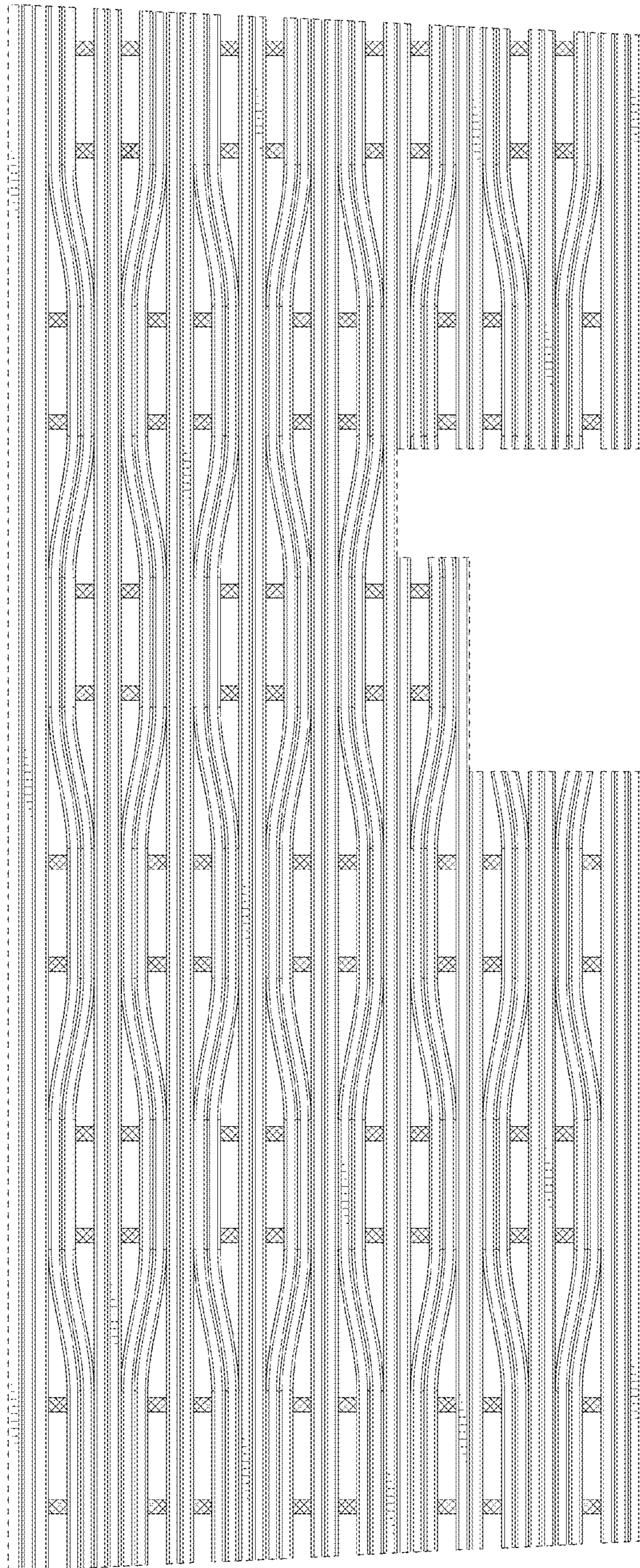

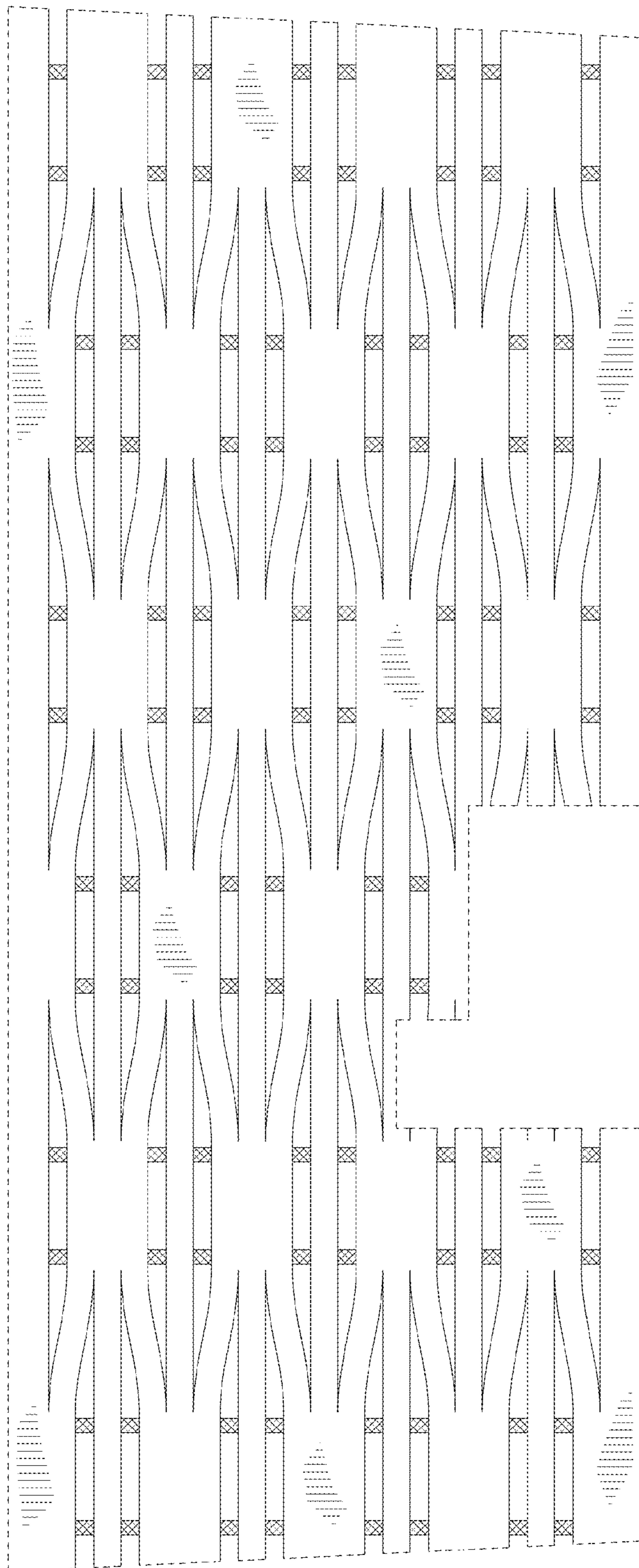

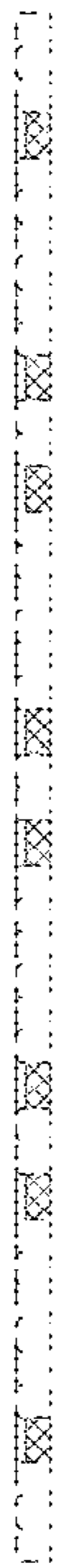

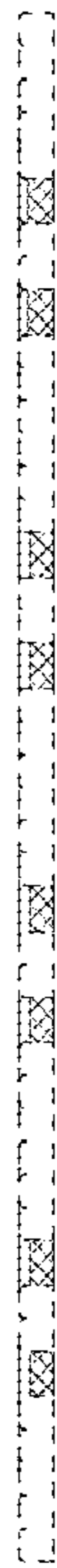

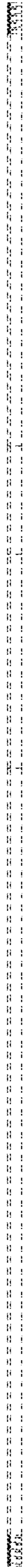

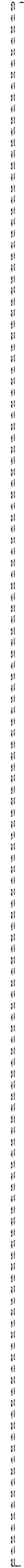
