(57) **CLAIM**

The ornamental design for a flexible printed circuit board for battery module, as shown and described.

FIG. 7 is a bottom view thereof; and,

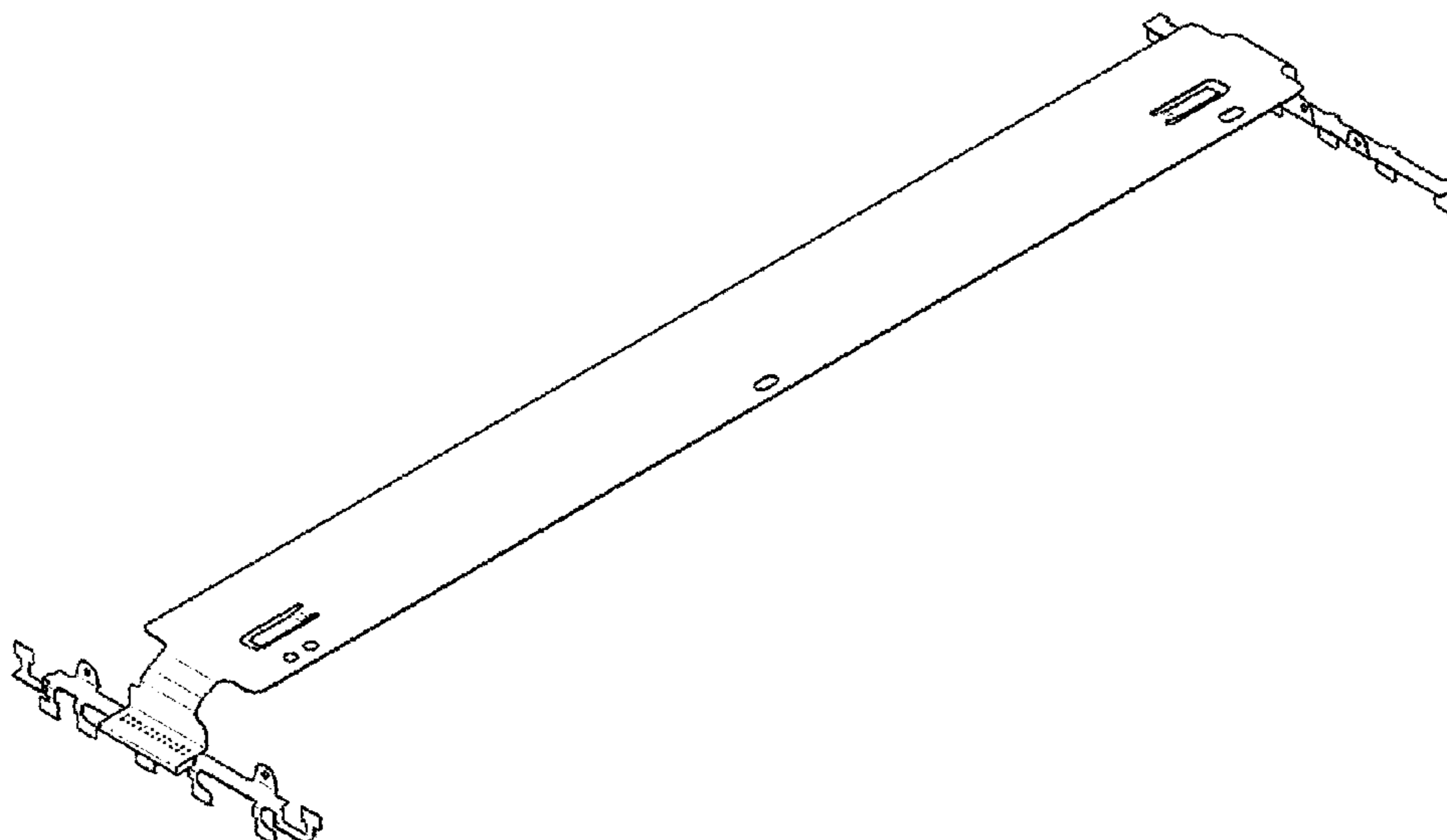
FIG. 8 is a rear perspective view thereof.

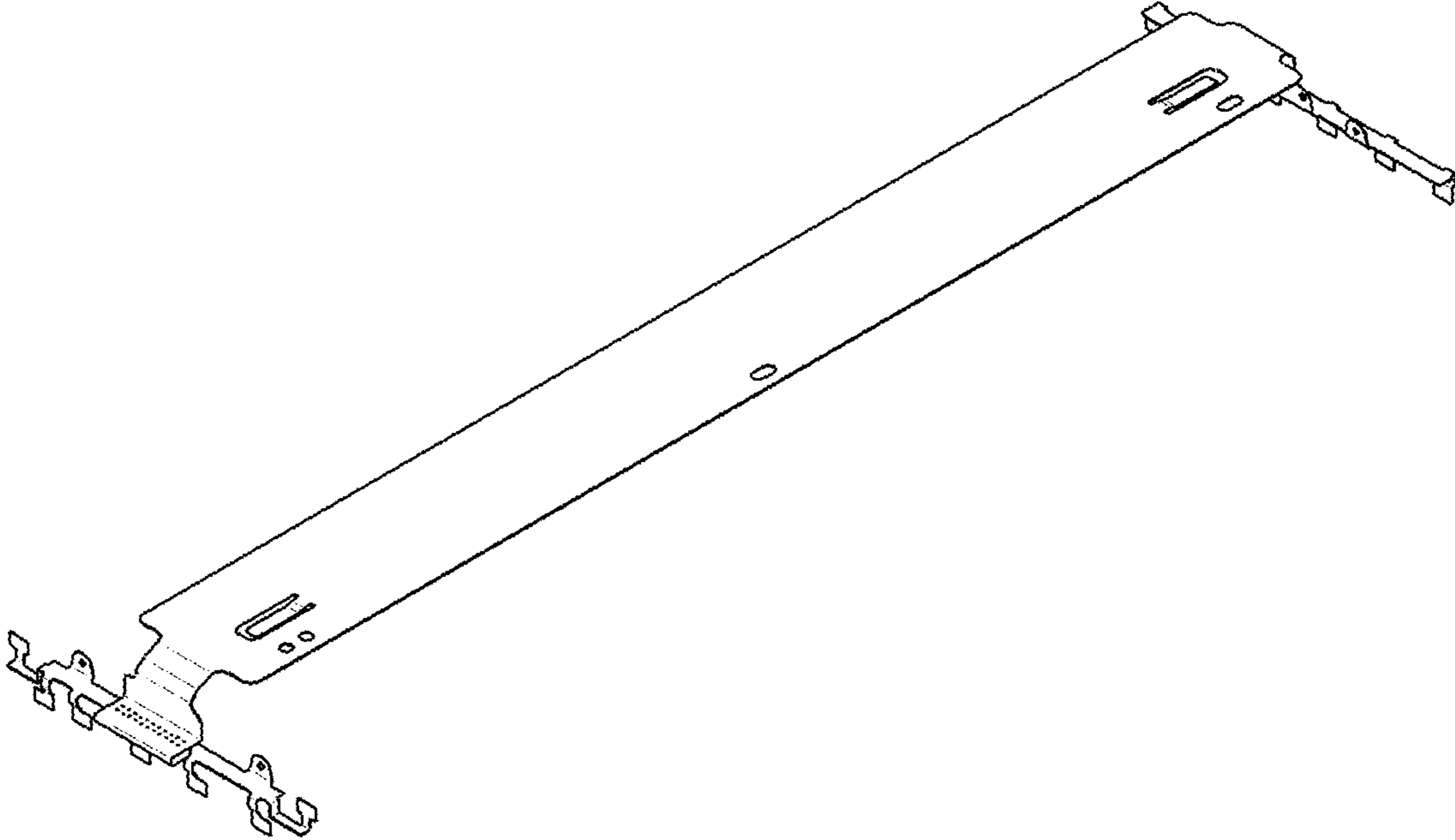

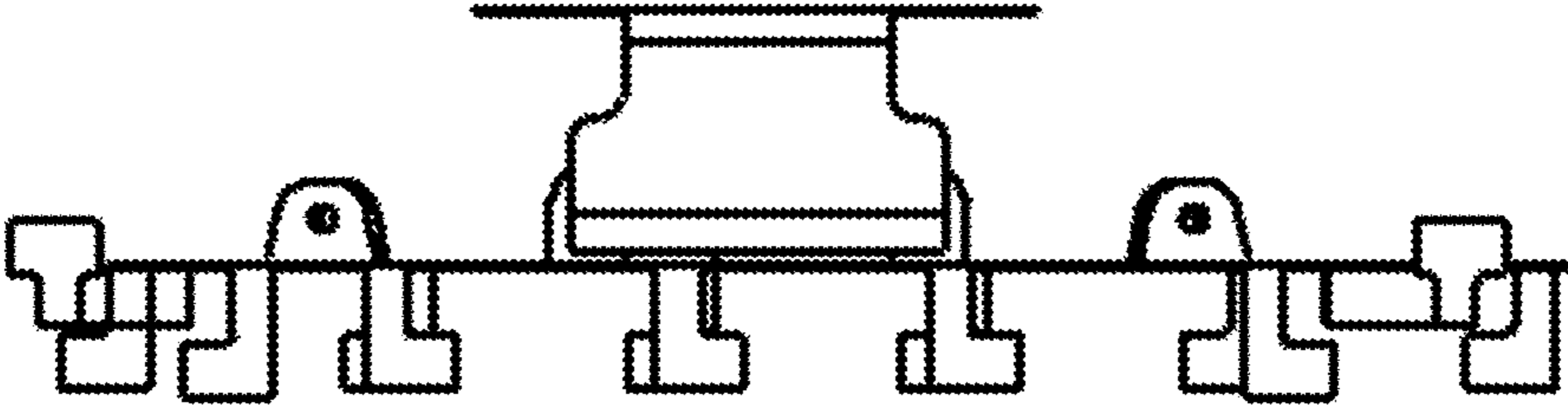

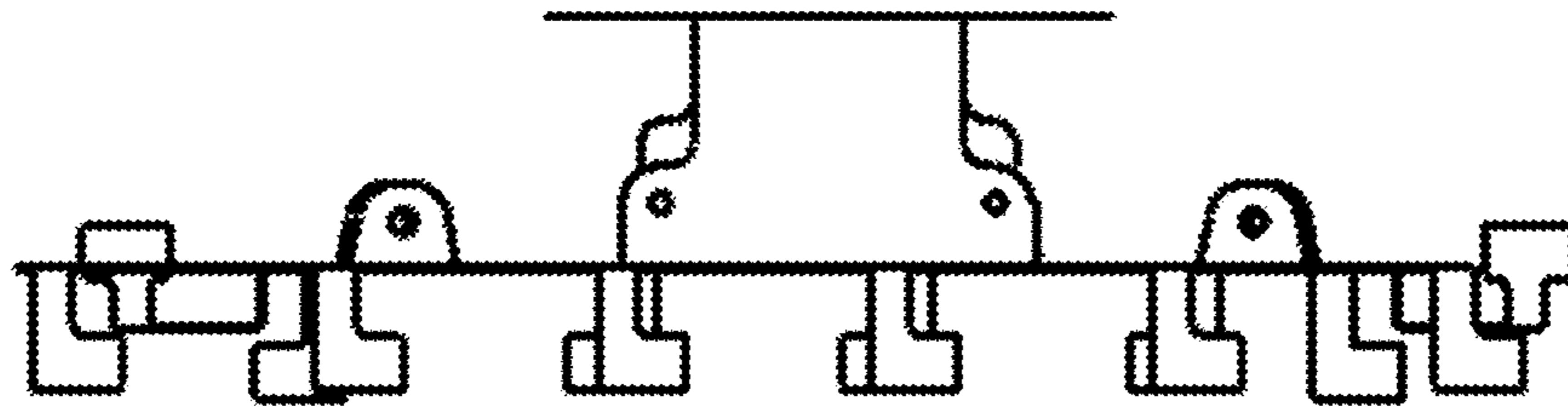

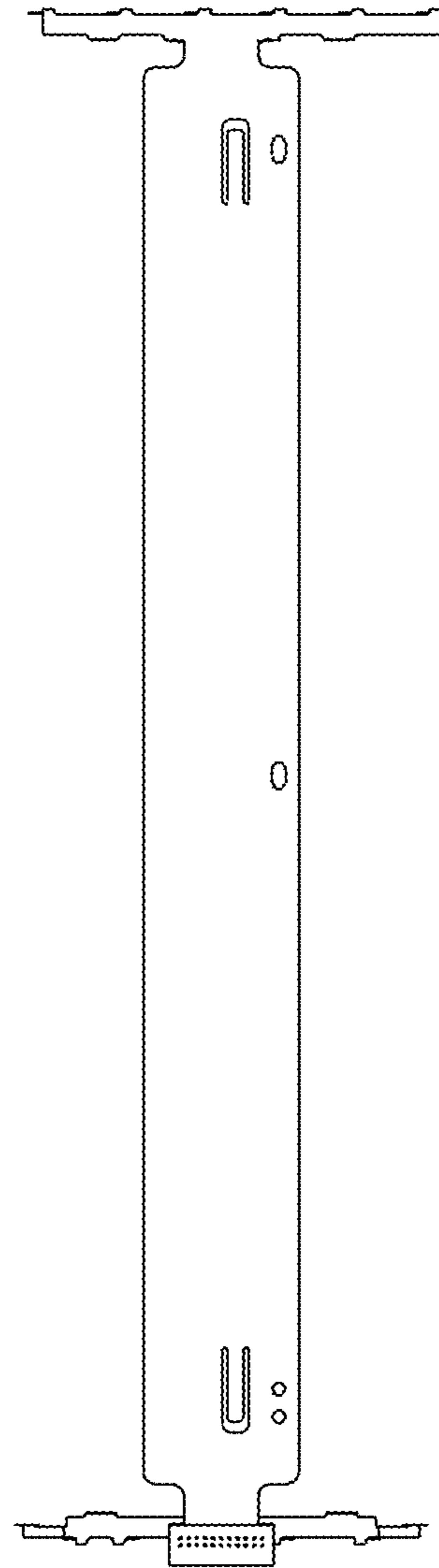

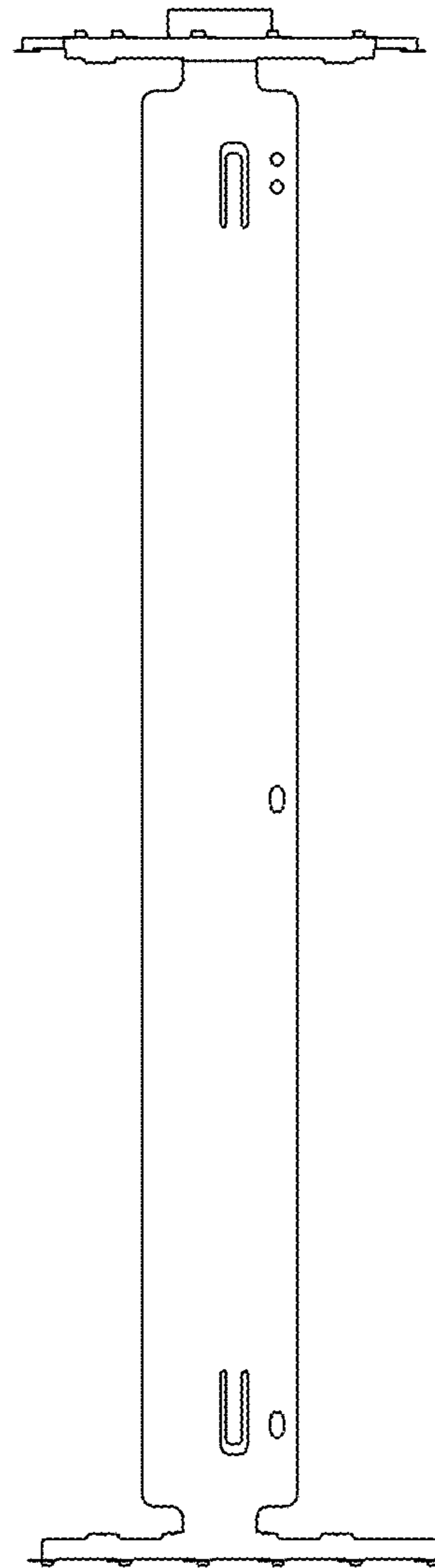
