(57) **CLAIM**

The ornamental design for a removable medical pillow cover, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a removable medical pillow cover; FIG. 2 is a bottom view of the removable medical pillow cover;

FIG. 3 is a front view illustrating wide stitching at the boundary of the removable medical pillow cover;

FIG. 4 is a back view illustrating wide stitching at the boundary of the removable medical pillow cover;

FIG. 5 is a first side view illustrating wide stitching at the boundary and a handle of the removable medical pillow cover;

FIG. 6 is a second side view illustrating wide stitching at the boundary of the removable medical pillow cover;

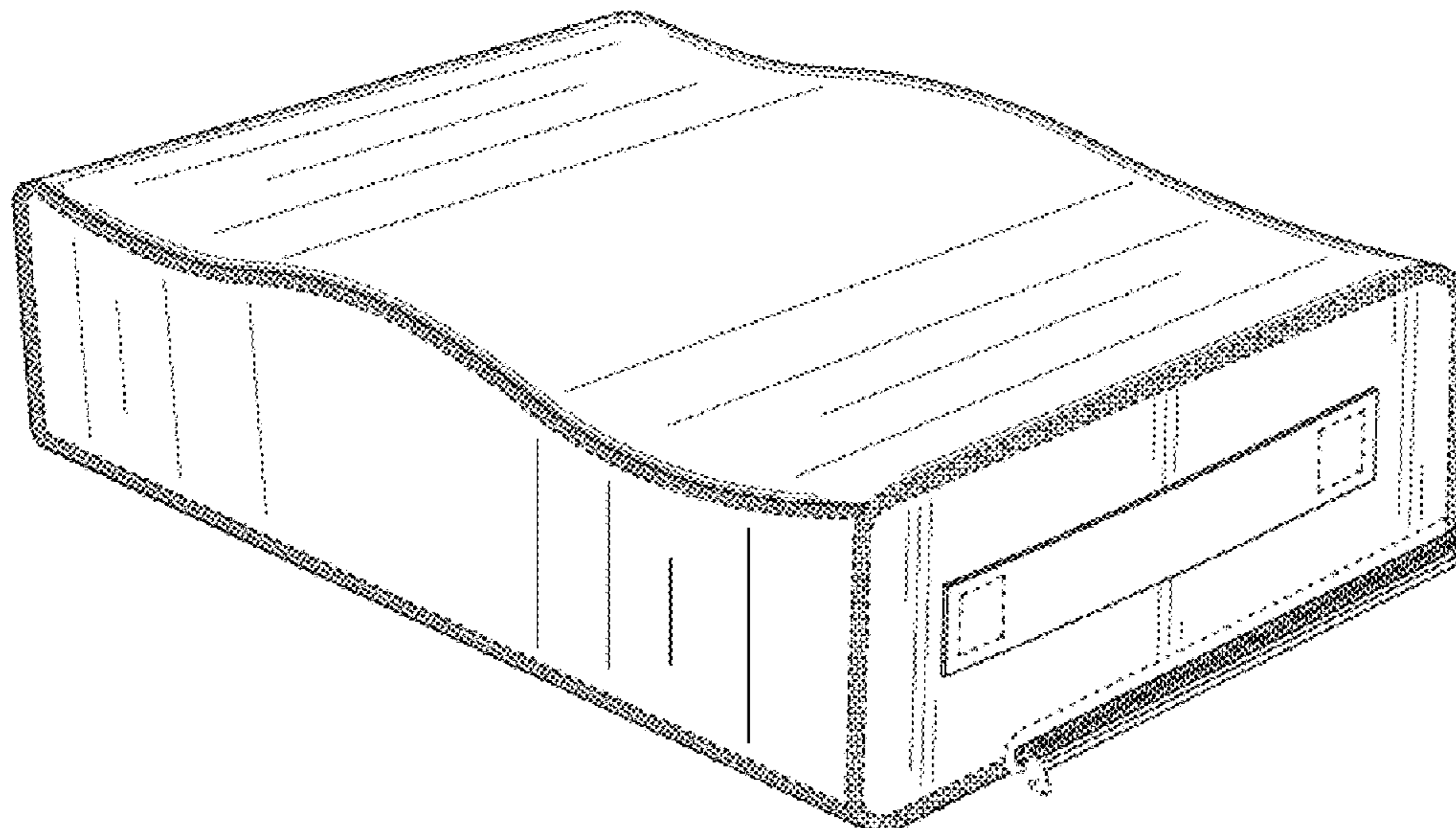
FIG. 7 is a perspective view illustrating wide stitching at the boundary of the removable medical pillow cover in operation by a user;

FIG. 8 is a perspective view illustrating wide stitching at the boundary of the removable medical pillow cover in operation by a user; and,

FIG. 9 is a perspective view illustrating wide stitching at the boundary of the removable medical pillow cover in operation by a user.

The single dashed or broken lines as illustrated in FIGS. 2-9, represent a first type of stitching forming no part of the claimed design. The single dashed or broken lines as illustrated in FIGS. 2-8, represent the zip fastener grip forming no part of the claimed design. The single dashed or broken lines as illustrated in FIGS. 7-8 represents a user forming no part of the claimed design. The wide stitching, as illustrated in FIGS. 3-9 as a chequered pattern form part of the claimed design.

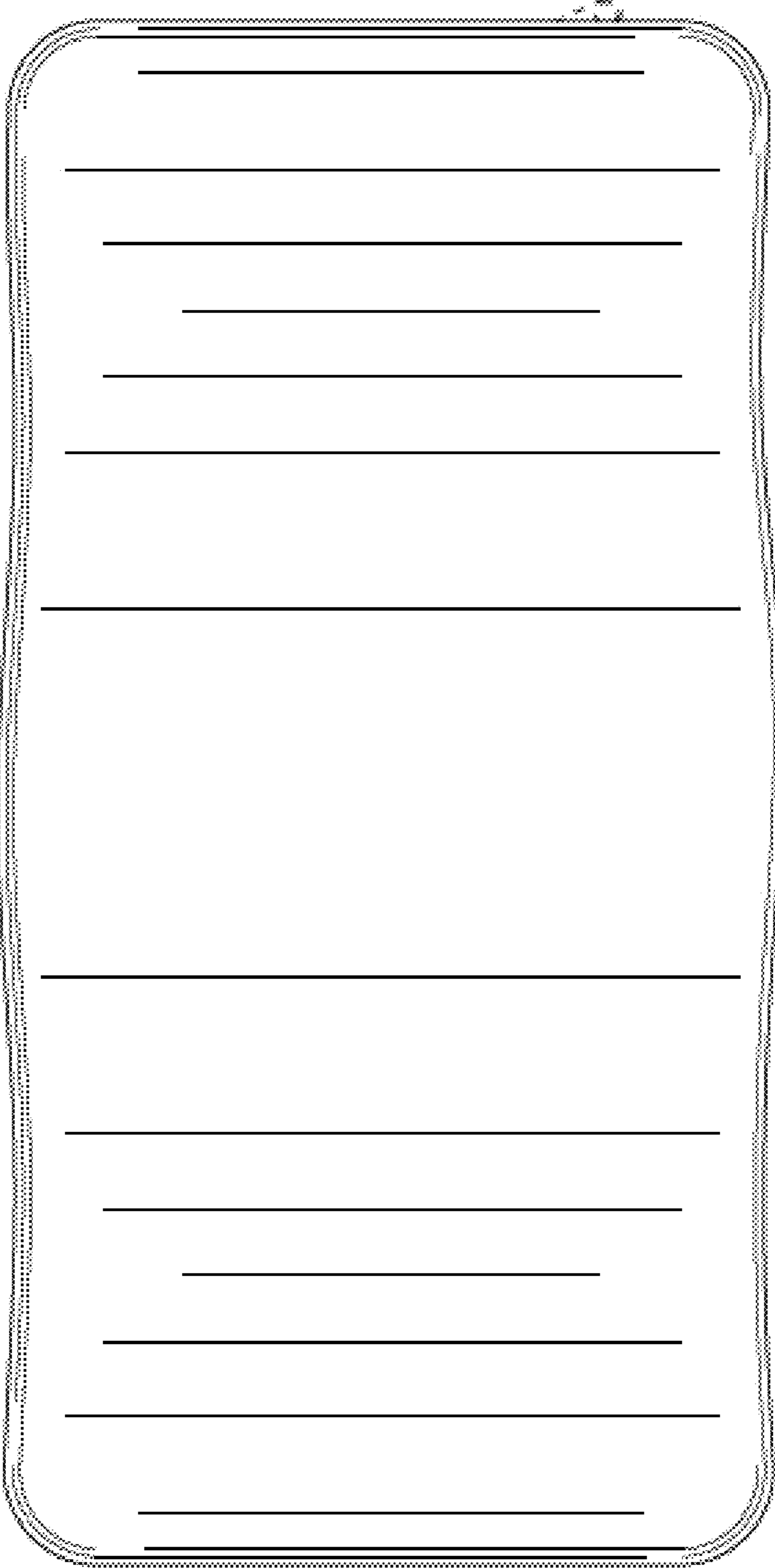

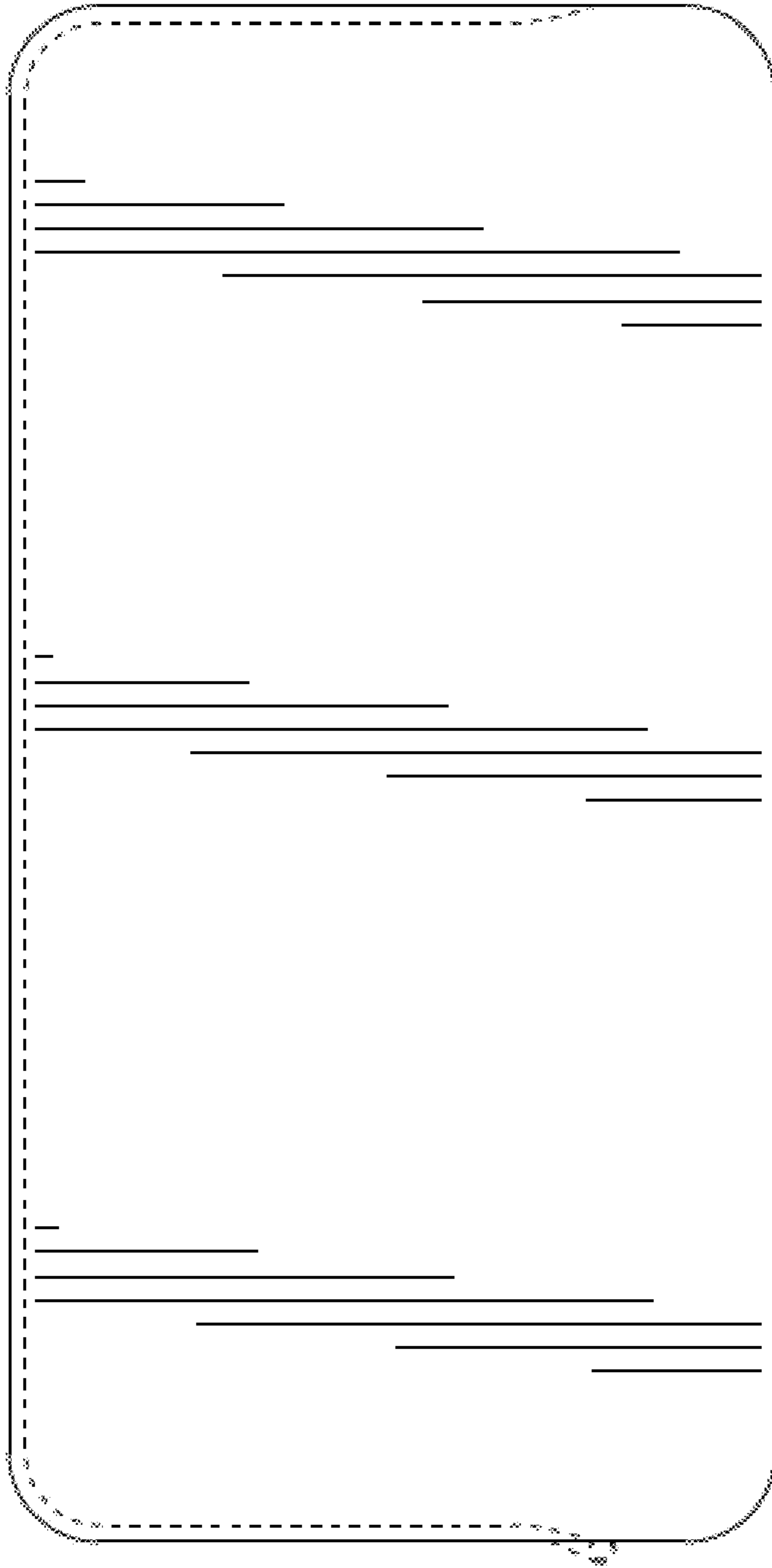

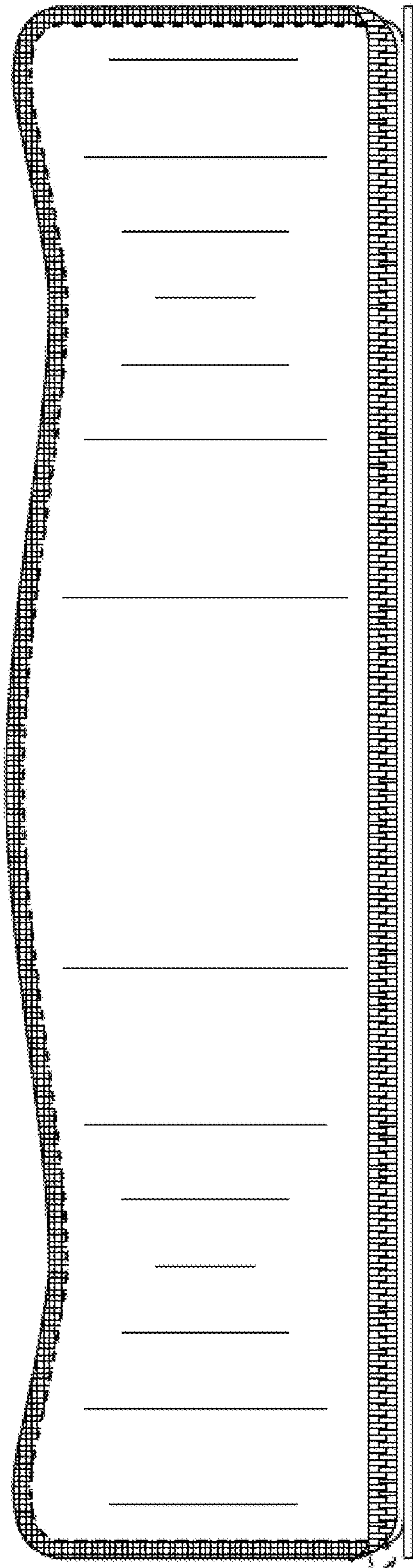

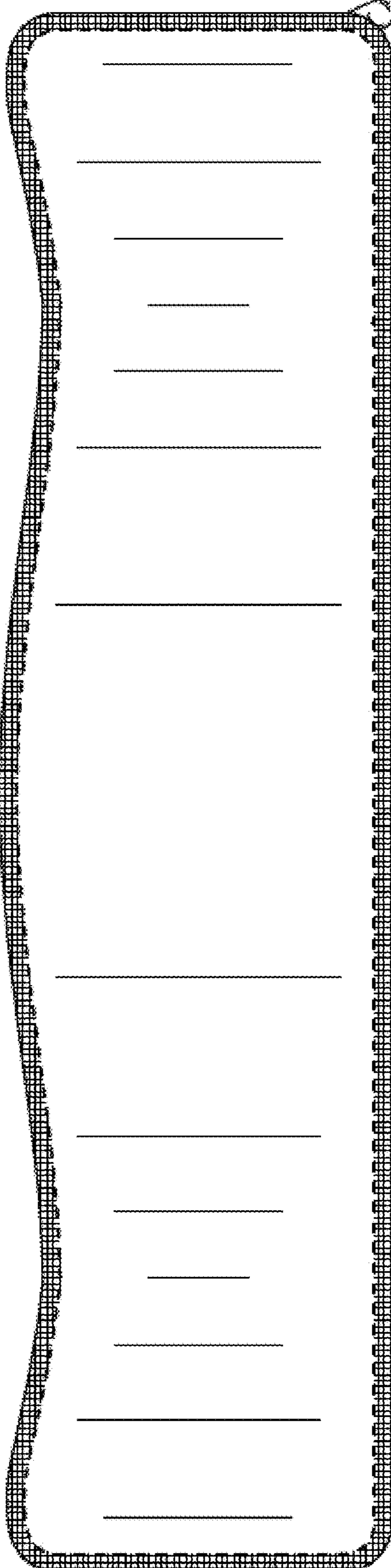

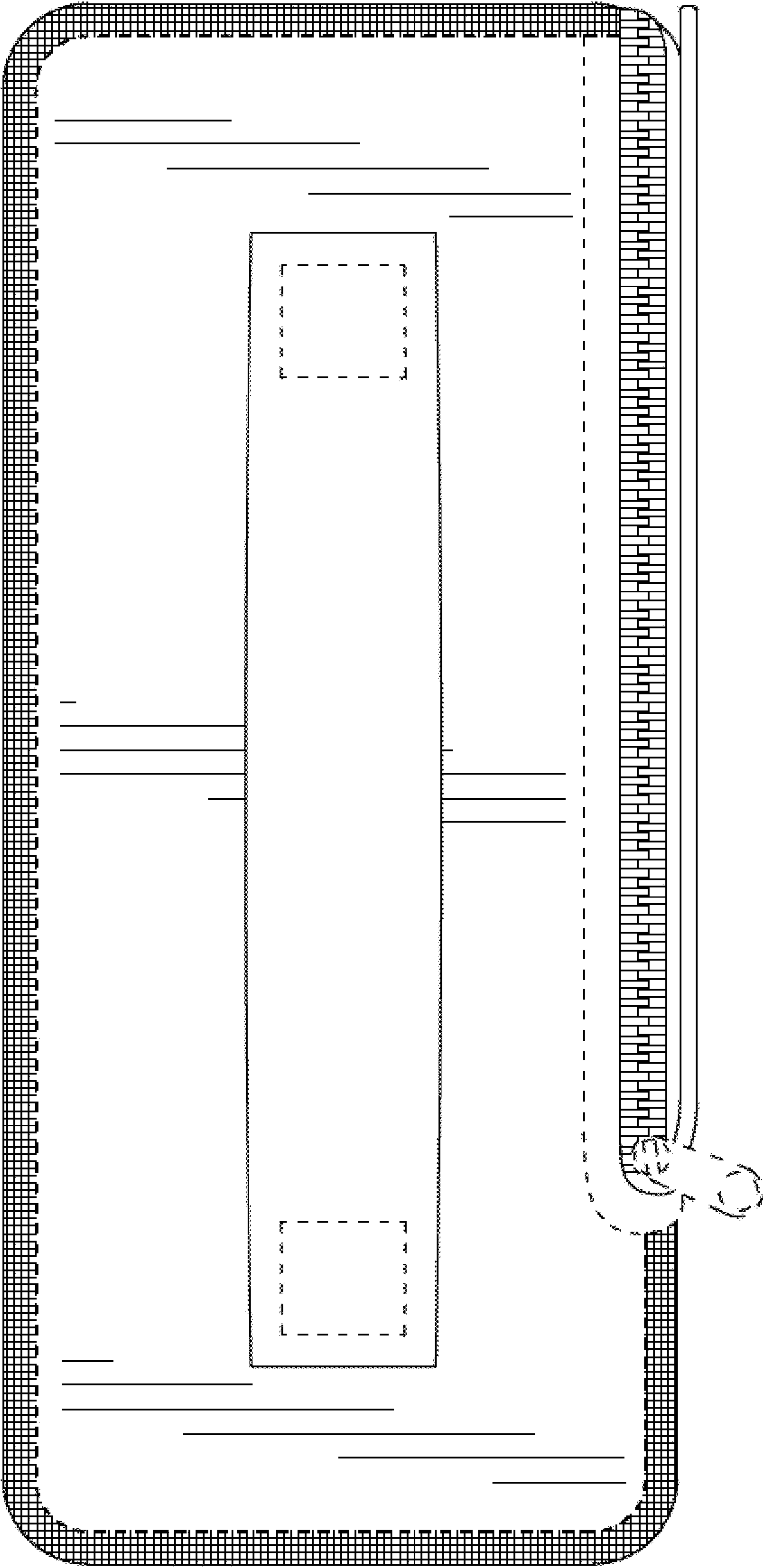

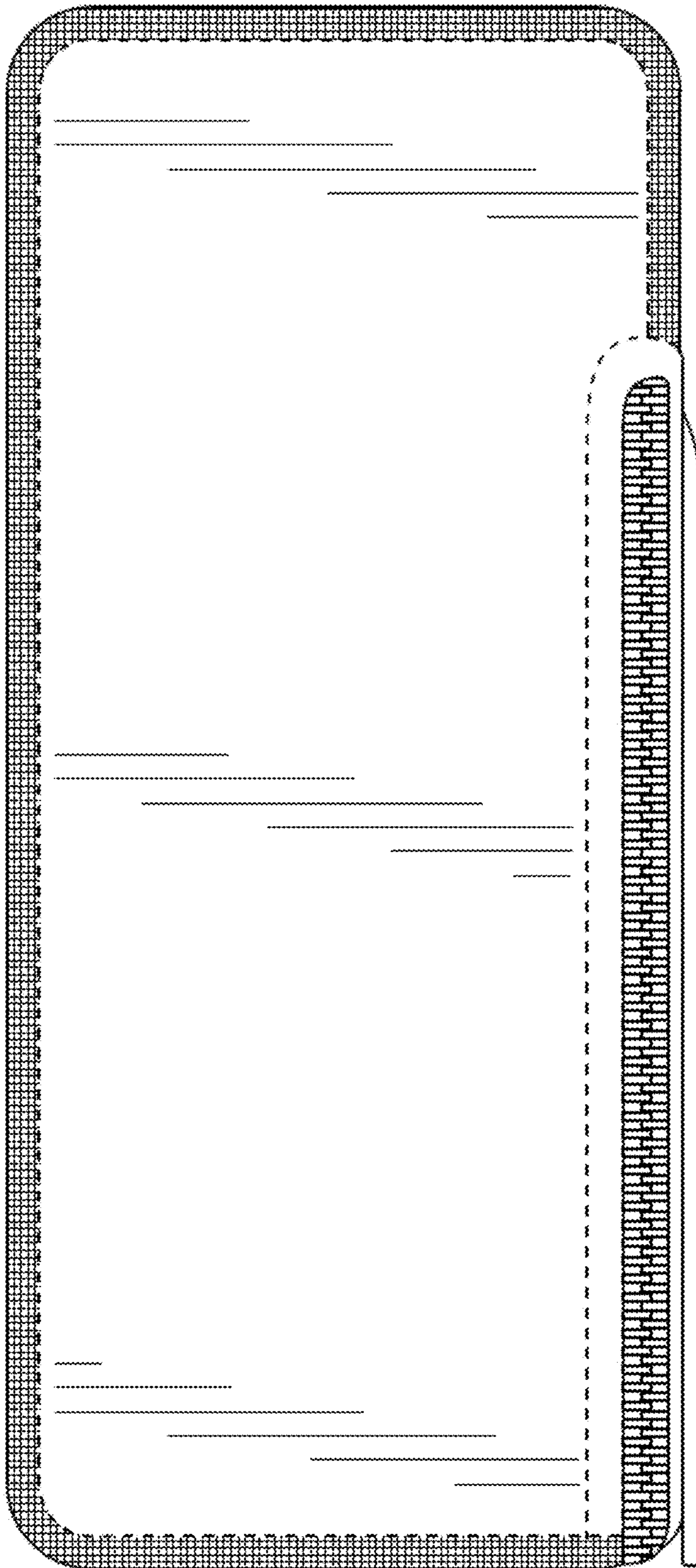

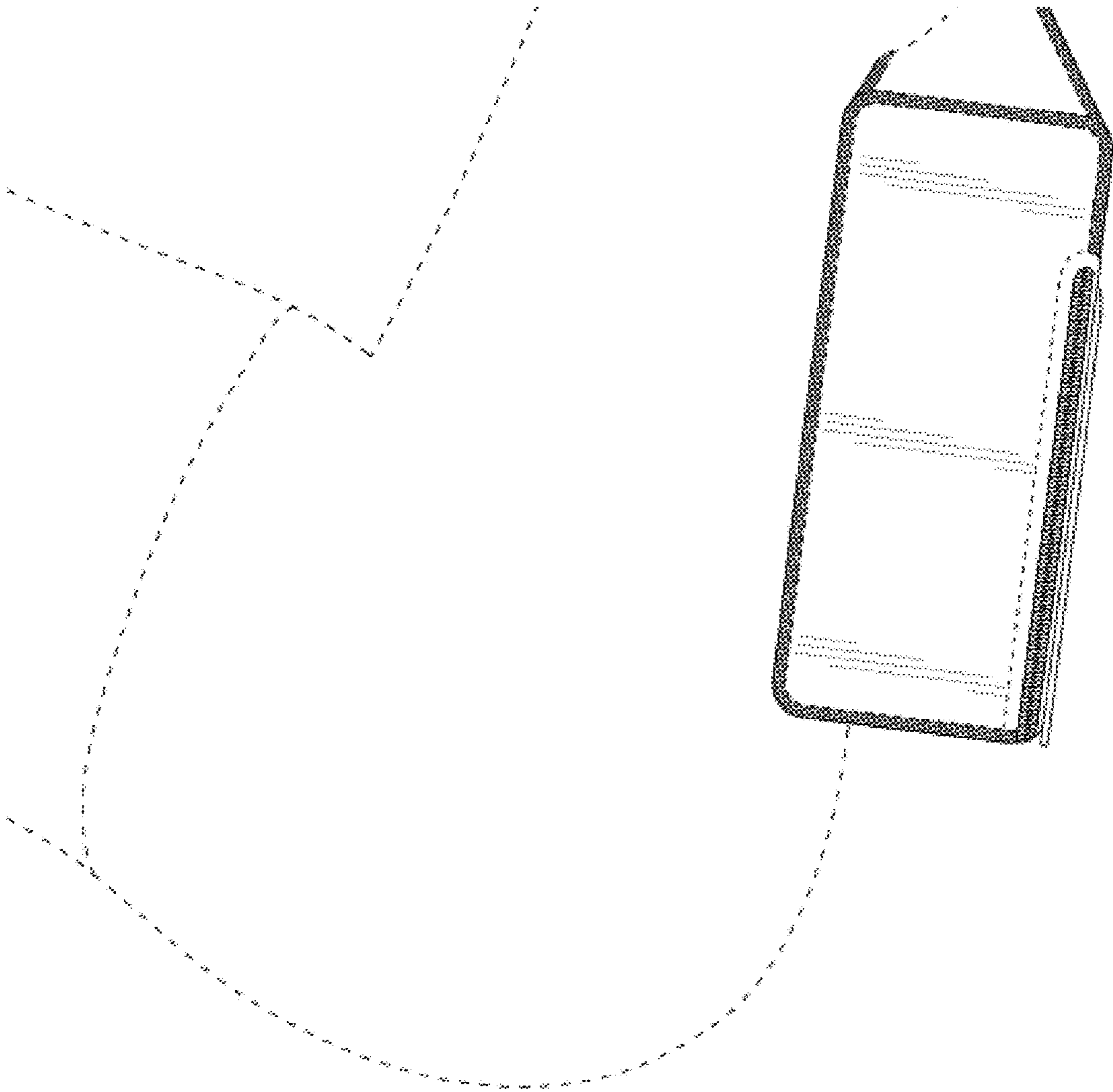

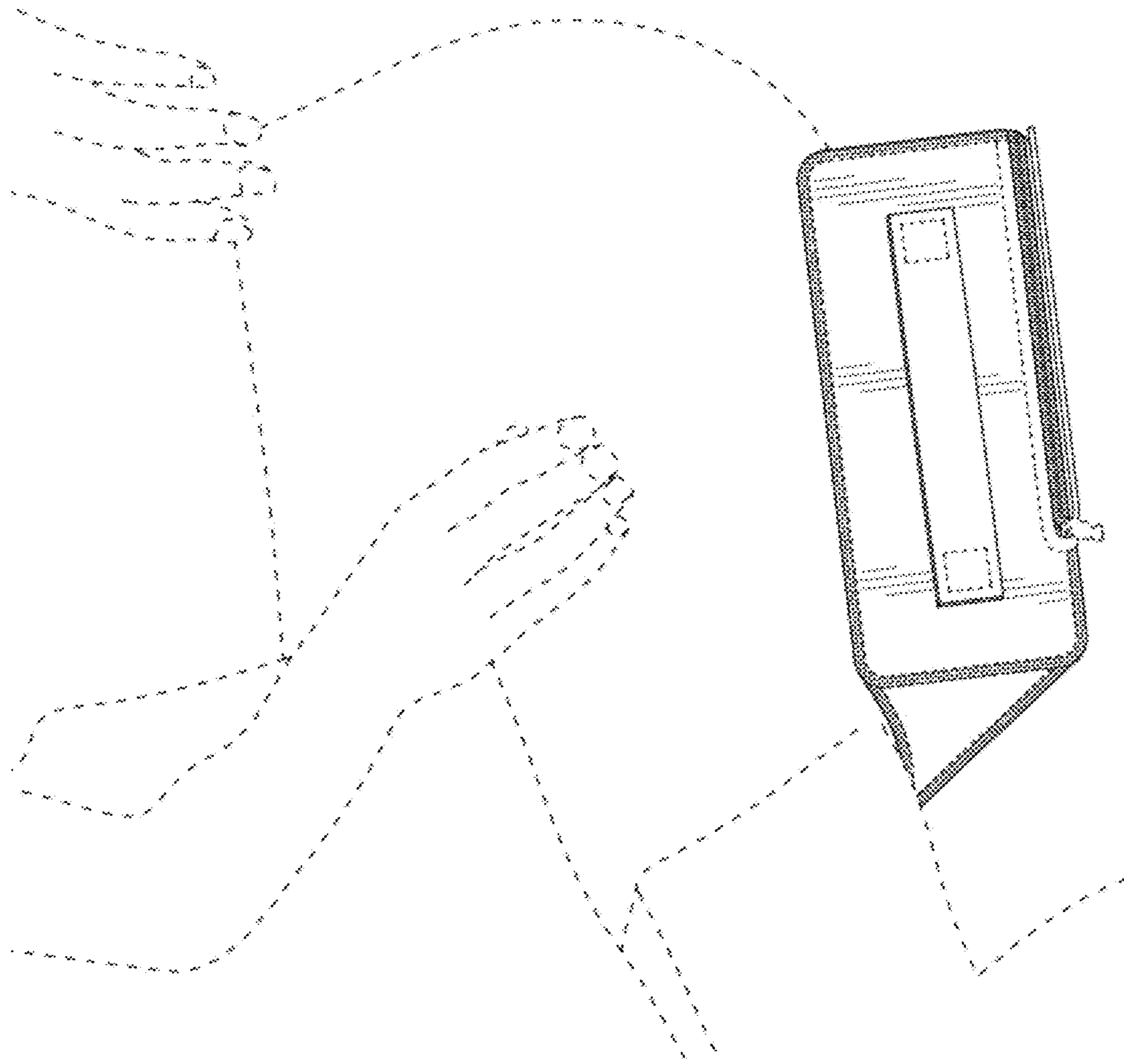

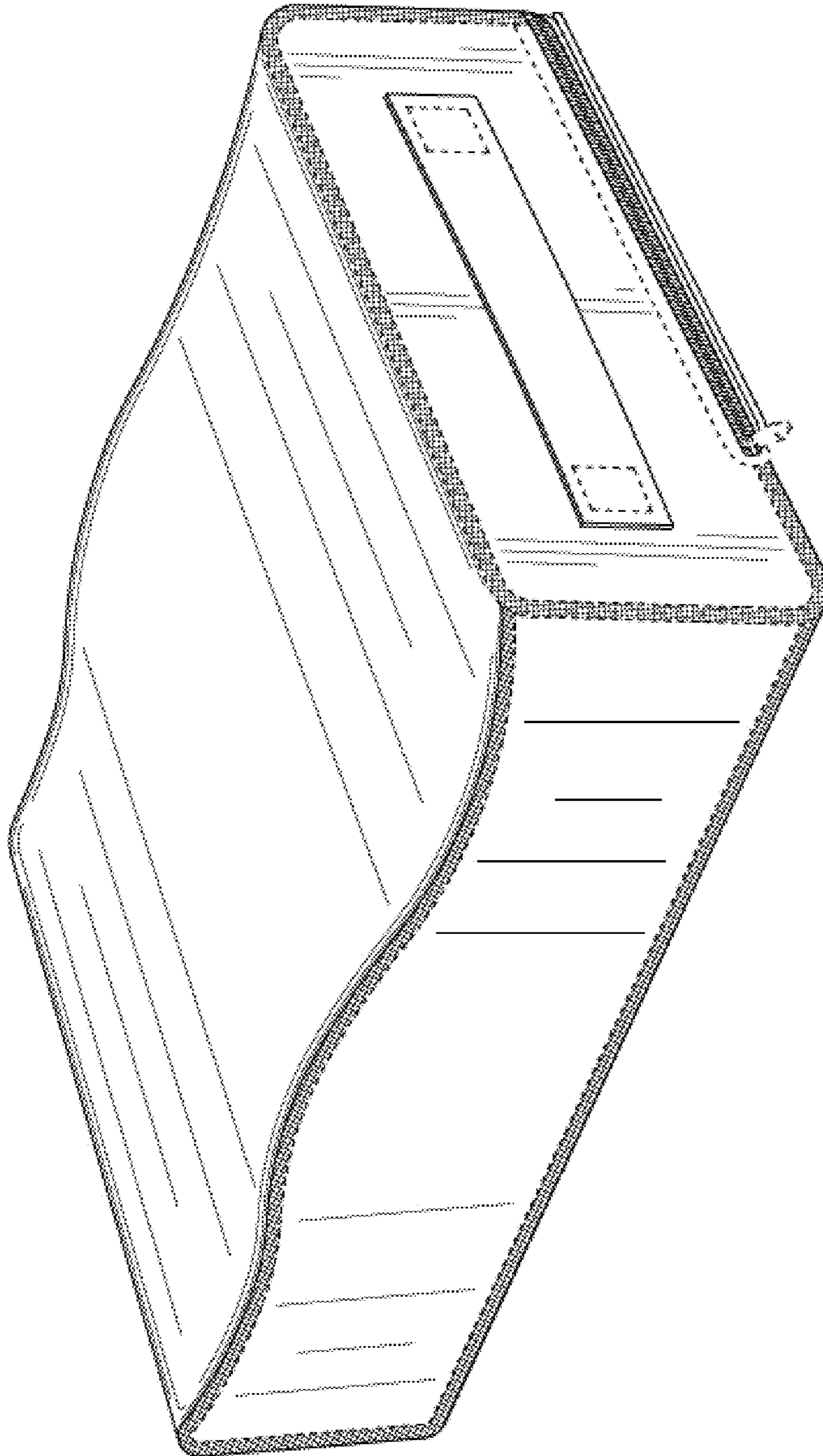
