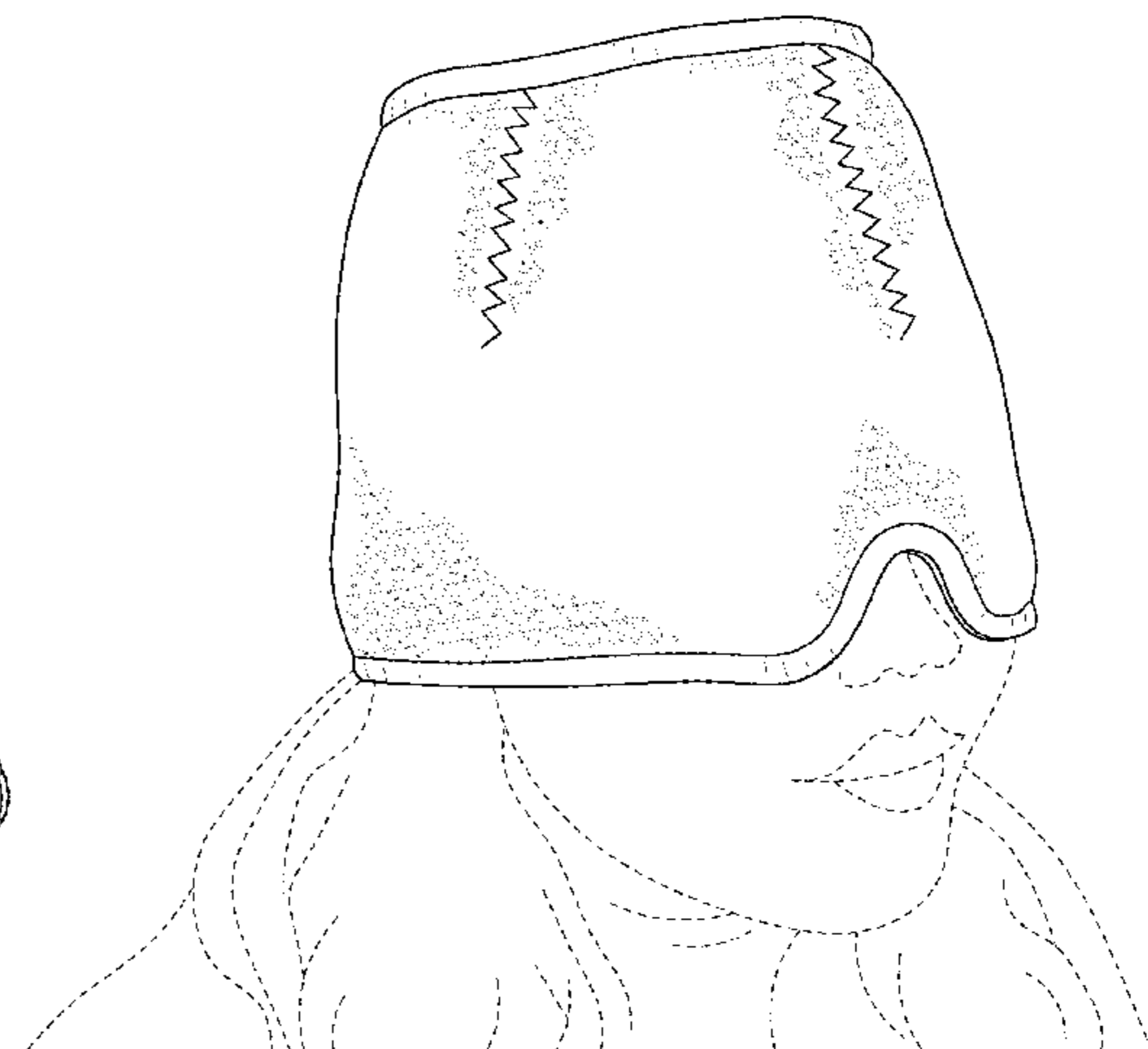
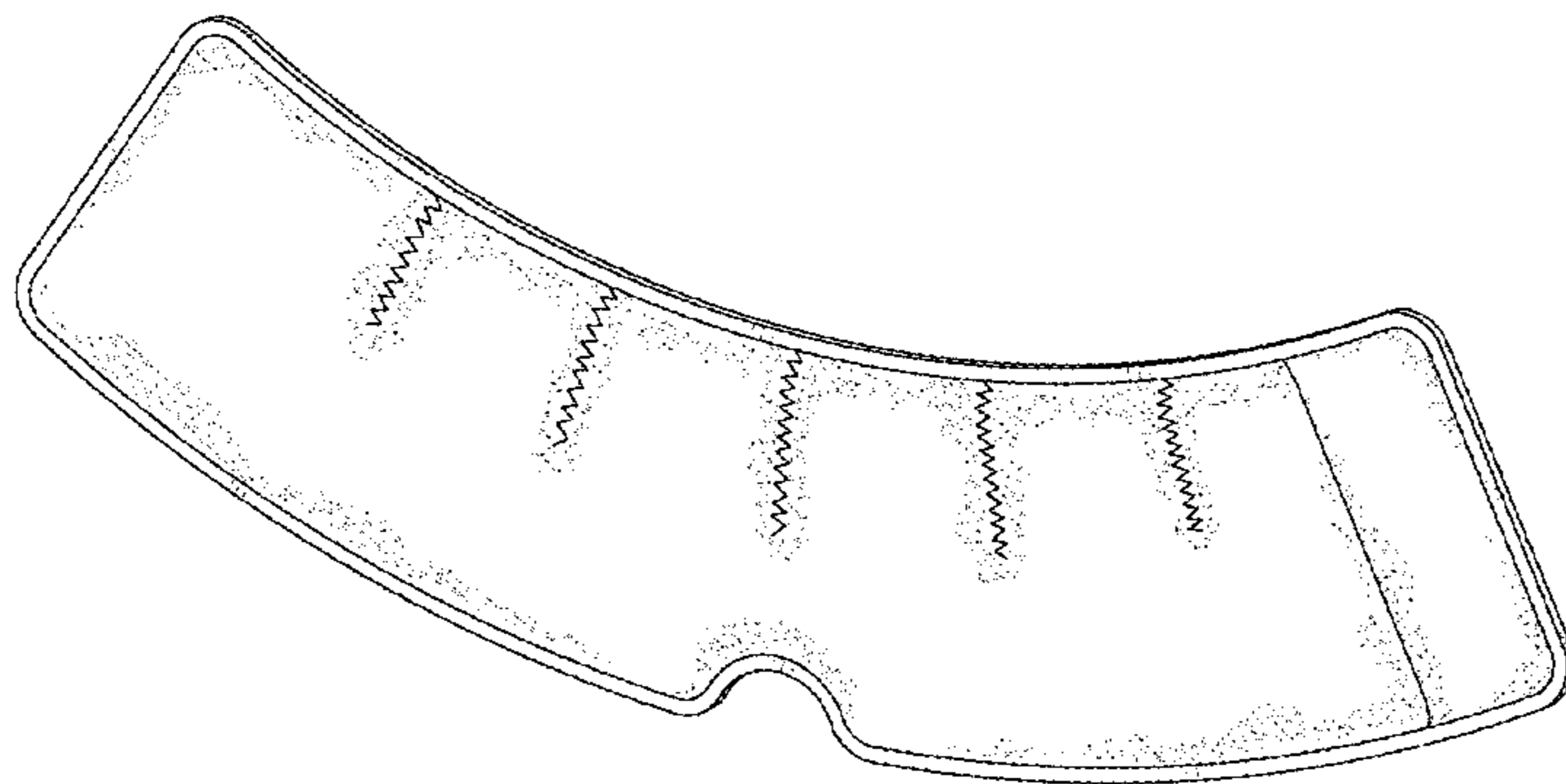
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a gel ice hat showing my new design;

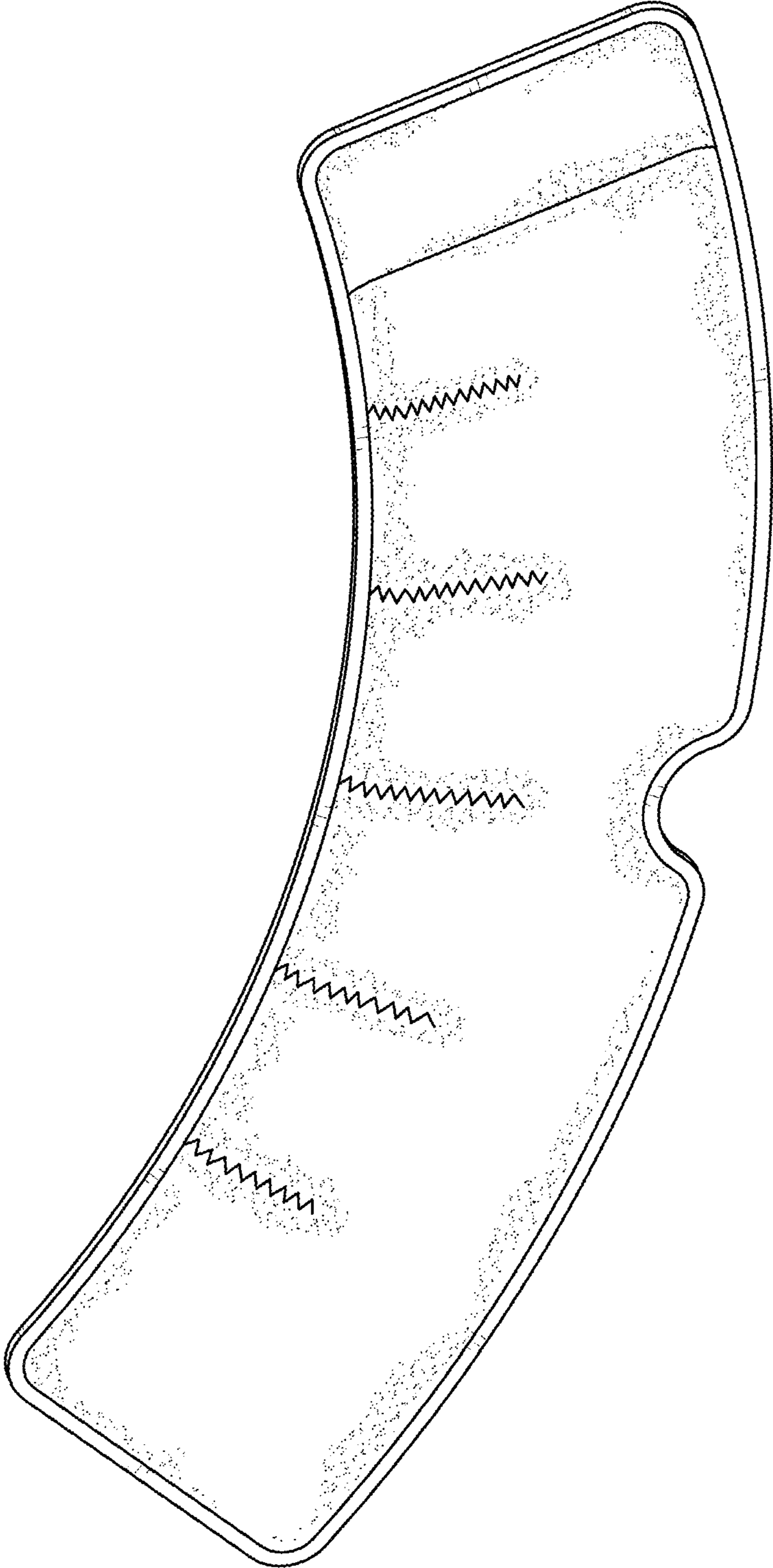

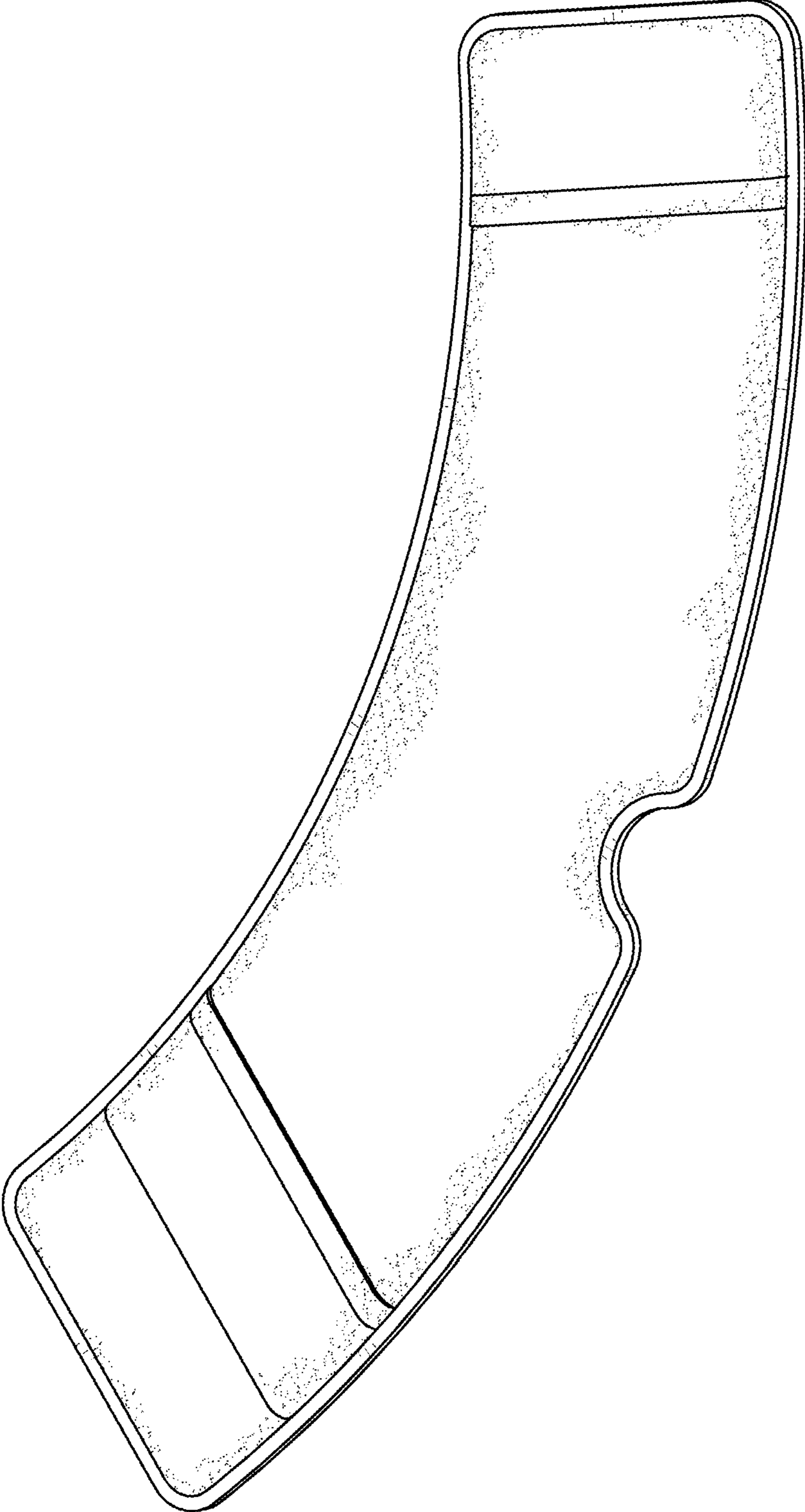

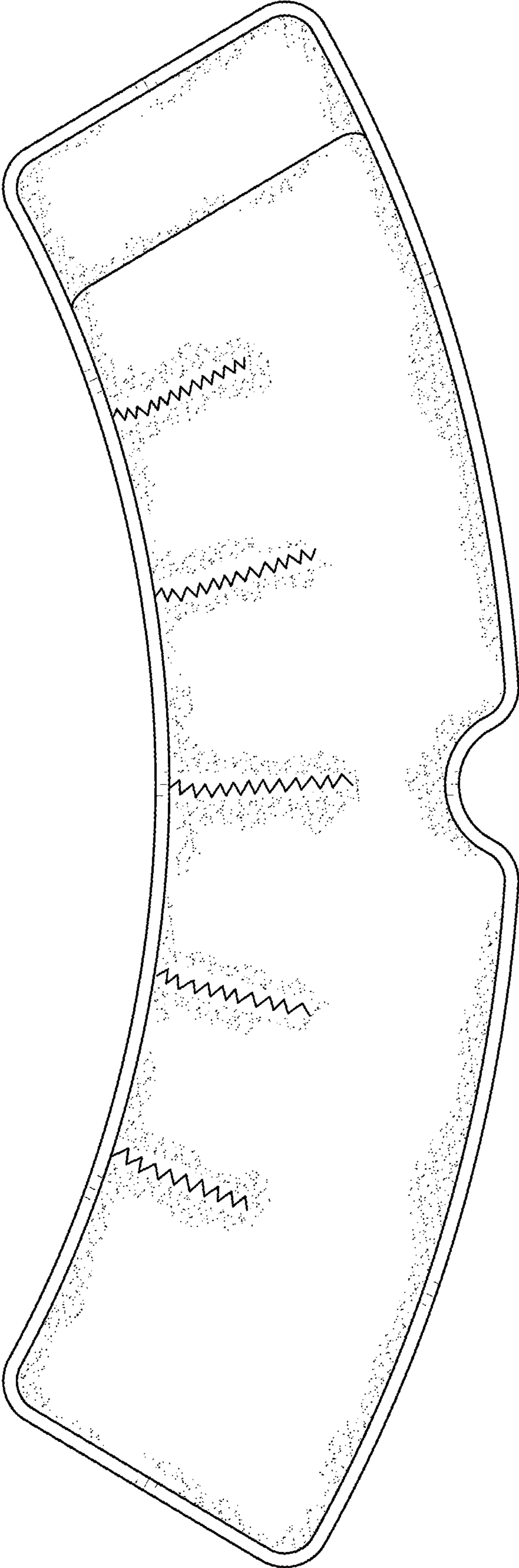

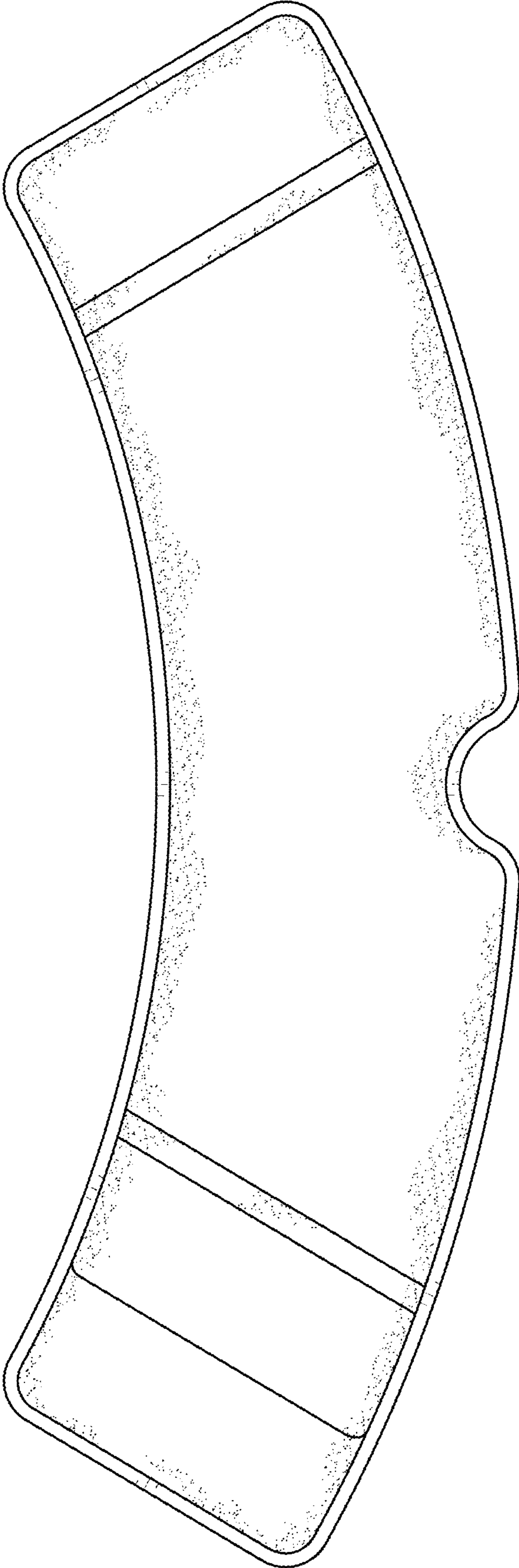

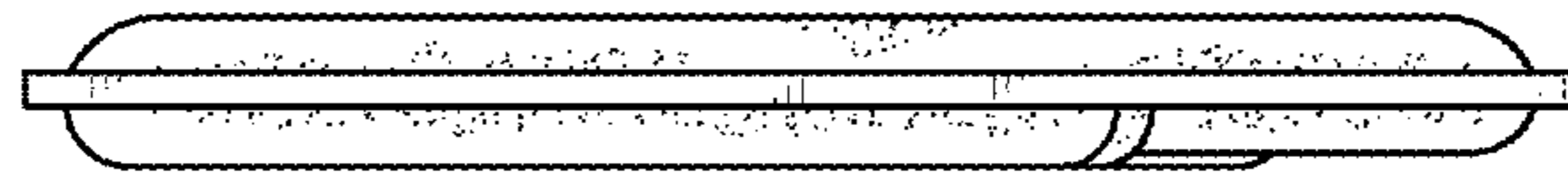

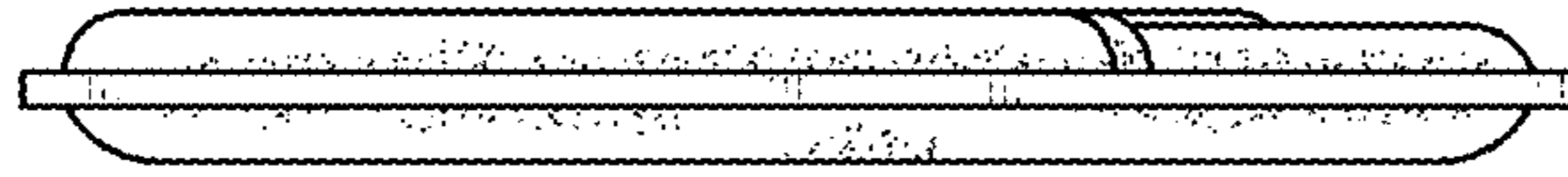

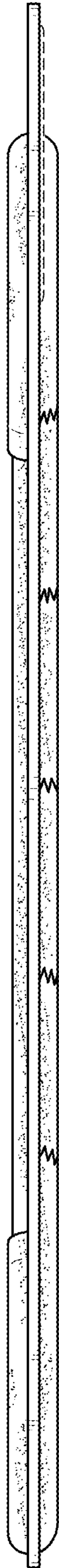

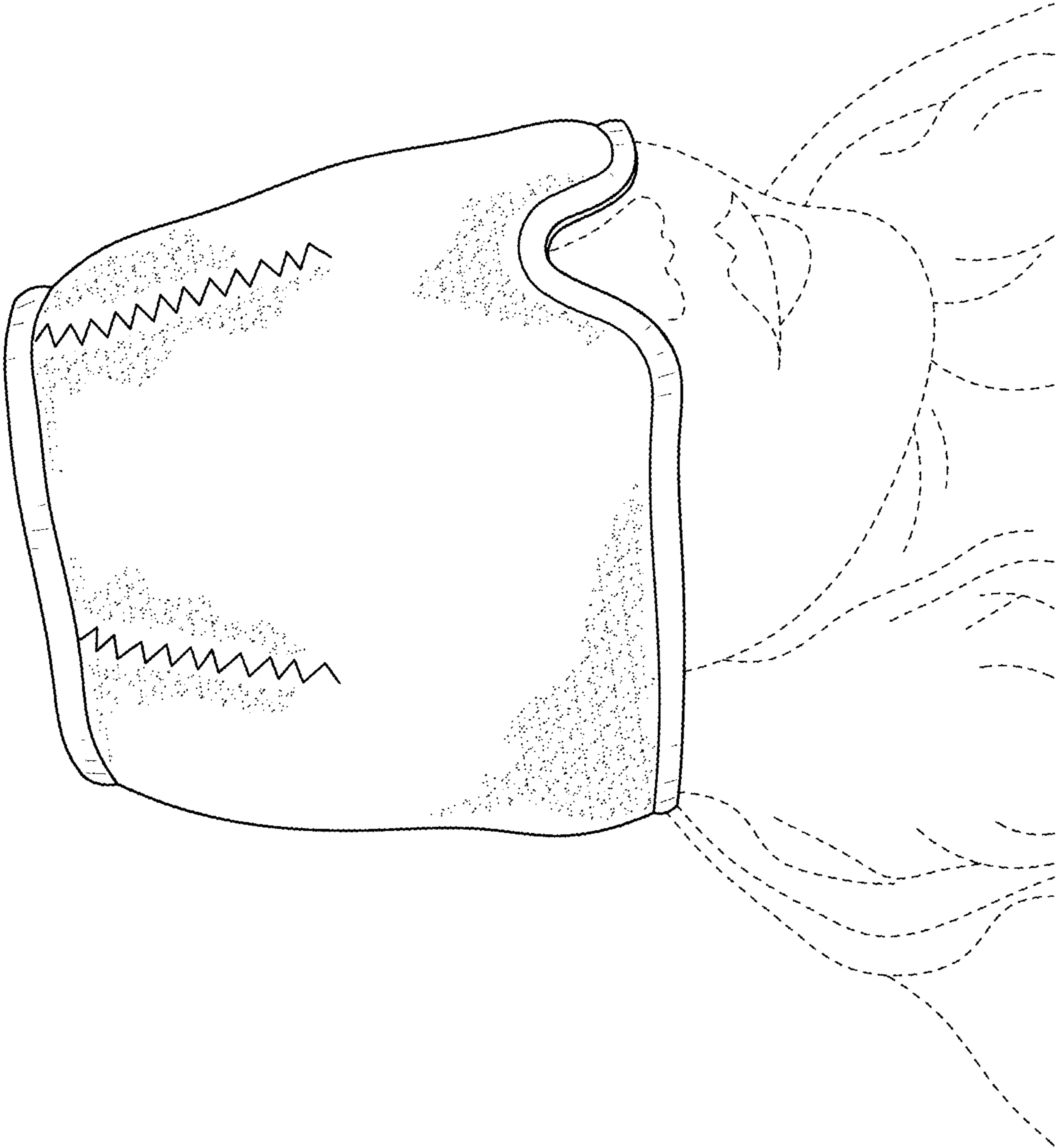
