(57) **CLAIM**

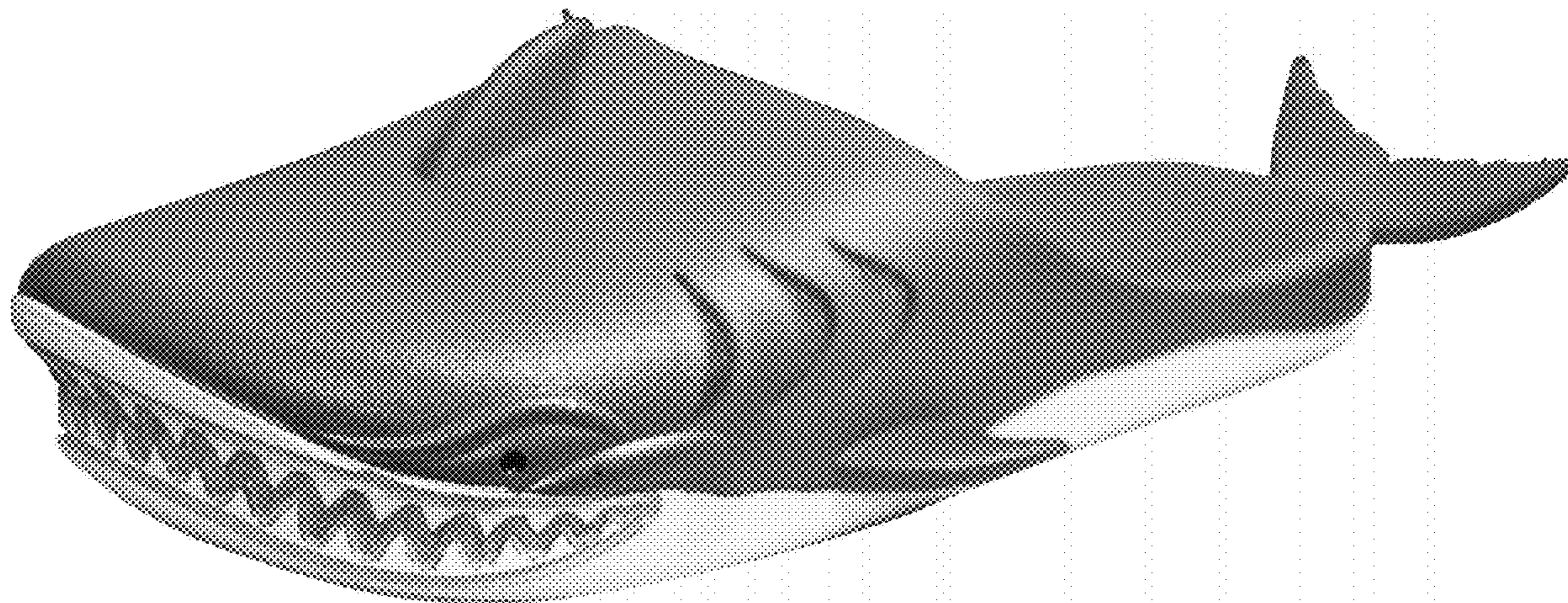
The ornamental design for a shark slippers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left, and top perspective view of a shark slippers, showing my design.  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a rear elevation view thereof.  
FIG. 4 is a left side elevation view thereof.  
FIG. 5 is a right side elevation view thereof.  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
A shark slipper for a right foot is a mirror image of the shark slipper for a left foot as shown in FIGS. 1 to 7.

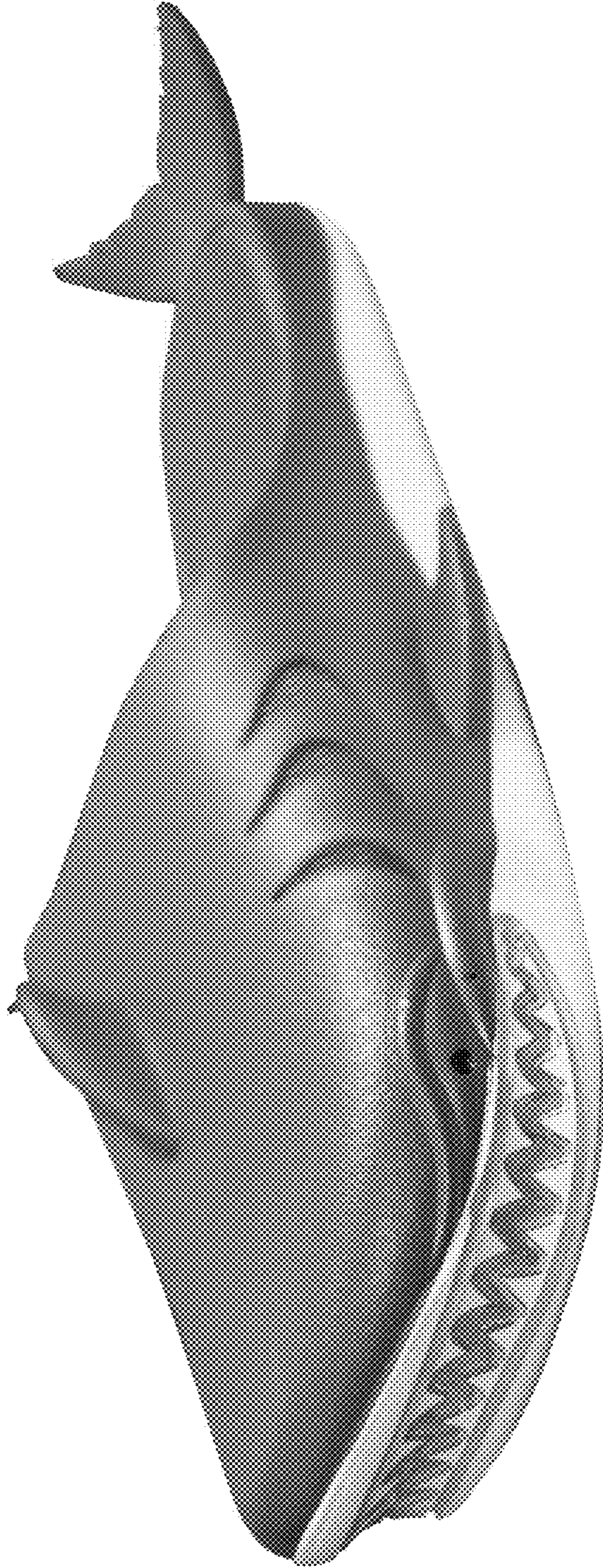

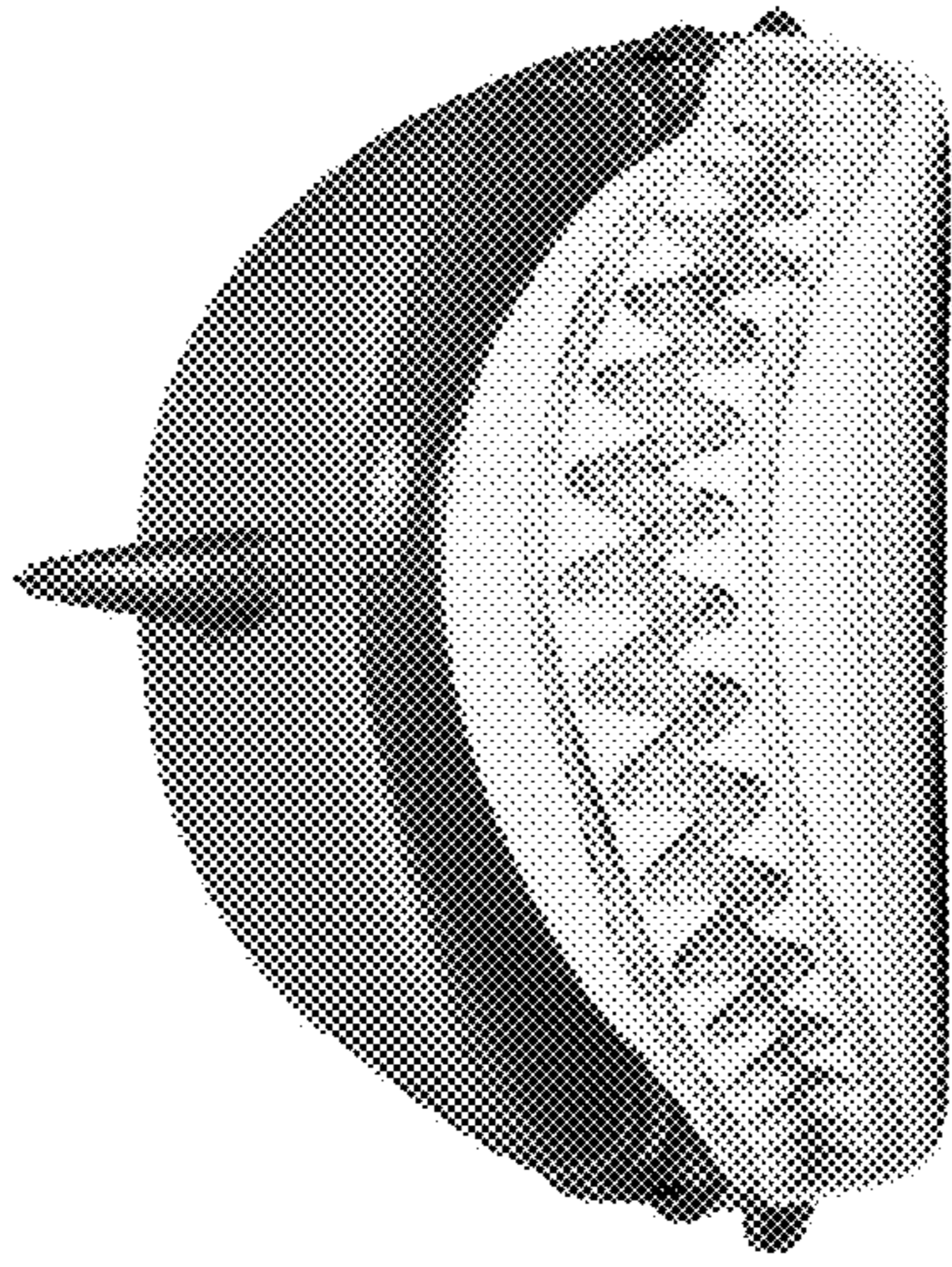

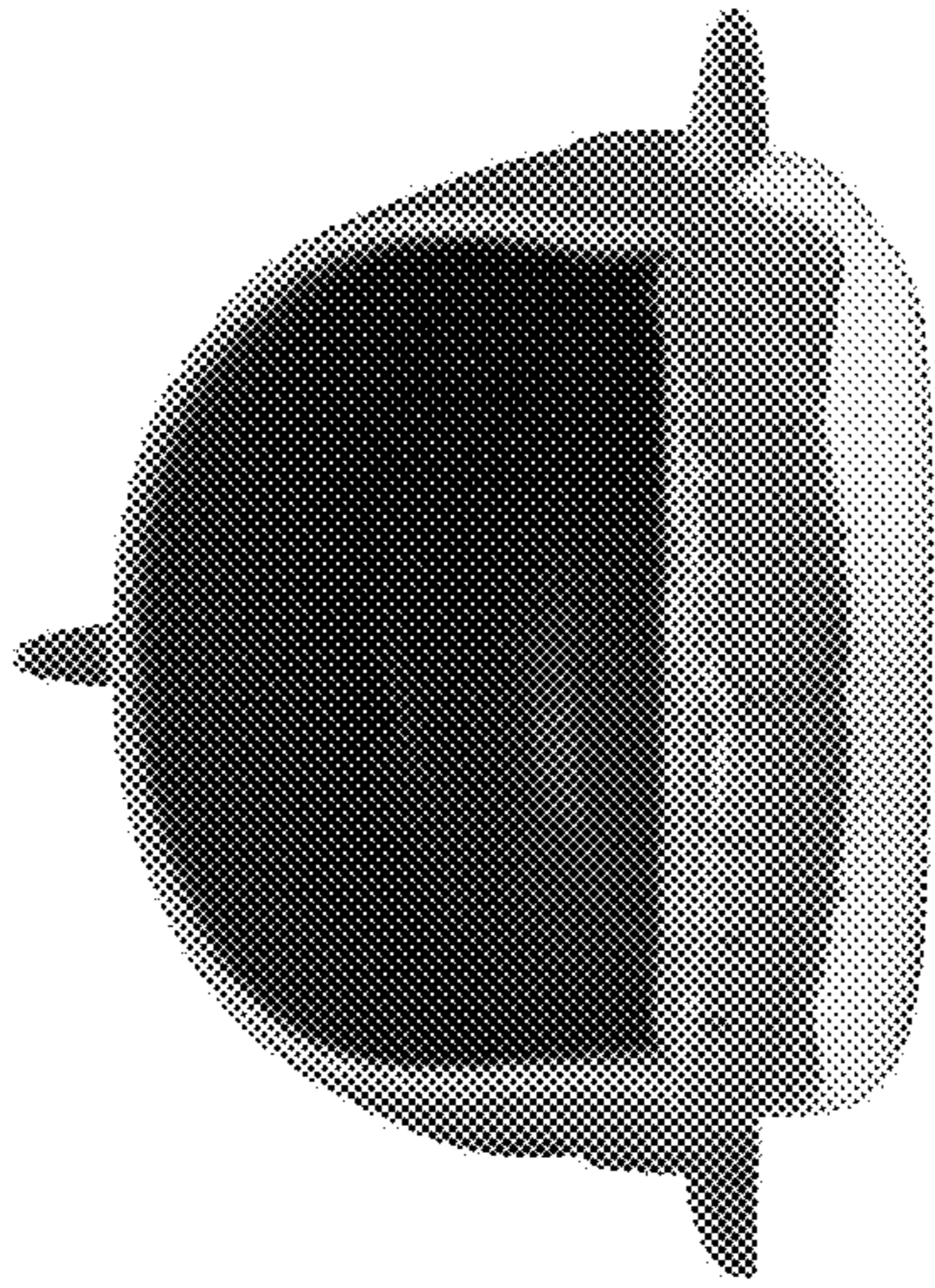

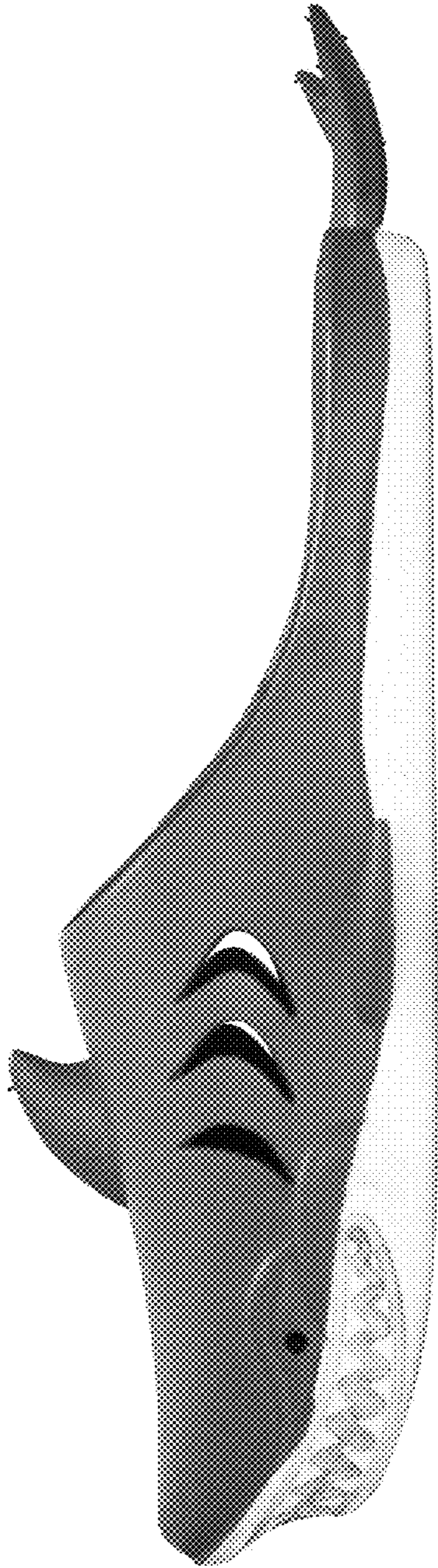

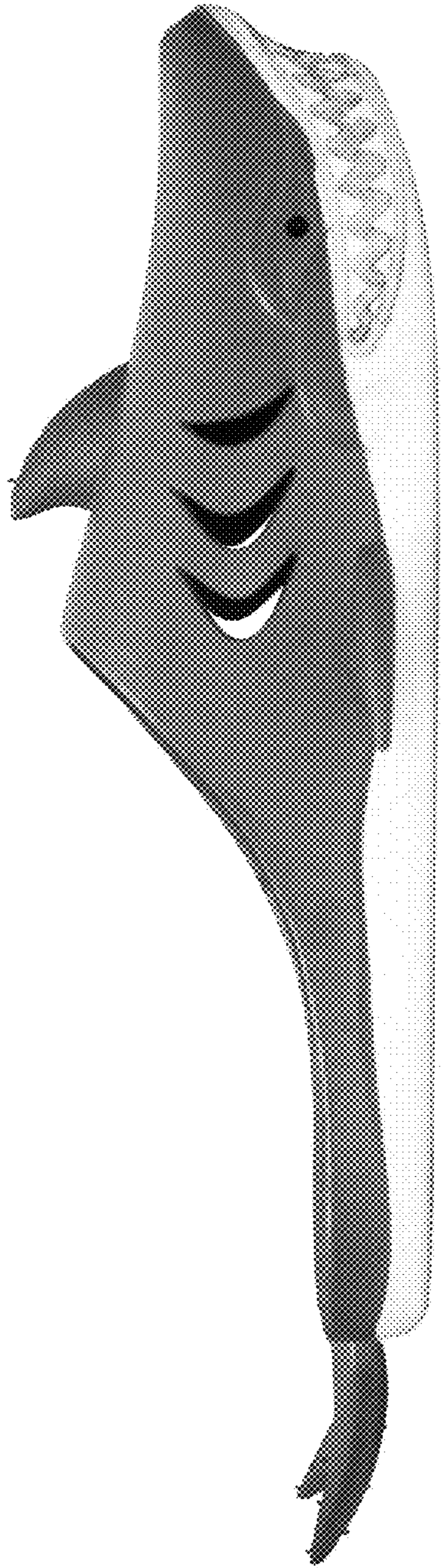

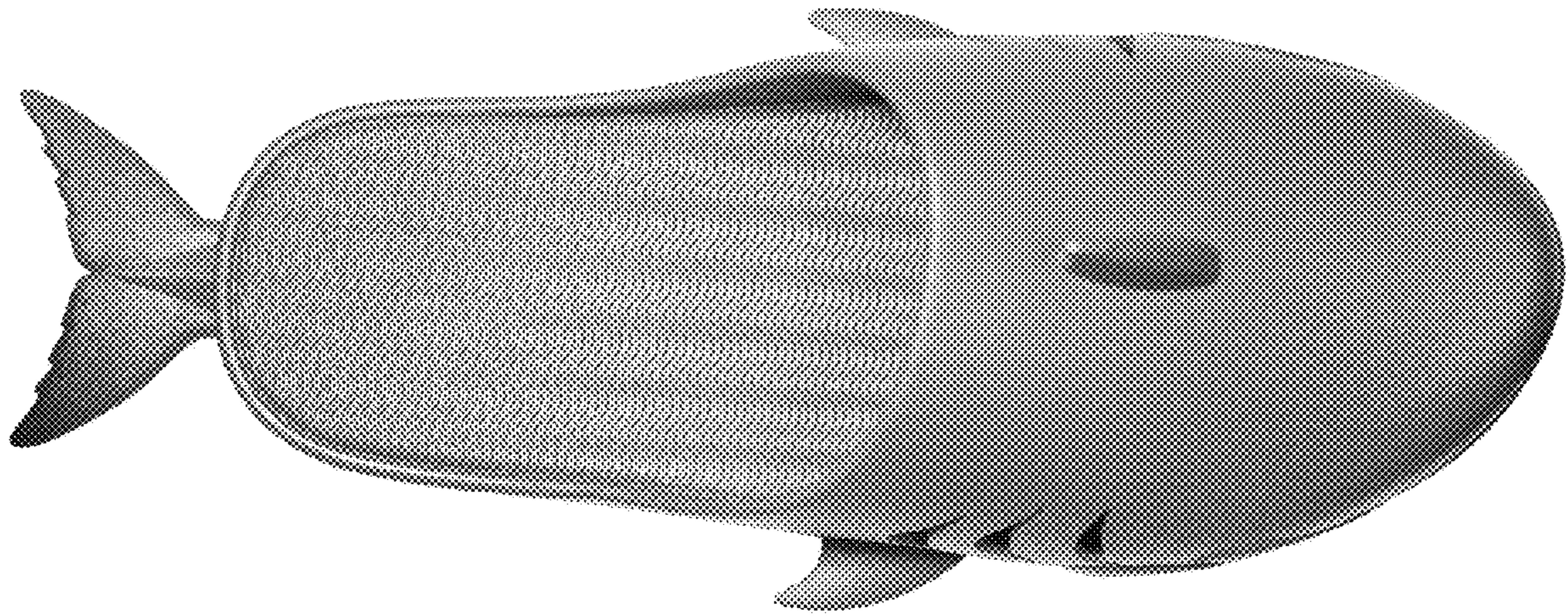

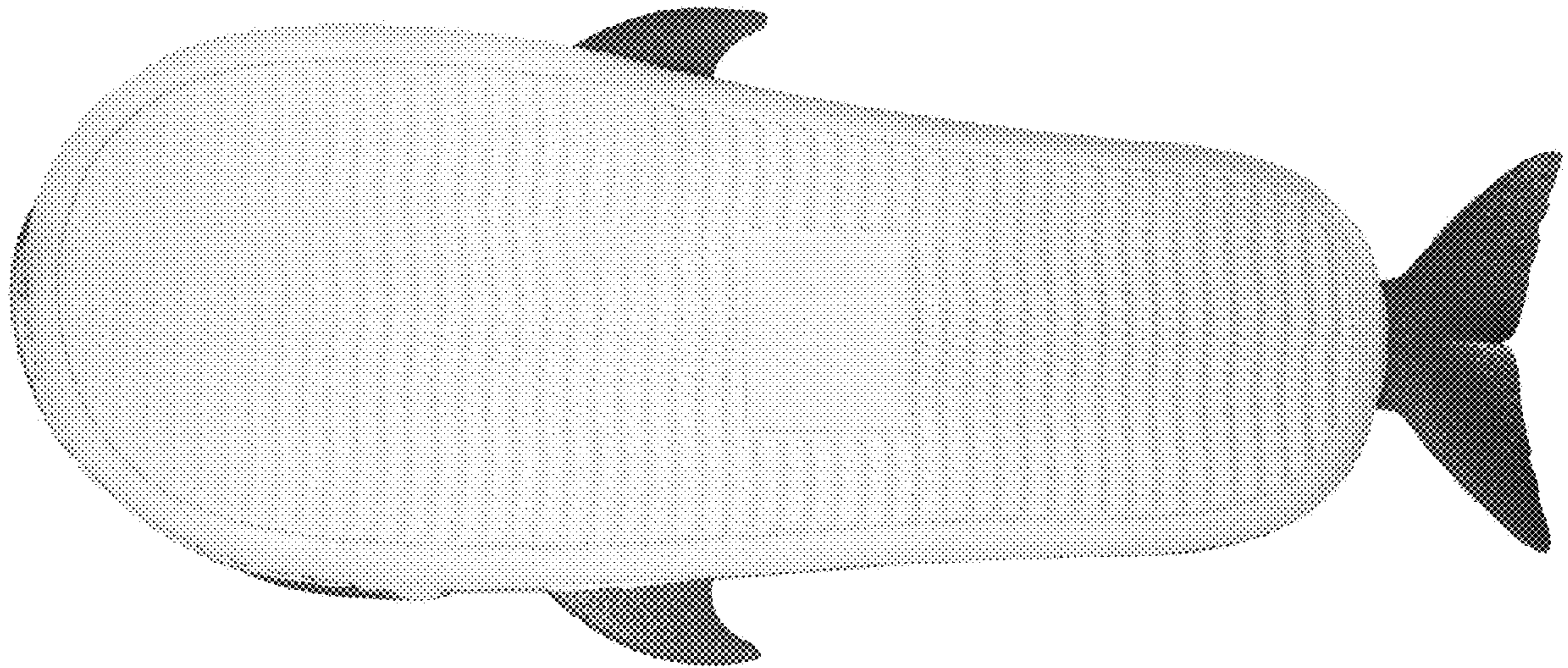
