The ornamental design for a shoe, as shown and described.

DESCRIPTION

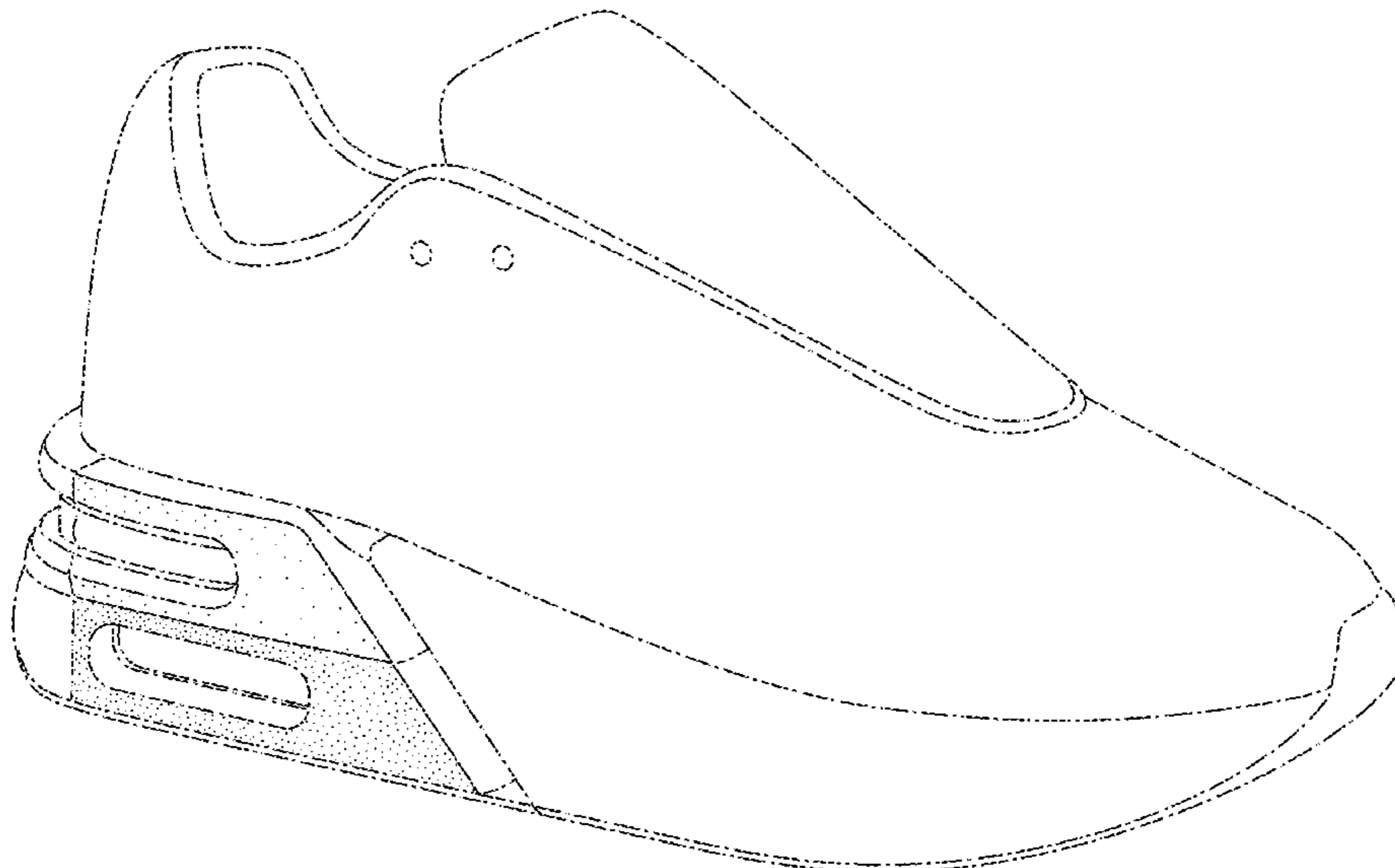
FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken lines showing the racetrack shaped regions form no part of the claimed design. The broken lines immediately adjacent to the rear of the shaded area define the bounds of the claimed design and form no part thereof. The contrast in stipple shading density between the upper and lower sections represents a contrast in appearance only and does not represent any particular color, material, texture, or finish. The broken lines depicting the remainder of the shoe form no part of the claimed design.

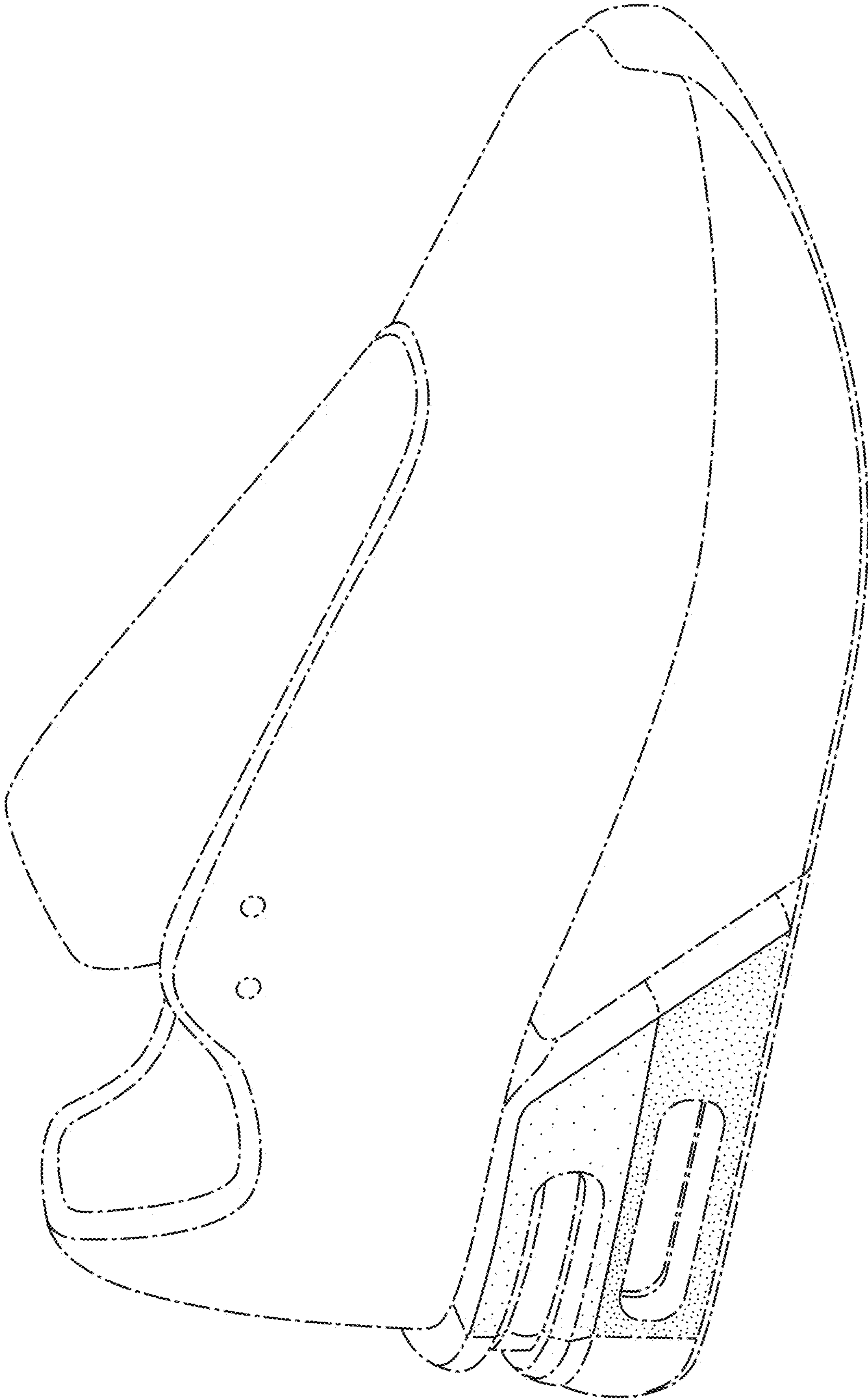

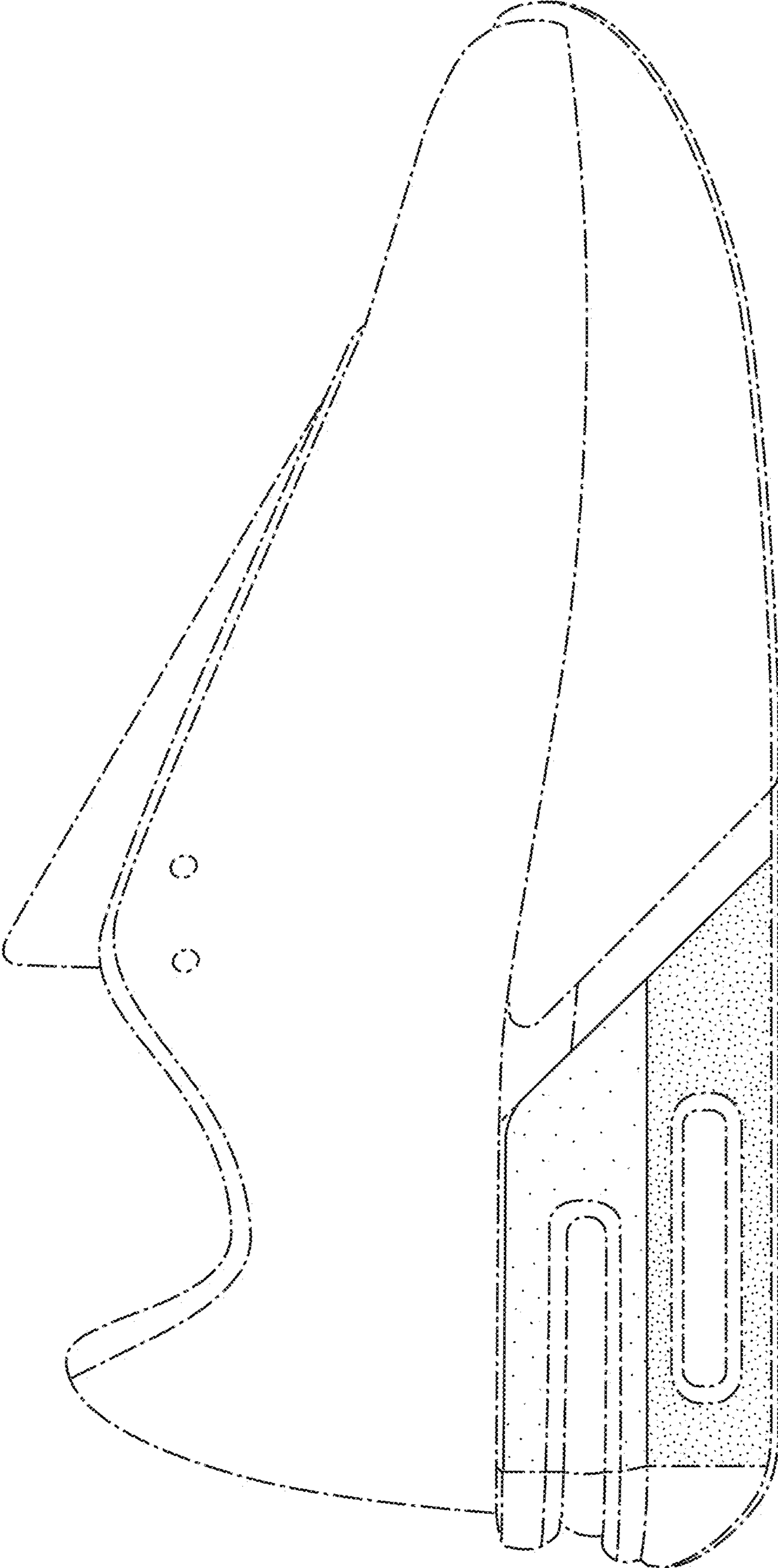

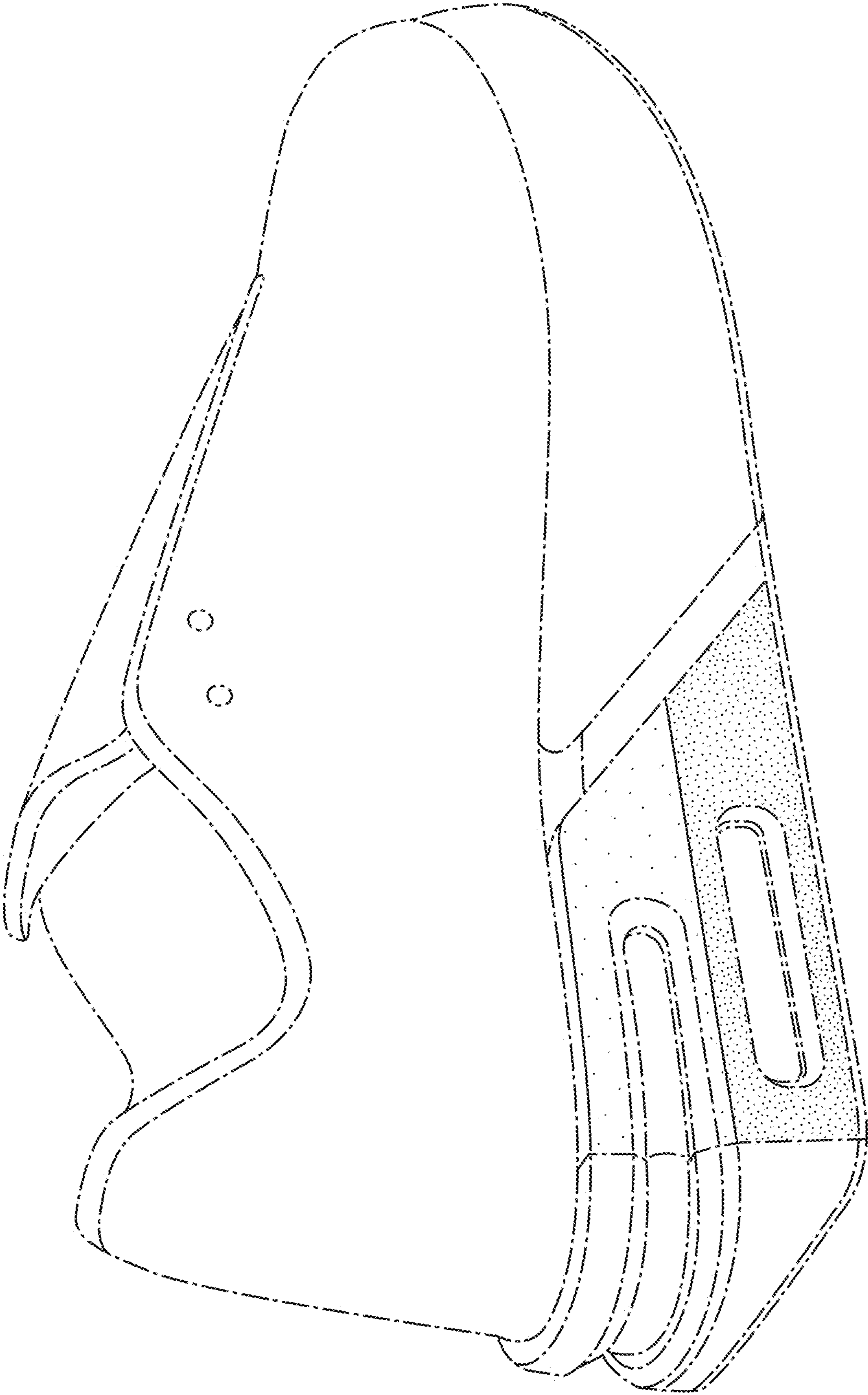
