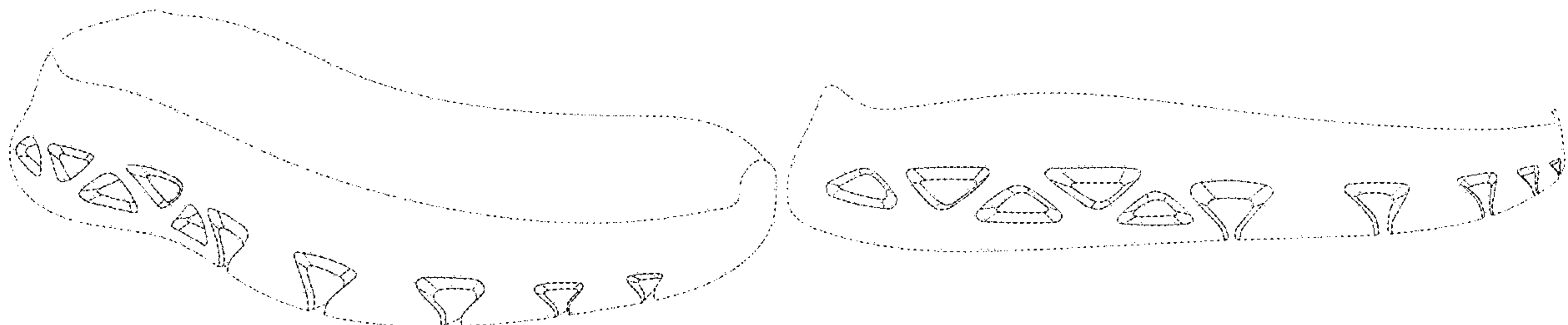
(57) **CLAIM**

The ornamental design for a shoe midsole periphery, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe midsole periphery in accordance with my new design; and, FIG. 2 is a side elevation view thereof. The broken lines shown in the drawings represent portions of the shoe upper, midsole periphery and shoe that form no part of the claimed design. The surfaces devoid of shading lines are not claimed.

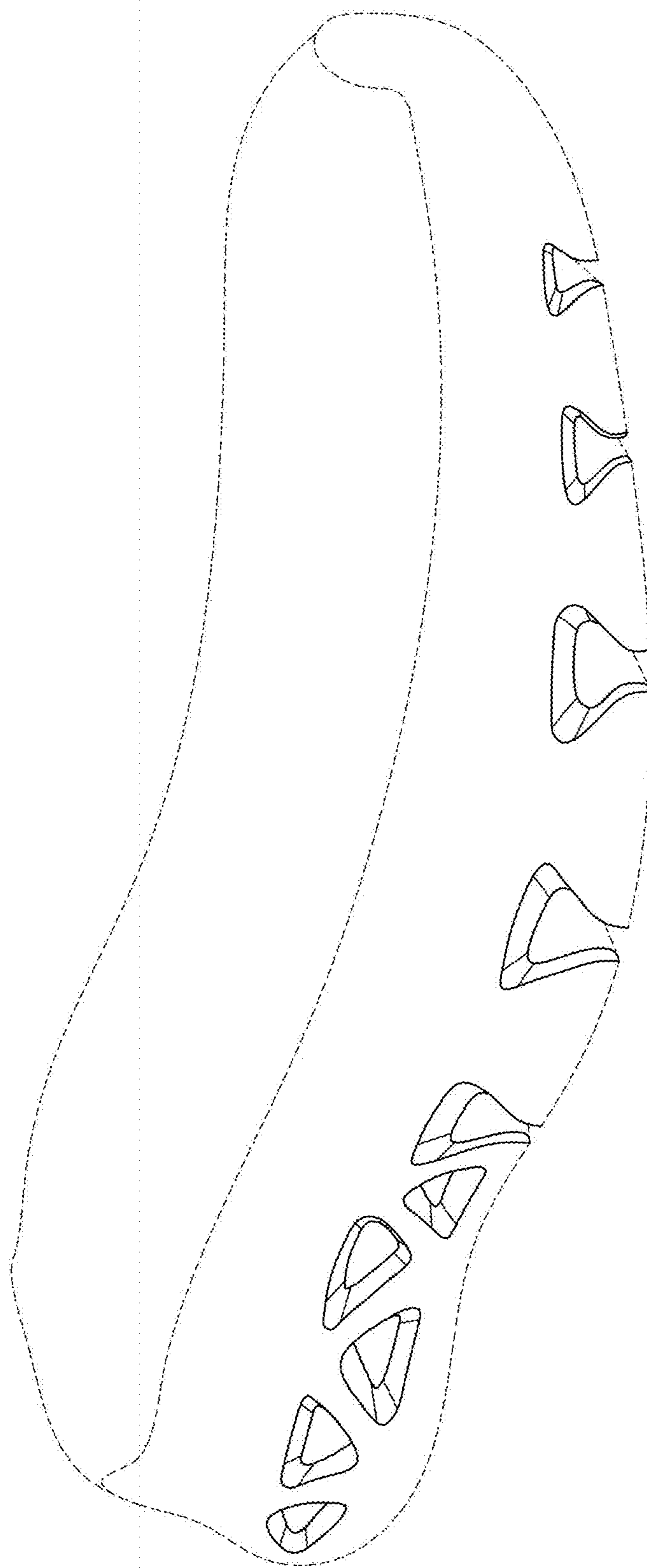

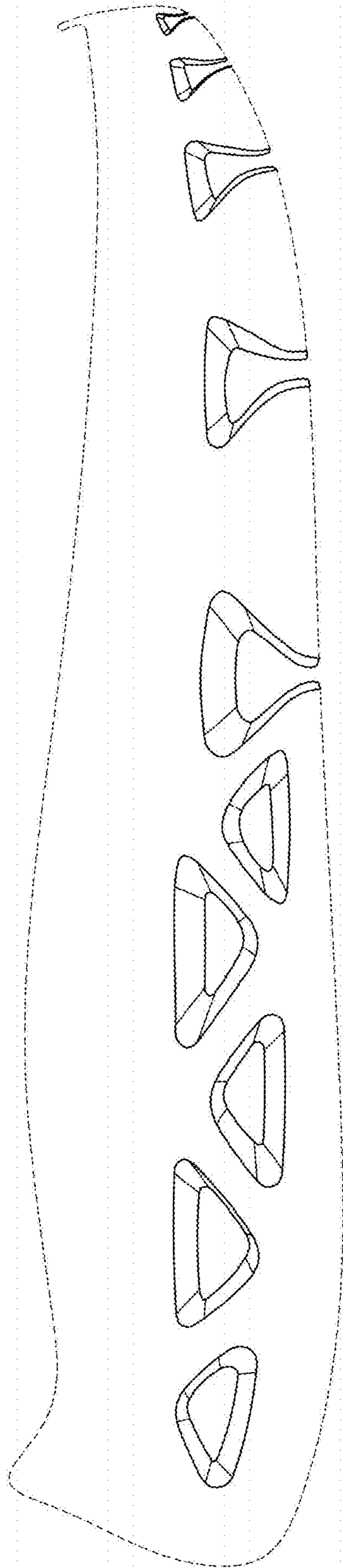
