FIG. 4 is a rear view of the blender cleaning brush.

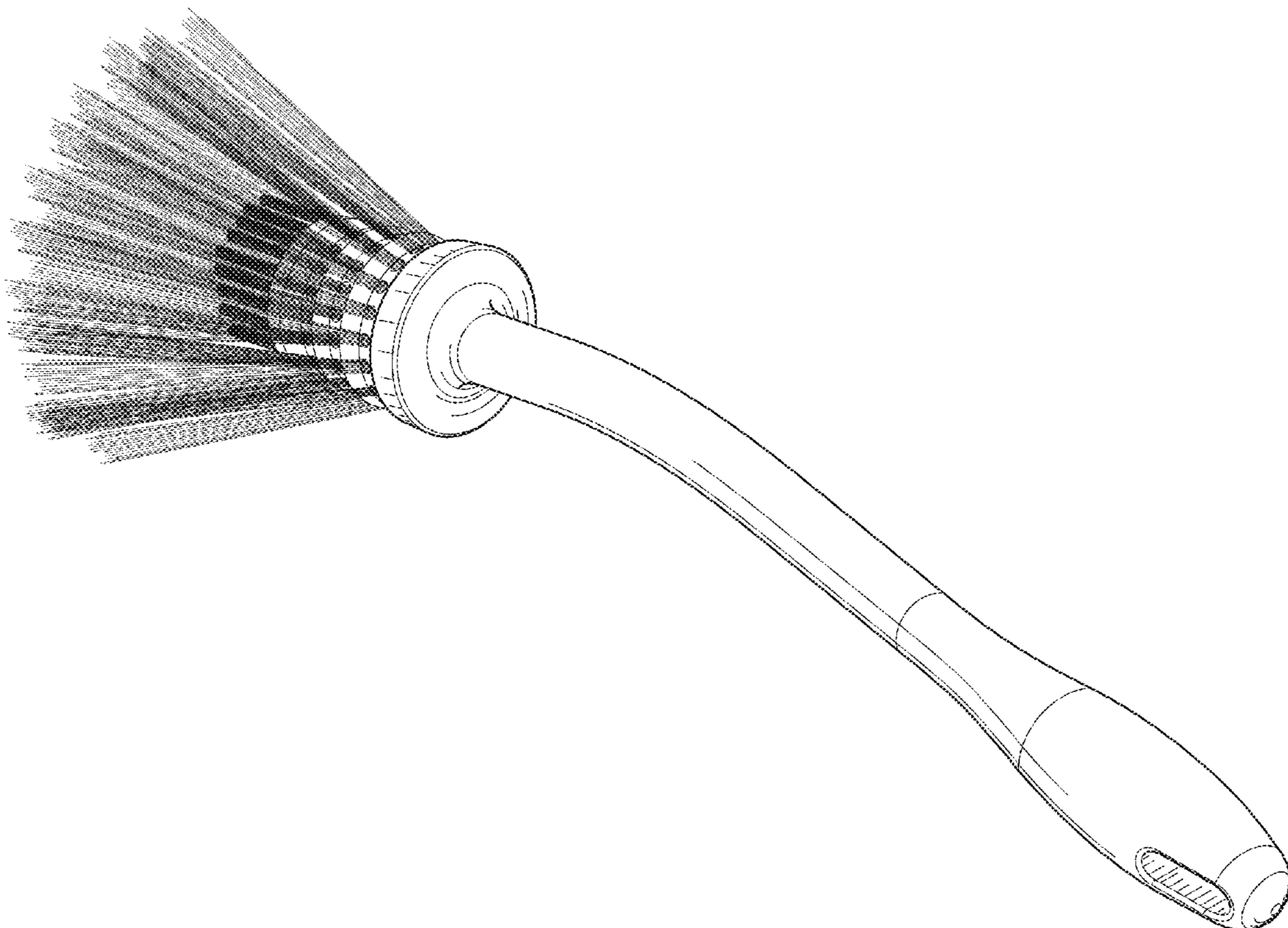
FIG. 5 is a first side view of the blender cleaning brush.

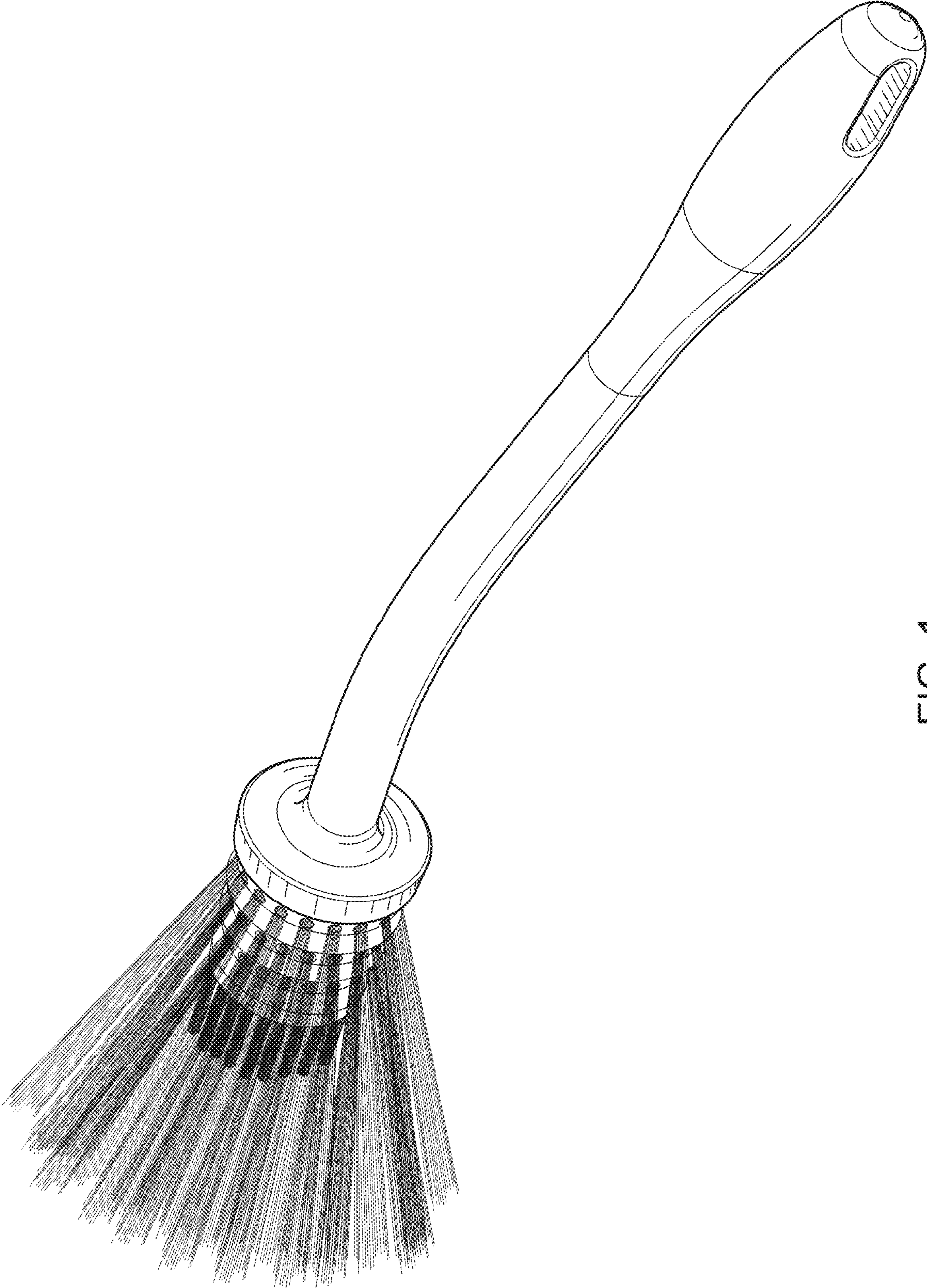

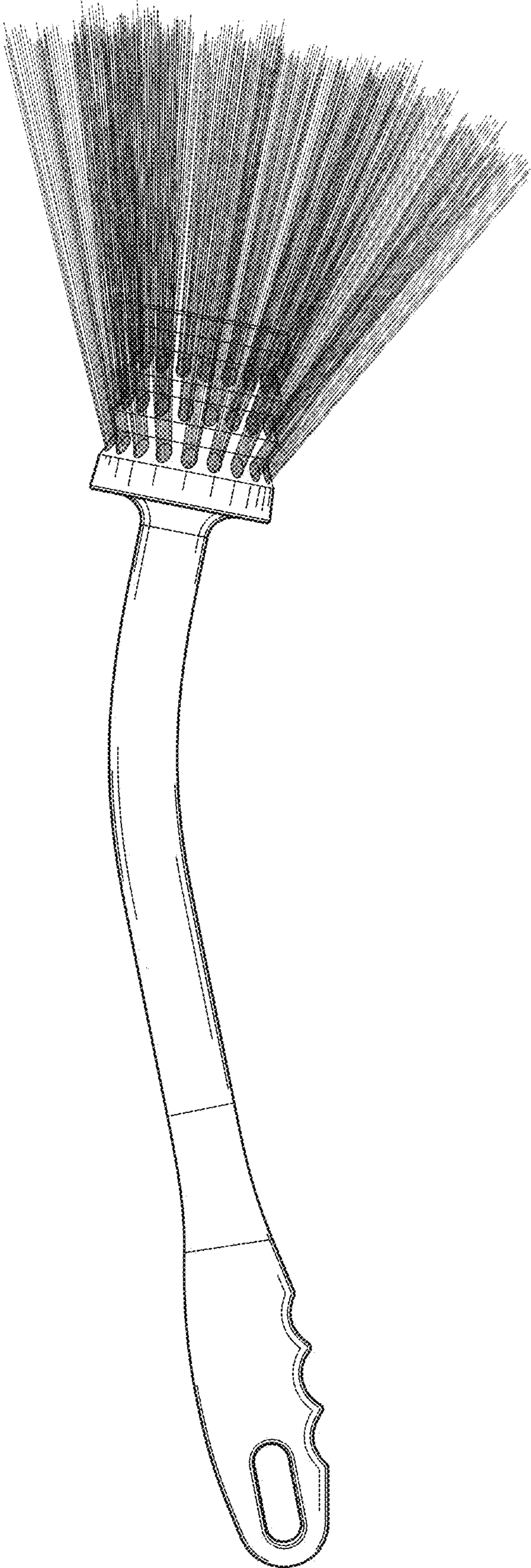

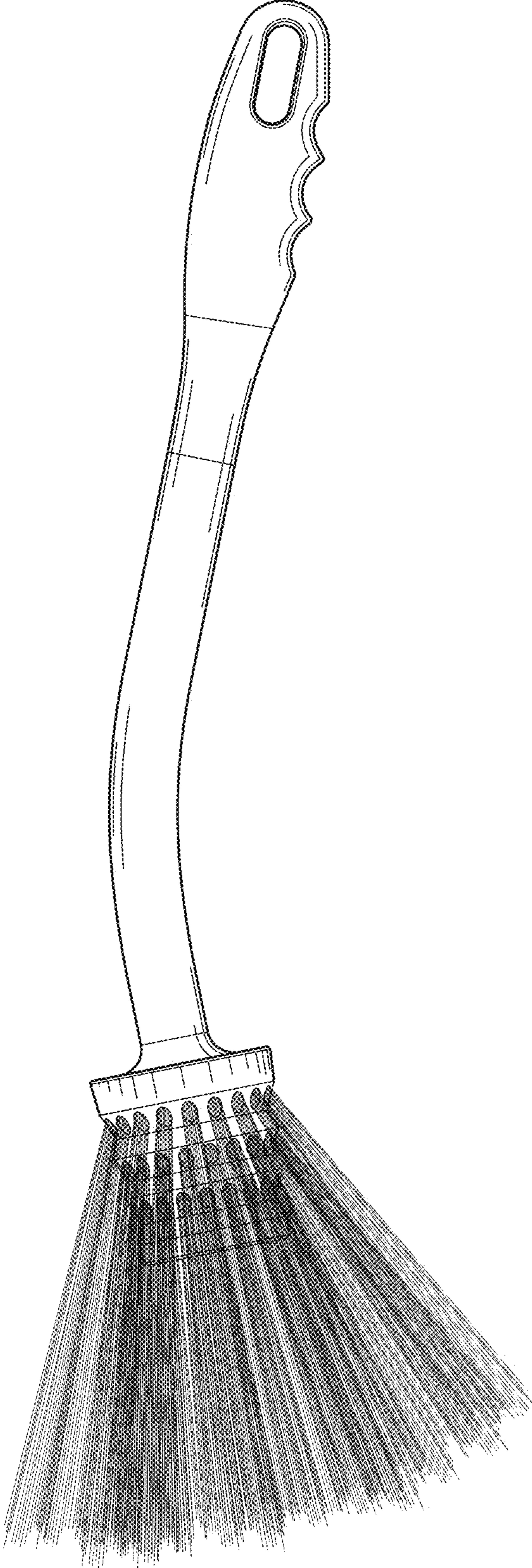

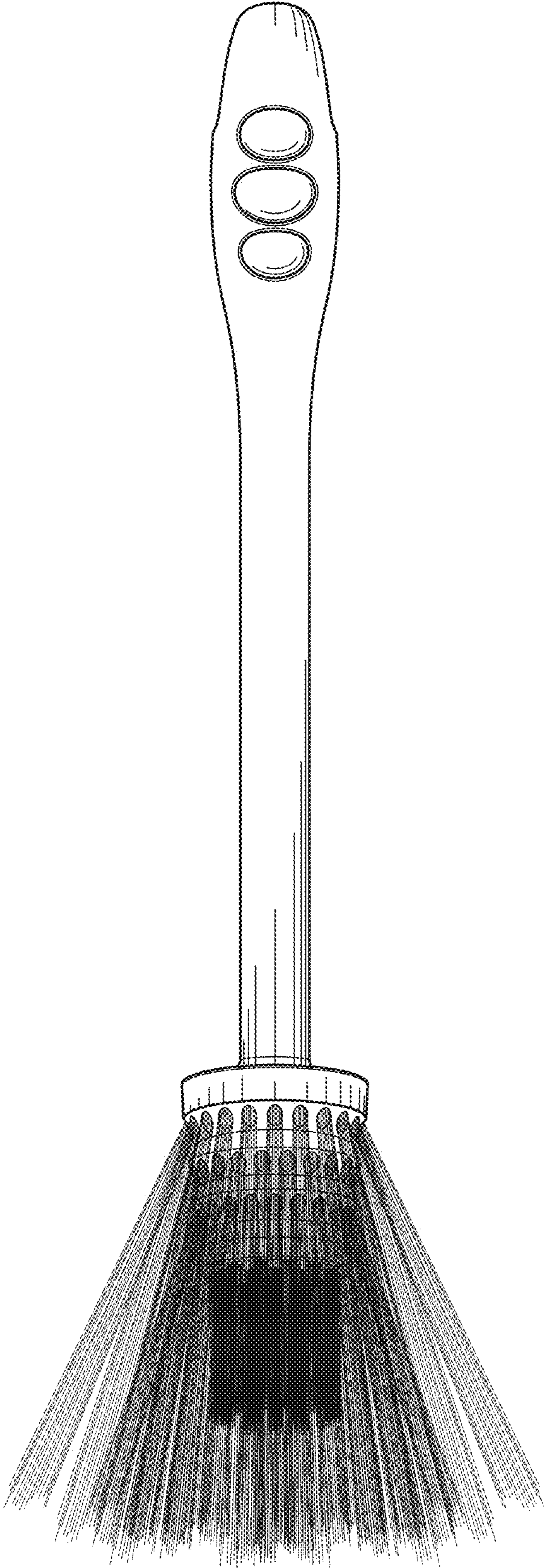

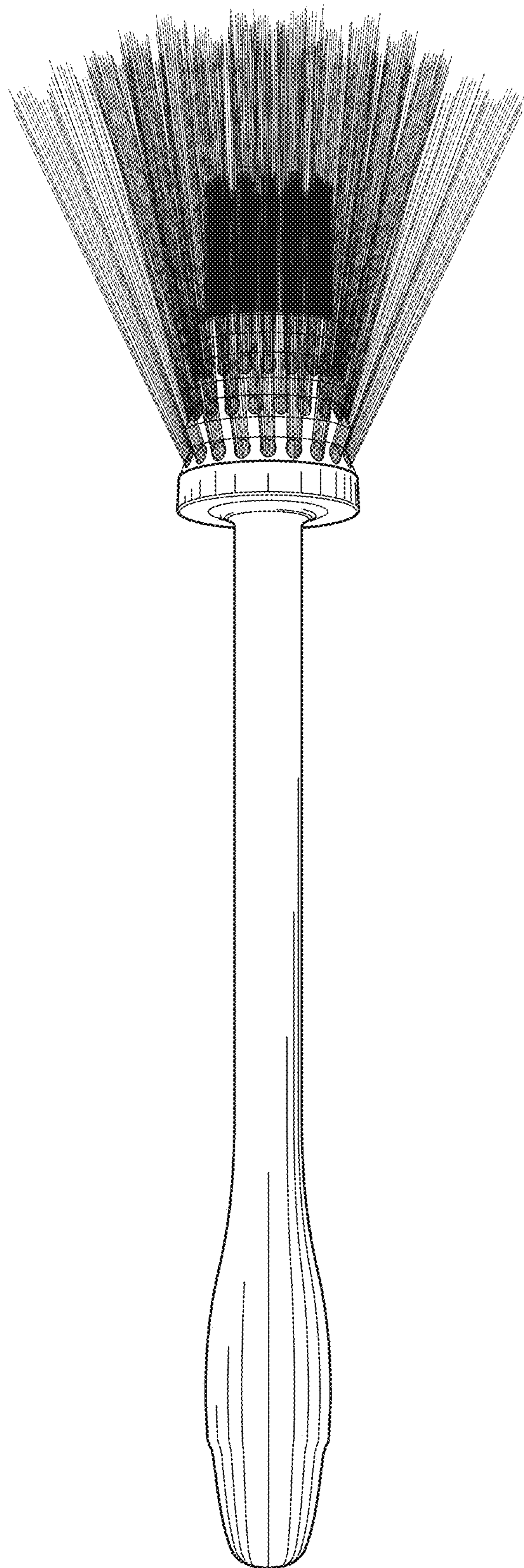

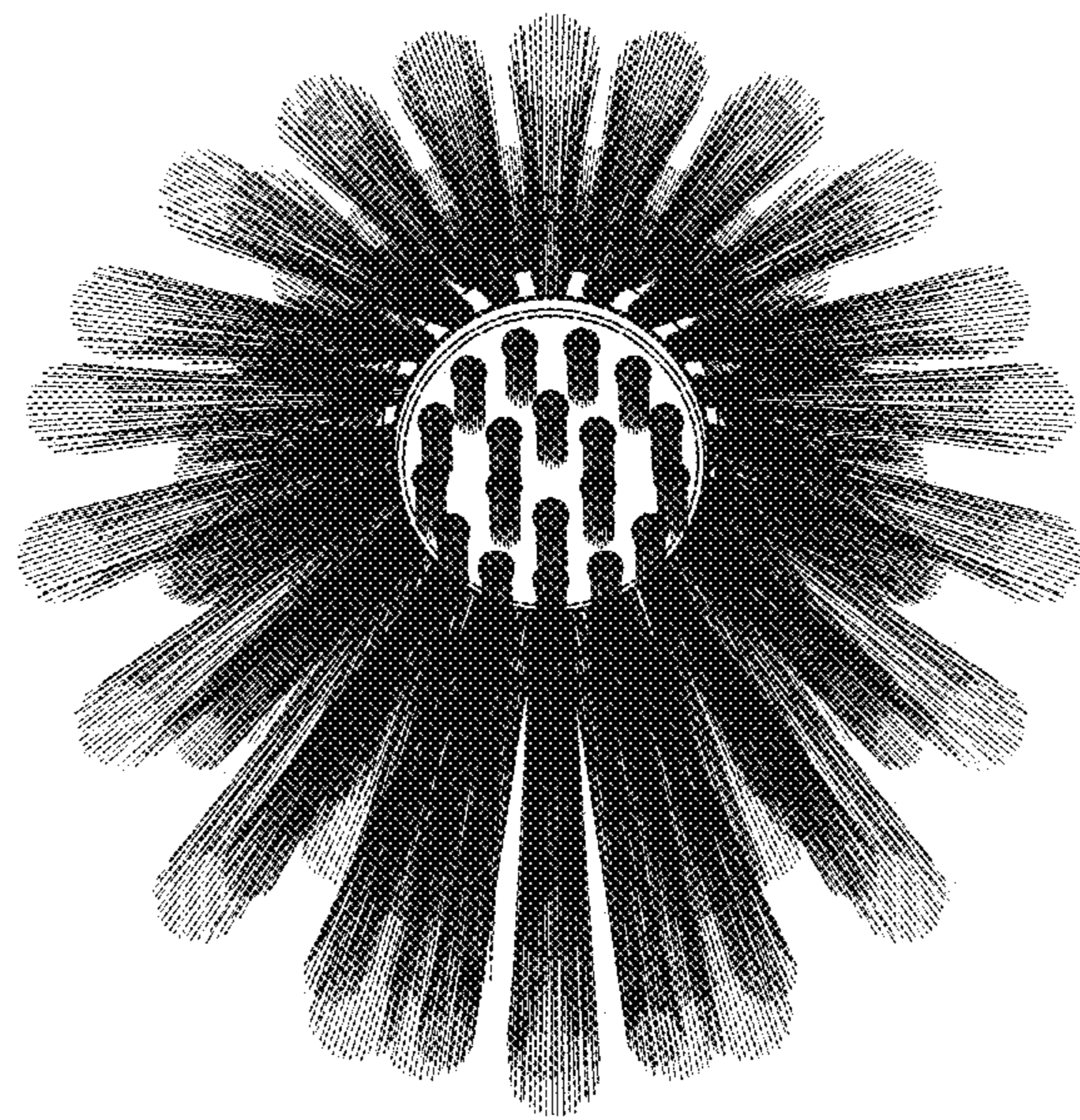

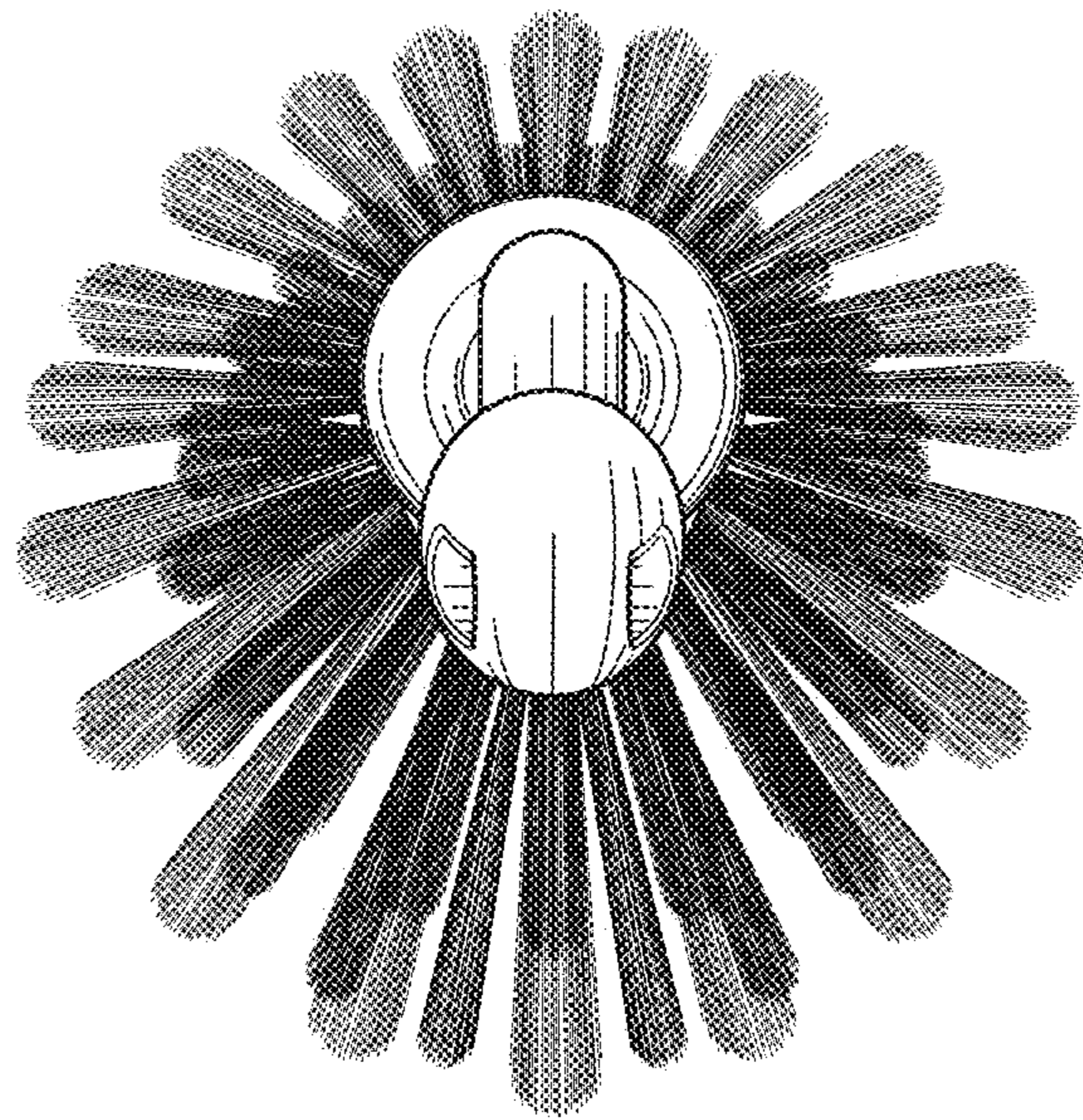
