(57) **CLAIM**

We claim the design for a cooking brick, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cooking brick showing the new design, shown in a closed configuration.

FIG. 2 is another perspective view thereof.

FIG. 3 is a perspective view of the cooking brick shown in an open configuration.

FIG. 4 is a top perspective view thereof.

FIG. 5 is a top perspective view of the cooking brick shown in the open configuration, with the top and bottom portions shown separately to show aspects of the design that are not visible when combined.

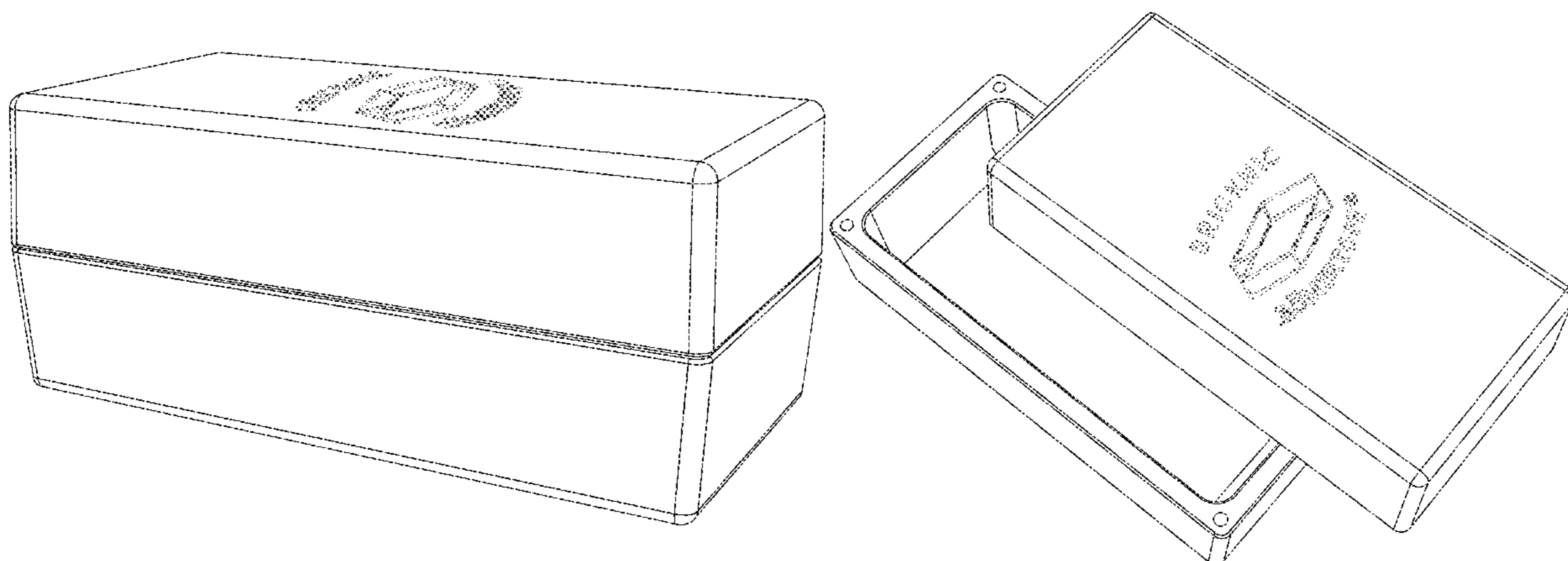
FIG. 6 is a top plan view of the cooking brick shown in the closed configuration.

FIG. 7 is a top plan view of the cooking brick shown in the open configuration, with the top and bottom portions shown separately to show aspects of the design that are not visible when combined; and,

FIG. 8 is a perspective view of the cooking brick shown in the open configuration, with the top portion set inside the bottom portion.

The broken lines in the drawing depict portions of the cooking brick that are not part of the claimed design.

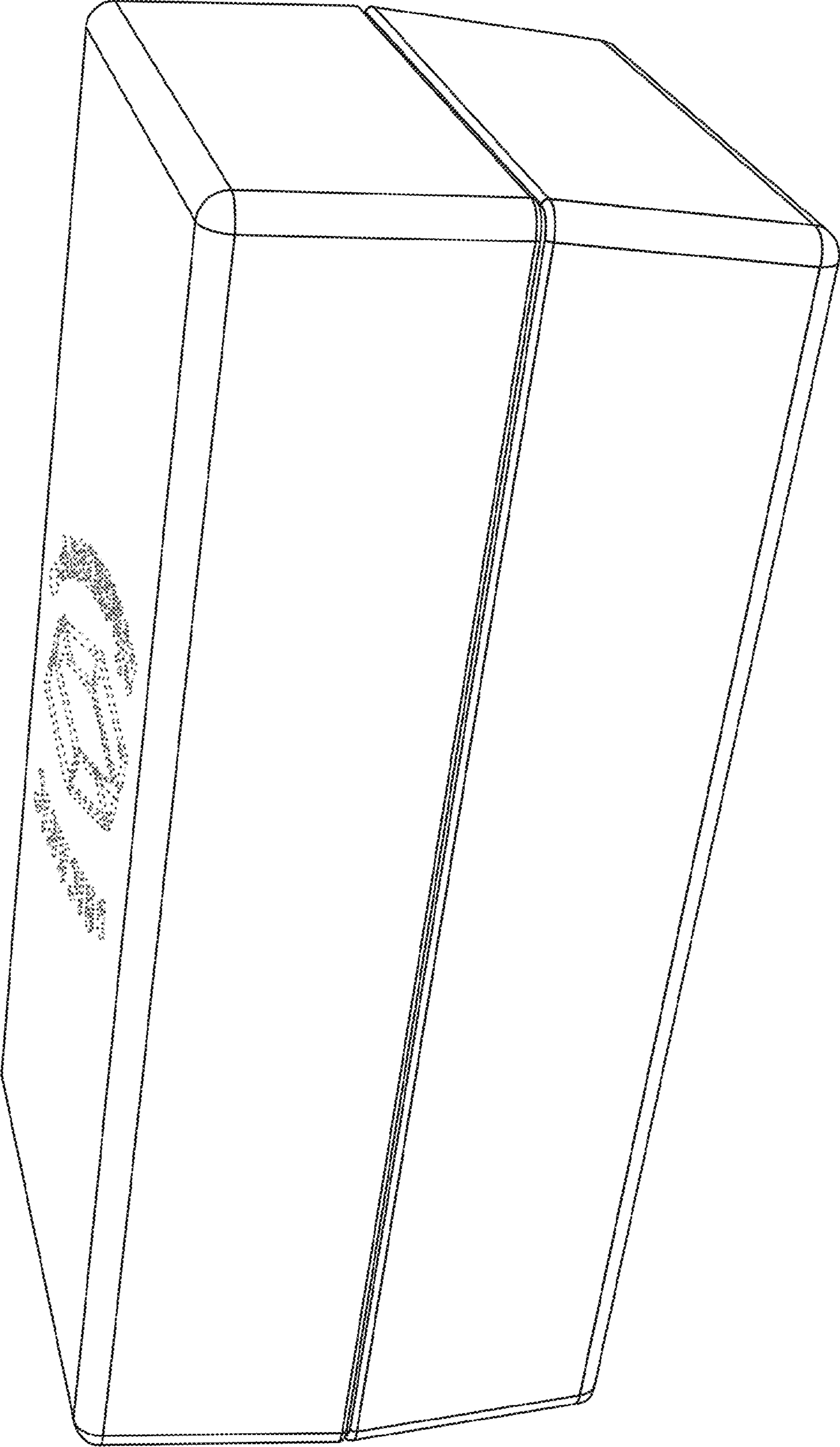

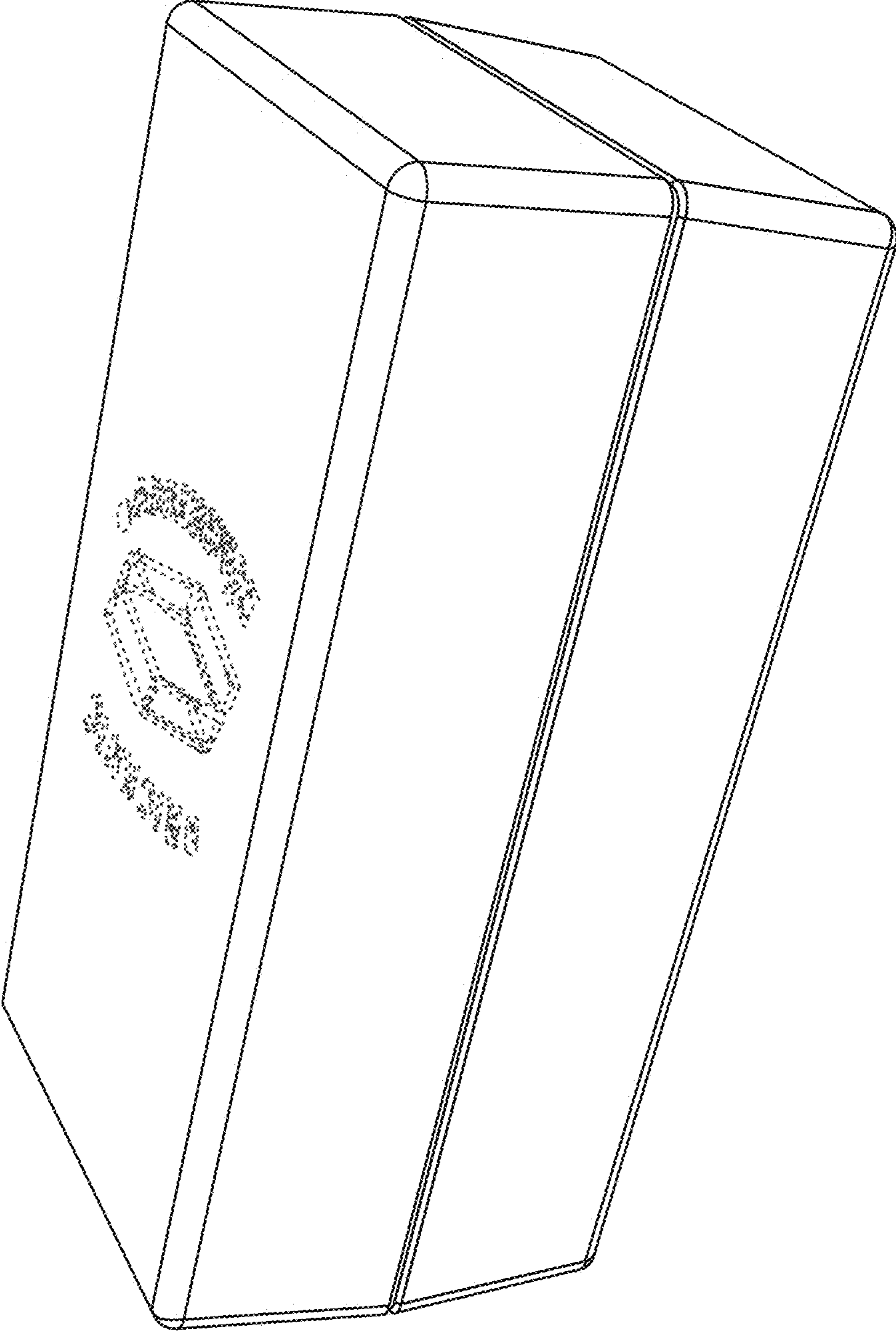

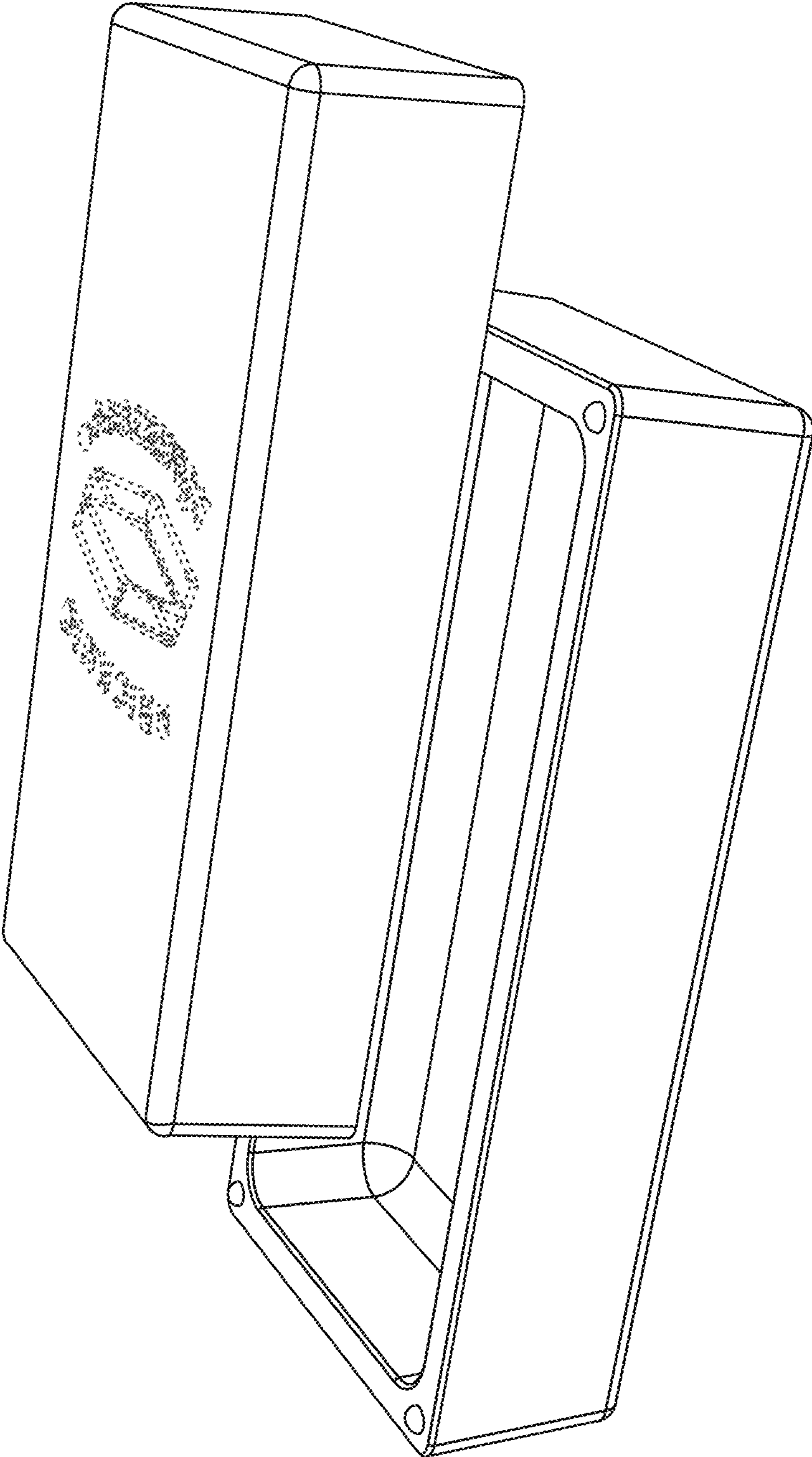

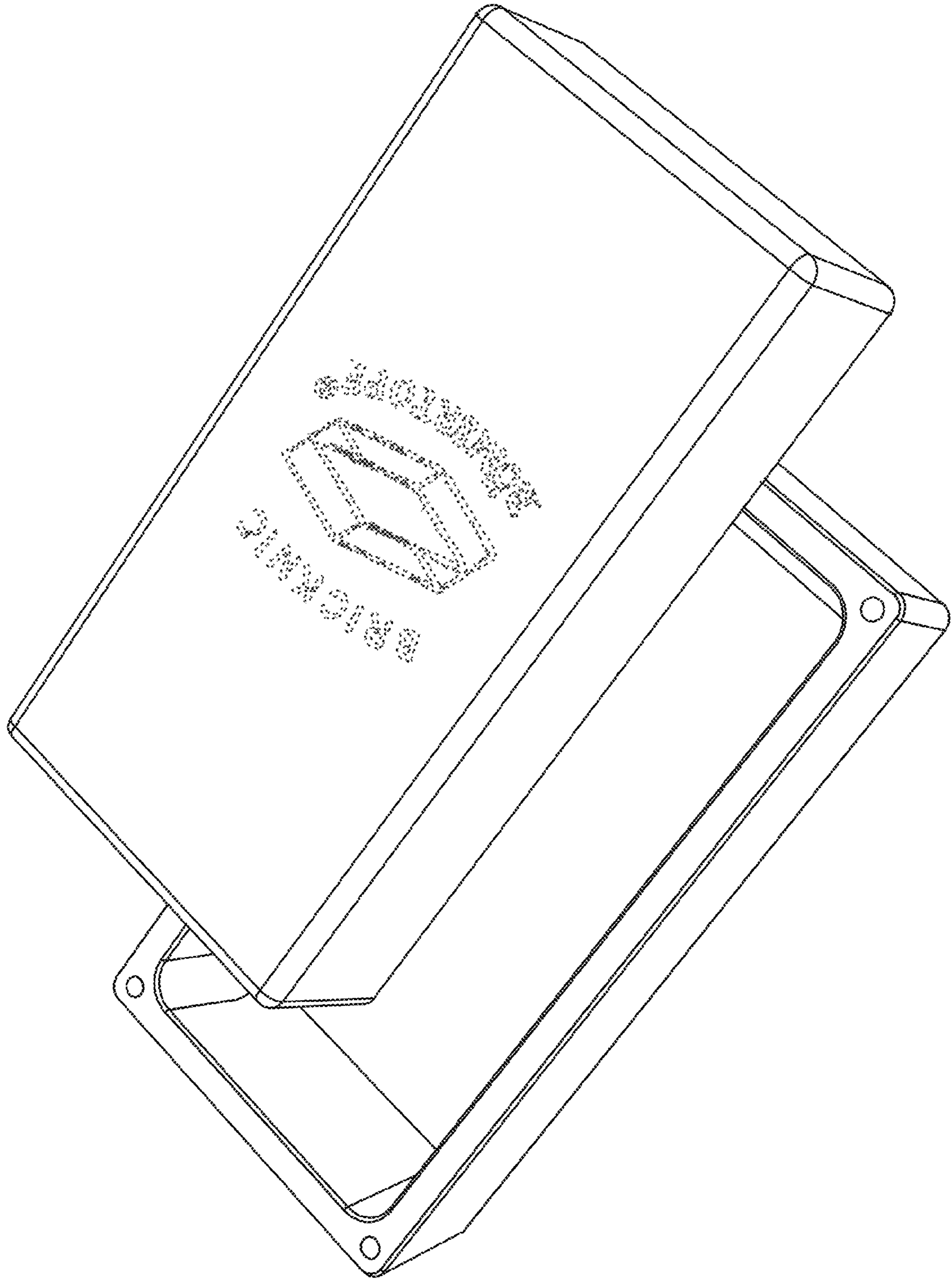

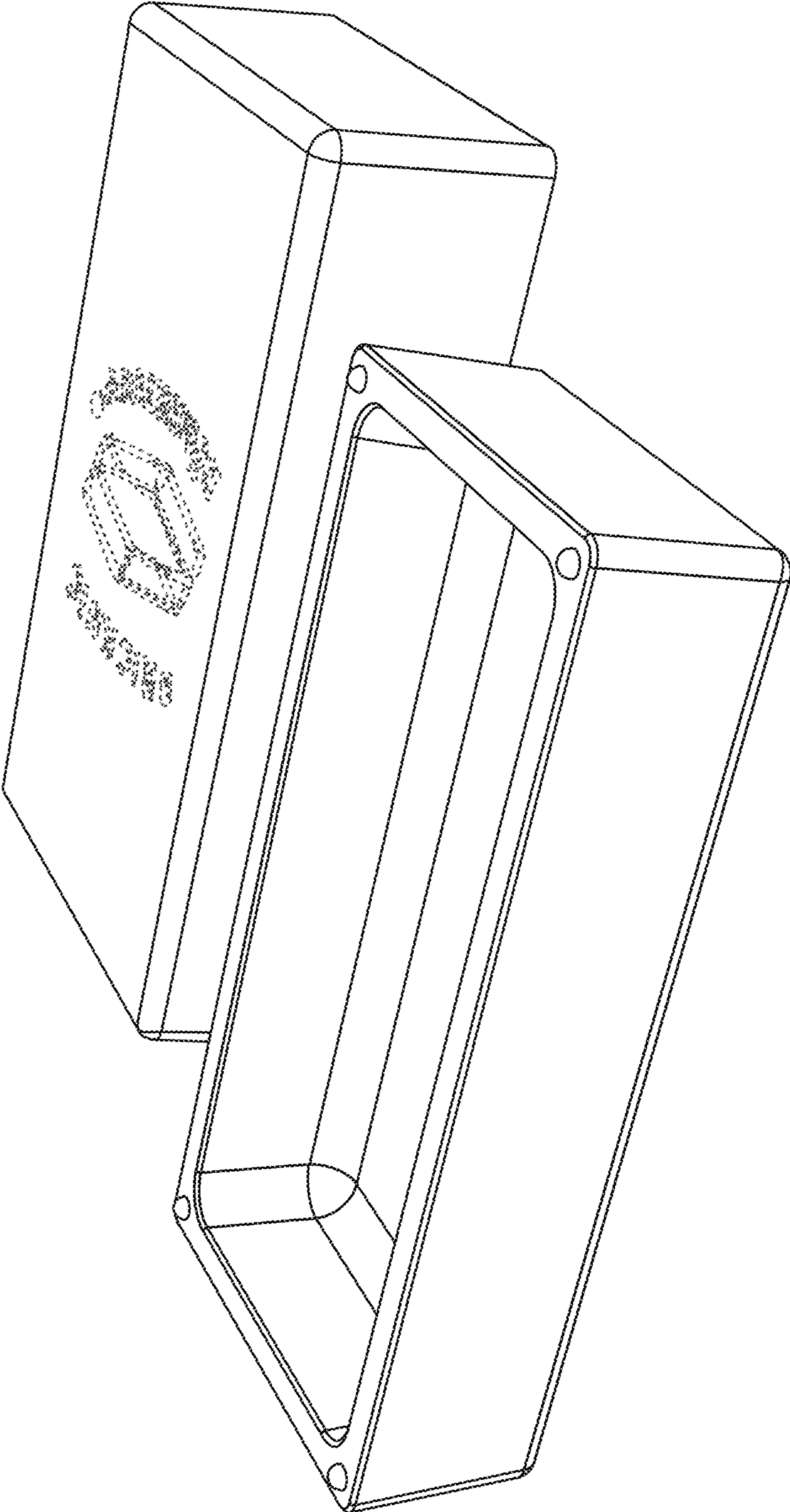

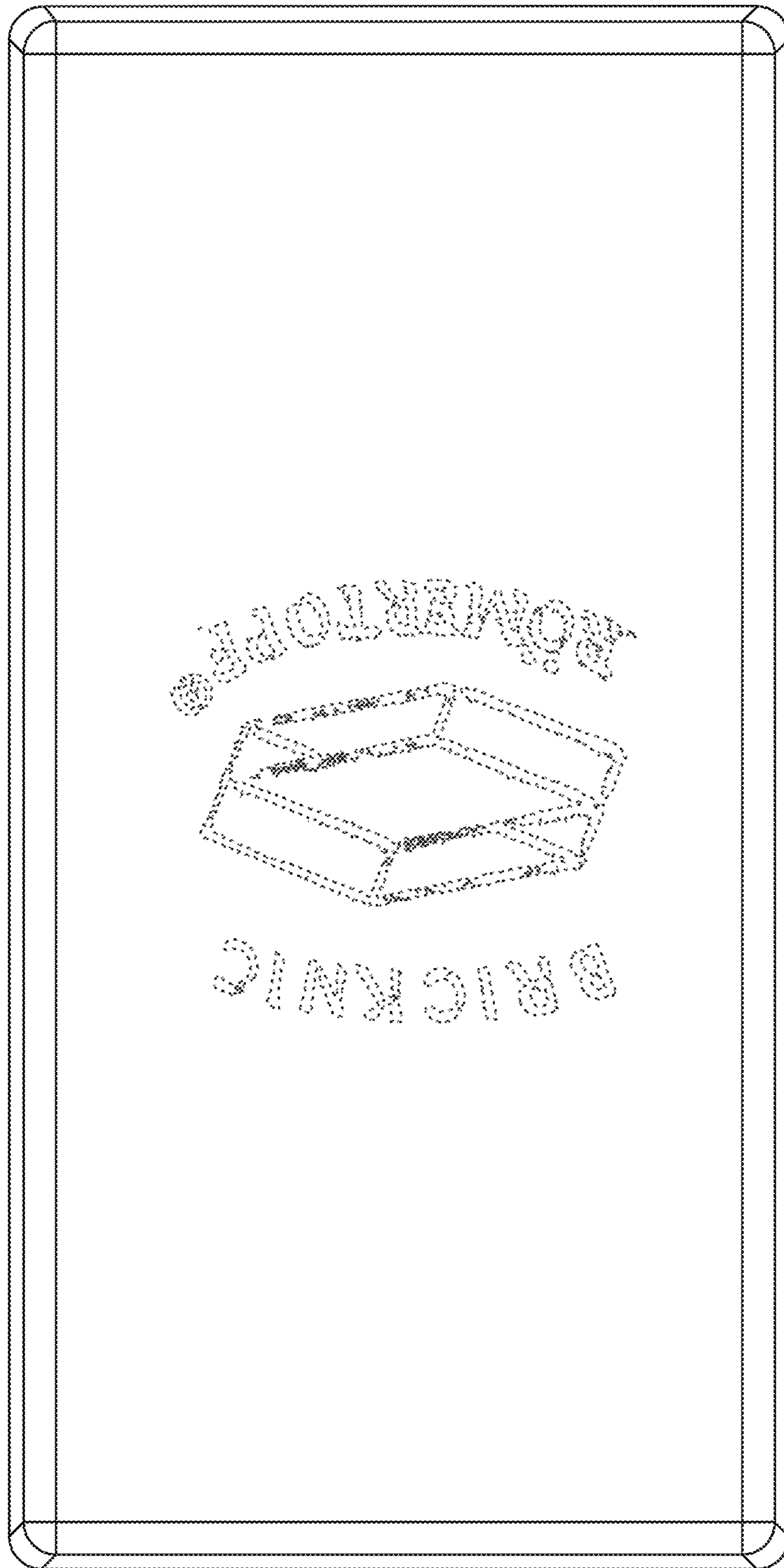

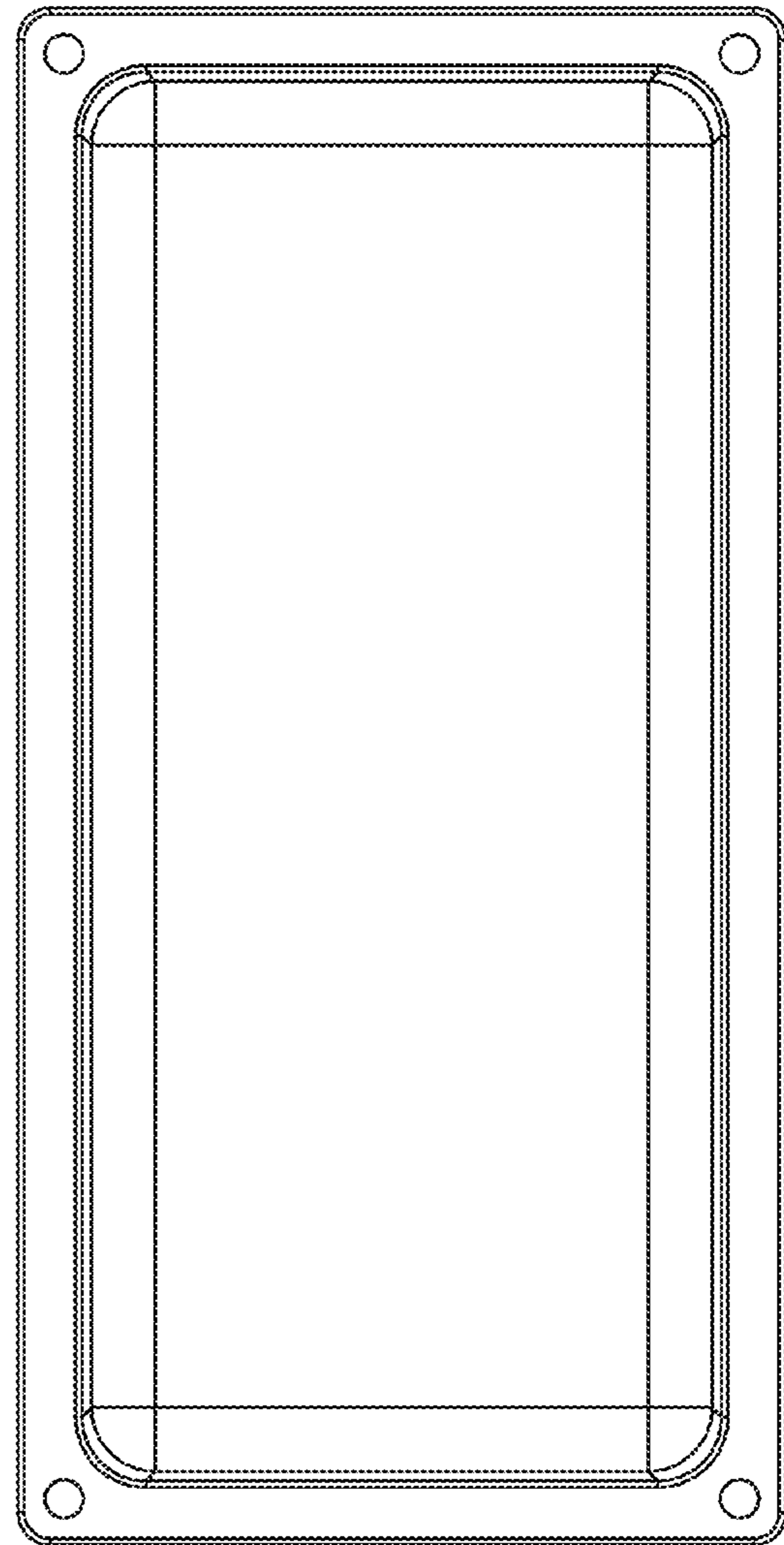
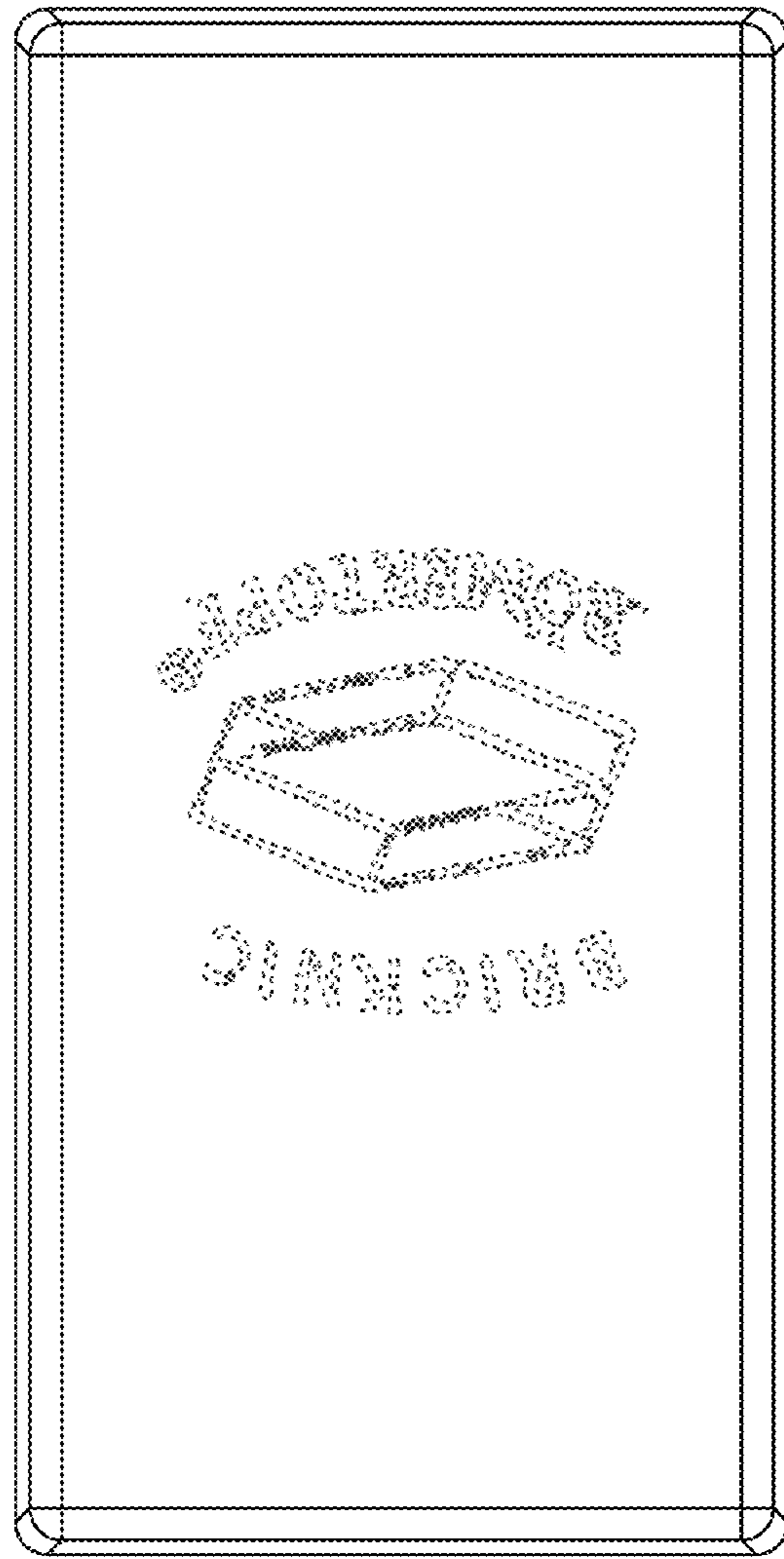
