FIG. 11 is a bottom plan view thereof.

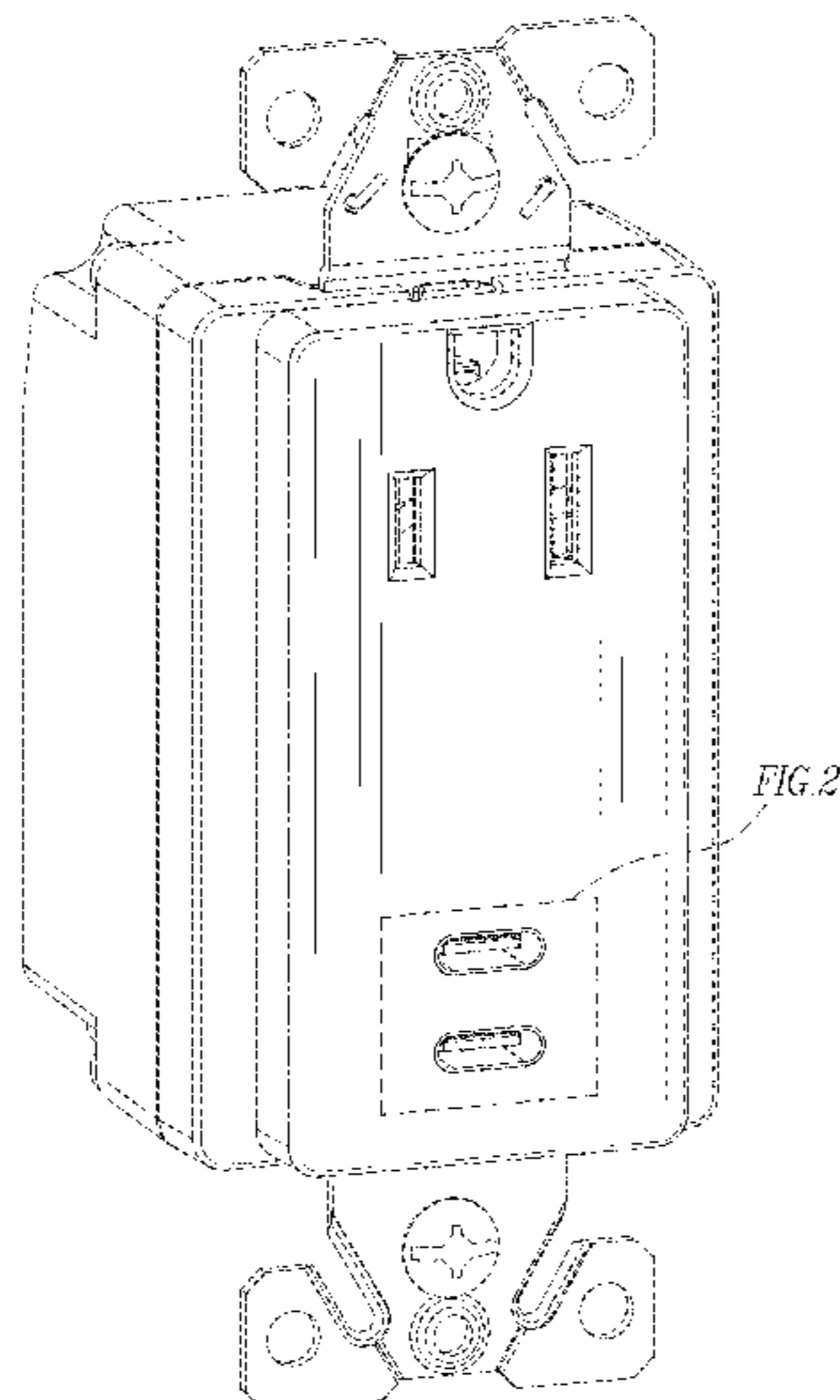

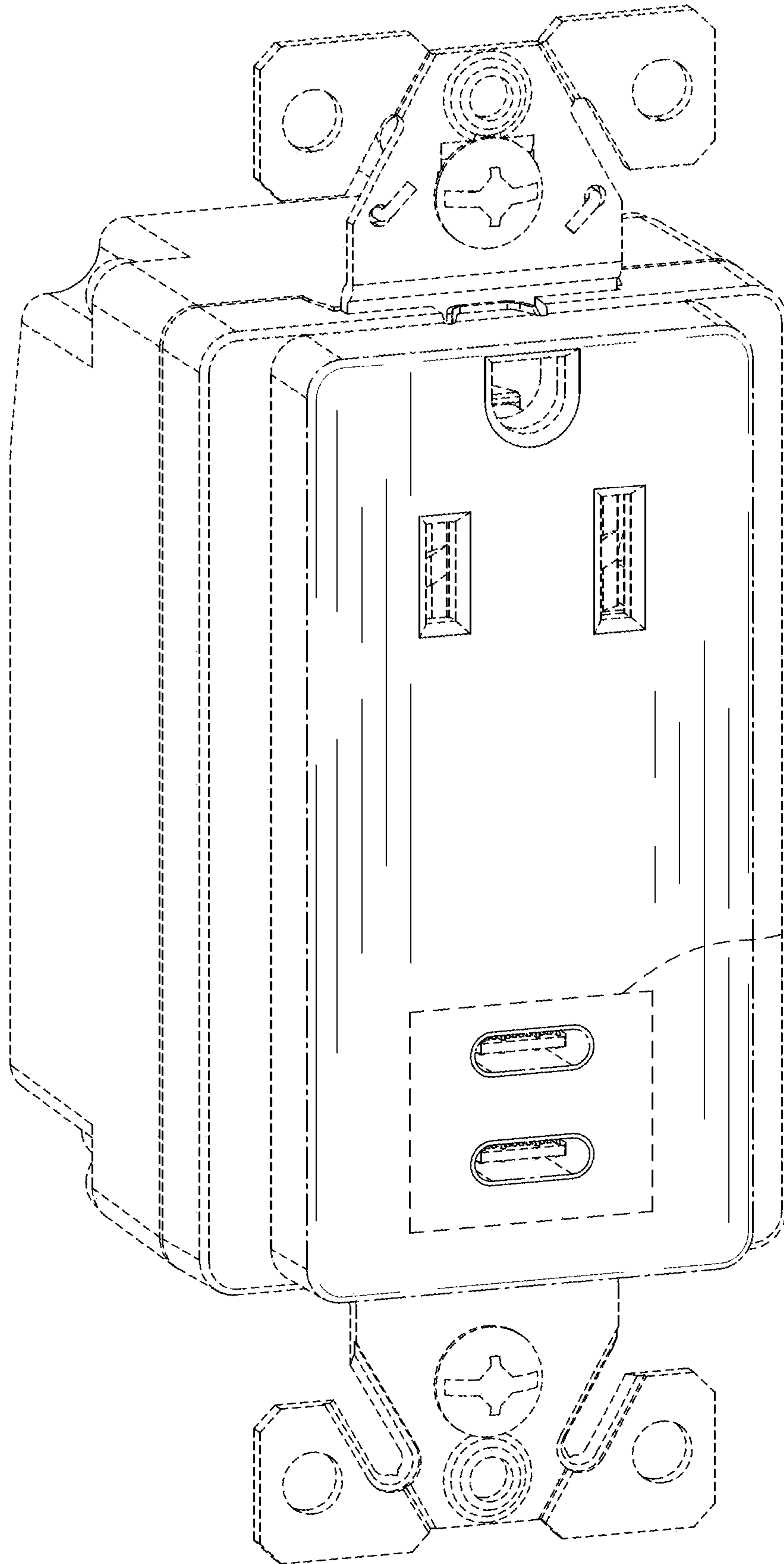

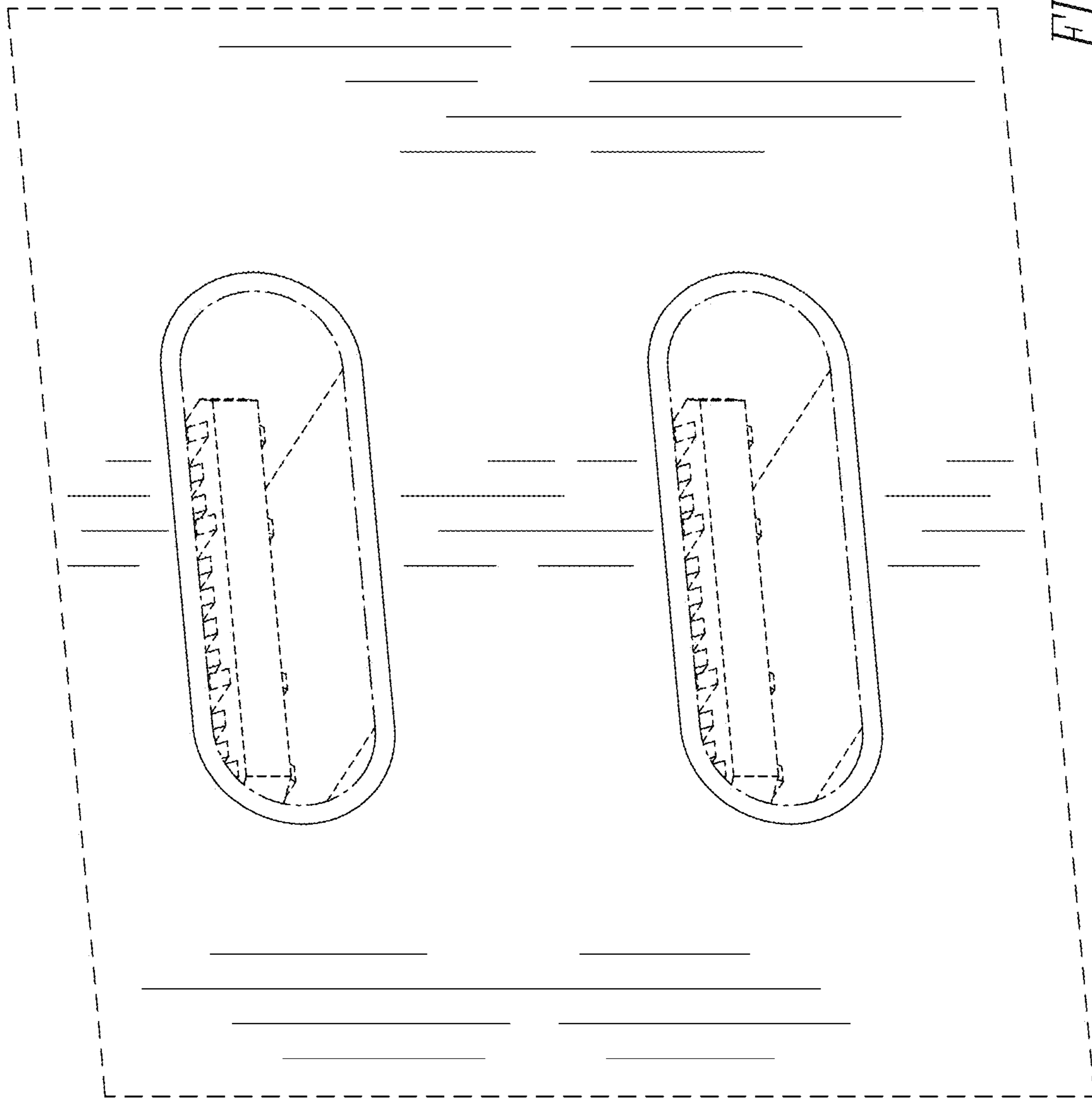

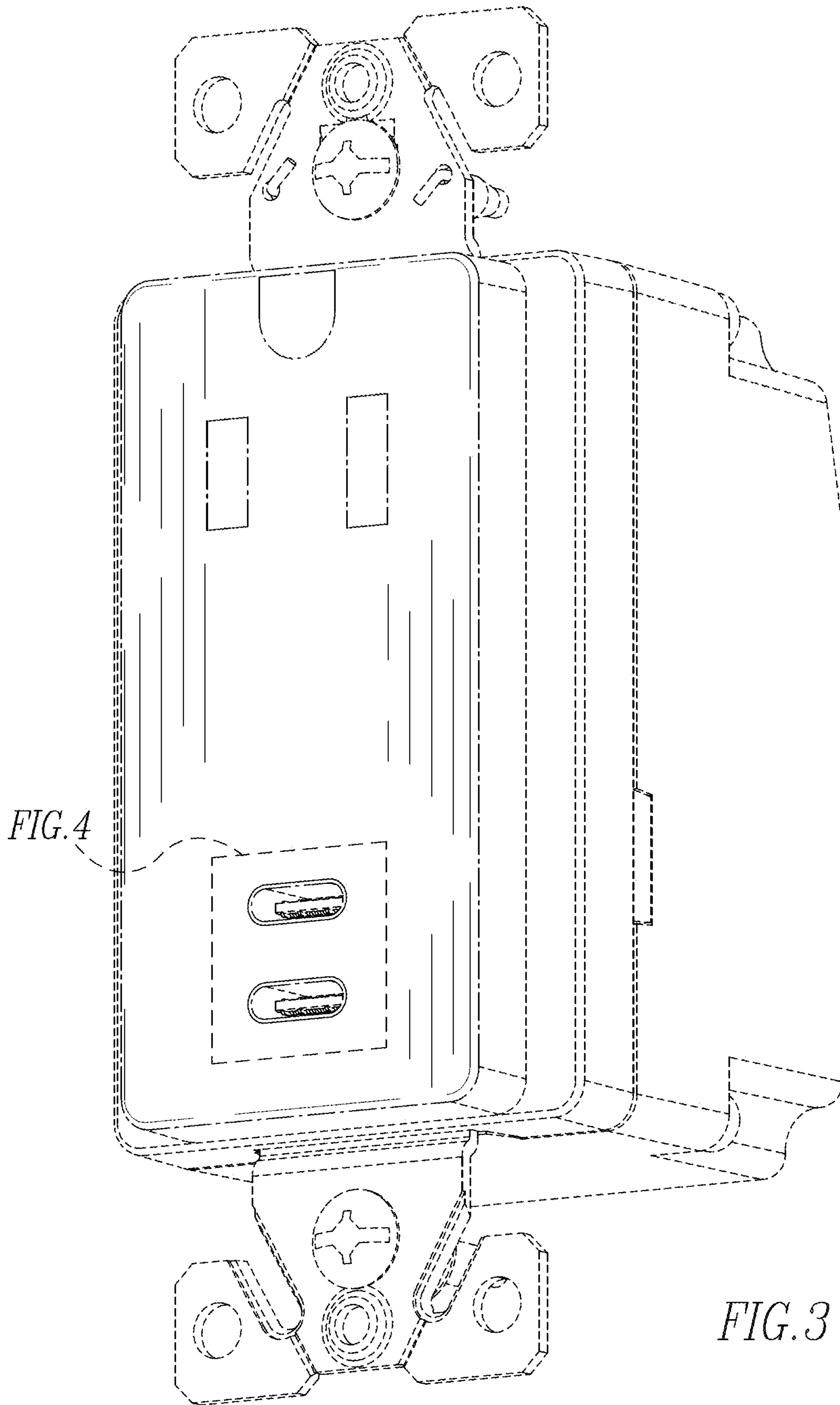
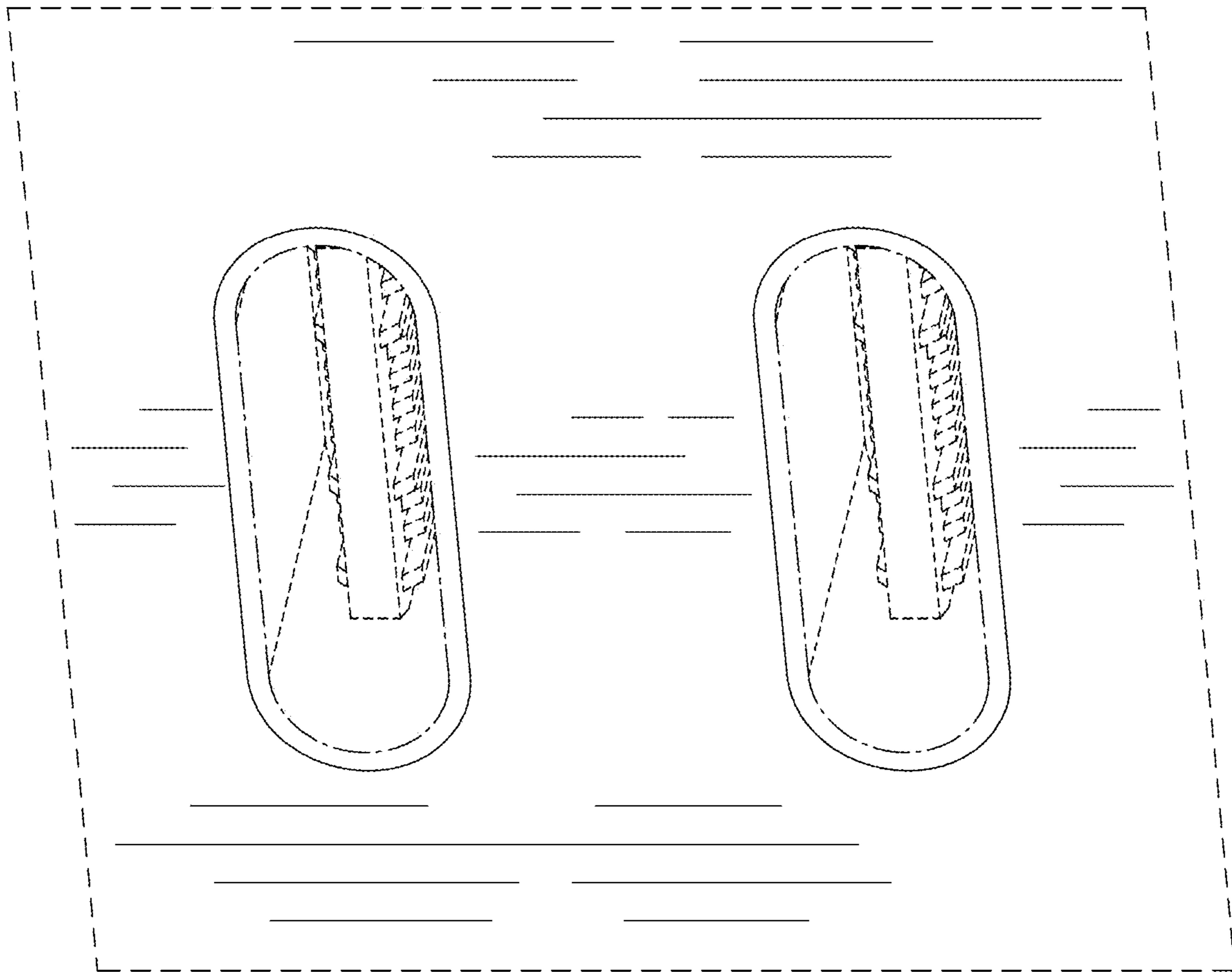

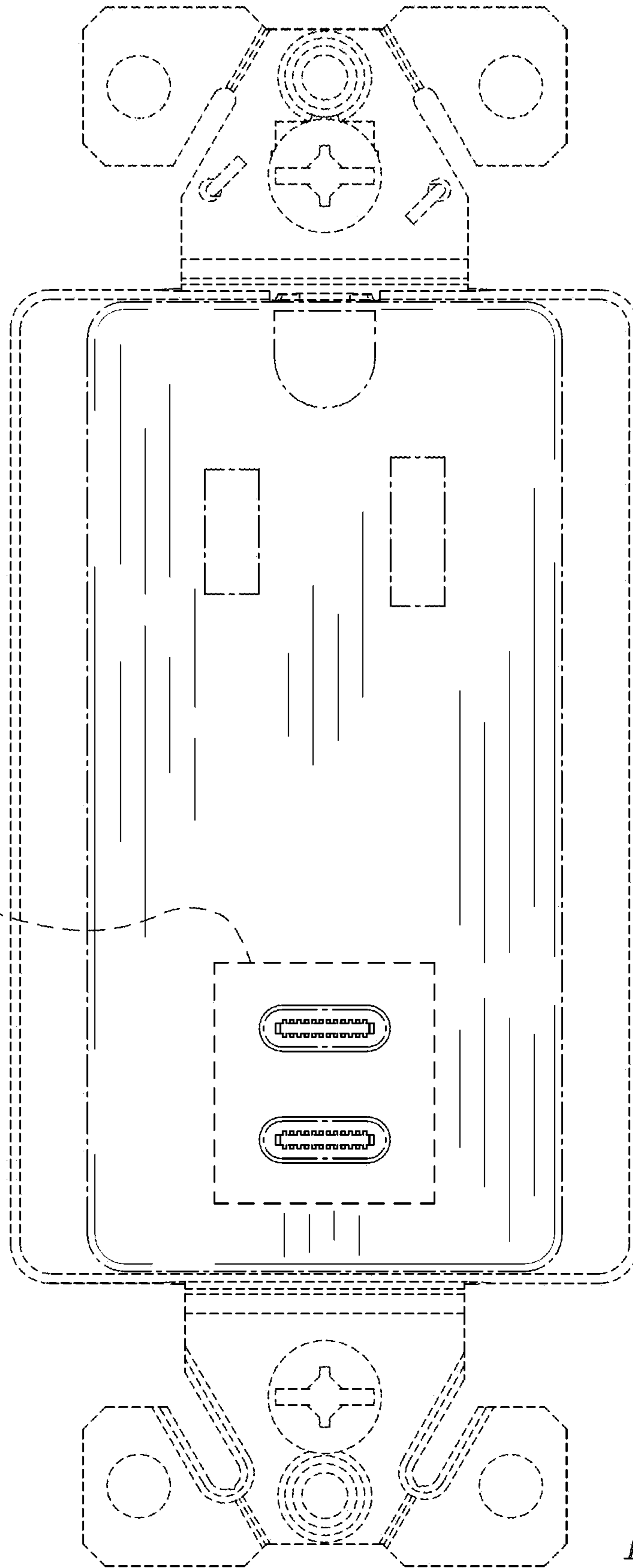

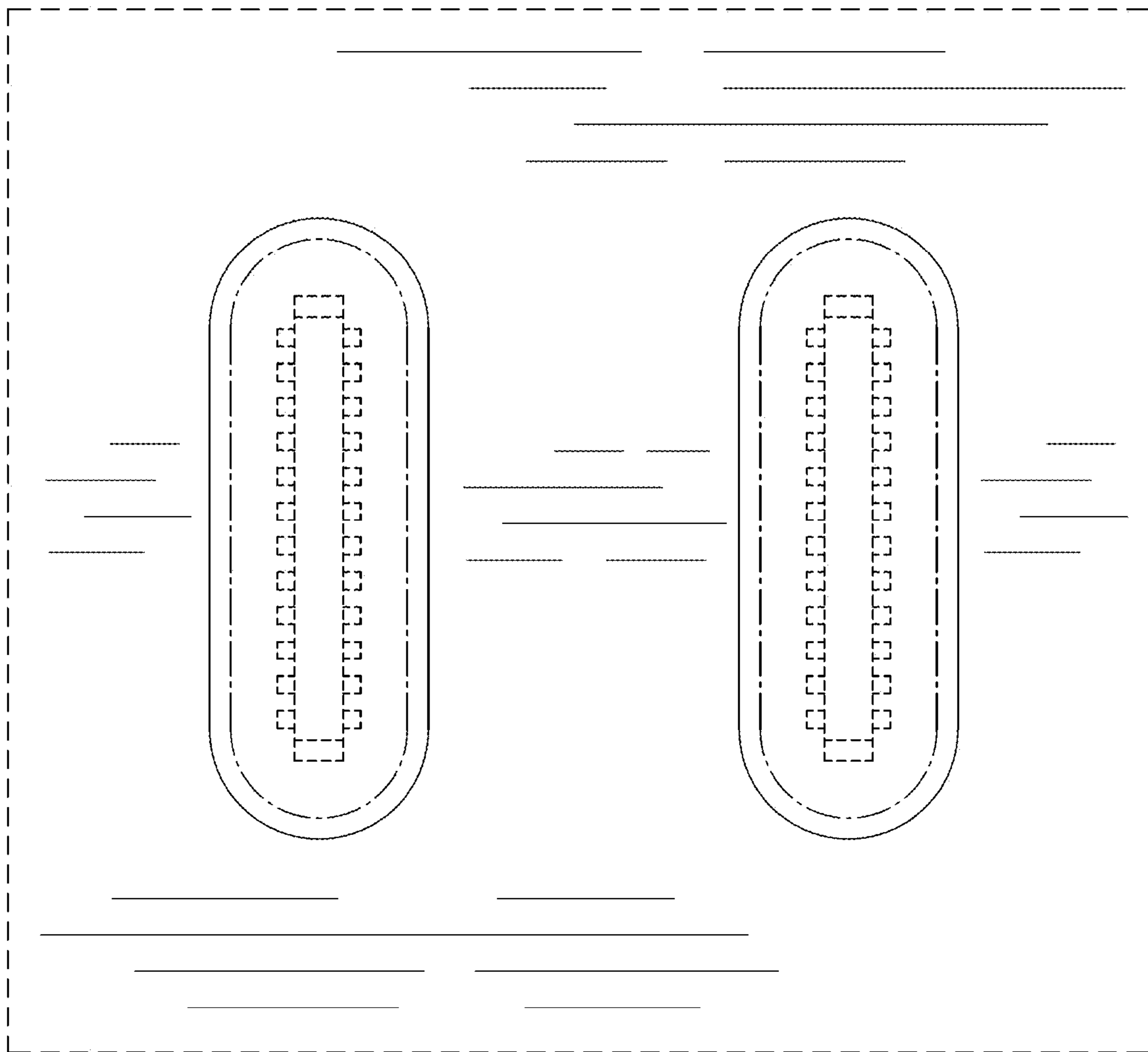

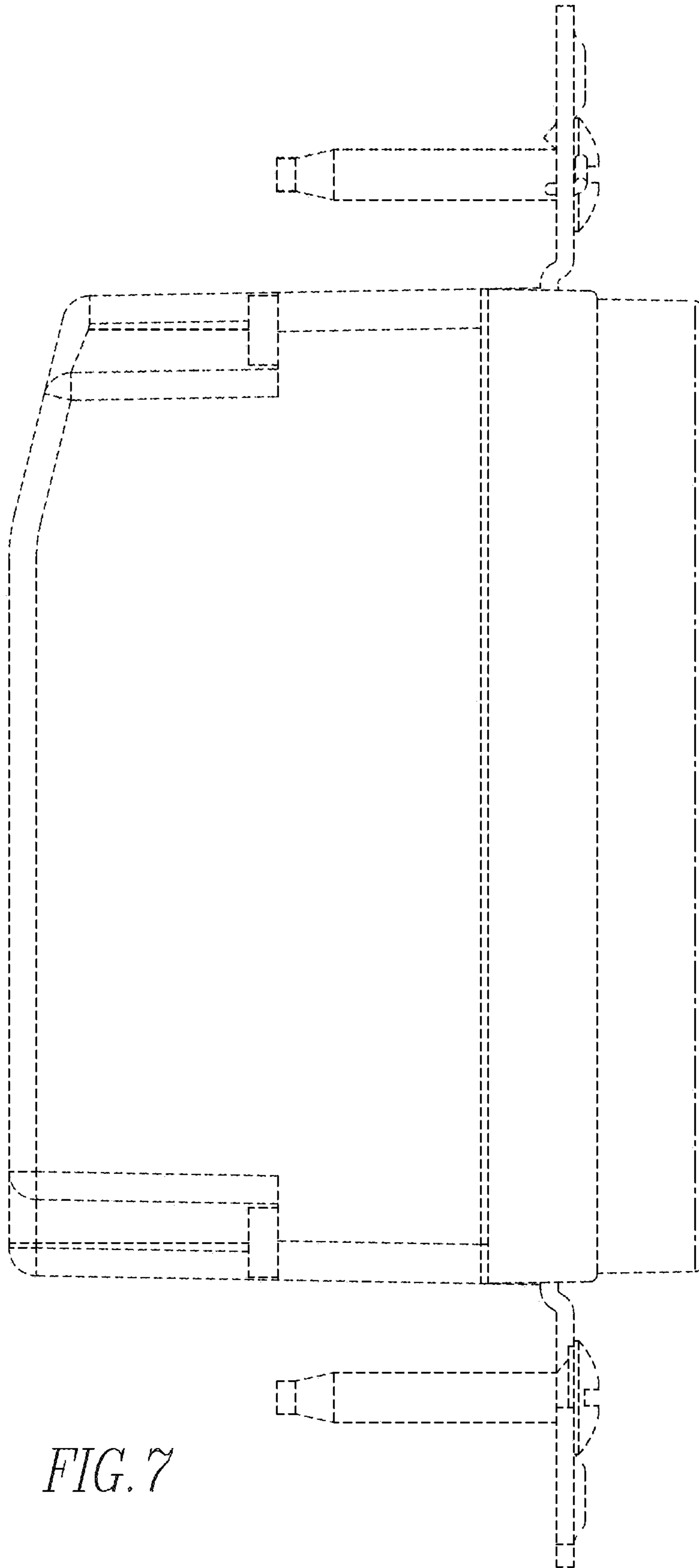

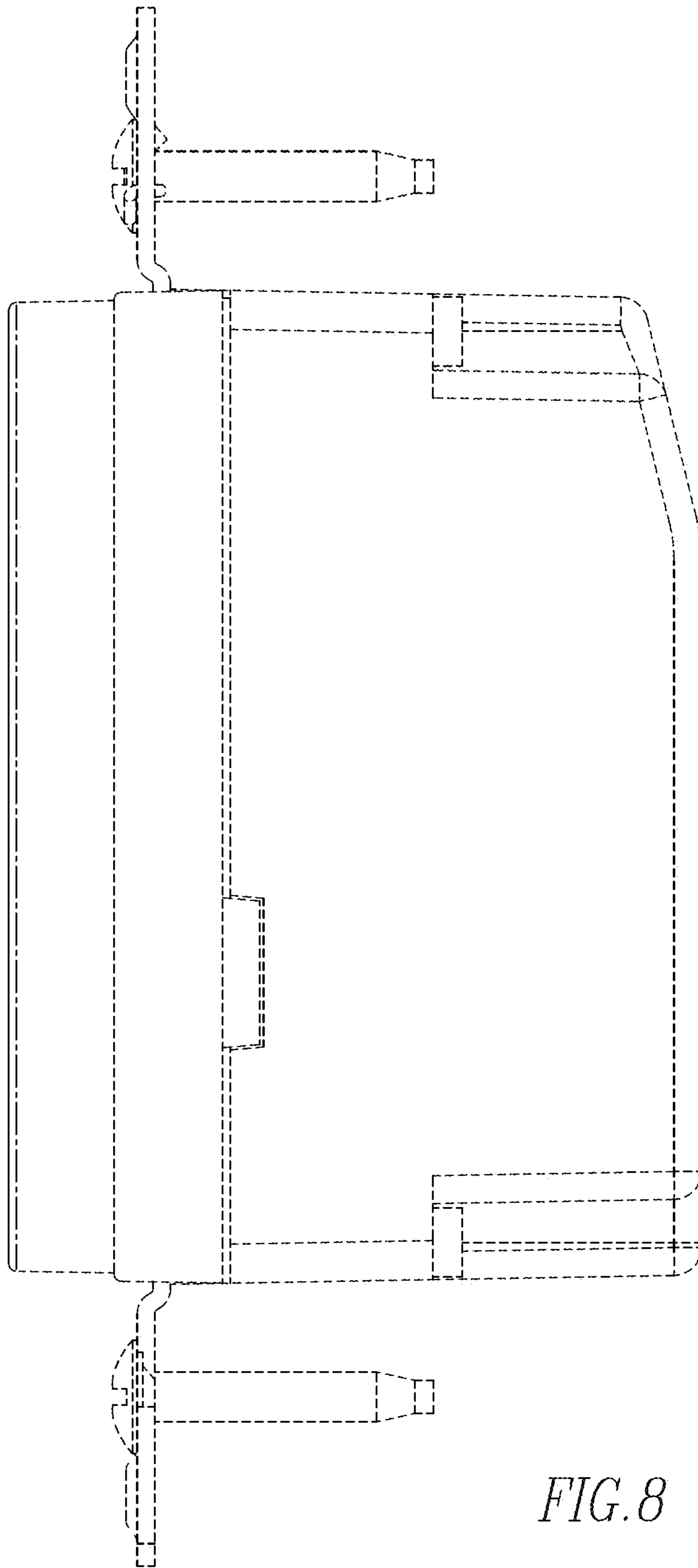

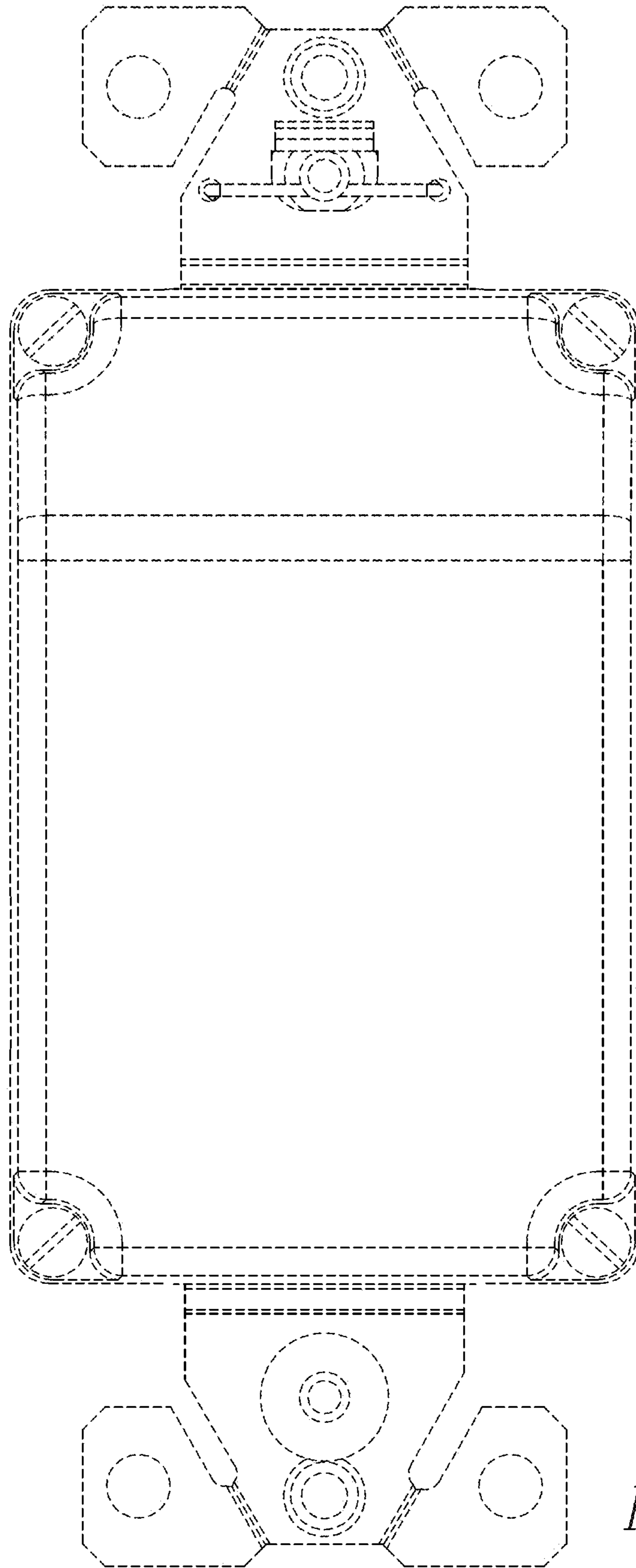
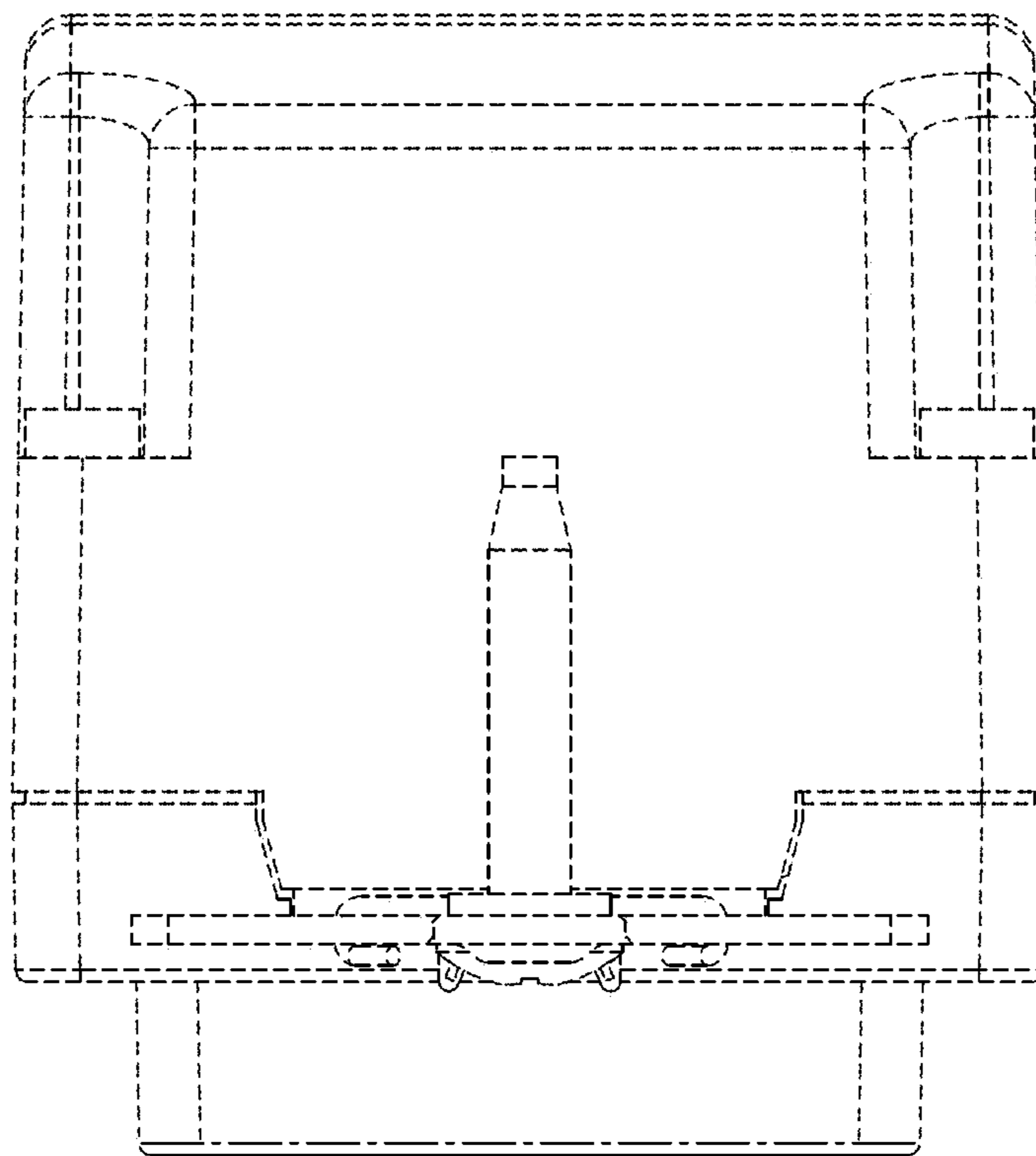
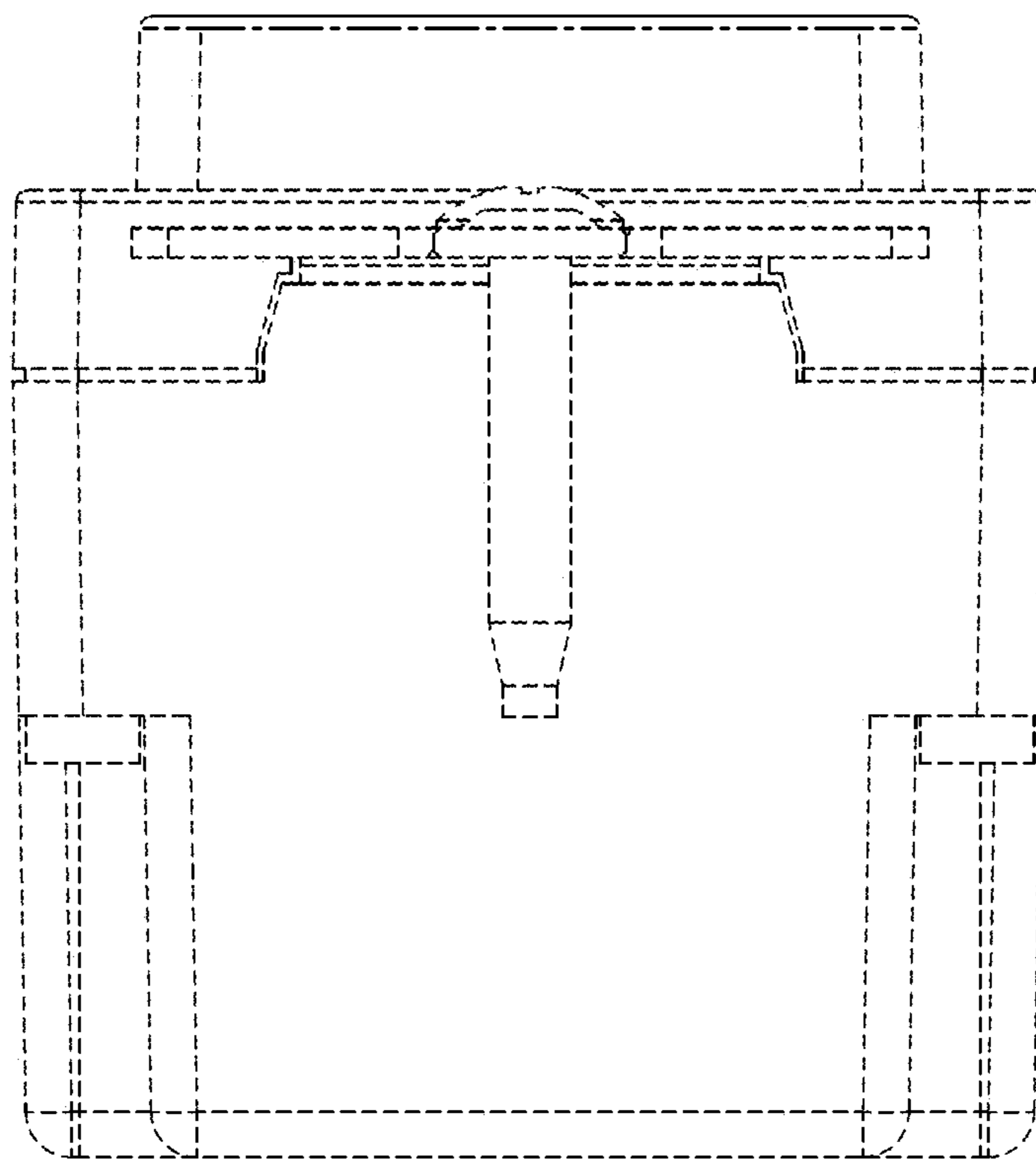
