(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

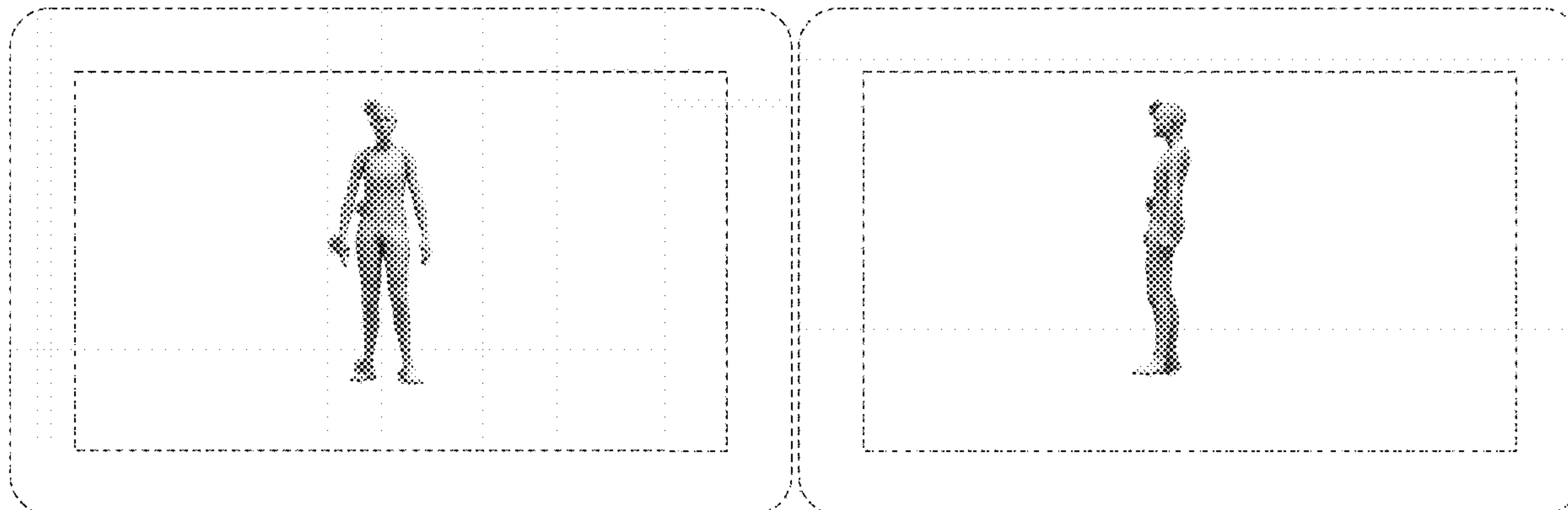
**DESCRIPTION**

FIG. 1 is a front view of a display screen with graphical user interface, showing the new design; FIG. 2 is a second image thereof; FIG. 3 is a third image thereof; and, FIG. 4 is a fourth image thereof.

The broken lines in the drawings showing the display screen with graphical user interface illustrate portions of the display screen with graphical user interface that form no part of the claimed design.

The subject matter in this patent includes a process or period in which an image changes to another image. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-4. The process or period, in which one image transitions to another image, forms no part of the claimed design.

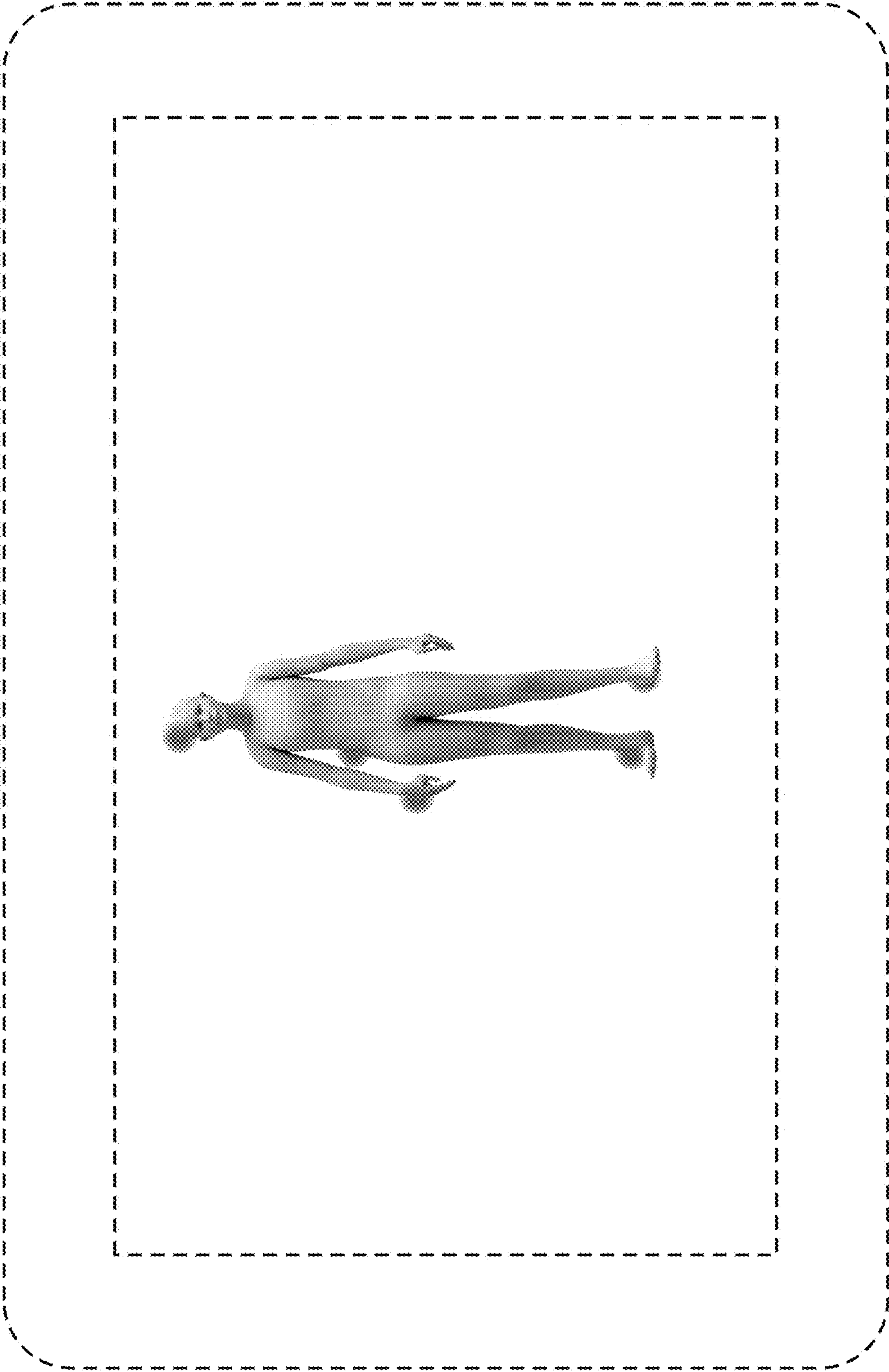

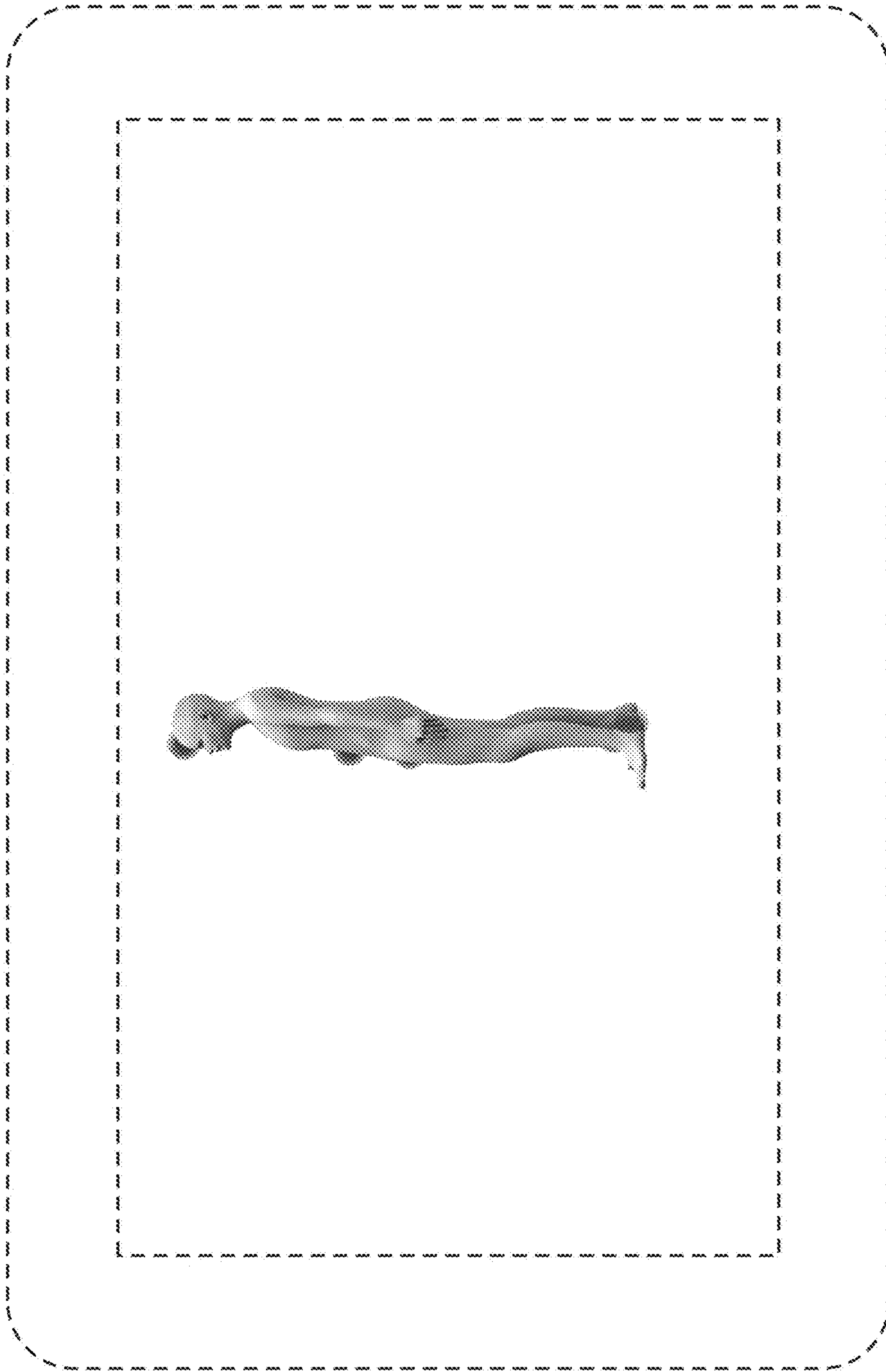

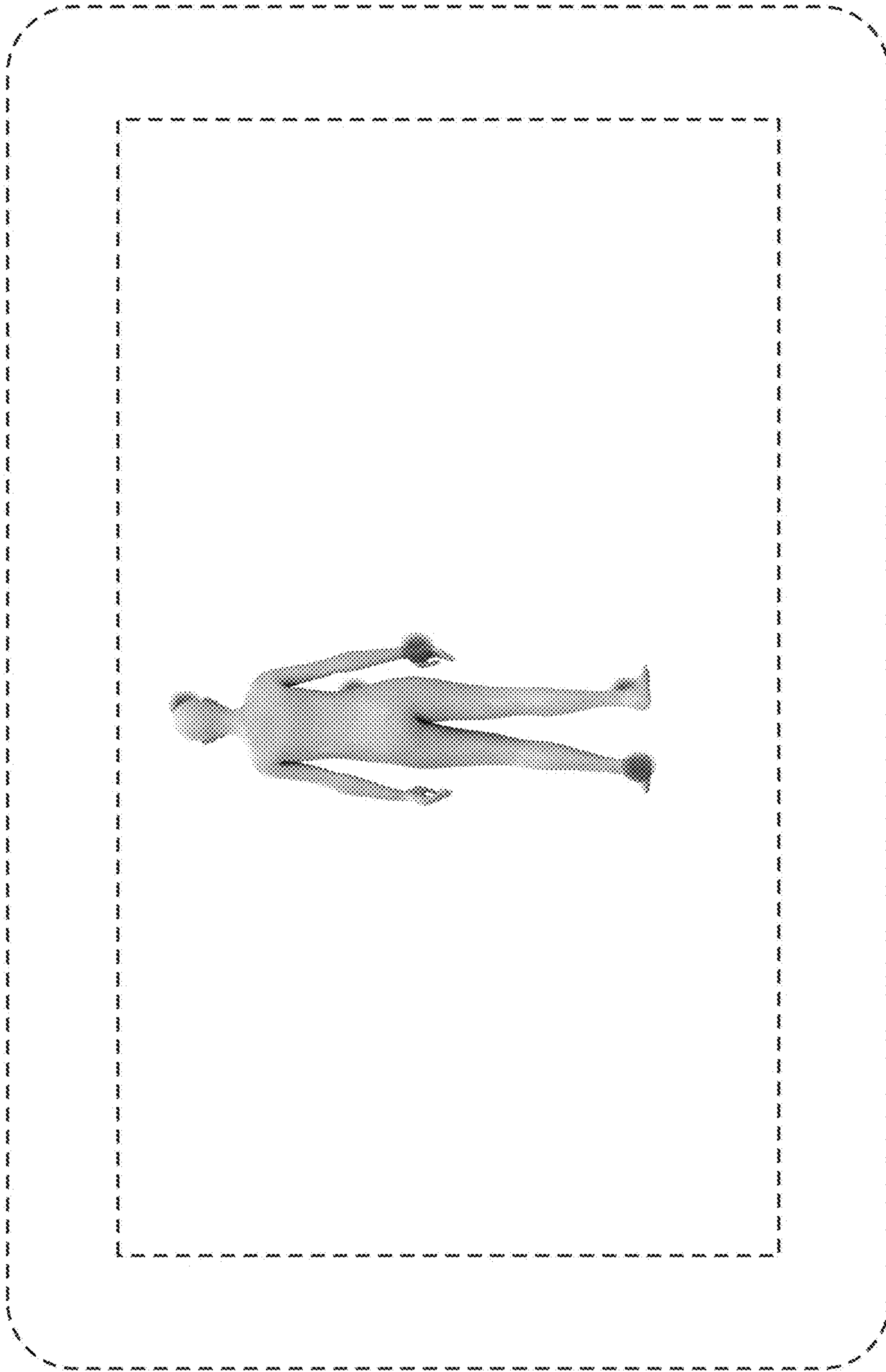

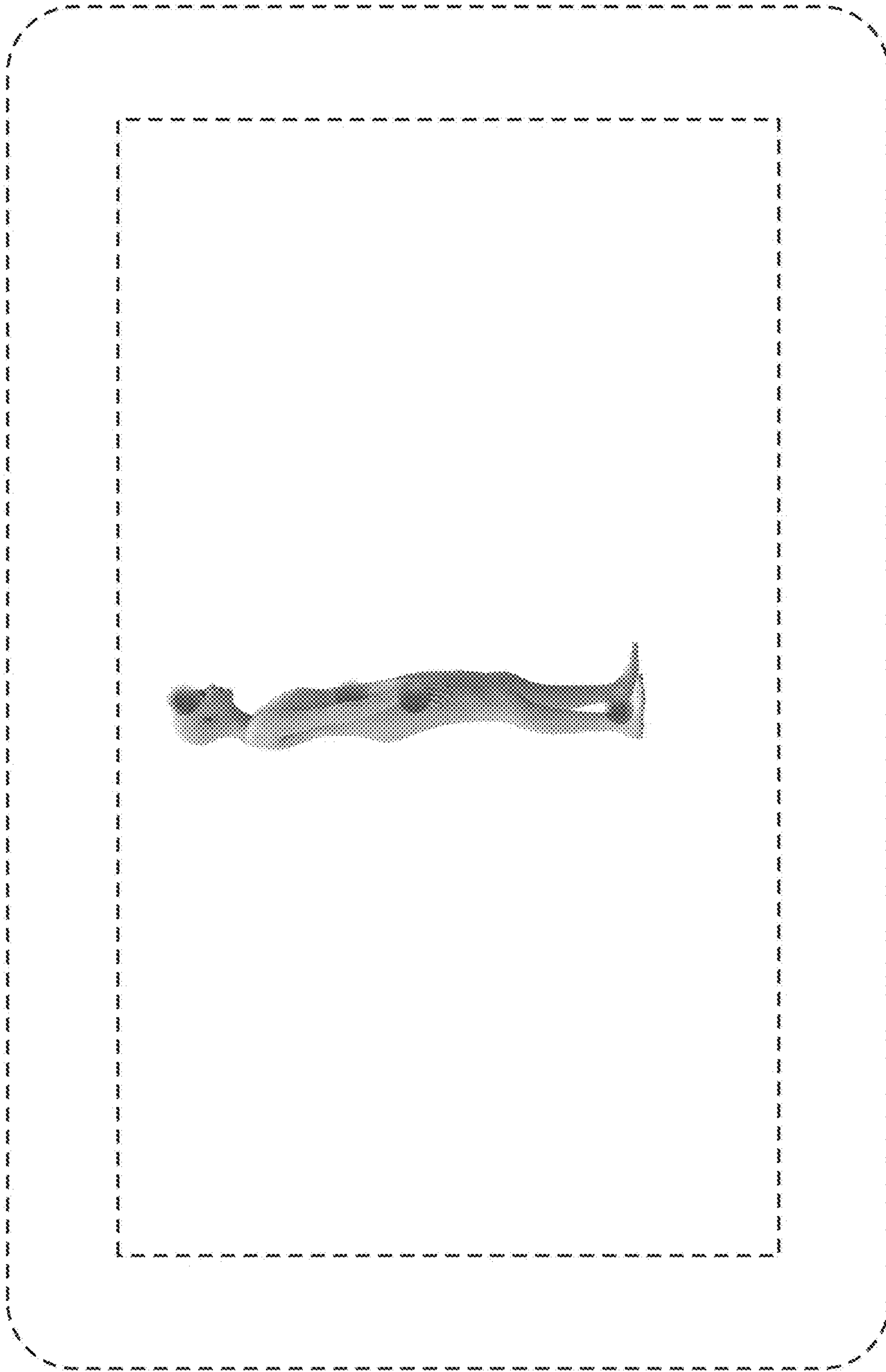
