The ornamental design for a display screen or portion thereof with graphical user interface for podcasts, as shown and described.

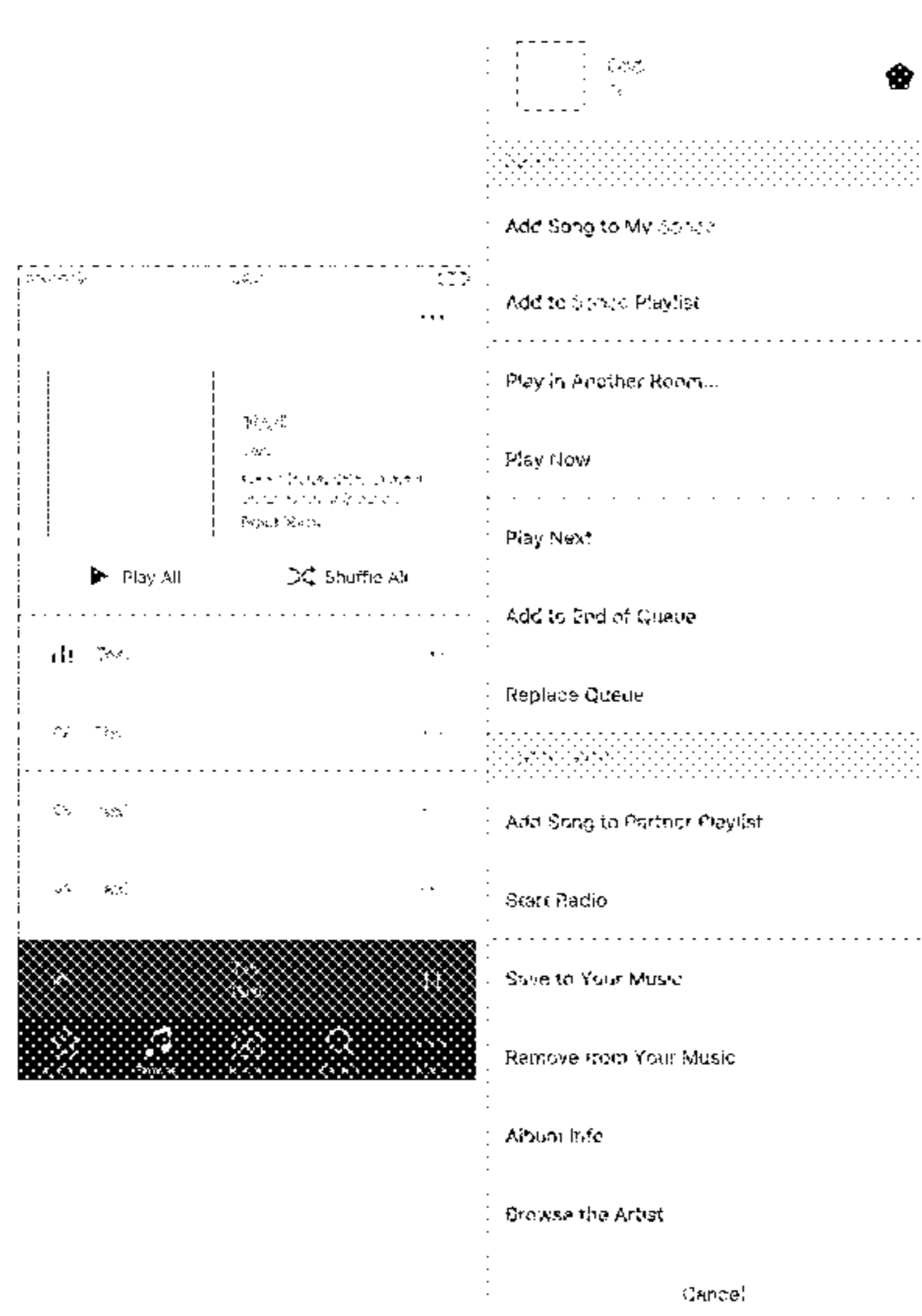
DESCRIPTION

FIG. 1 is a front elevational view of a first image in a sequence for a display screen with graphical user interface for podcasts in accordance with a first embodiment; FIG. 2 is a front elevational view of a second image in the sequence of the first embodiment; FIG. 3 is a front elevational view of a first image in a sequence for a display screen with graphical user interface for podcasts in accordance with a second embodiment; FIG. 4 is a front elevational view of a second image in the sequence of the second embodiment; FIG. 5 is a front elevational view of a first image in a sequence for a display screen with graphical user interface for podcasts in accordance with a third embodiment; and, FIG. 6 is a front elevational view of a second image in the sequence of the third embodiment.

The broken line showing of the display screen and remainder of the graphical user interface forms no part of the claimed design.

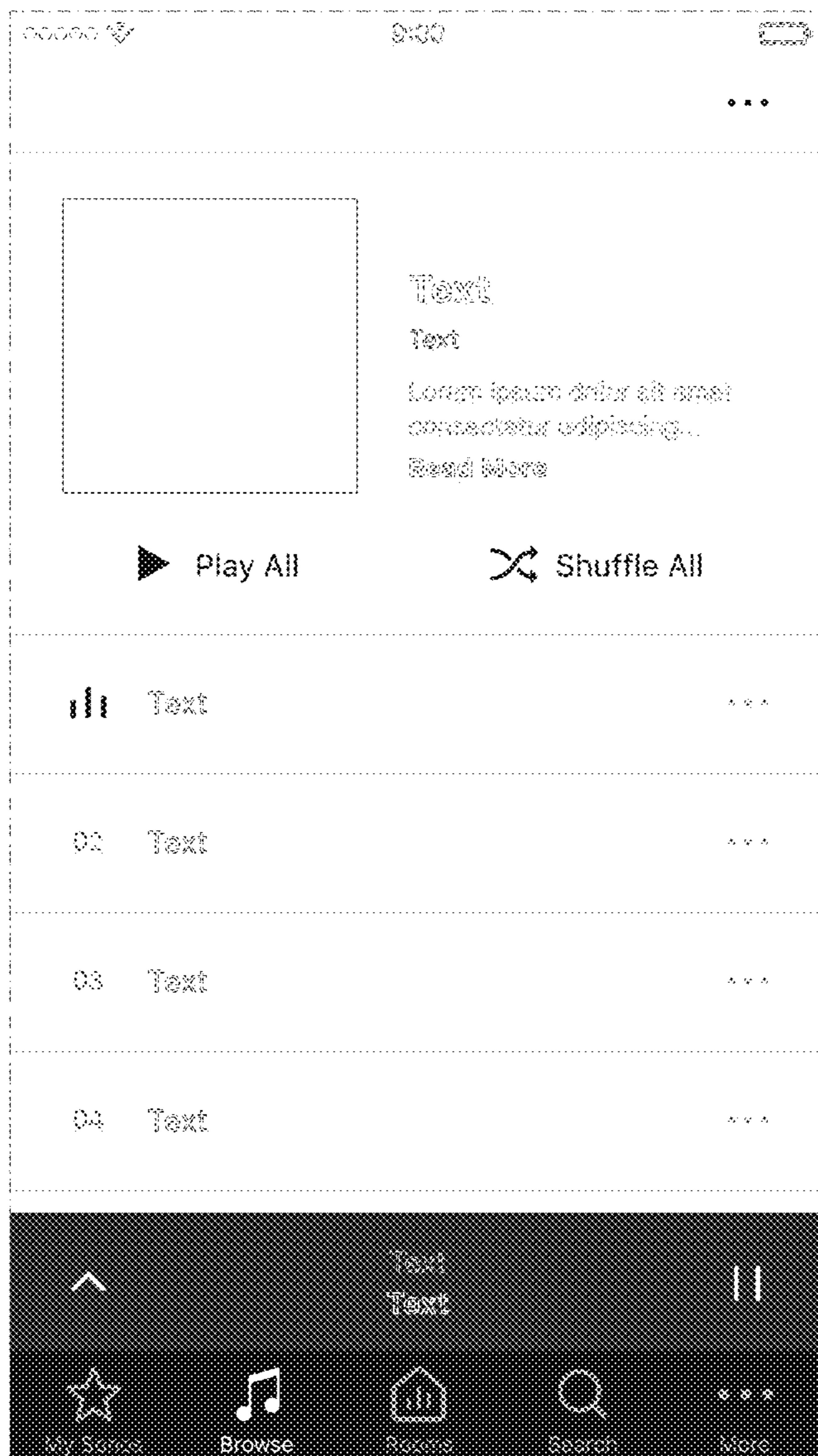

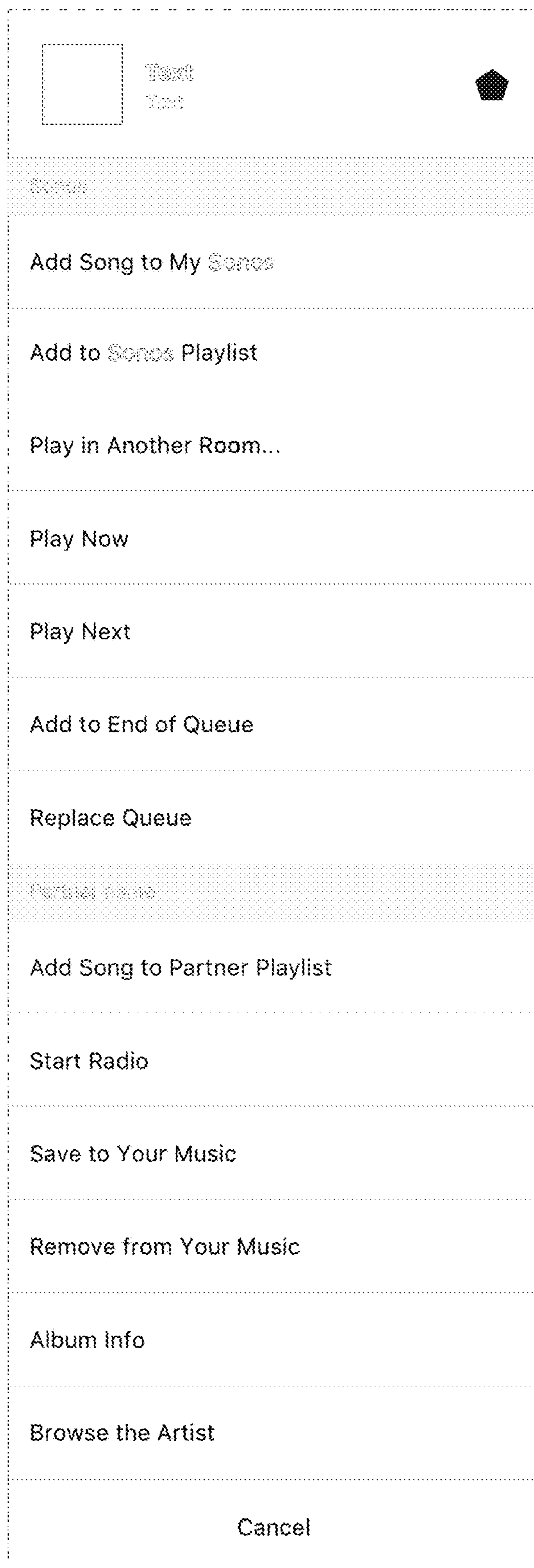

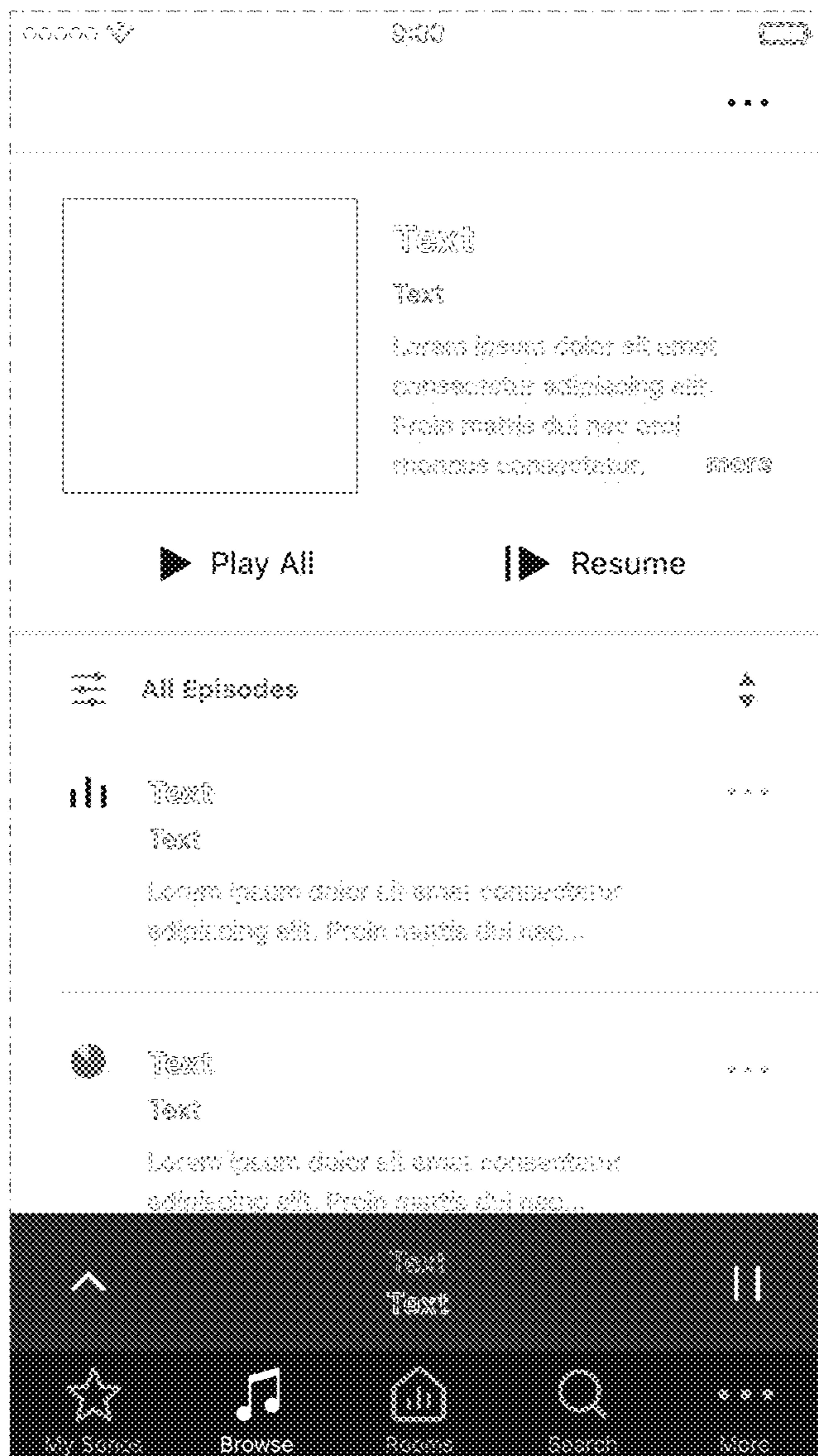

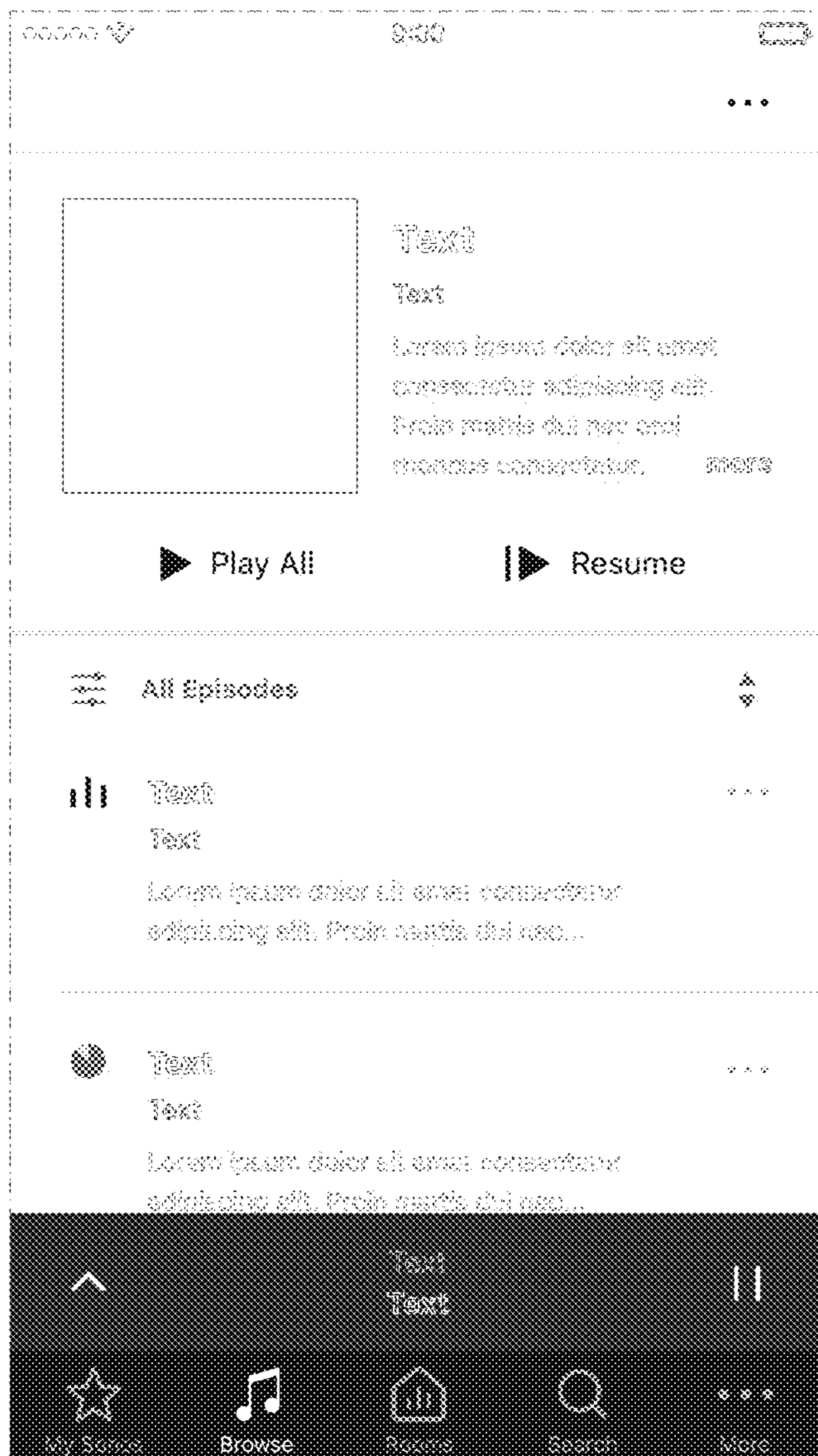

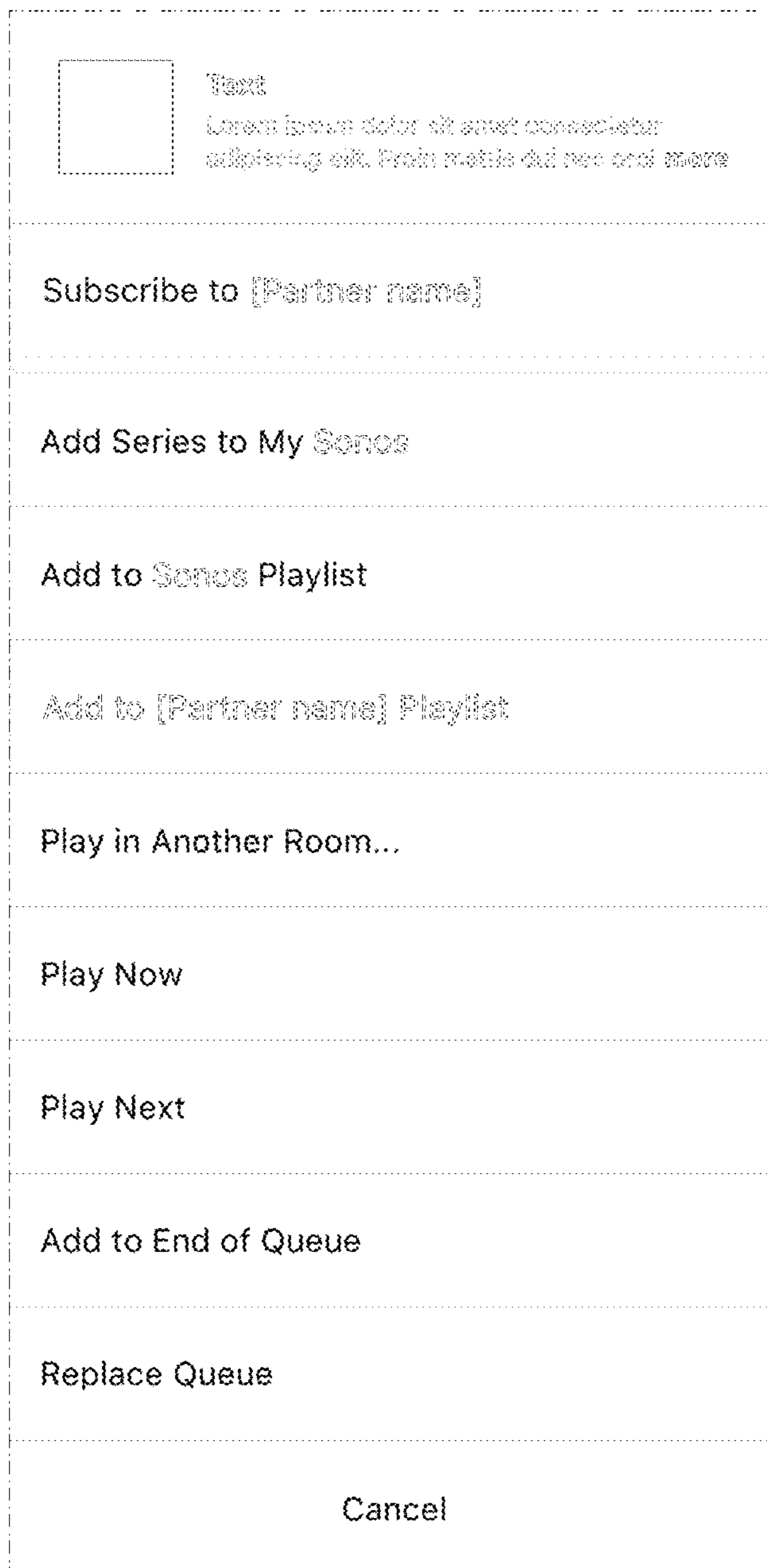
