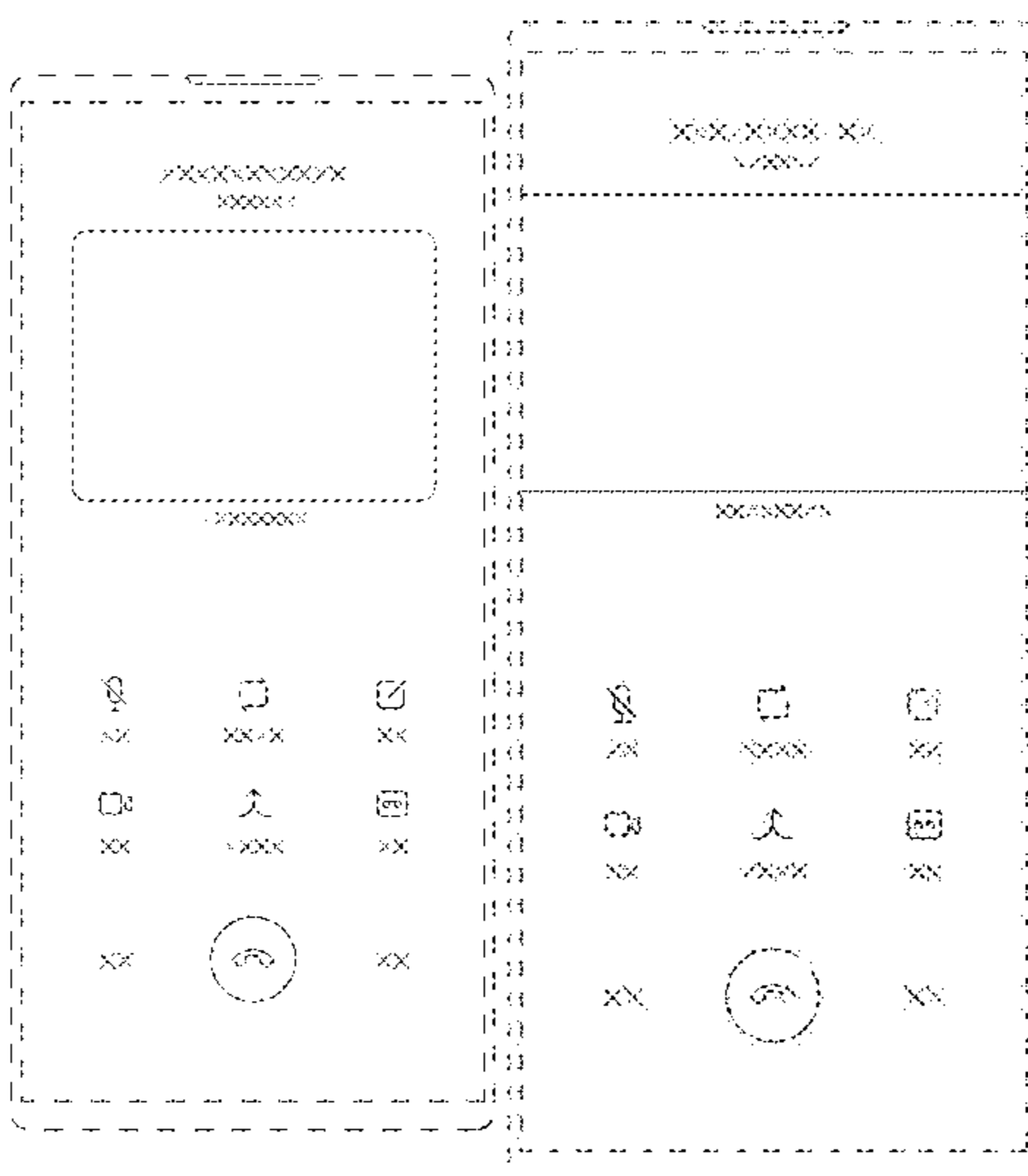
The ornamental design for a cell phone with graphical user interface, as shown and described.

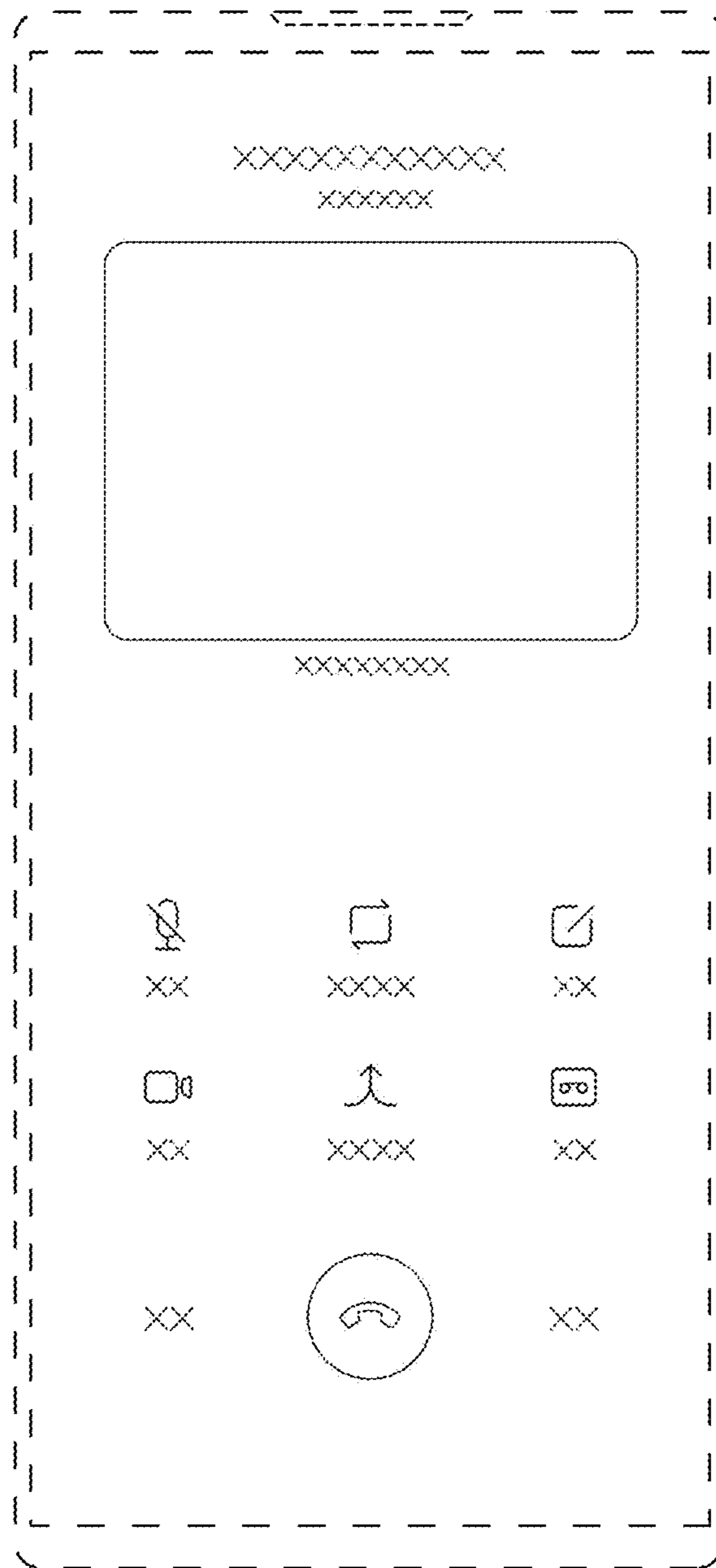

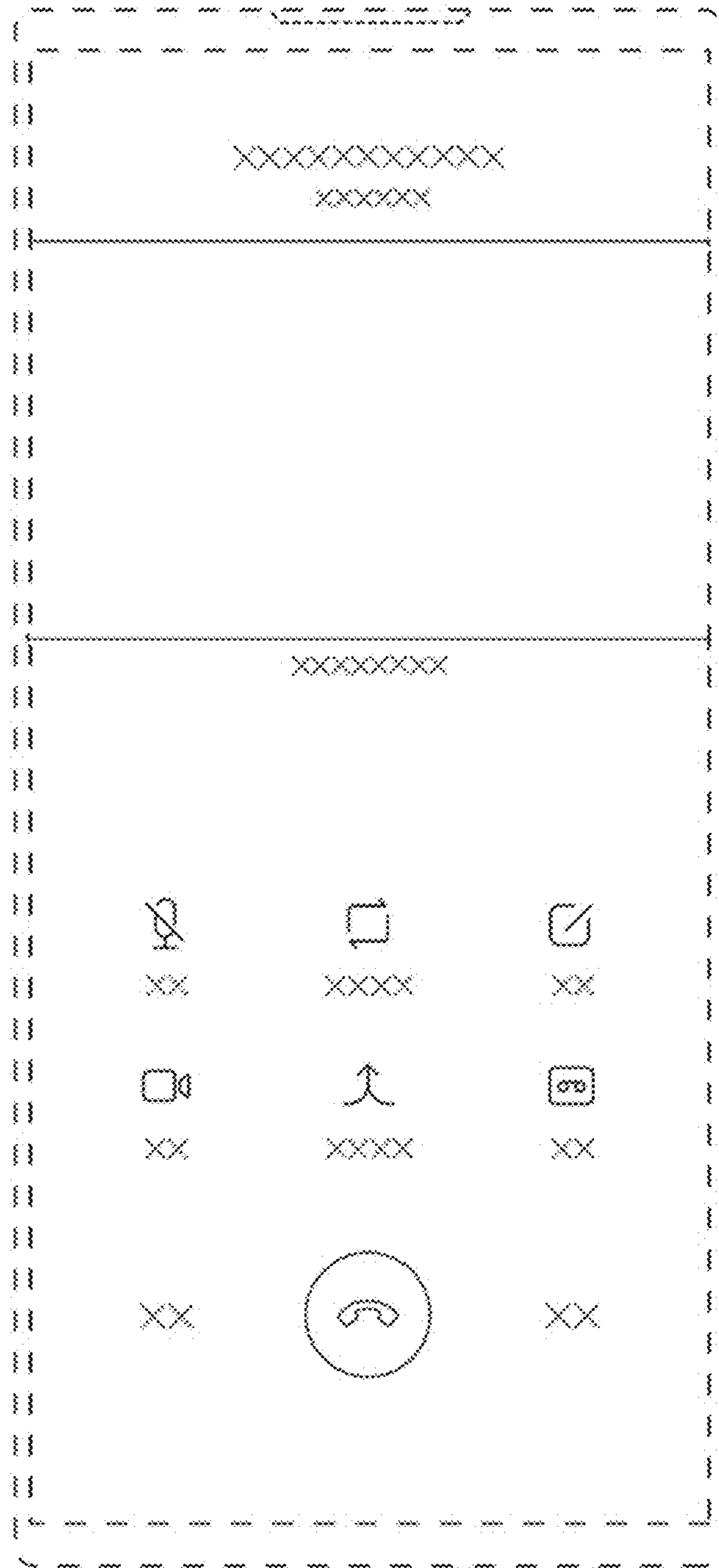
