DESCRIPTION

 The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

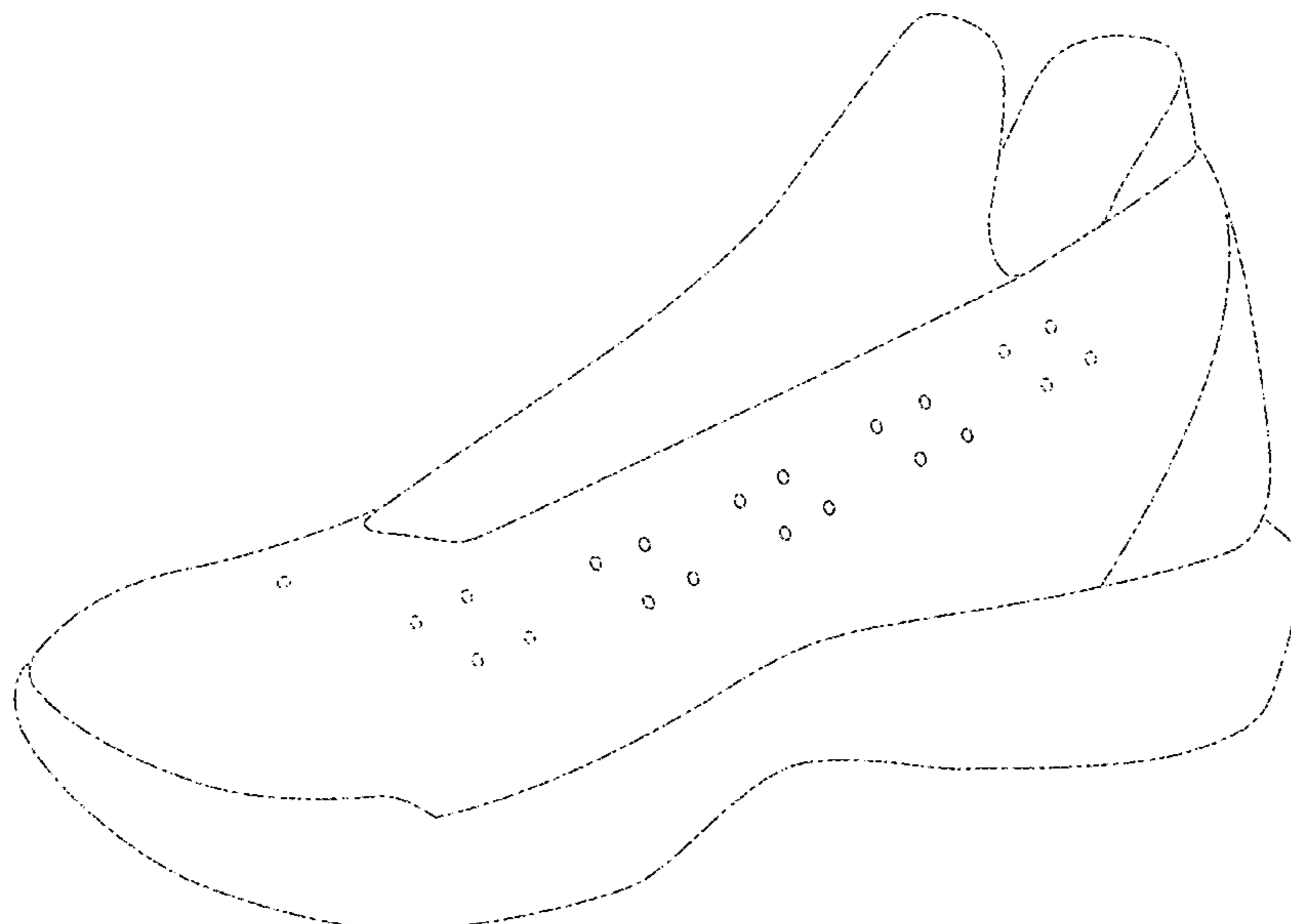

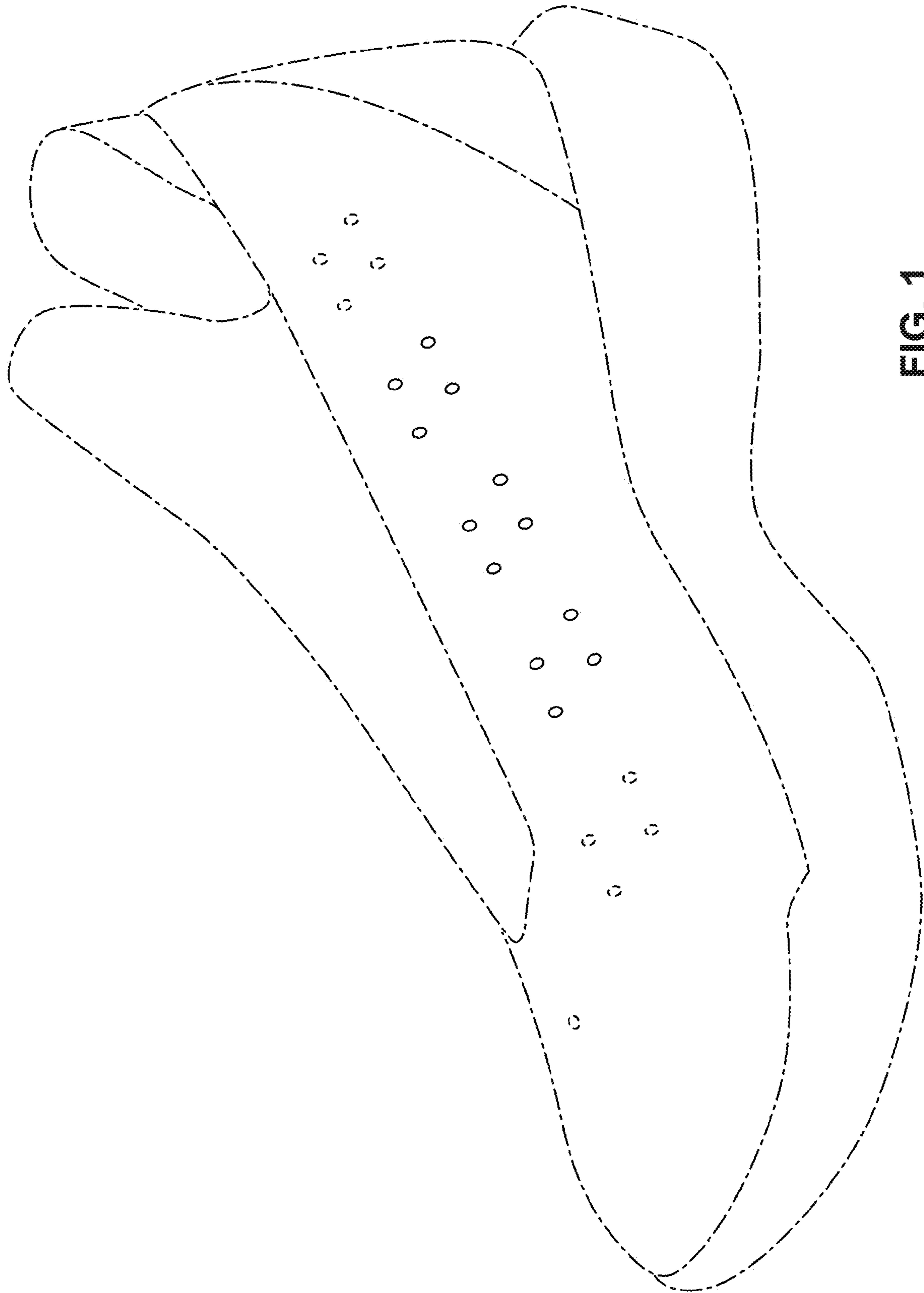

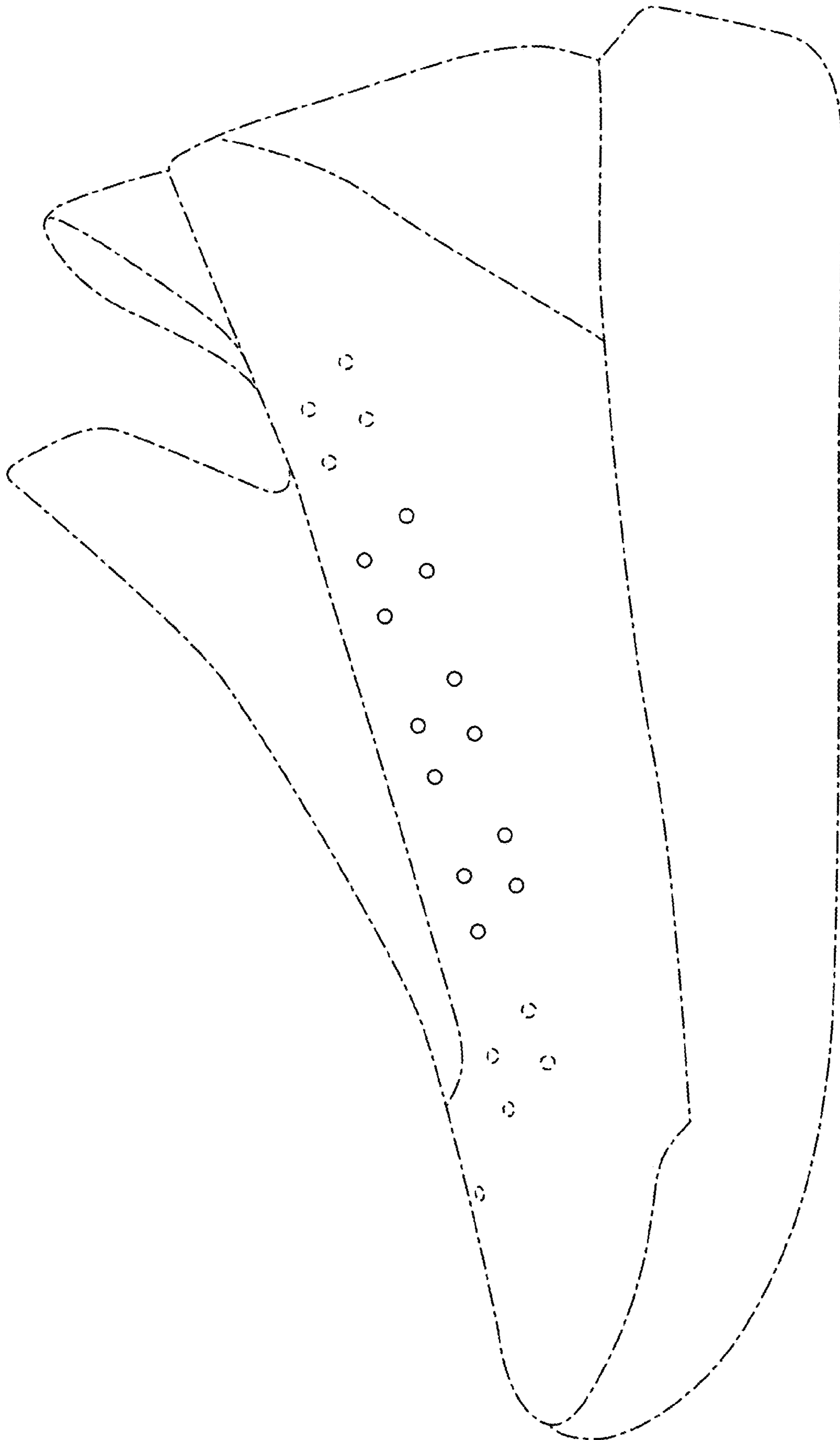

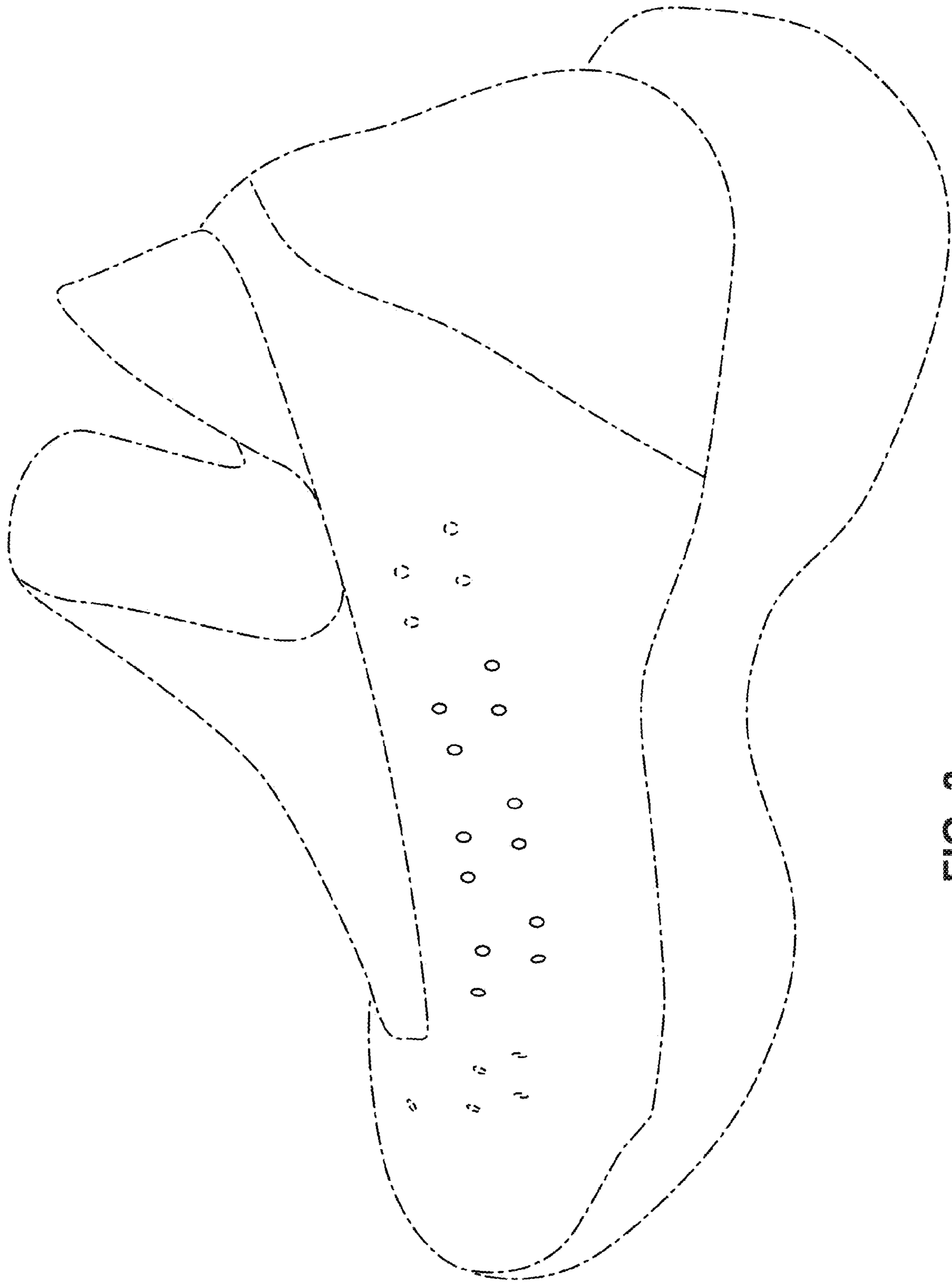

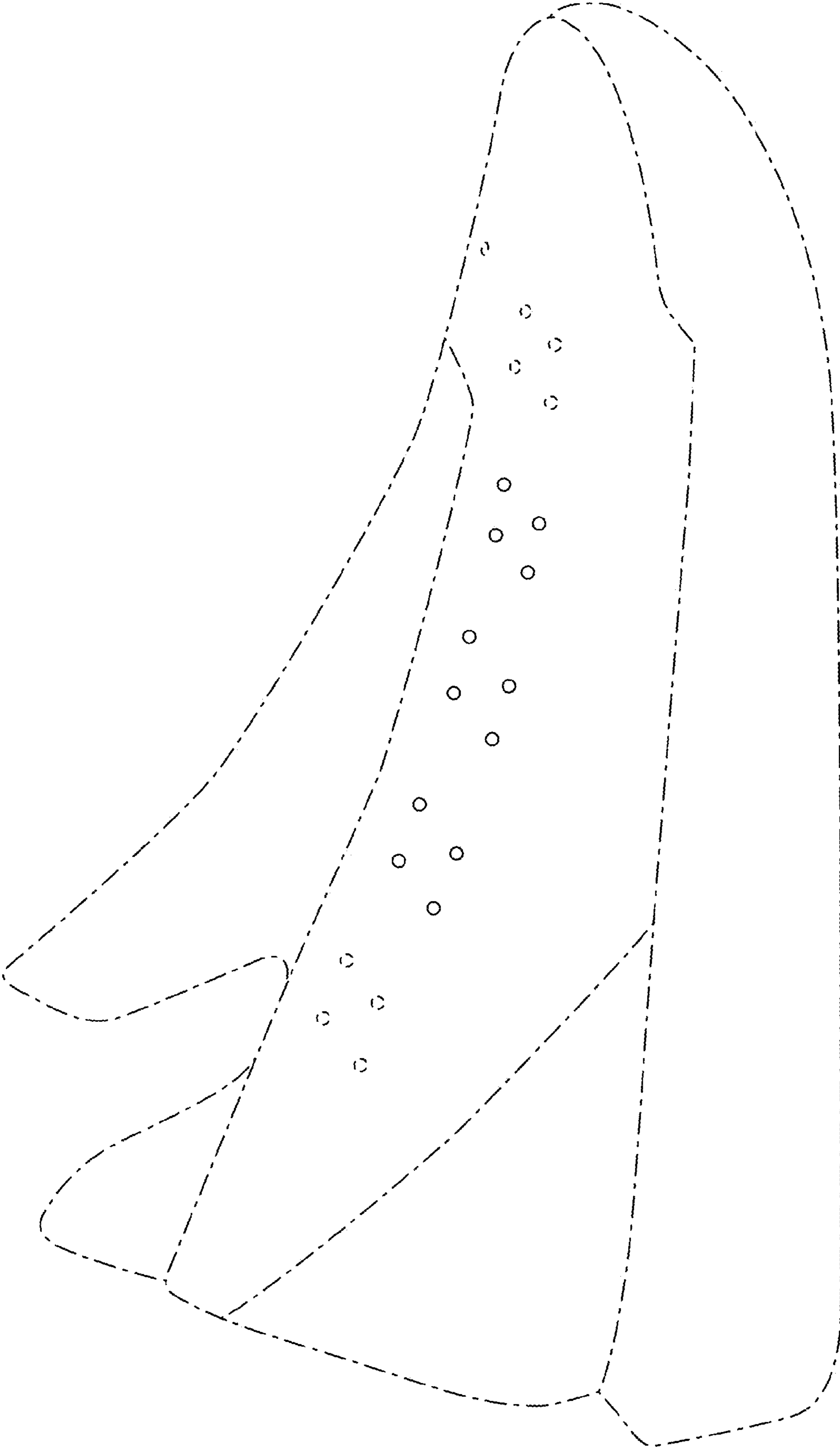

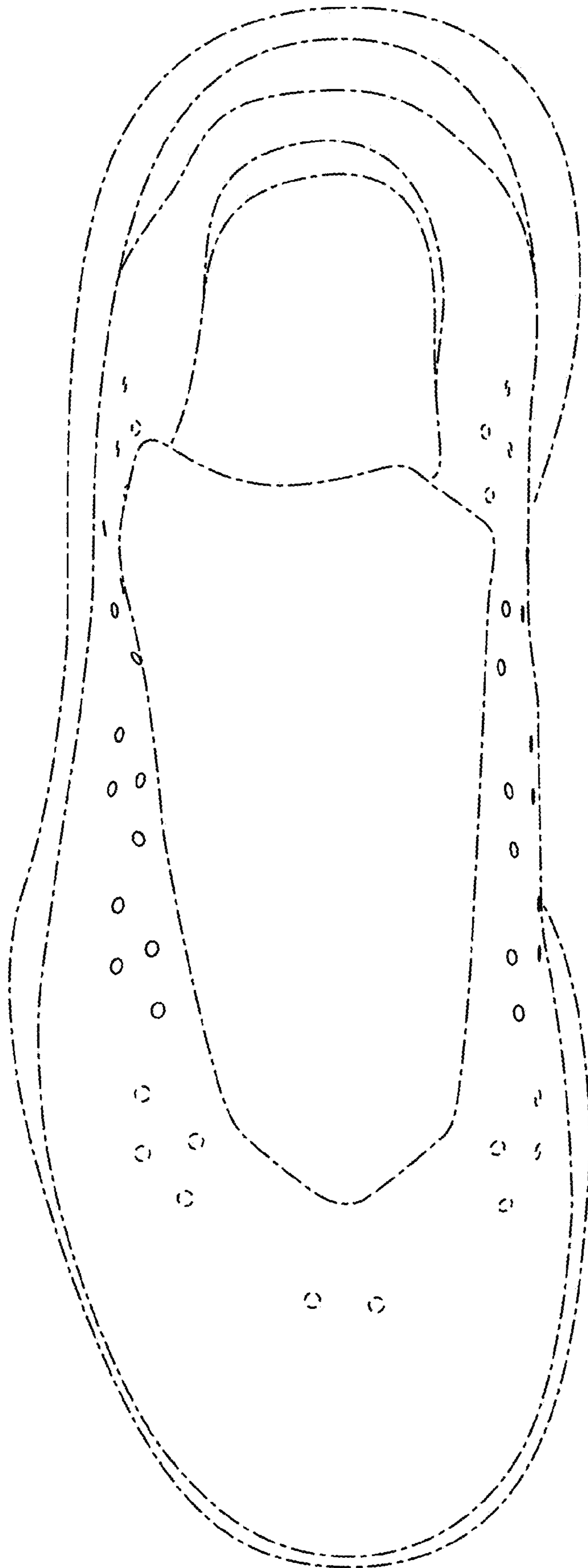

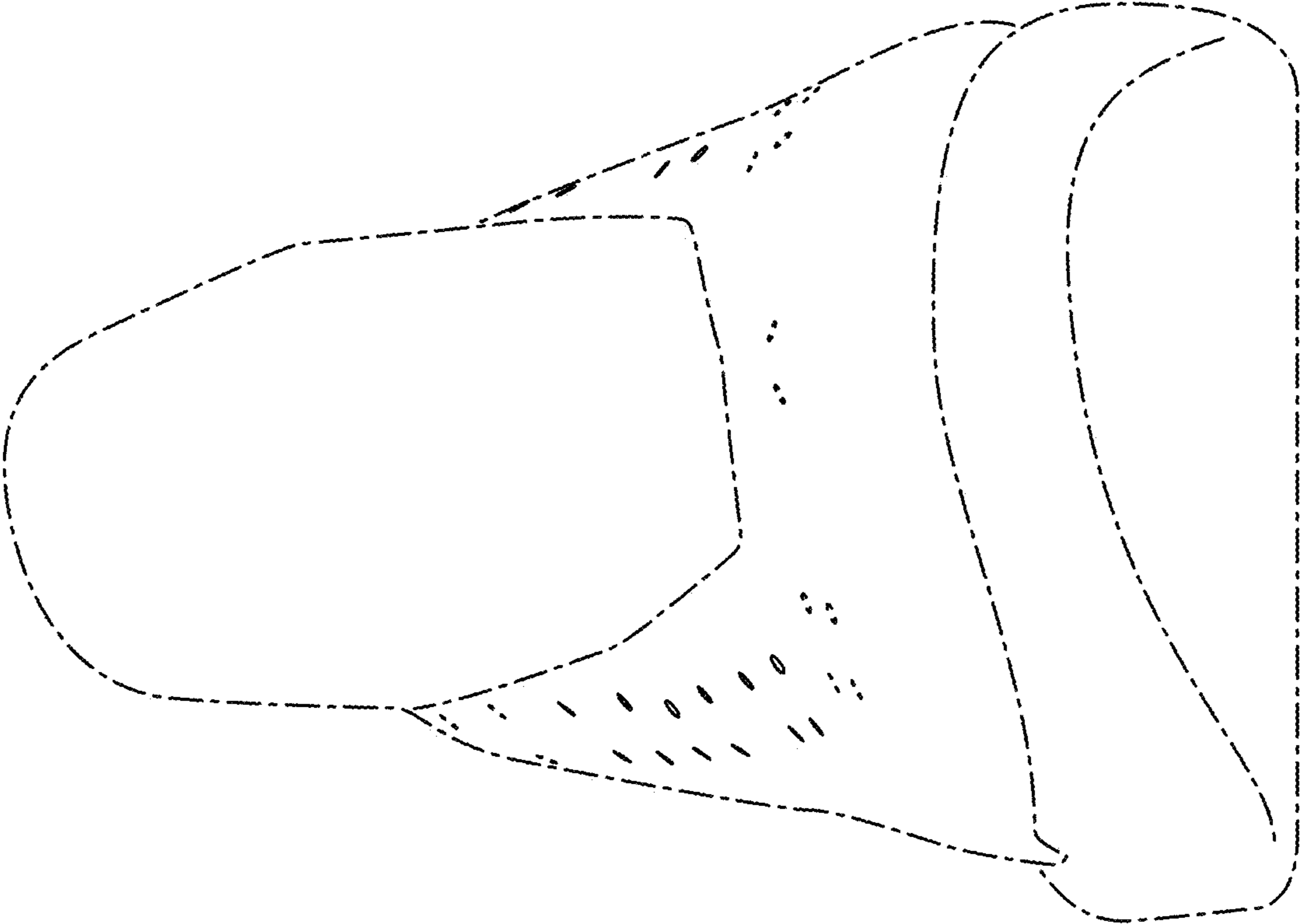

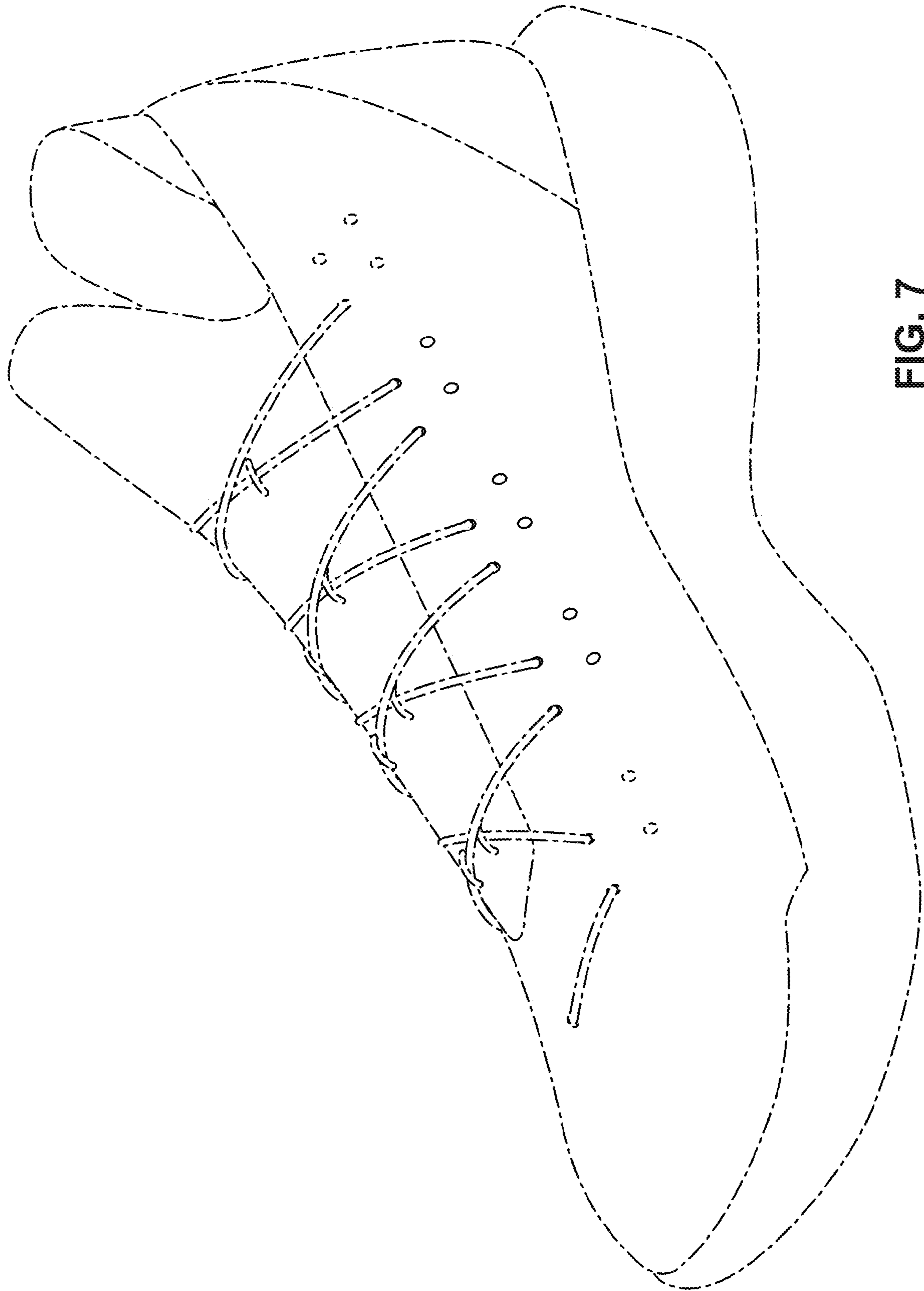

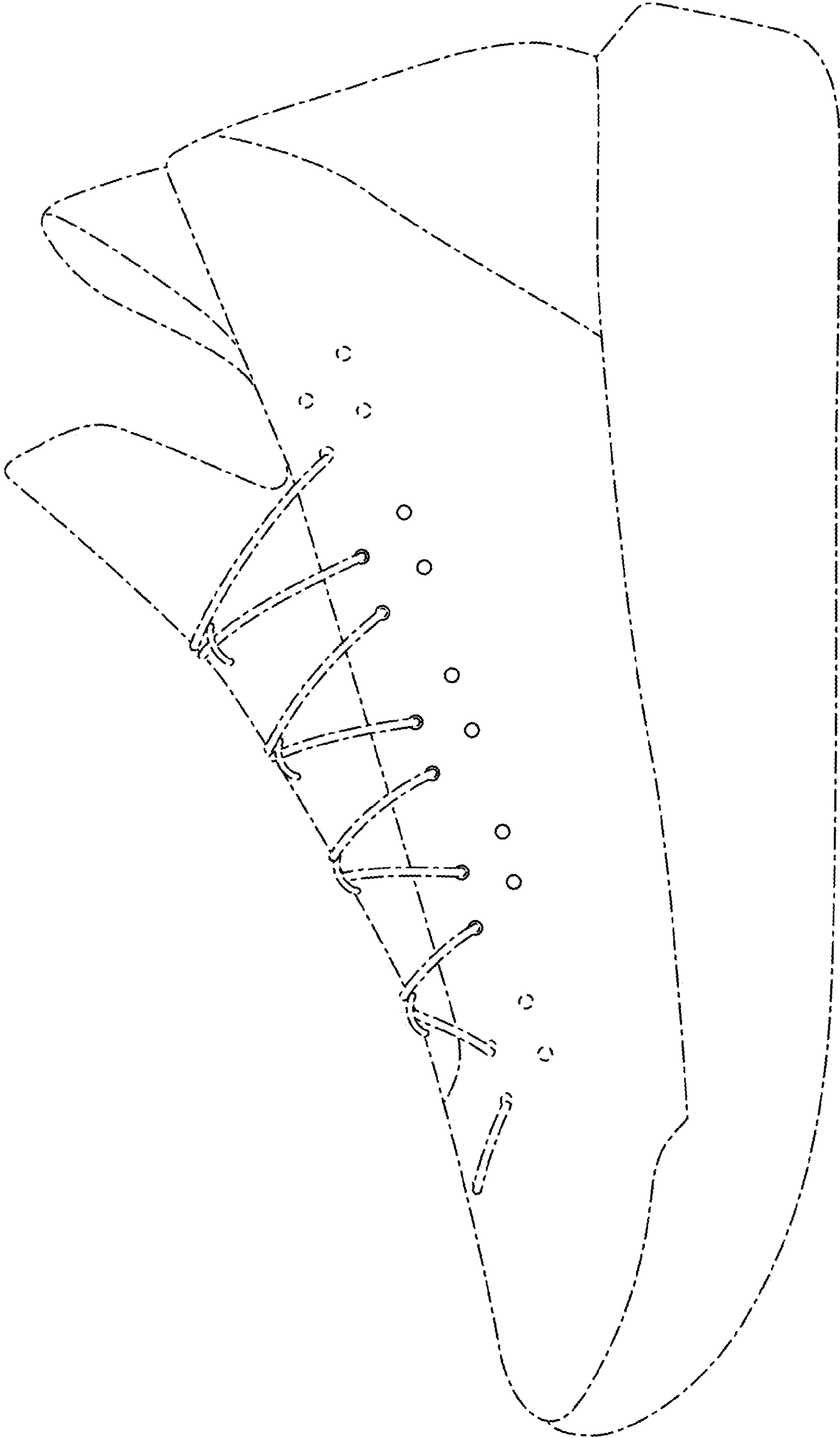

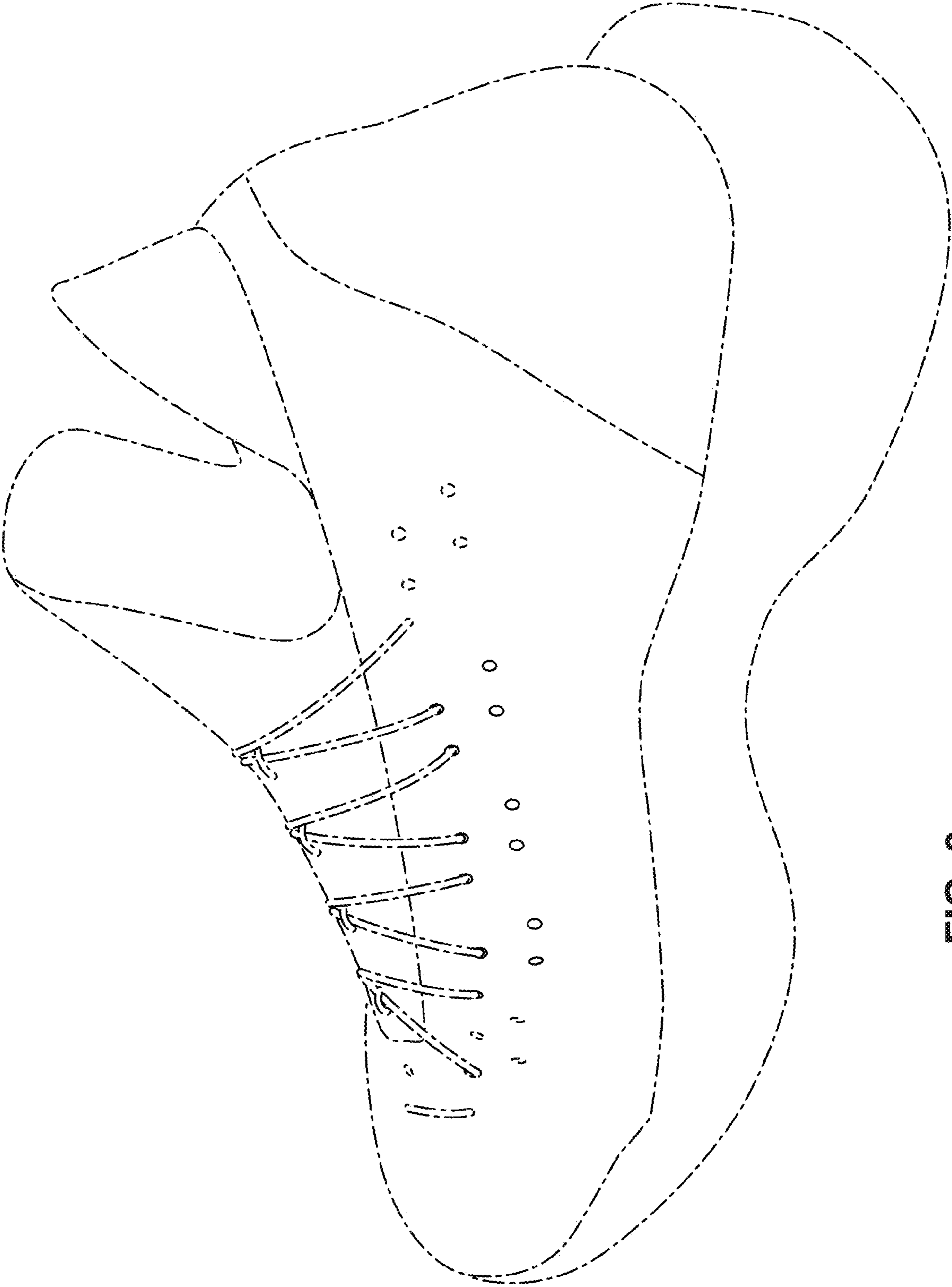

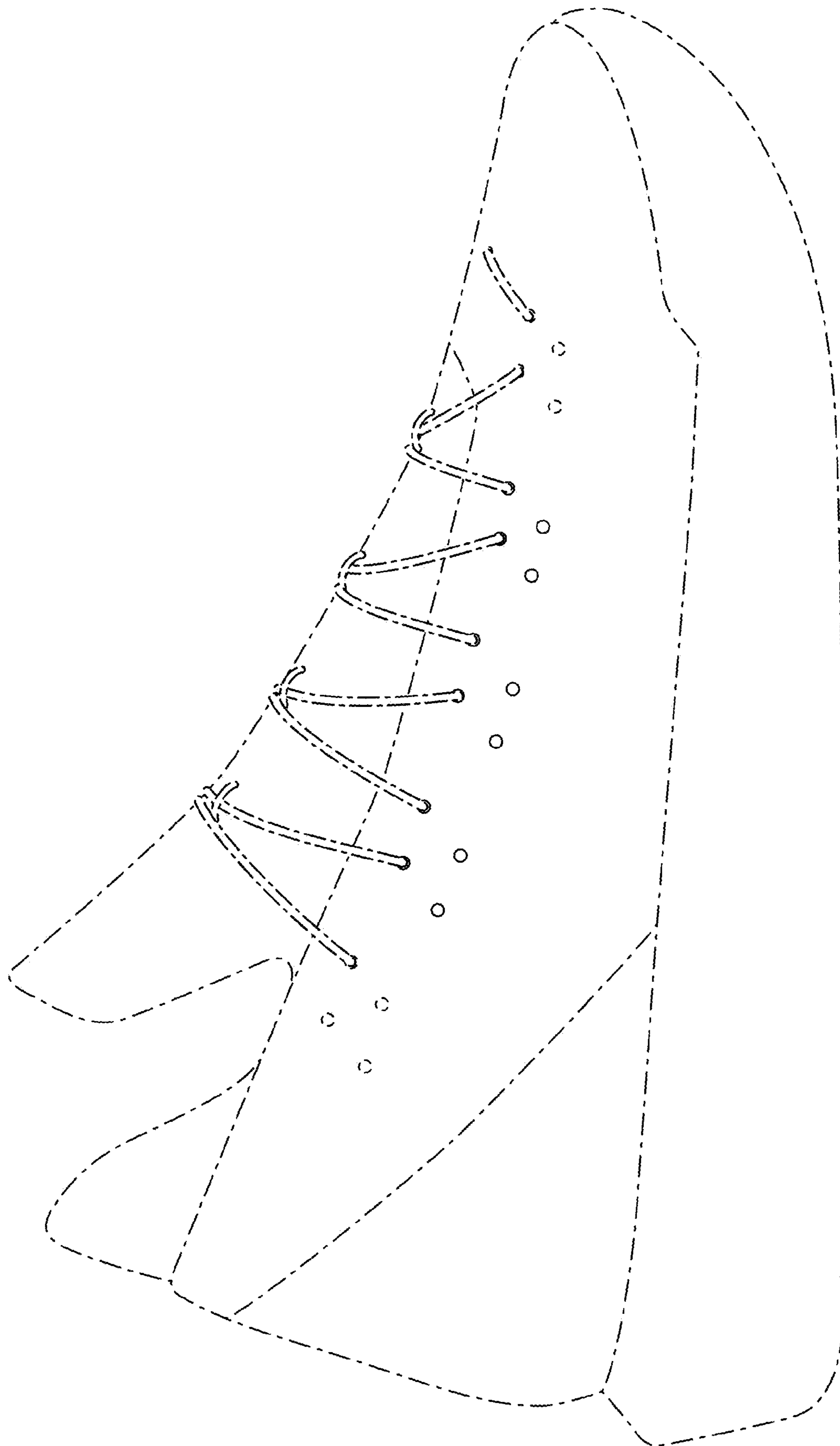

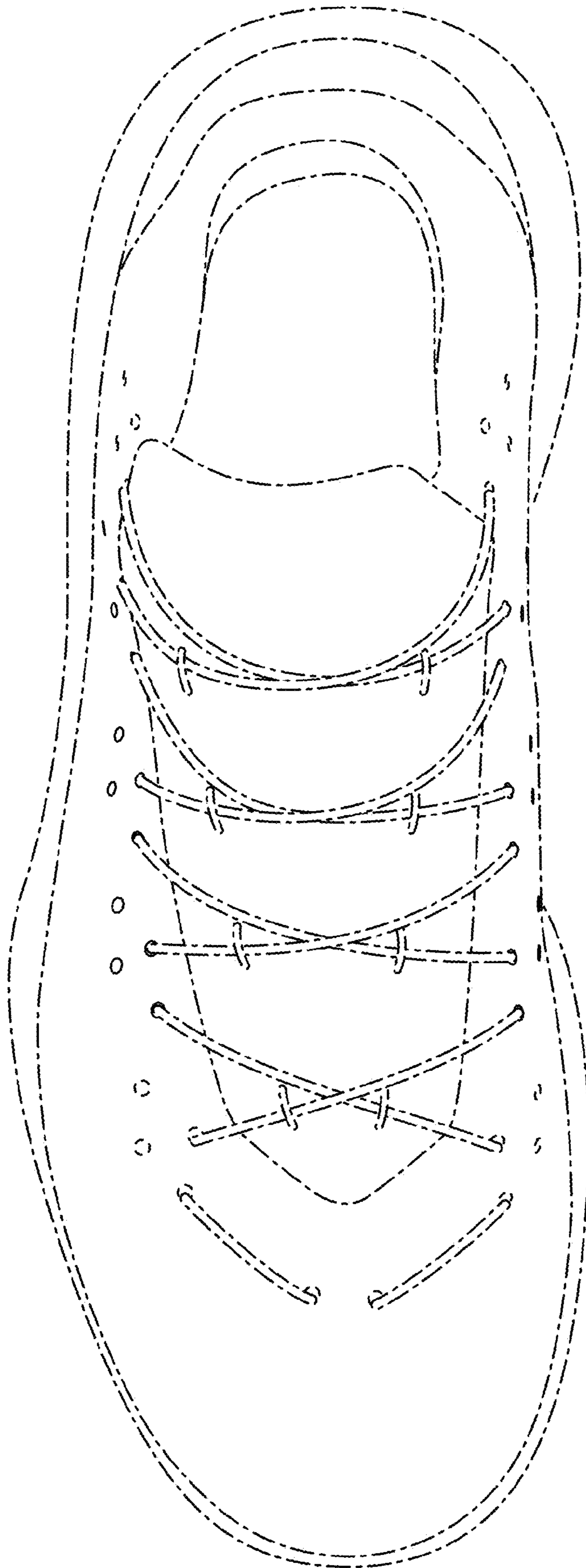

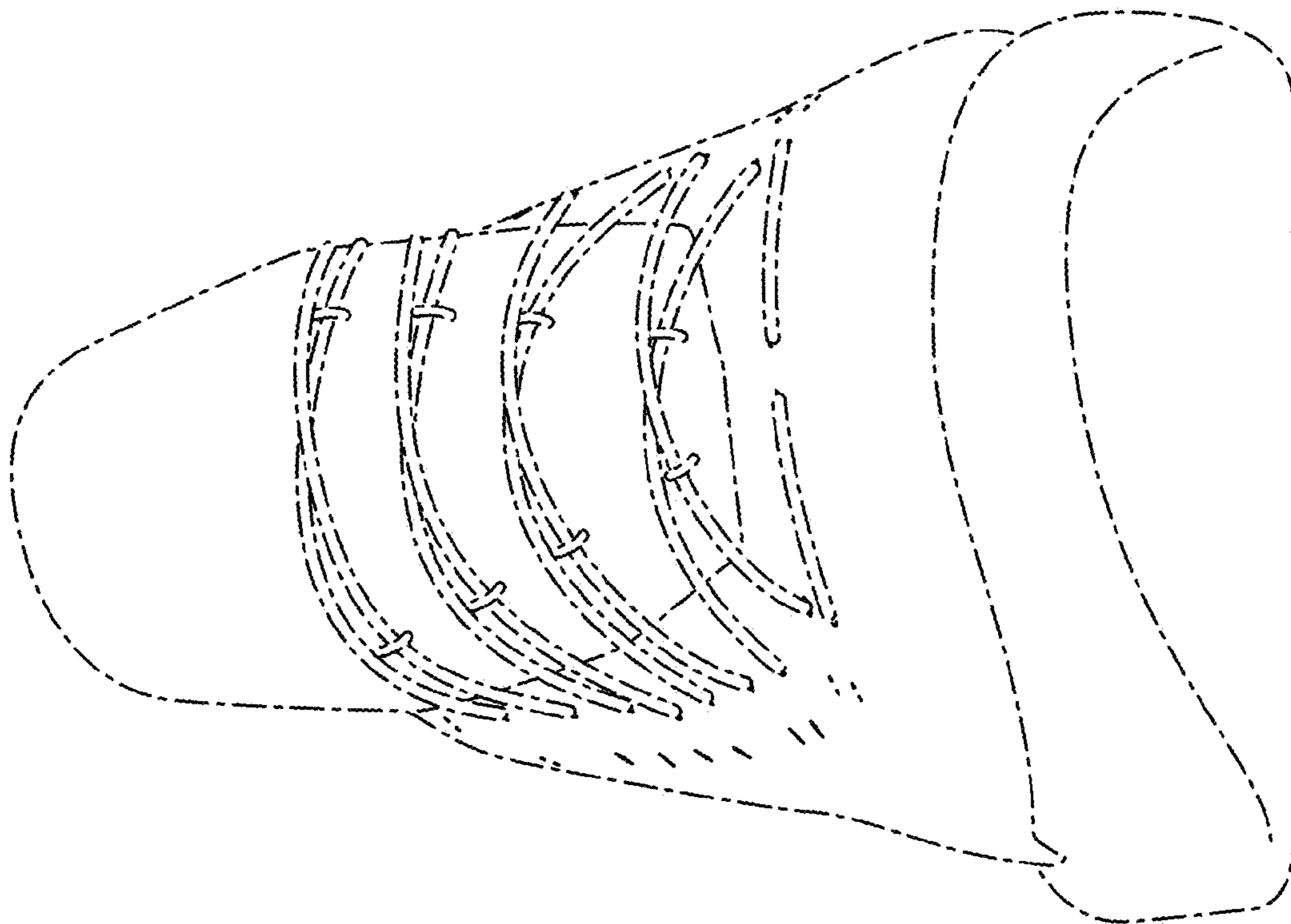
