FIG. 4.5 is a back view thereof;

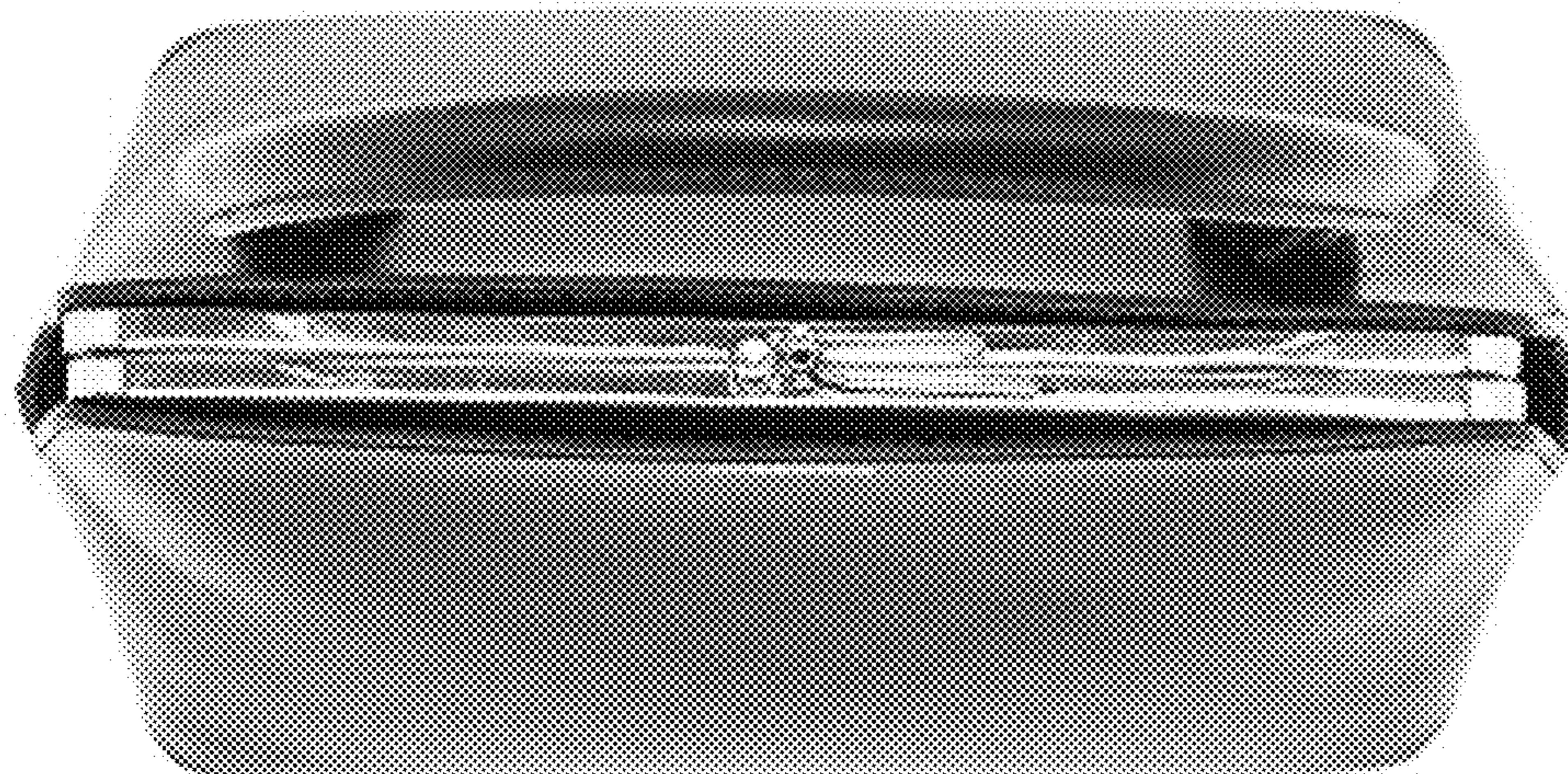
FIG. 4.6 is a close-up top perspective view thereof; and

FIG. 4.7 is a front view thereof.

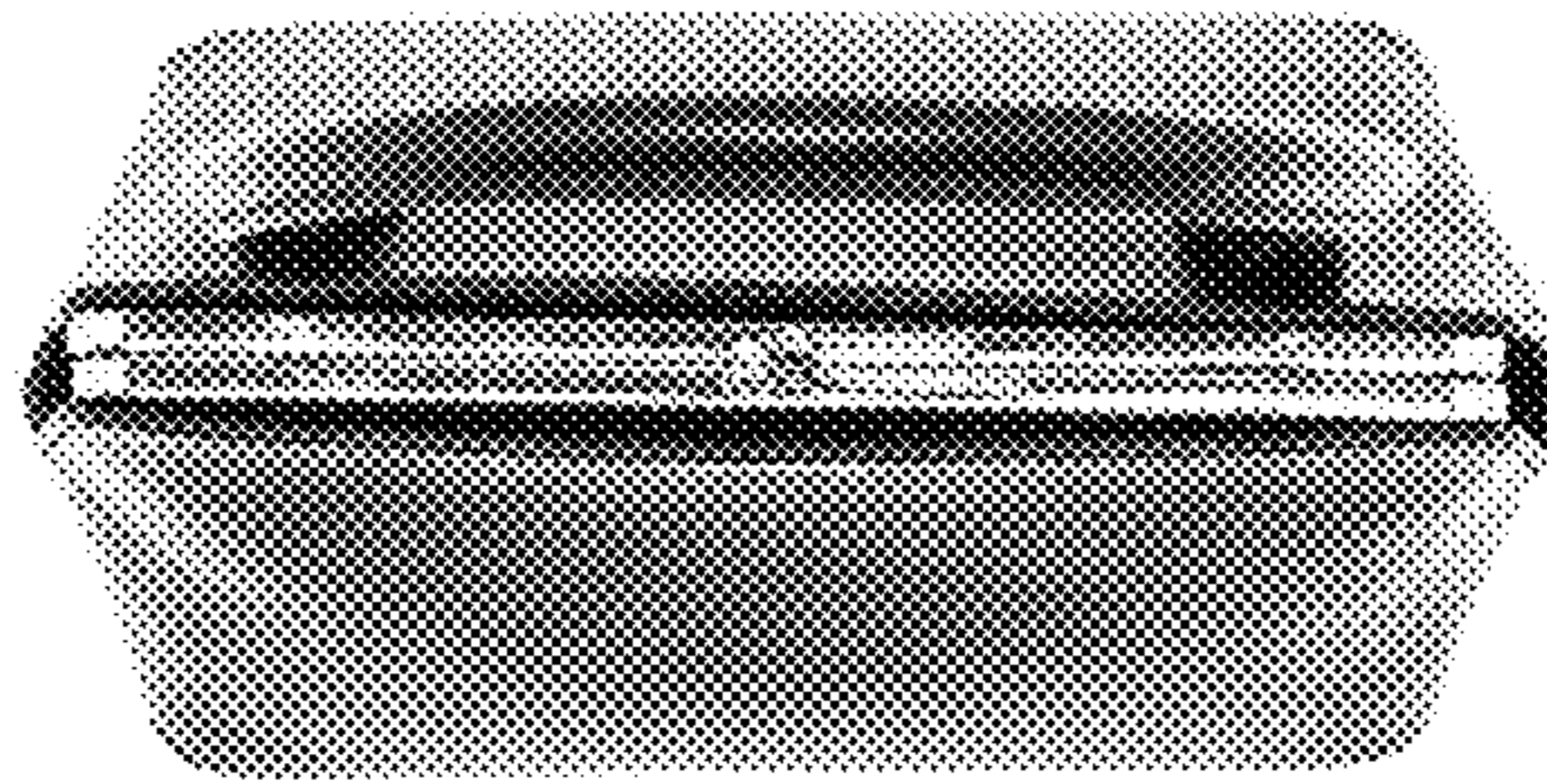

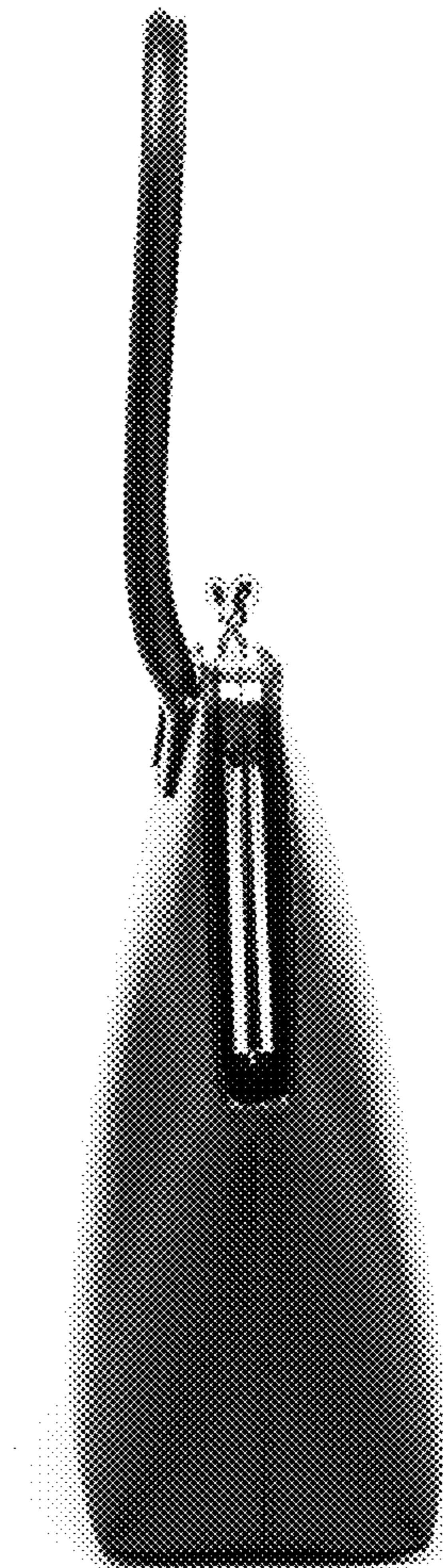
