DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new design;

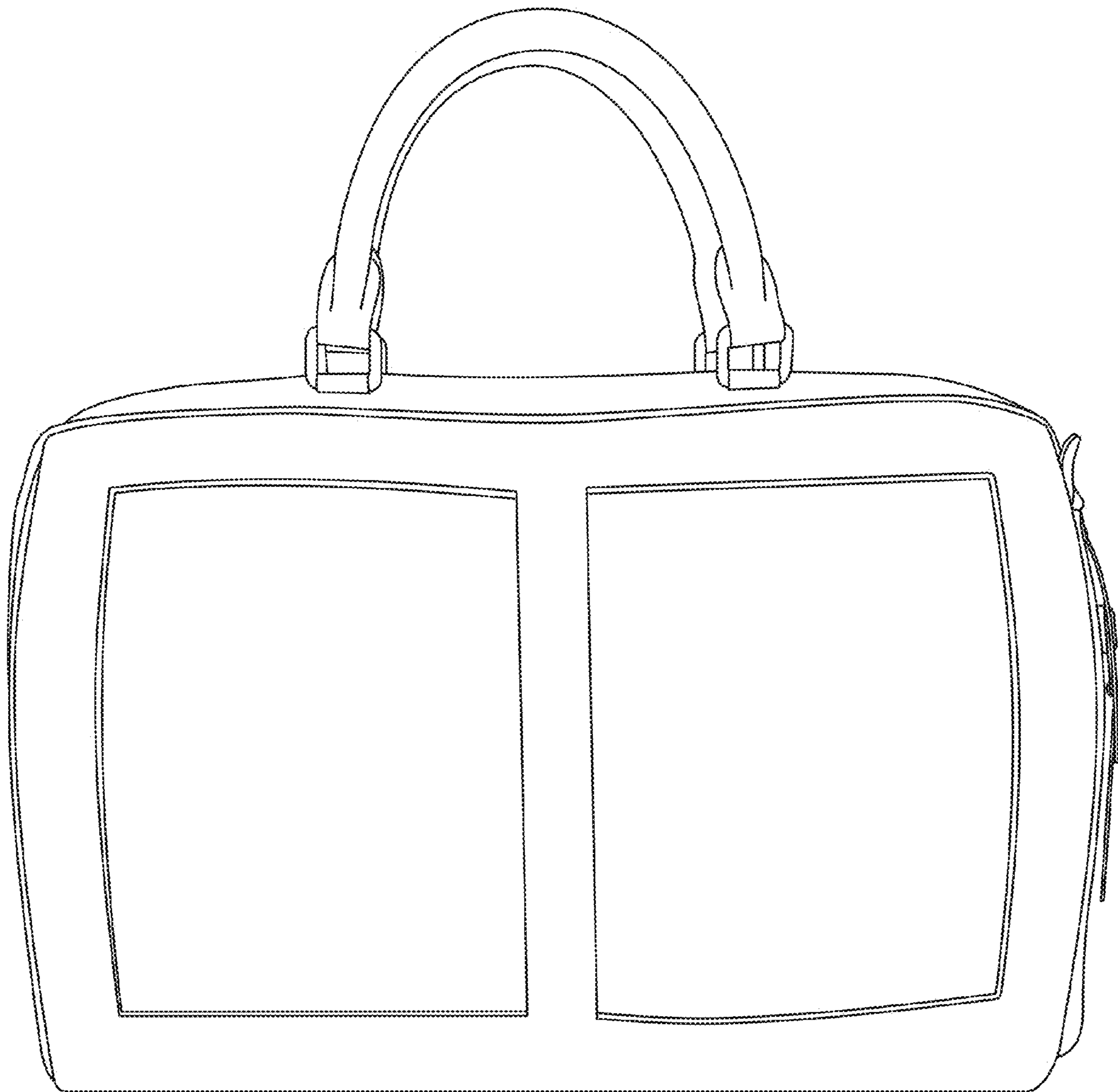

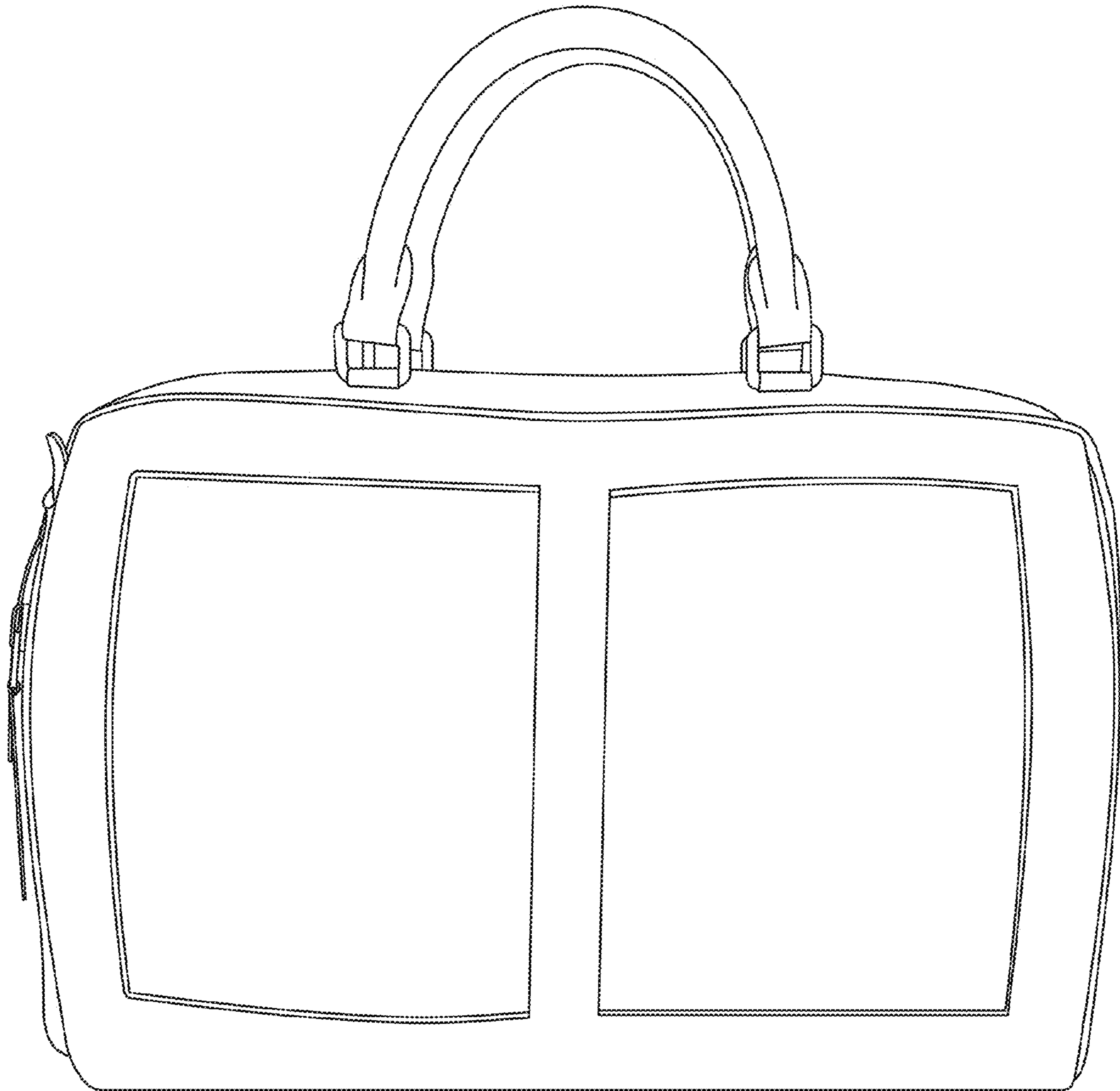

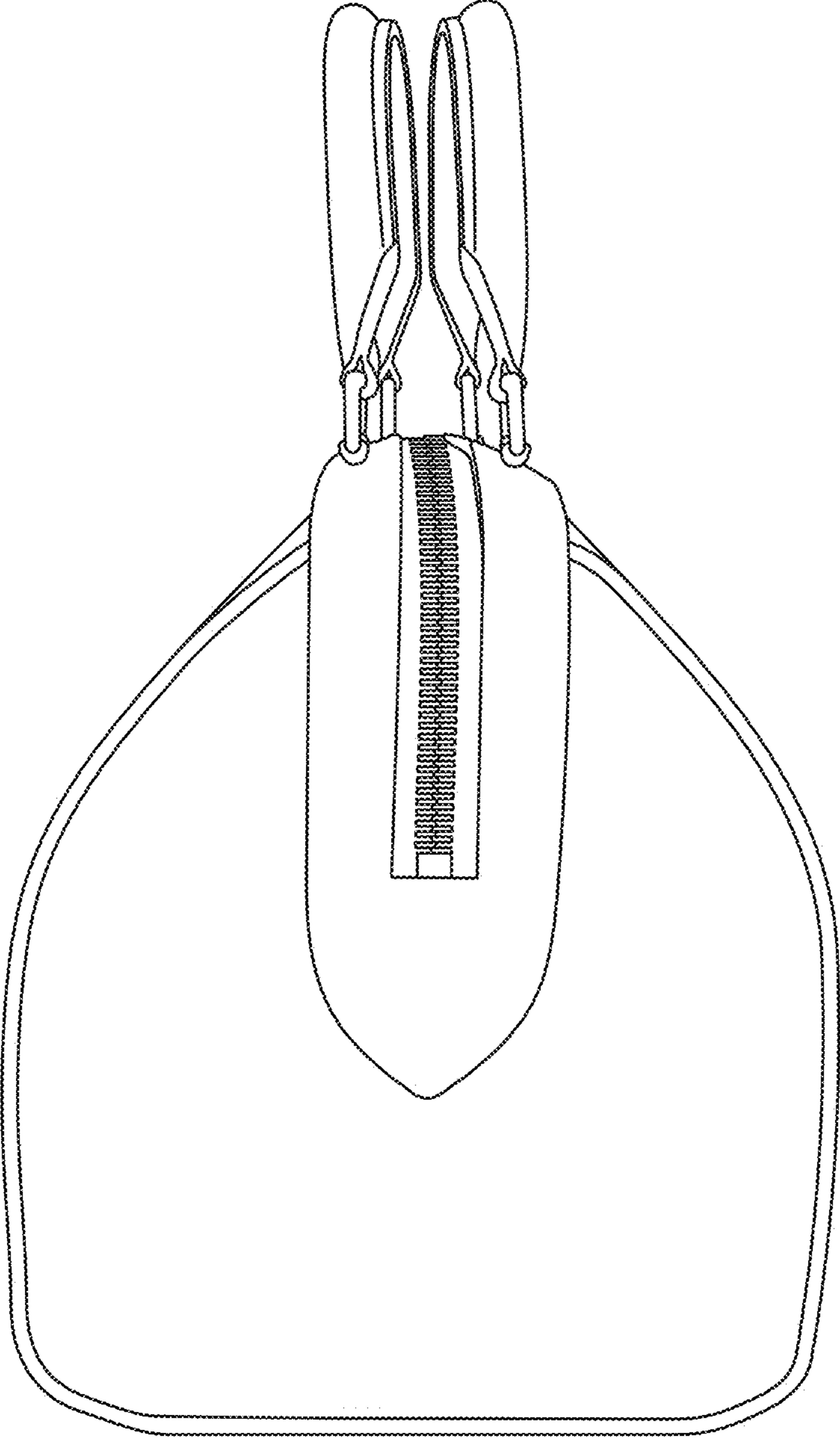

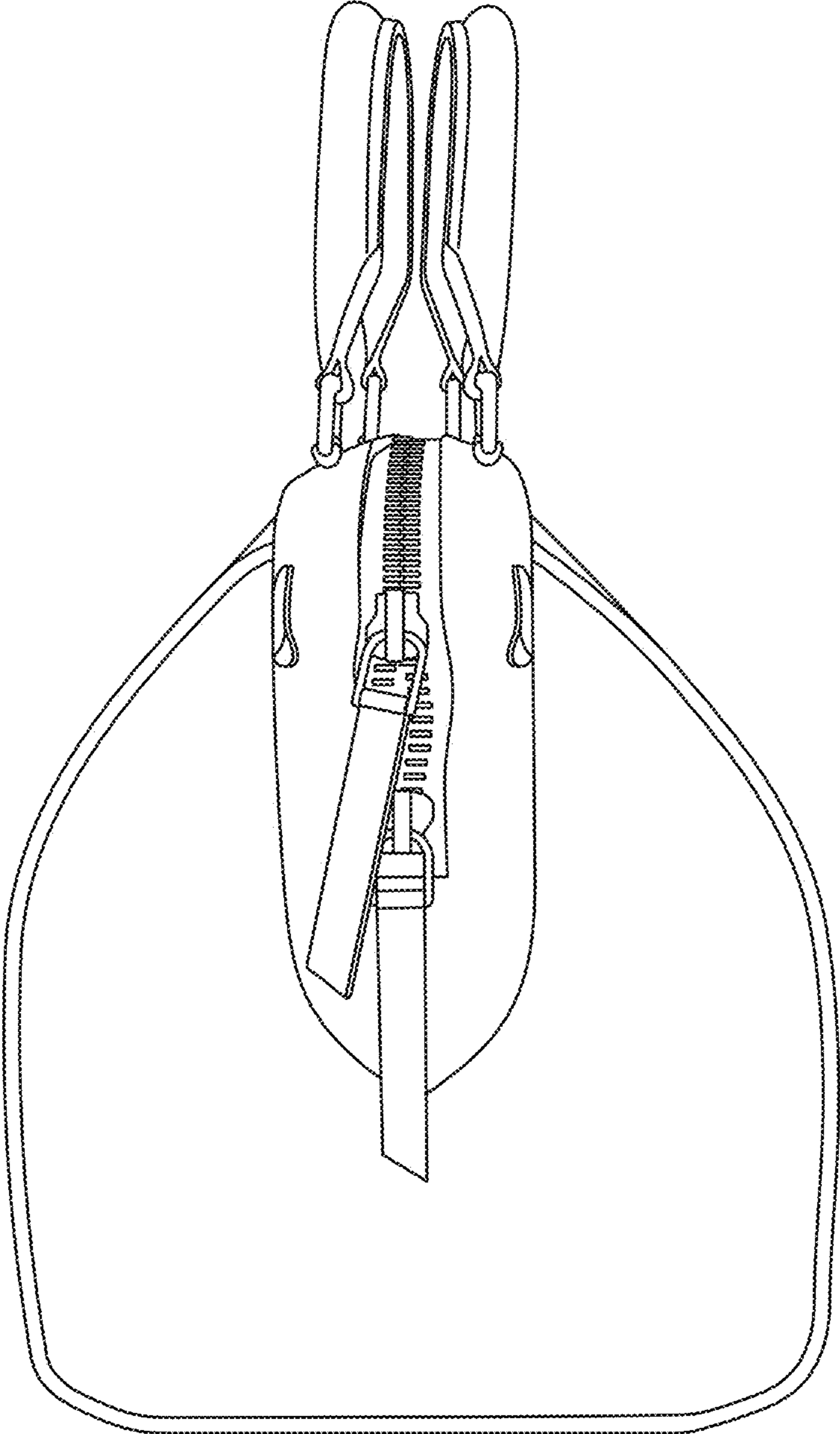

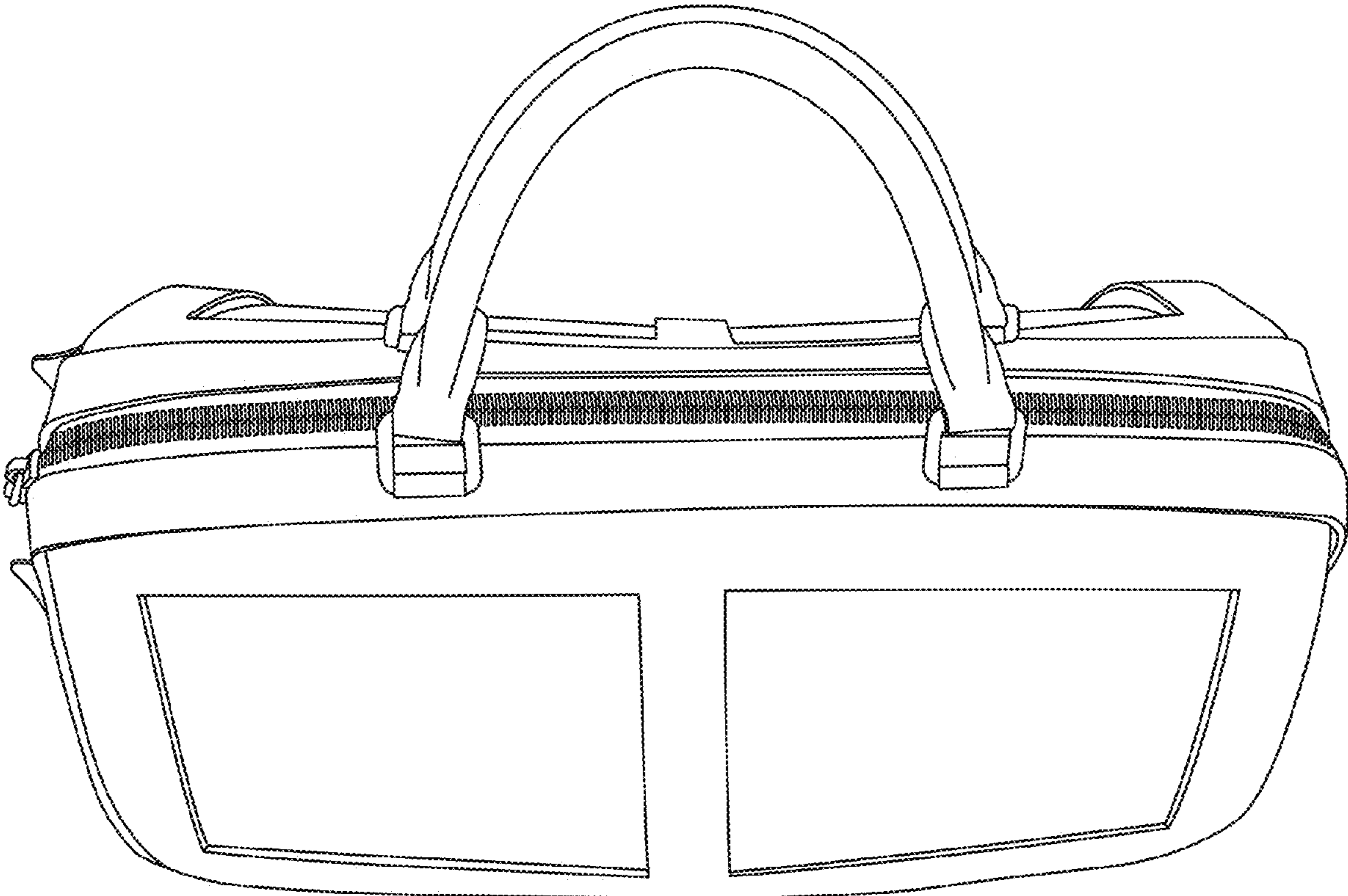

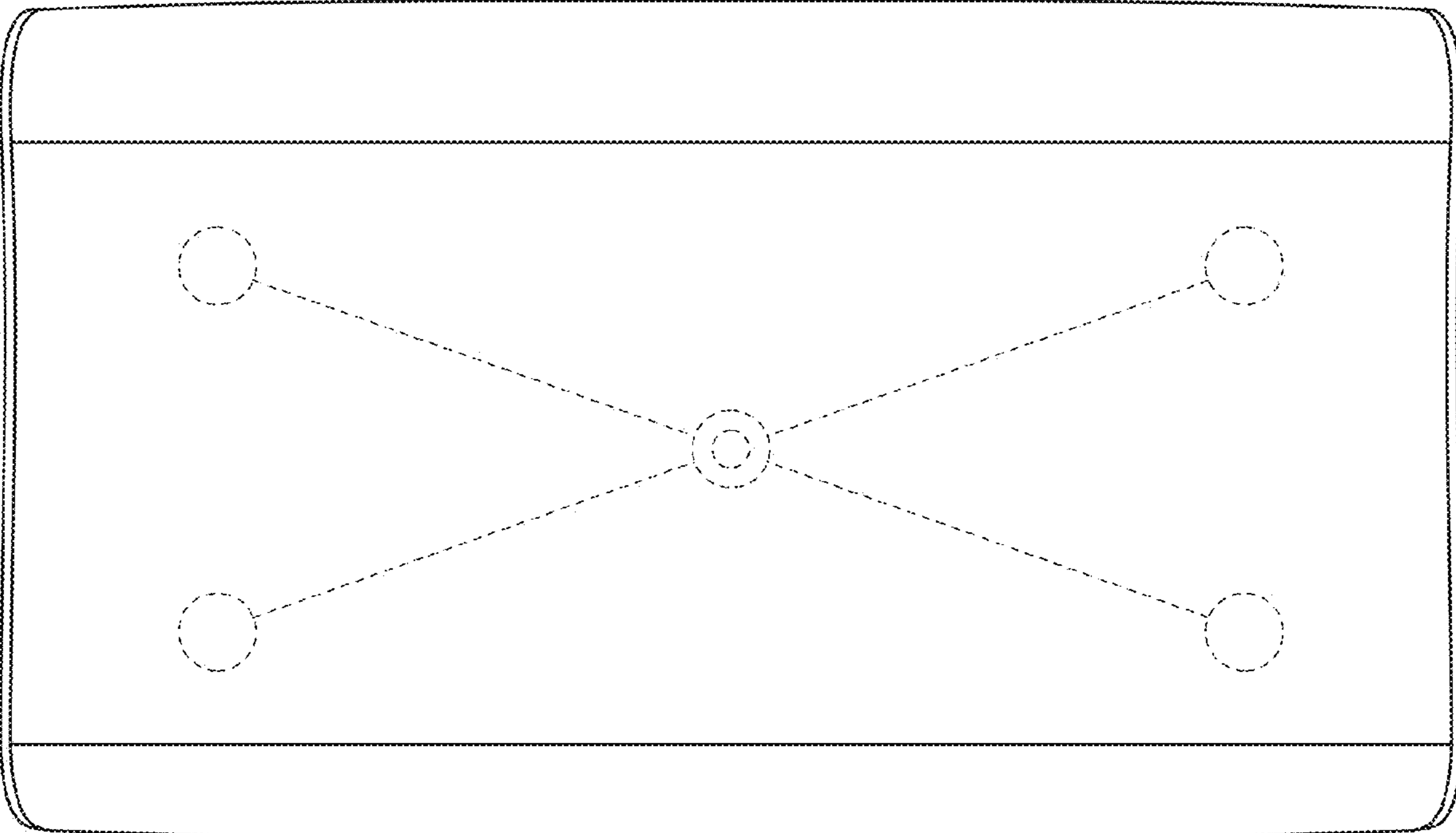
