(57) **CLAIM**

The ornamental design for a back and seat for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the right side, top and front of a back and seat for a chair which forms my new design;

FIG. 2 is a perspective view showing the left side, top and rear thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

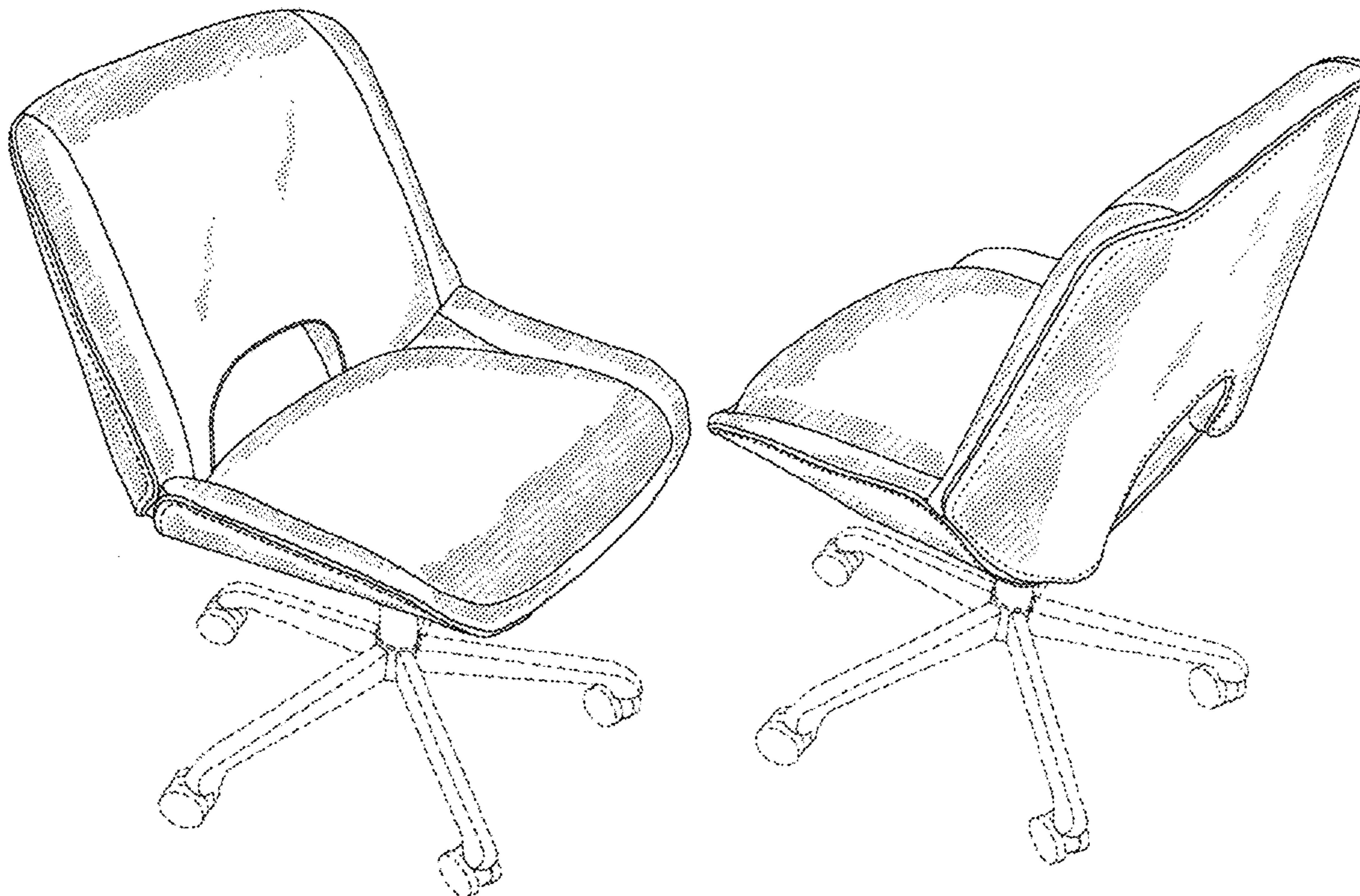
FIG. 6 is a left side elevational view thereof;

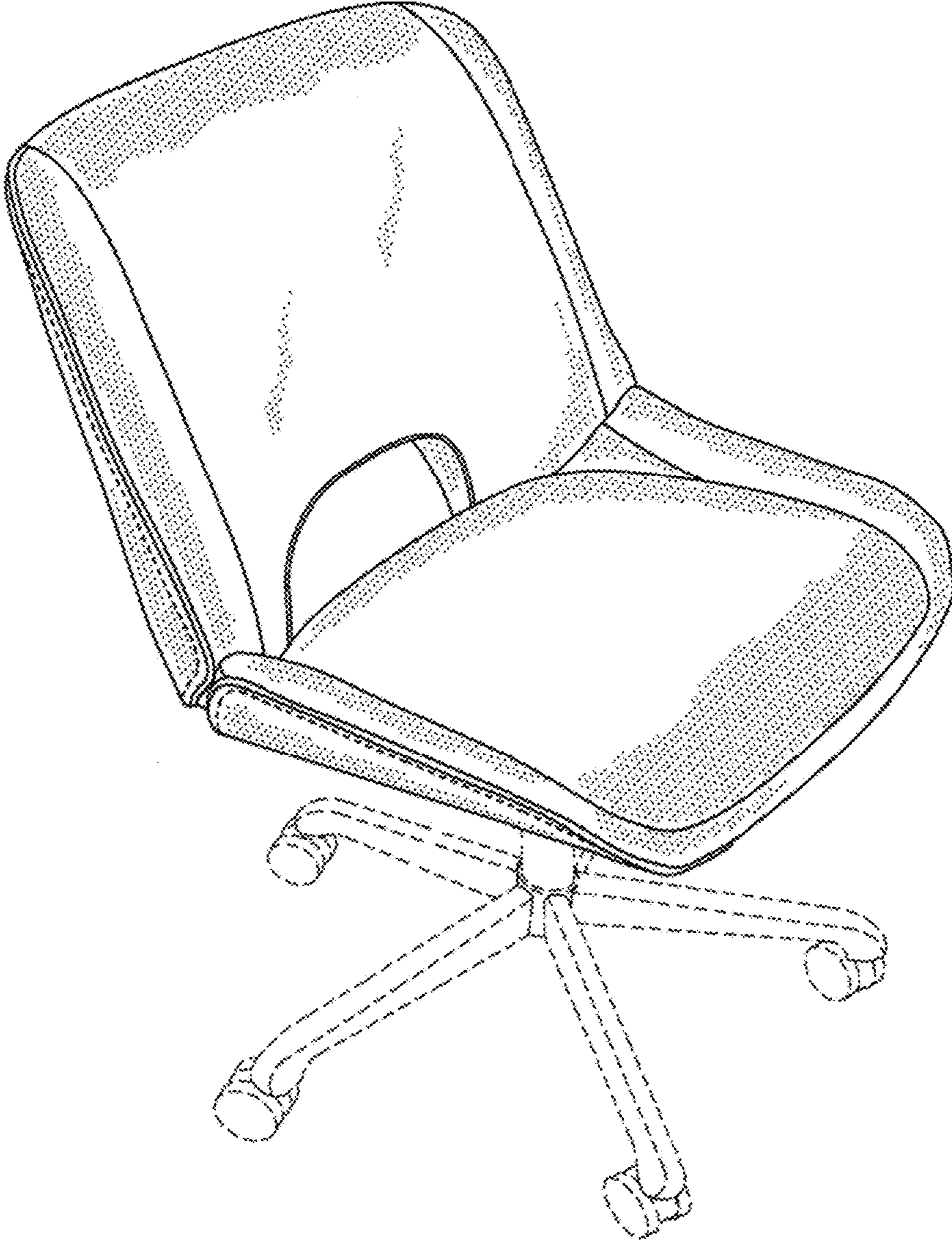

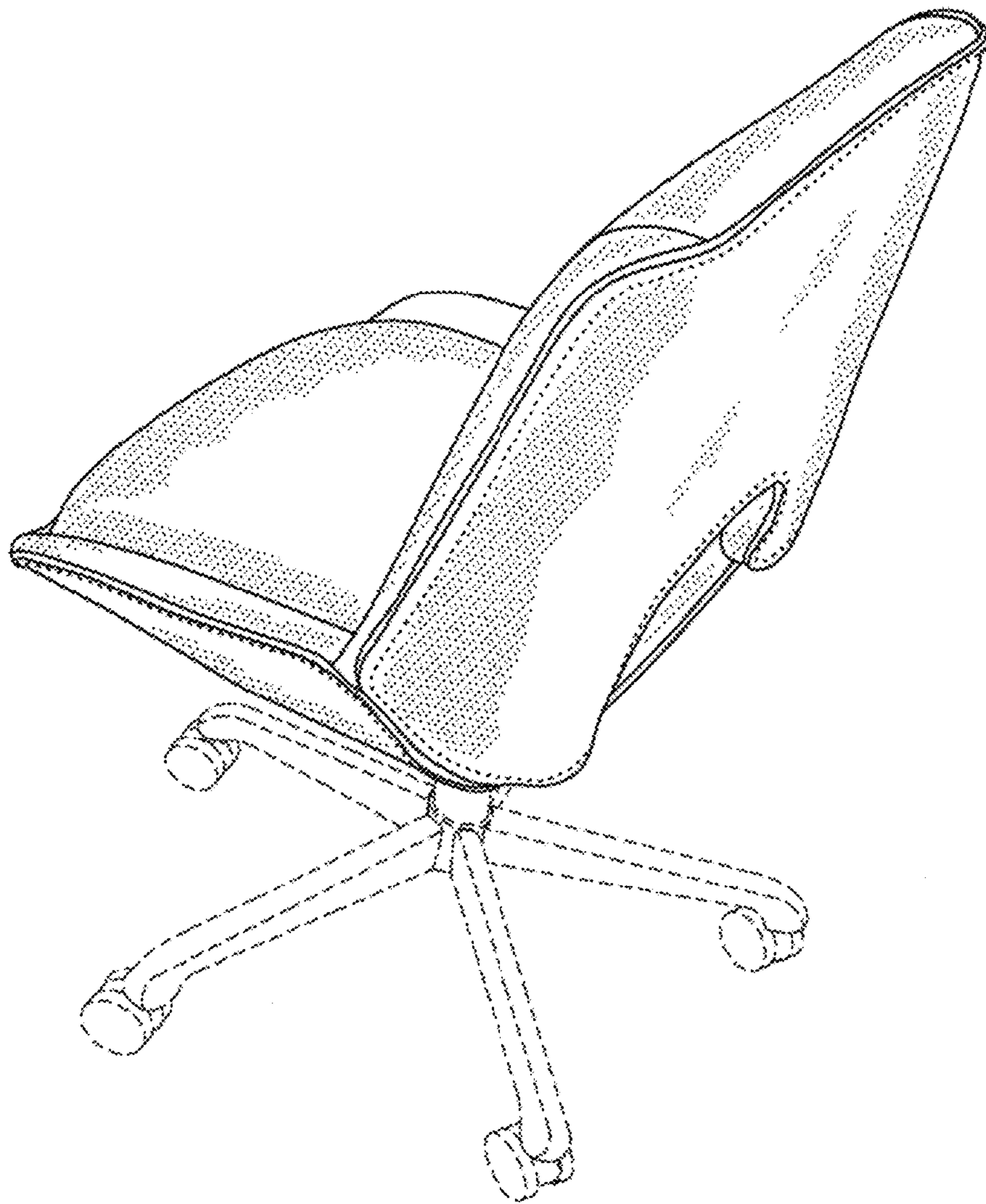

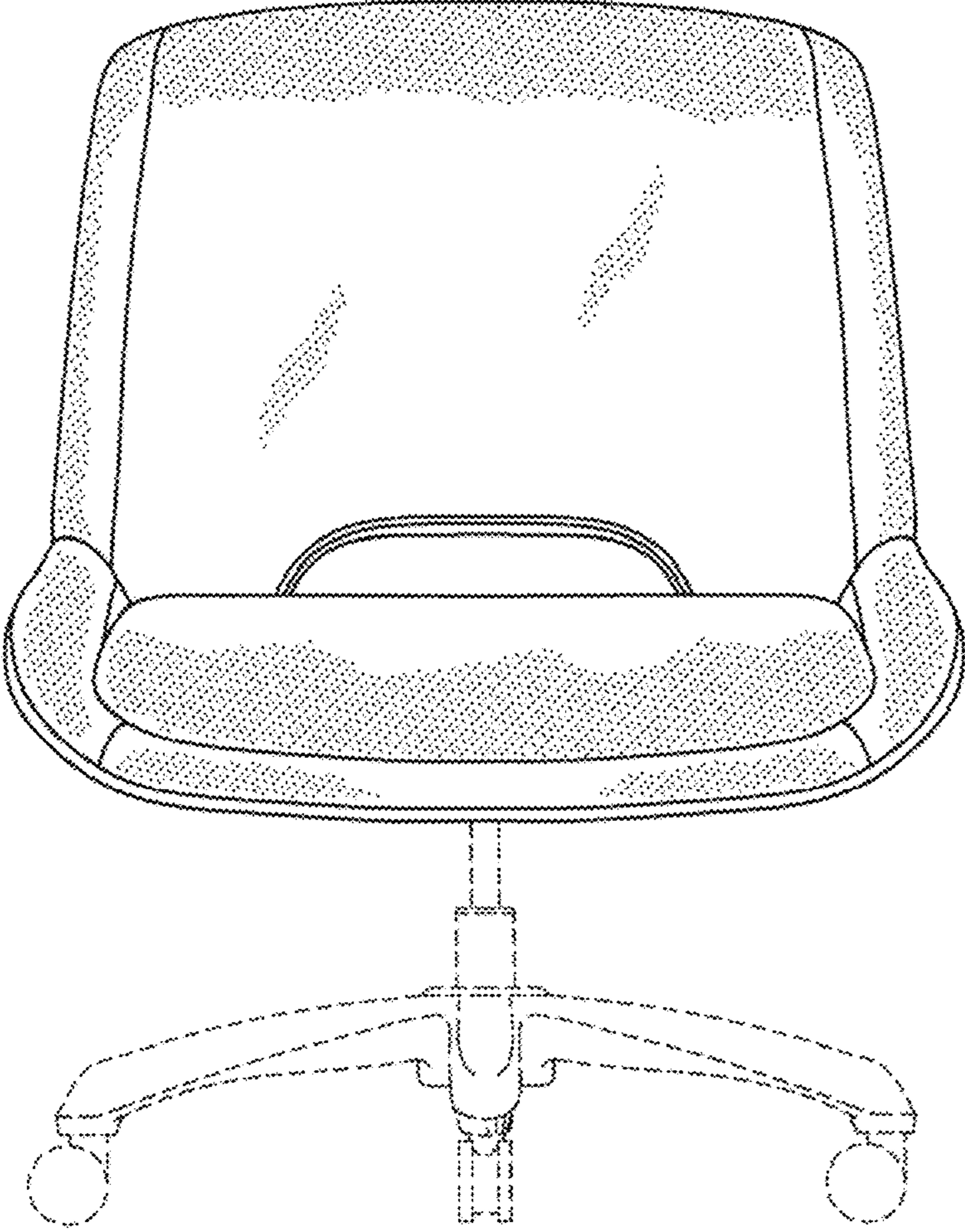

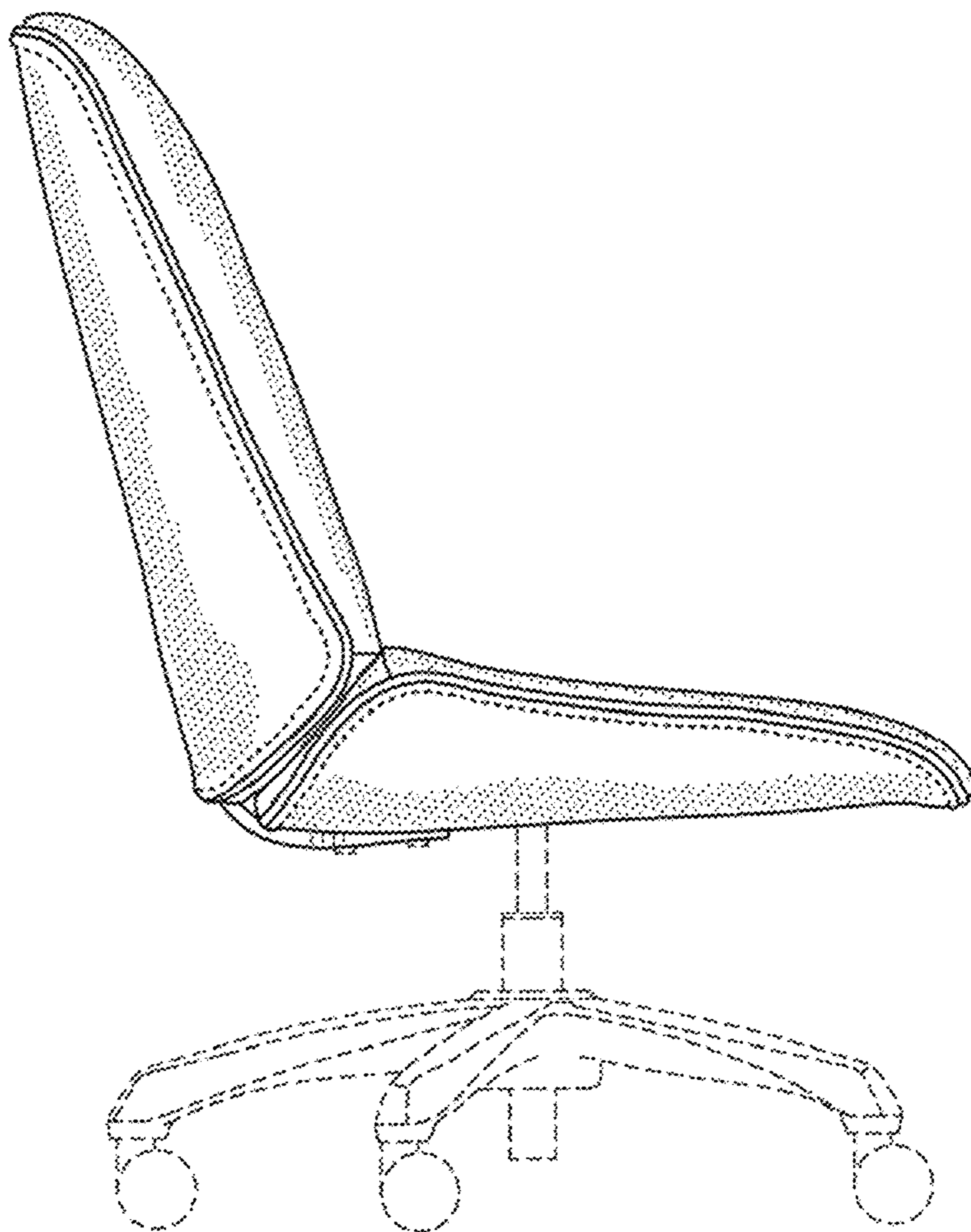

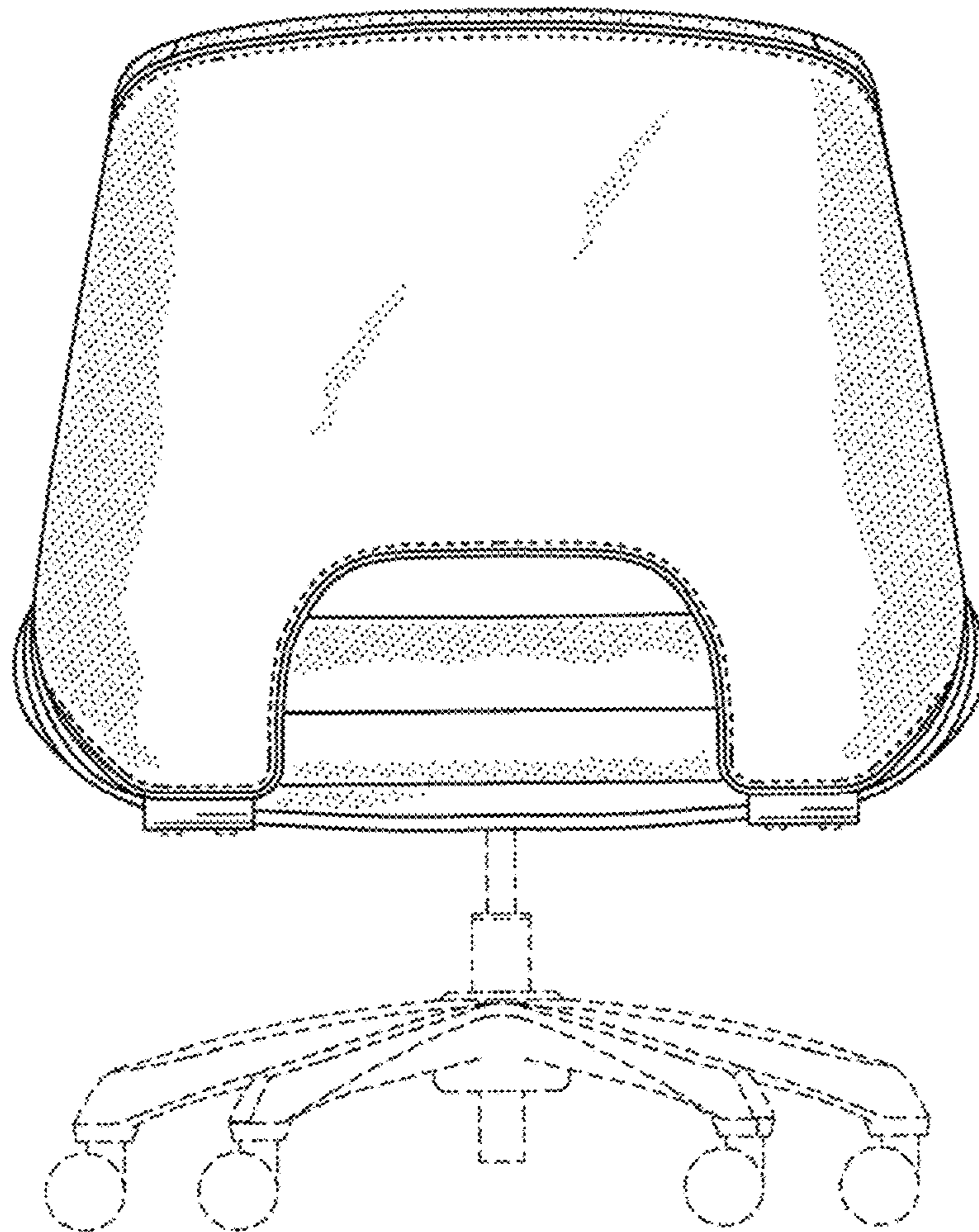

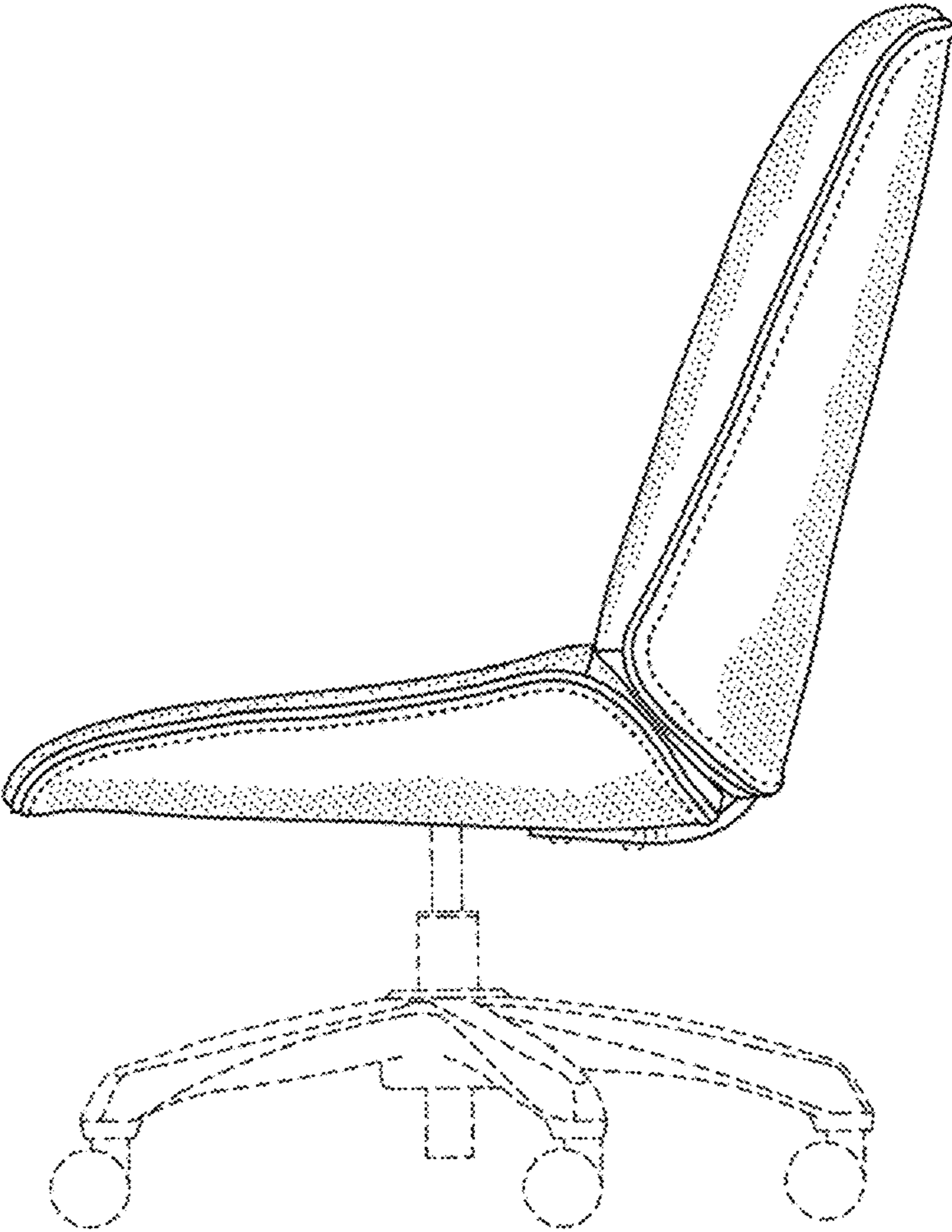

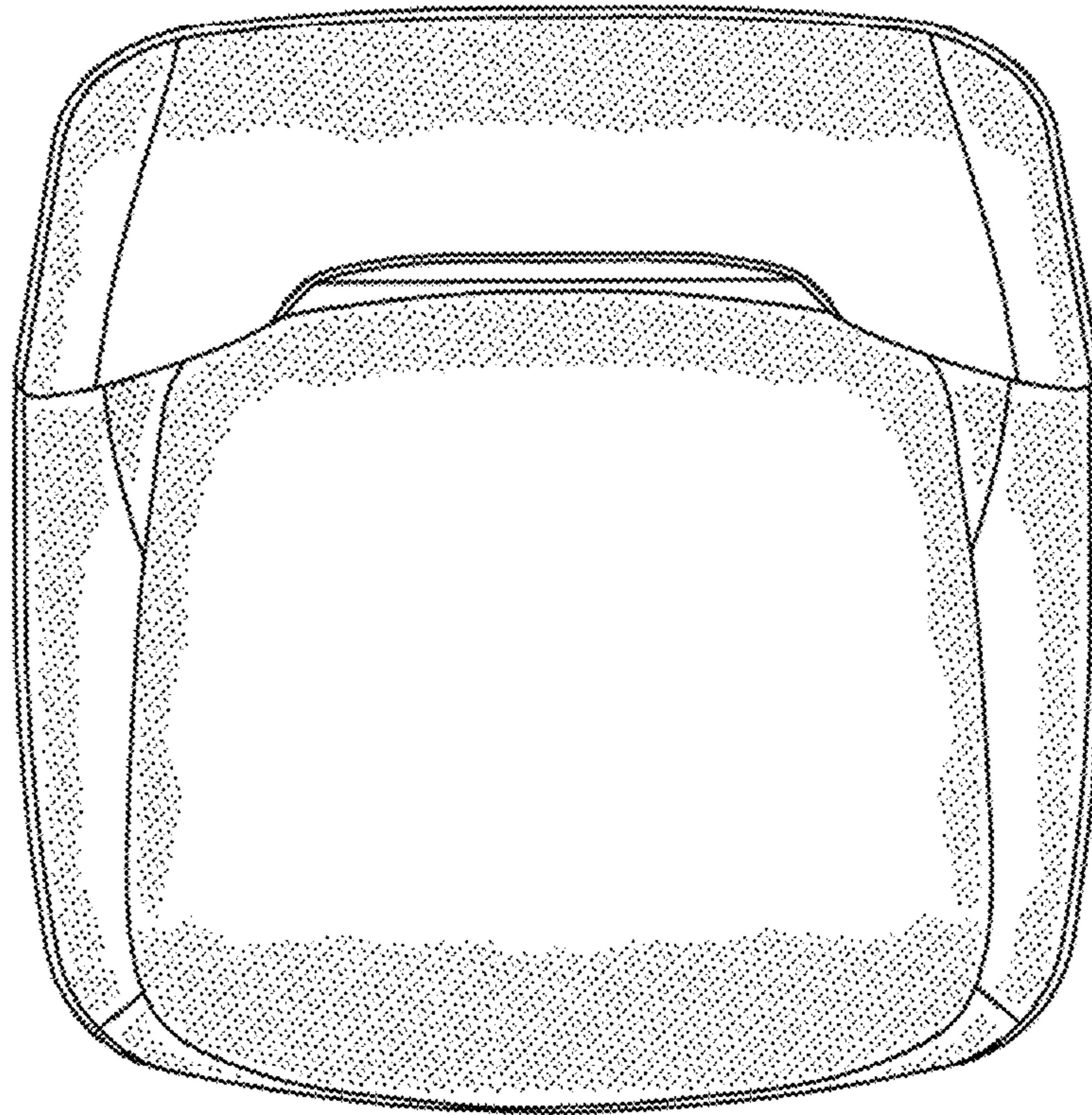

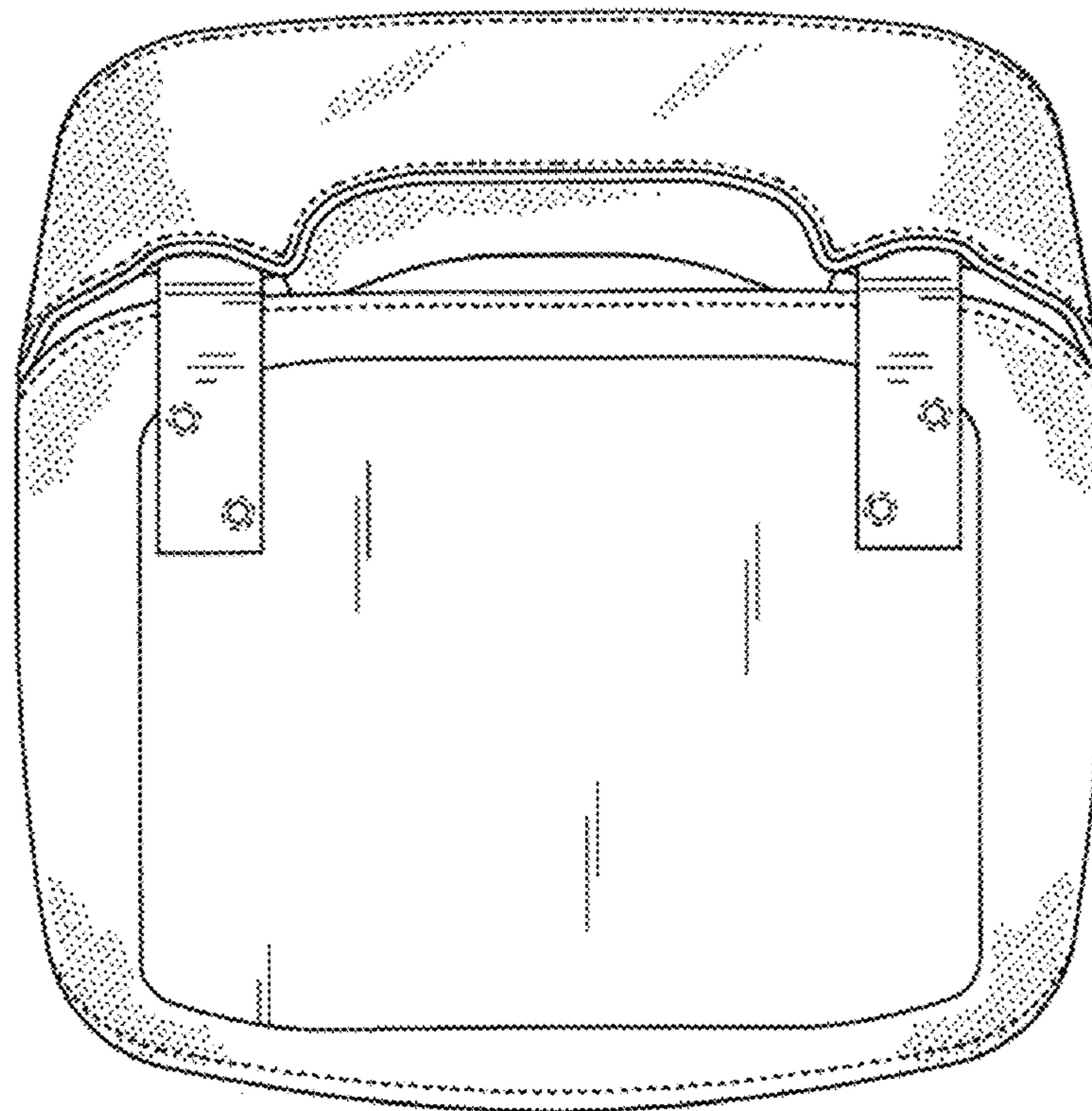
