FIG. 20 is a top view thereof; and,

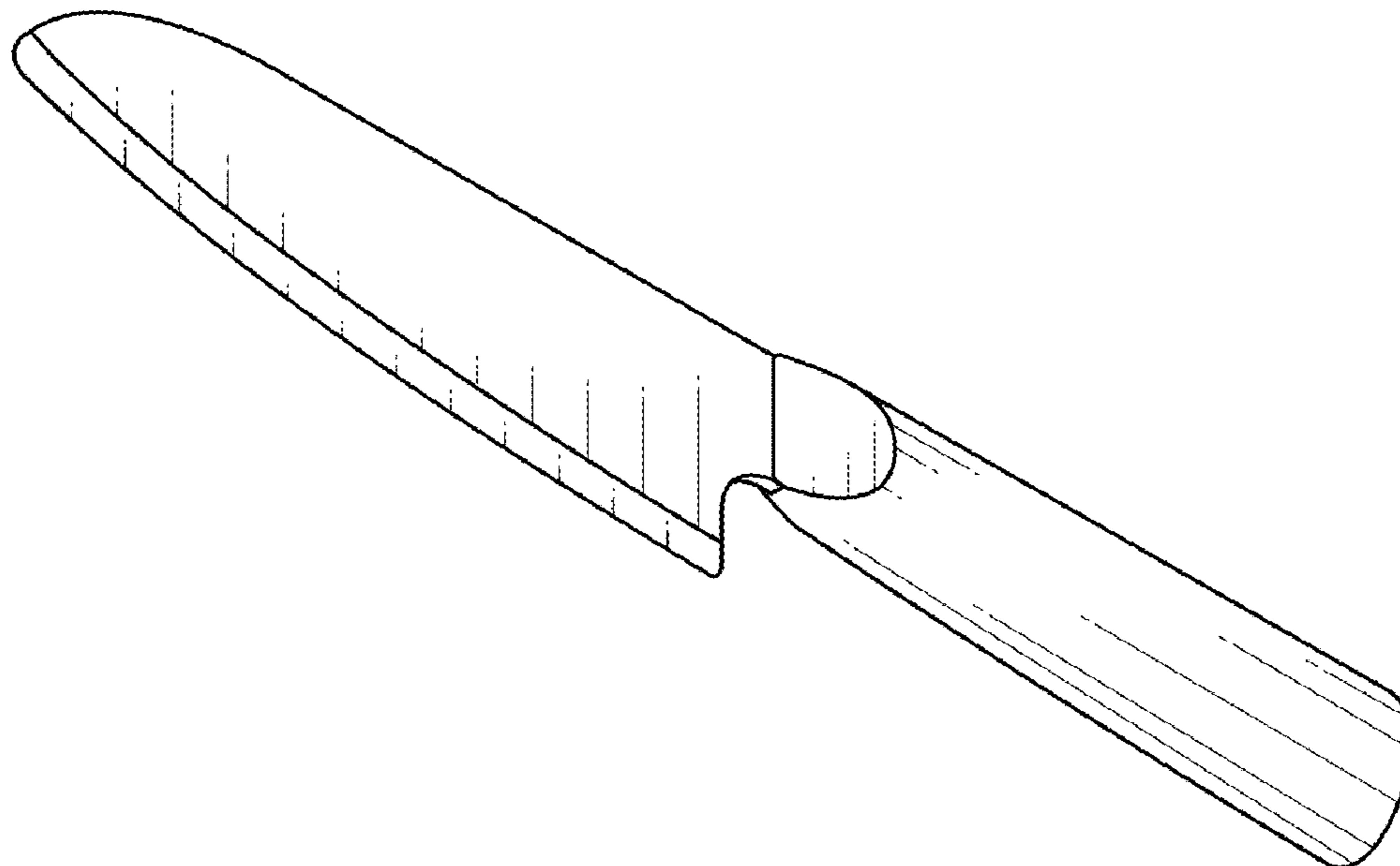
FIG. 21 is a bottom view thereof.

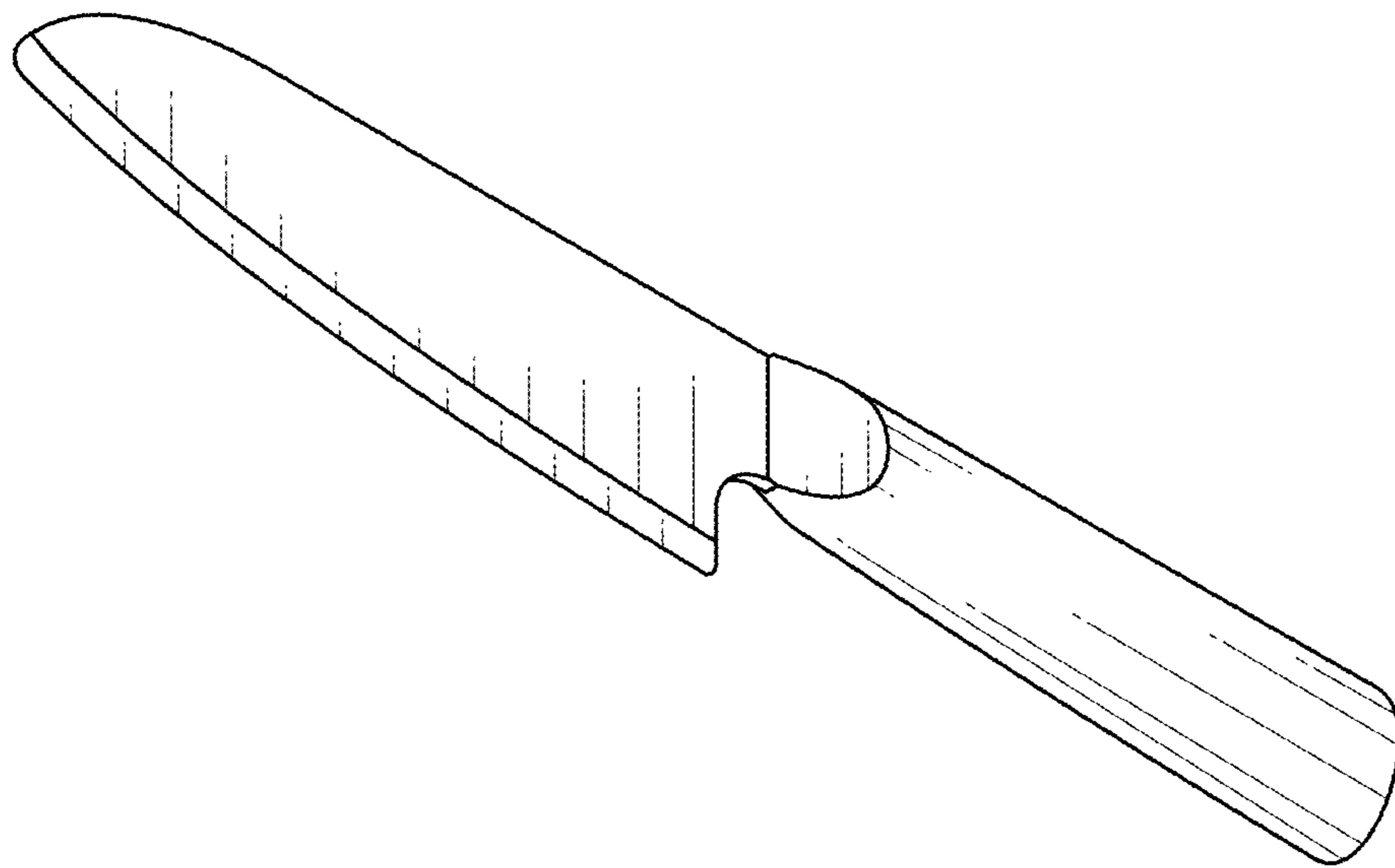

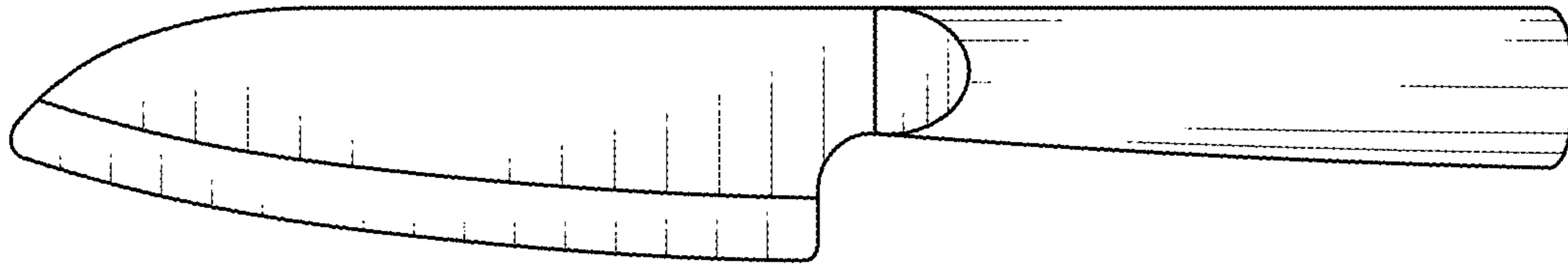

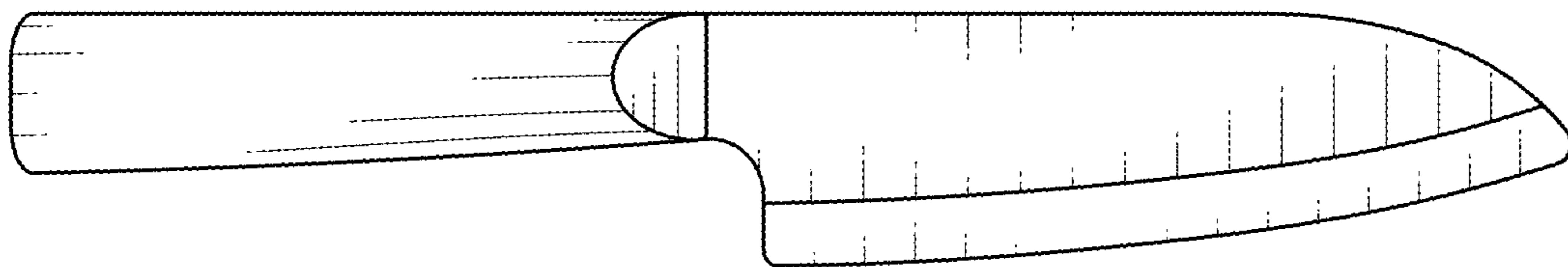

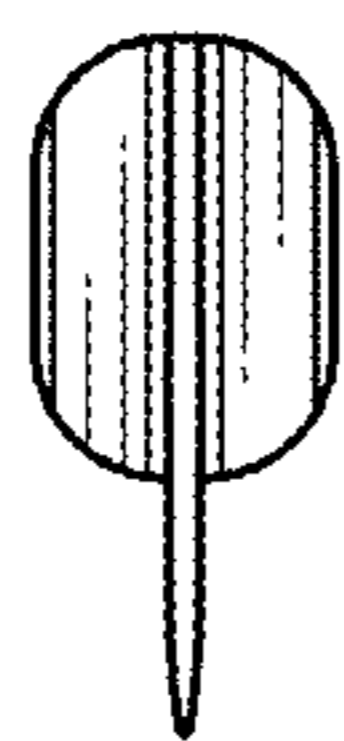

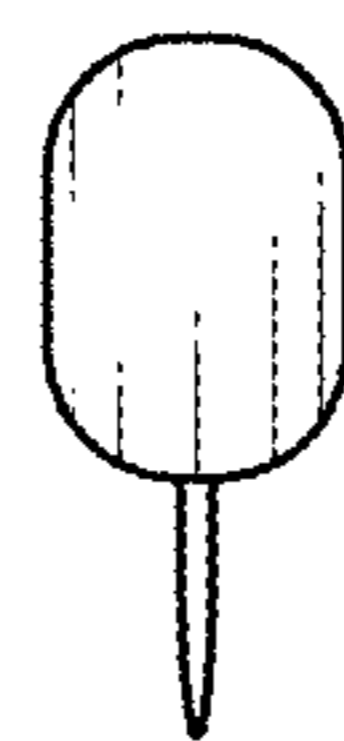

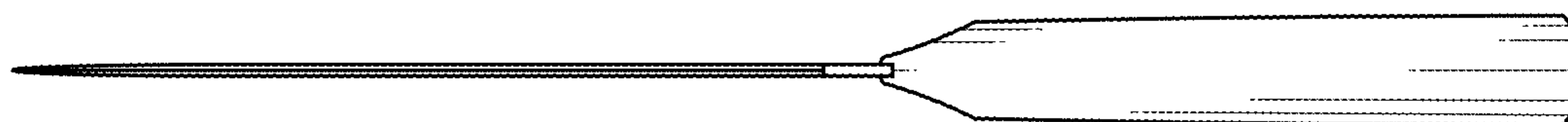

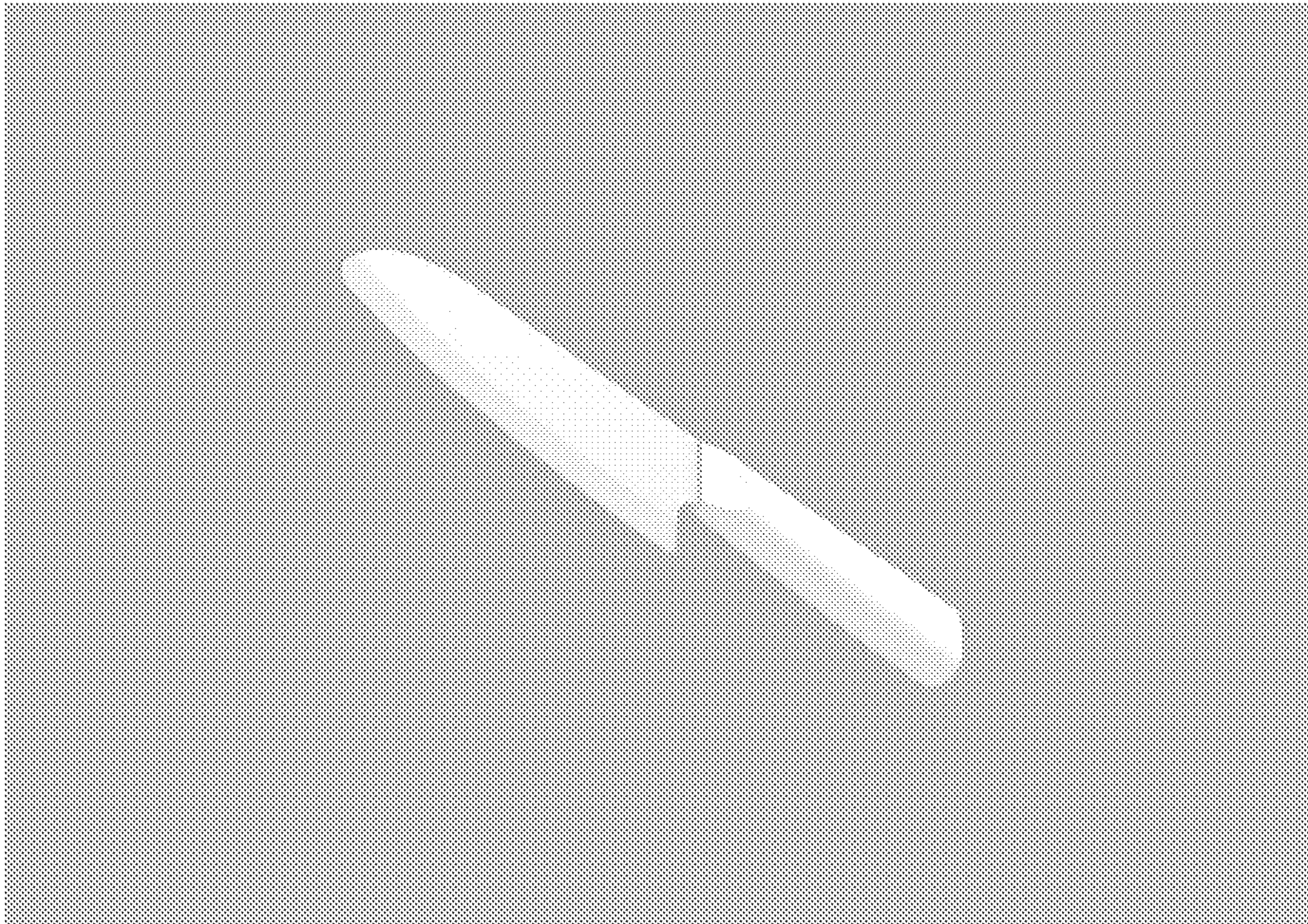

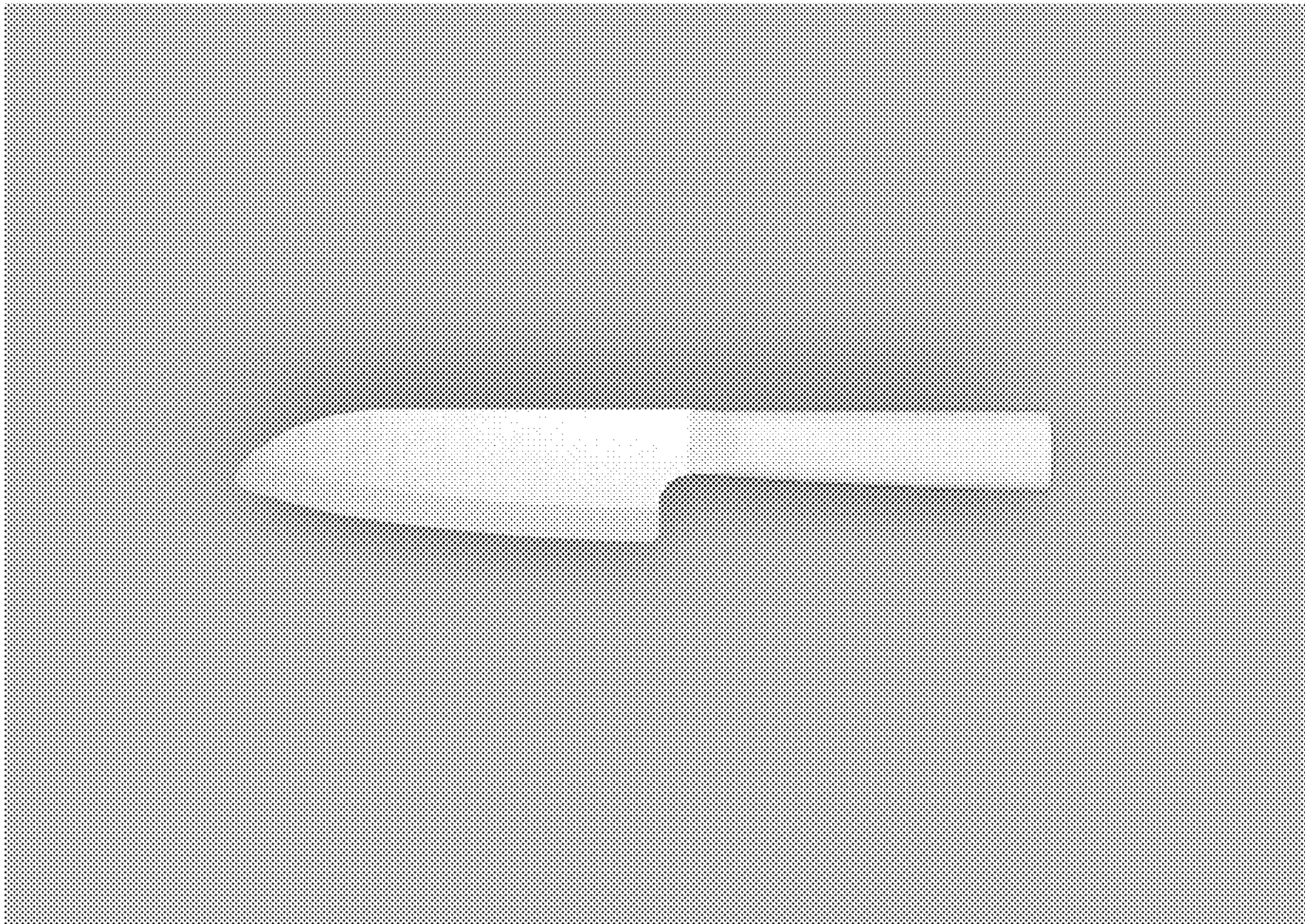

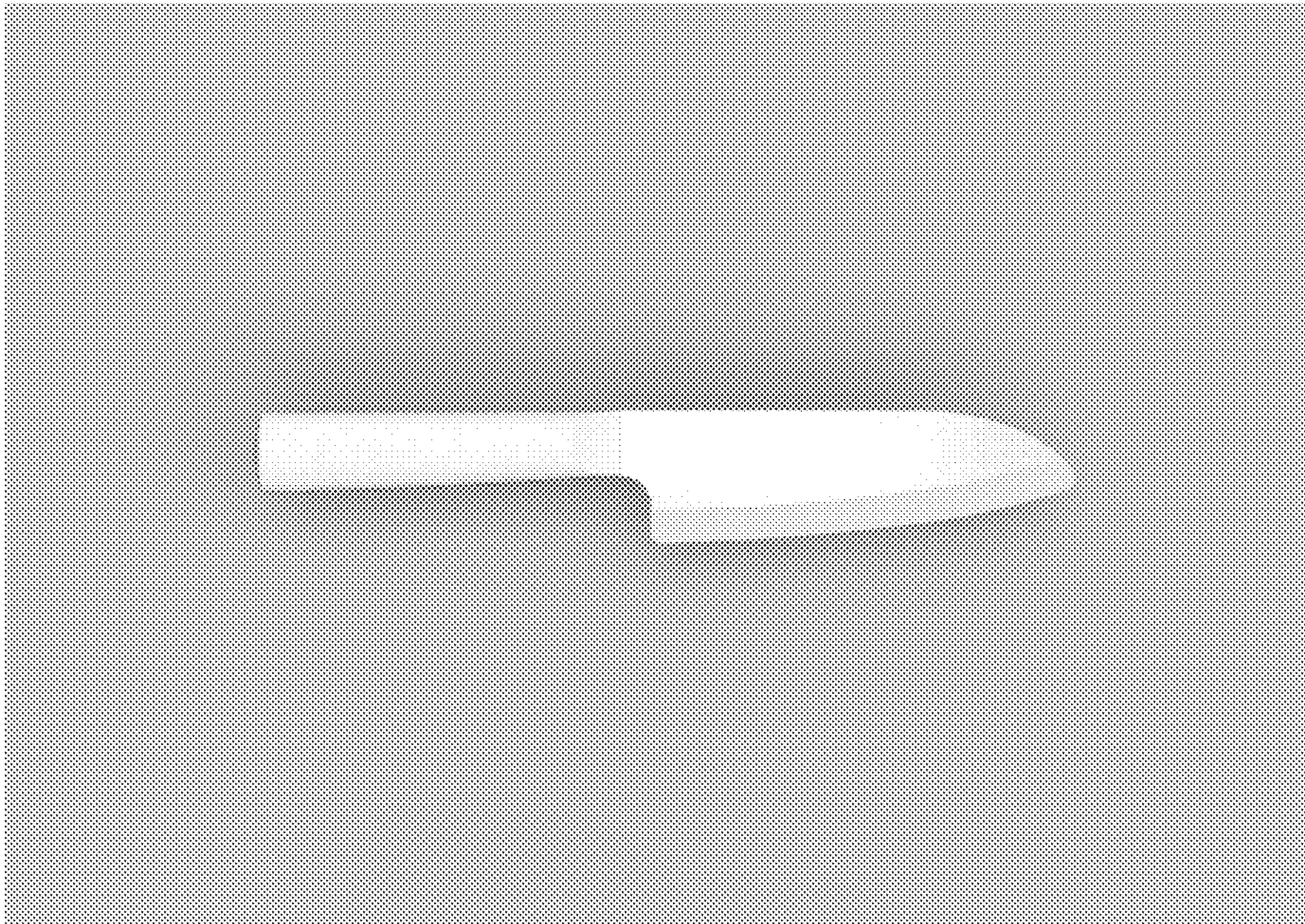

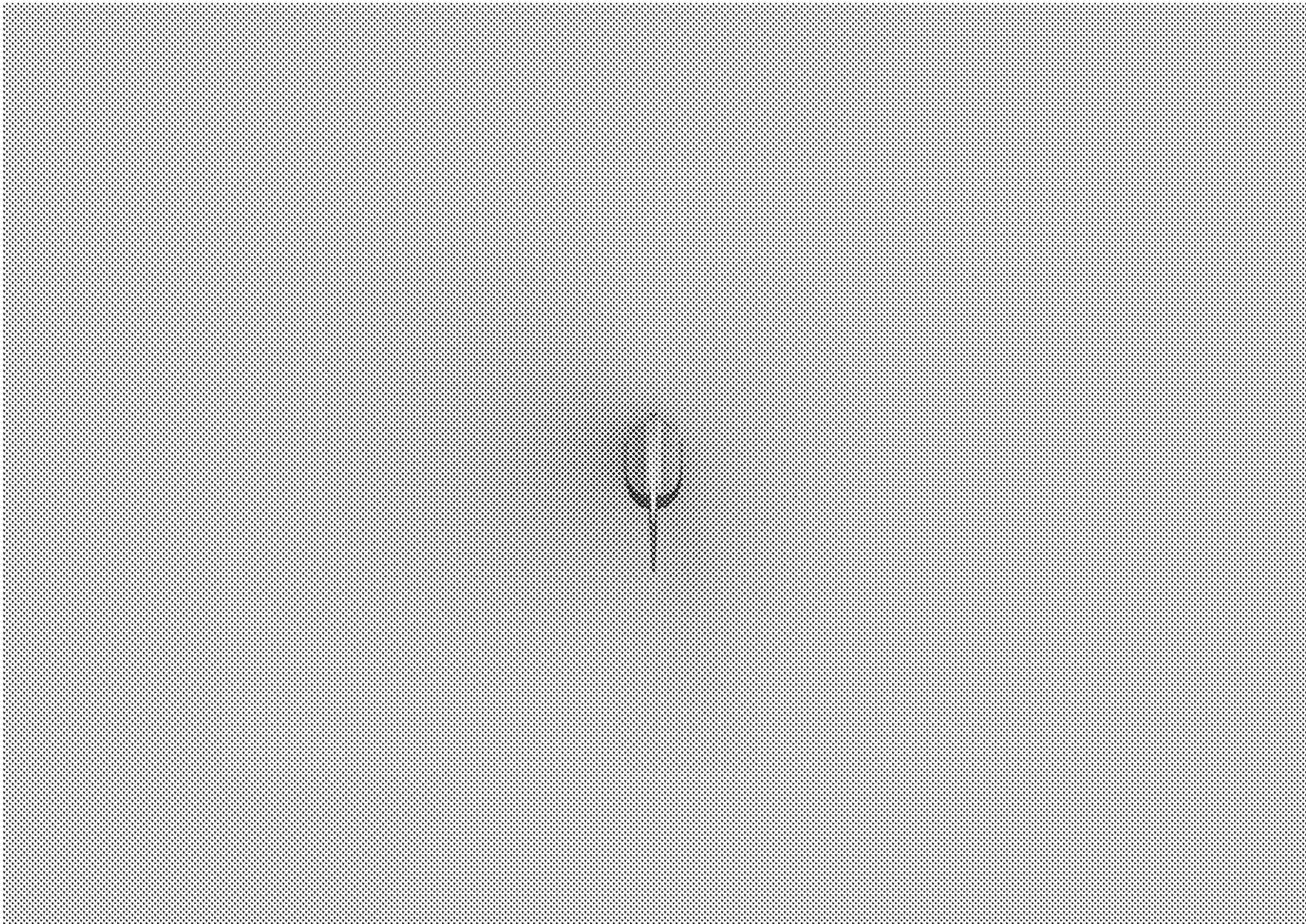

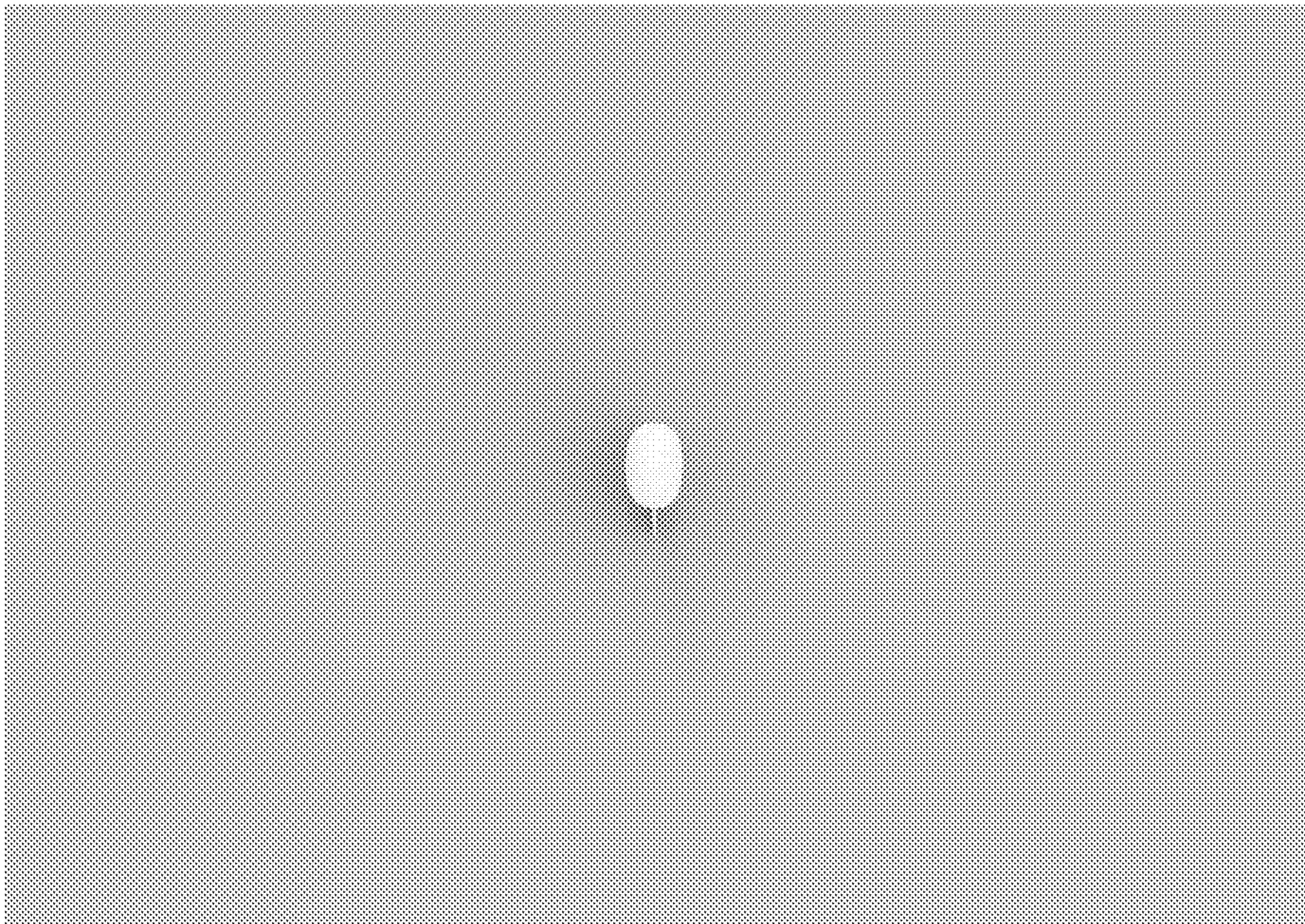

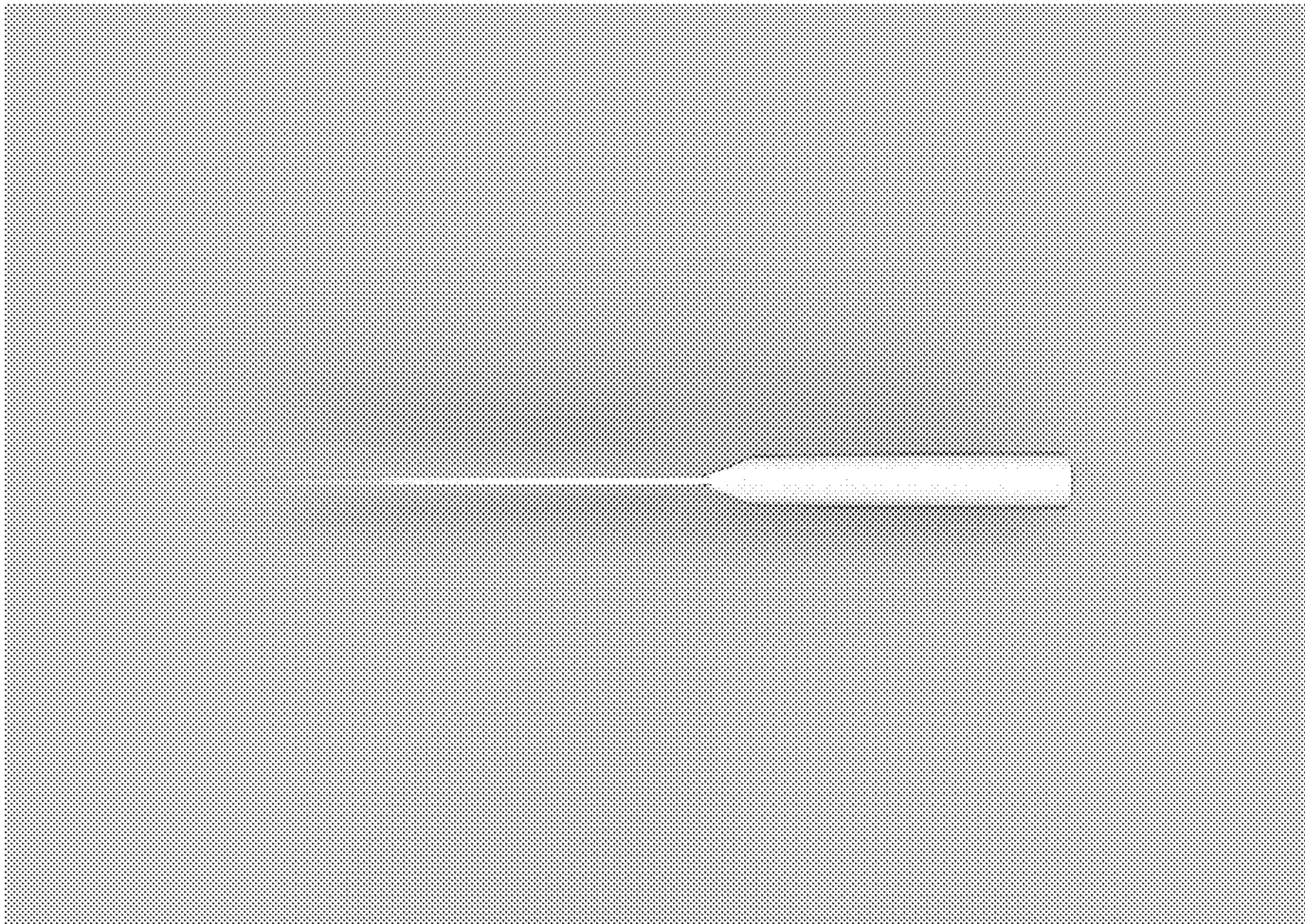

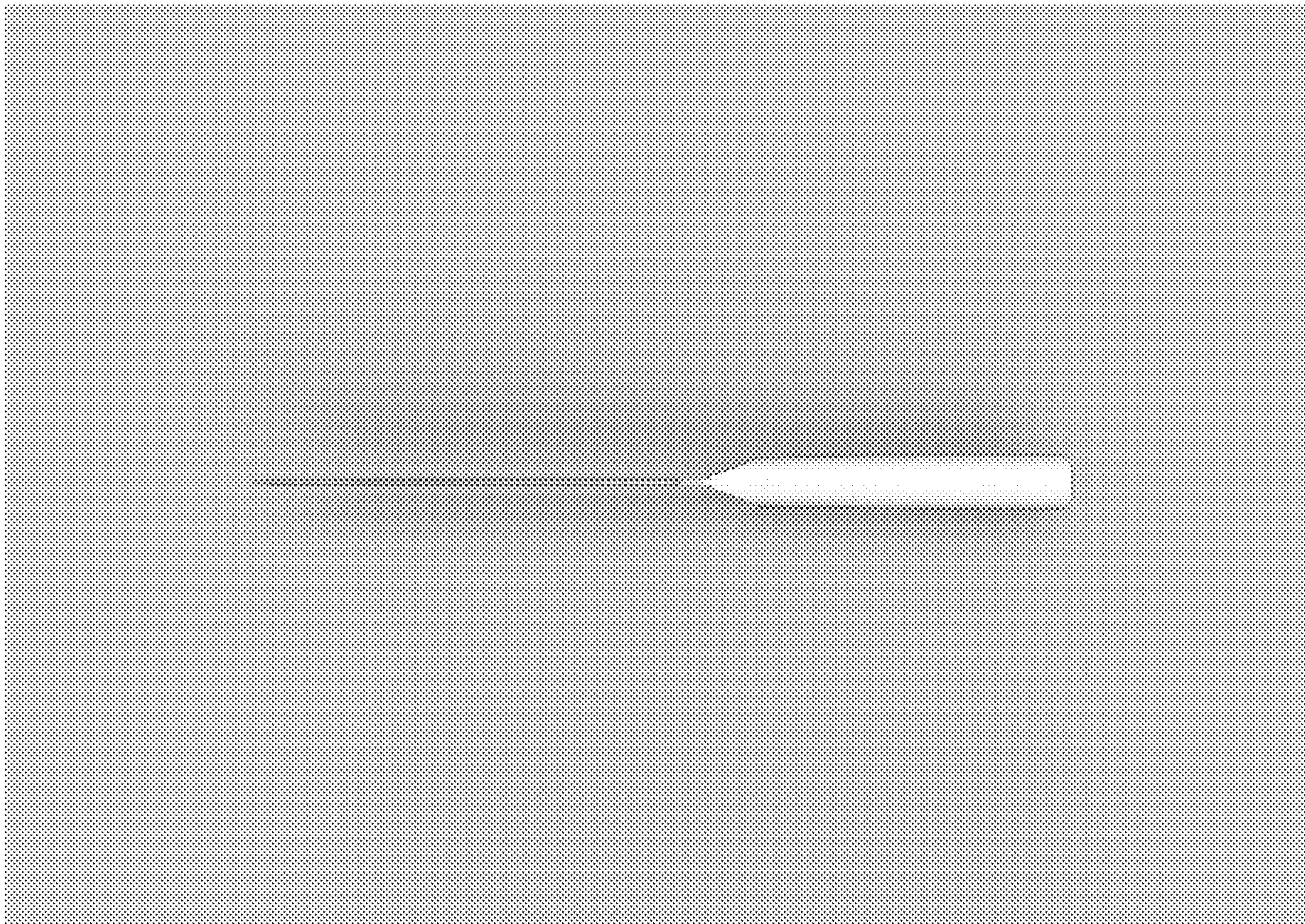

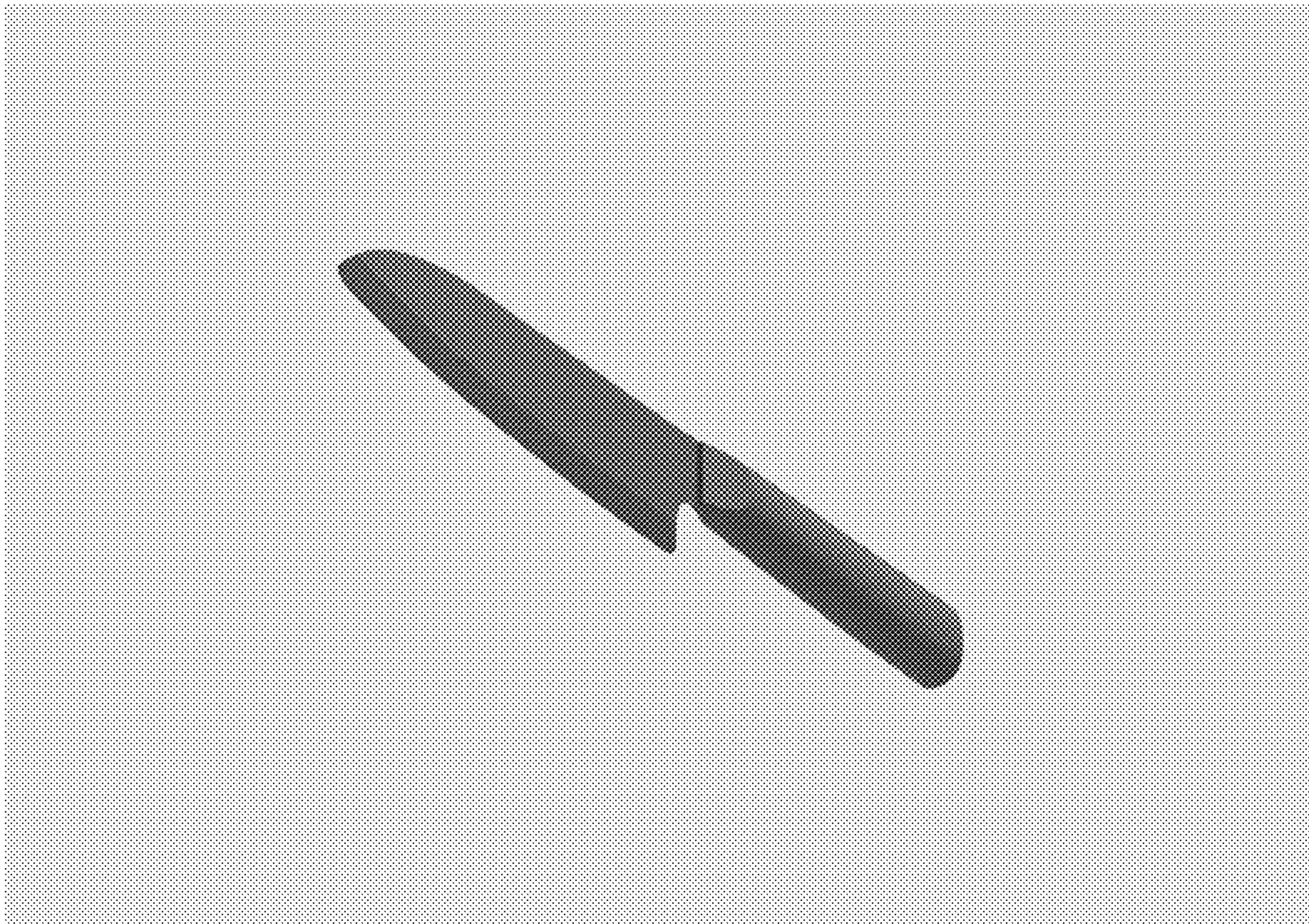

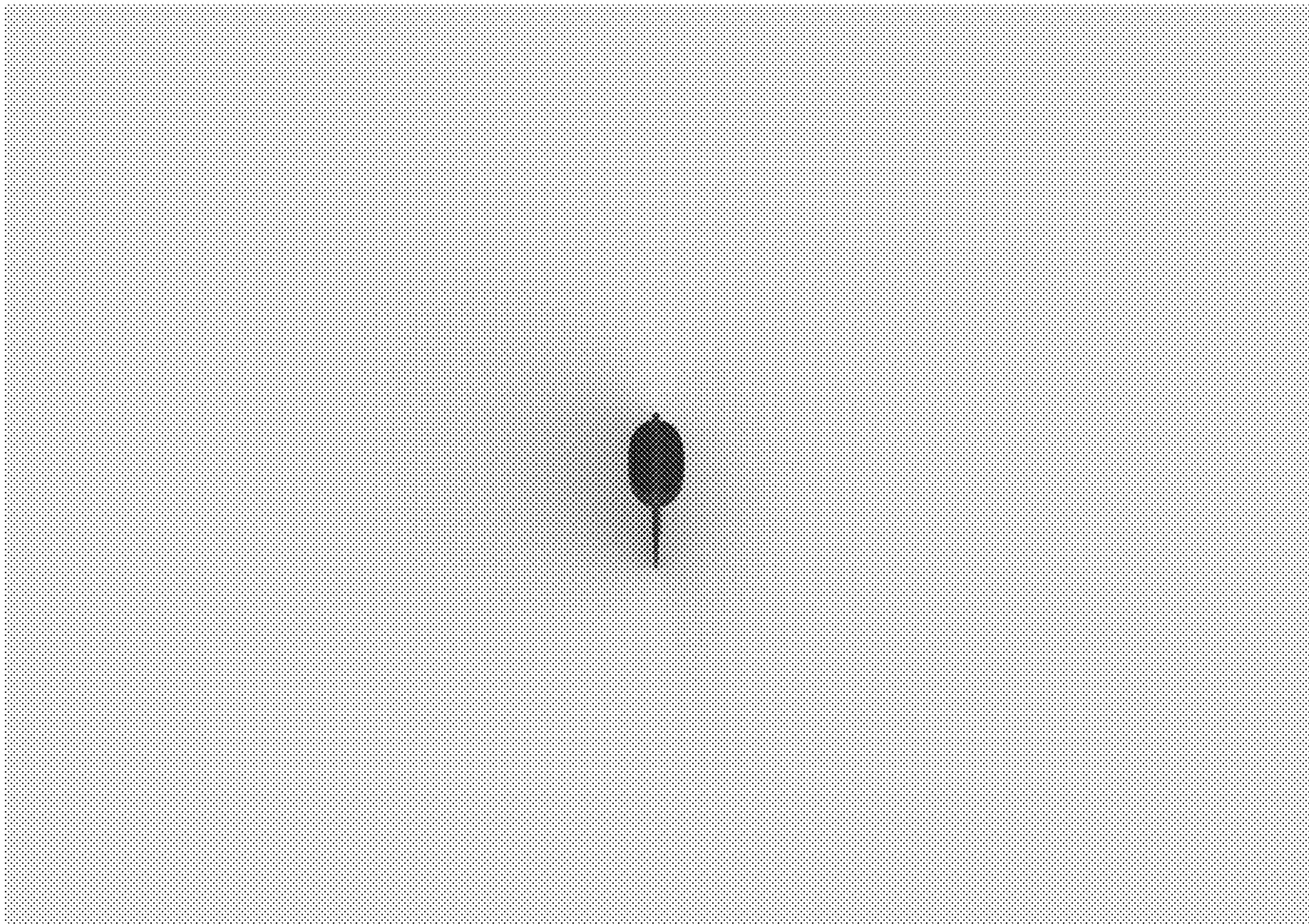

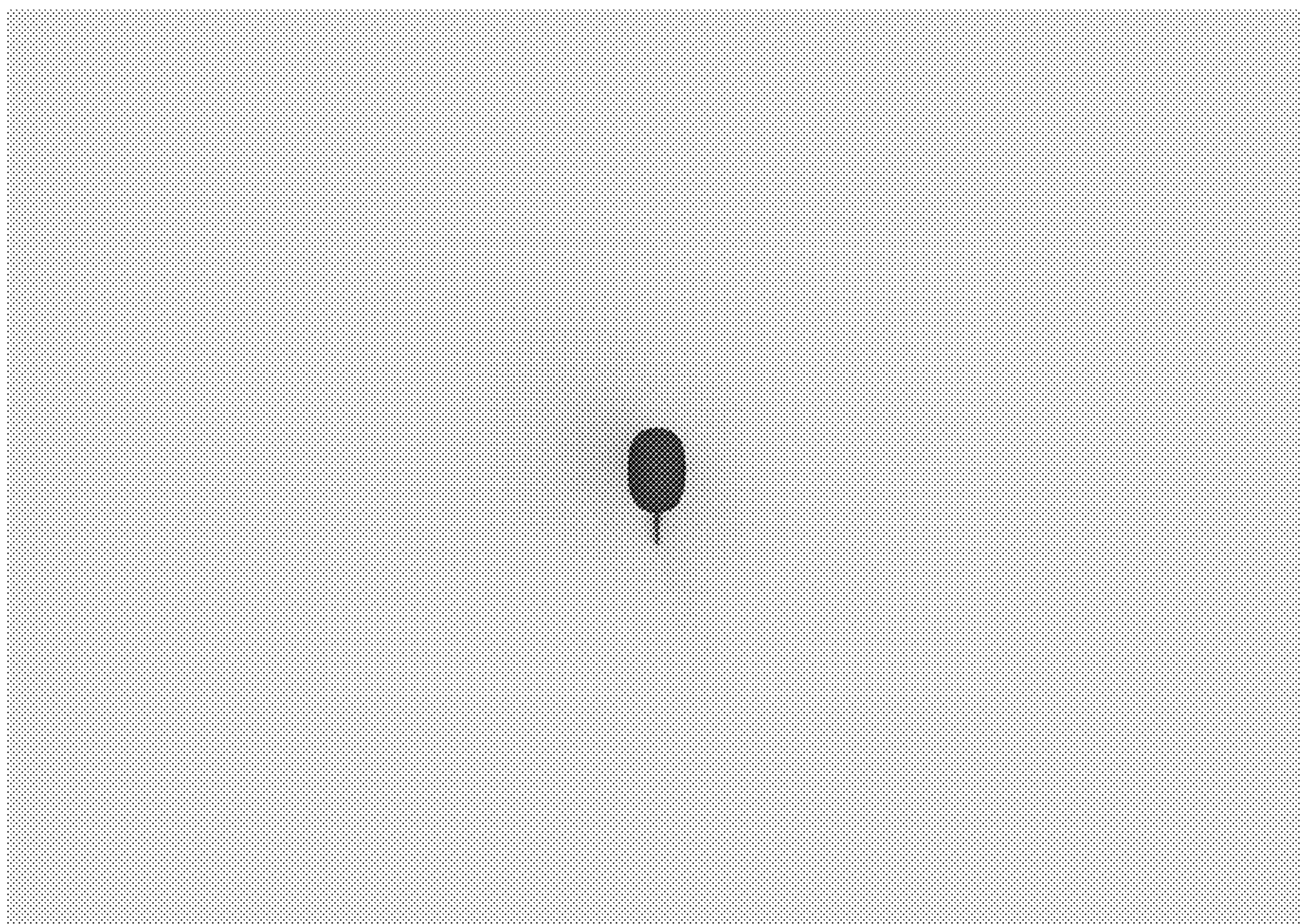

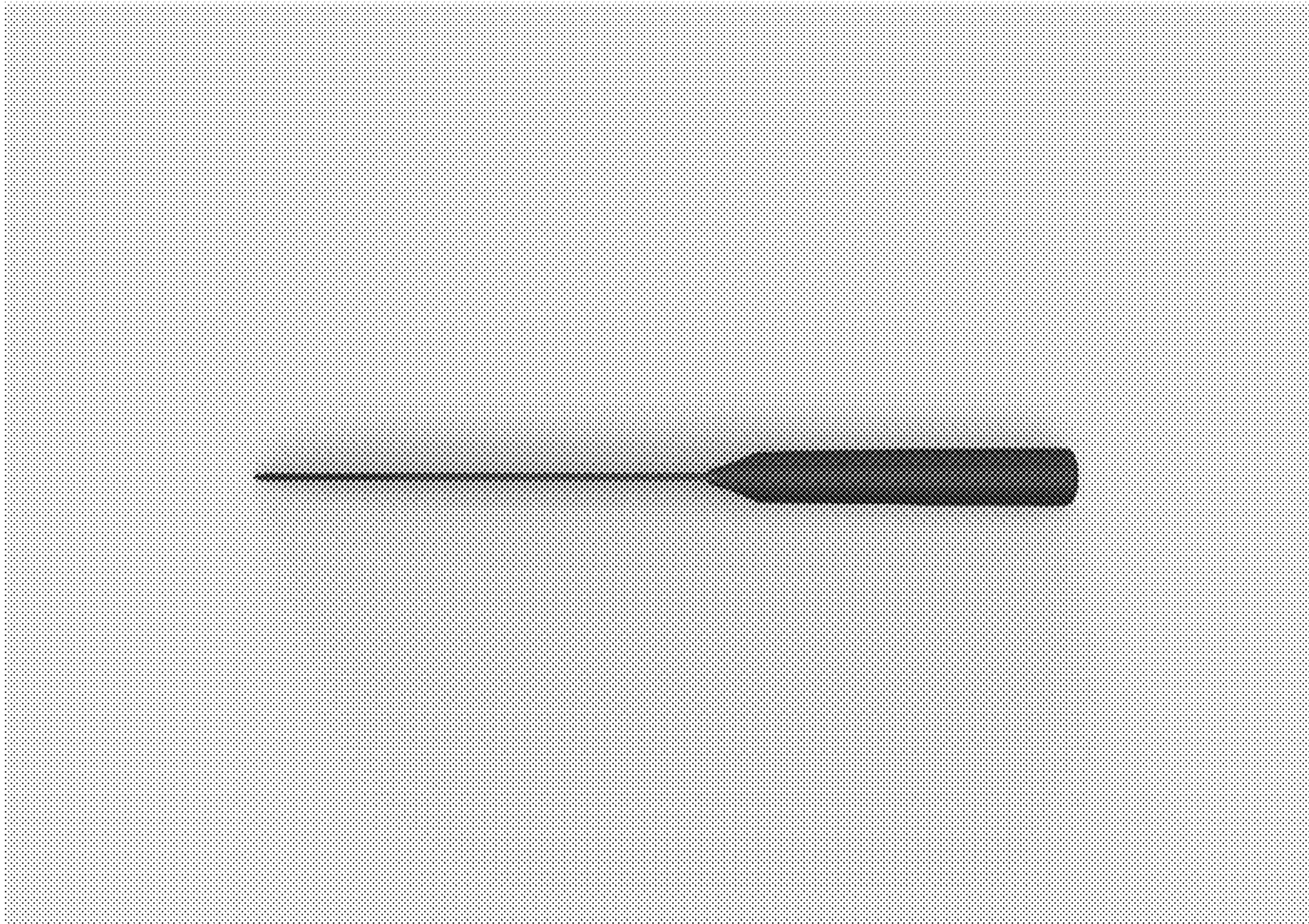

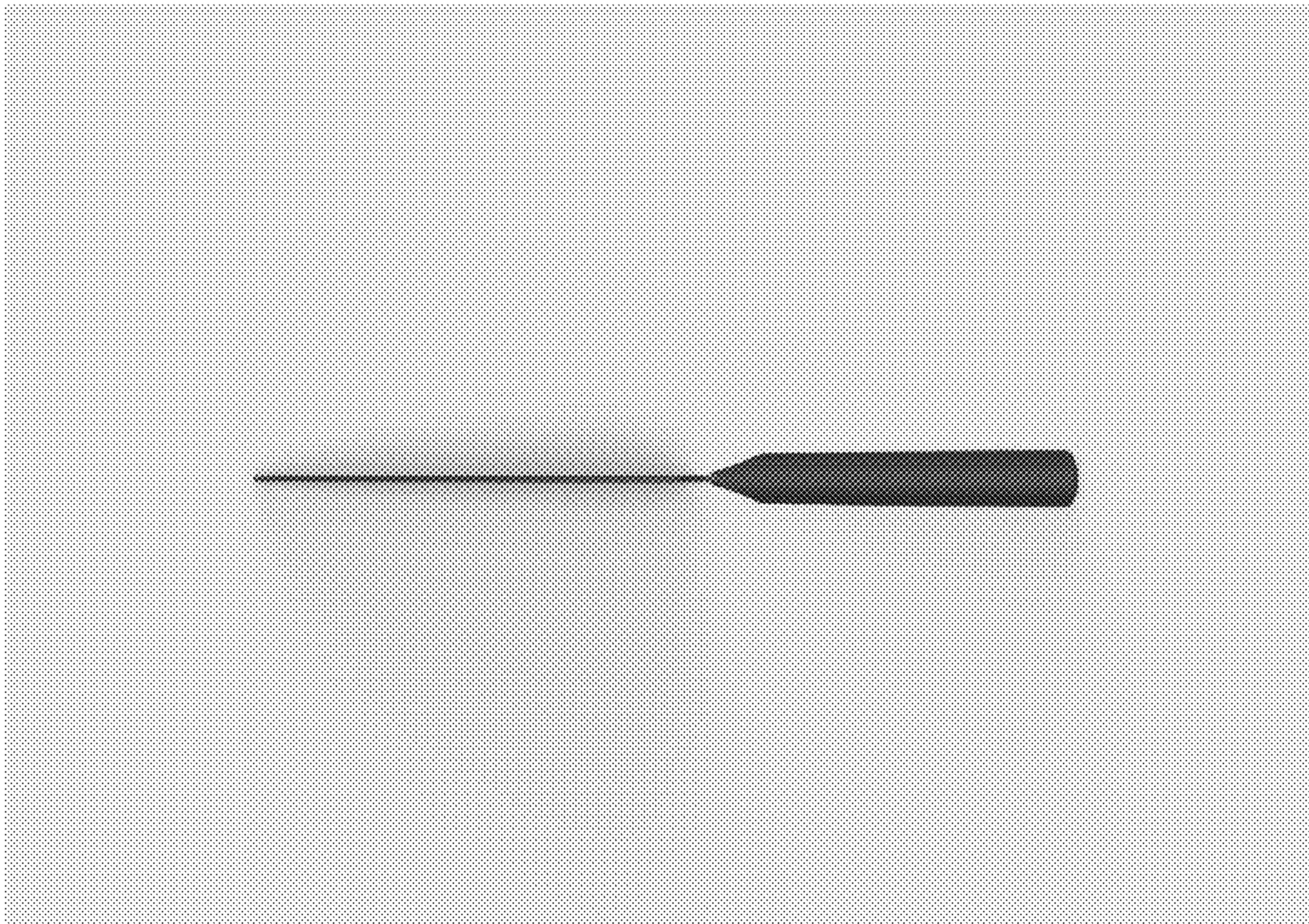
