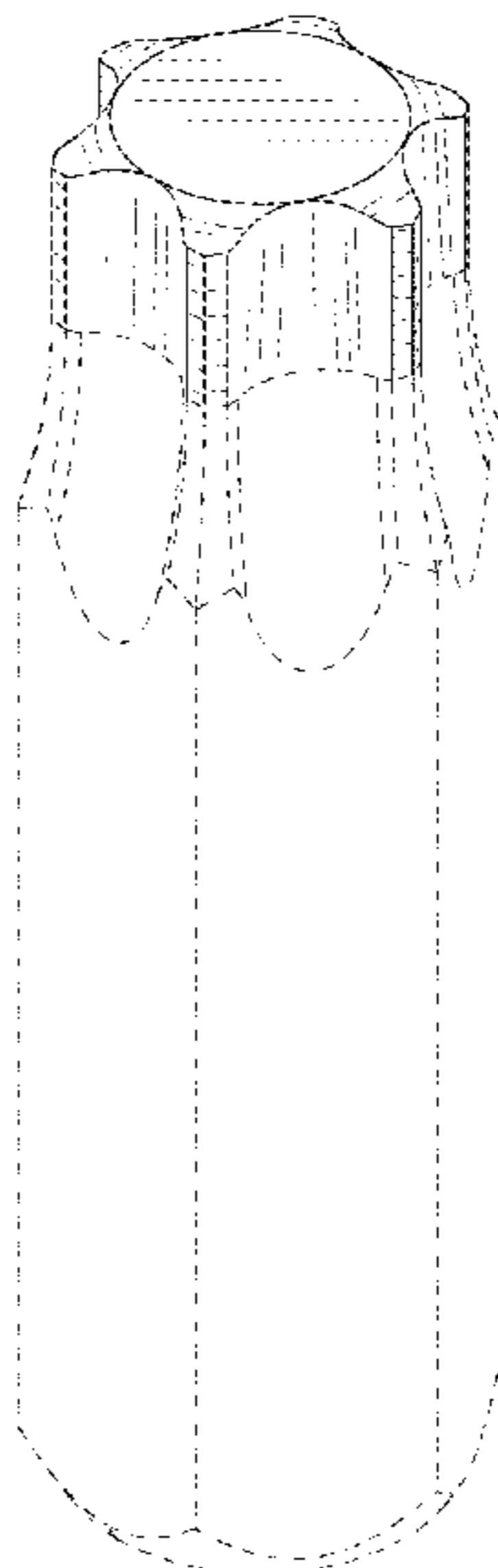
(57) **CLAIM**

The ornamental design for a head of a fastener driver, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a head of a fastener driver showing my new design;
 FIG. 2 is a bottom-rear-right perspective view thereof;
 FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 5 is an enlarged top plan view thereof; and,
 FIG. 6 is an enlarged bottom plan view thereof.
 The broken lines depict portions of the head of a fastener driver in which the design is embodied that are not considered part of the claimed design.

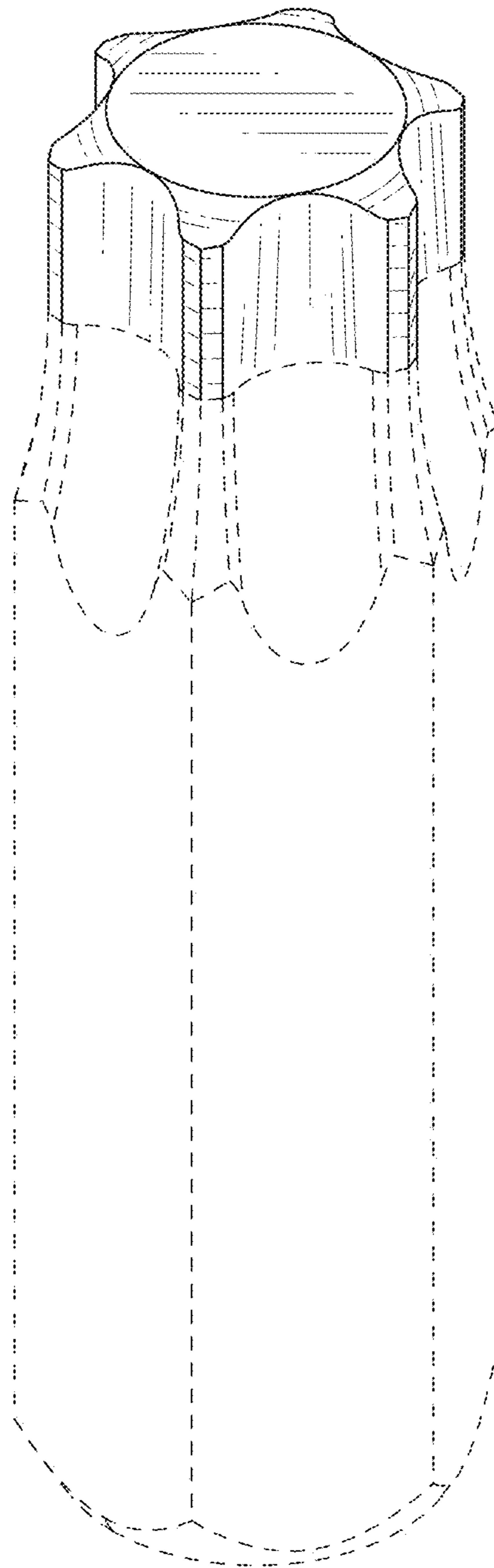

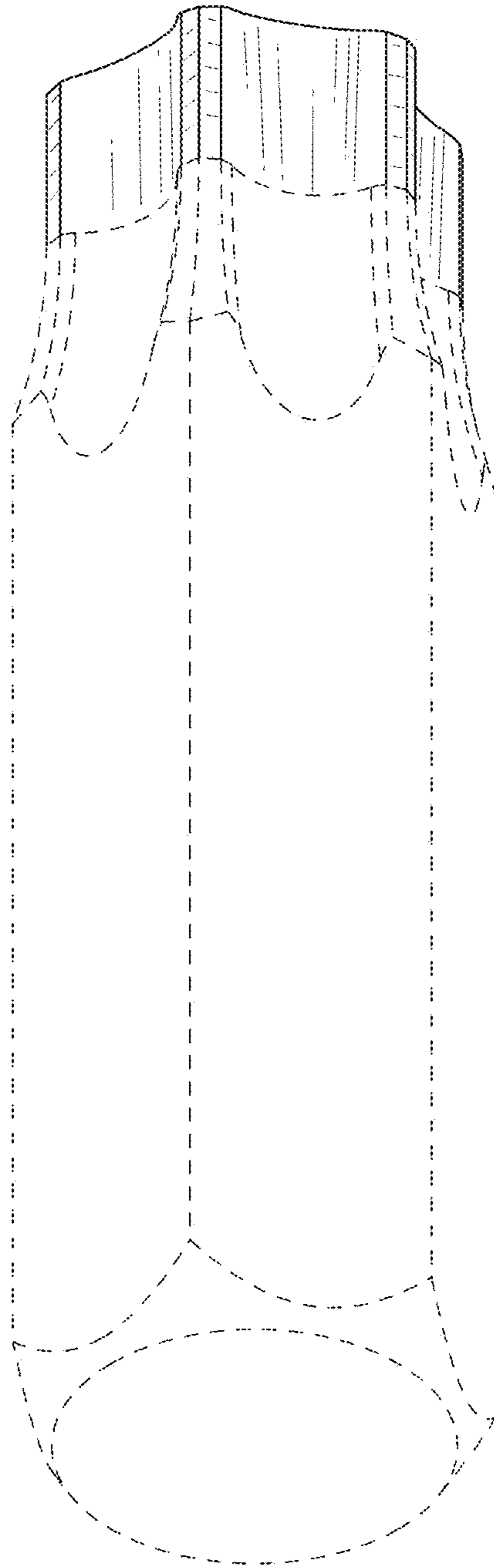

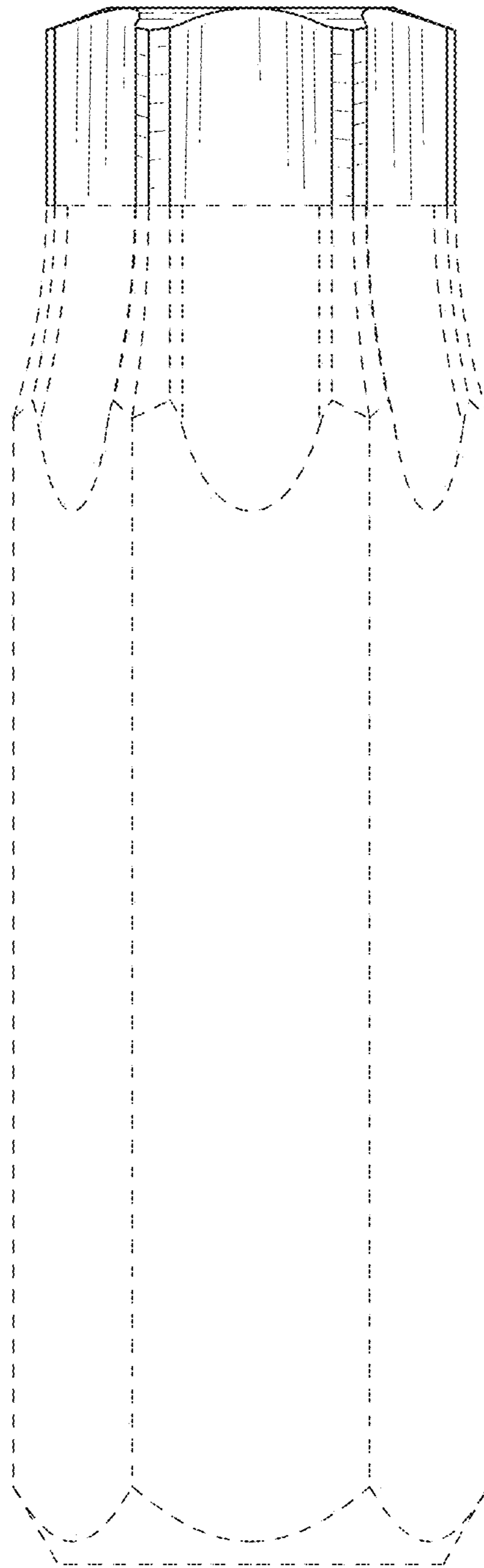

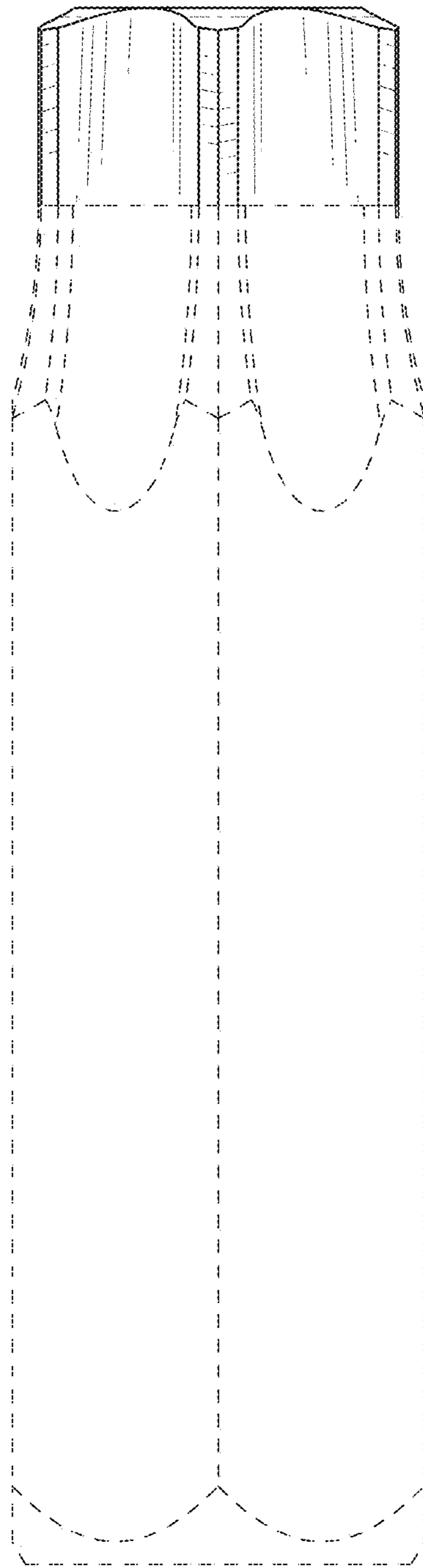

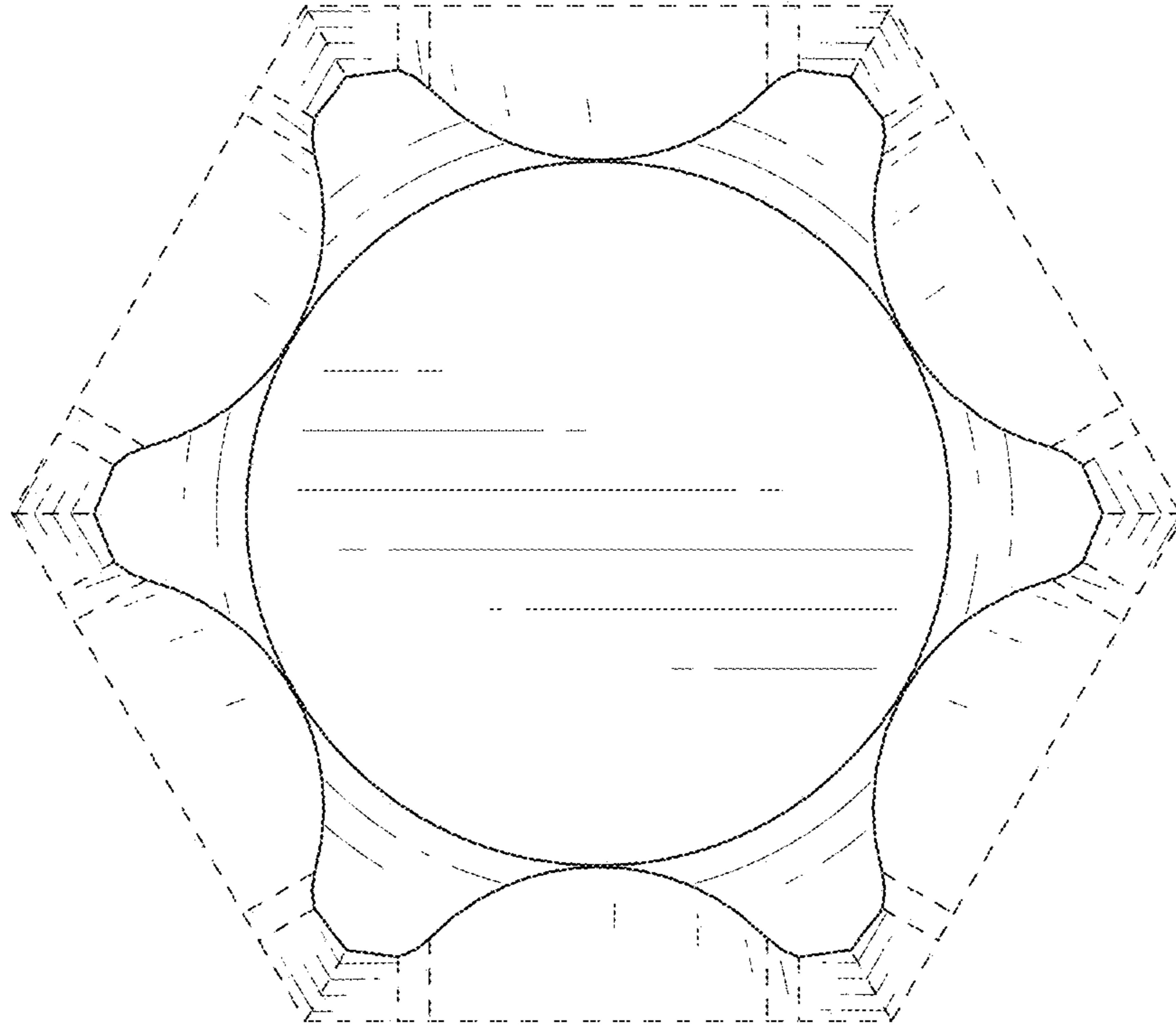

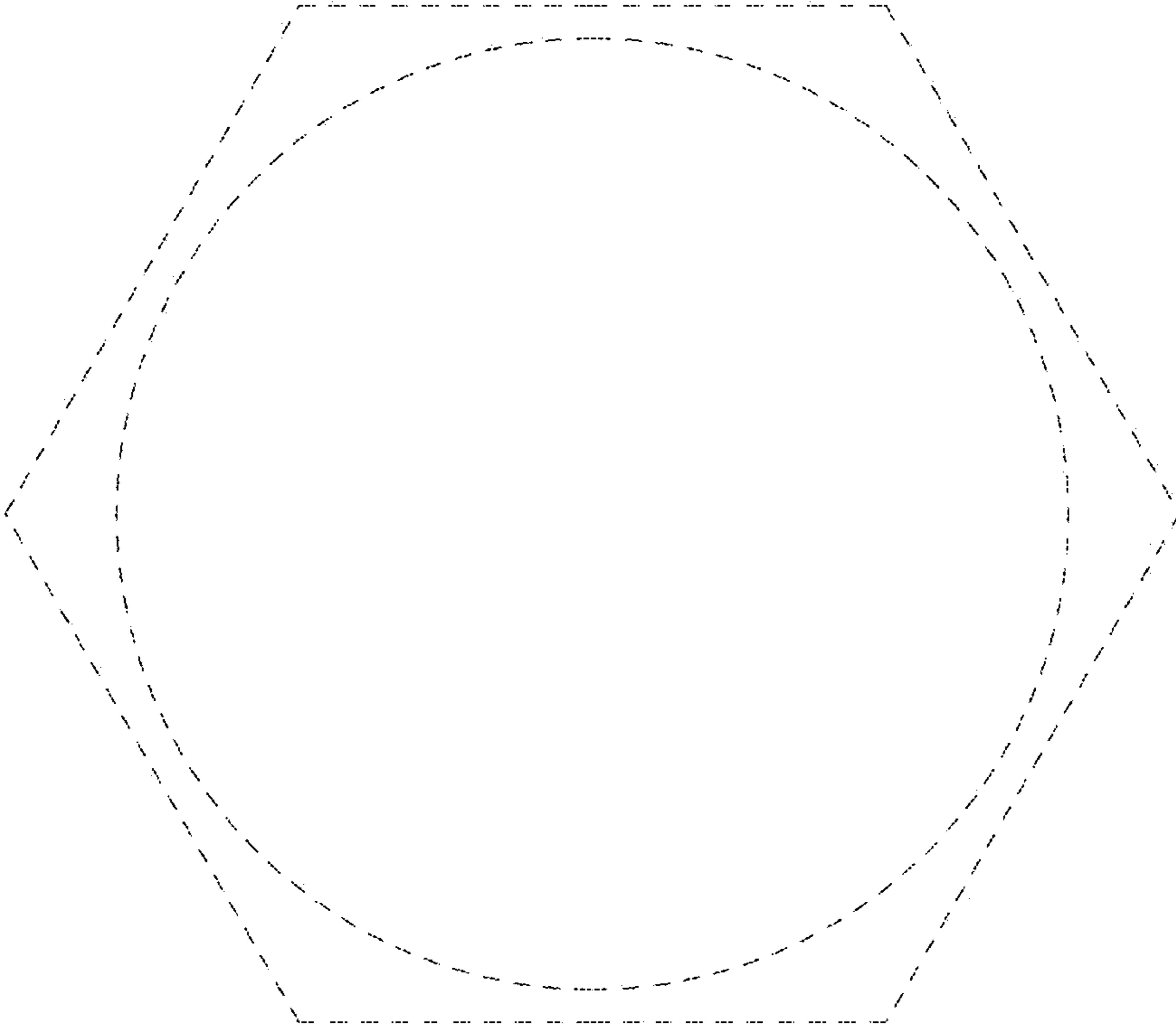
