DESCRIPTION

FIG. 1 is a front right perspective view of a tire showing the claimed design;

FIG. 9 is an enlarged view taken along line 9-9 in FIG. 1;

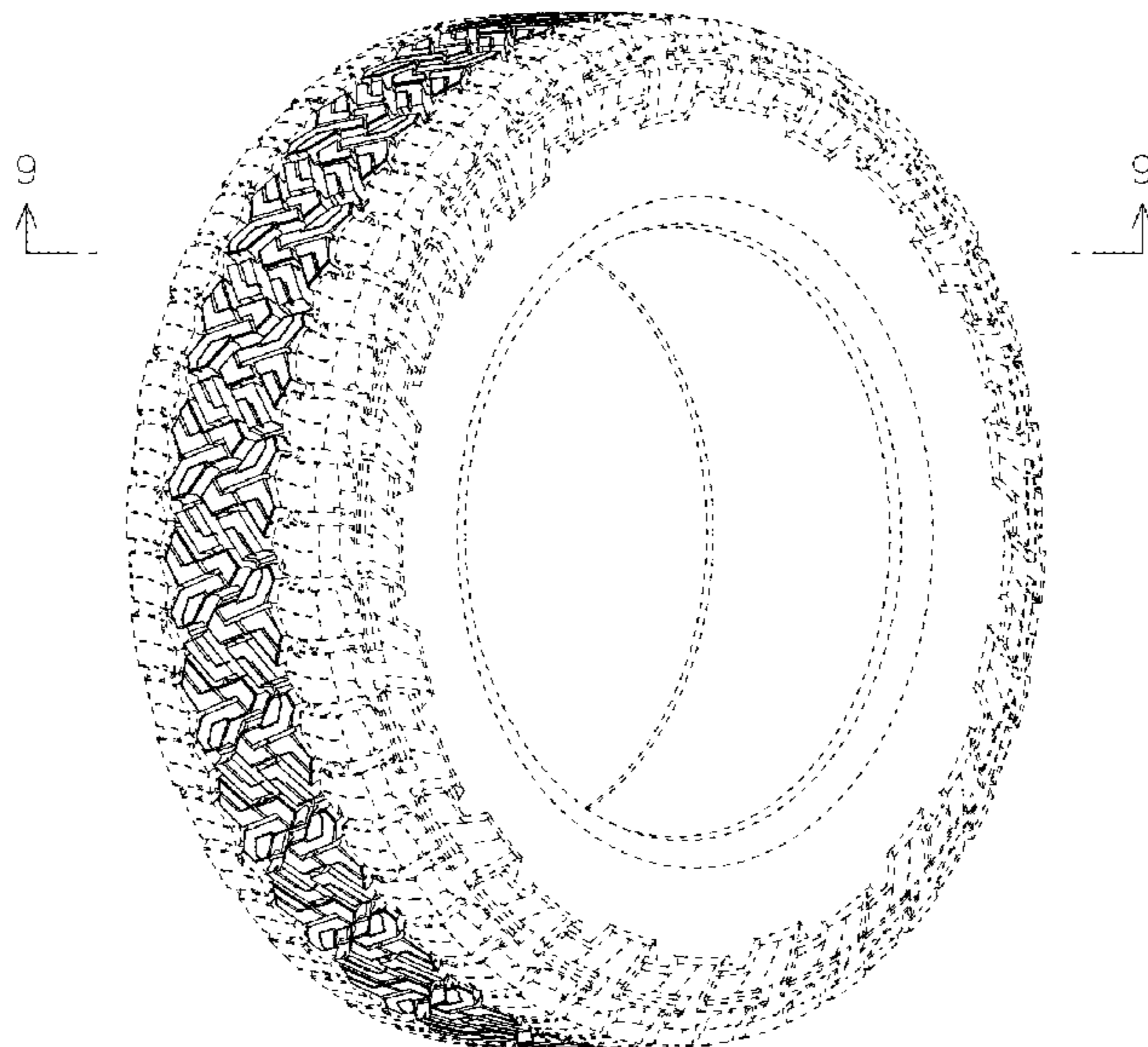
FIG. 10 is an enlarged view taken along line 10-10 in FIG. 2;

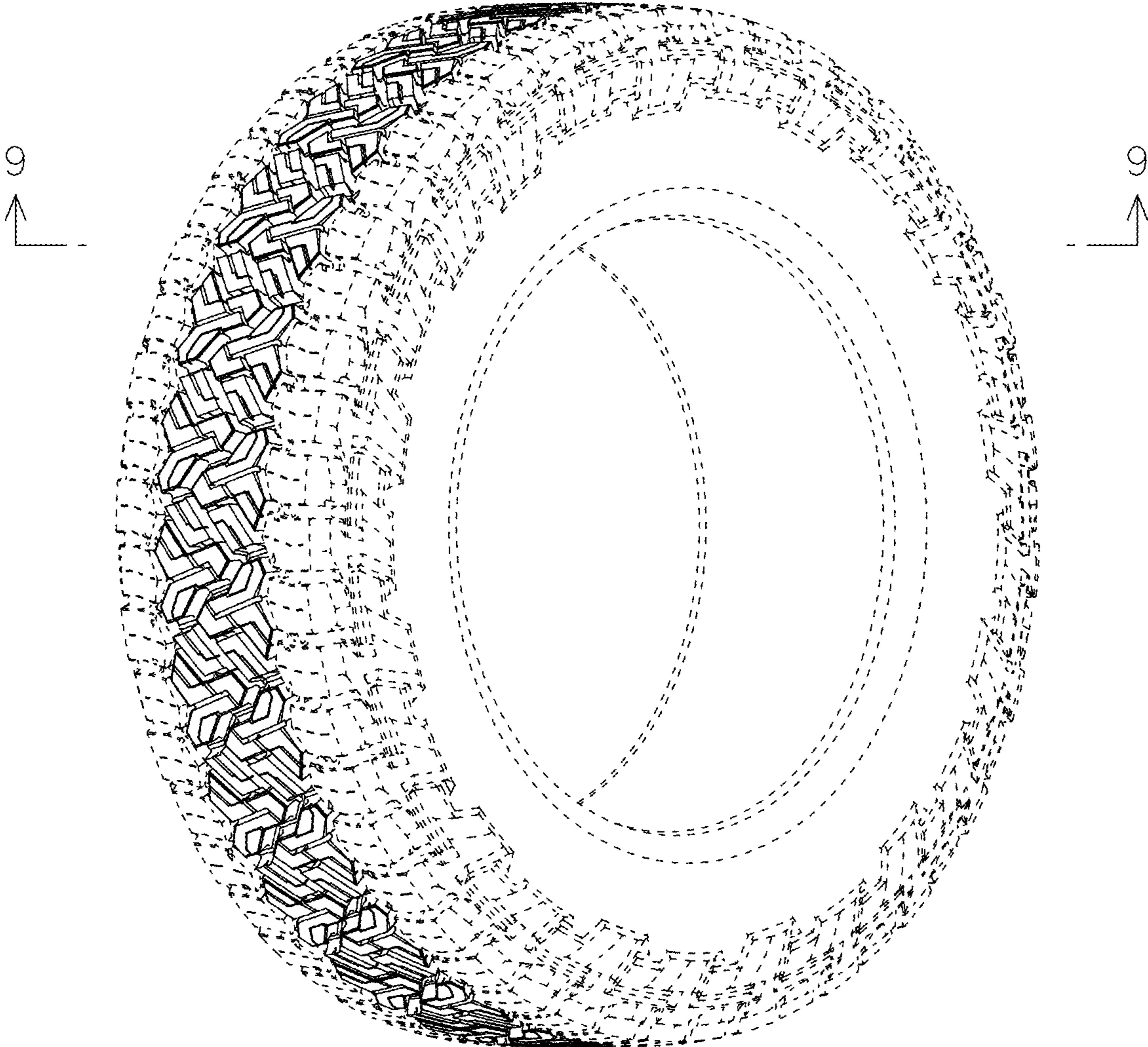

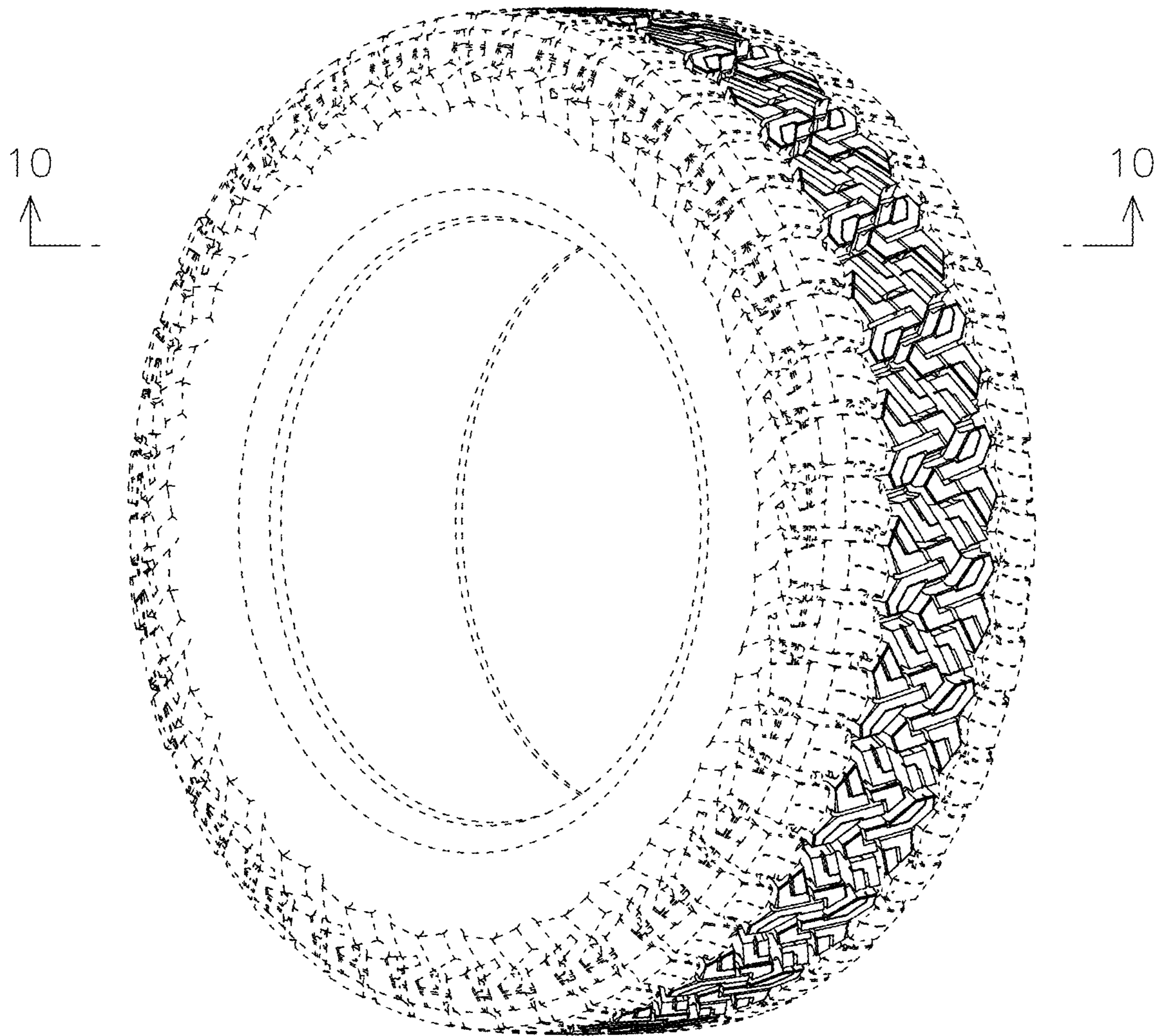

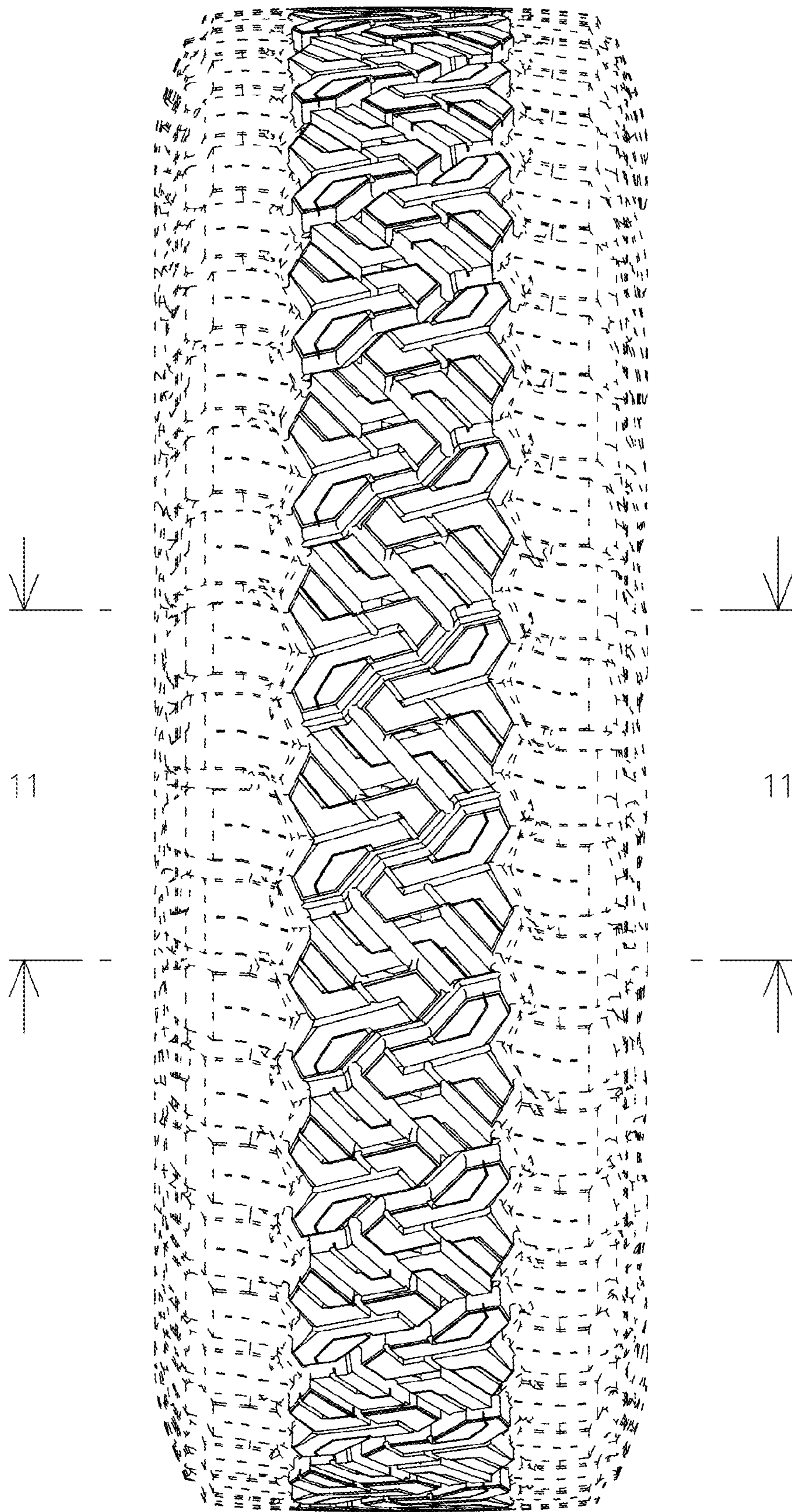

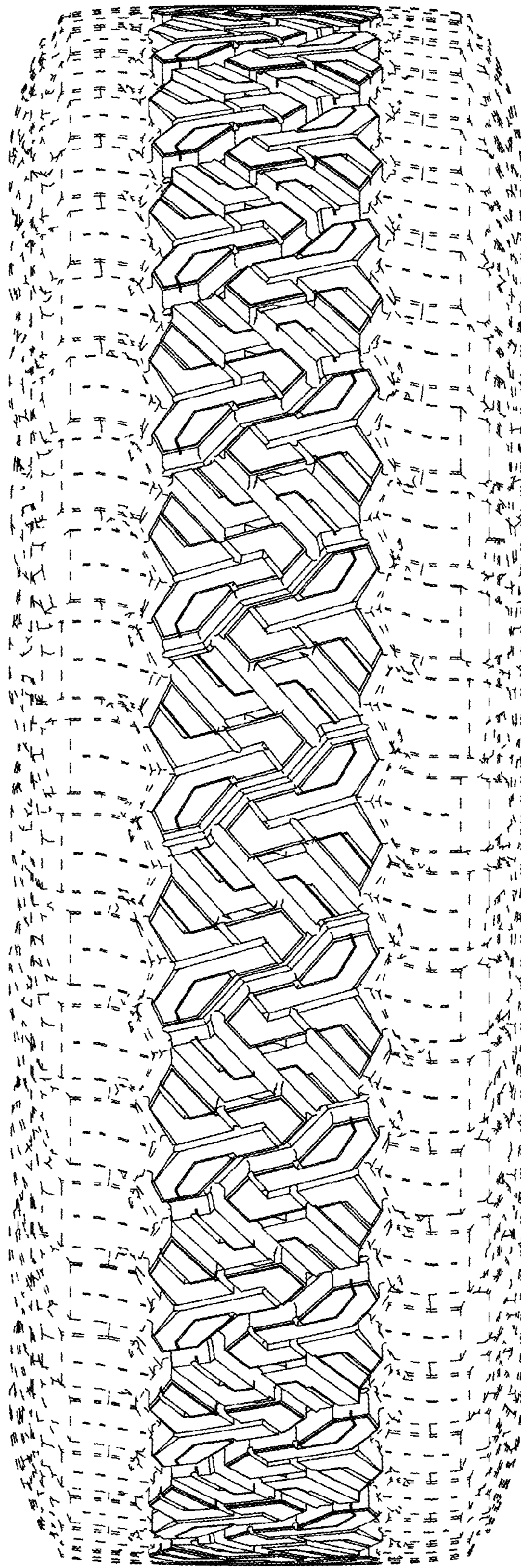

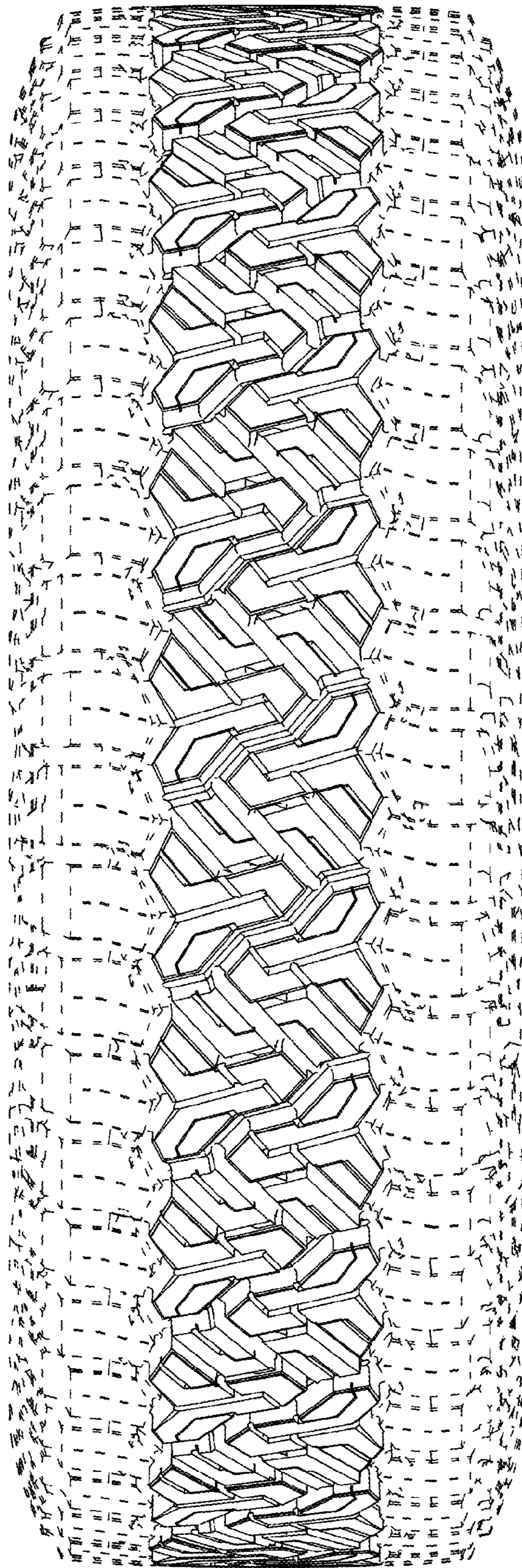

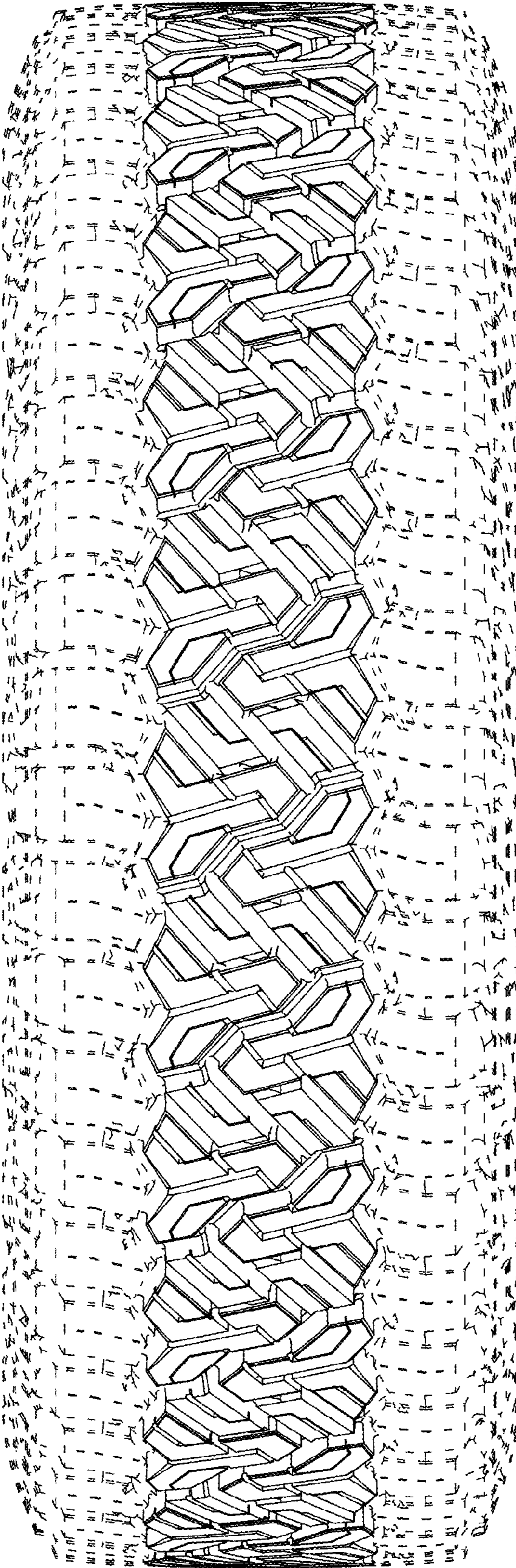

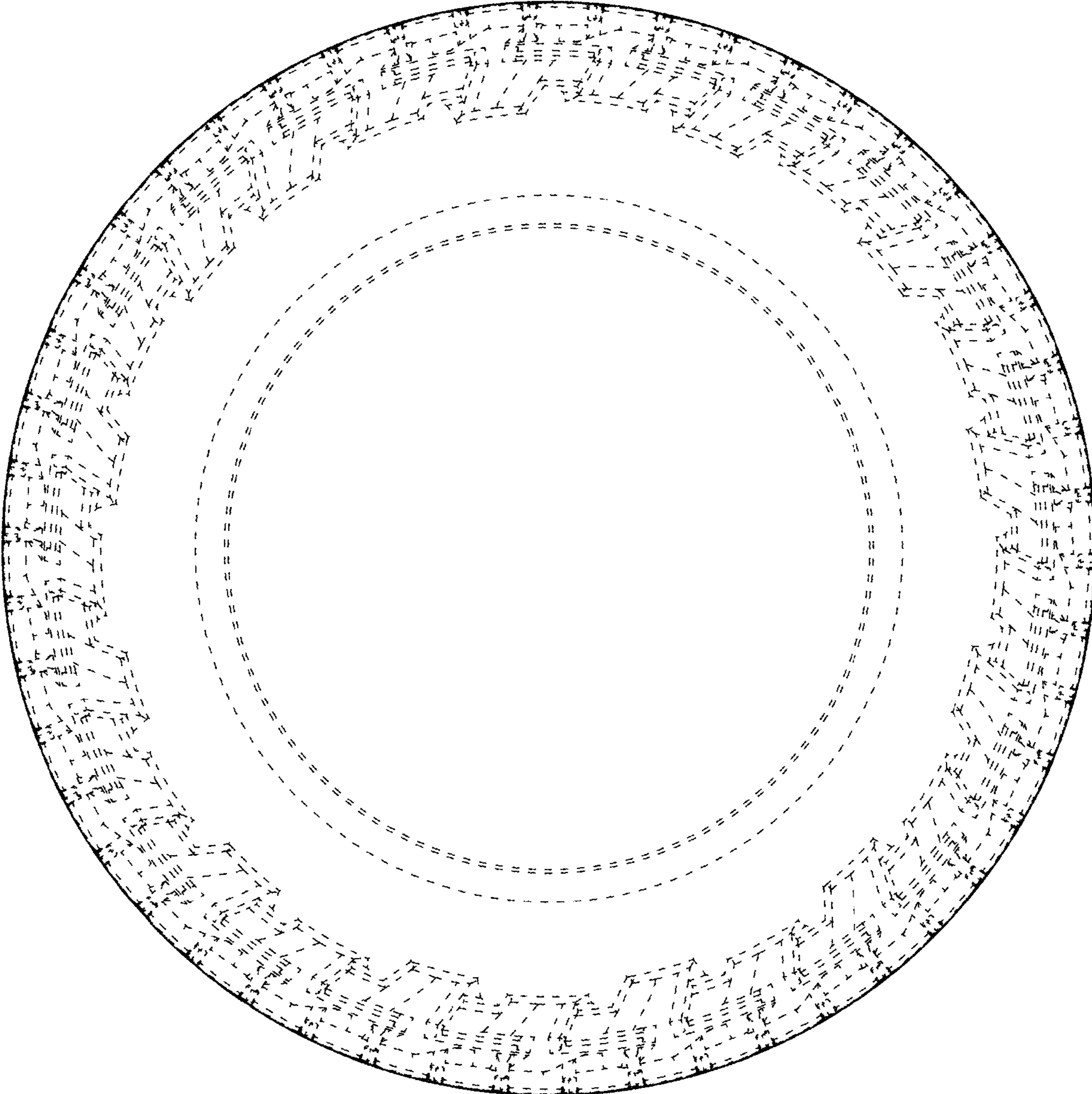

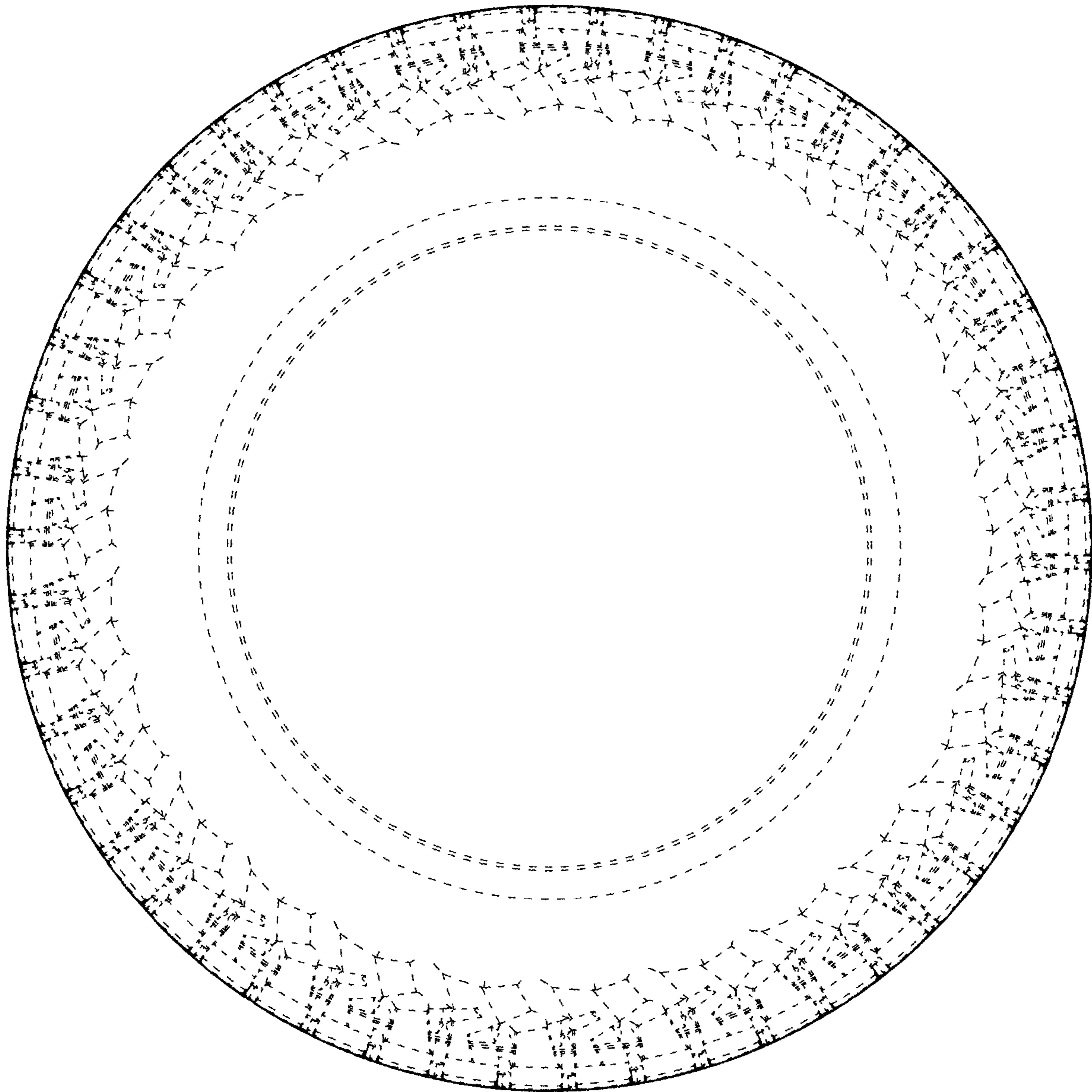

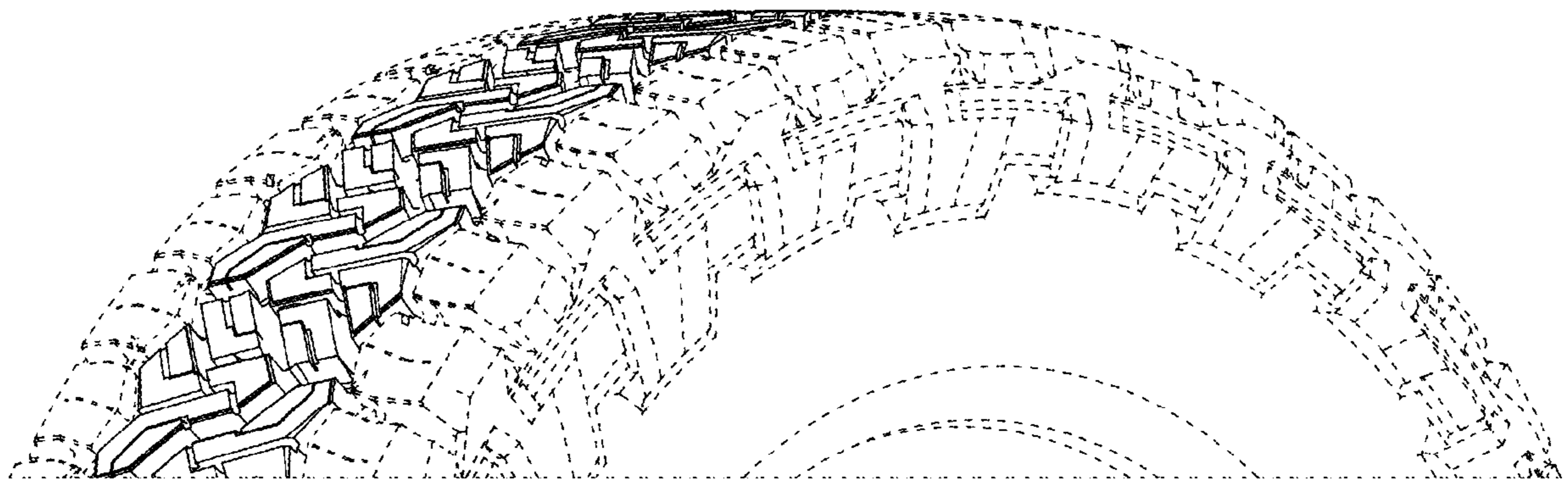

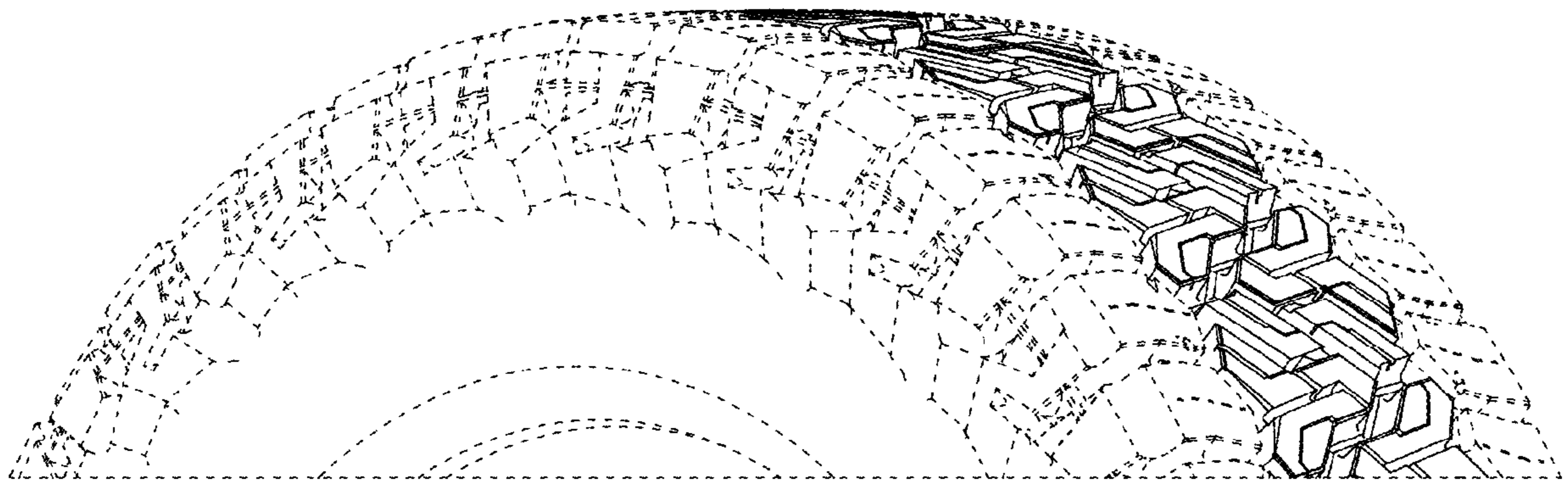

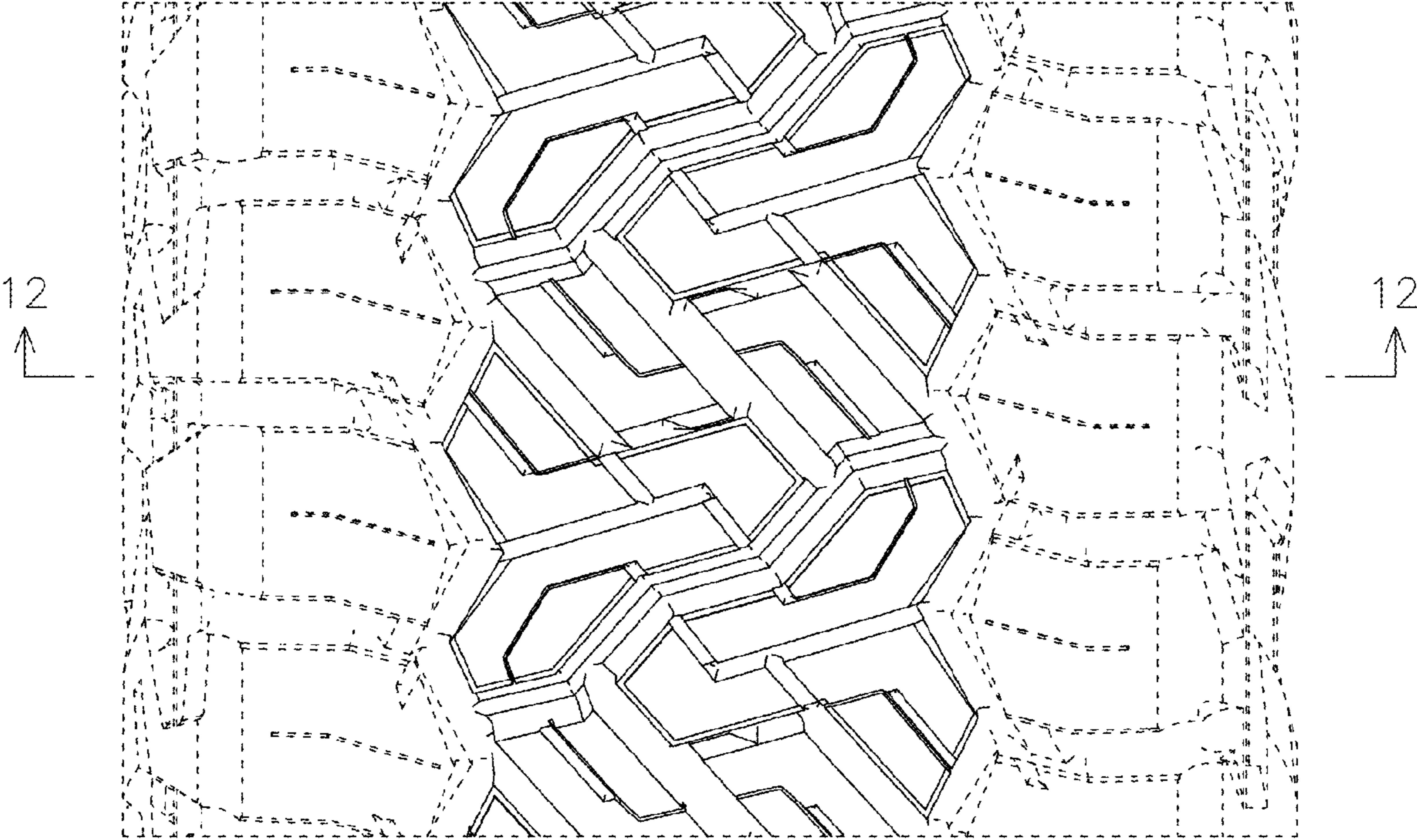

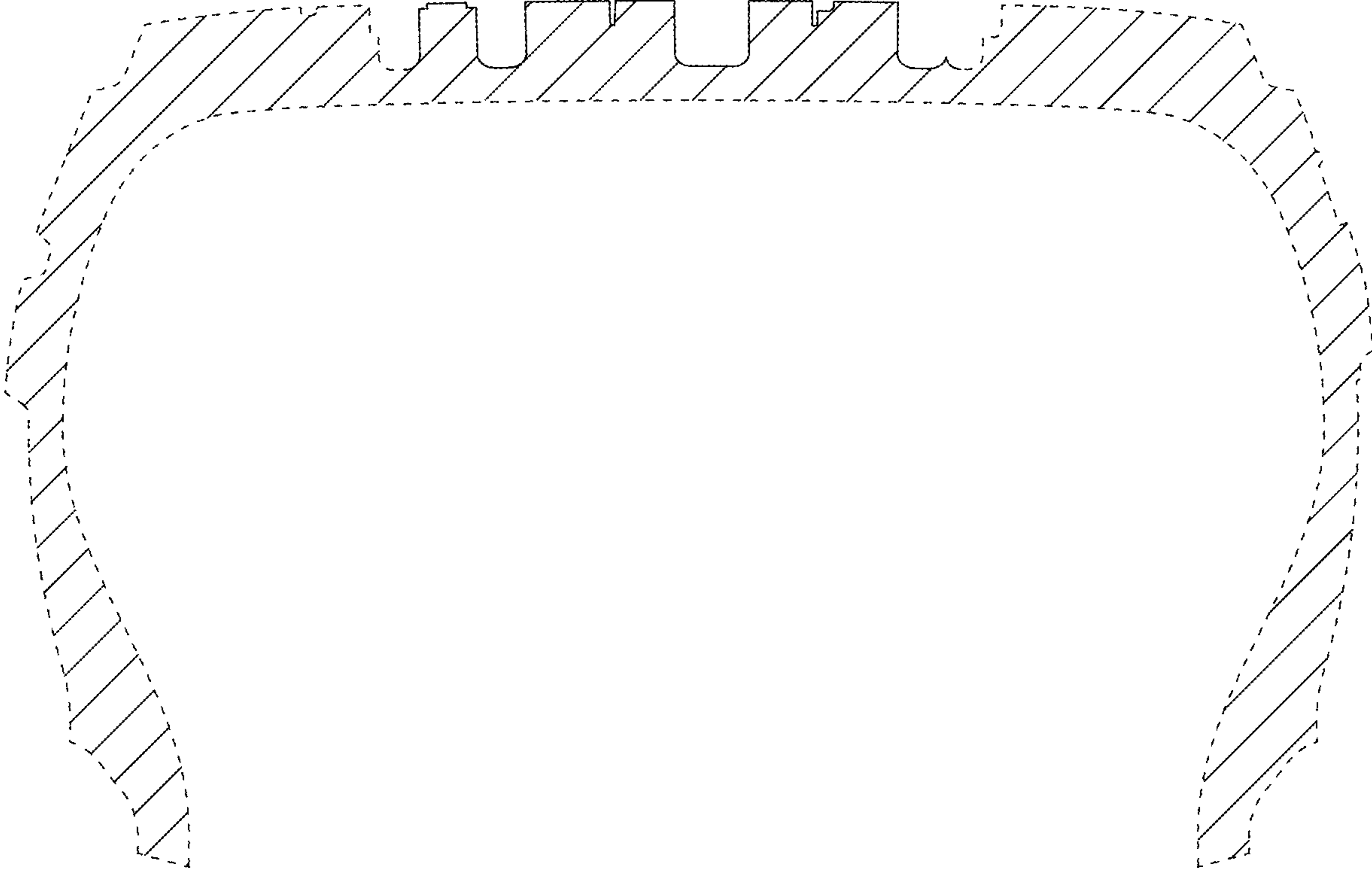
