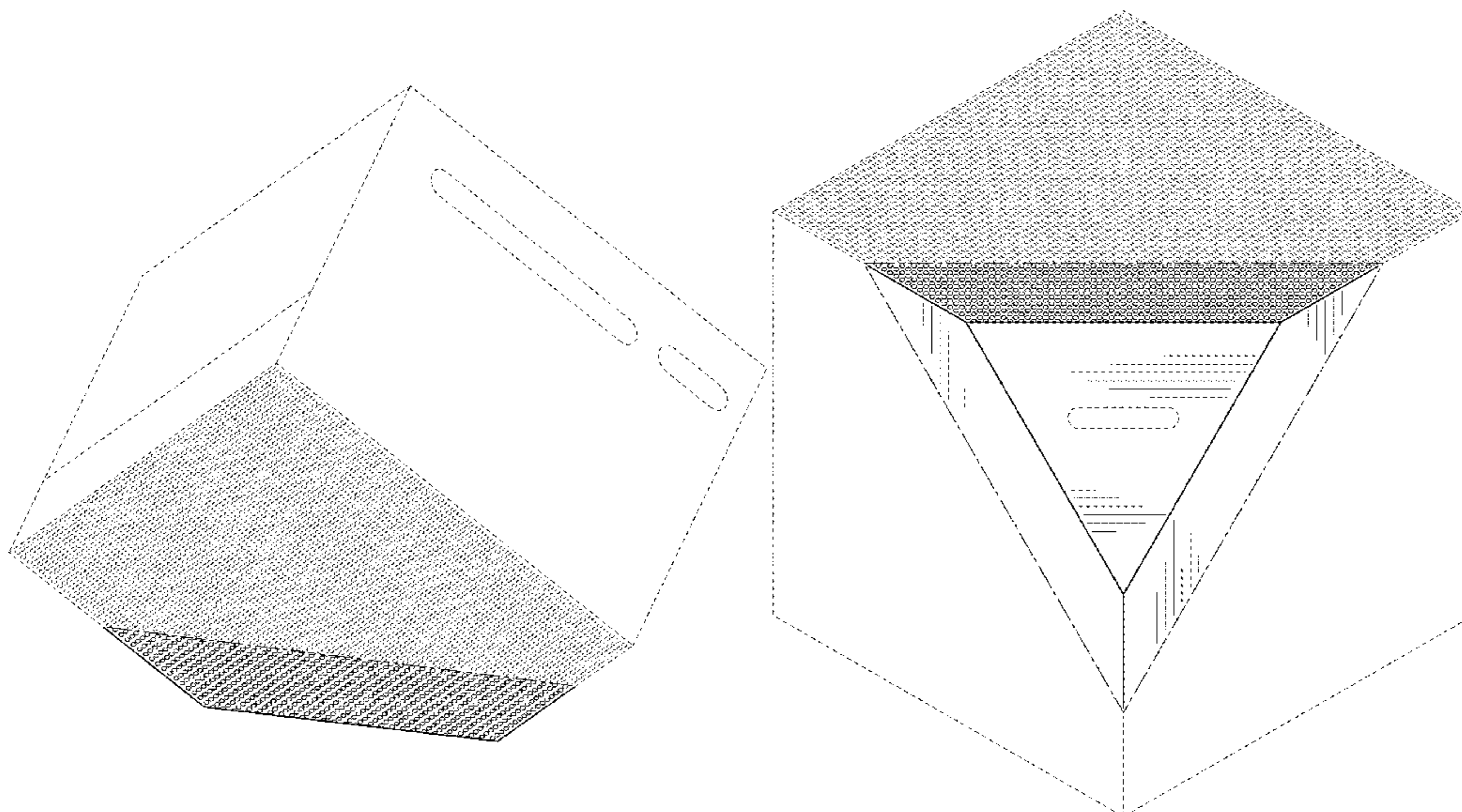
(57) **CLAIM**

The ornamental design for a speaker, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, front, and left side isometric view of a first embodiment of a speaker, showing my new design; FIG. 2 is a front elevational view of the speaker of FIG. 1; FIG. 3 is a rear elevational view of the speaker of FIG. 1; FIG. 4 is a left side elevational view of the speaker of FIG. 1; FIG. 5 is a right side elevational view of the speaker of FIG. 1; FIG. 6 is a top plan view of the speaker of FIG. 1; and, FIG. 7 is a bottom plan view of the speaker of FIG. 1. The dash-dash-dash lines are included for the purpose of illustrating portions that form no part of the claimed design. The dash-dot-dash lines are included for the purpose of illustrating boundary lines and form no part of the claimed design.

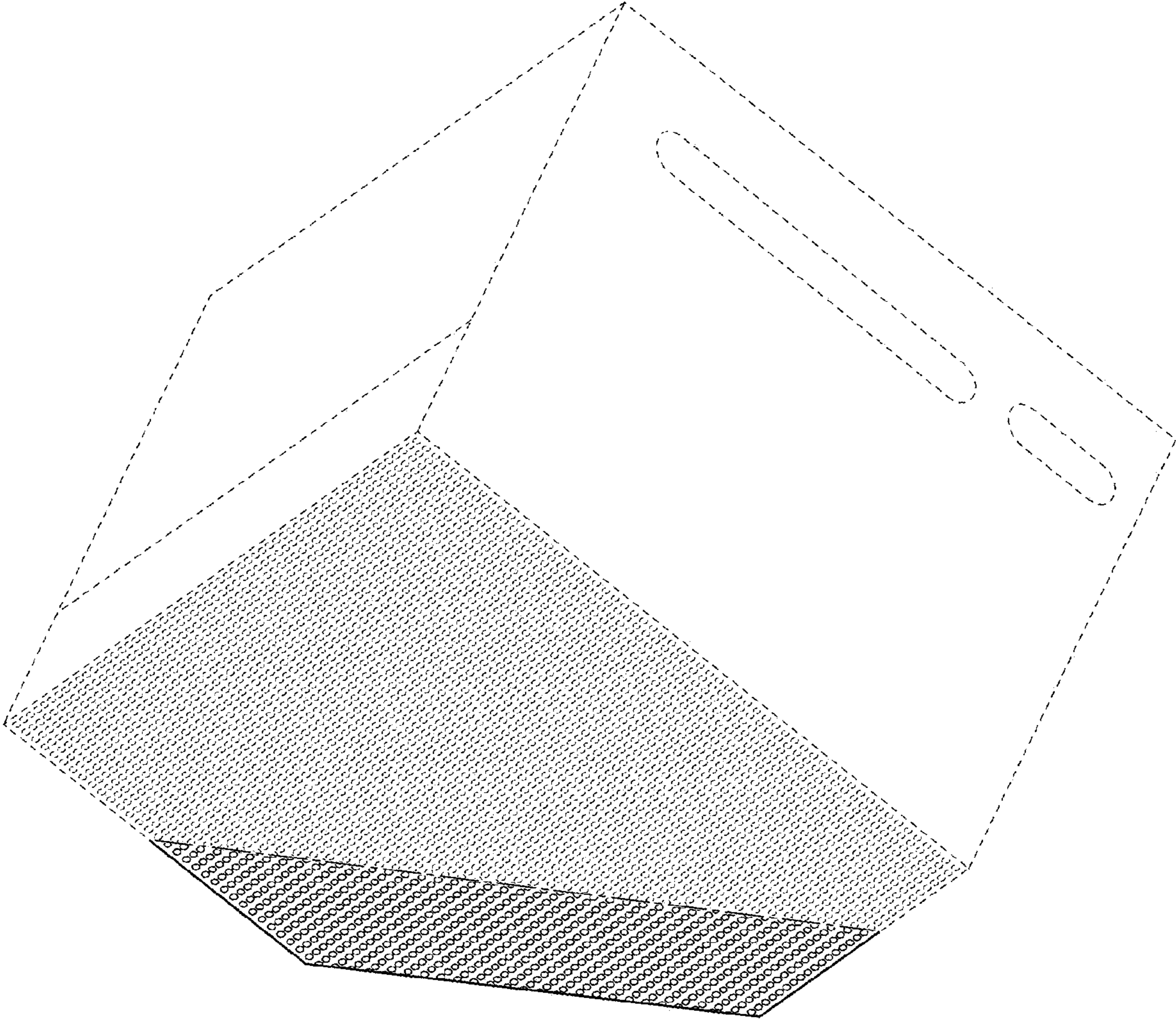

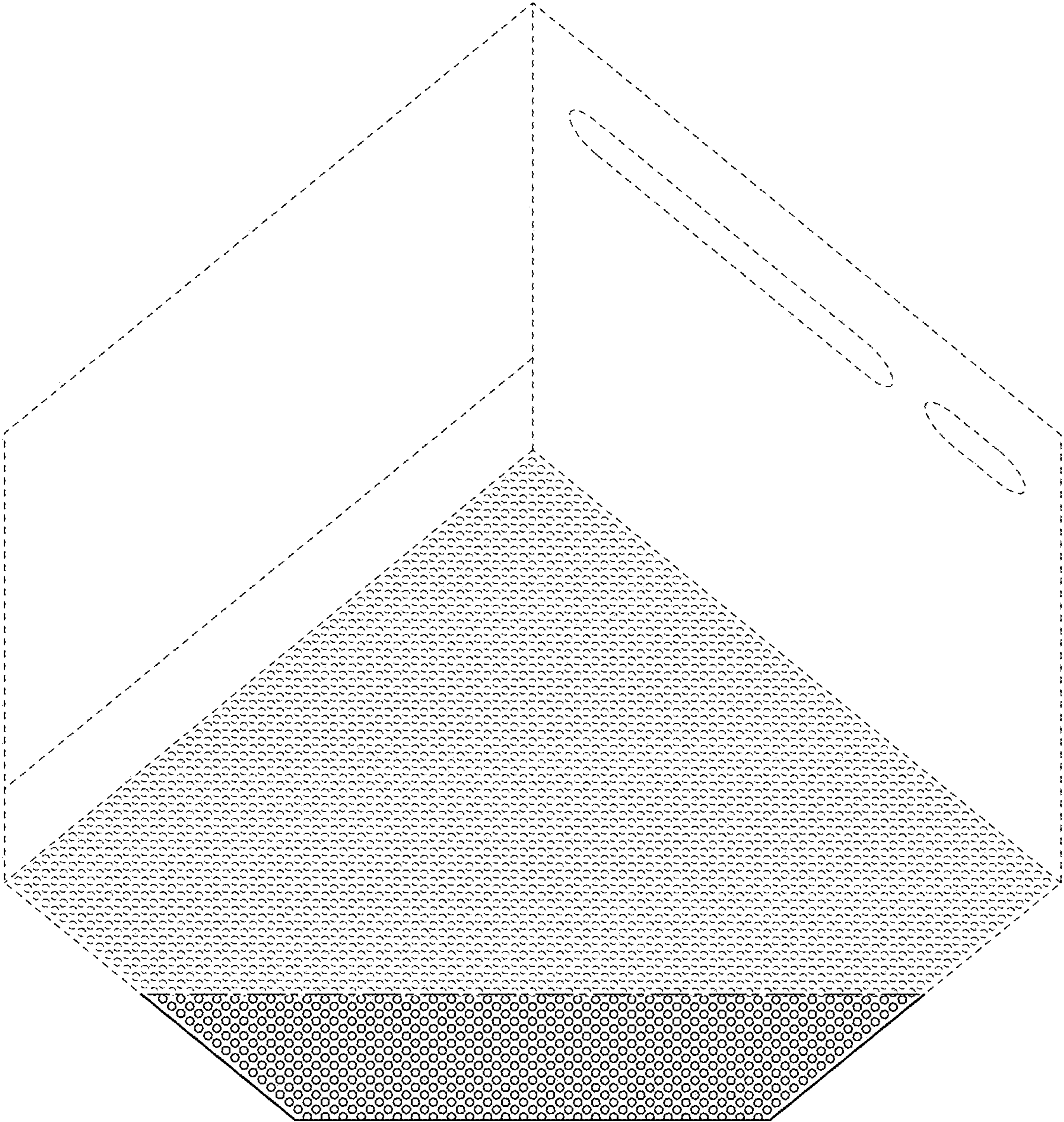

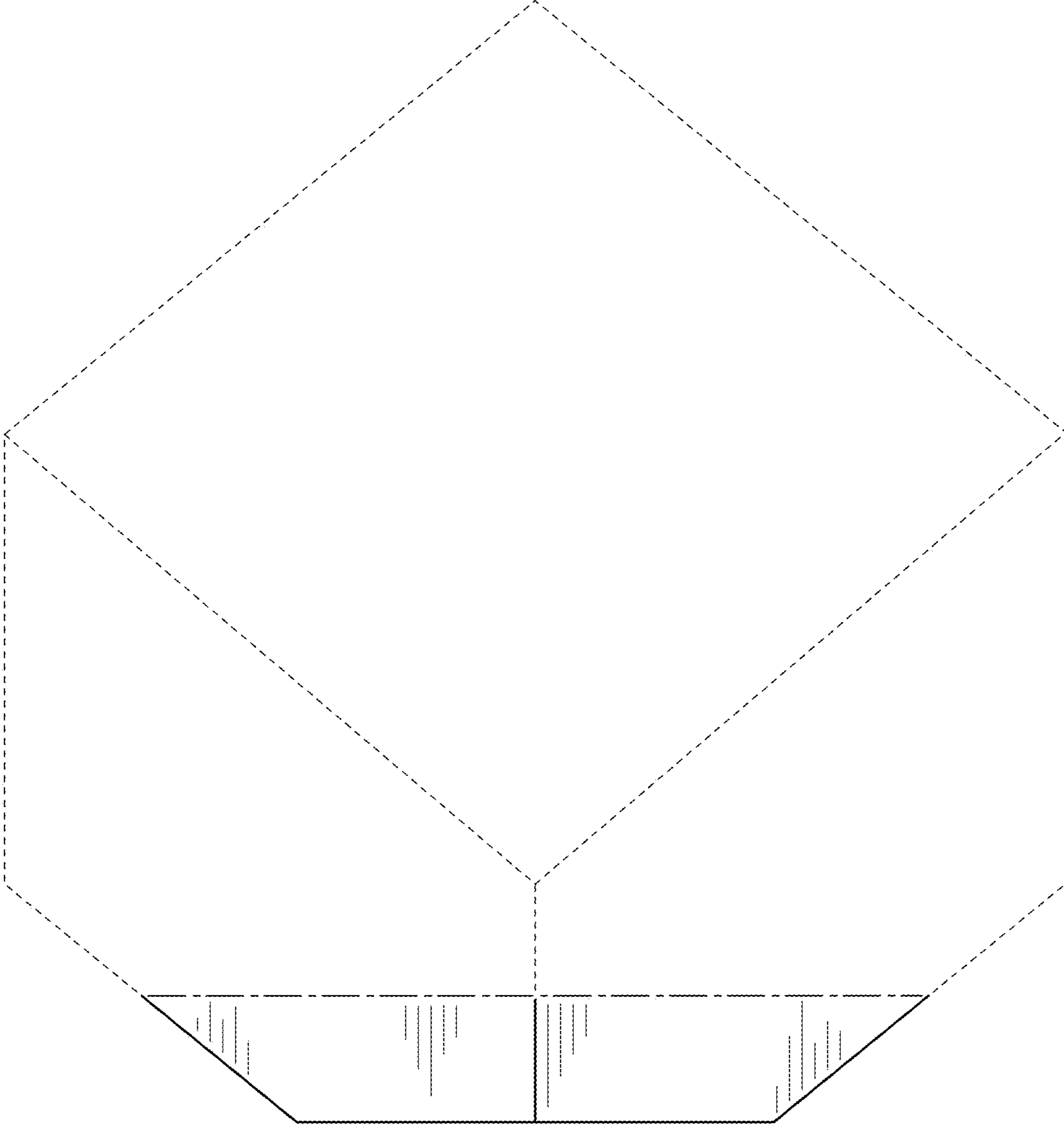

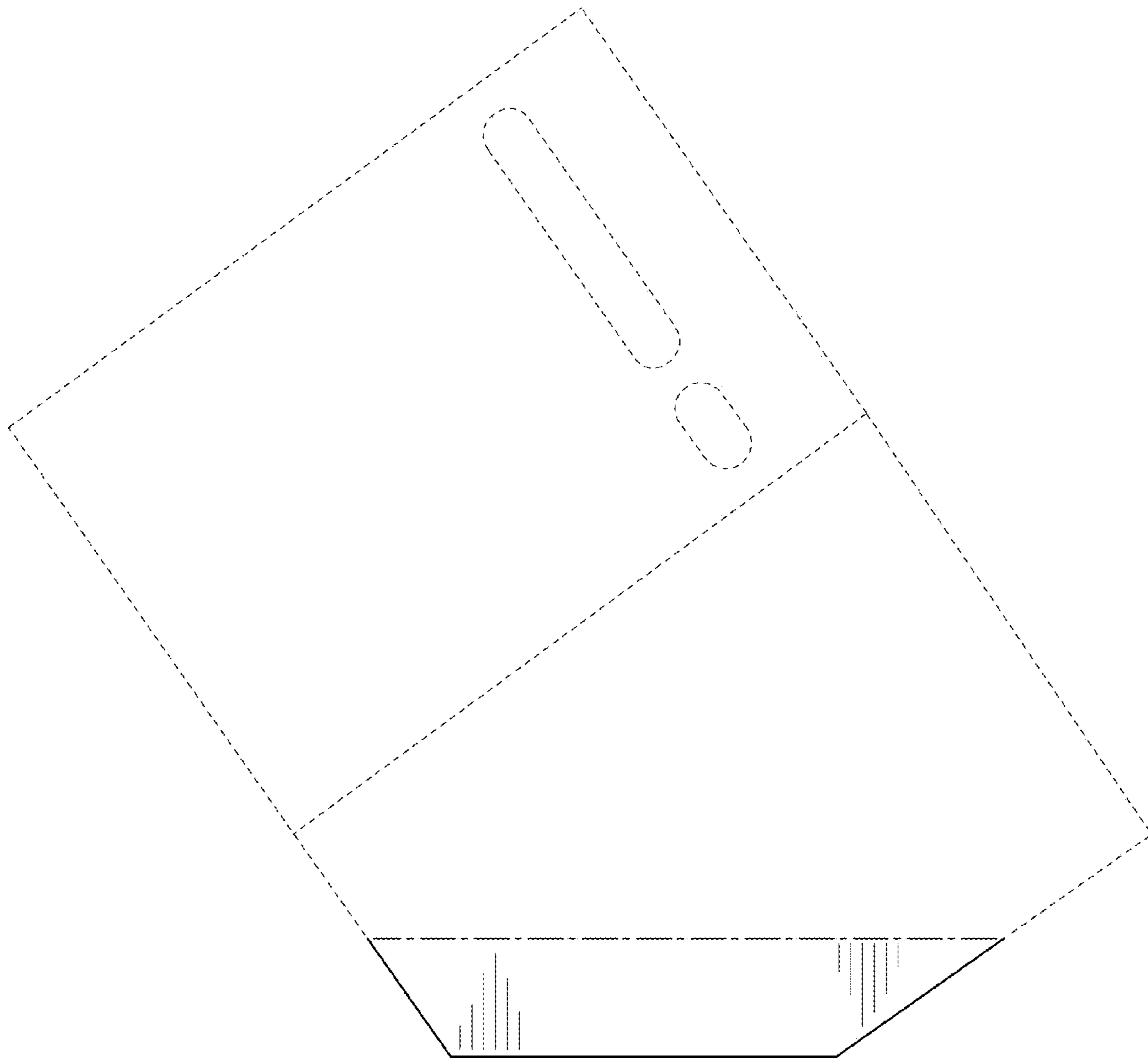

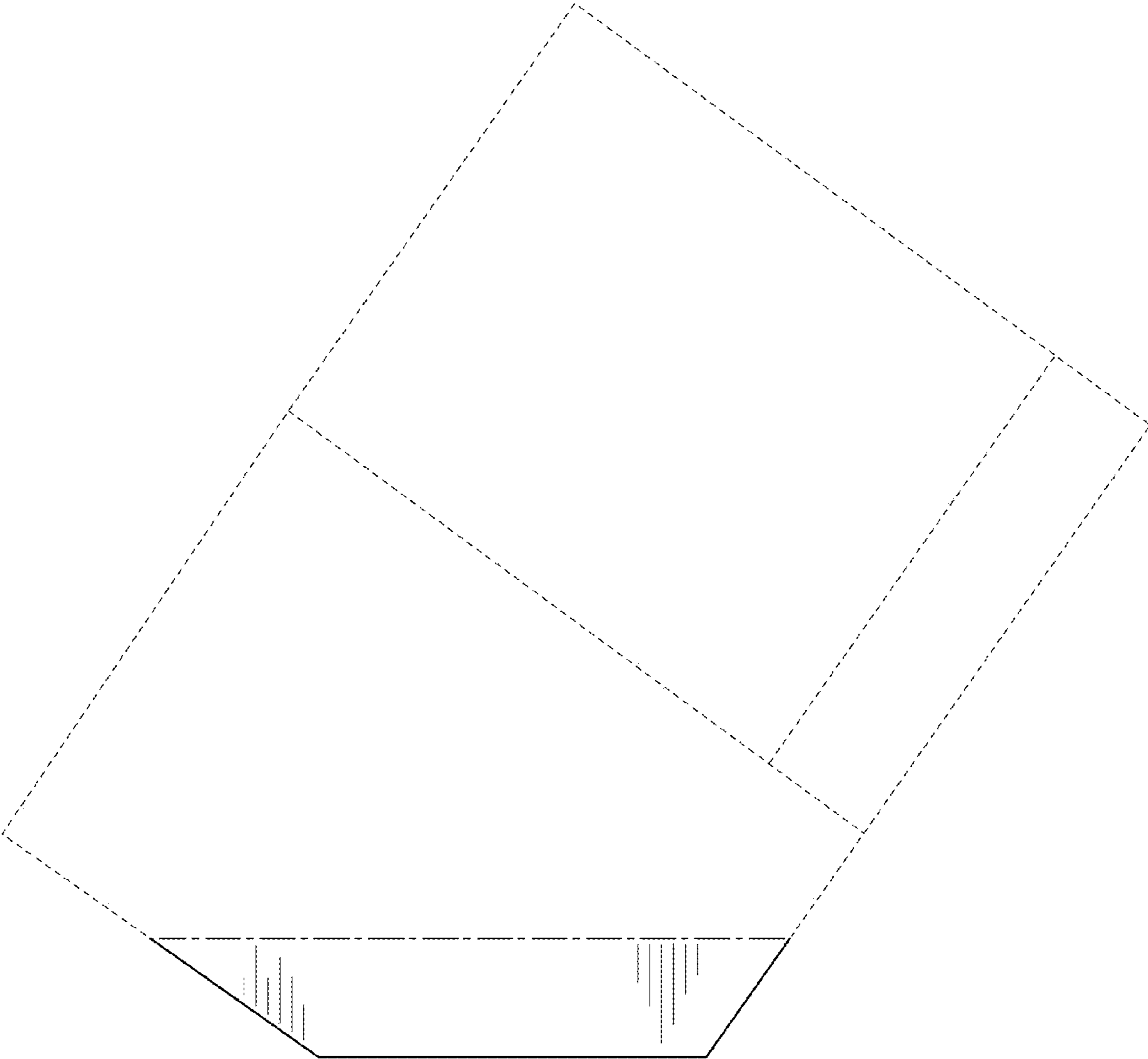

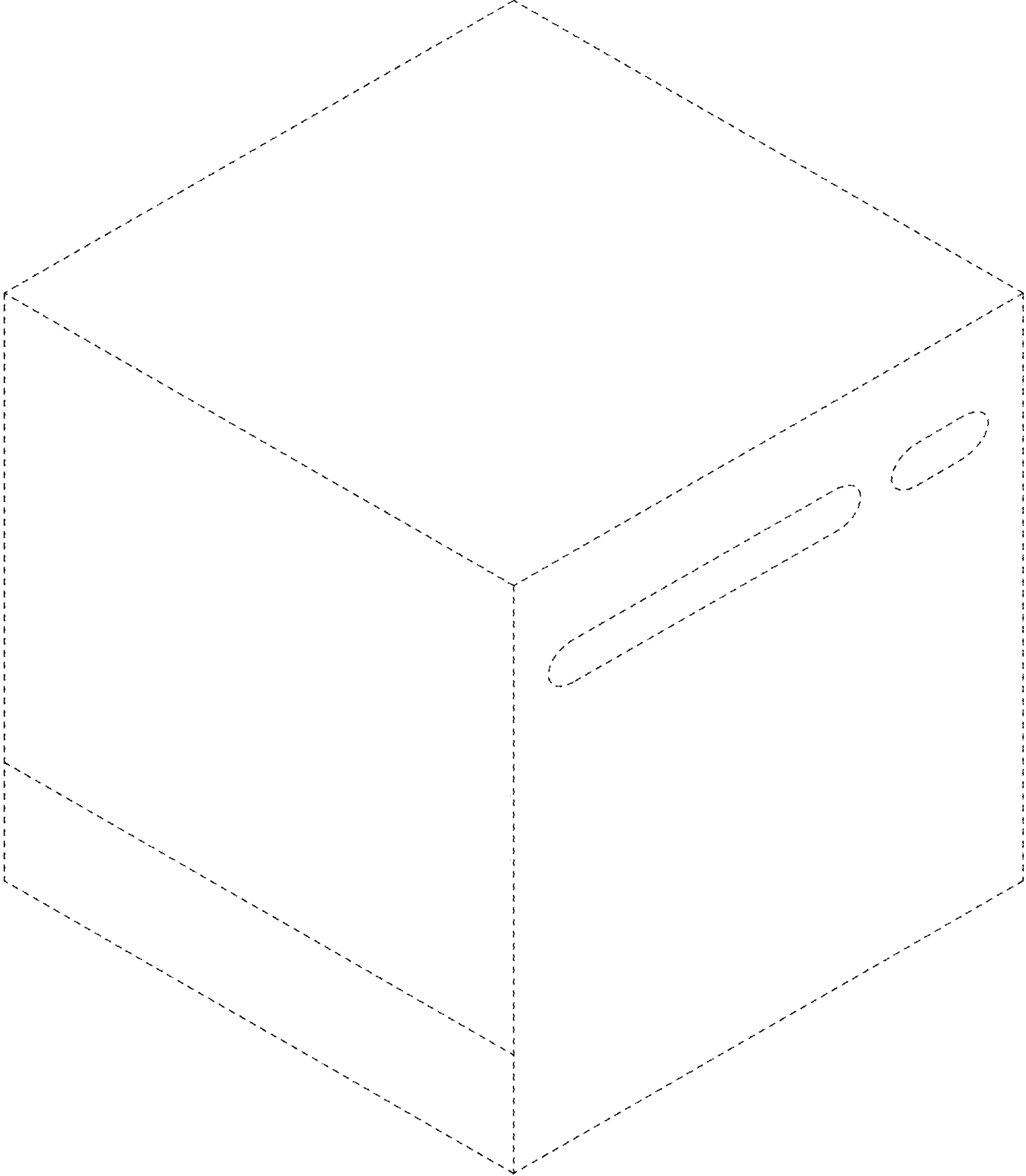

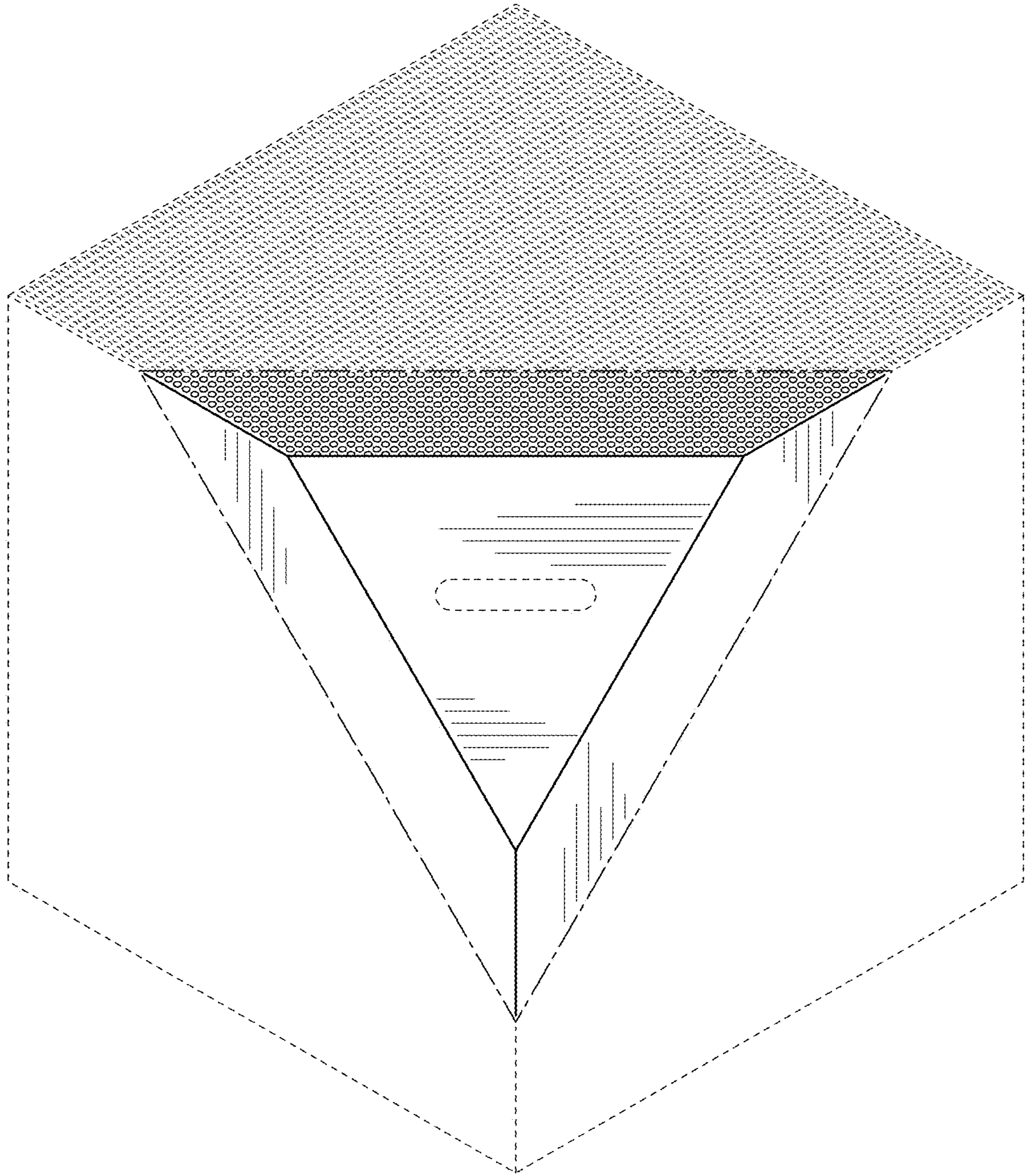
