(57) **CLAIM**

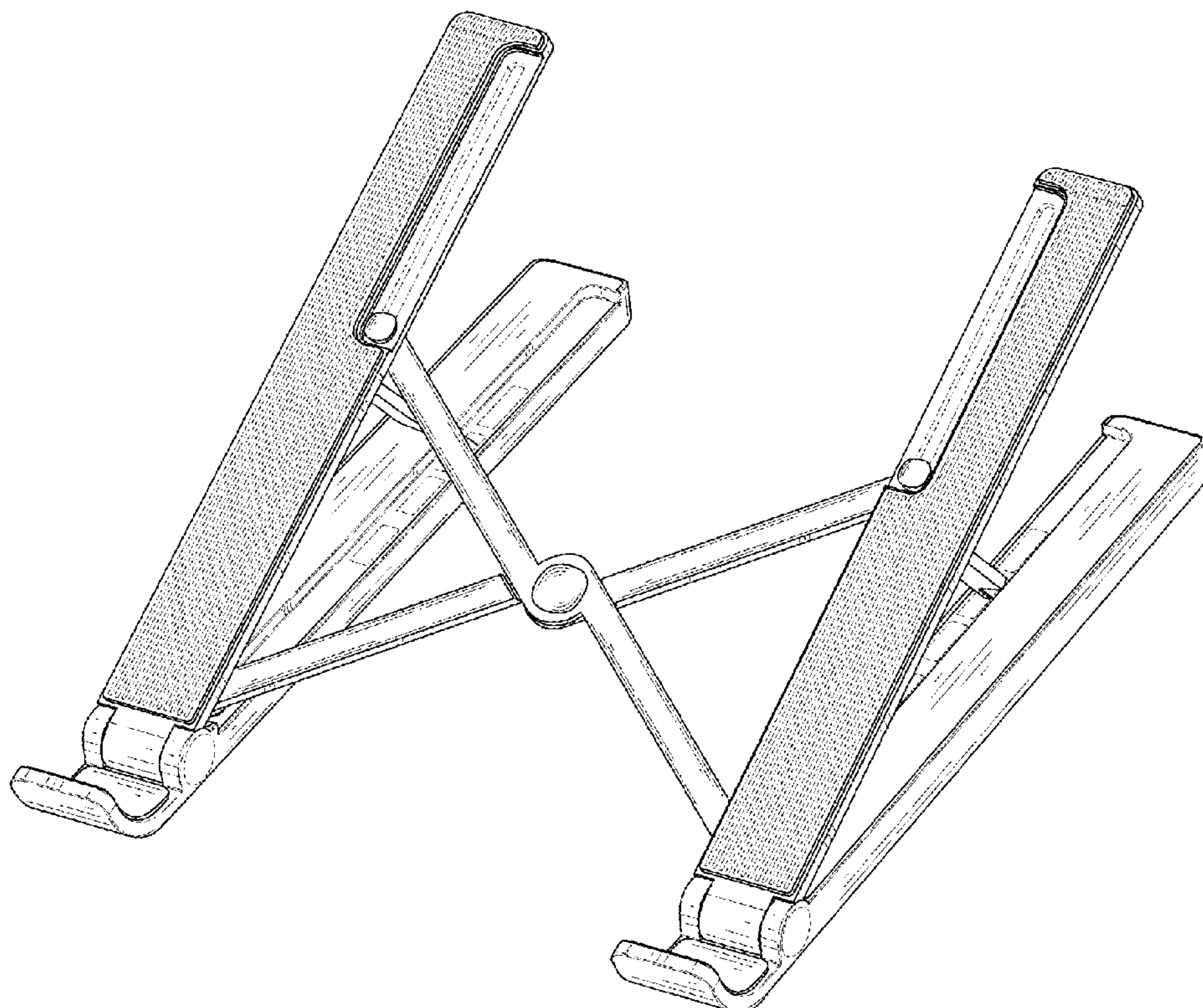
The ornamental design for an extension dock holder, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of an extension dock holder showing my new design;

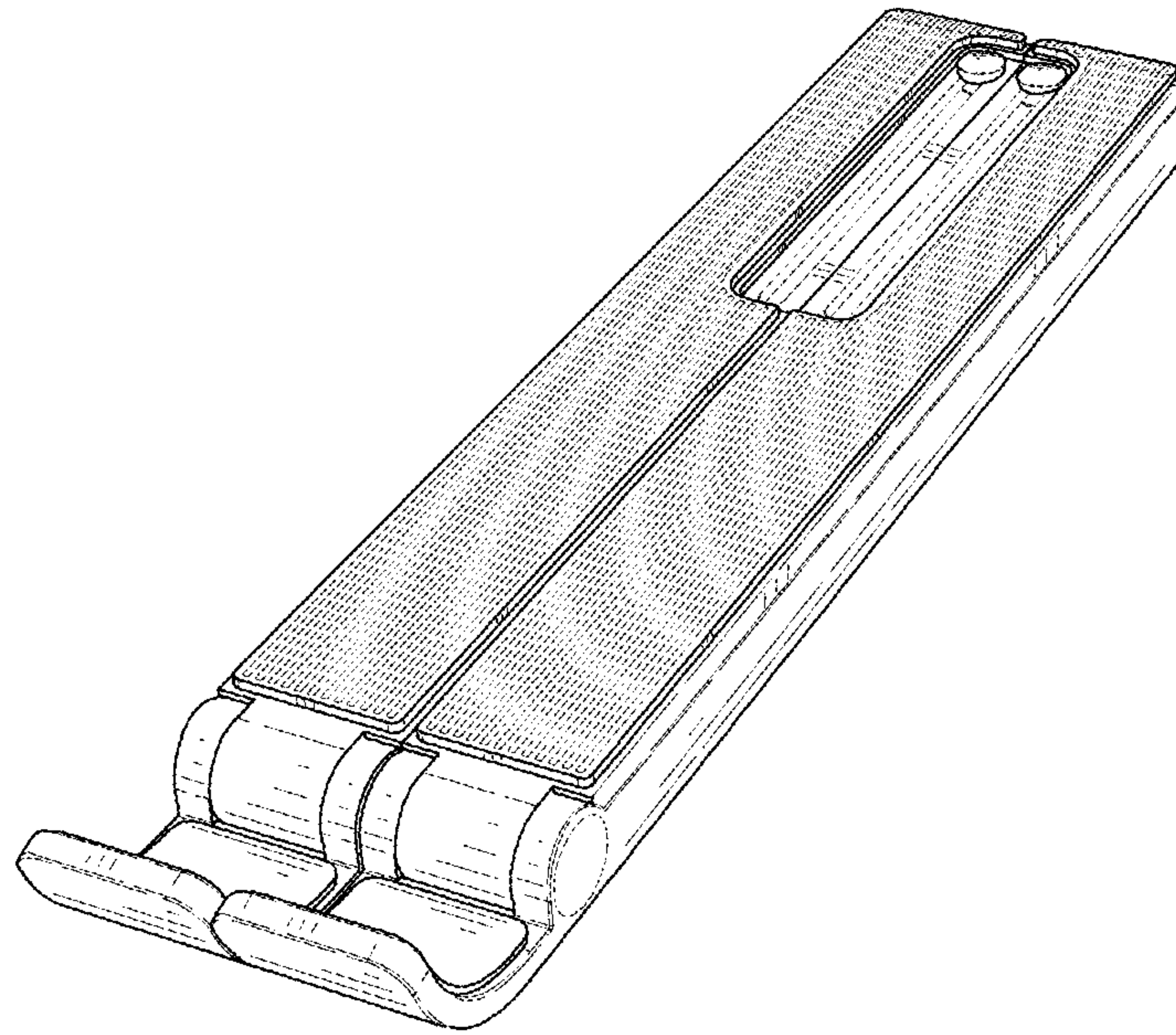

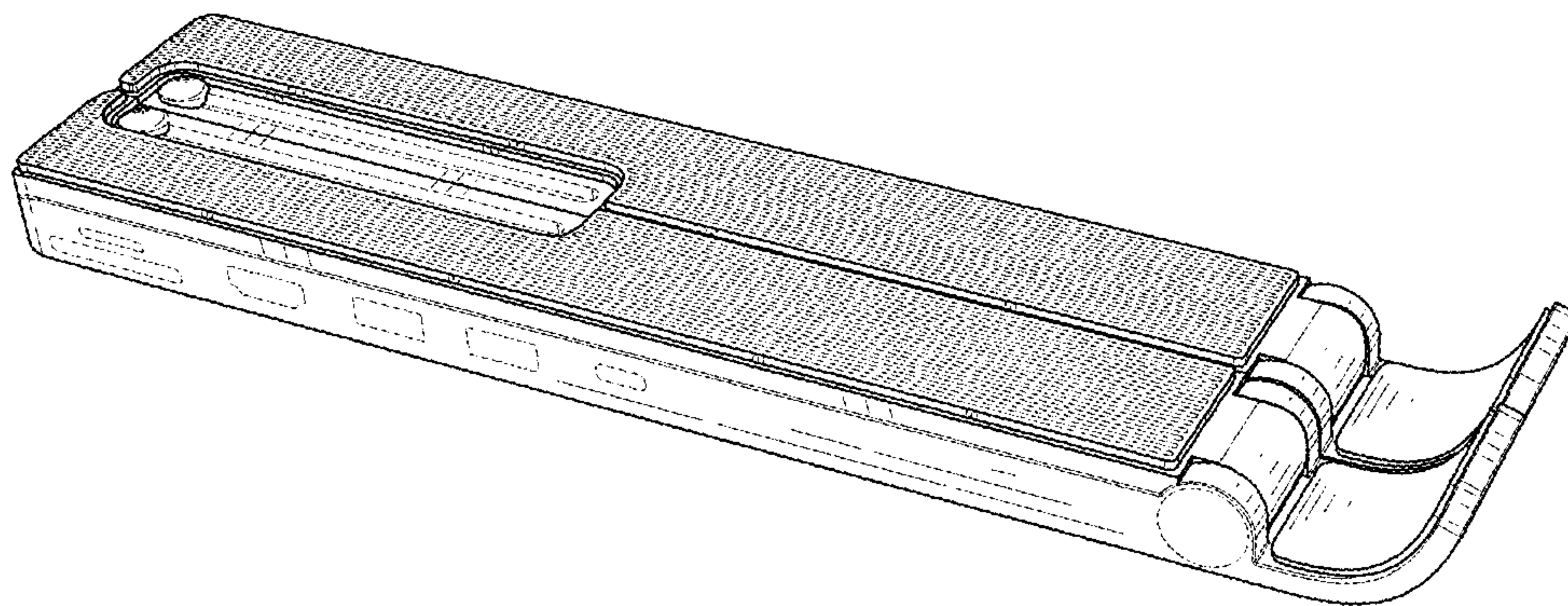

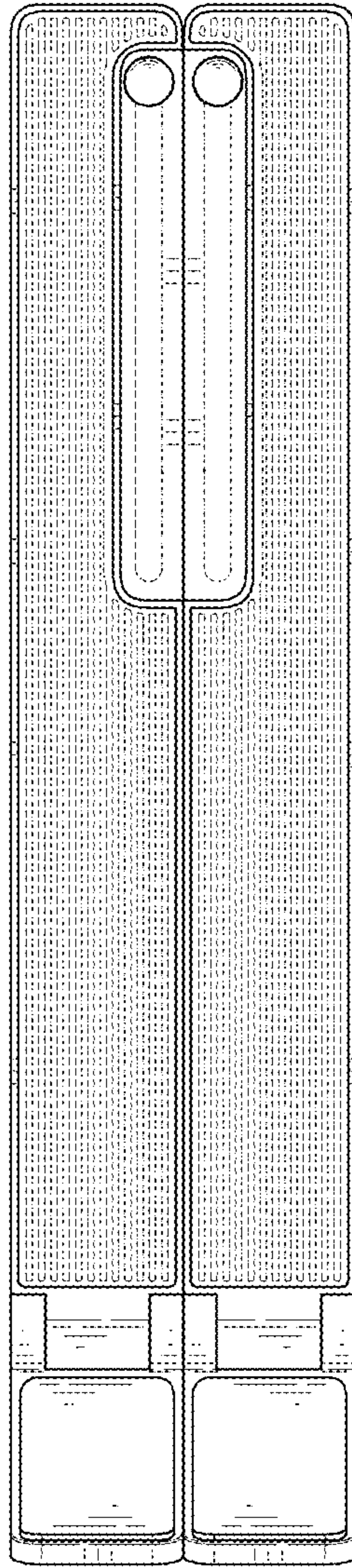

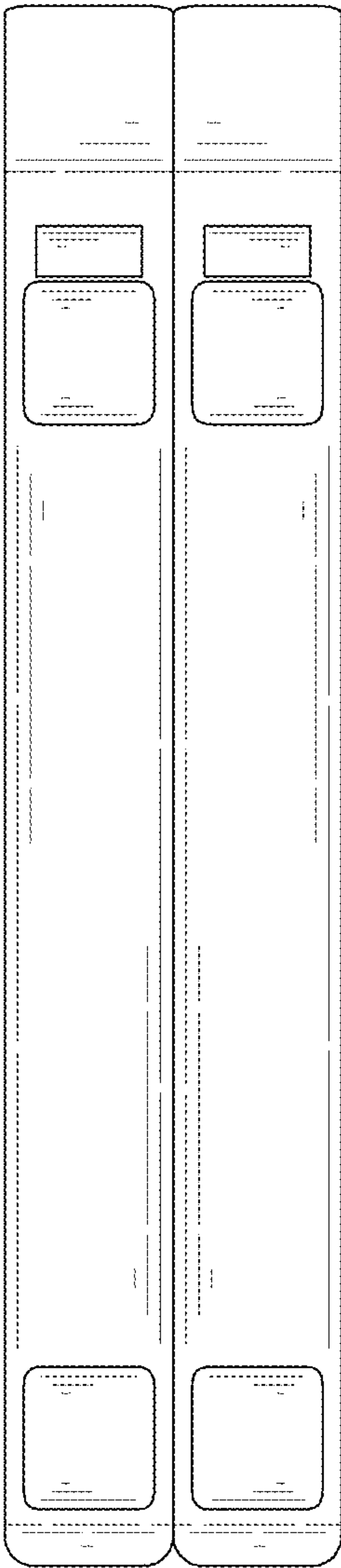

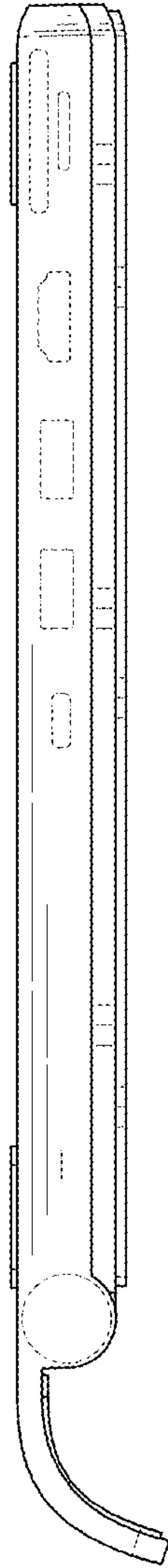

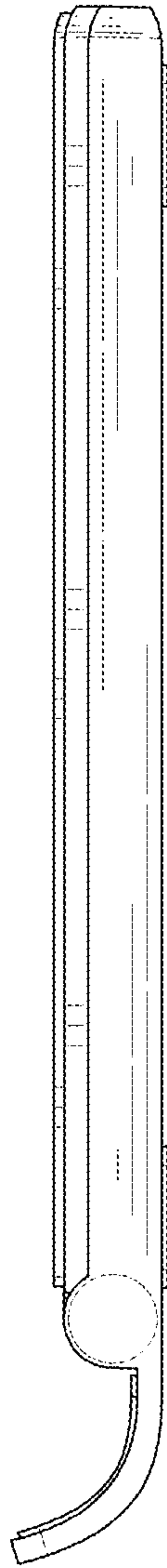

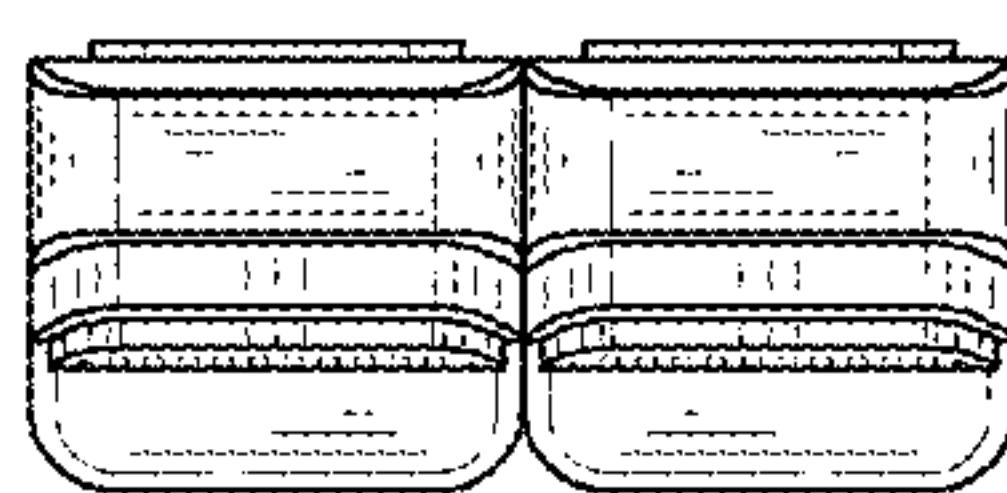

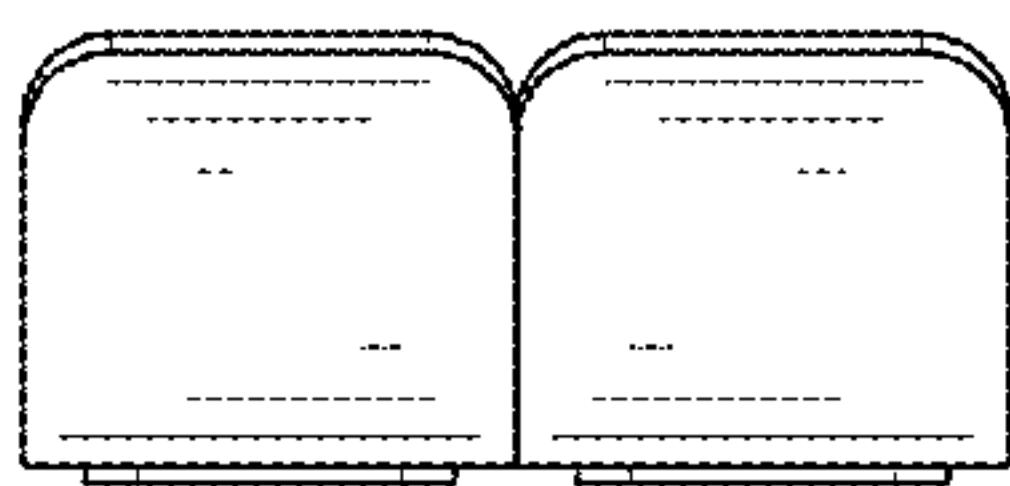

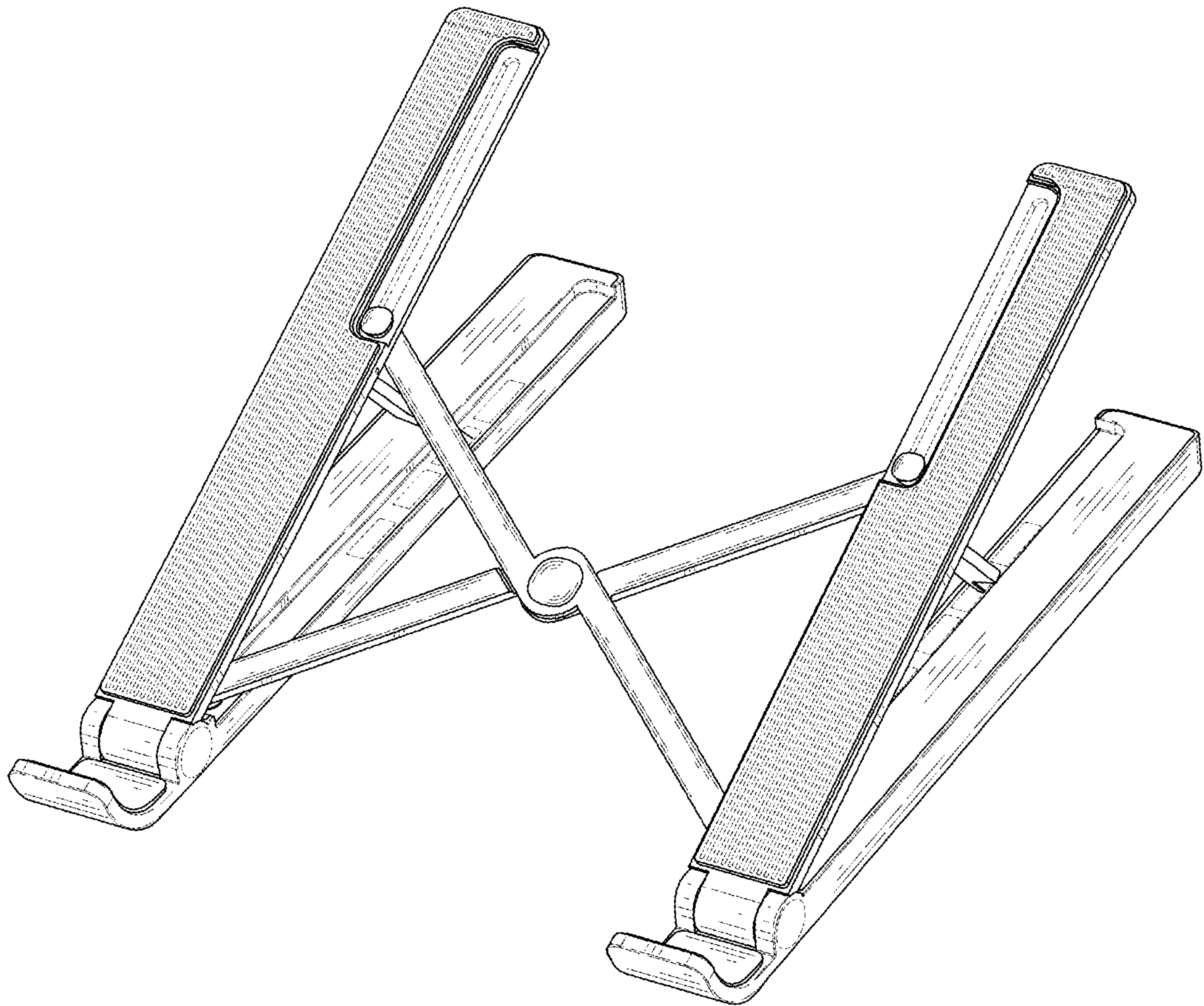
