FIG. 4 is a top view of the knife according to the present invention.

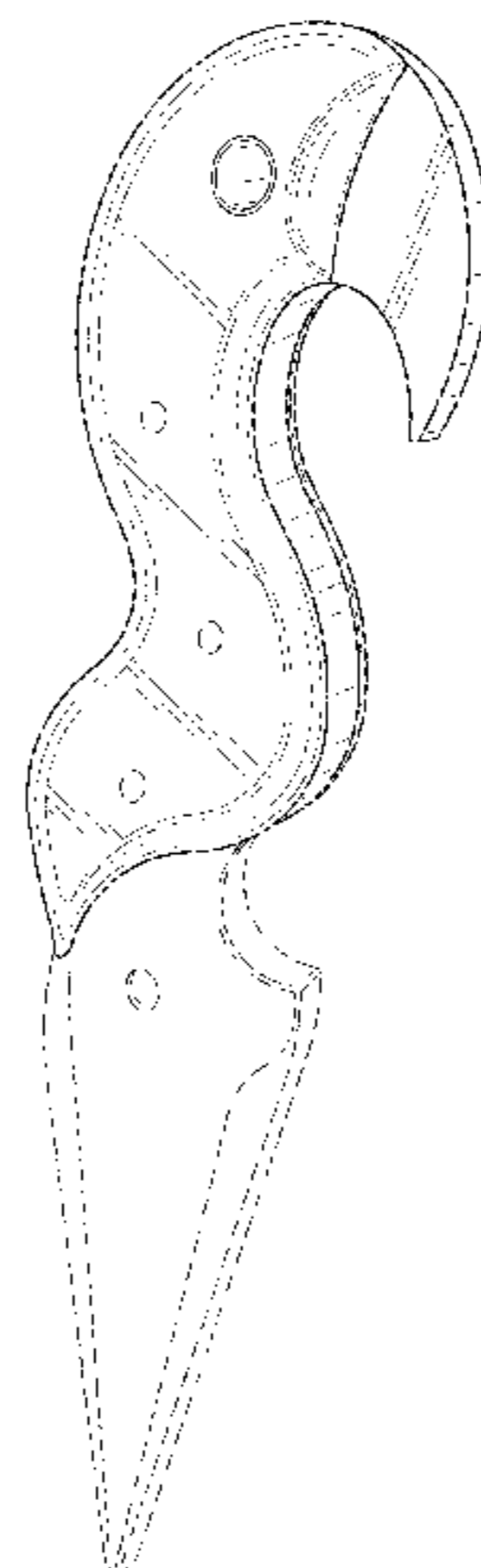
FIG. 5 is a bottom view of the knife according to the present invention.

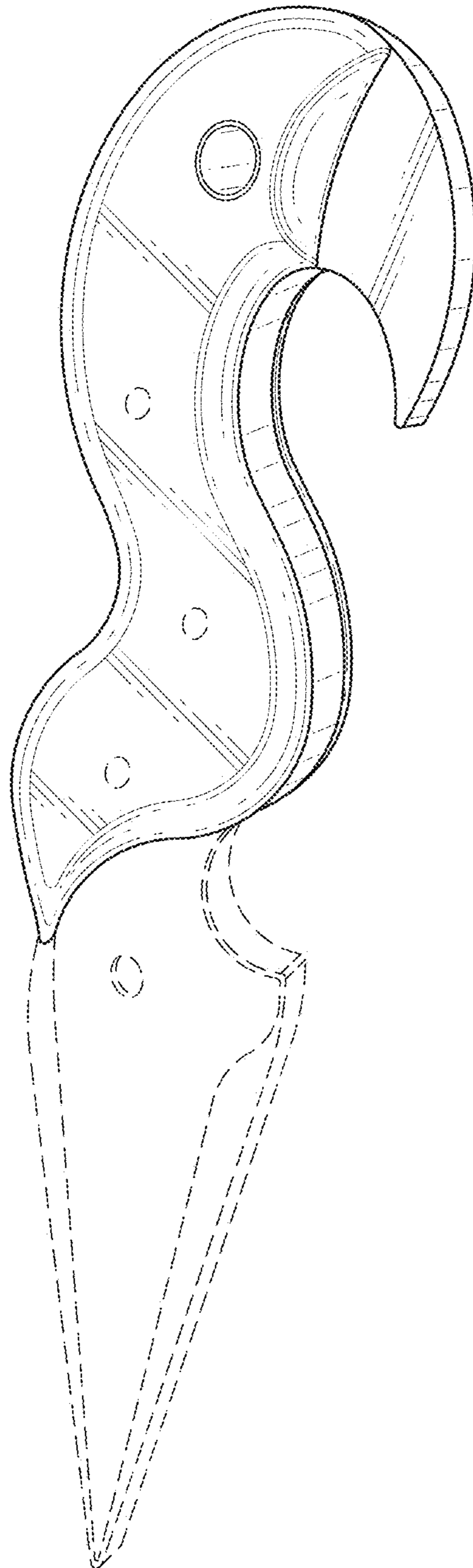

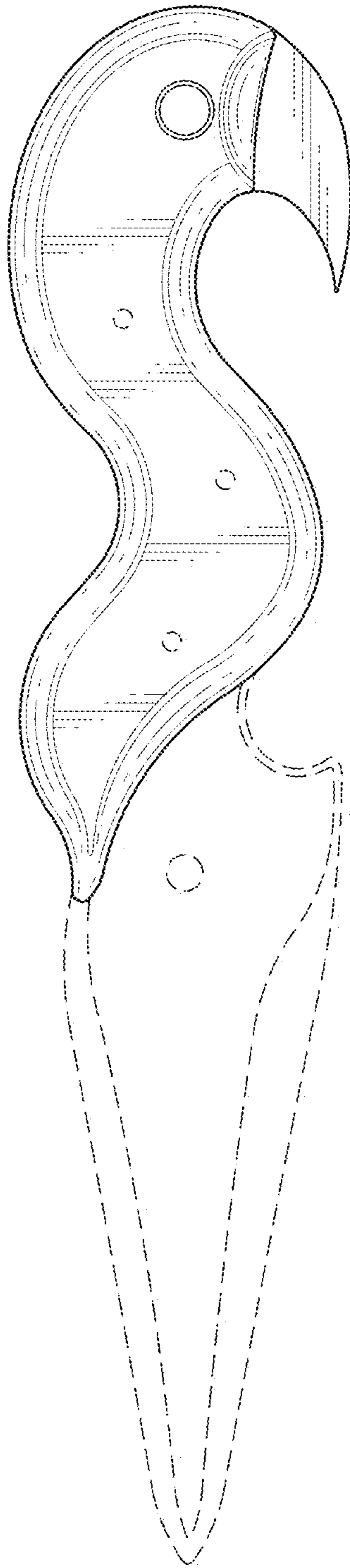

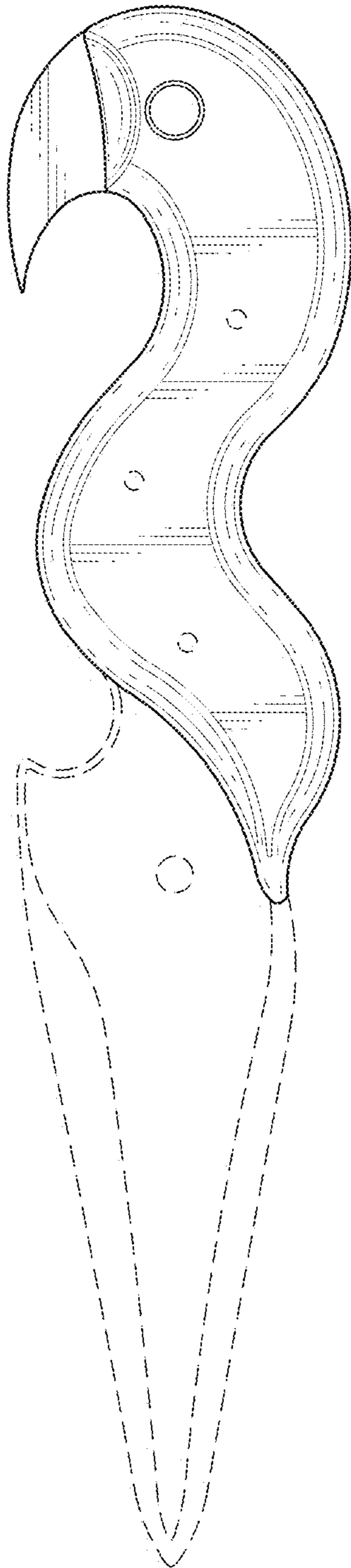

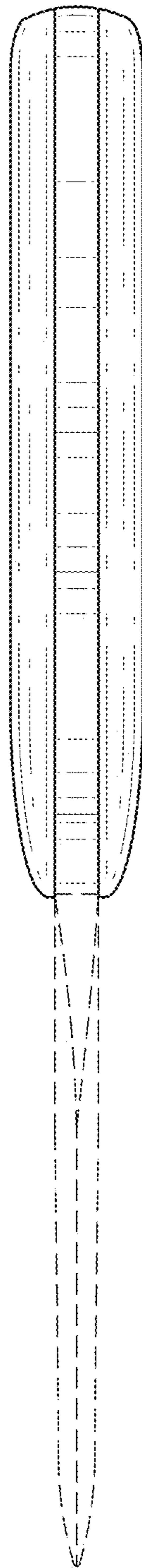

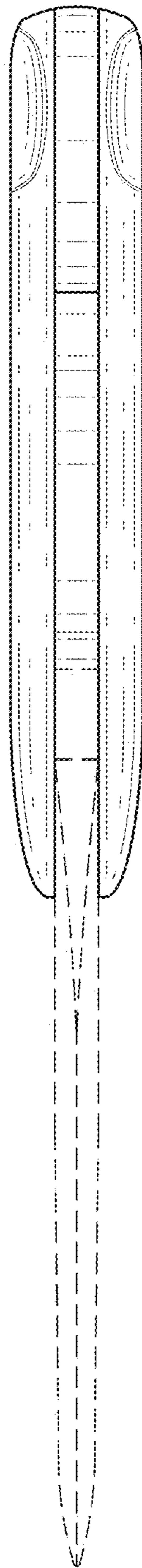

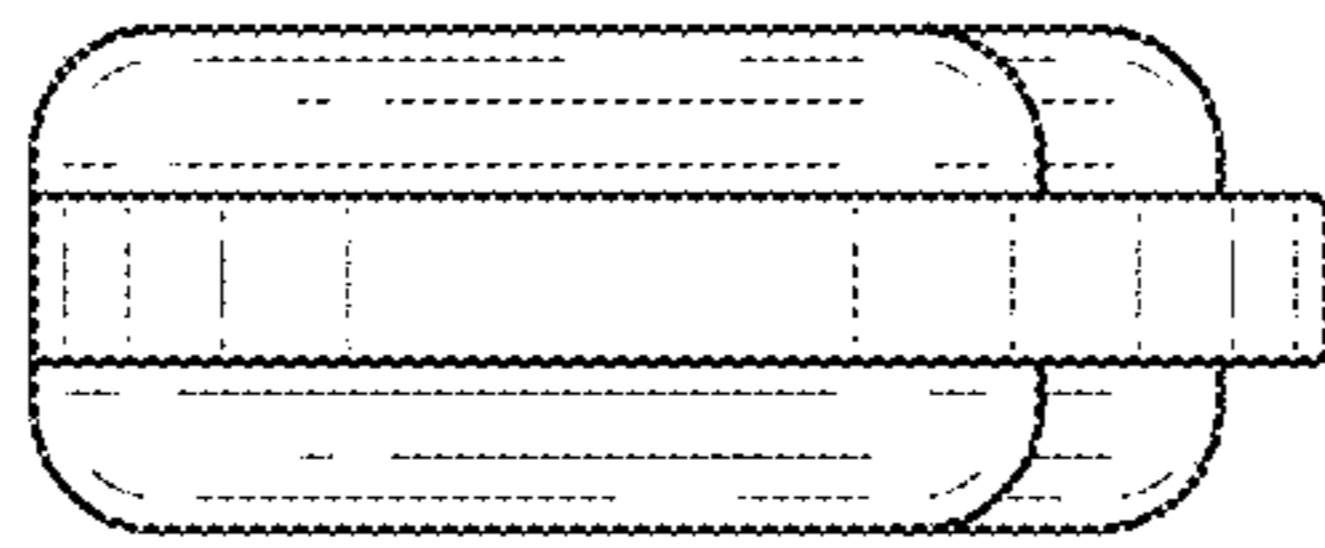

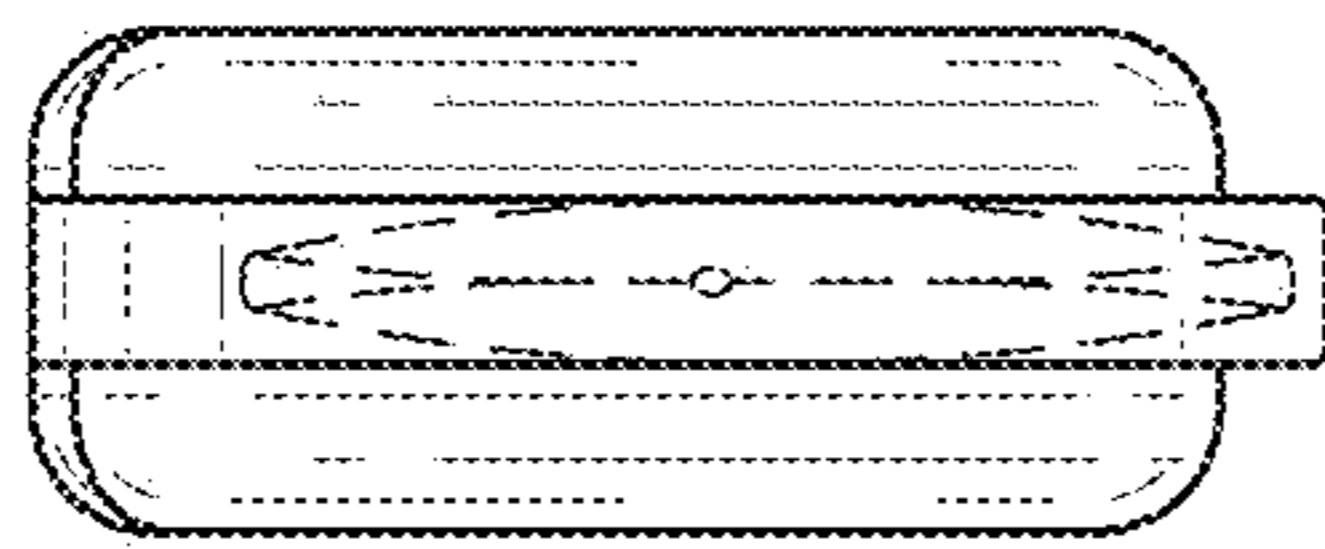
