(57) **CLAIM**

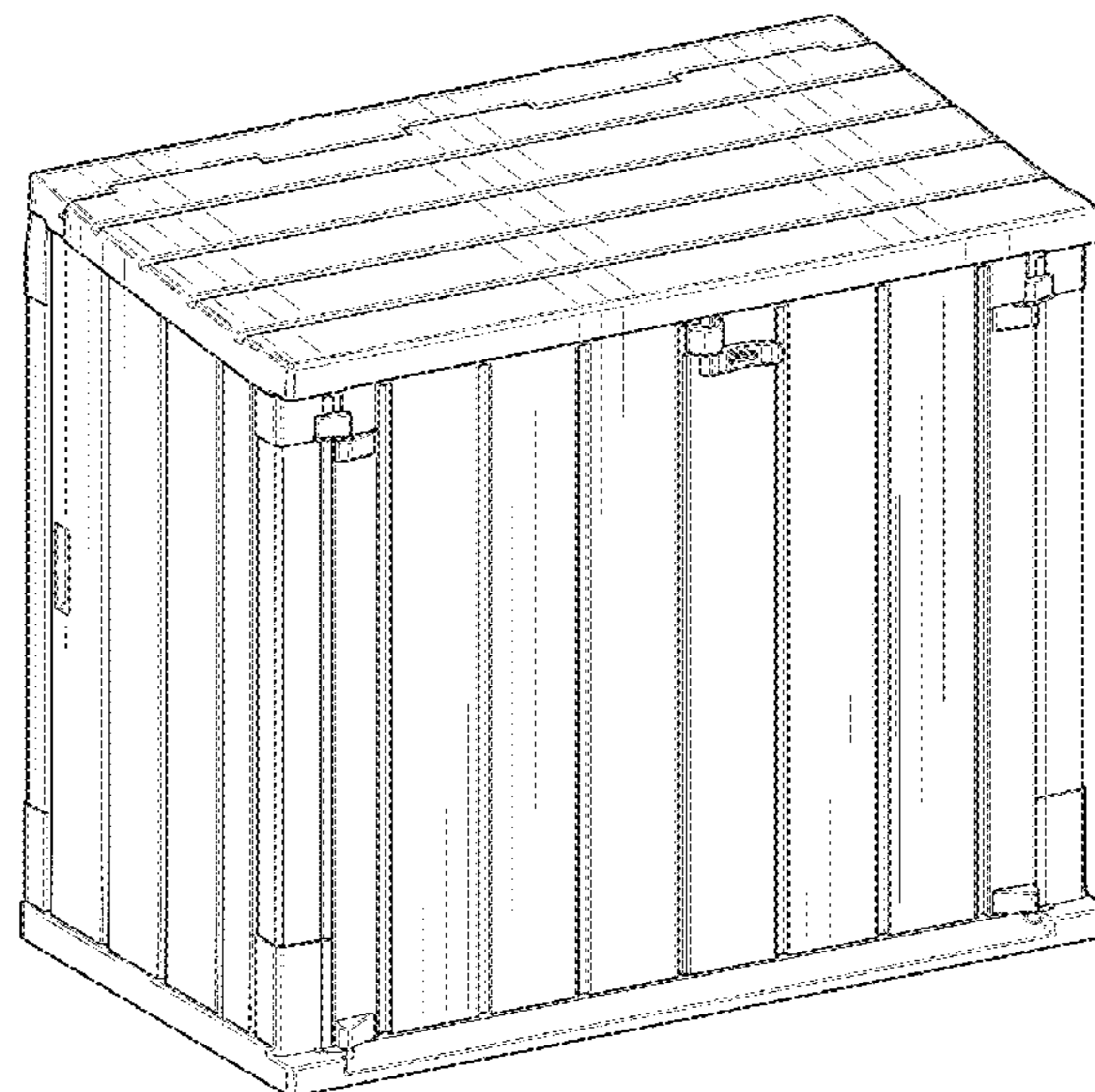
The ornamental design for a garden shed, as shown and described.

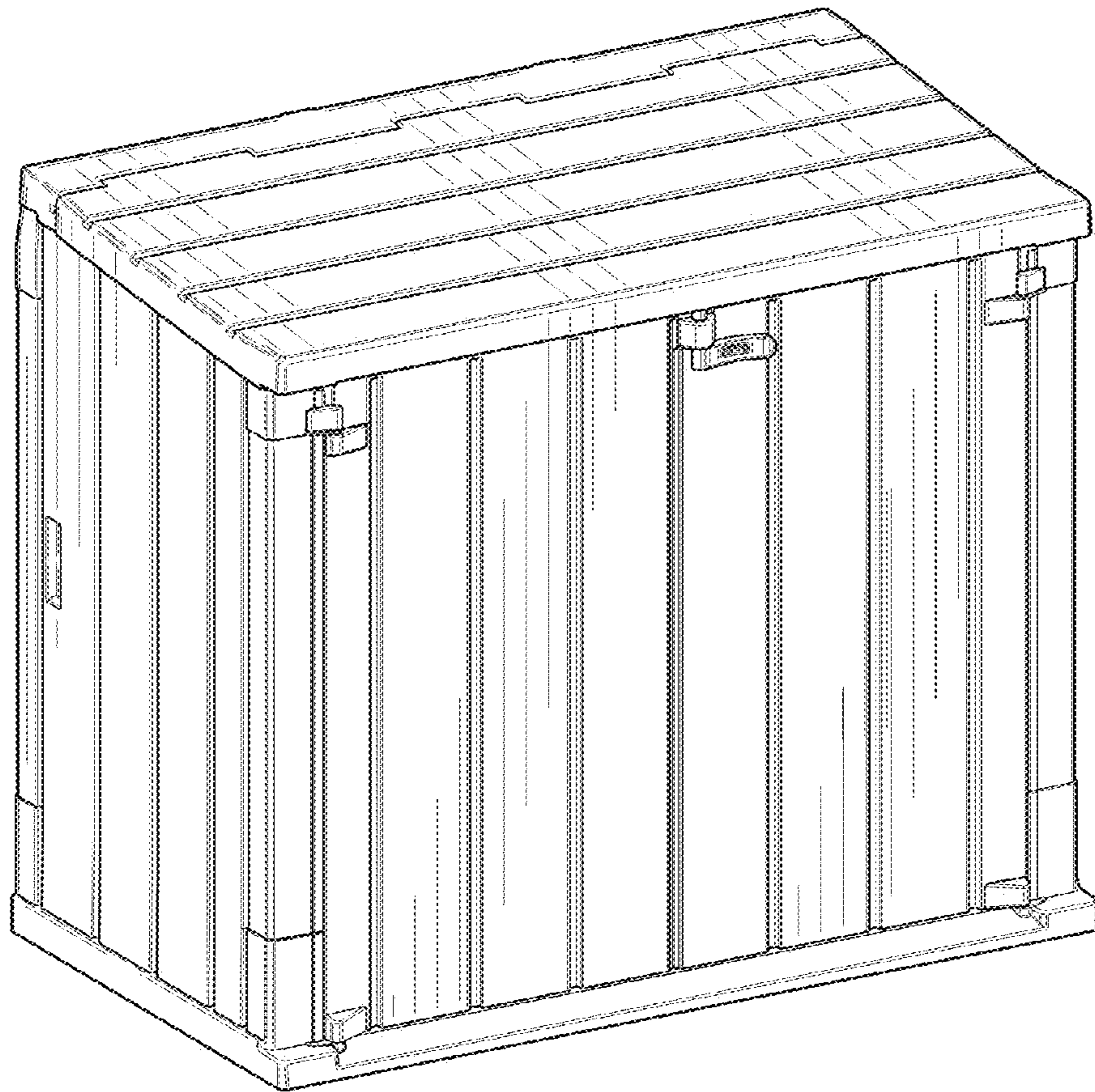

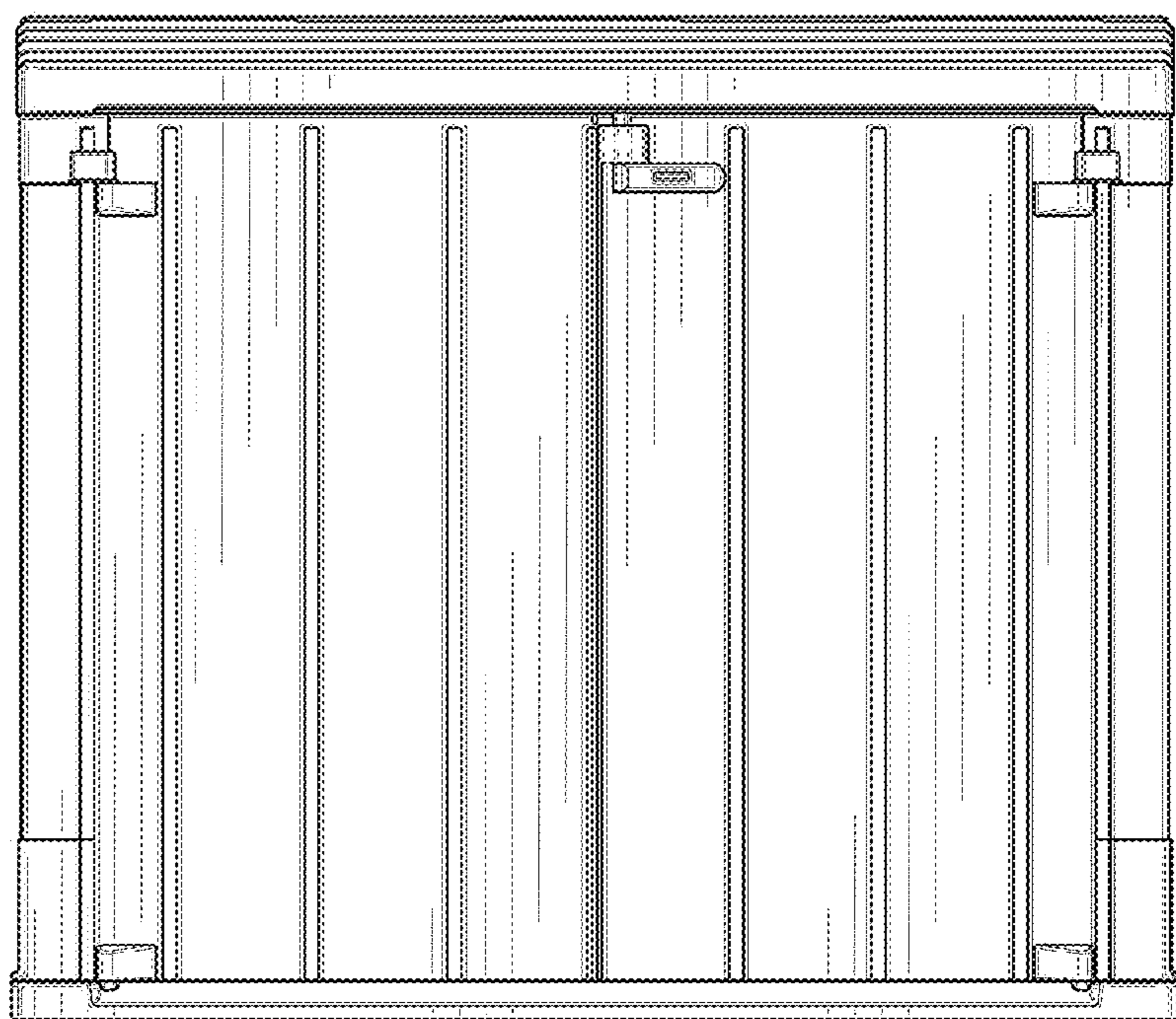

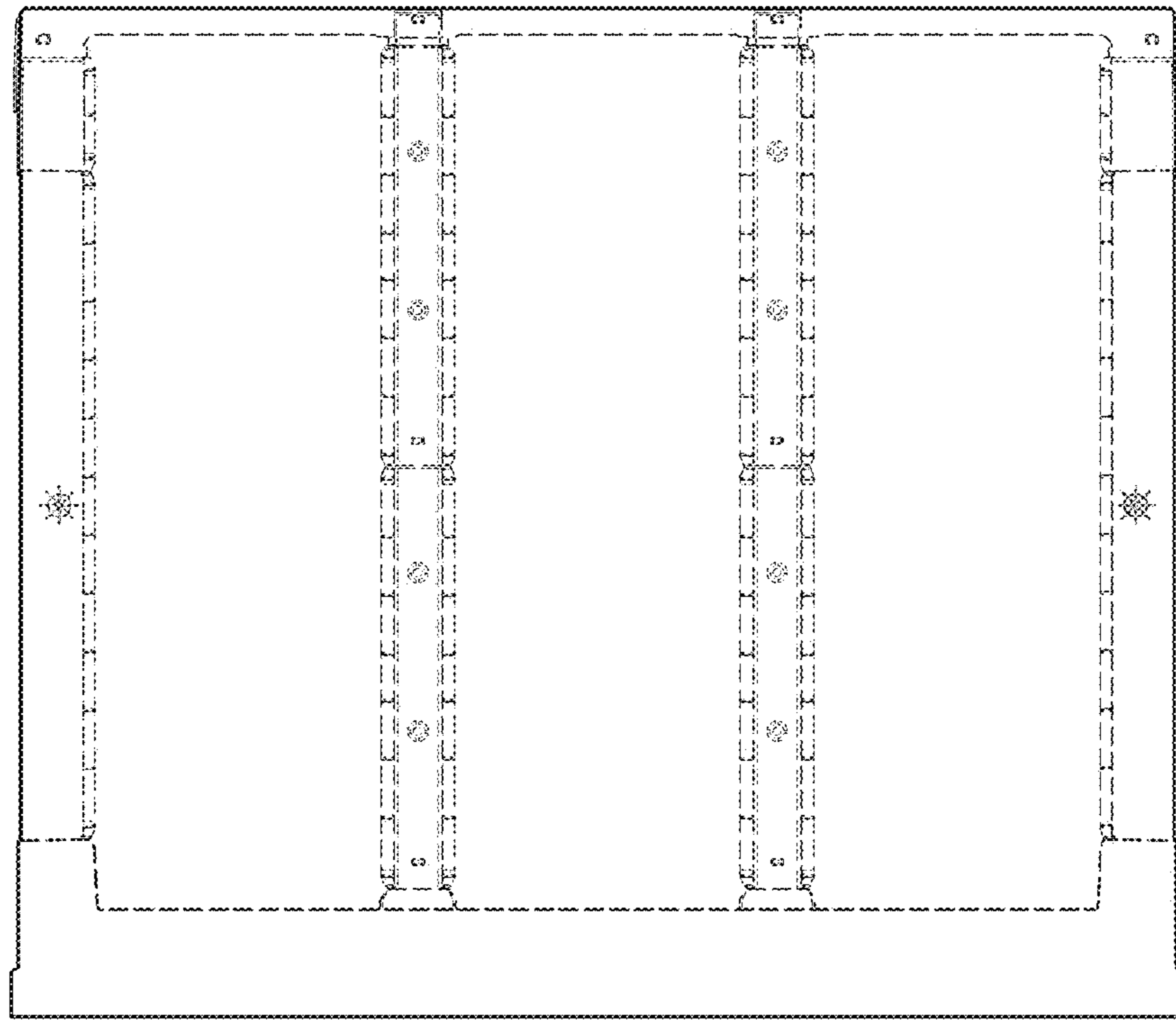

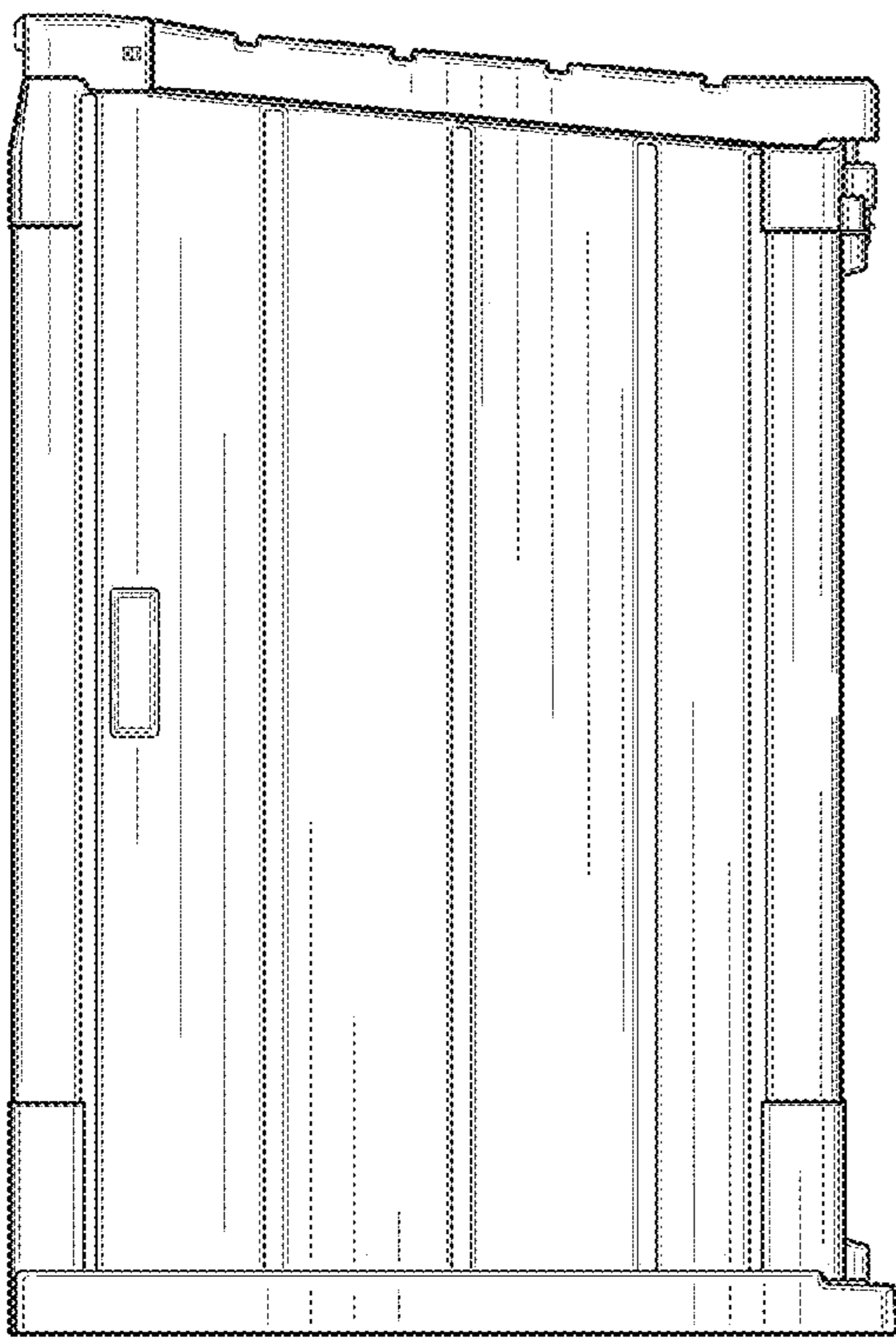

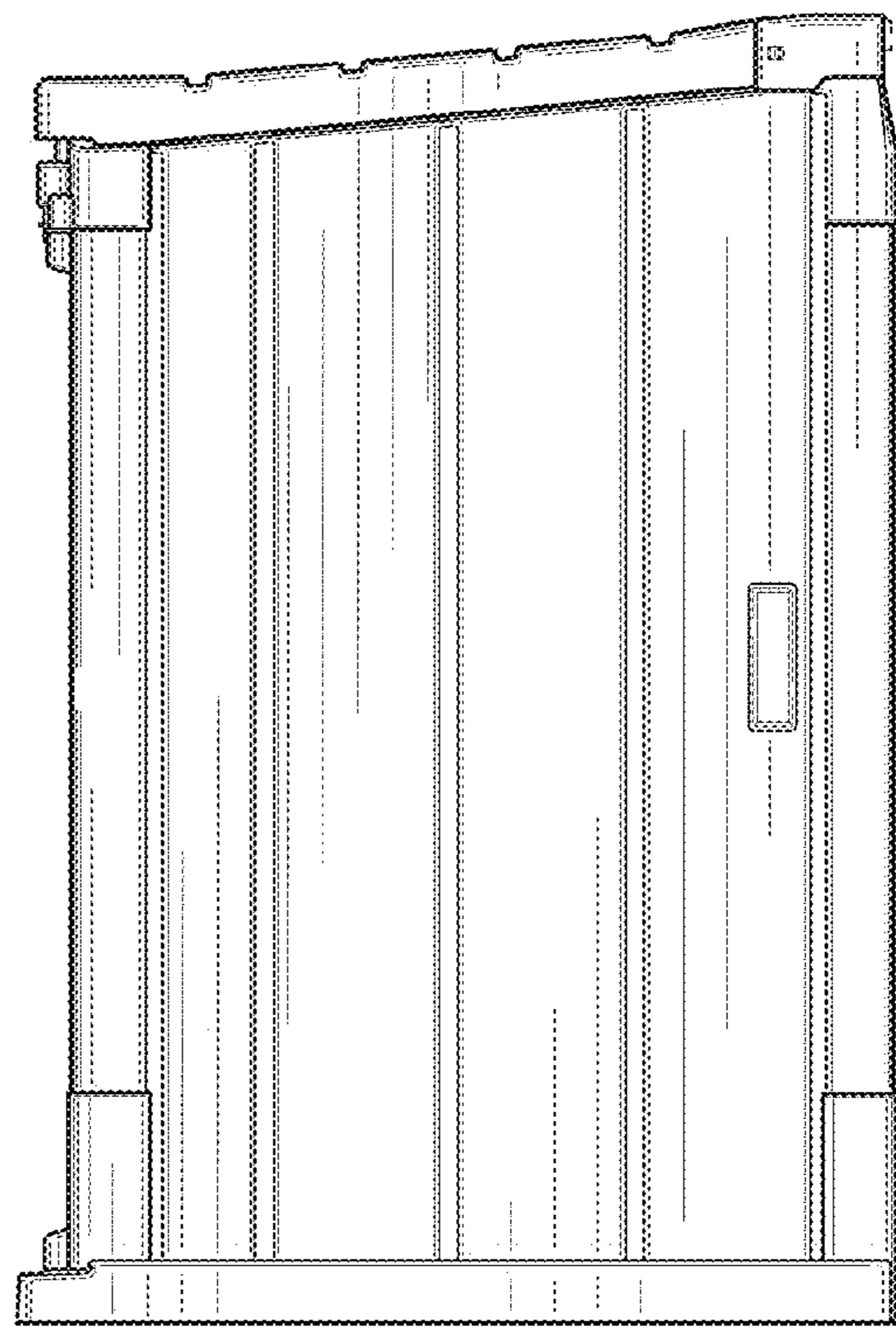

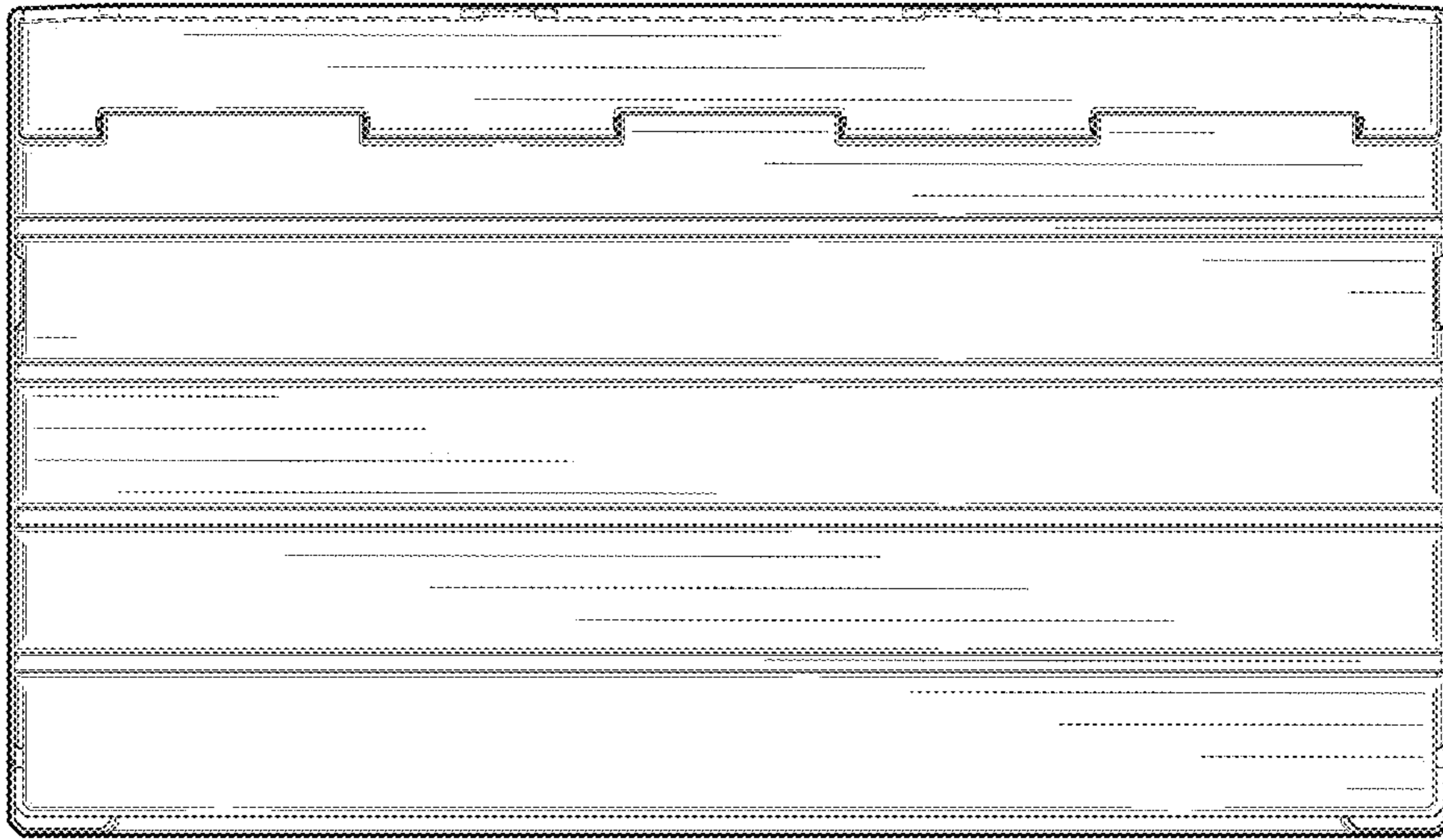

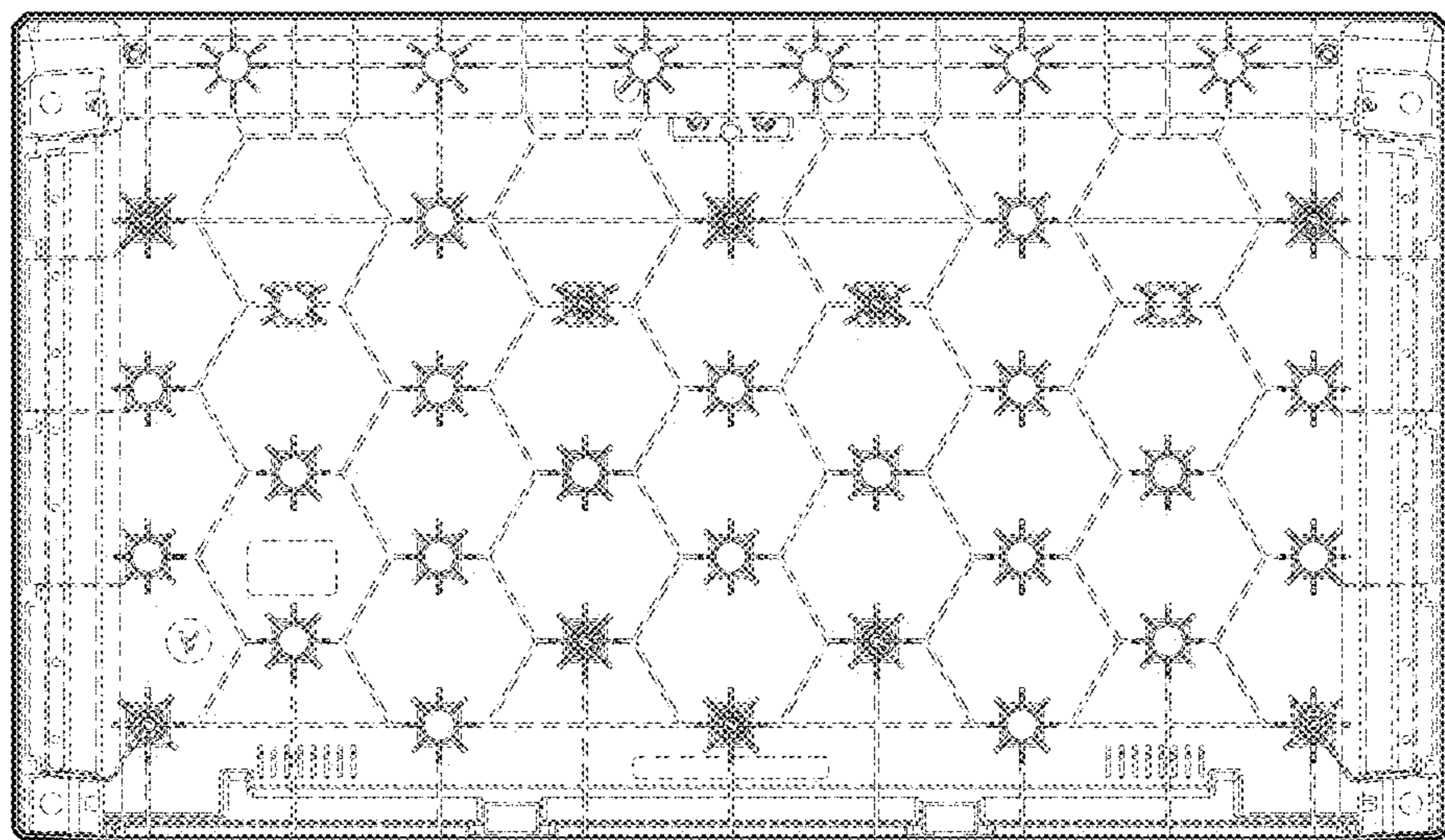
