(57) **CLAIM**

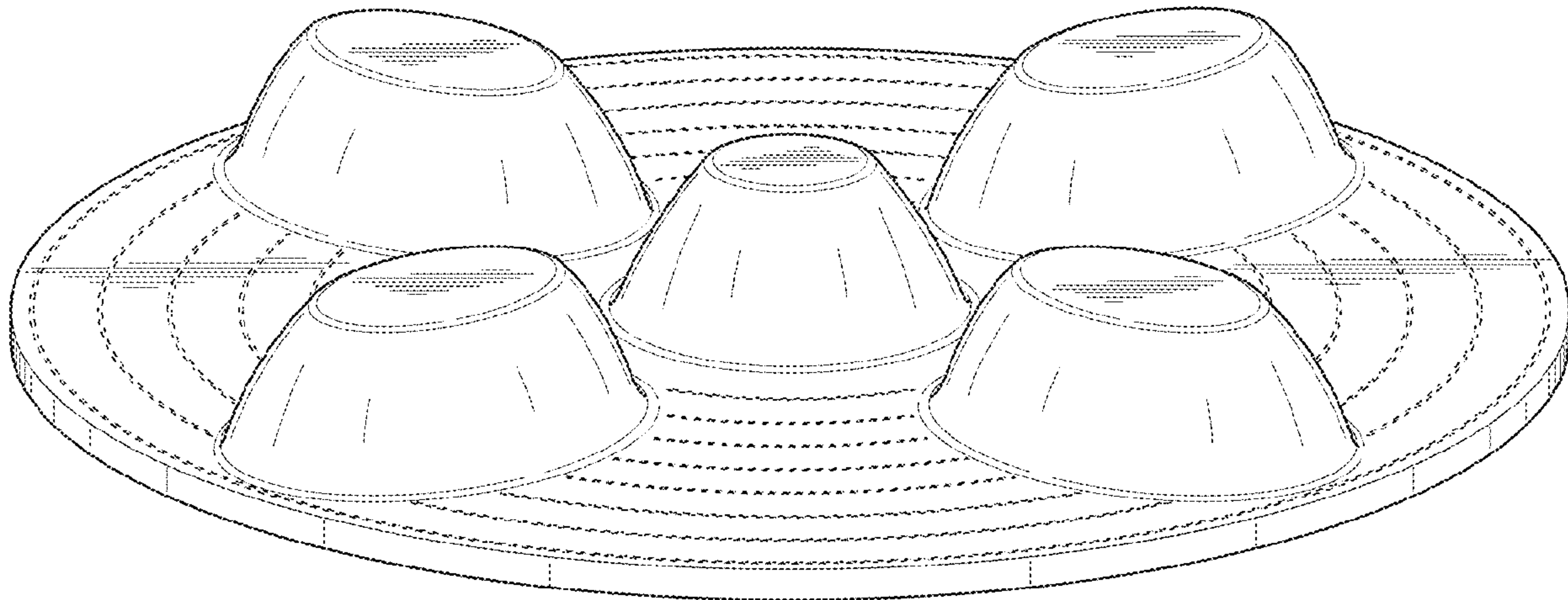
The ornamental design for a slow-consume animal feeding

**DESCRIPTION**

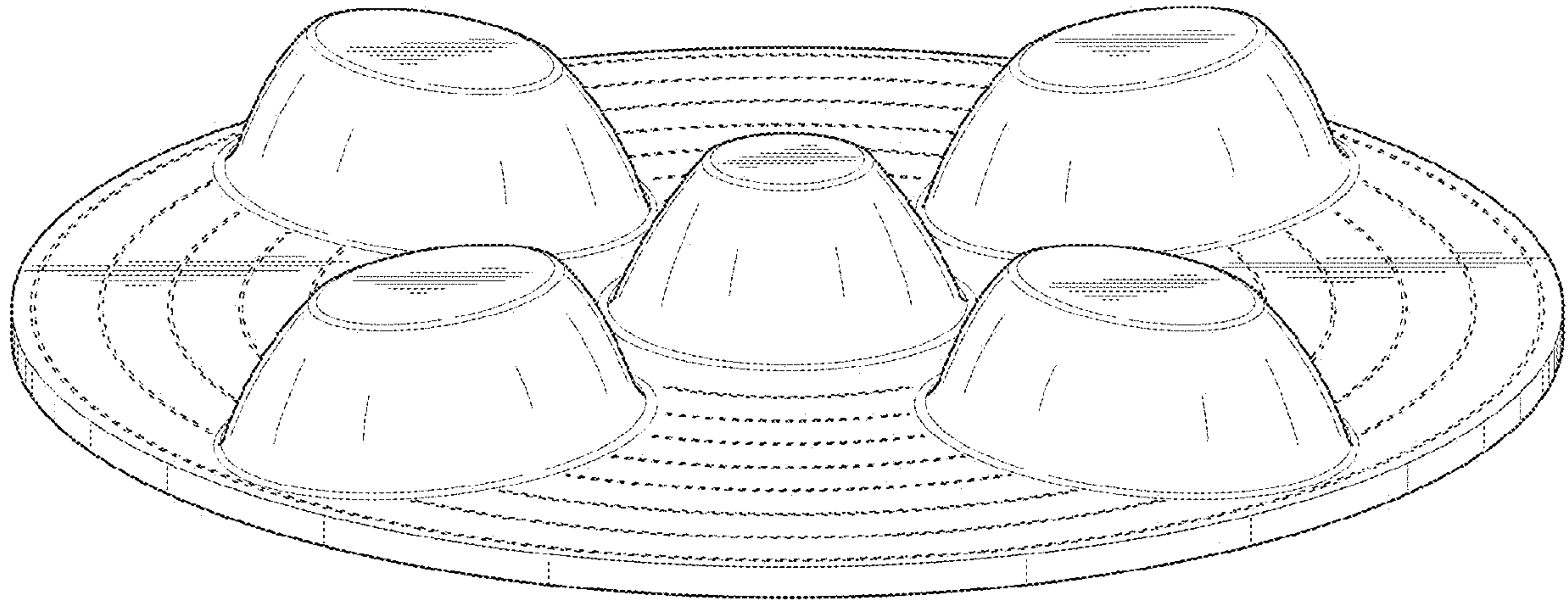

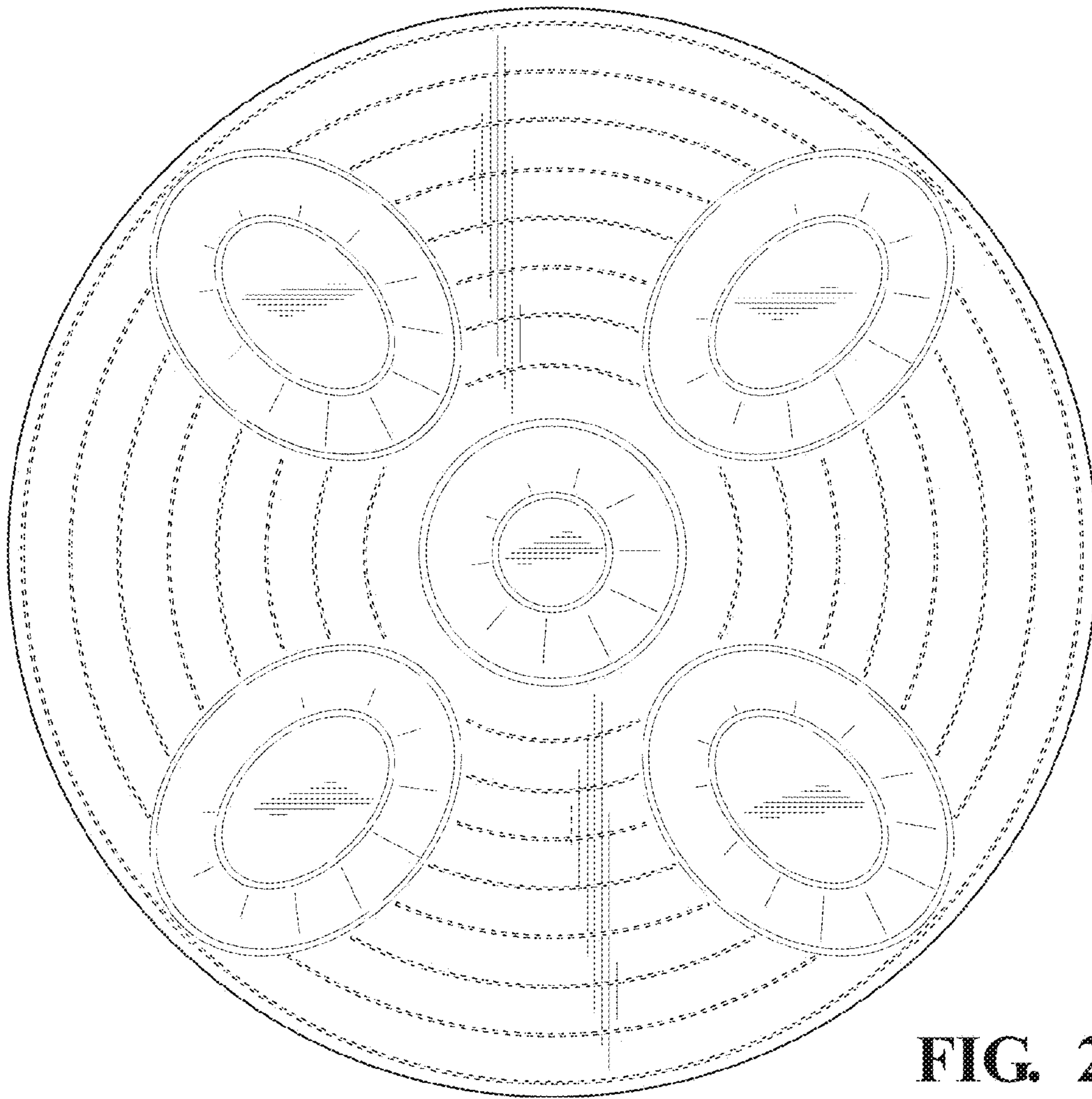

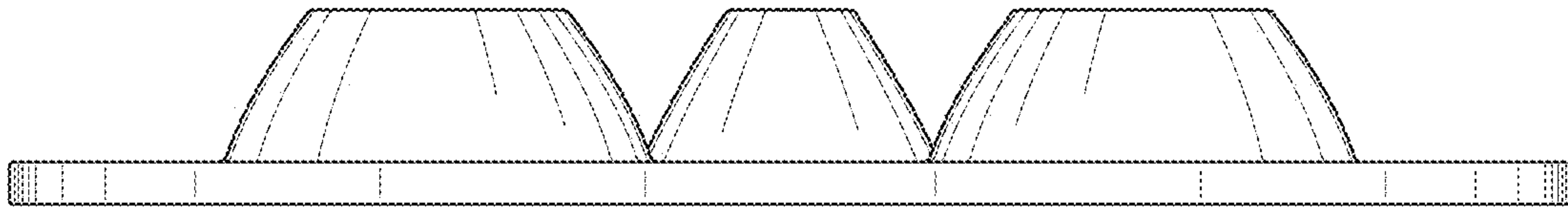




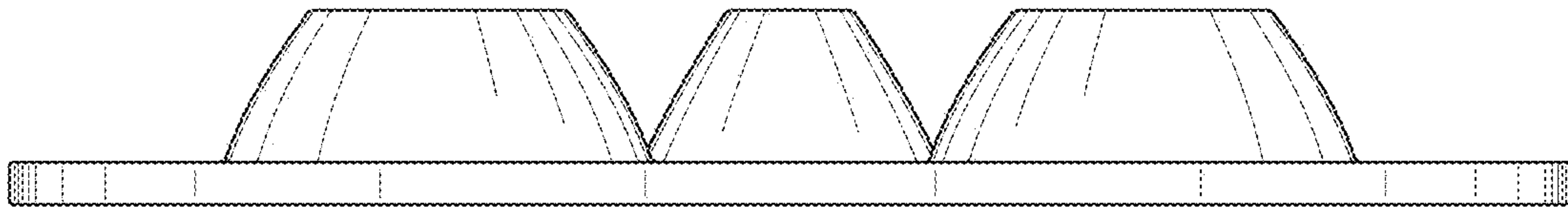

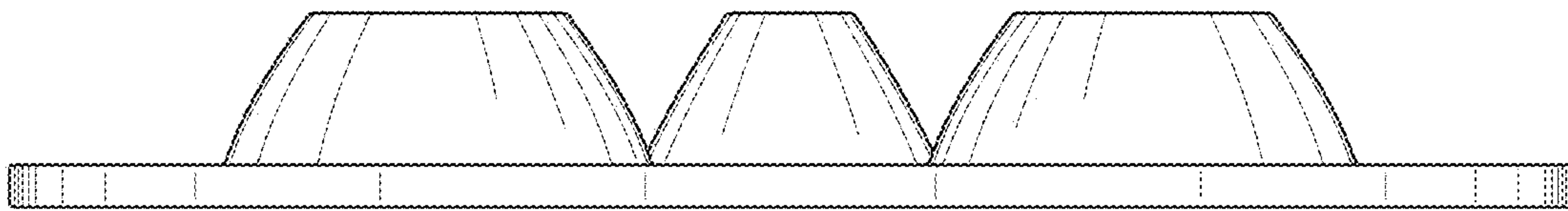

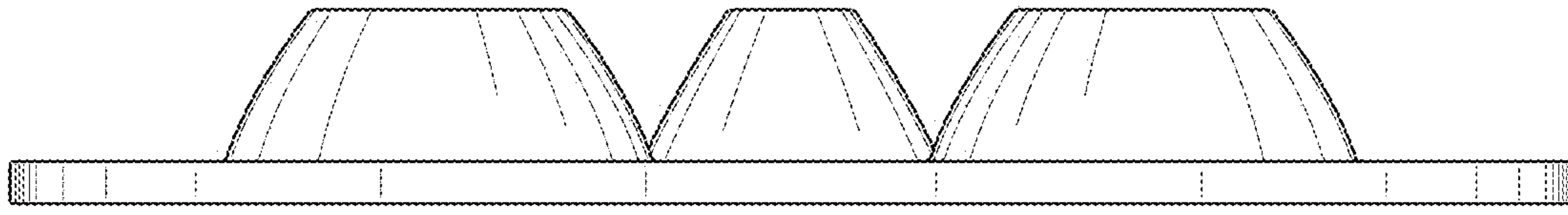

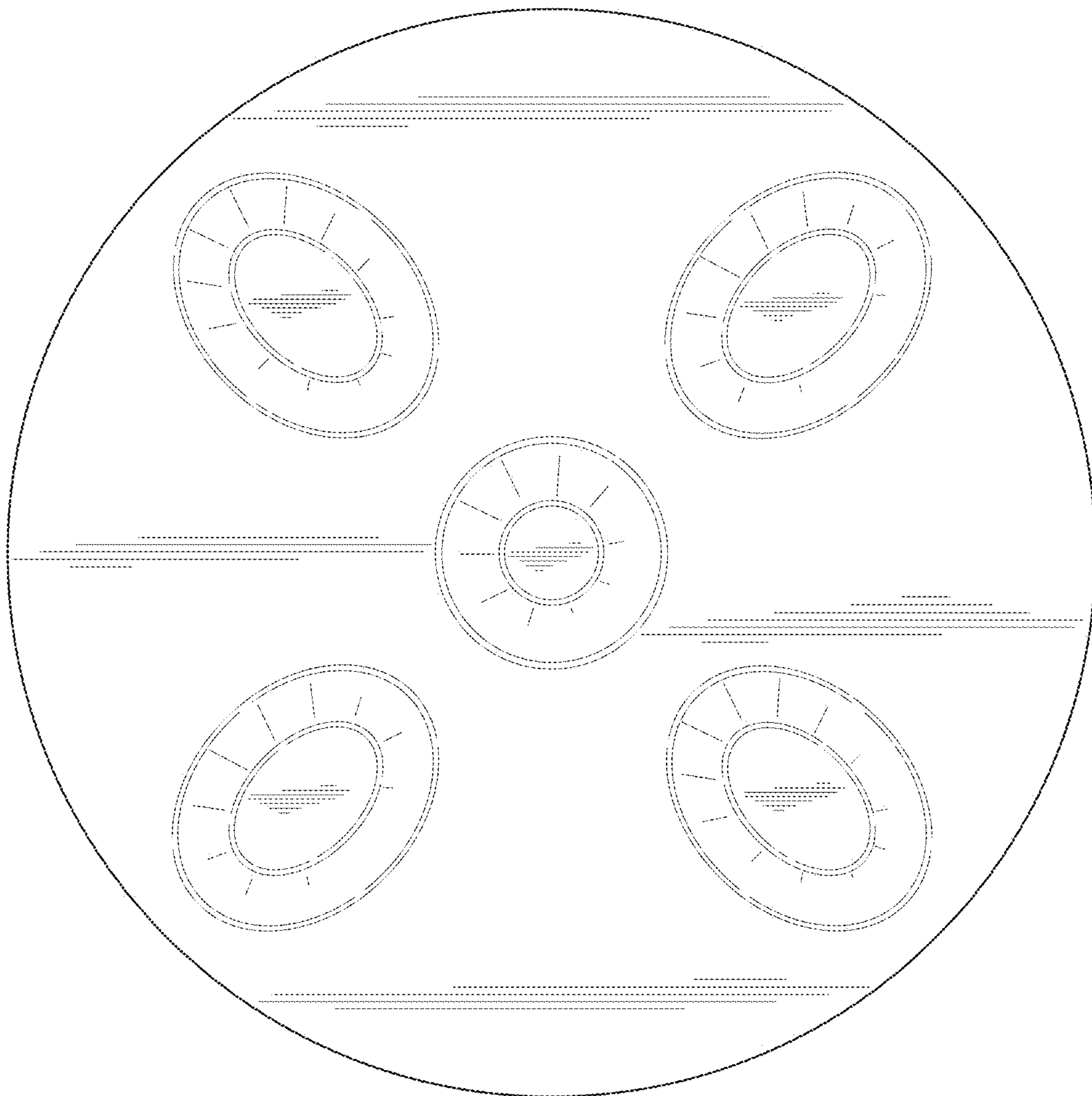
