The ornamental design for a debossed chewing gum stick, as shown and described.

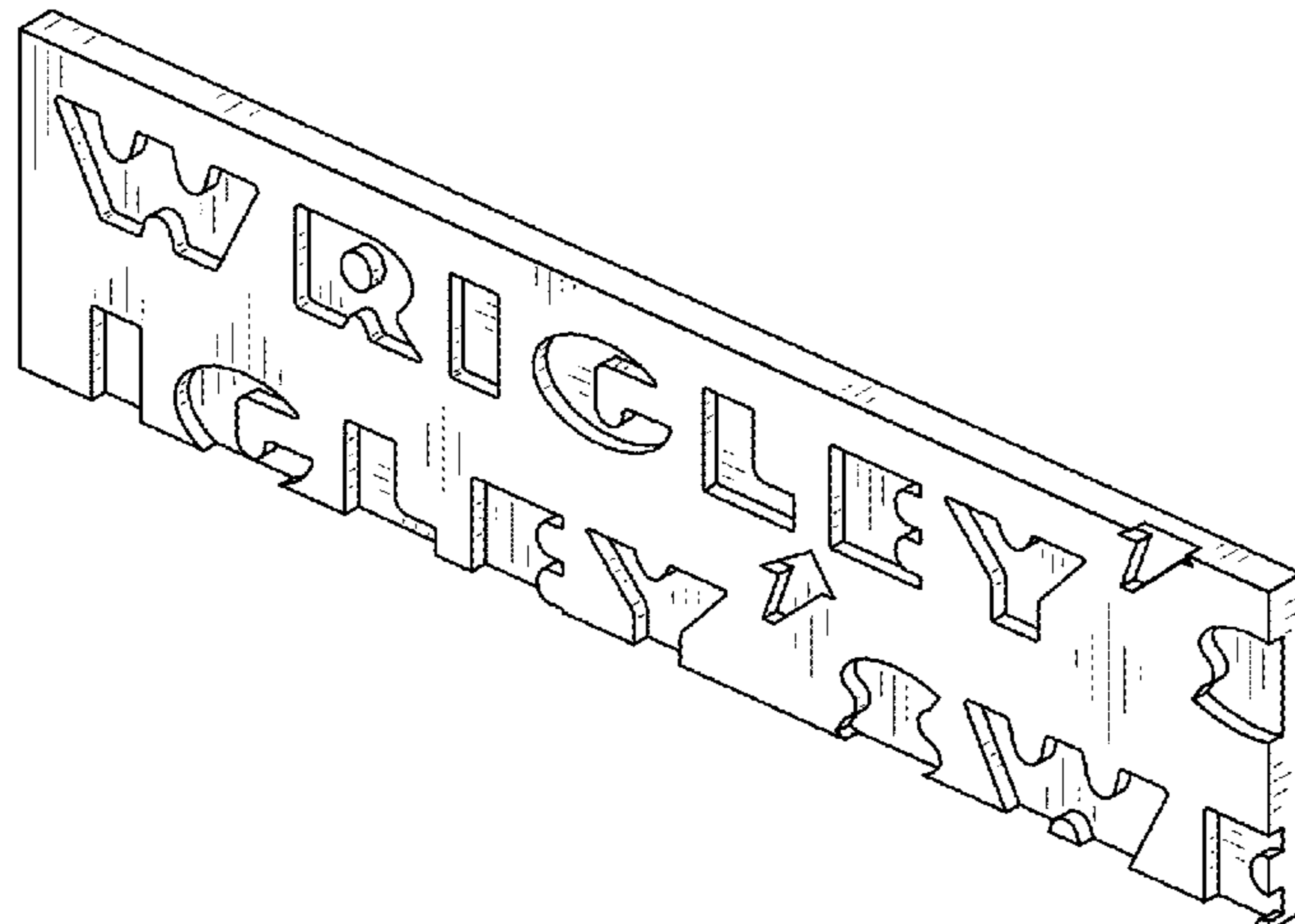


FIG. 36 is a front, bottom, right side perspective view of a sixth embodiment of a debossed chewing gum stick showing our new design;

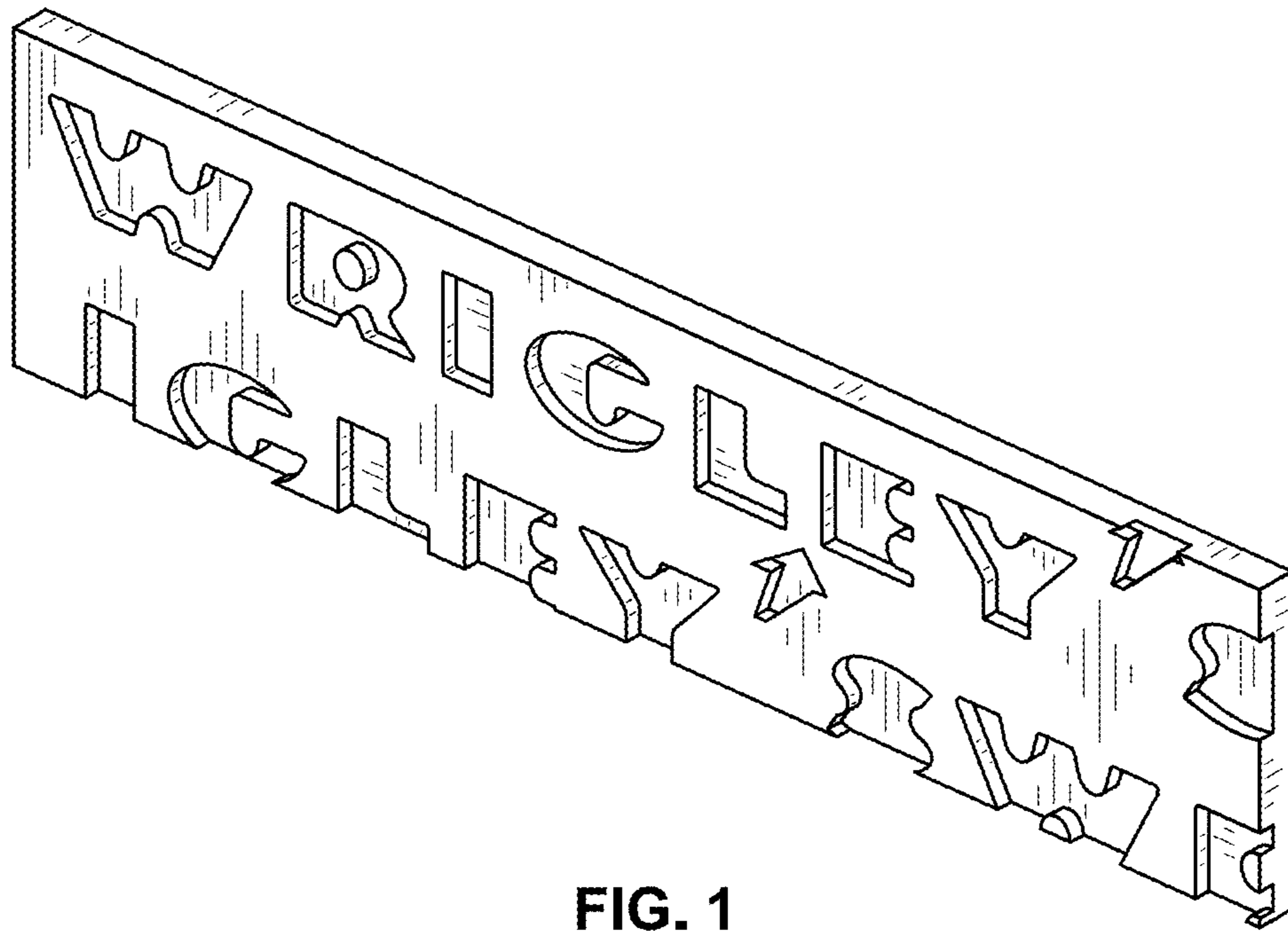

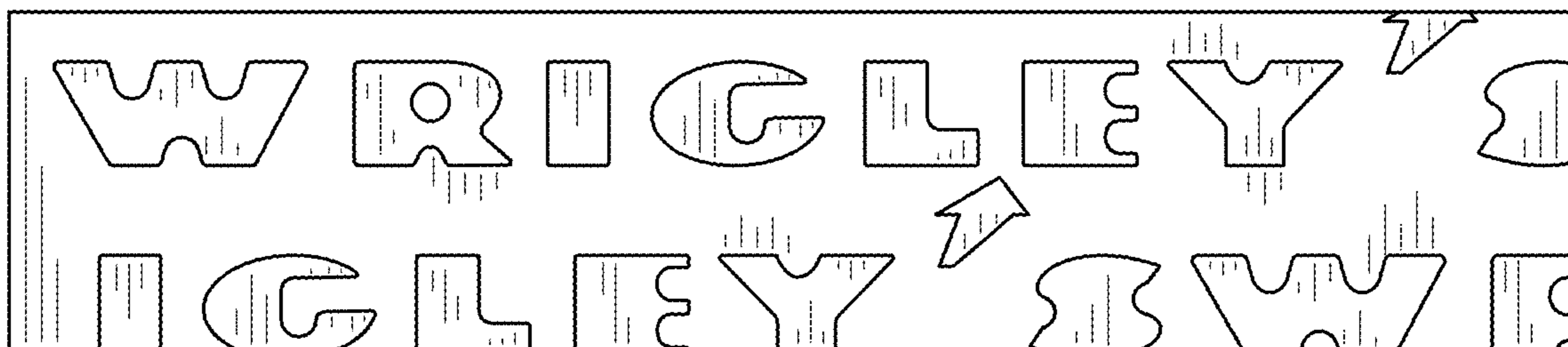

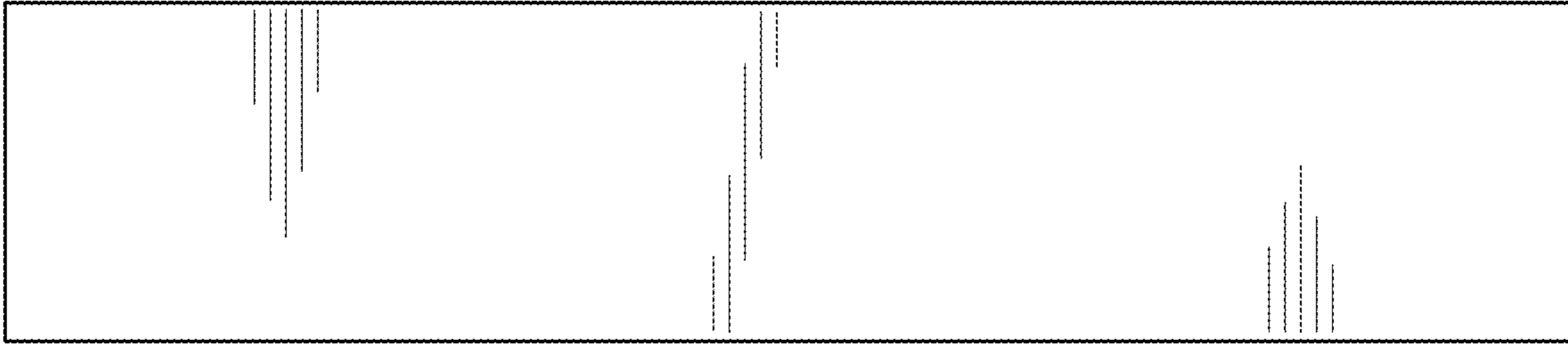

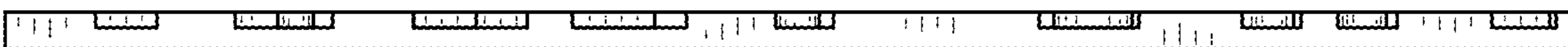

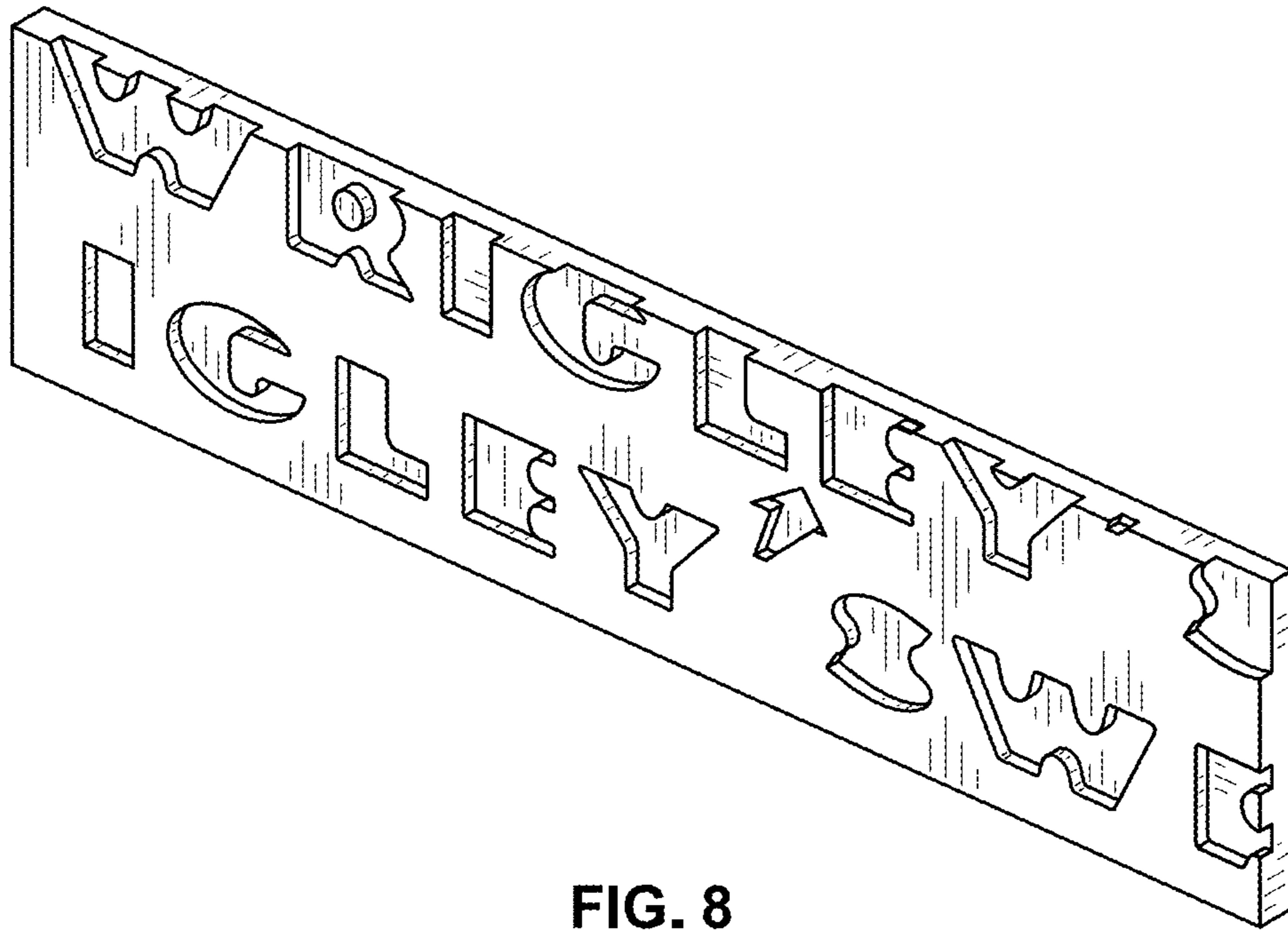

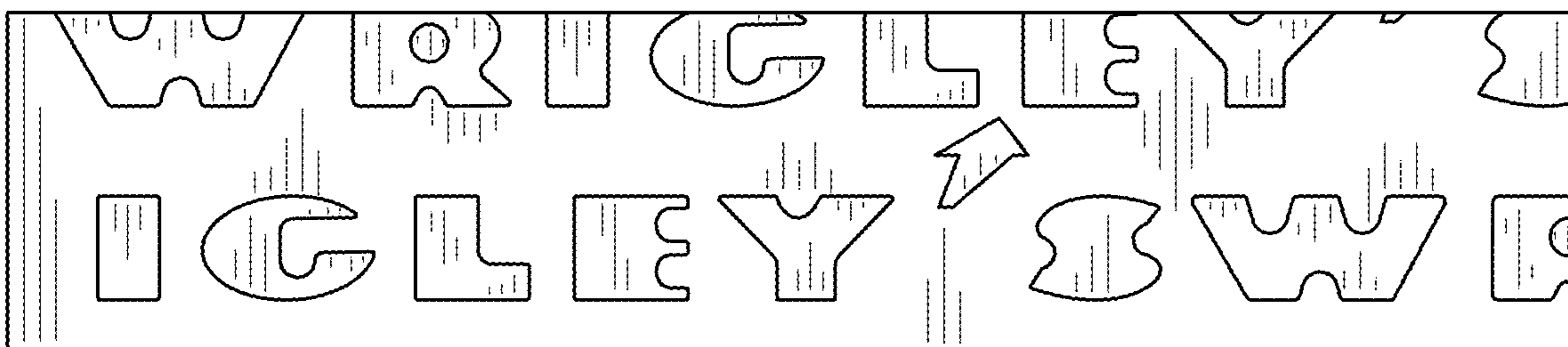

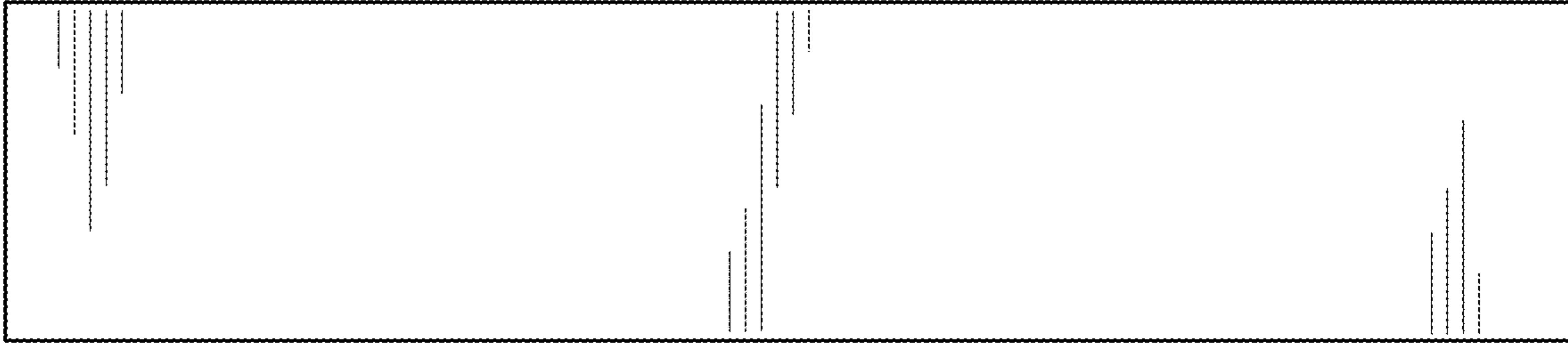

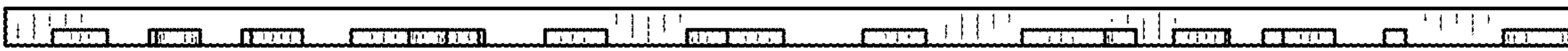

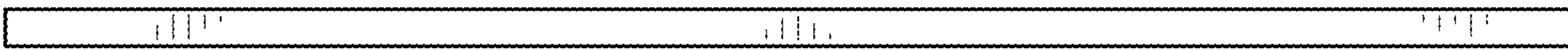

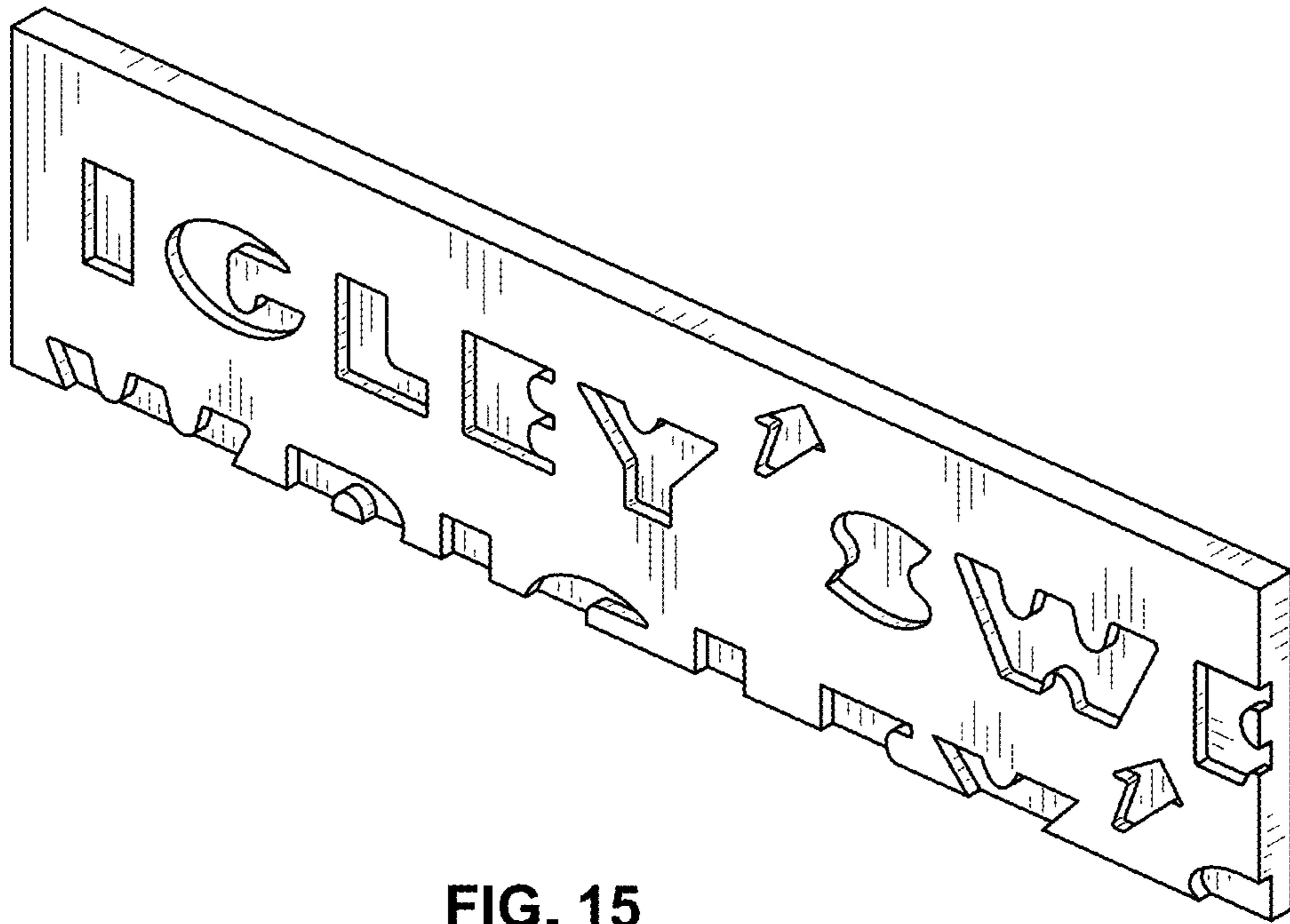

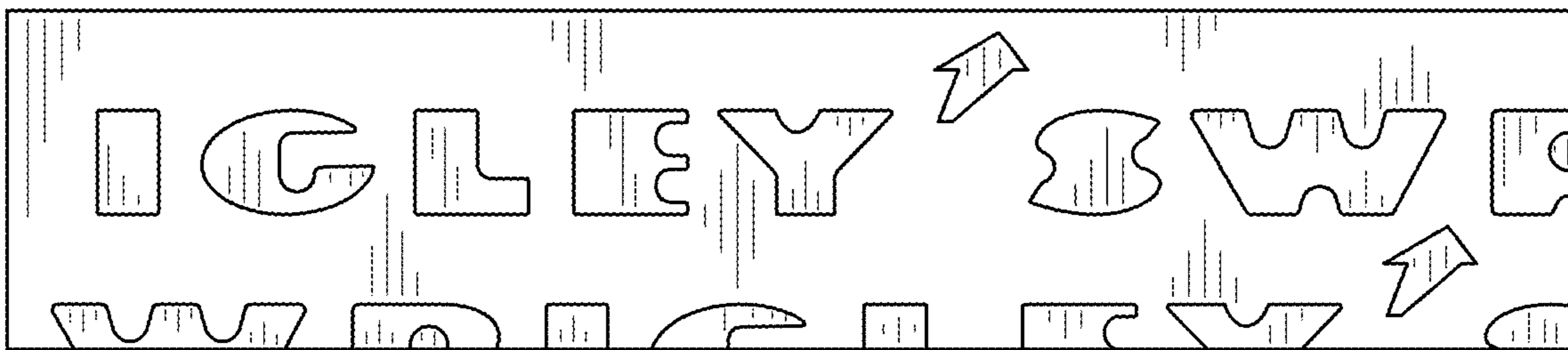

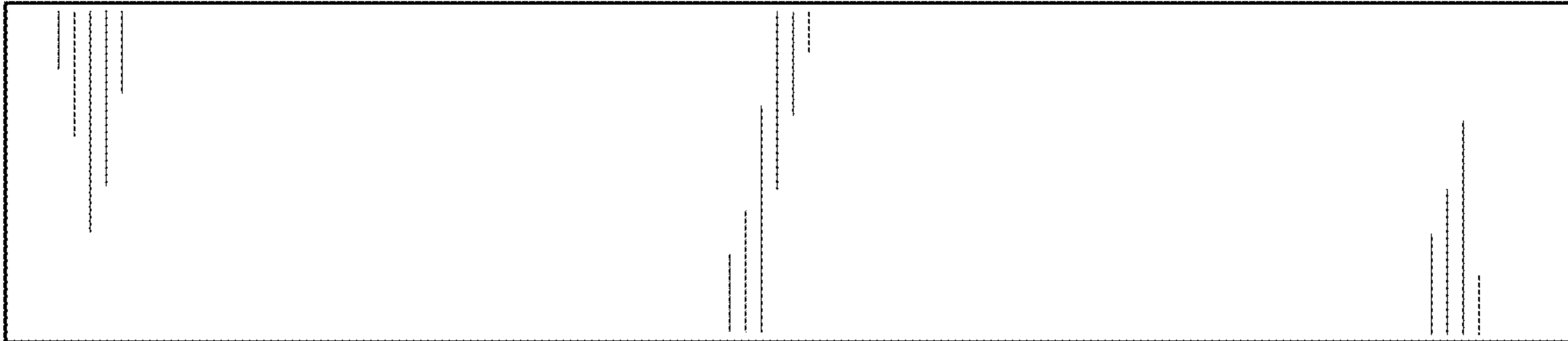

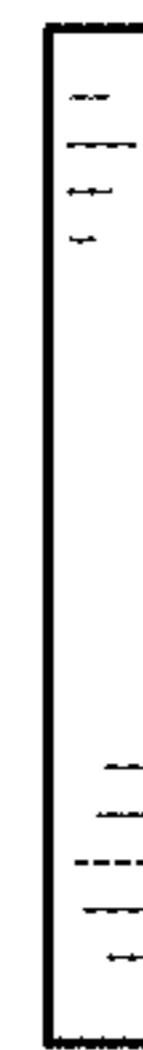

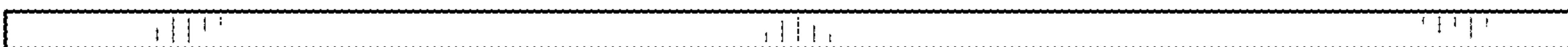

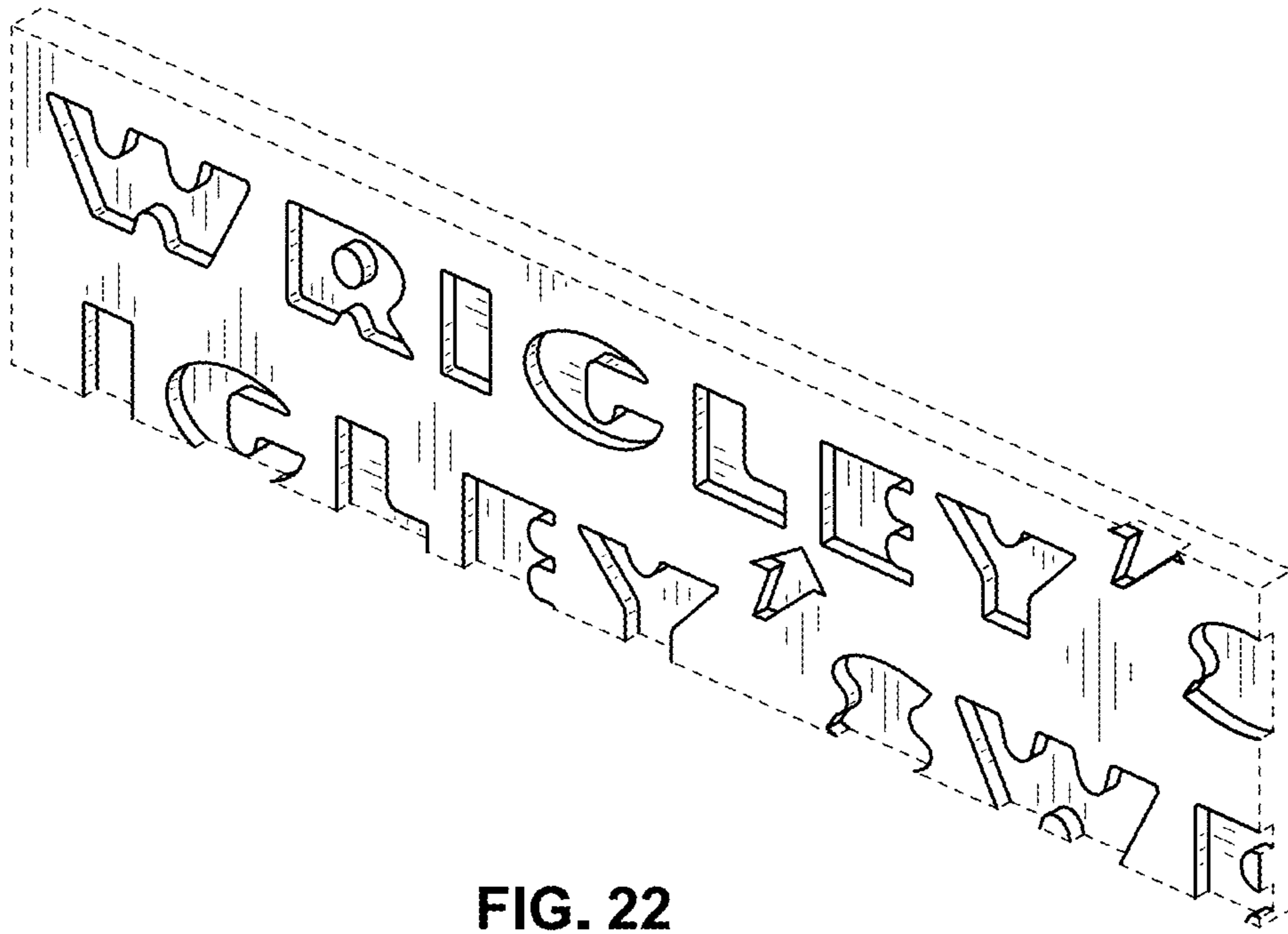

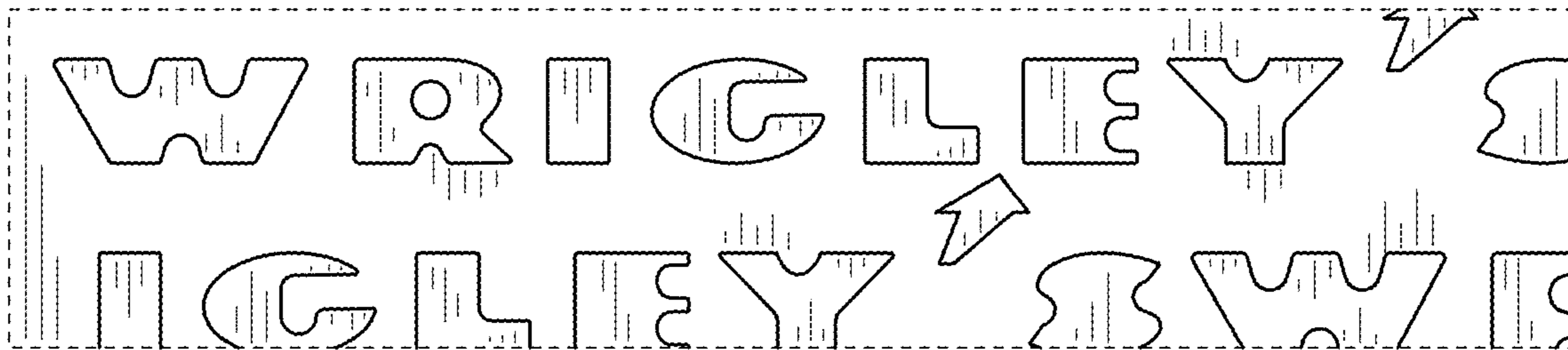


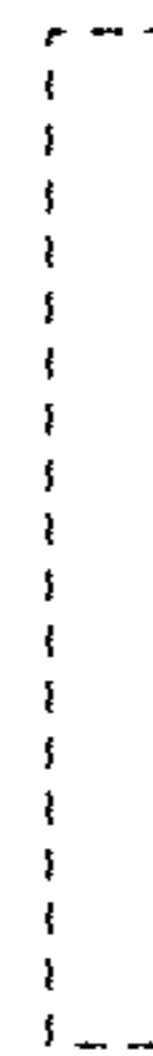

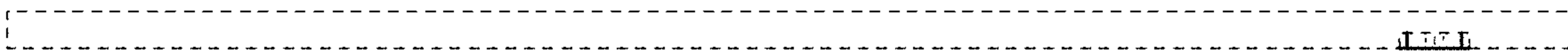

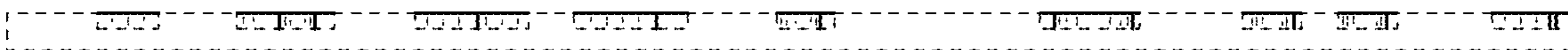

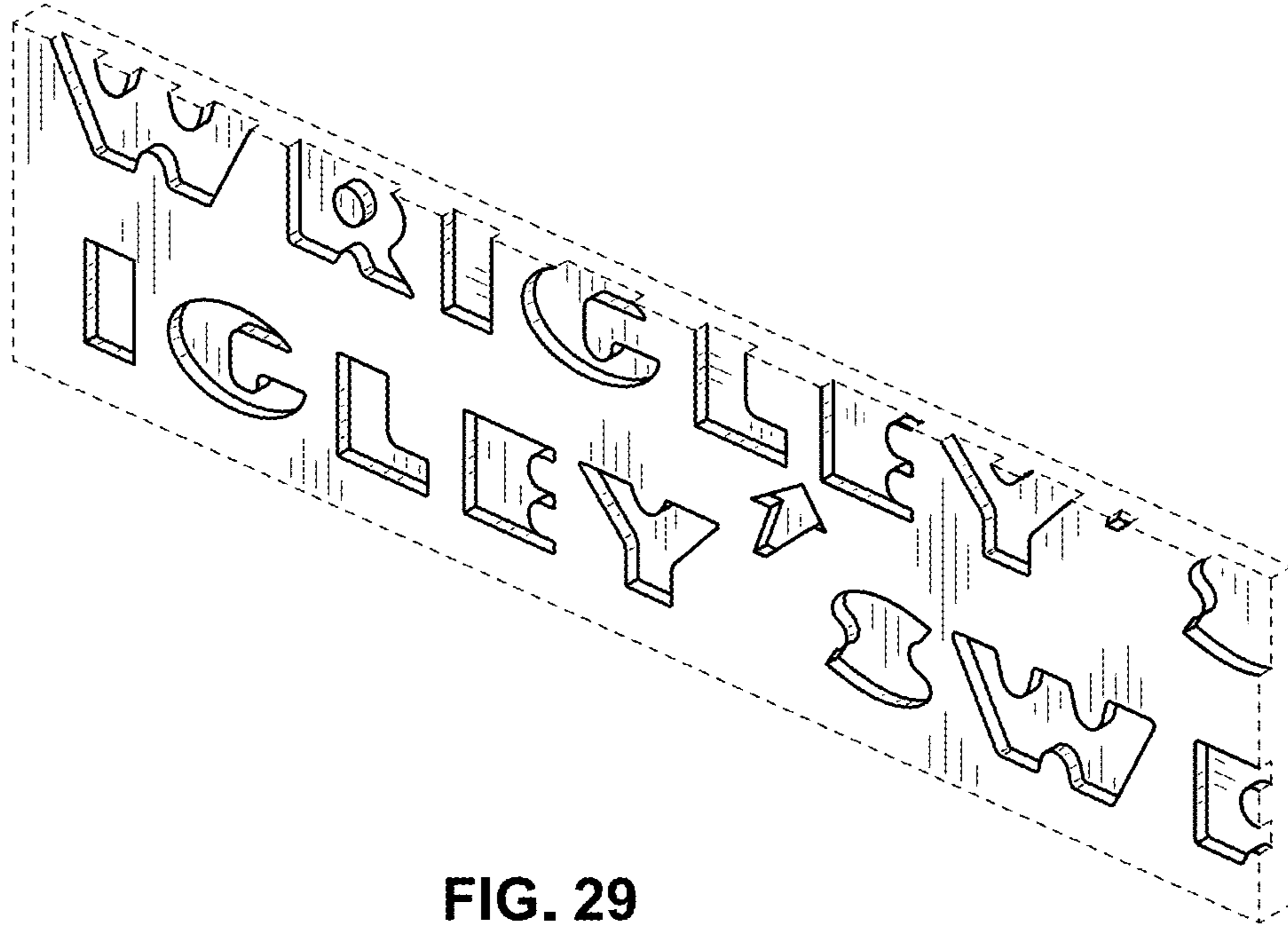

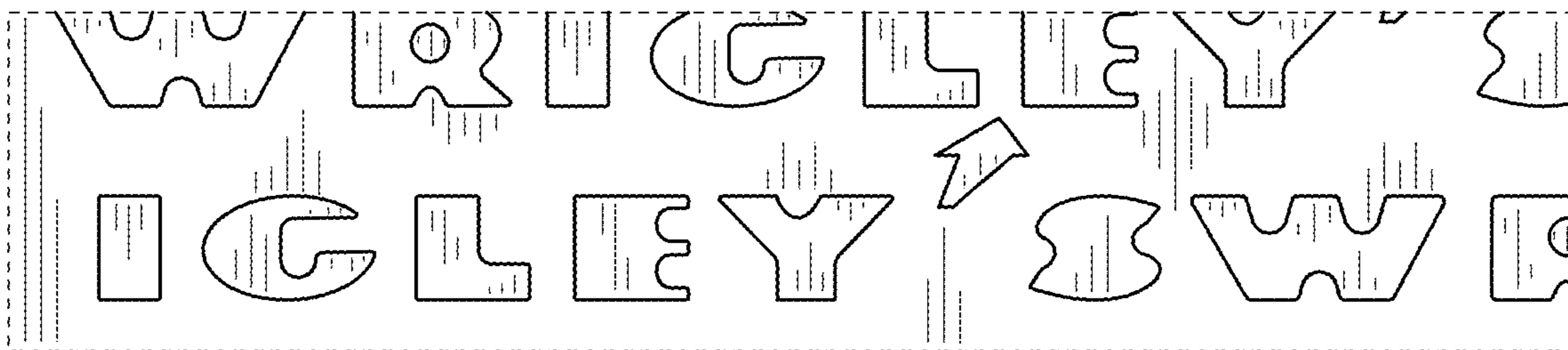
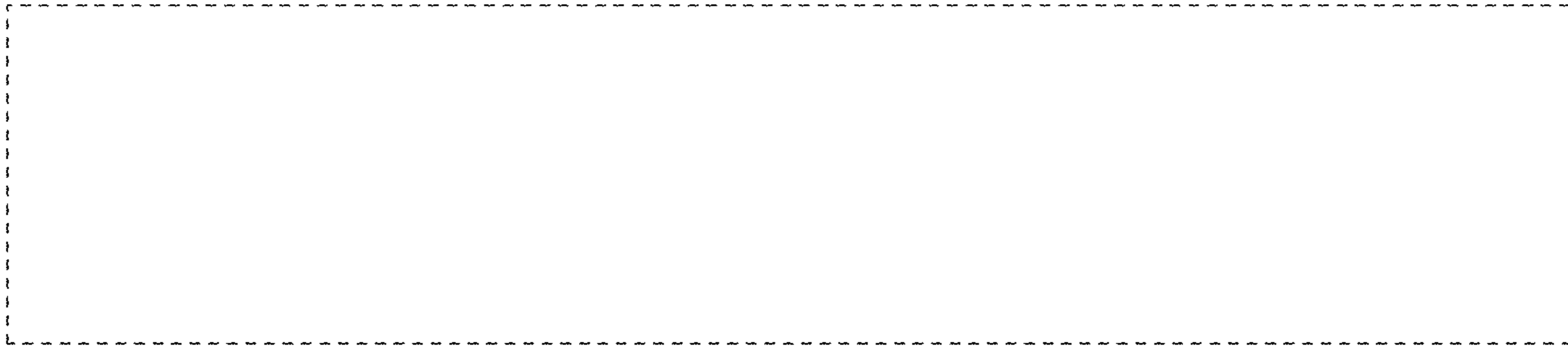
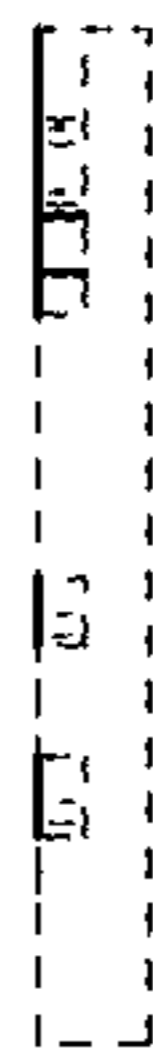


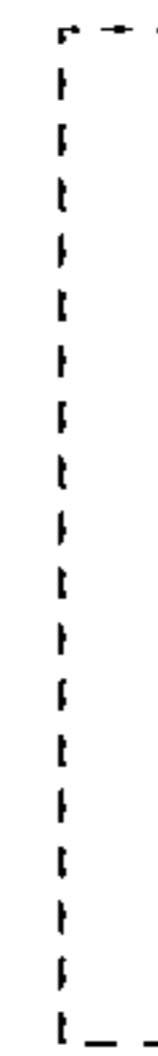

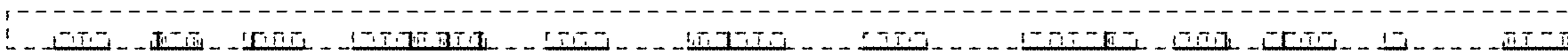

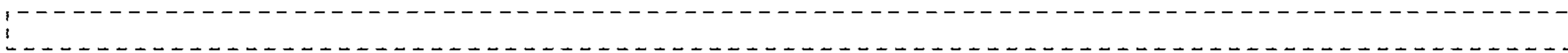

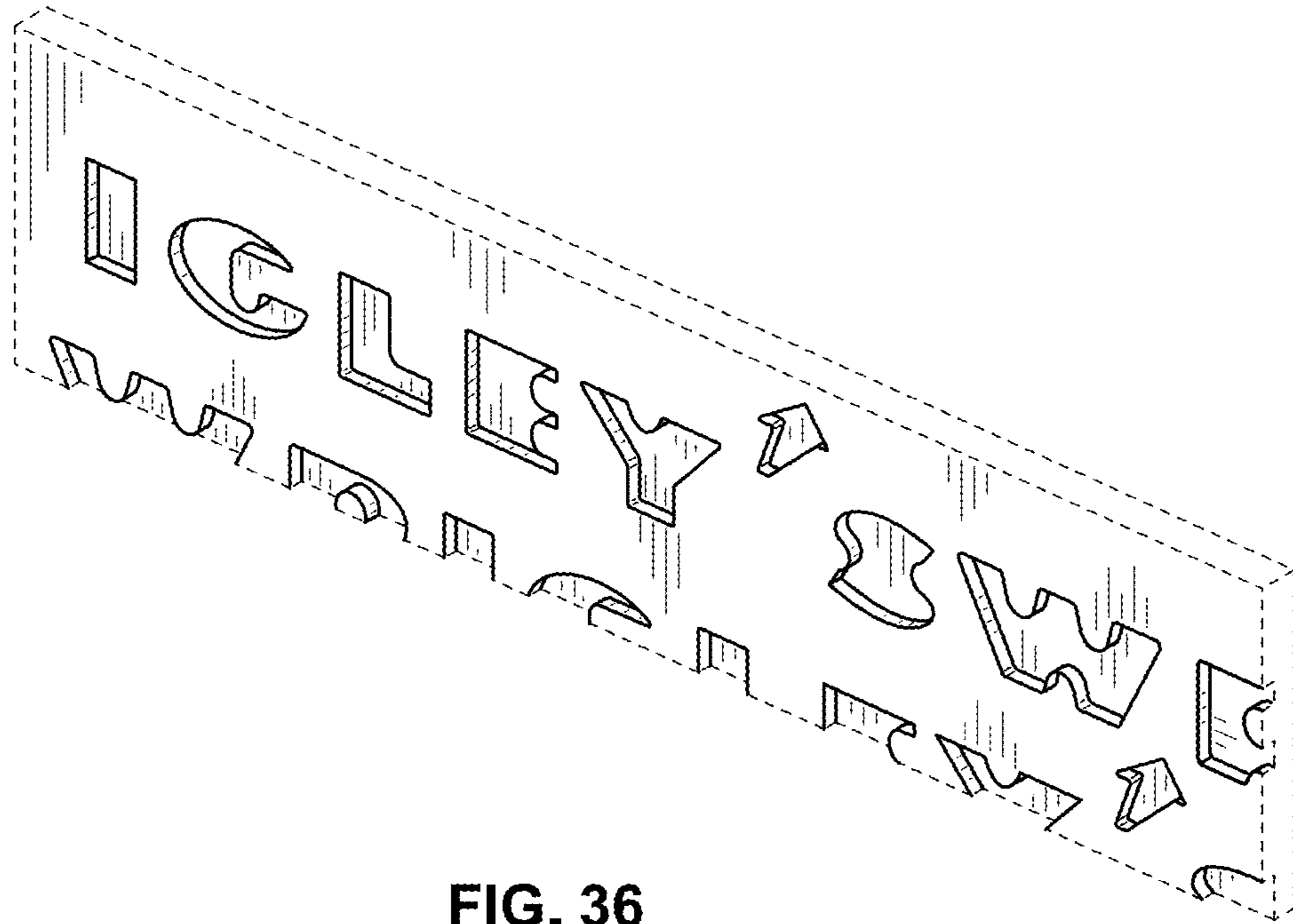

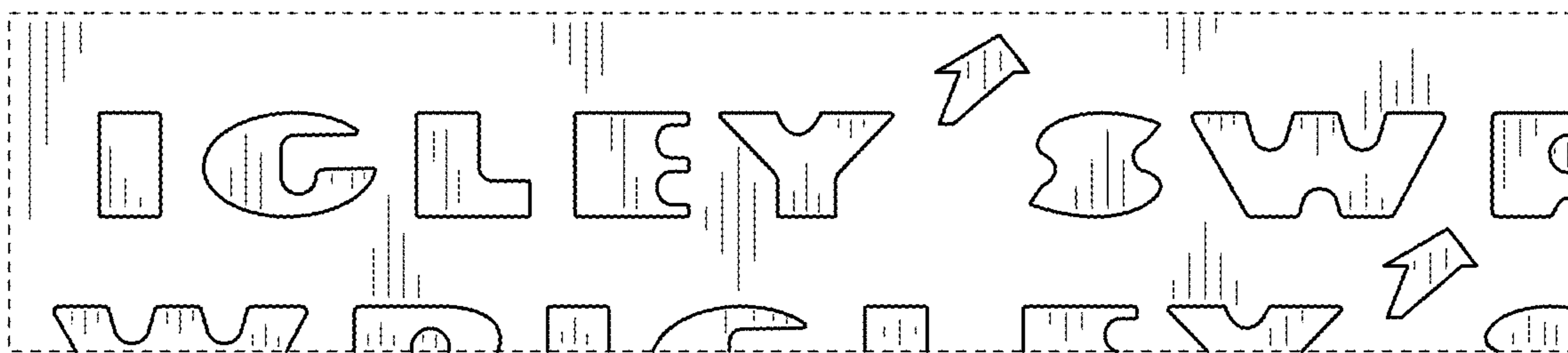
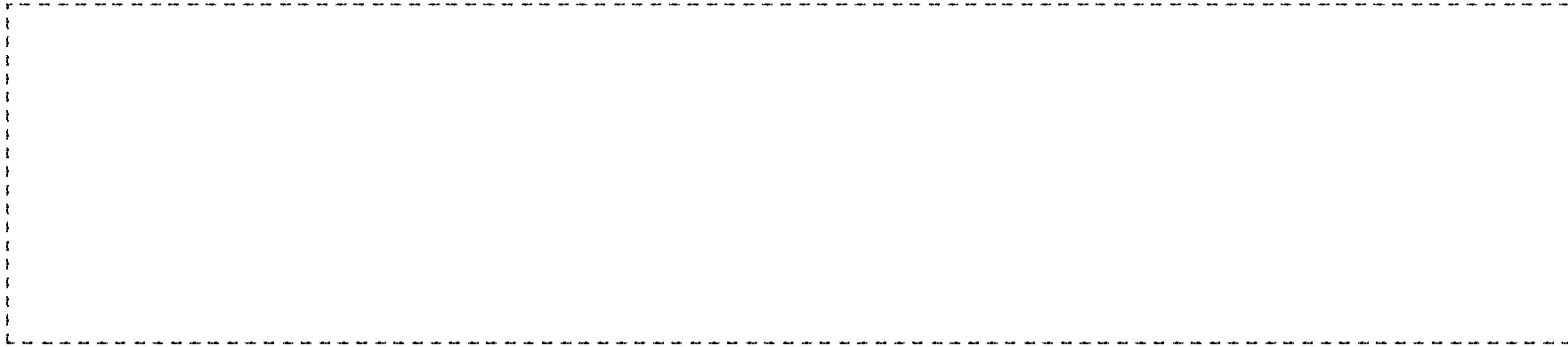
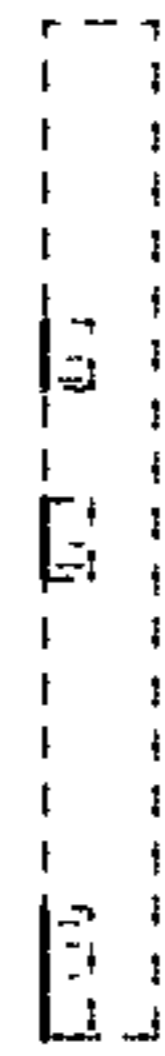


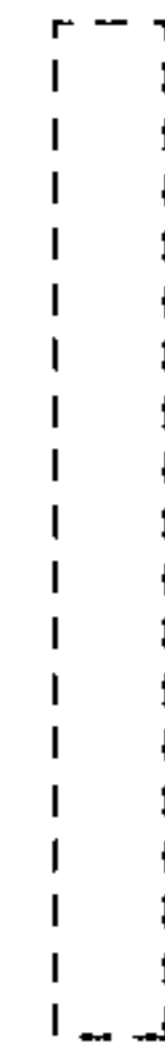

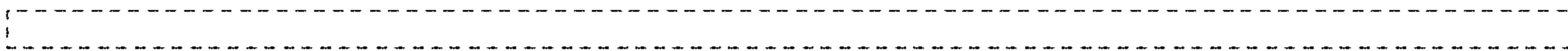

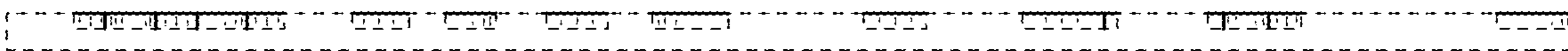
