FIG. 1 is a front, top and right side perspective view of a waffle;

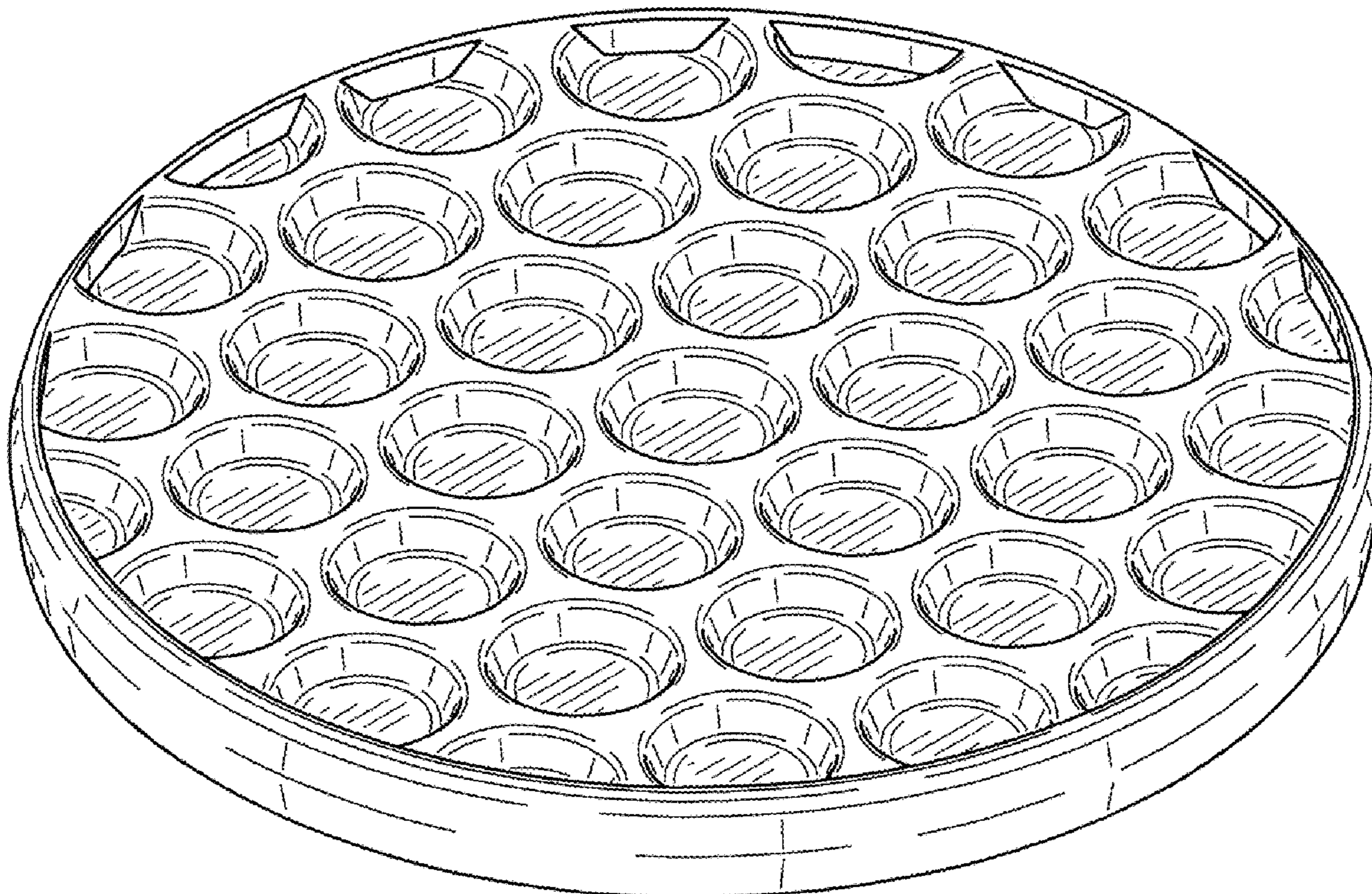
FIG. 2 is a front elevation view thereof;

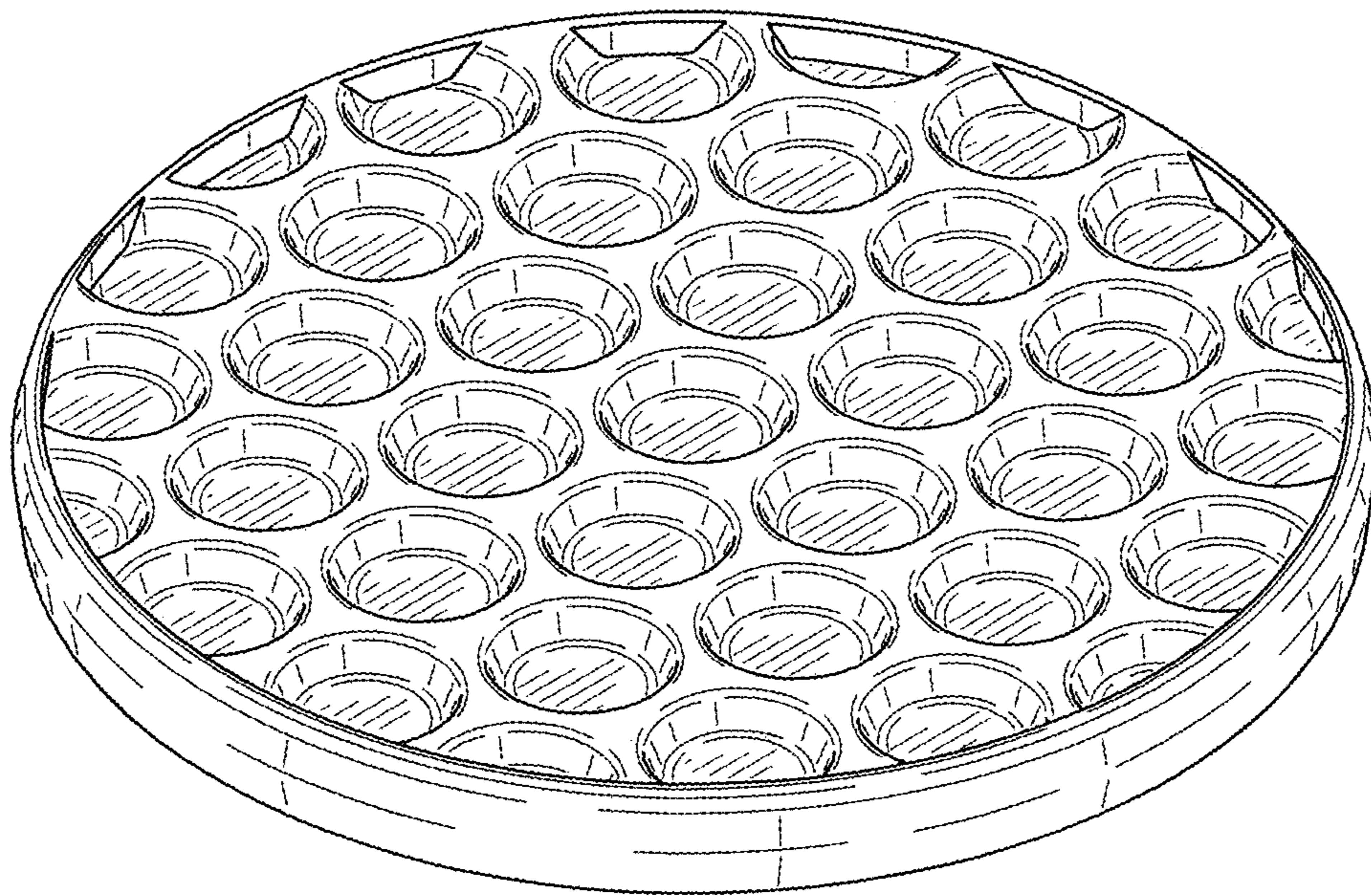

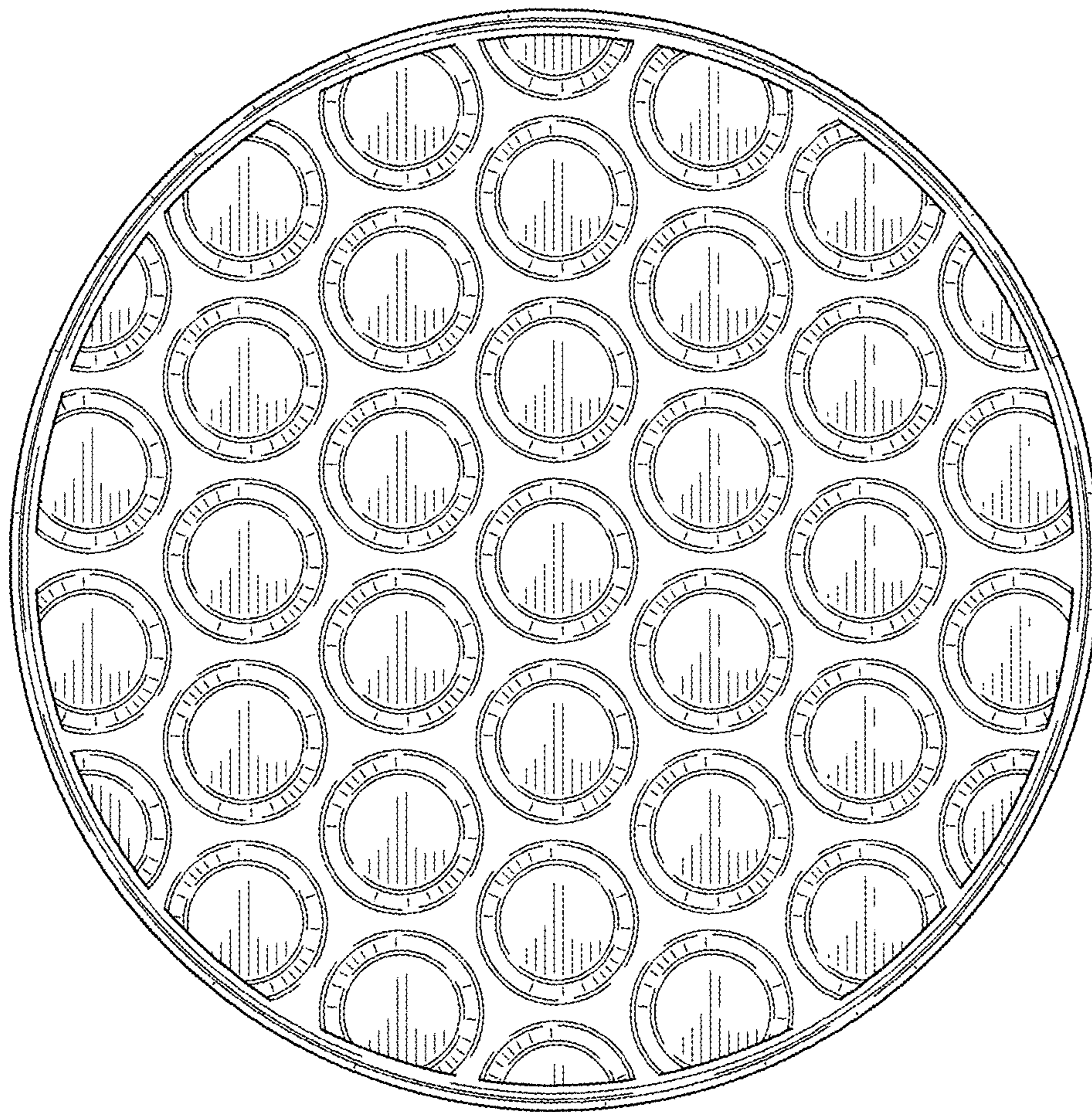

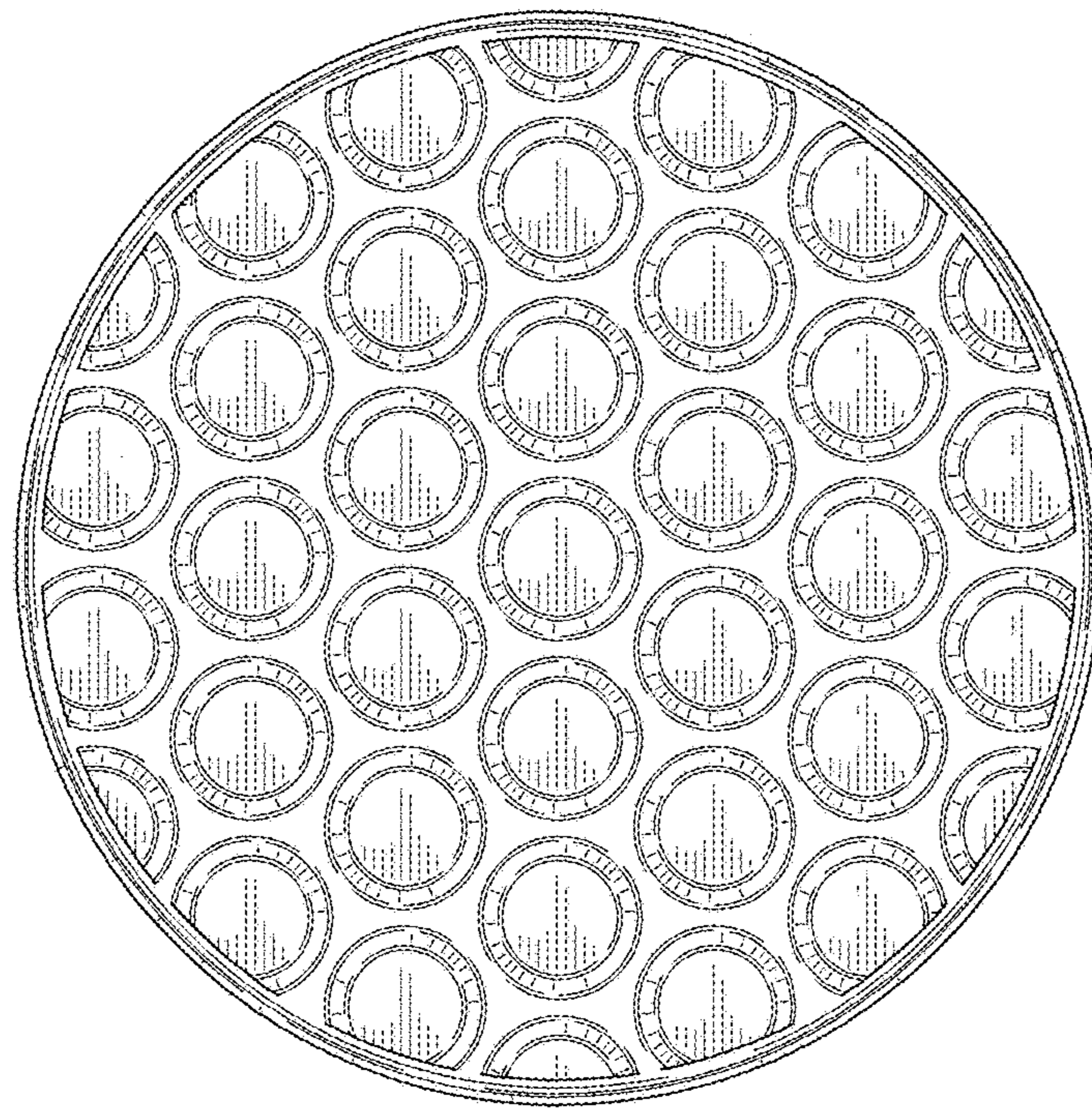
