**DESCRIPTION**

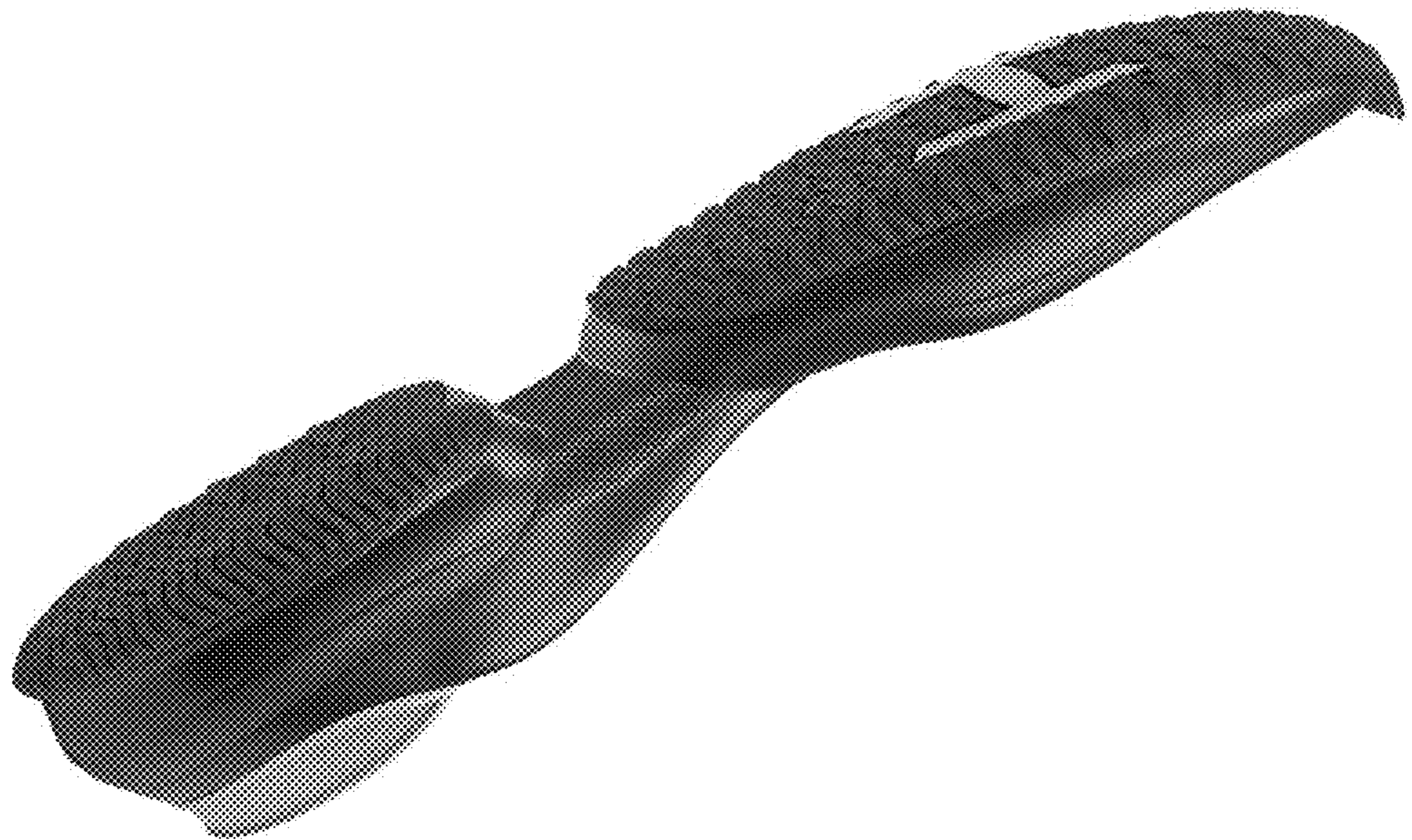
- 1. Shoe sole

The various views of the design show only the right shoe sole; the left shoe sole is not shown as it is symmetrical to the right one.

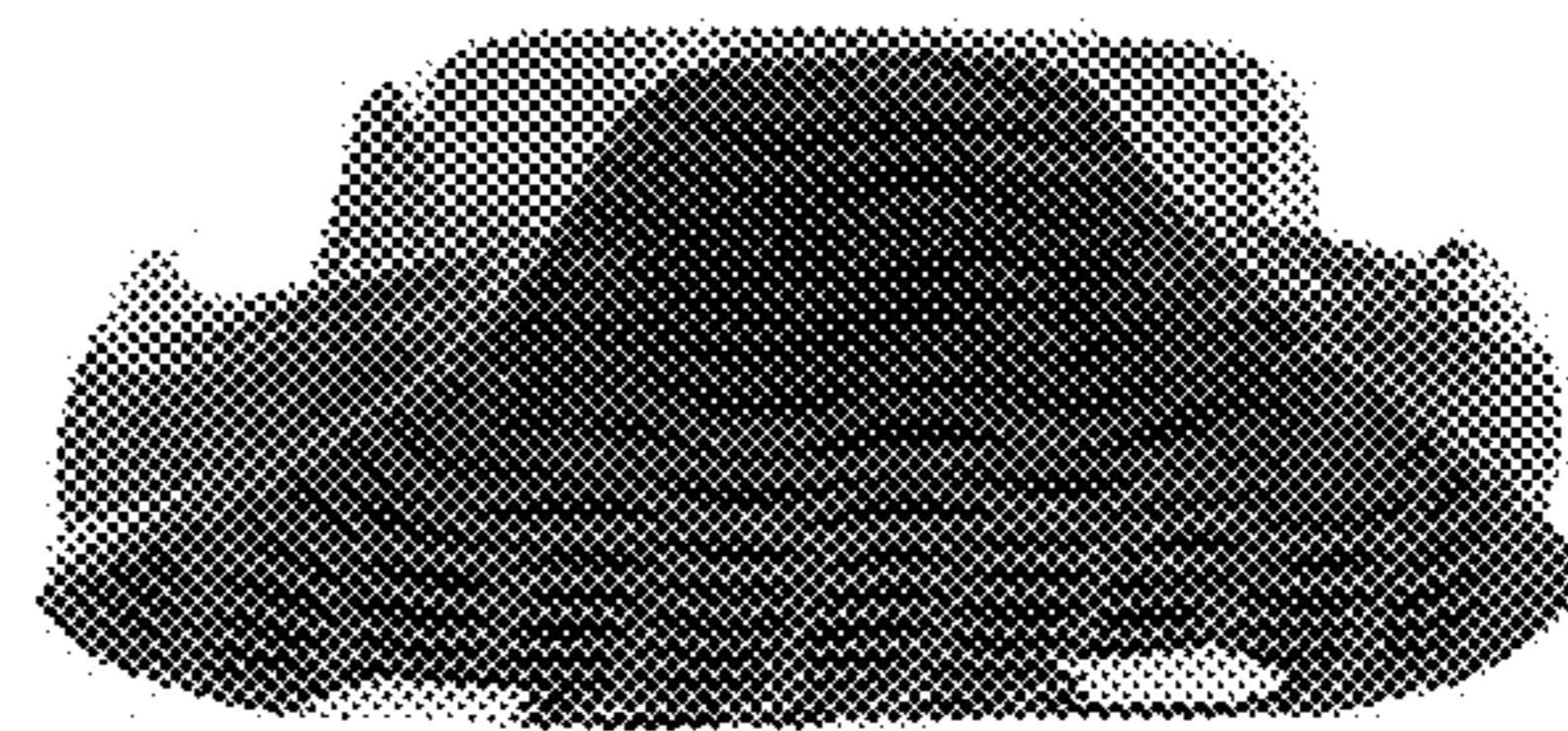

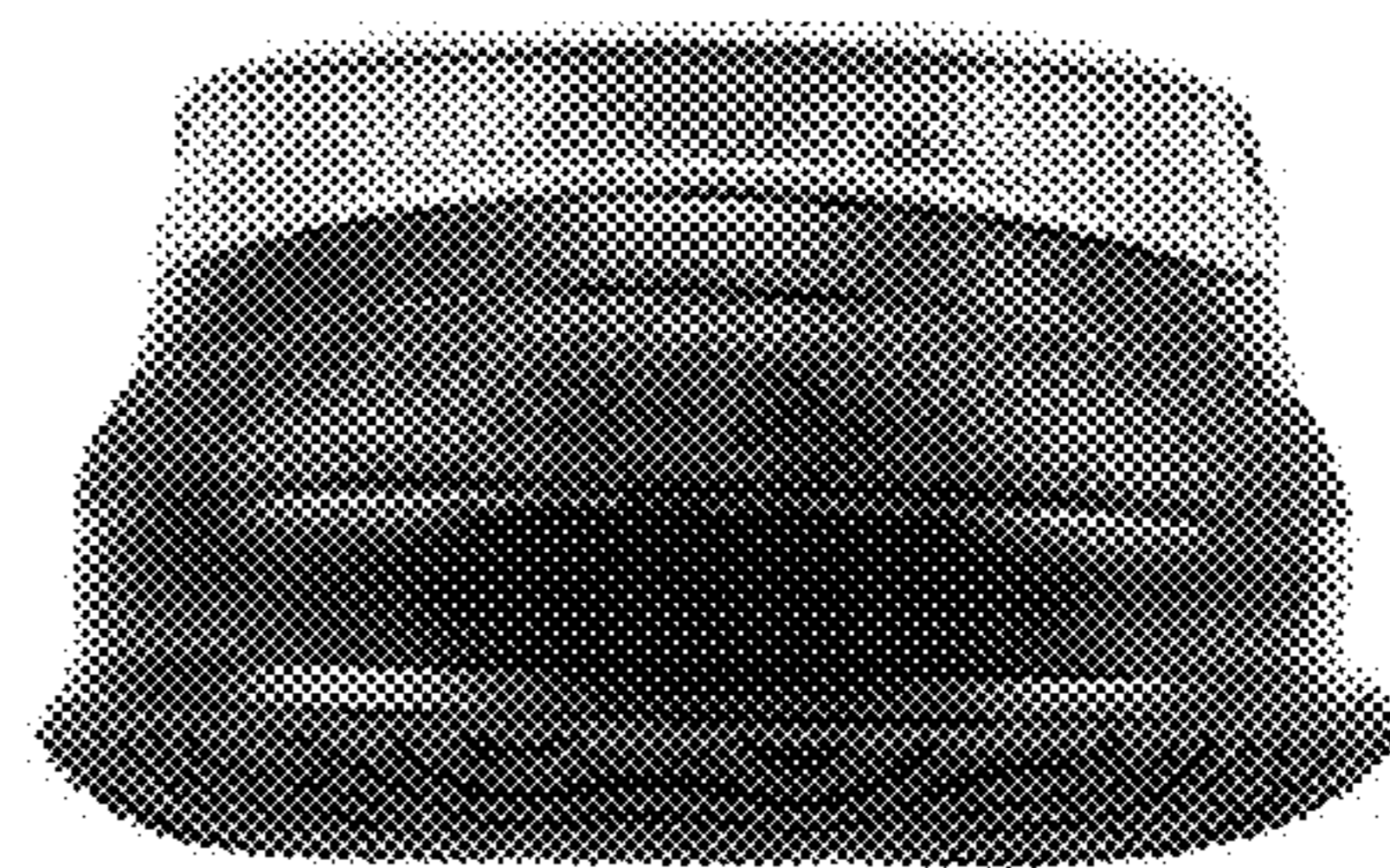
