(57) **CLAIM**

The ornamental design for a shoe with ornamentation, as shown and described.

DESCRIPTION

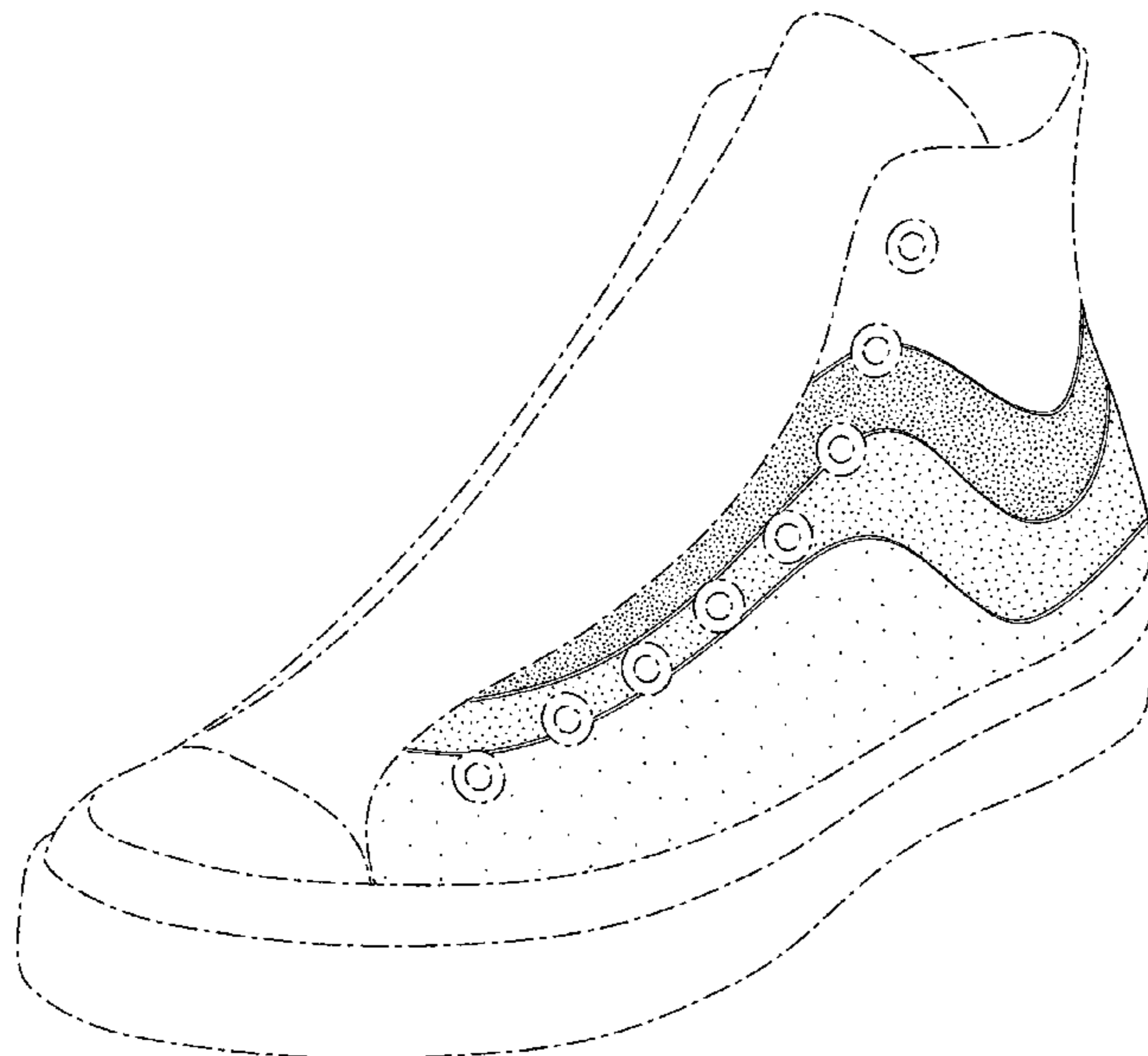
FIG. 1 is a front perspective view of a shoe with ornamentation showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a front perspective view showing an alternative embodiment of my new design;
FIG. 5 is a side view thereof; and,
FIG. 6 is a rear perspective view thereof.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken line circular elements represent eyelets which form no part of the claimed design. The contrast in shading between the three panels represents a contrast in color appearance only between the three regions from darkest (as represented by the heaviest stippling) to lightest (as represented by the lightest stippling) and does not represent any particular colors. The broken lines depicting the remainder of the shoe form no part of the claimed design.

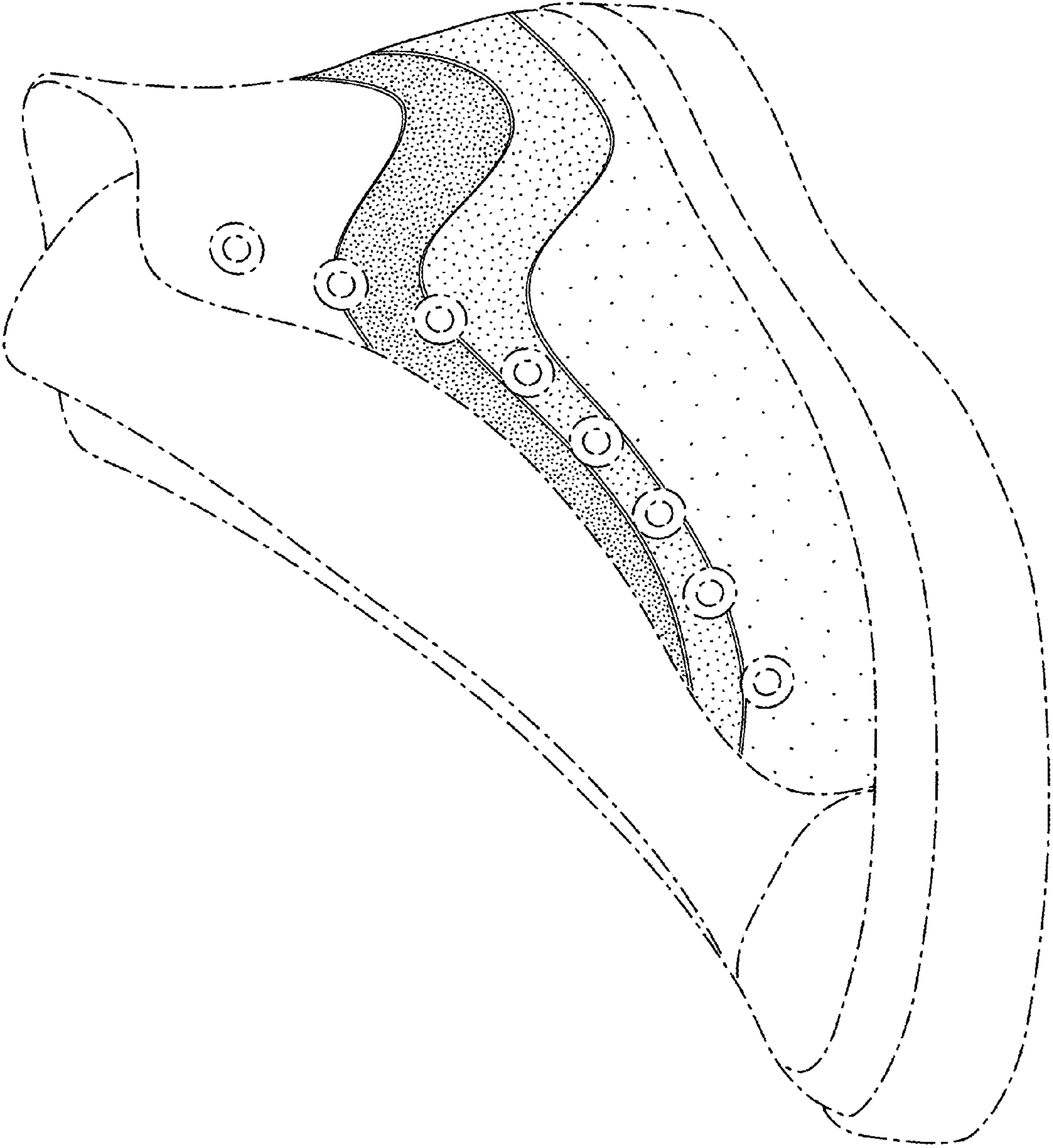

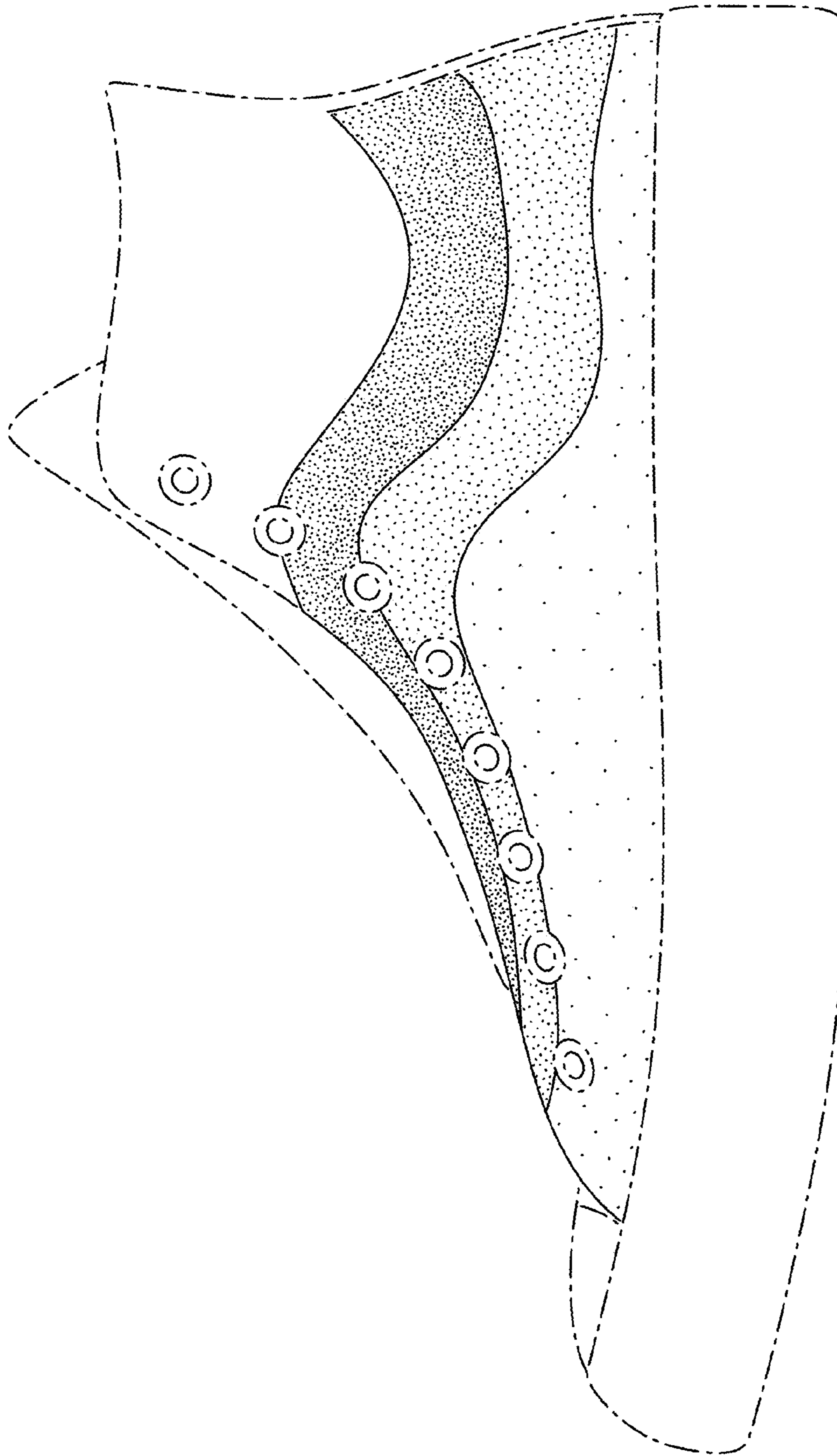

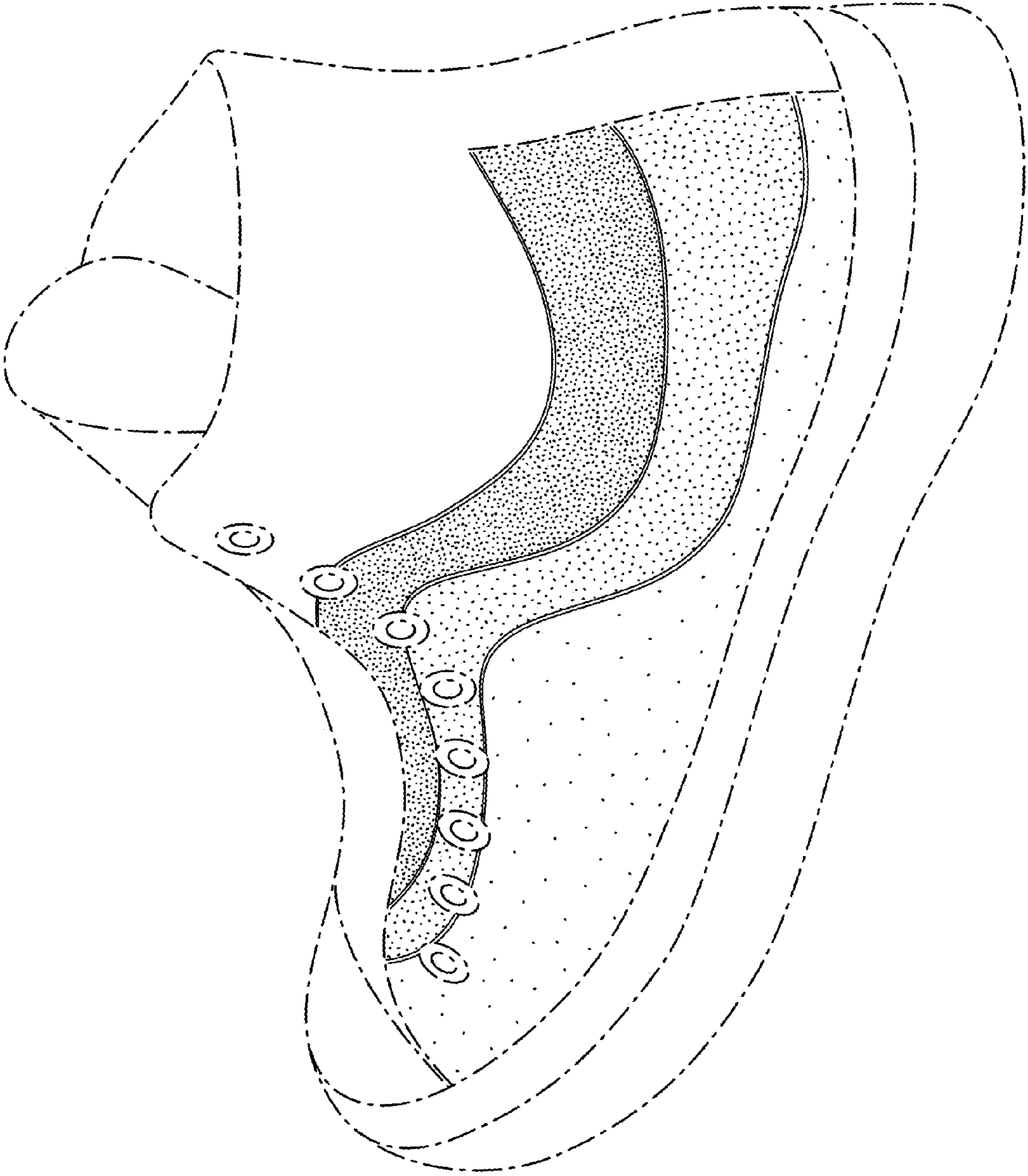

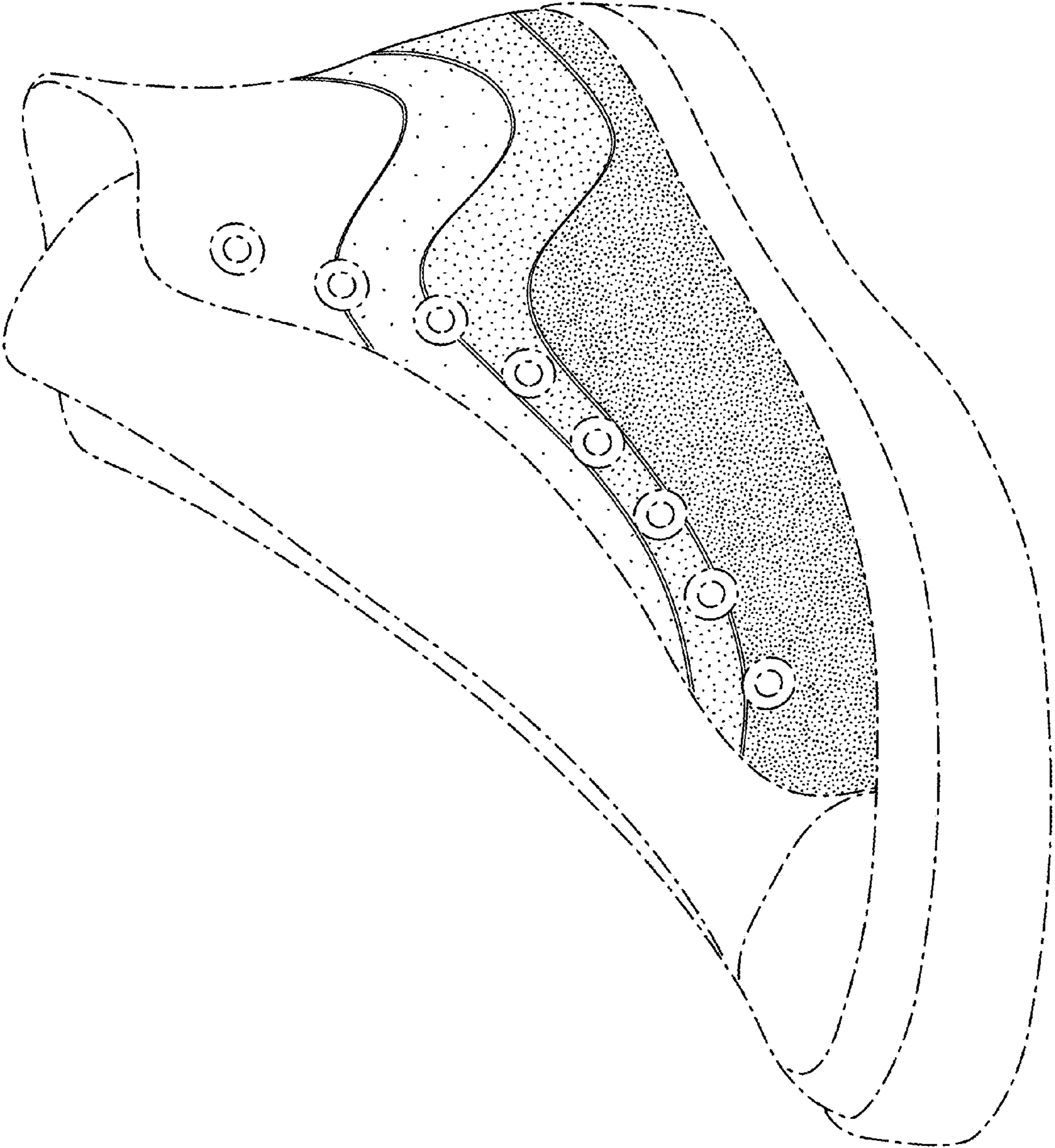

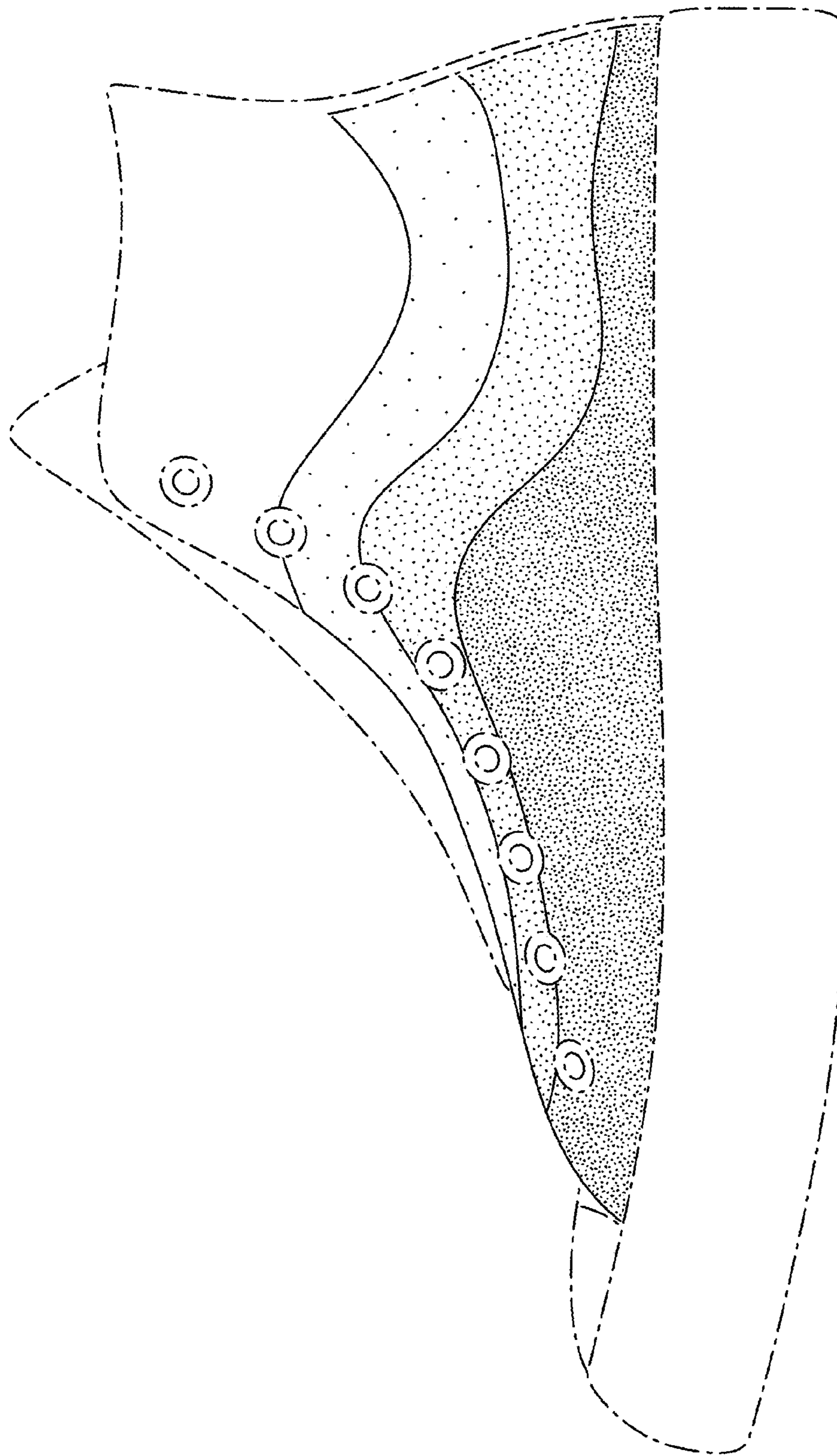

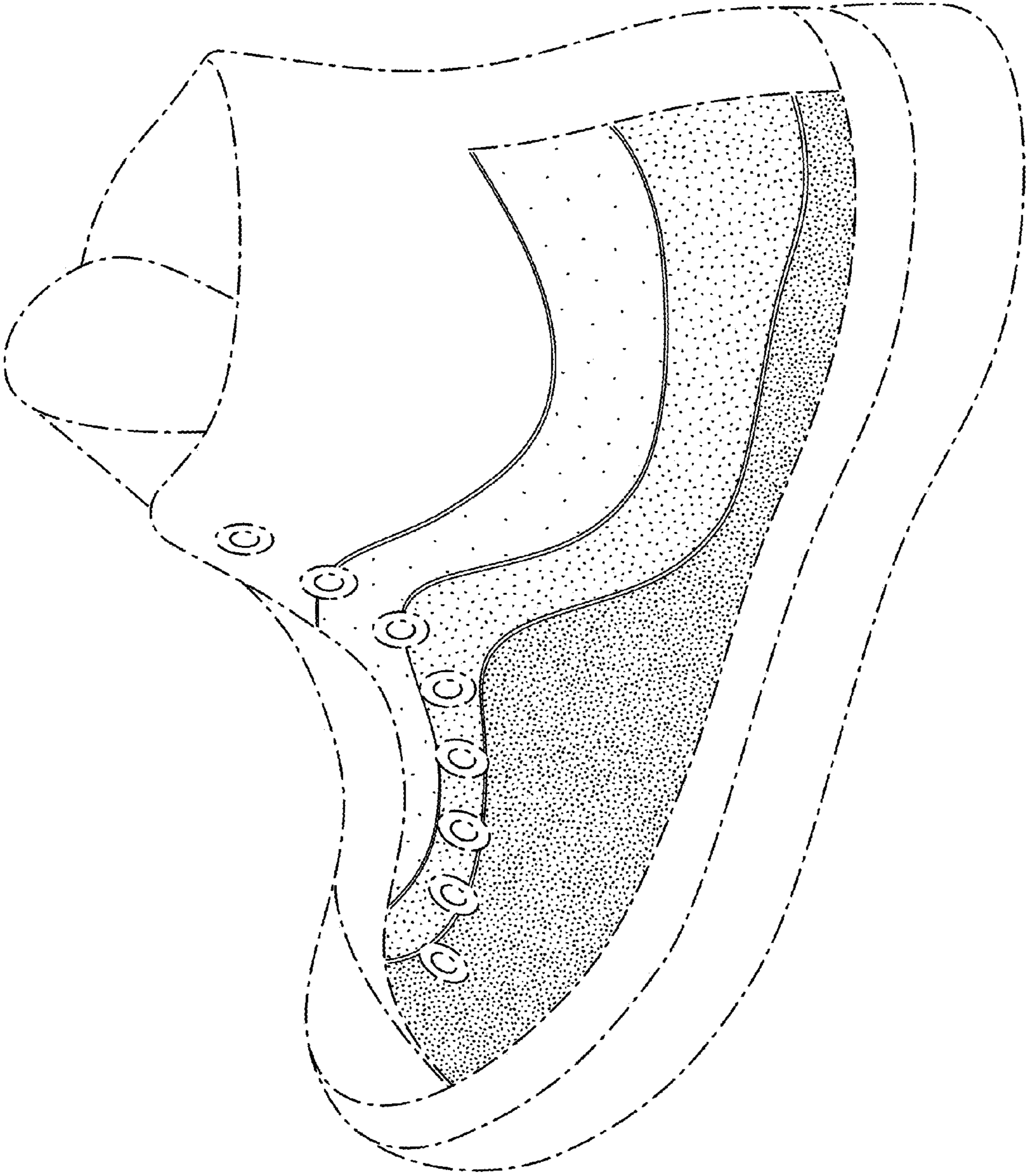
