(57) **CLAIM**

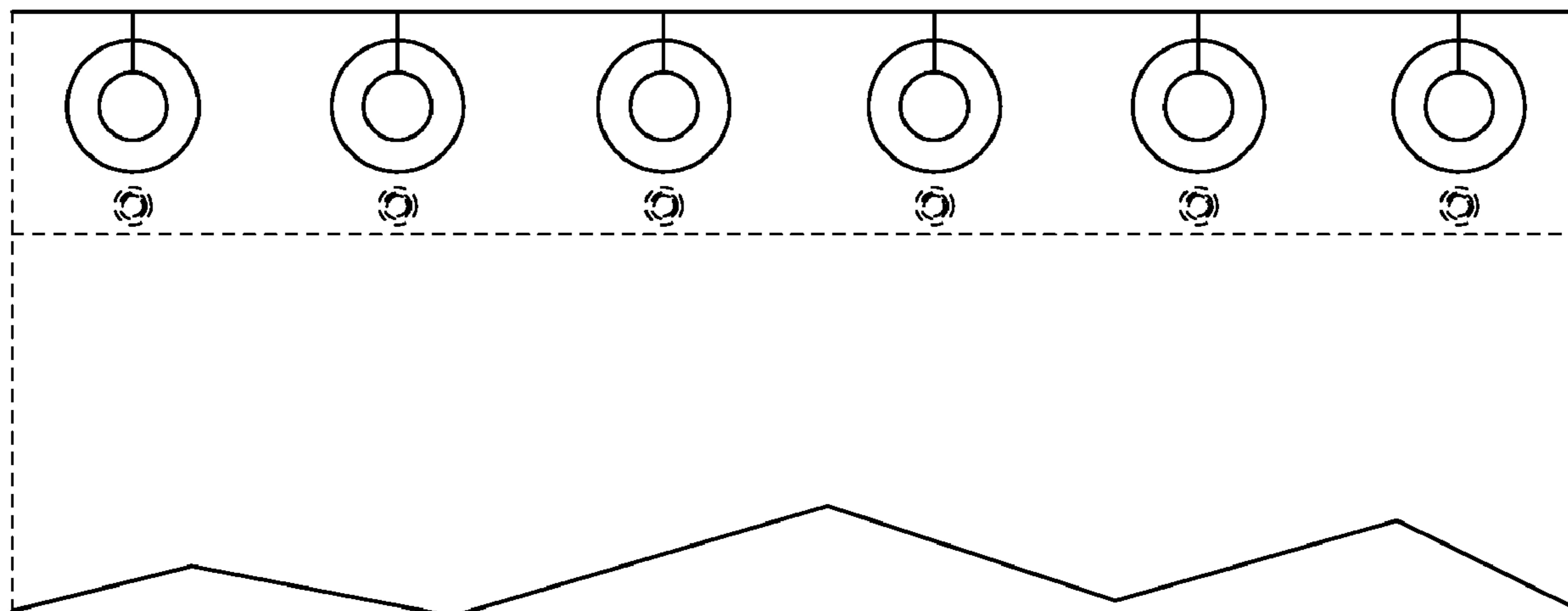
I claim the ornamental design for a shower curtain, as shown and described.
