(57) **CLAIM**

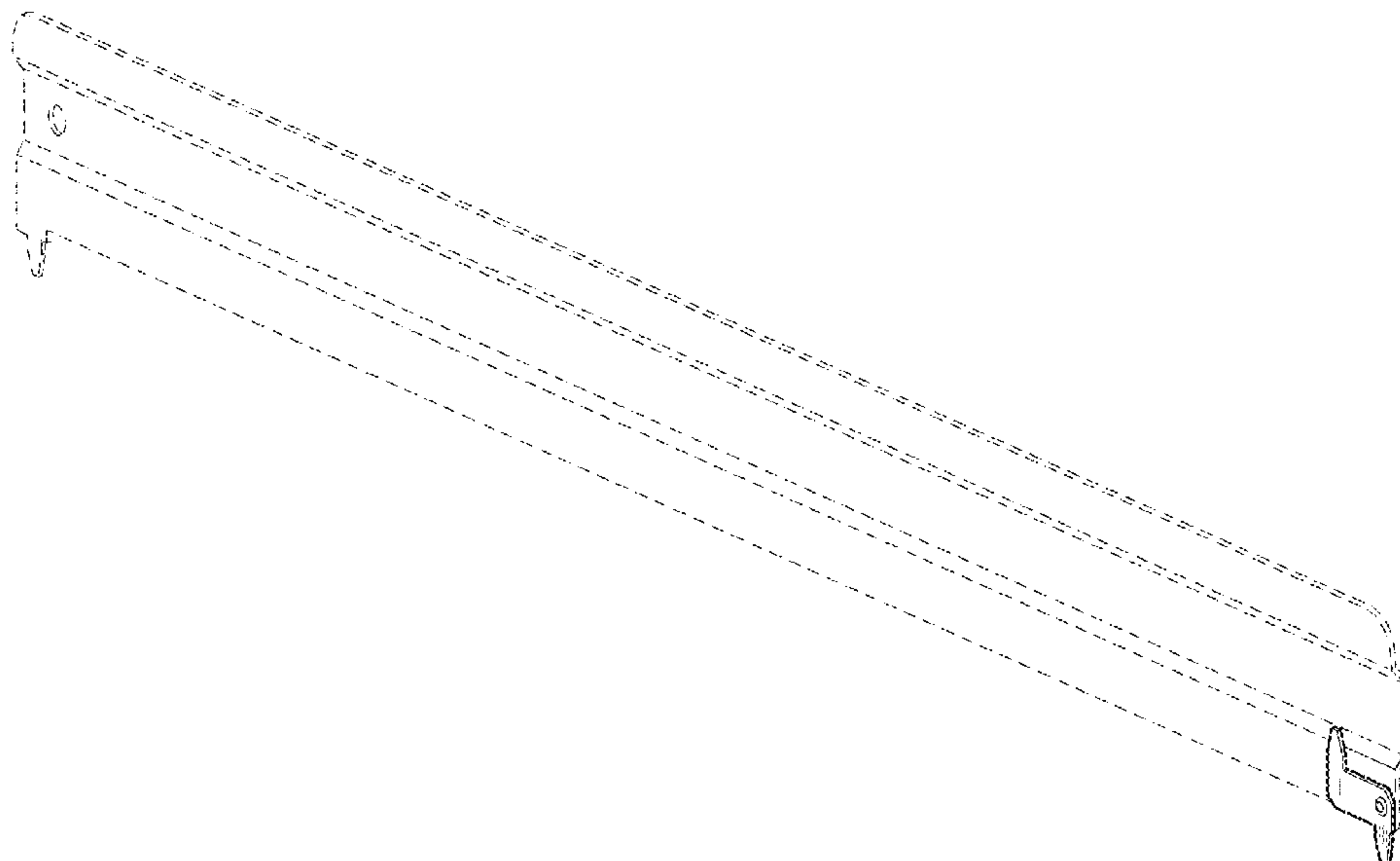
The ornamental design for a divider member having adjustable securement fin, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a divider member having adjustable securement fin showing the new design; FIG. 2 is a left side view of the invention illustrated in FIG. 1; FIG. 3 is a right side view of the invention illustrated in FIG. 1; FIG. 4 is a rear view of the invention illustrated in FIG. 1; FIG. 5 is a front view of the invention illustrated in FIG. 1; FIG. 6 is a bottom view of the invention illustrated in FIG. 1; FIG. 7 is a top view of the invention illustrated in FIG. 1; FIG. 8 is a perspective view of the invention illustrated in FIG. 1, with a securement fin thereof in another position; FIG. 9 is a right side view of the invention as illustrated in FIG. 8; FIG. 10 is a left side view of the invention as illustrated in FIG. 8; FIG. 11 is a rear view of the invention as illustrated in FIG. 8; FIG. 12 is a front view of the invention as illustrated in FIG. 8; FIG. 13 is a bottom view of the invention as illustrated in FIG. 8; and, FIG. 14 is a top view of the invention as illustrated in FIG. 8.

The broken lines in the drawings depict portions of the divider member having adjustable securement fin and form no part of the claimed design.

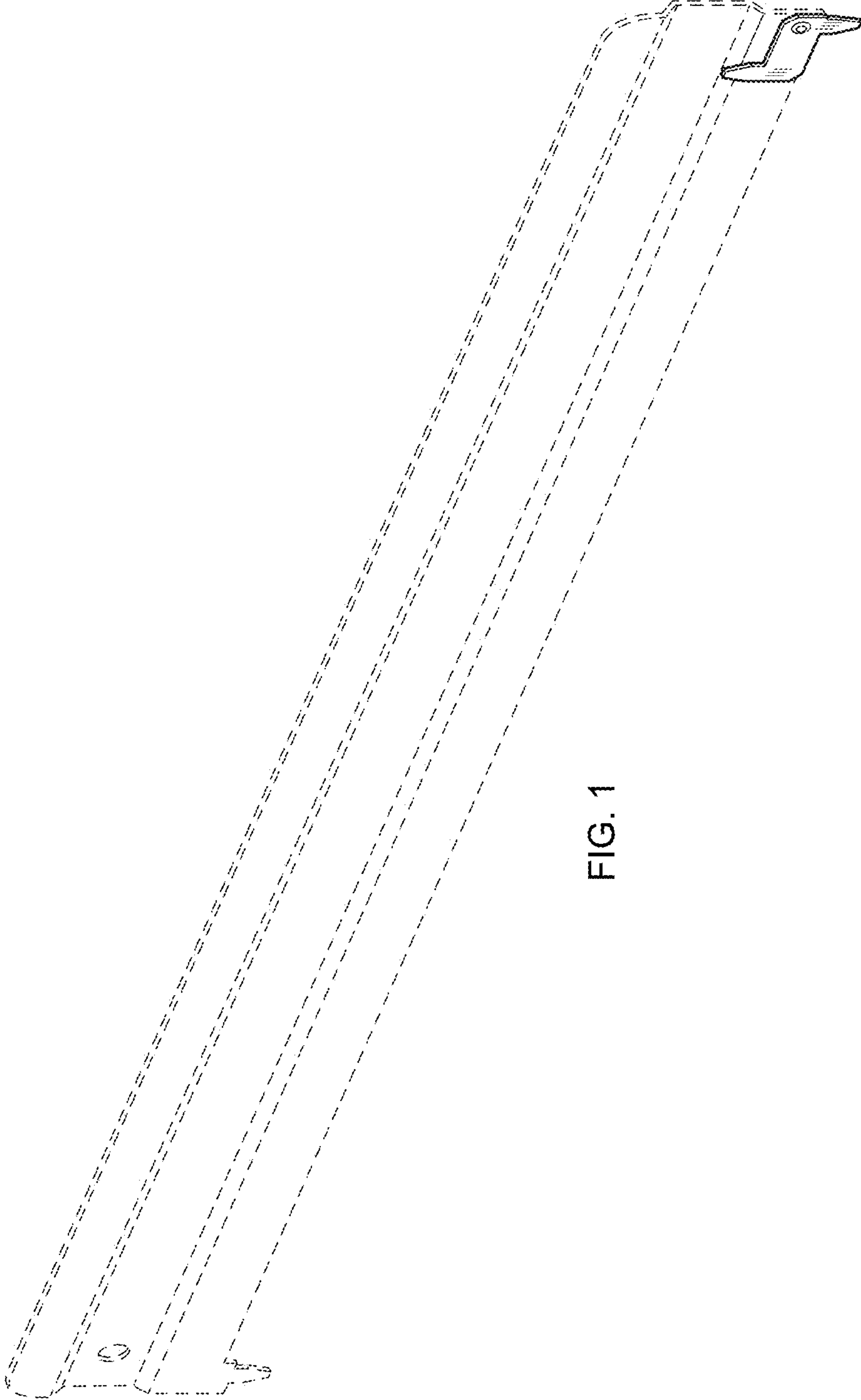

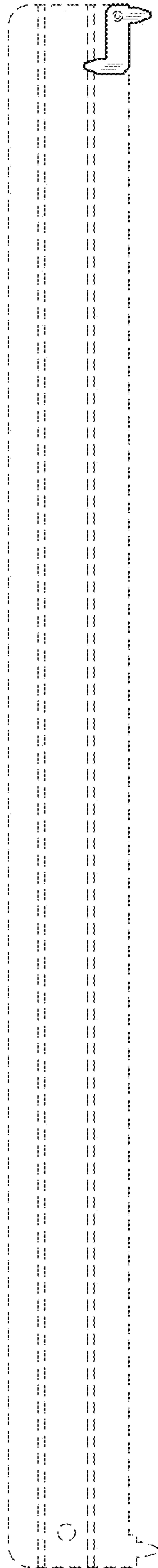

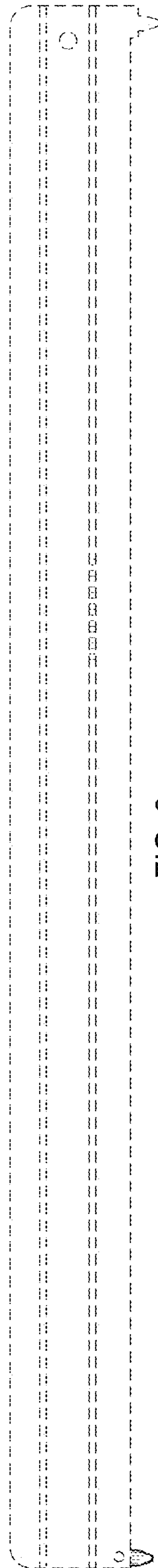

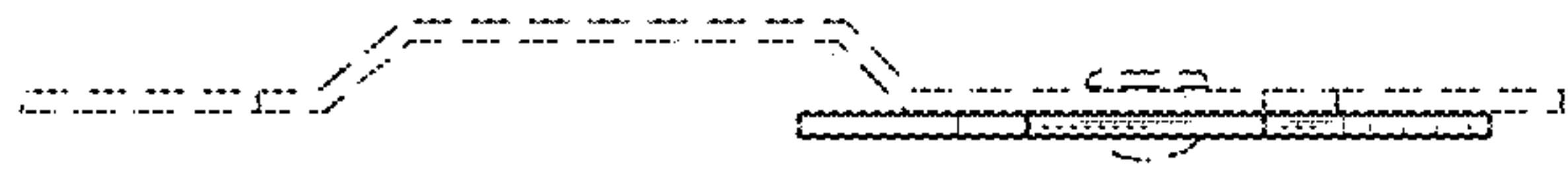

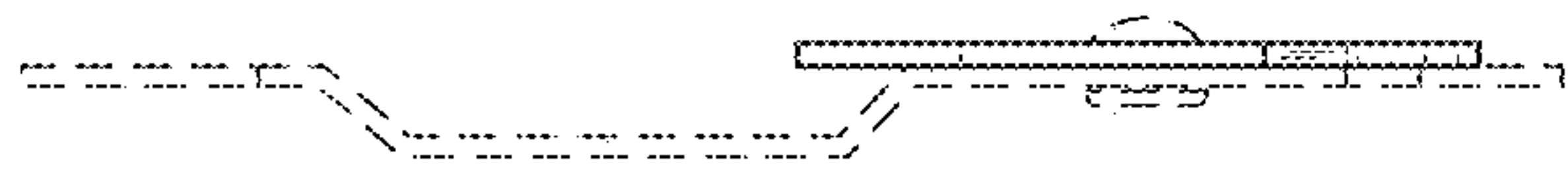

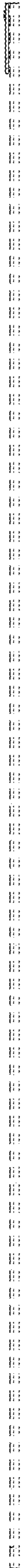

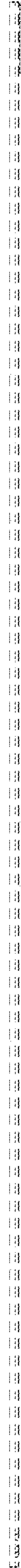

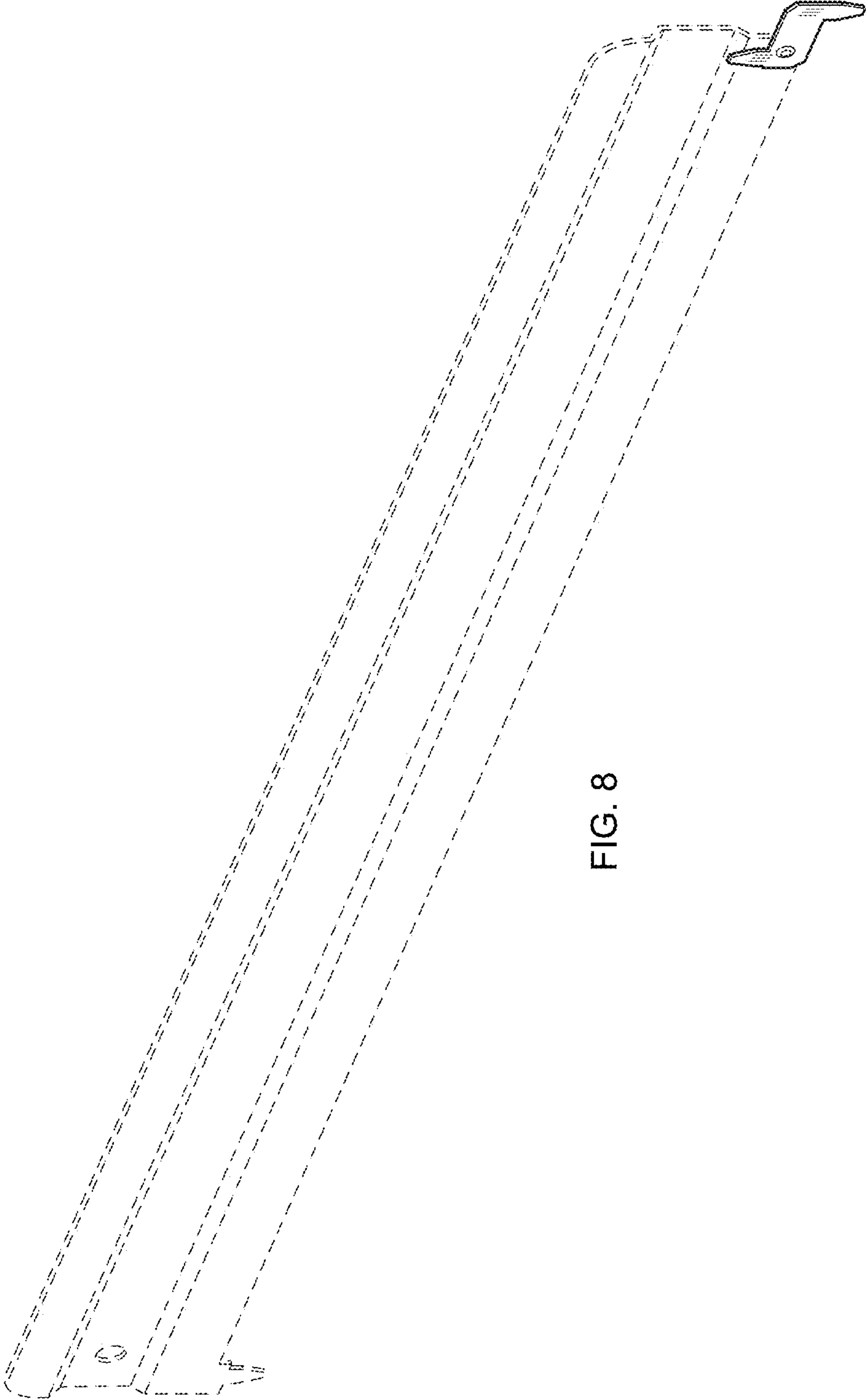

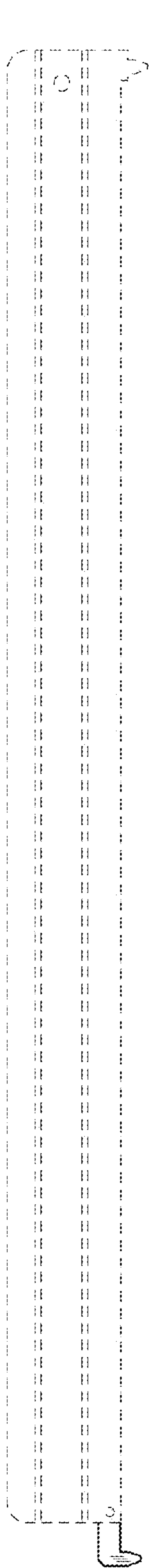

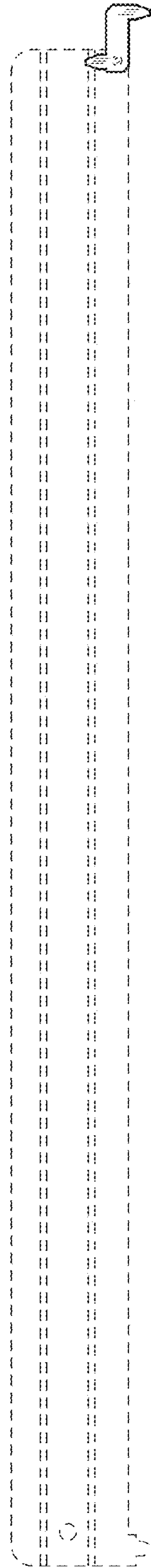

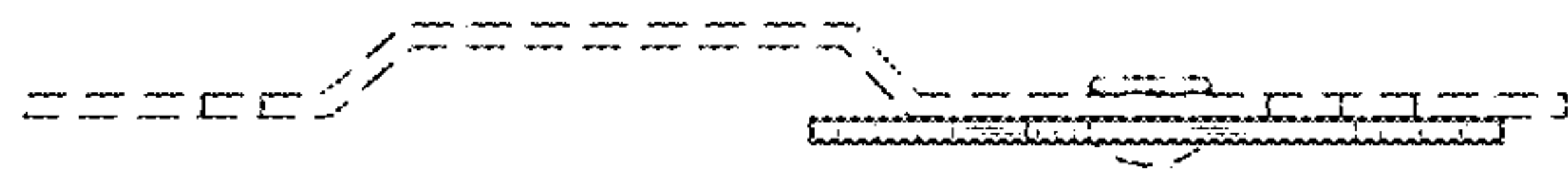

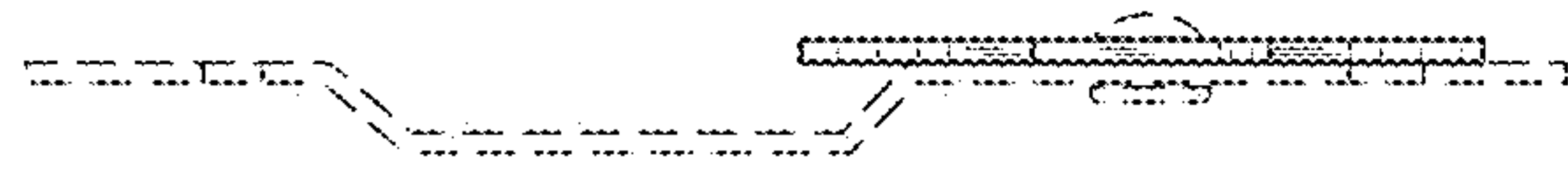

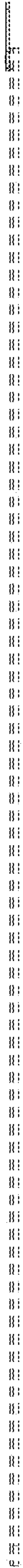

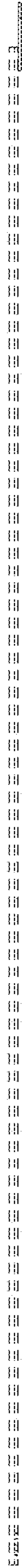
