**DESCRIPTION**

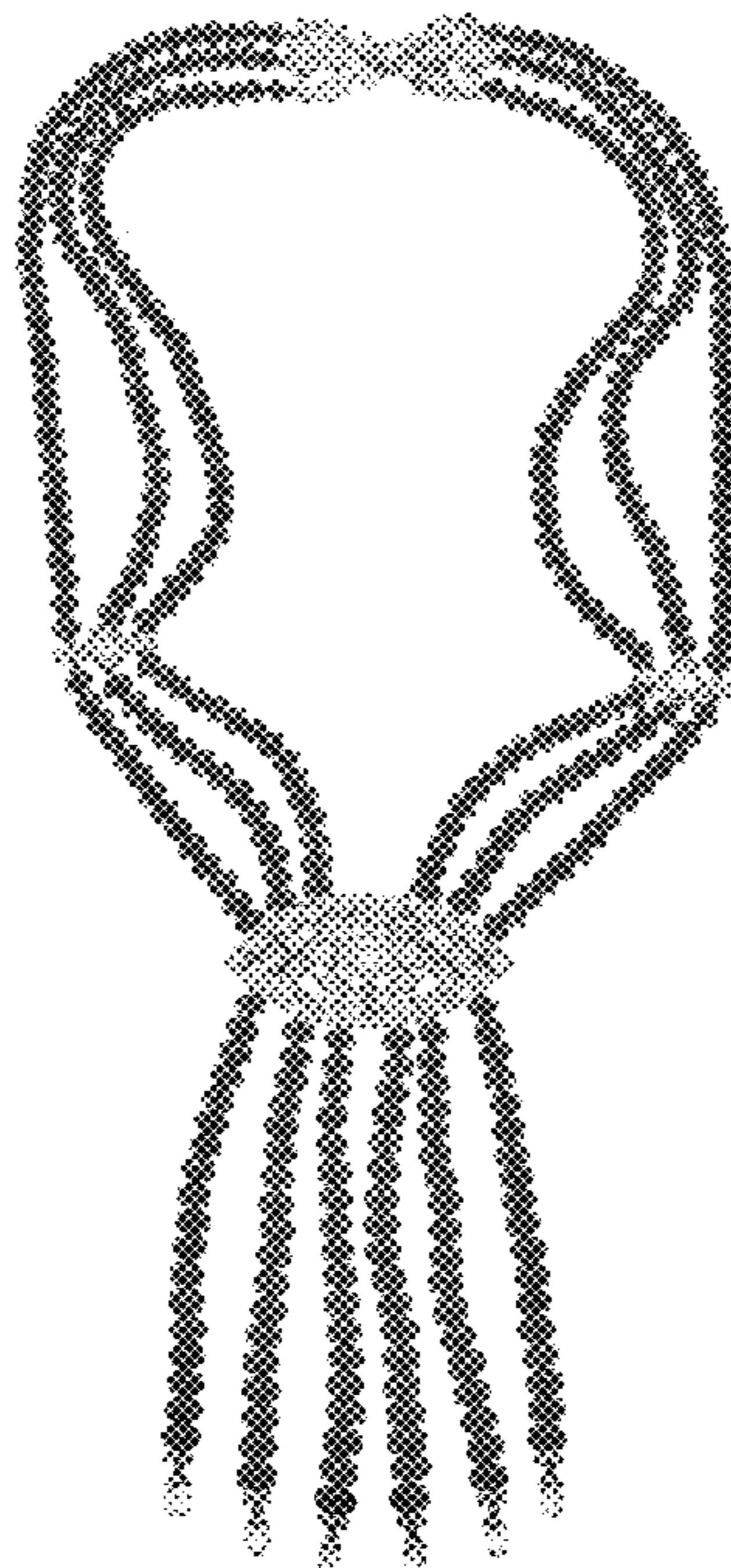

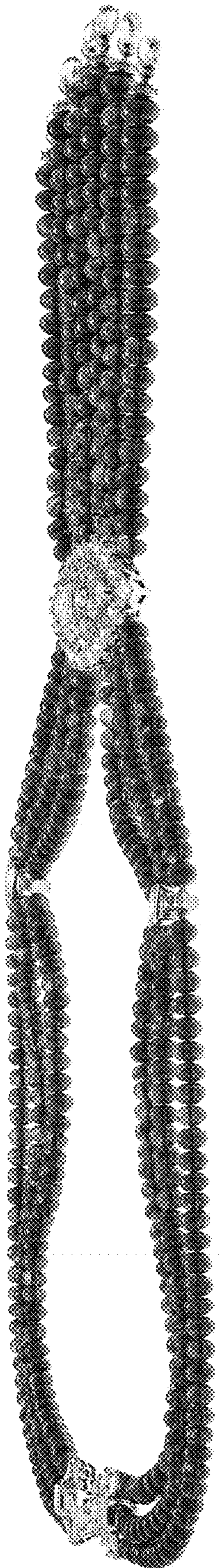

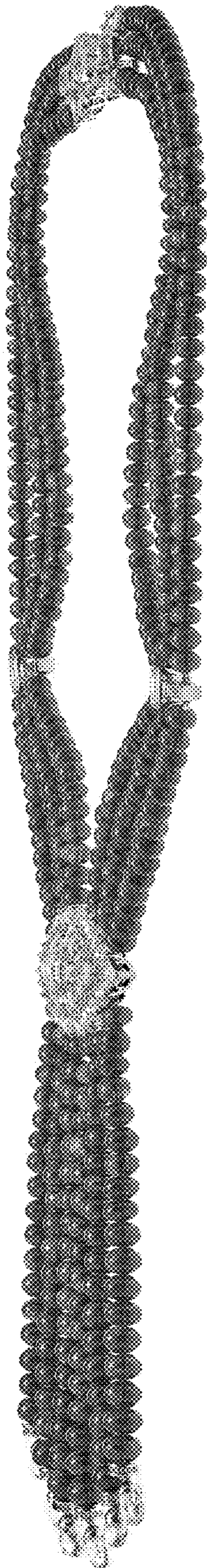

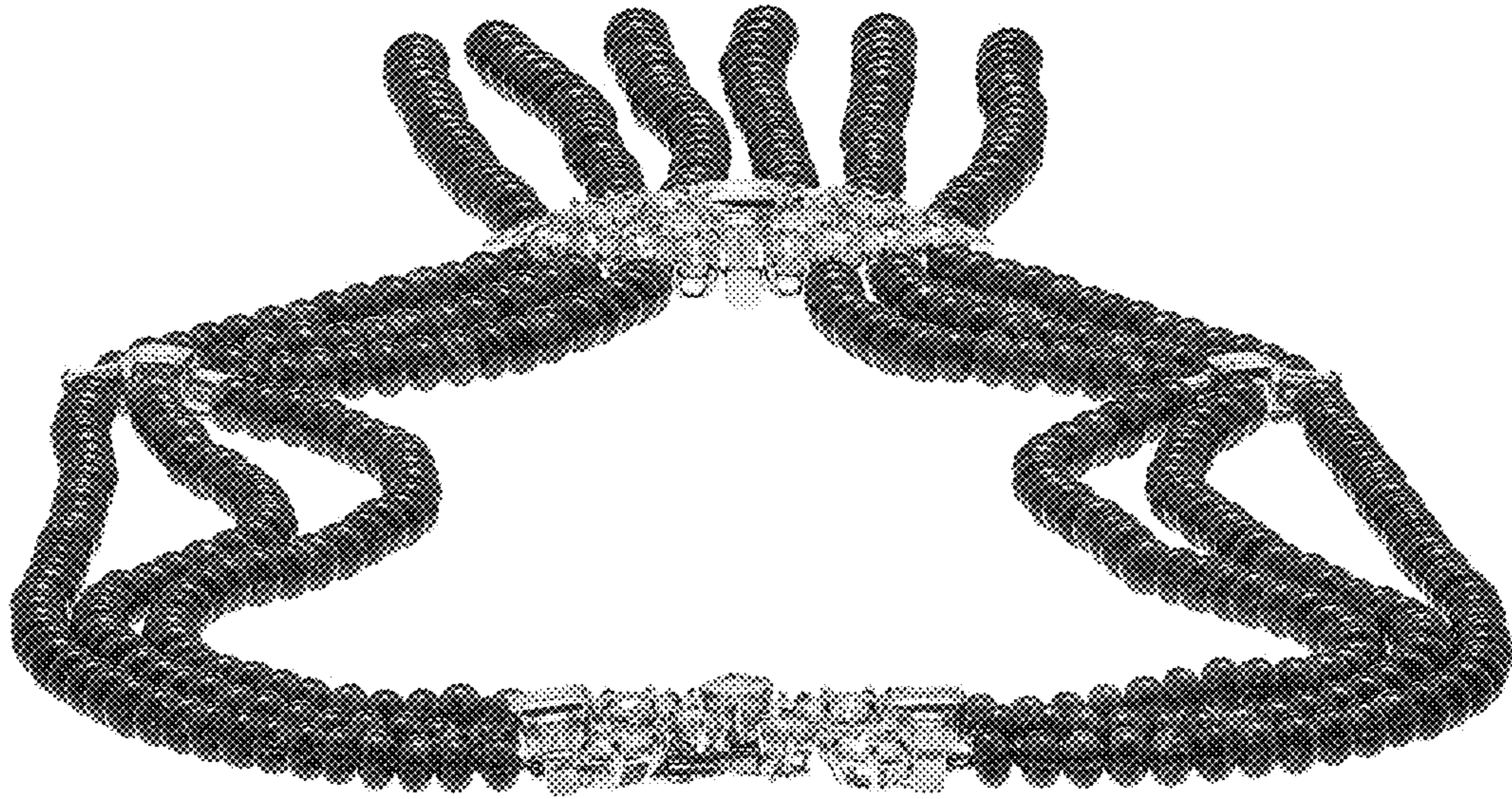
