(57) **CLAIM**

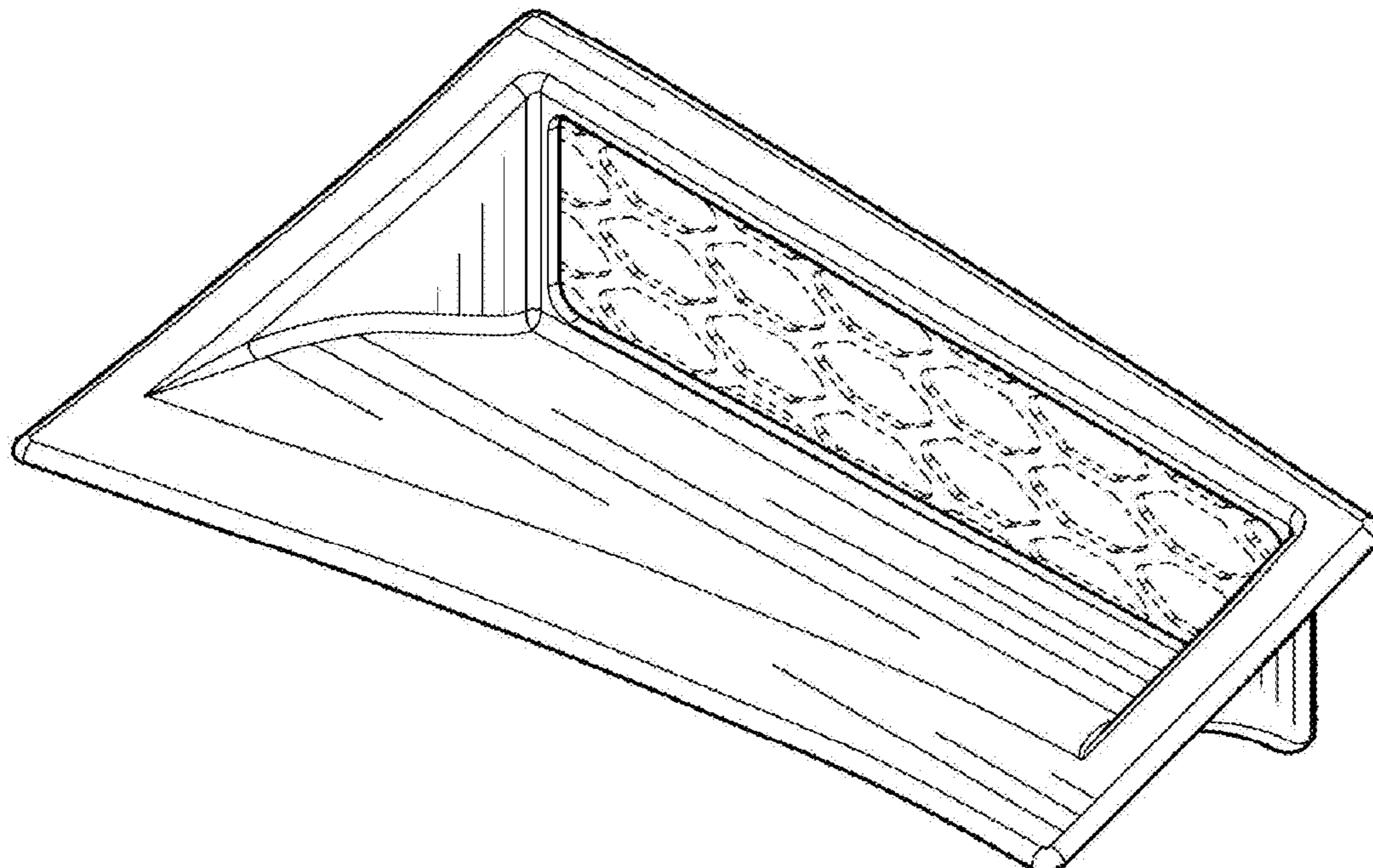
I claim the ornamental design for a fender air vent cover for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a fender air vent cover for a vehicle showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a top, rear, left side perspective view thereof, shown in a state of use.

The broken lines, in FIGS. 1 to 7, illustrate portions of the fender air vent cover for a vehicle that form no part of the claimed design. The broken lines, in FIG. 8, illustrate environmental structure and form no part of the claimed design.

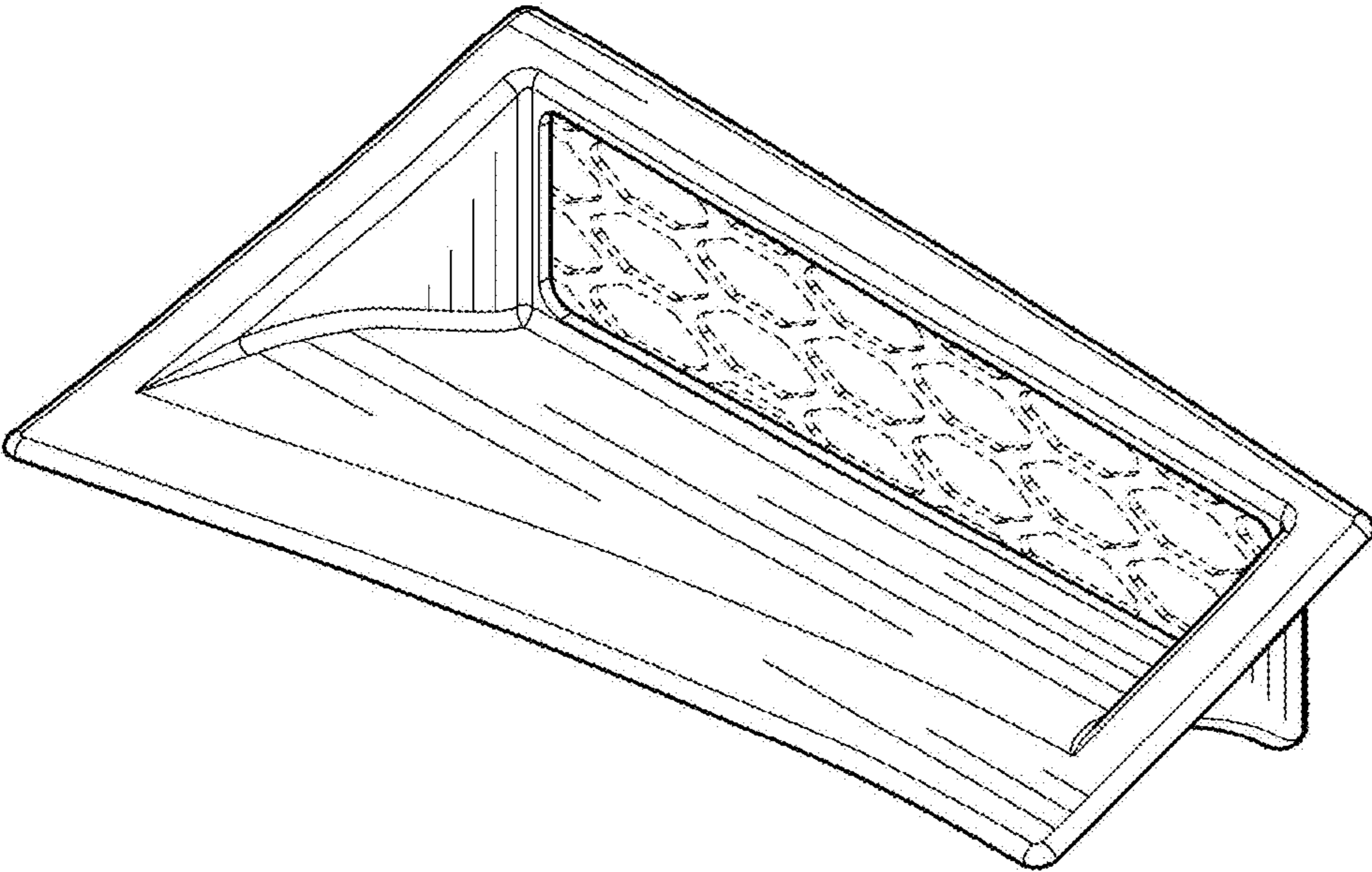

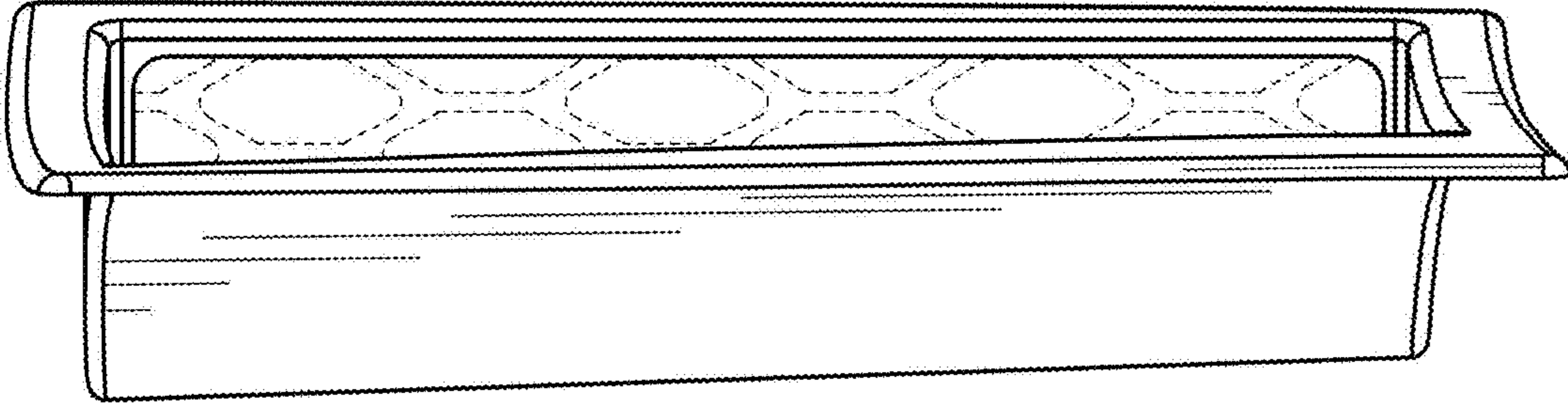

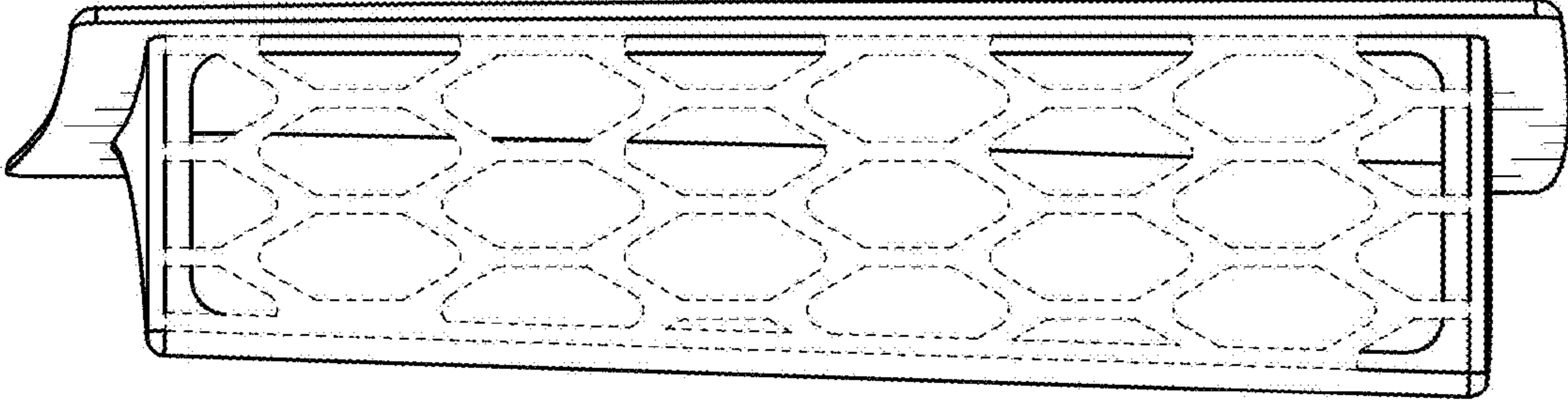

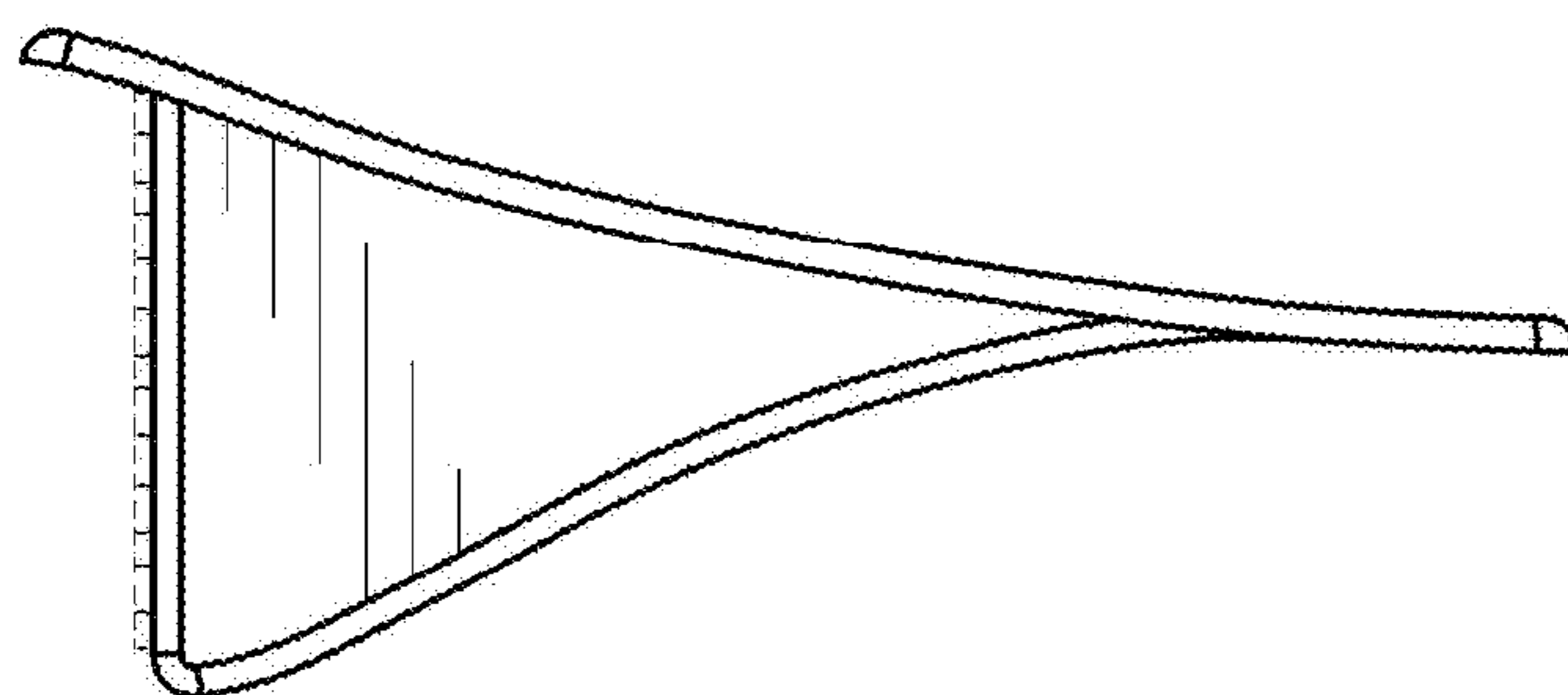

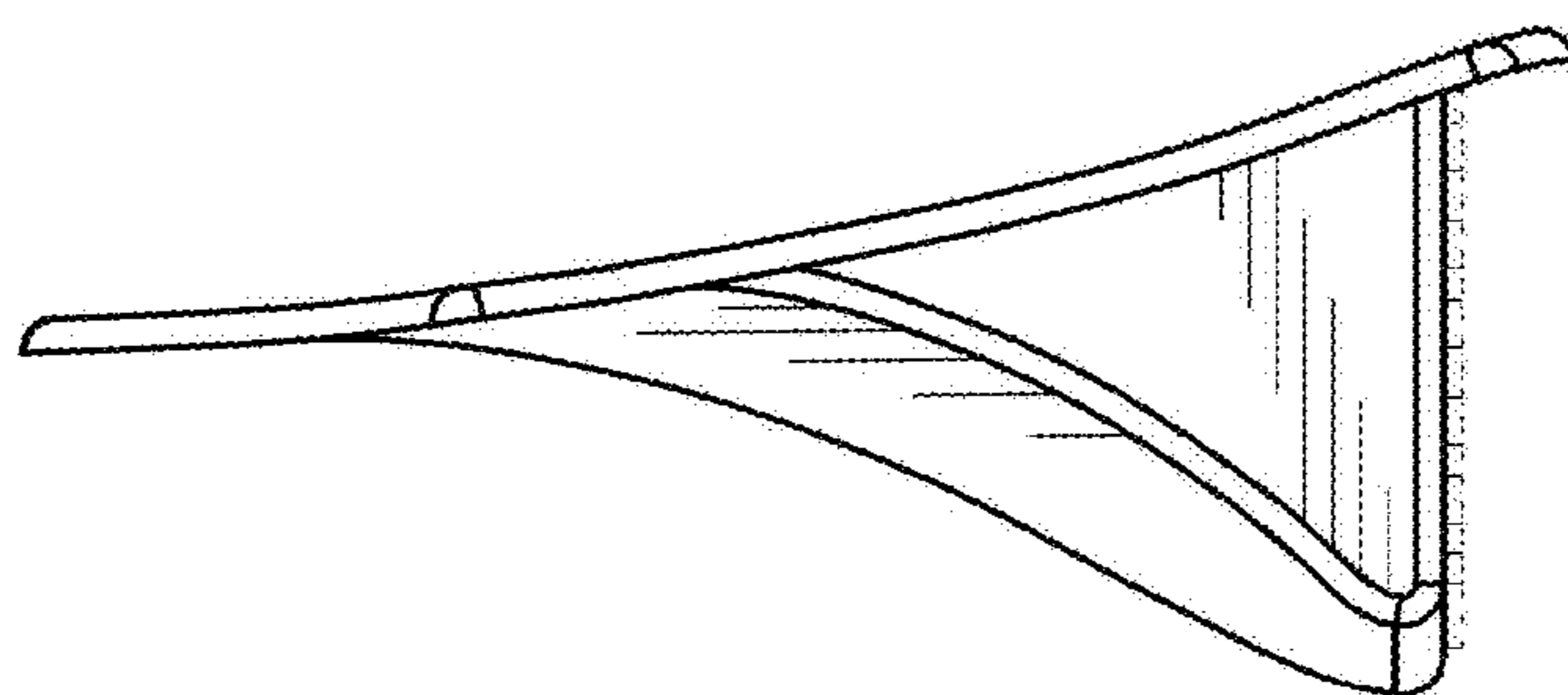

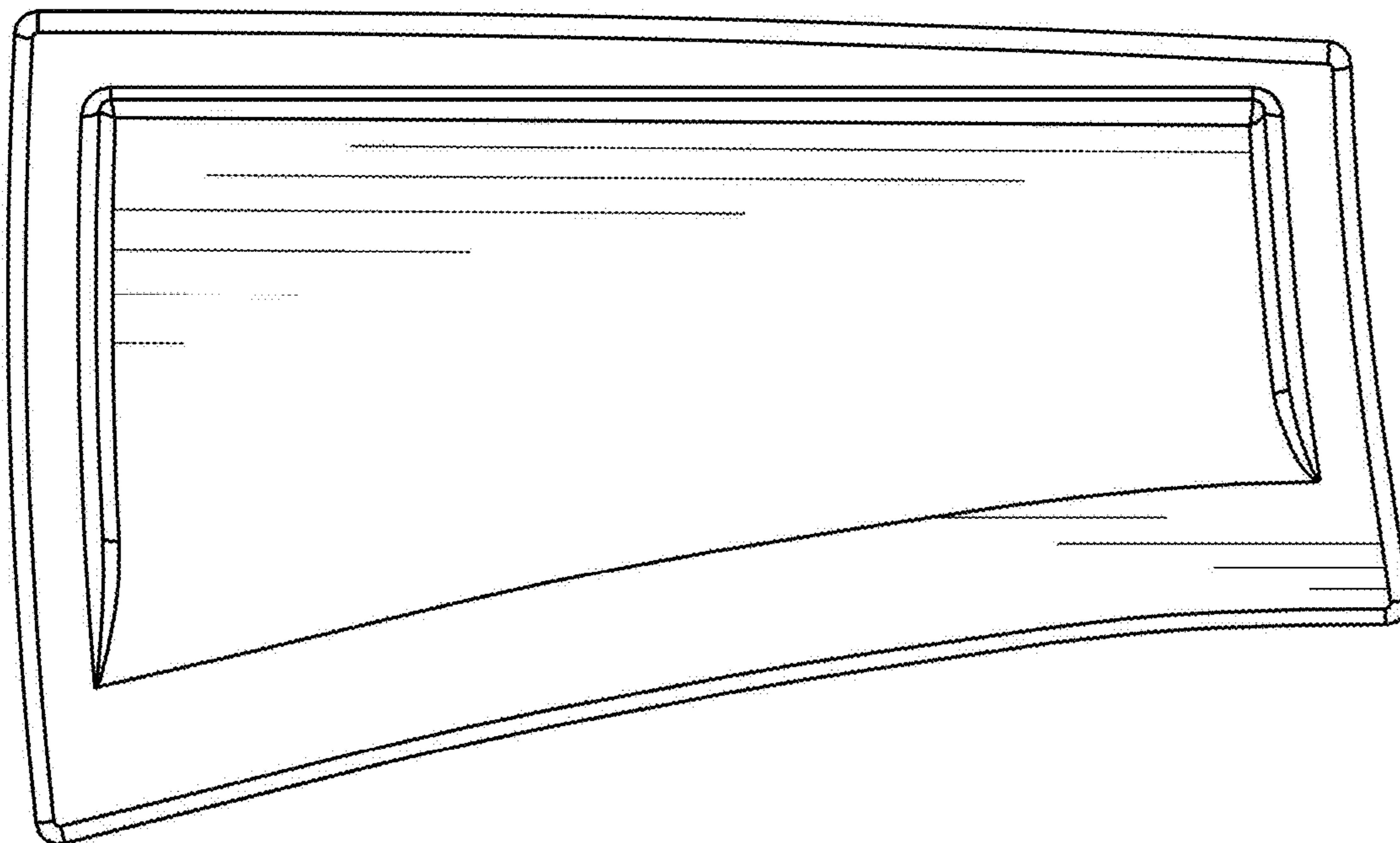

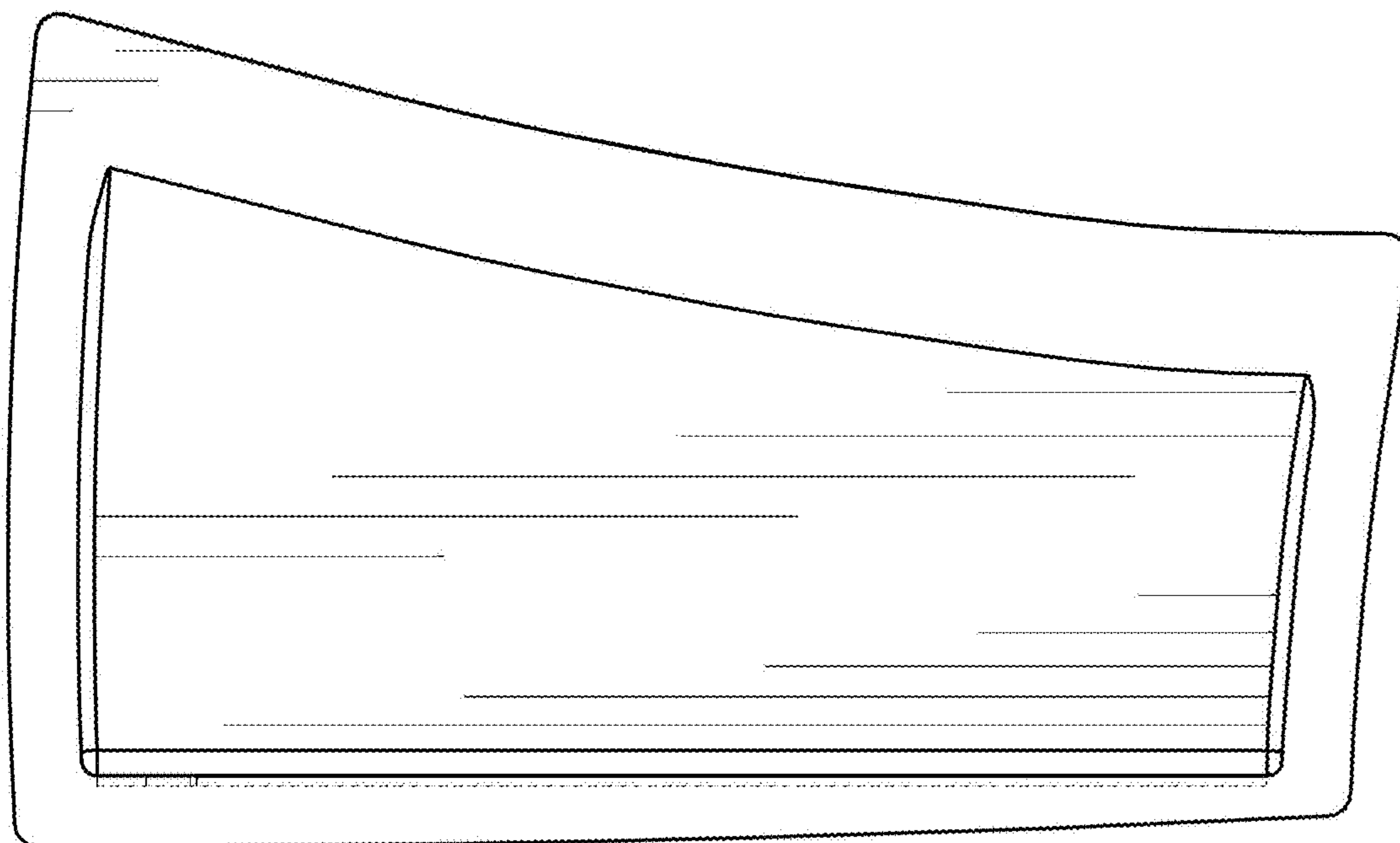

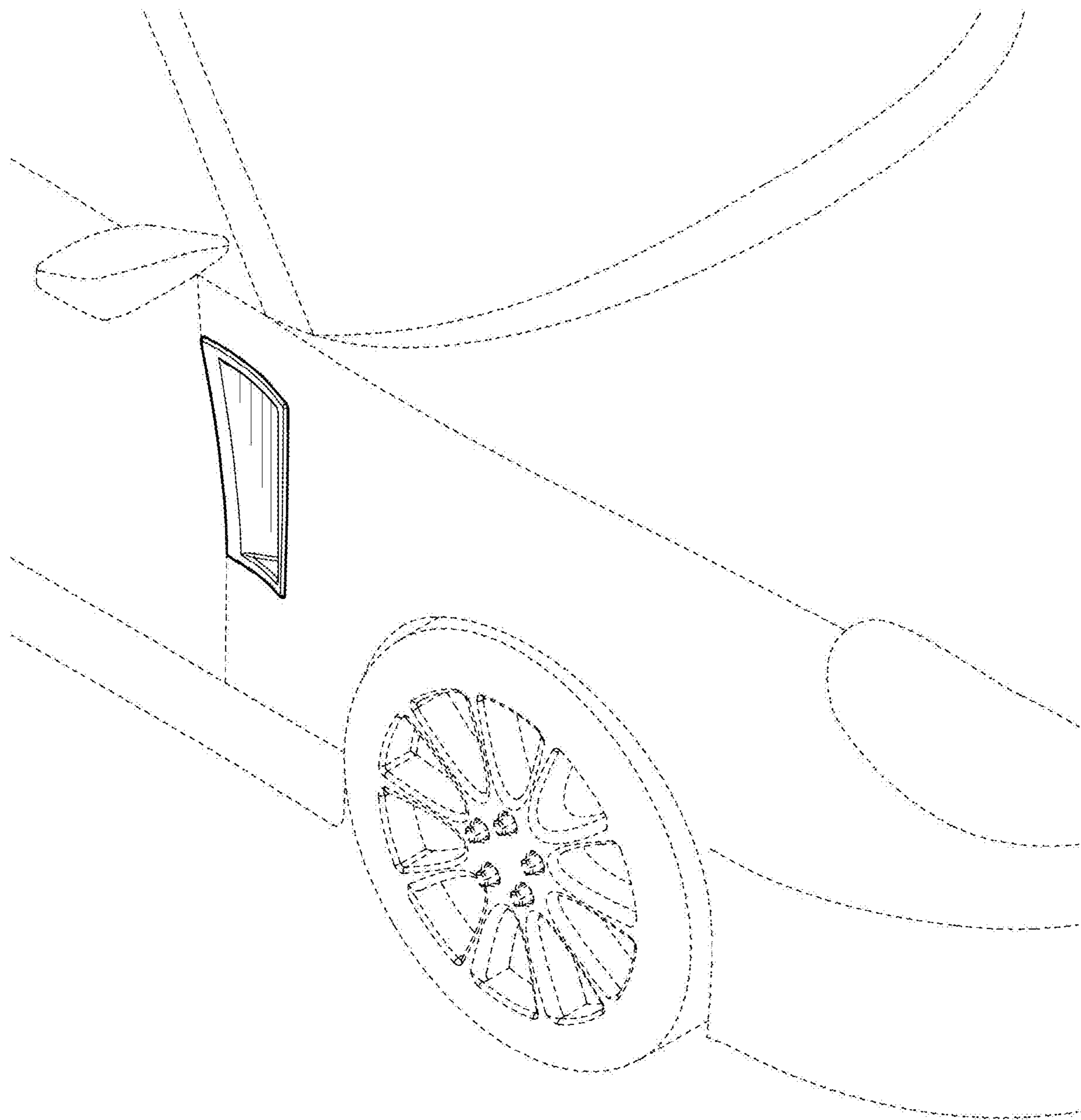
