(57) **CLAIM**

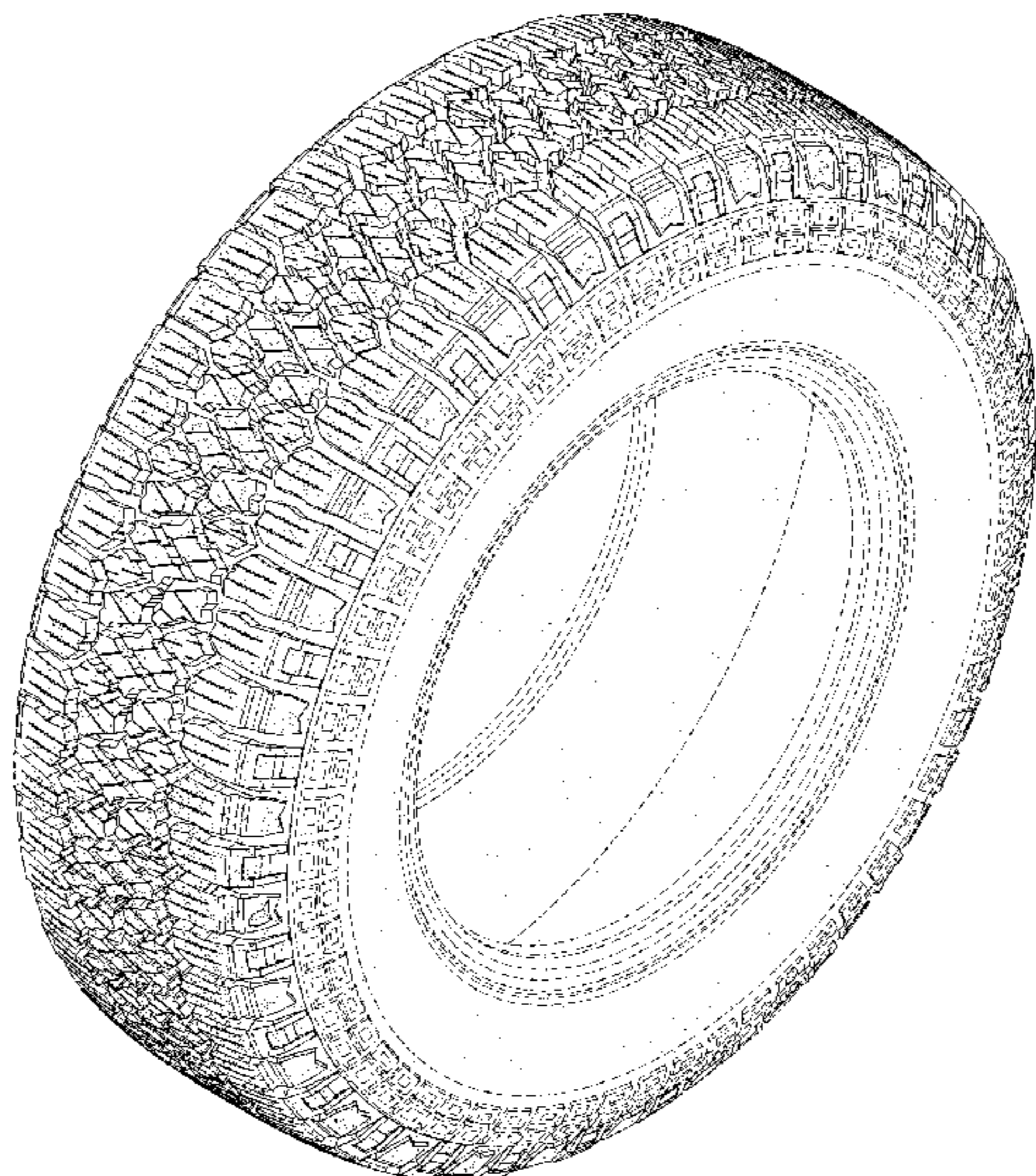
The ornamental design for a vehicle tire tread, as shown and described.

**DESCRIPTION**

FIG. 1 is an outside perspective view of a vehicle tire tread showing our design, it being understood that the depicted tread pattern extends over the entire circumference of the tire;  
FIG. 2 is front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is an outside elevational view thereof;  
FIG. 5 is an inside elevational view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is an outside perspective view of a second embodiment of the vehicle tire tread design shown in FIGS. 1-7; and,  
FIG. 9 is an inside perspective view of the second embodiment of the vehicle tire tread design shown in FIG. 8.

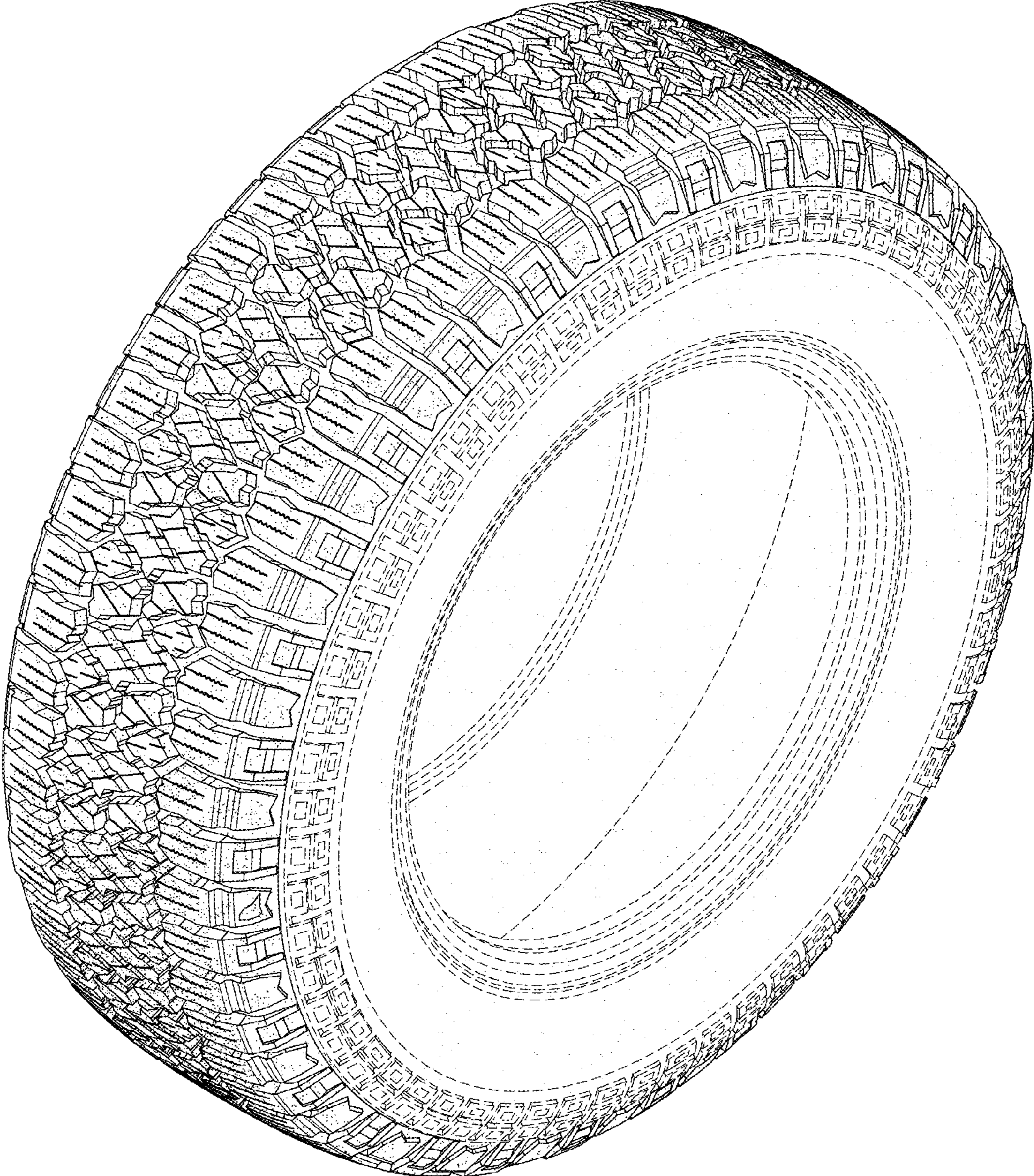

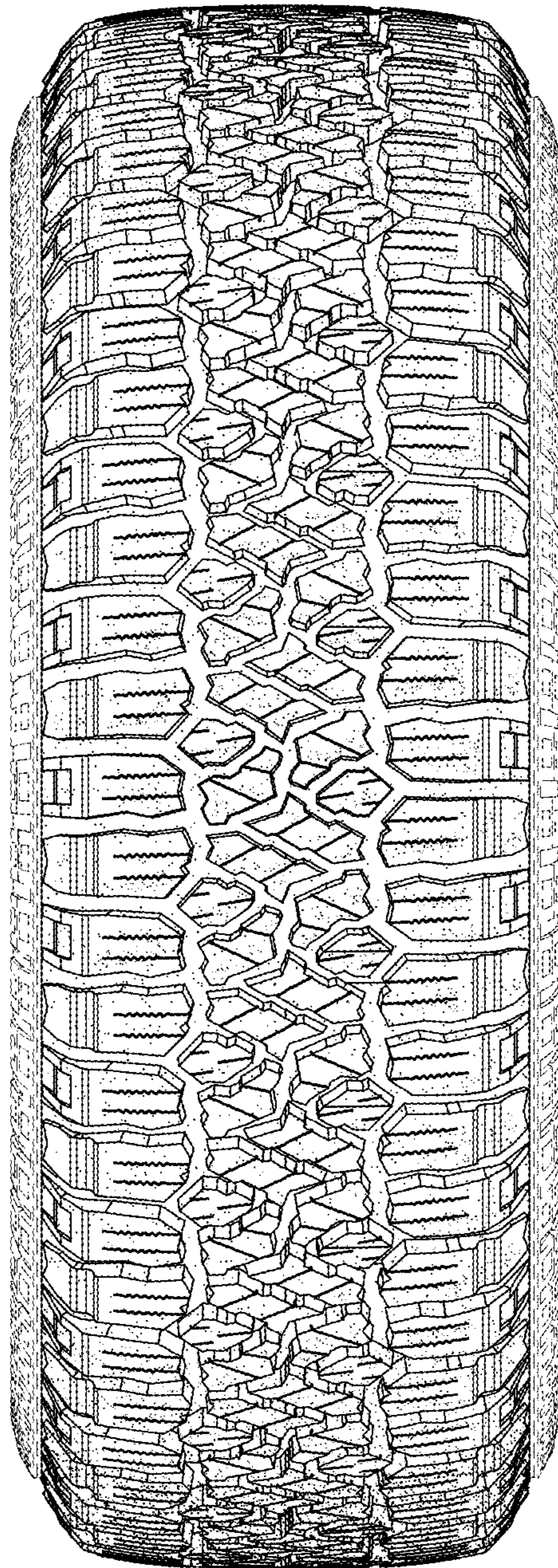

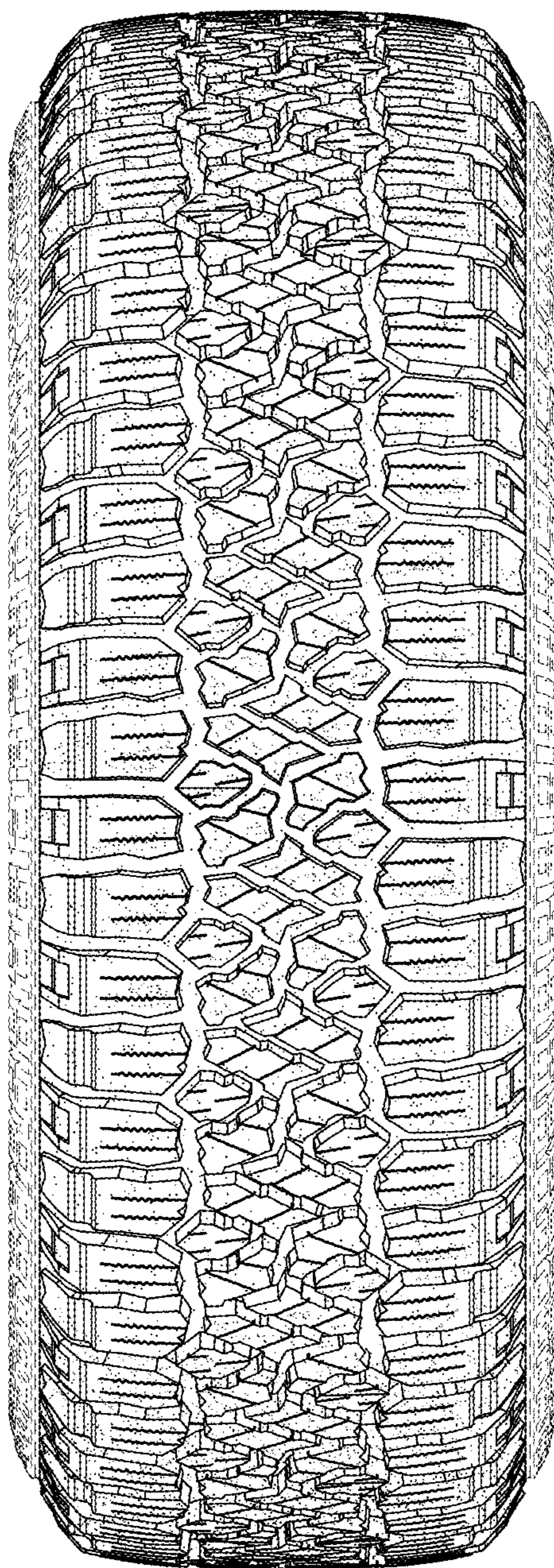

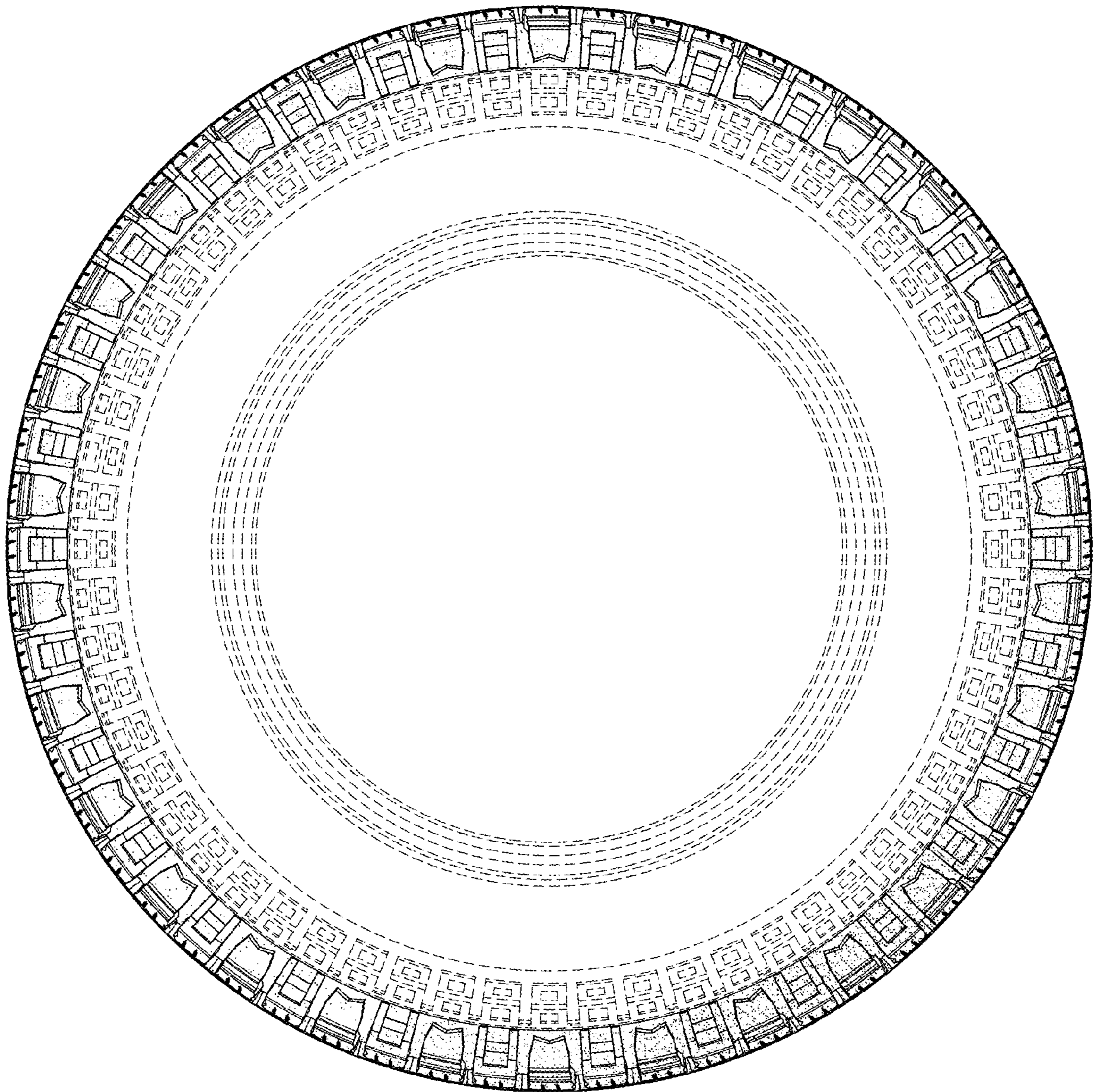

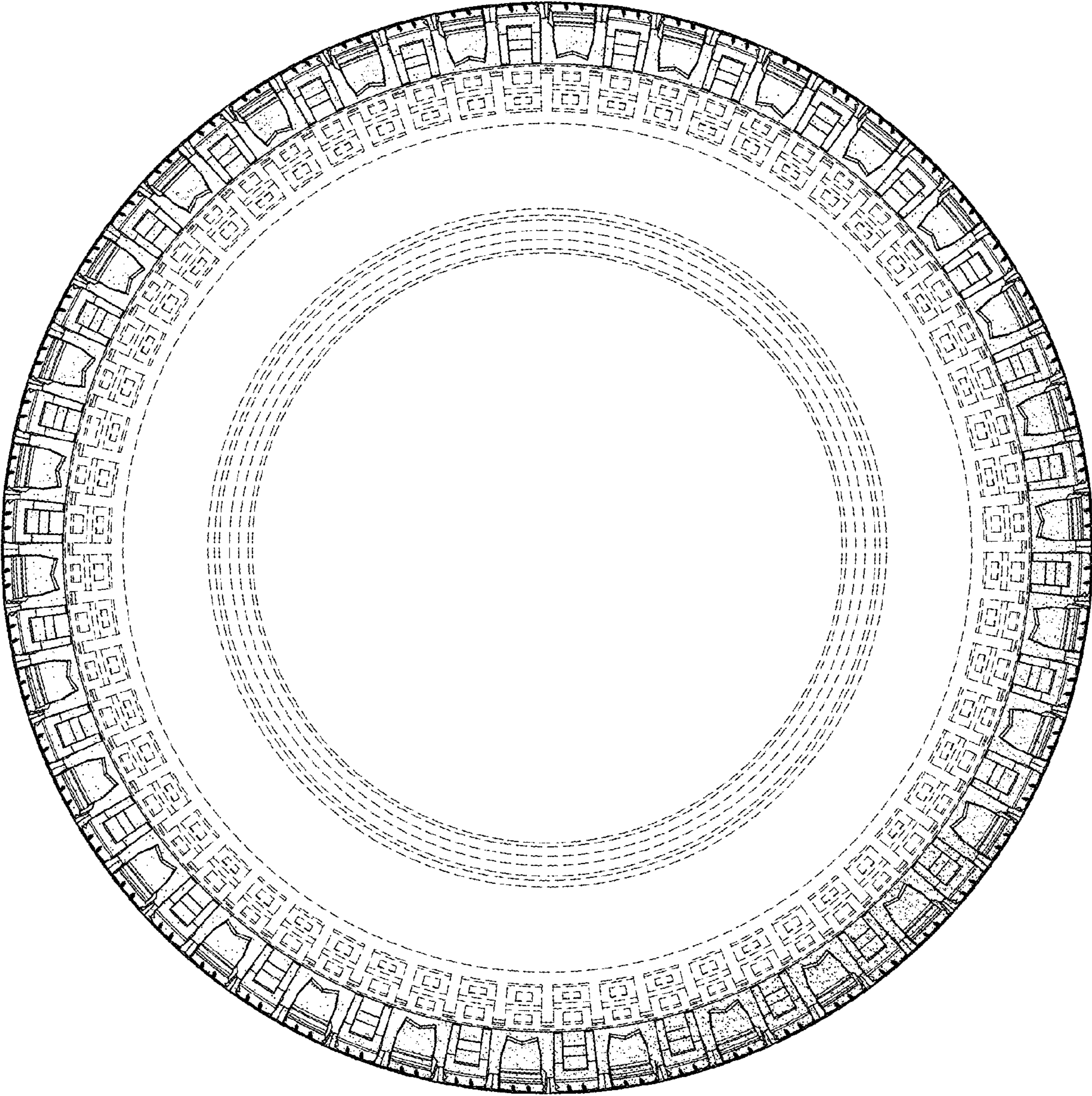

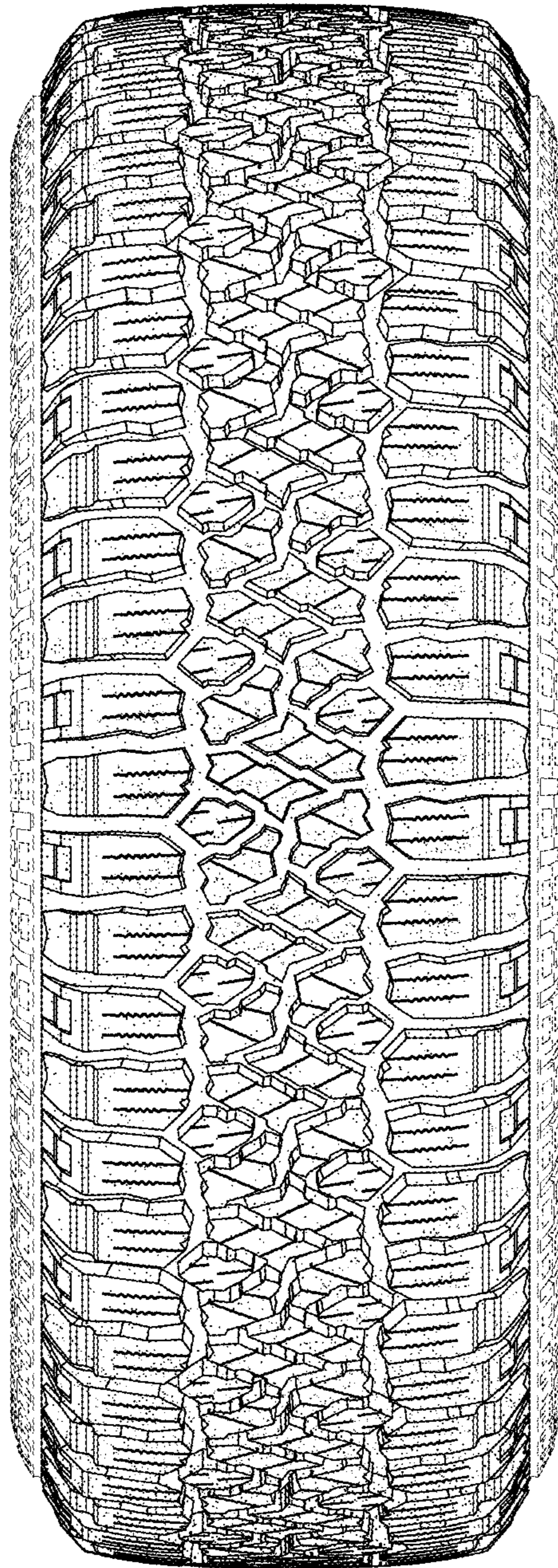

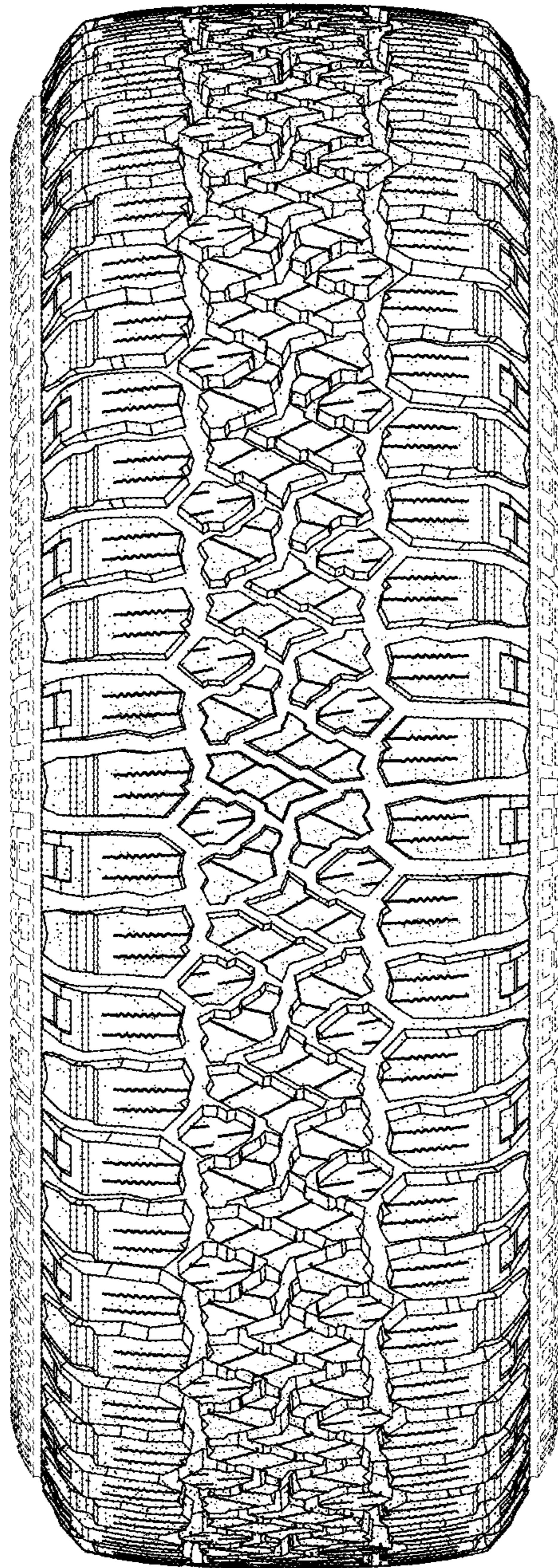

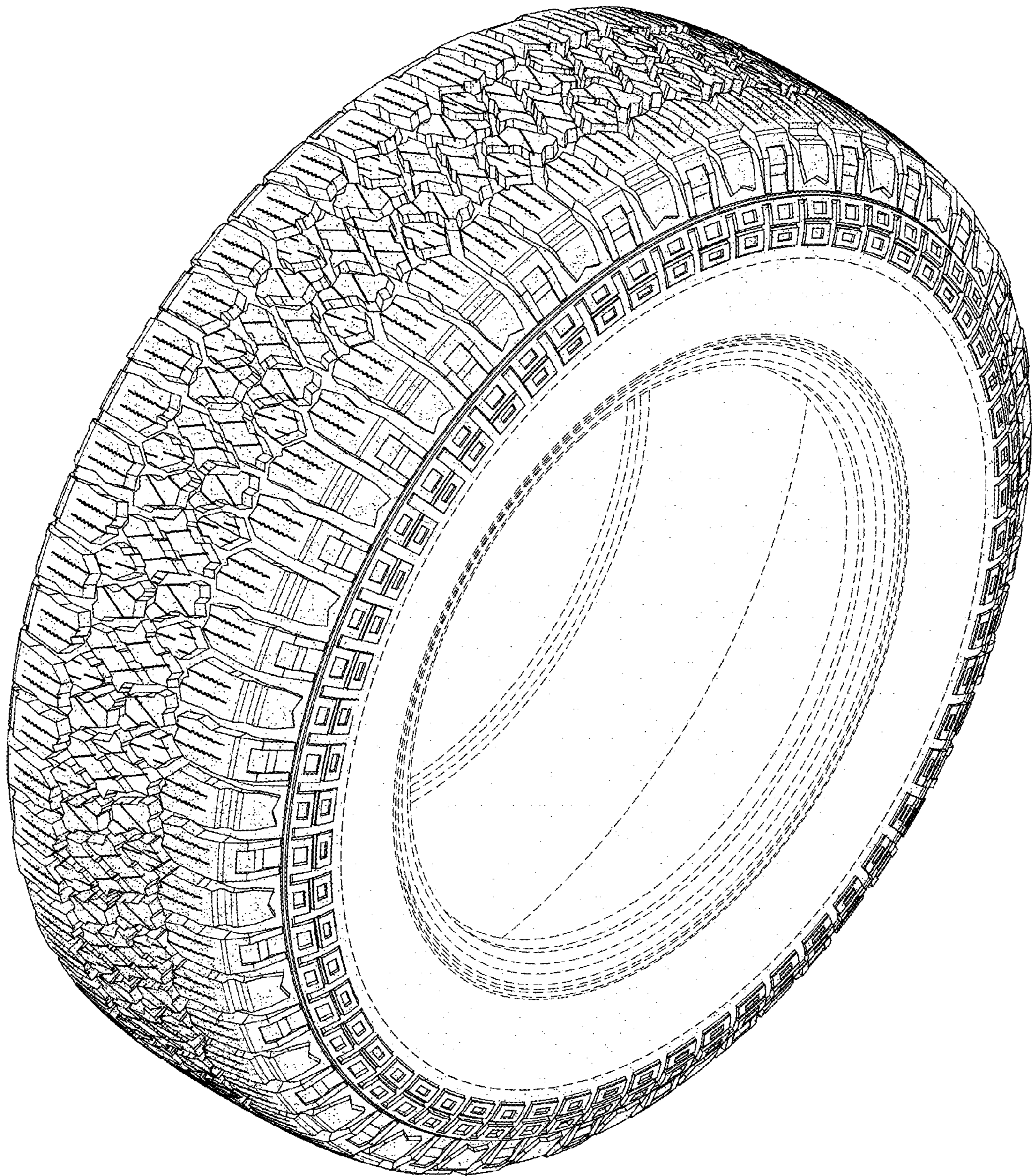

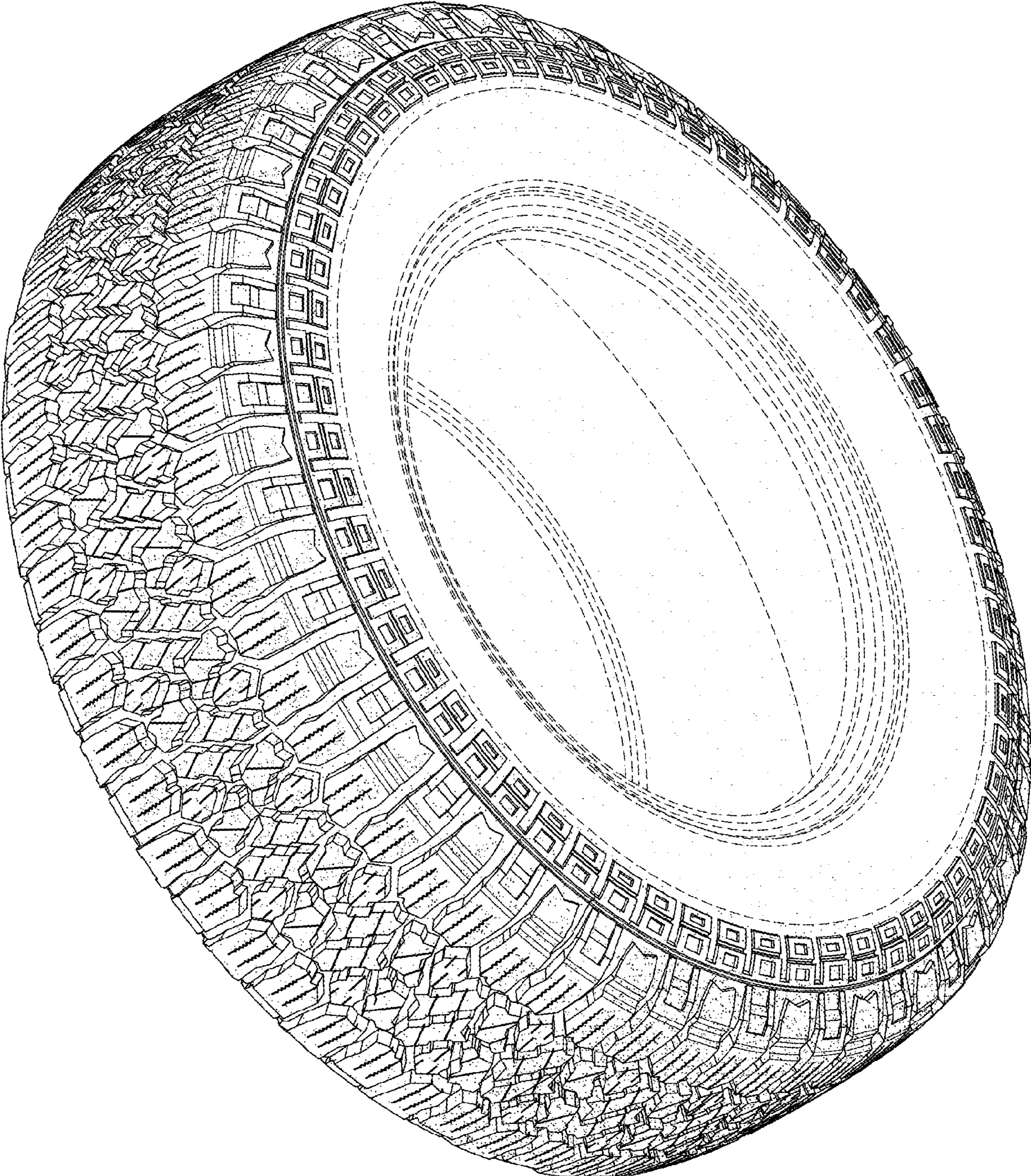
