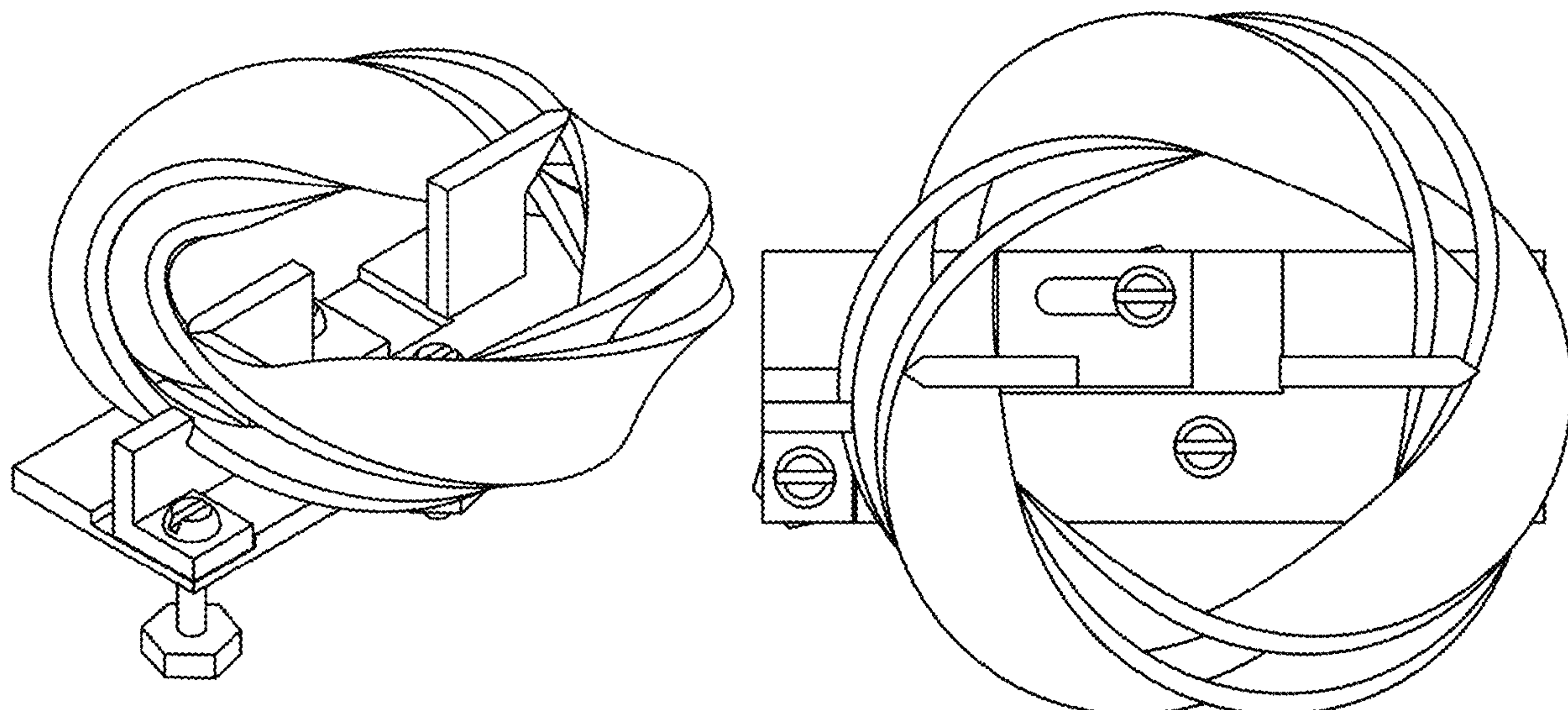
(57) **CLAIM**

The ornamental design for a double-negative metamaterial unit cell, as shown and described.

DESCRIPTION

FIG. 1 is a top-left-front perspective view of a double-negative metamaterial unit cell showing our new design; FIG. 2 is a top-right-front perspective view thereof; FIG. 3 is a top-left-rear perspective view thereof; FIG. 4 is a top-right-rear perspective view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

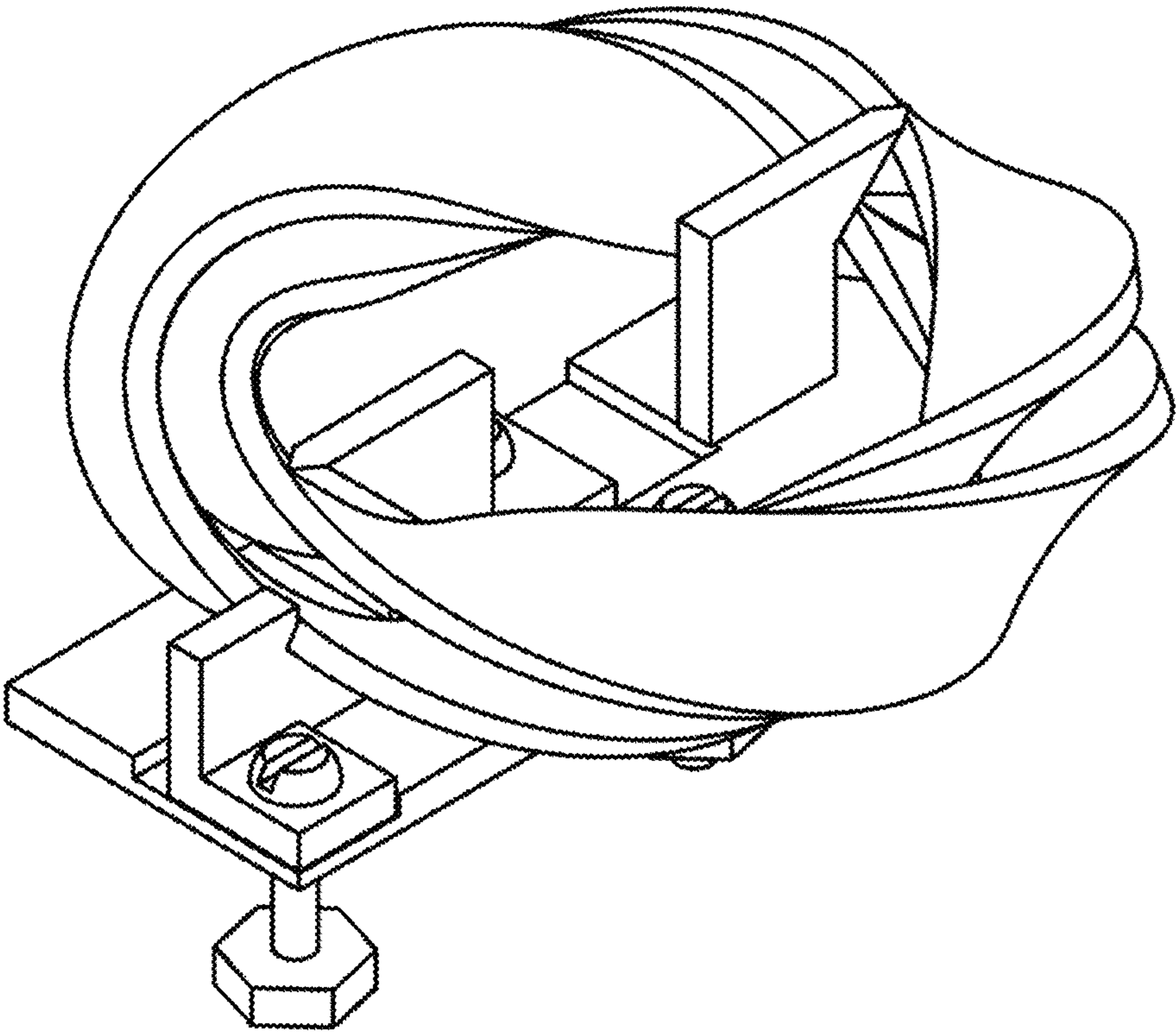

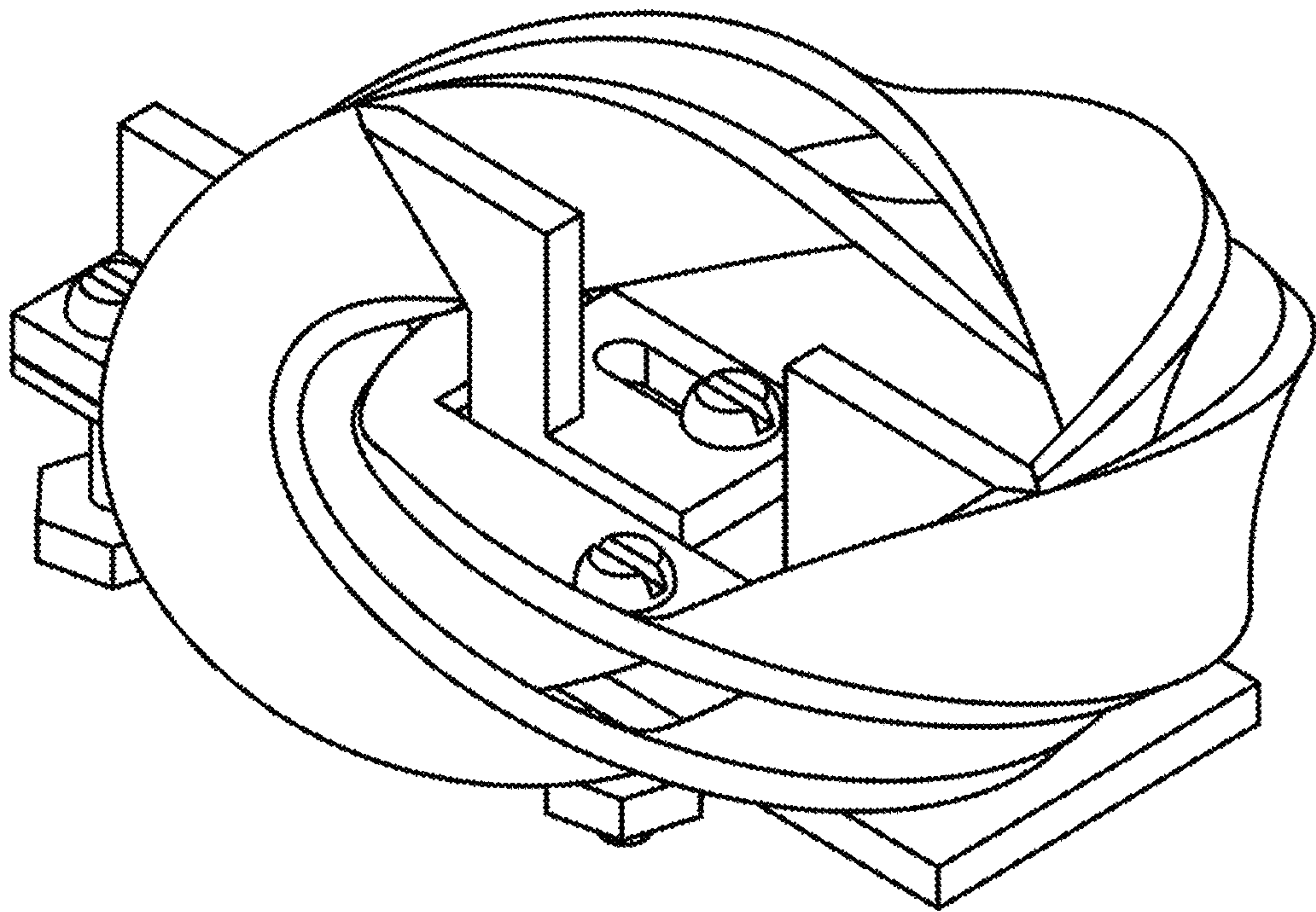

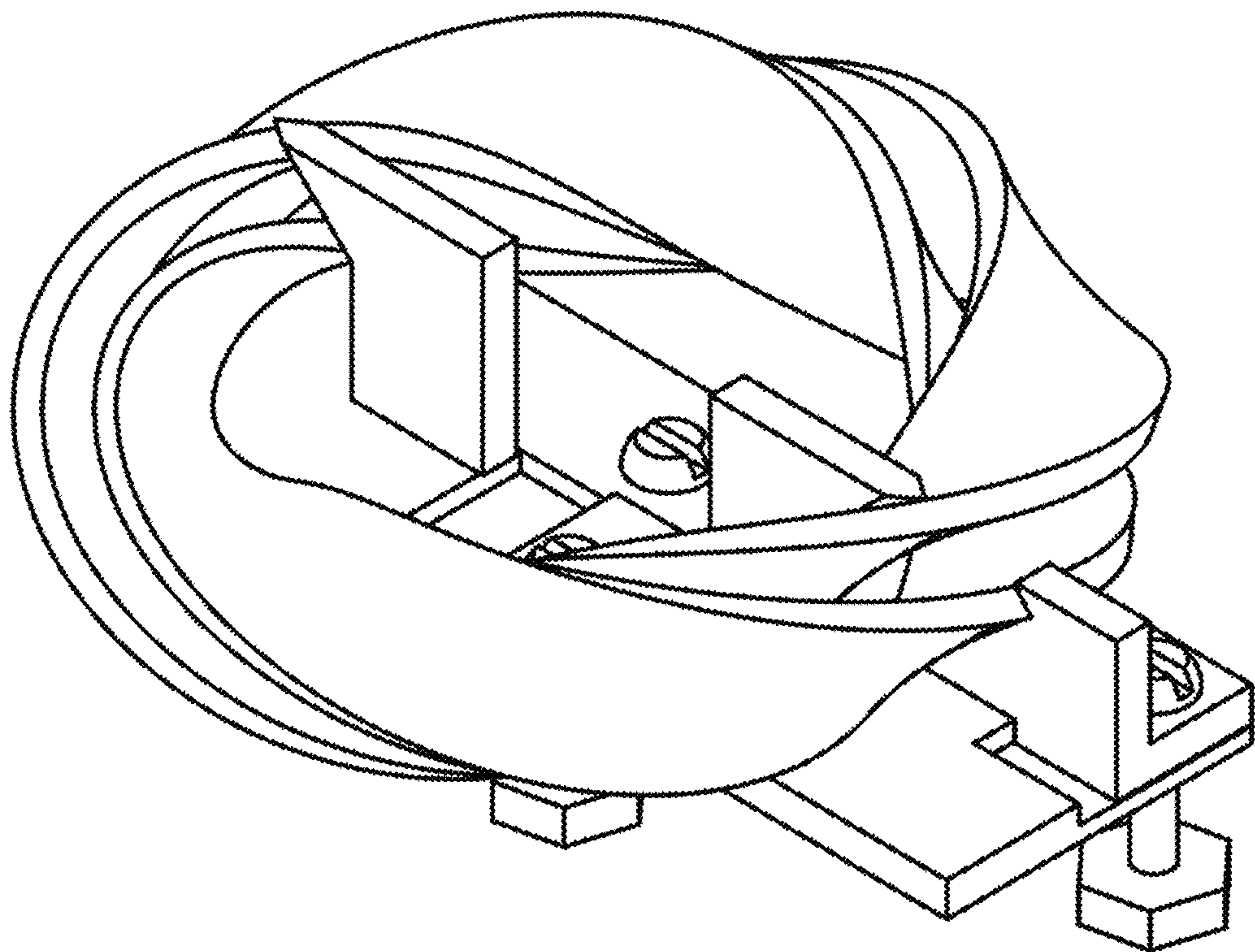

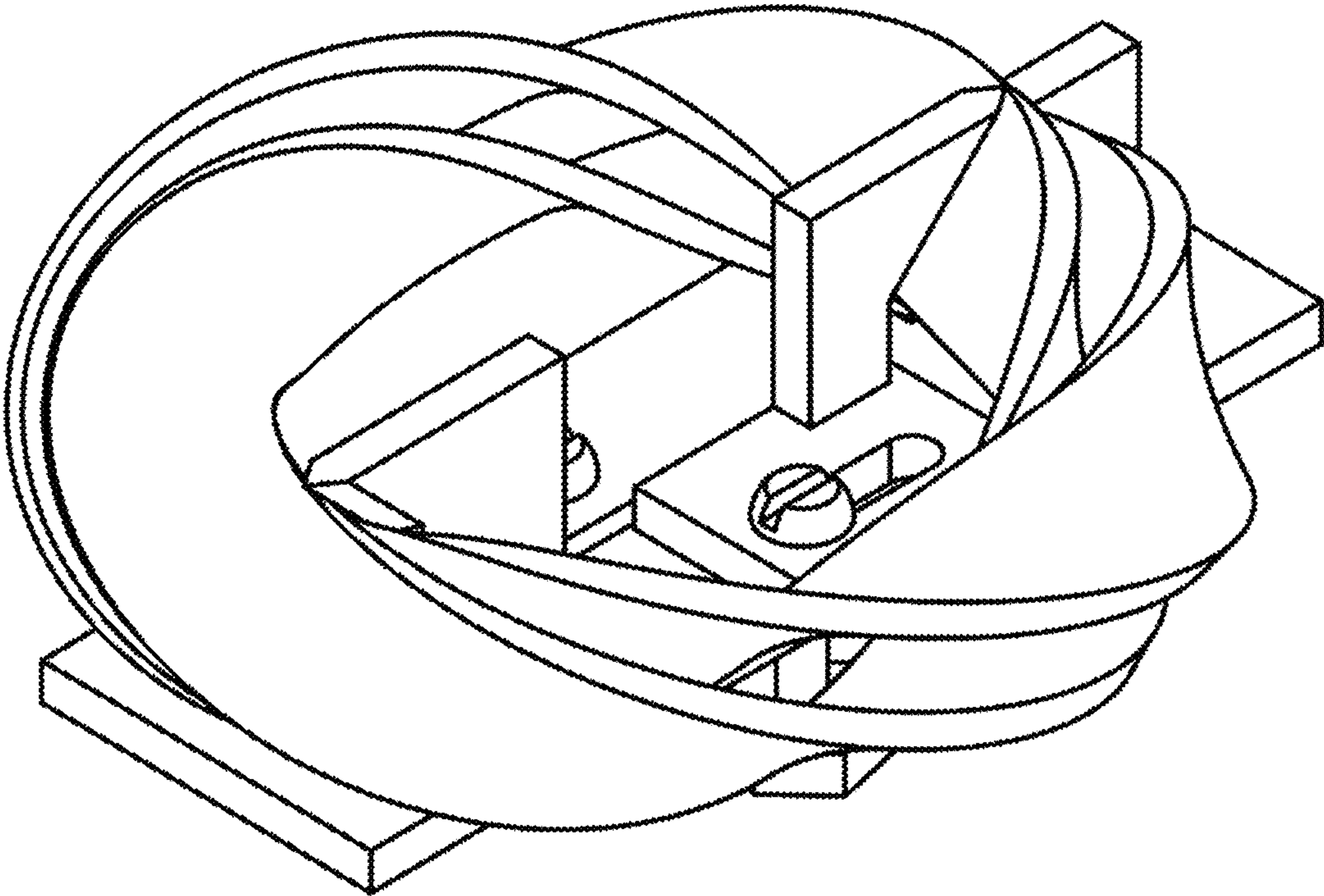

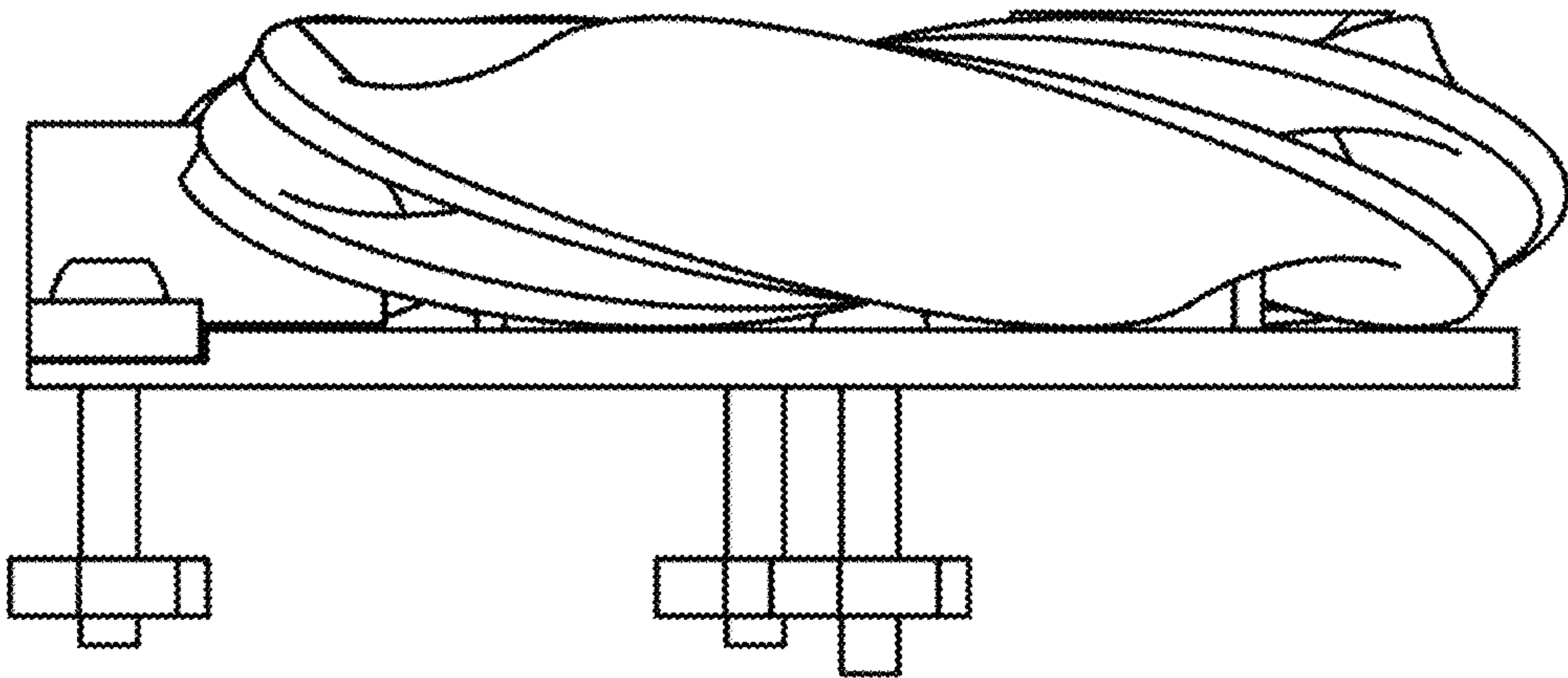

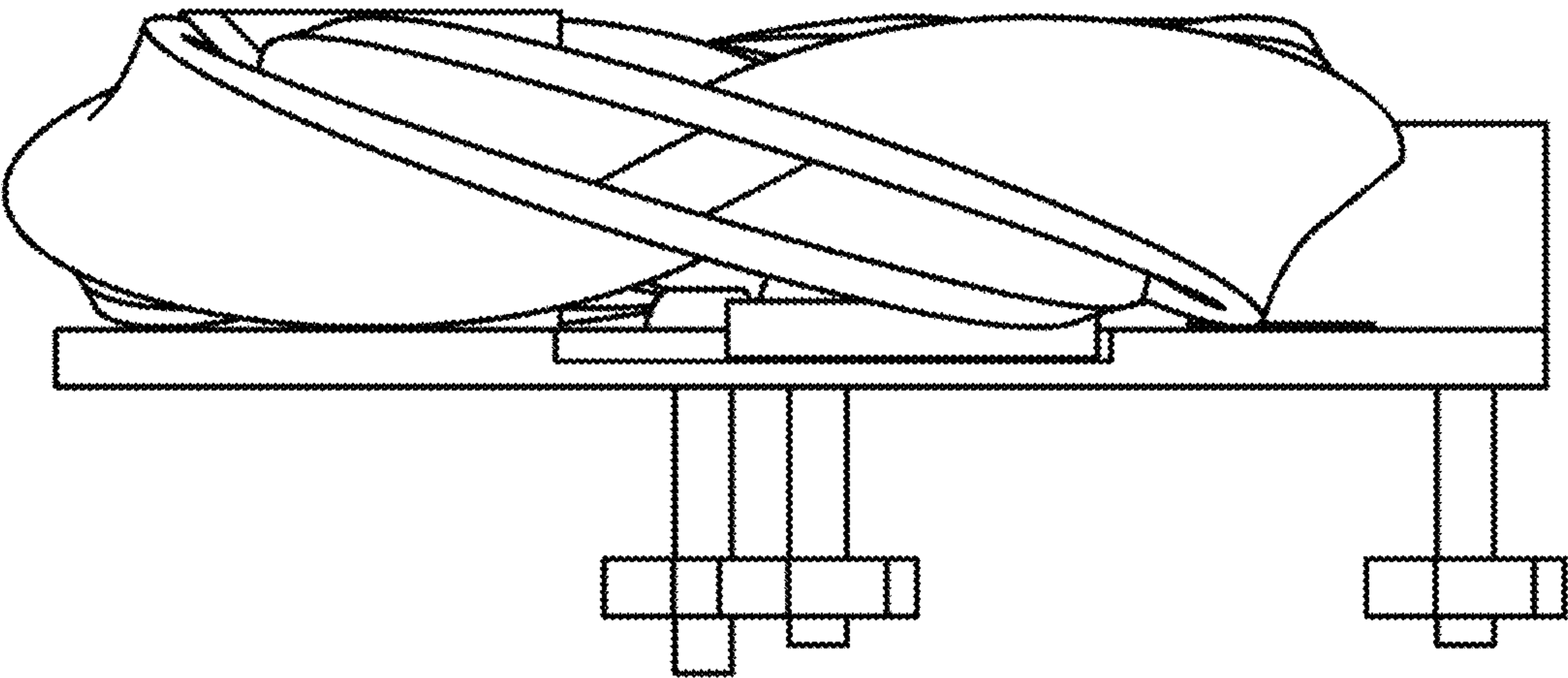

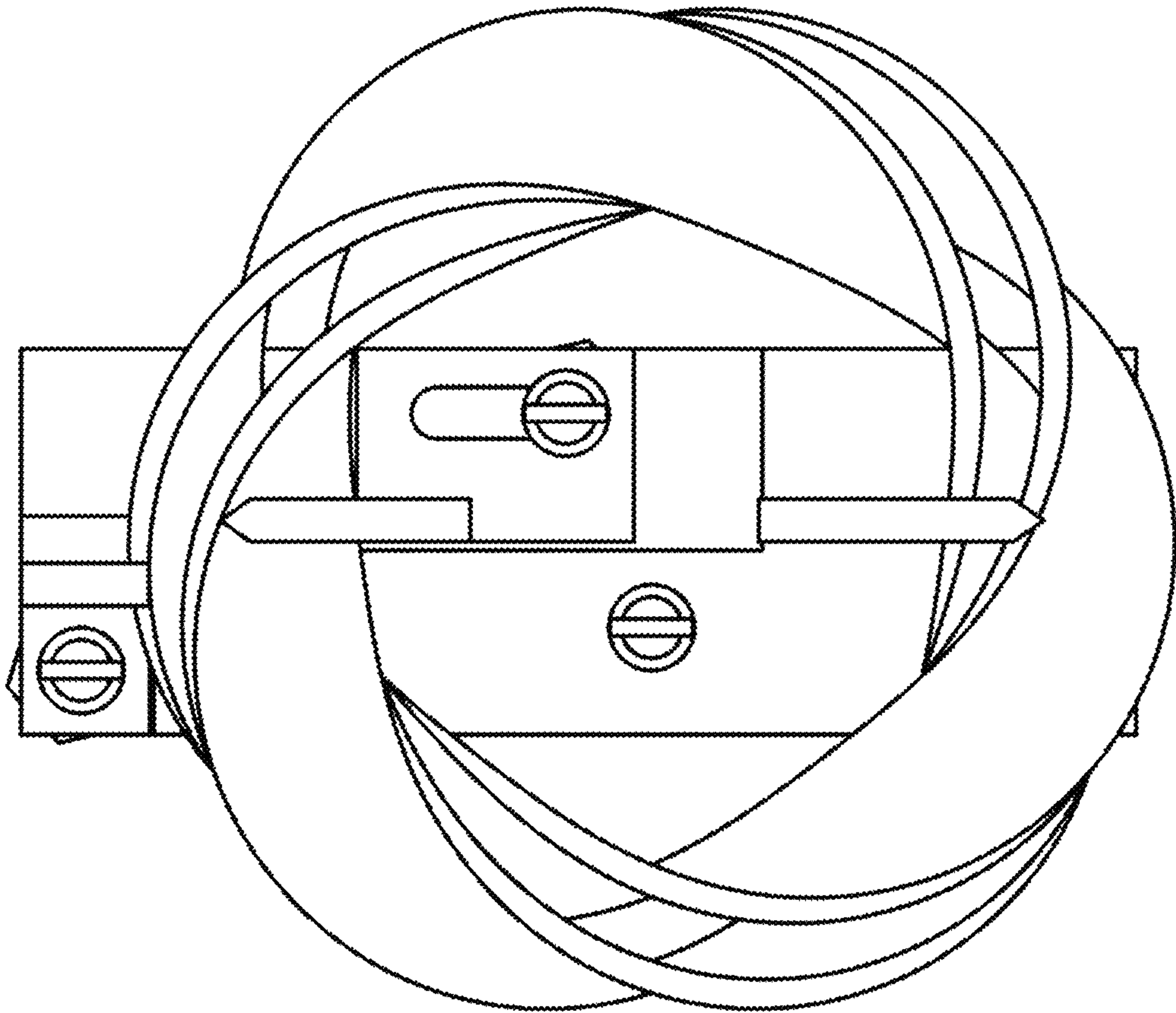

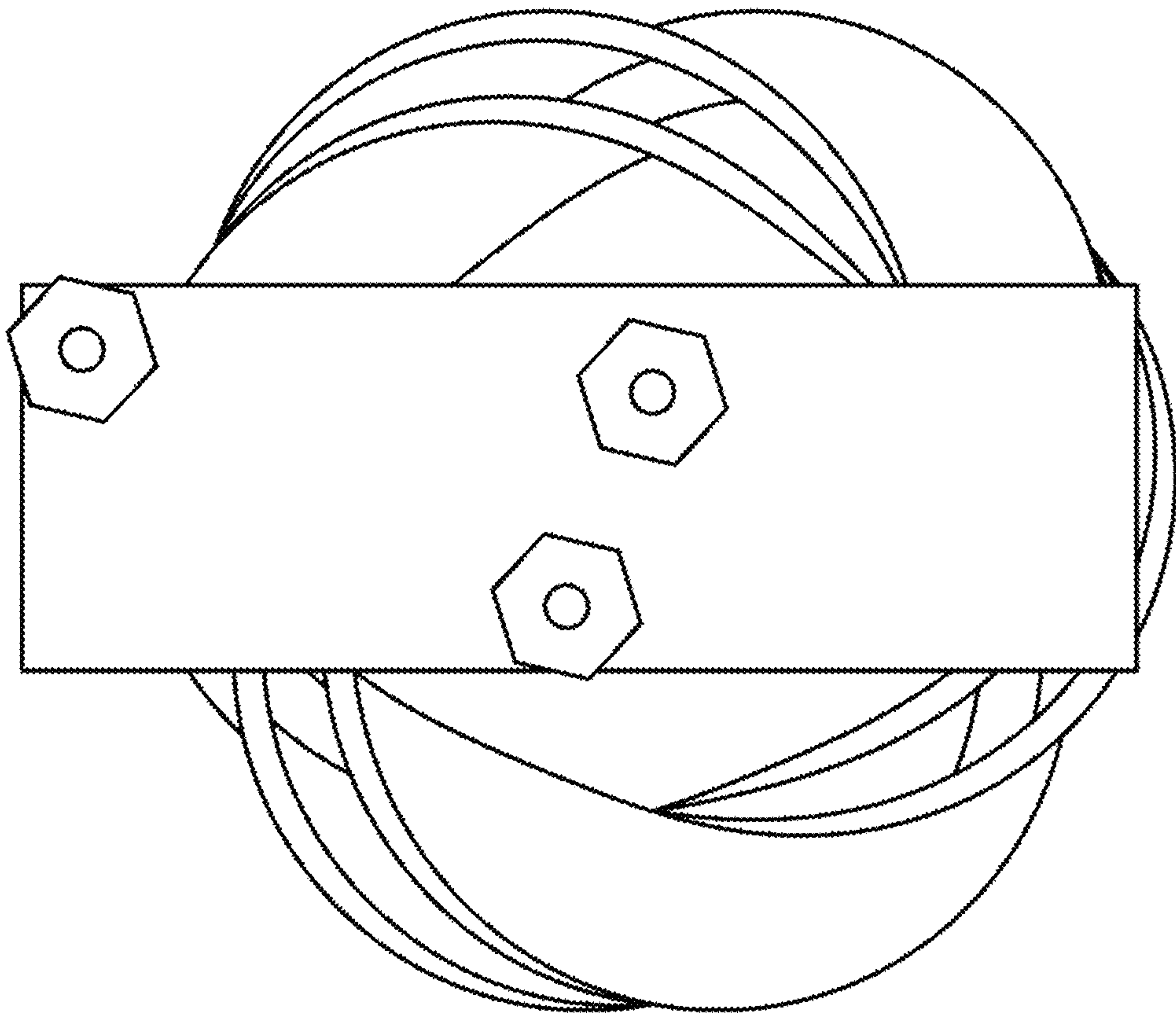
