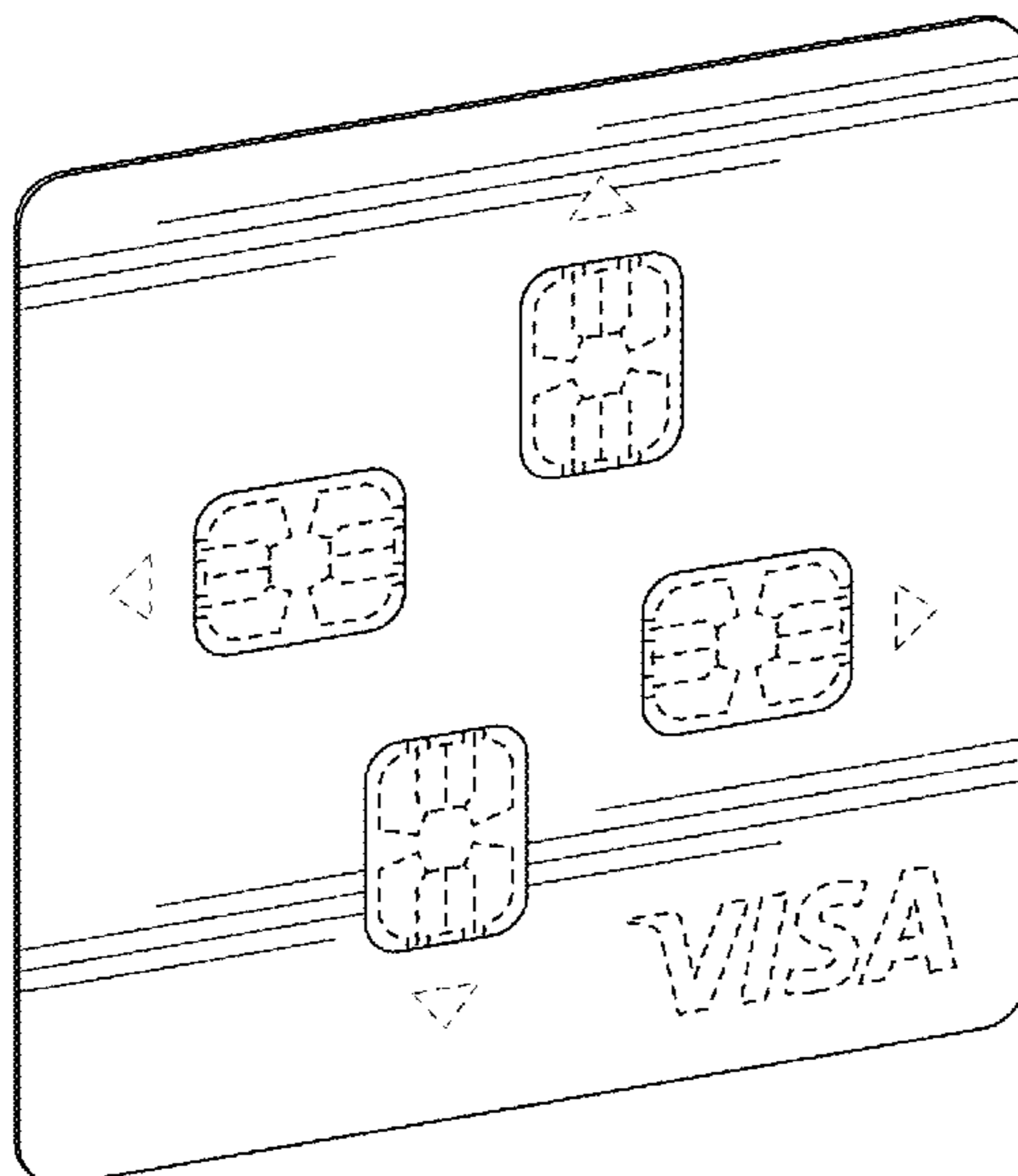
The ornamental design for an transaction card, as shown and described.

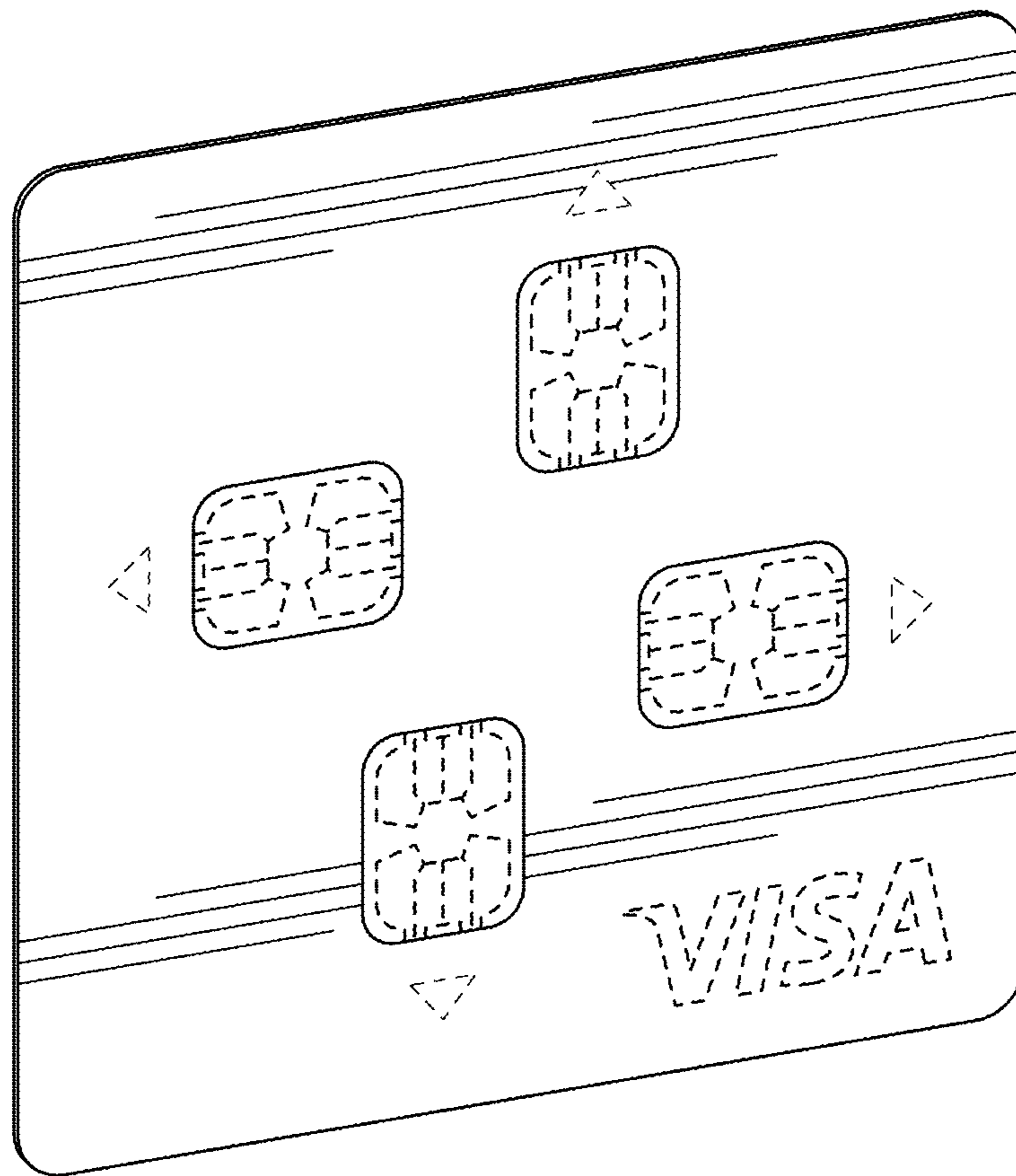

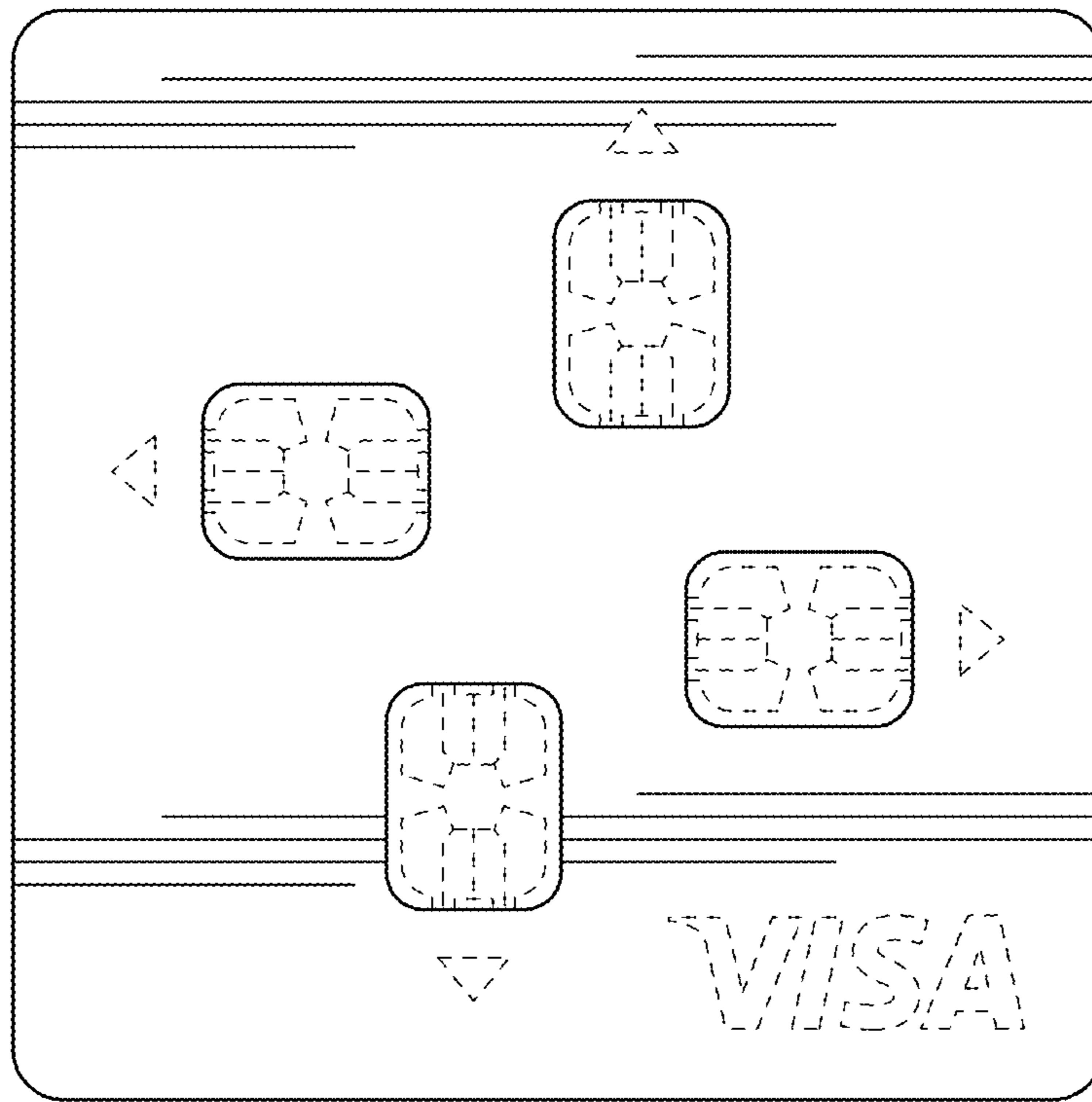

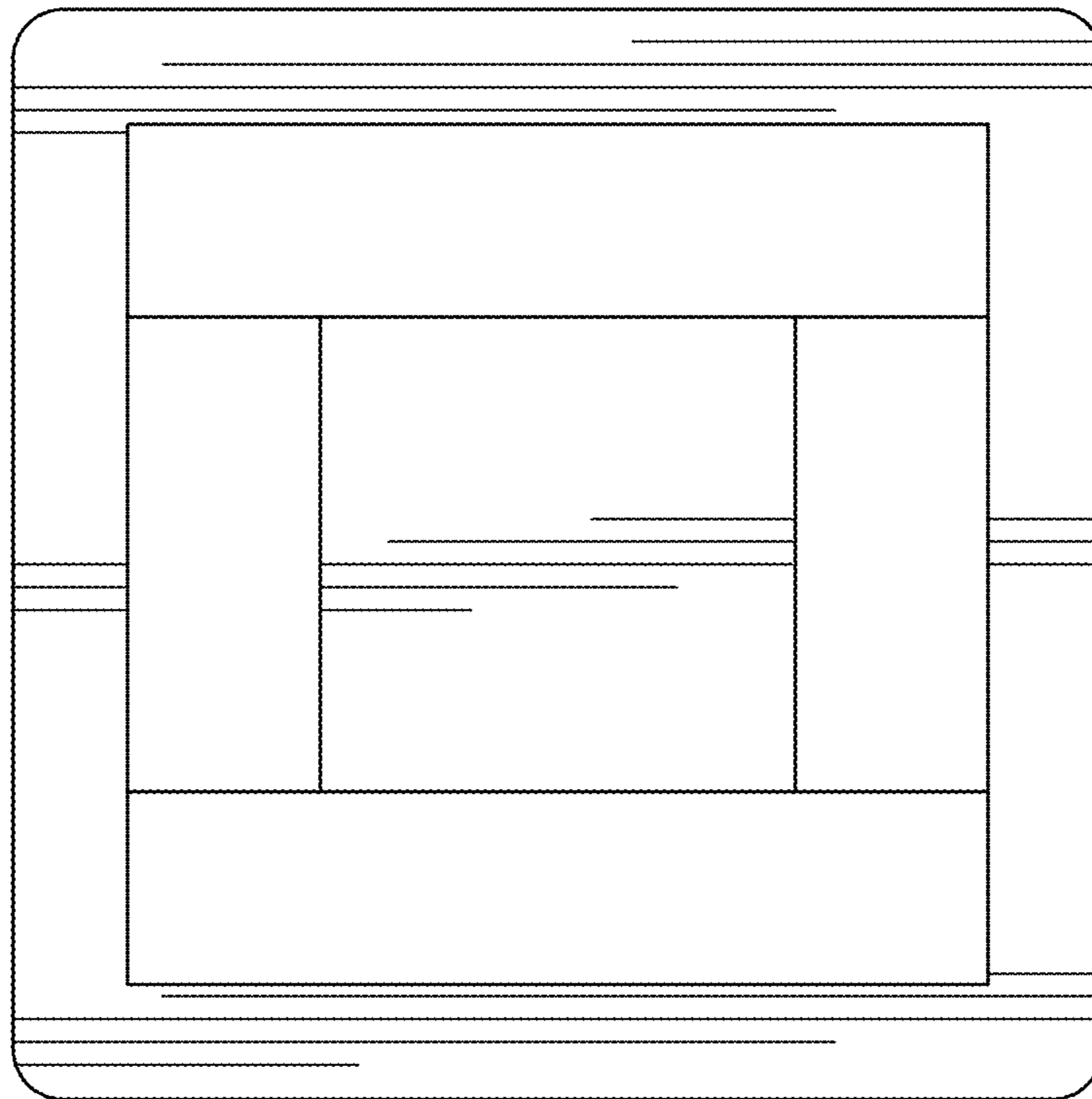
