(57) **CLAIM**

The ornamental design for a bread product with surface ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a bread product with surface ornamentation showing our new design, the rear elevation view being a mirror image thereof;

FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image thereof;


FIG. 4 is a top plan view thereof;








