(57) **CLAIM**

The ornamental design for an adjustable maternity gown, as shown and described above.

FIG. 1 shows a front elevation view of the adjustable maternity gown having a design in accordance with the present invention;

FIG. 2 shows another front elevation view of the bottom and top portions of the adjustable maternity gown in a separated condition having a design in accordance with the present invention;

FIG. 3 shows a back elevation view of the adjustable maternity gown having a design in accordance with the present invention;

FIG. 4 shows another back elevation view of the bottom and top portions of the adjustable maternity gown in a separated condition having a design in accordance with the present invention;

FIG. 5 shows a right elevation view of the adjustable maternity gown having a design in accordance with of the present invention;

FIG. 6 shows another right elevation view of the bottom and top portions of the adjustable maternity gown in a separated condition having a design in accordance with of the present invention;

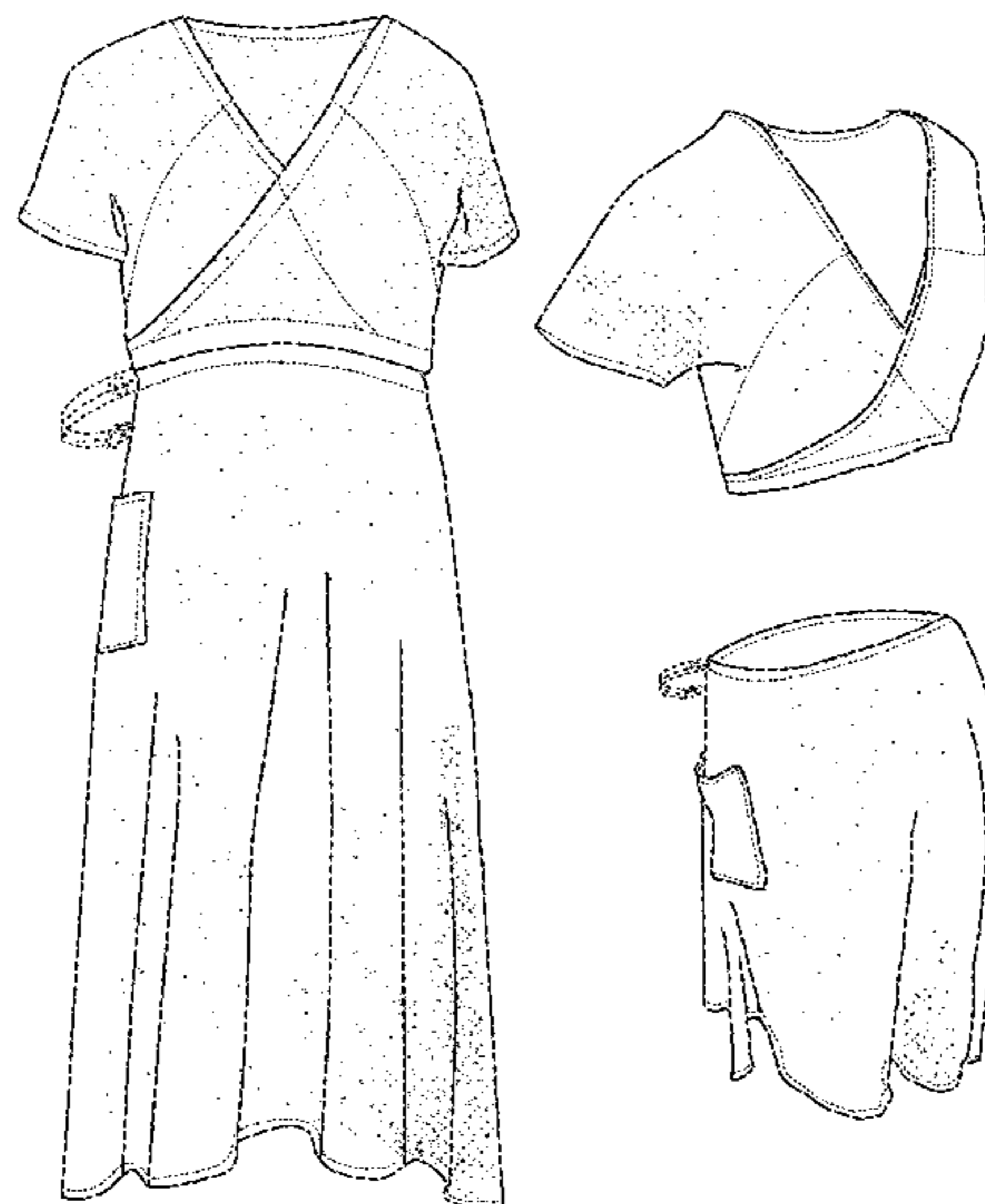
FIG. 7 shows a left elevation view of the adjustable maternity gown having a design in accordance with of the present invention;

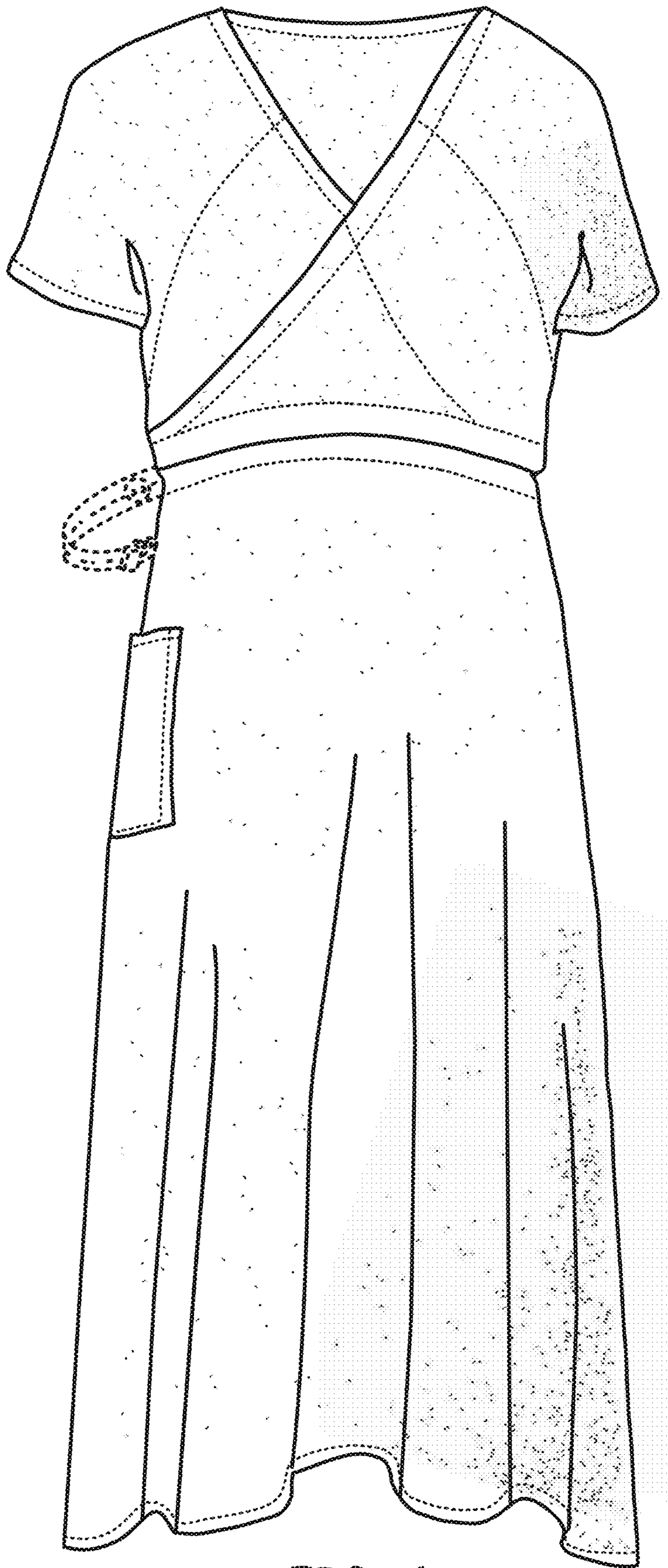

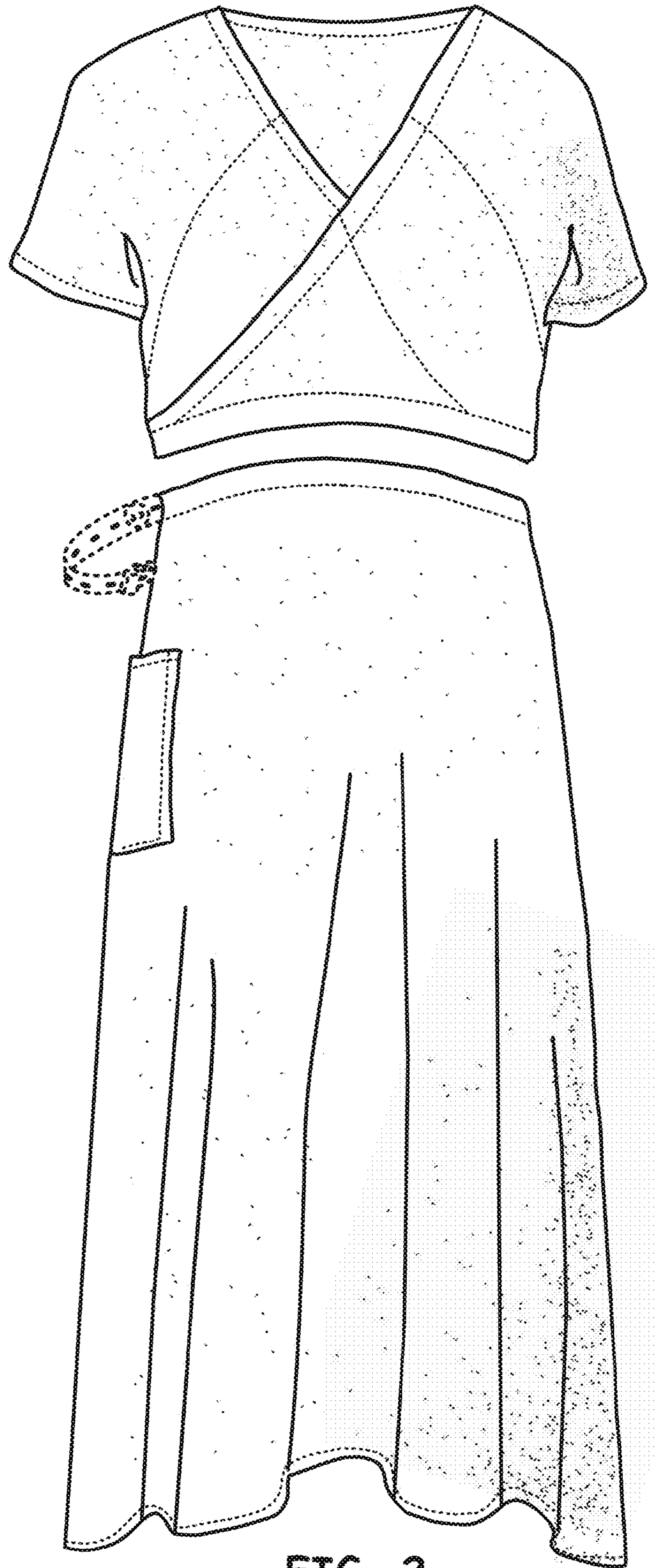

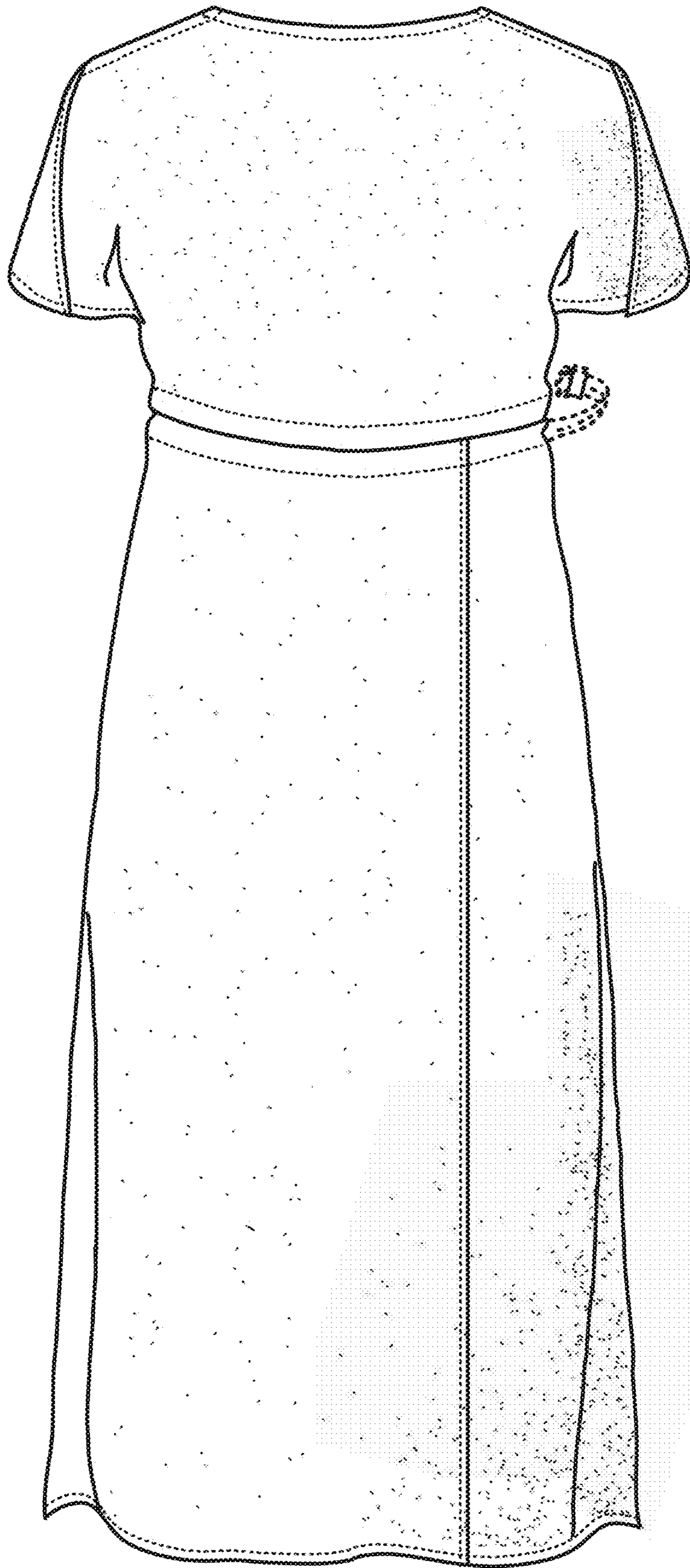

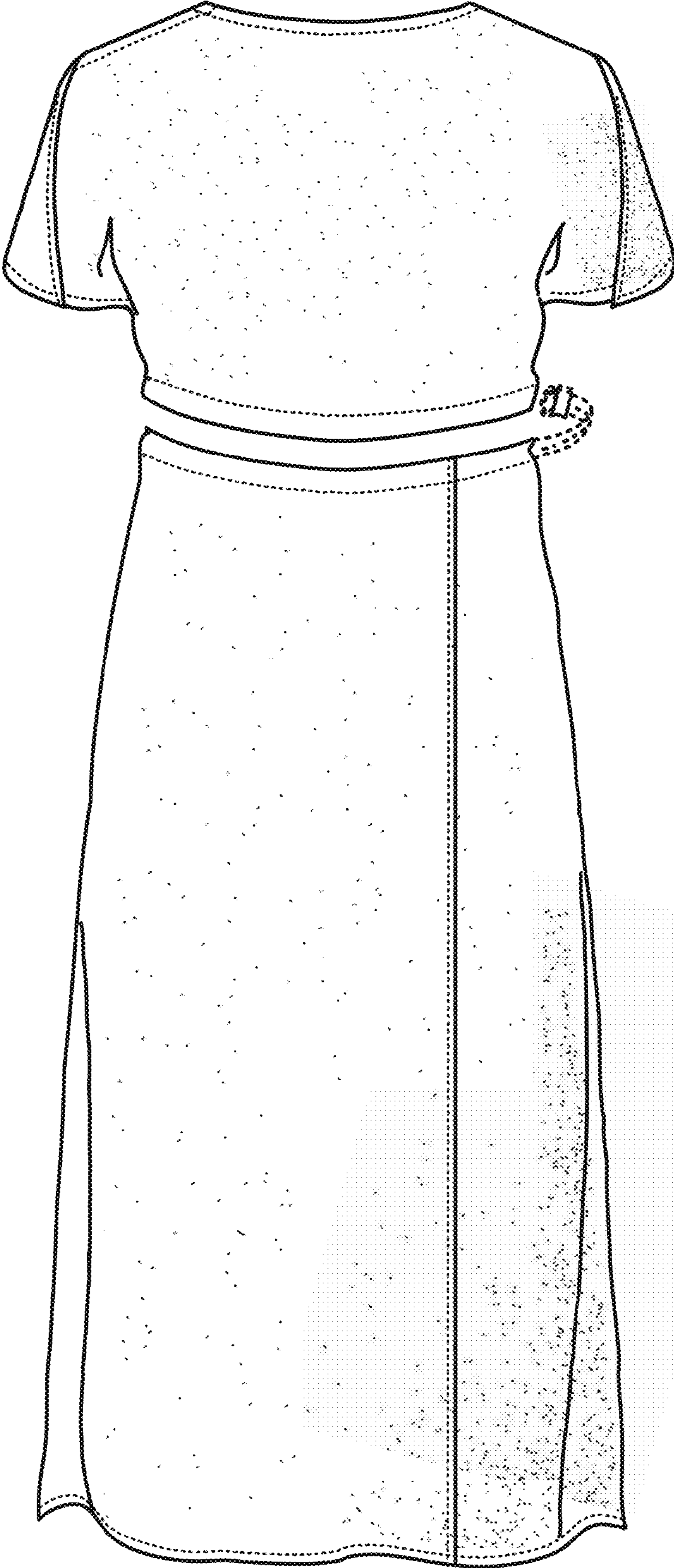

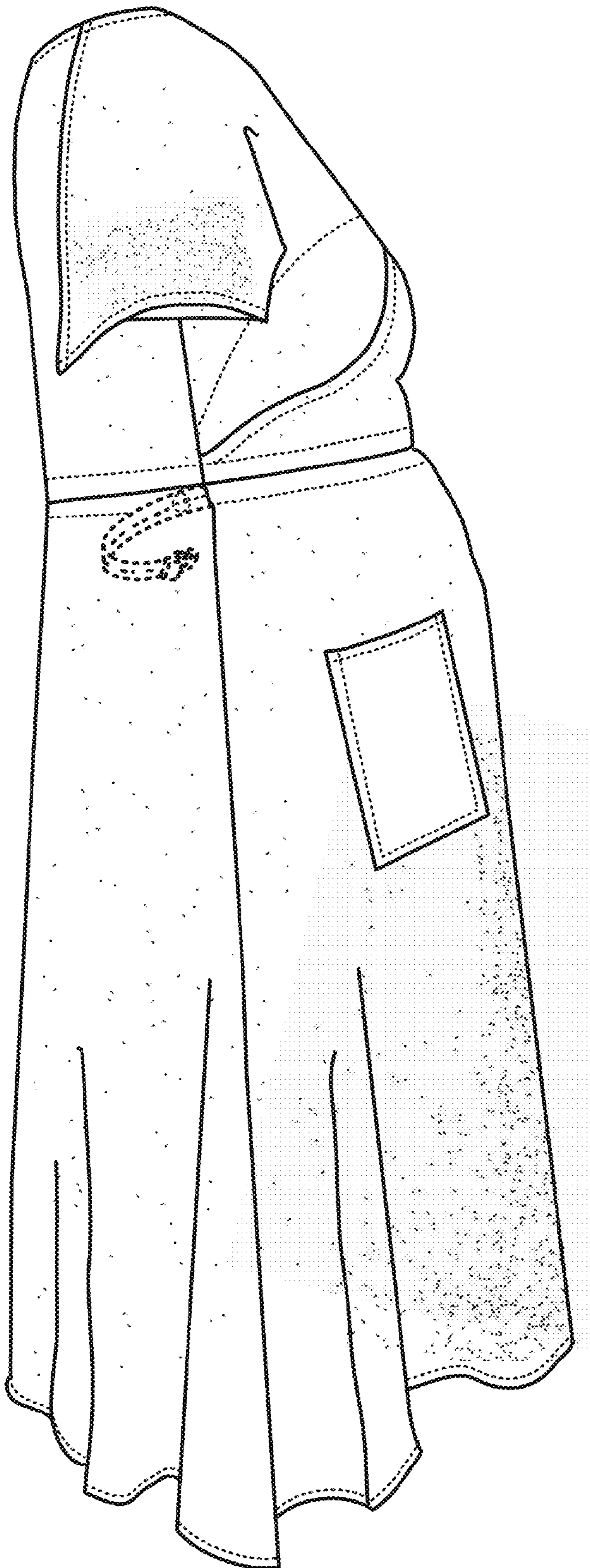

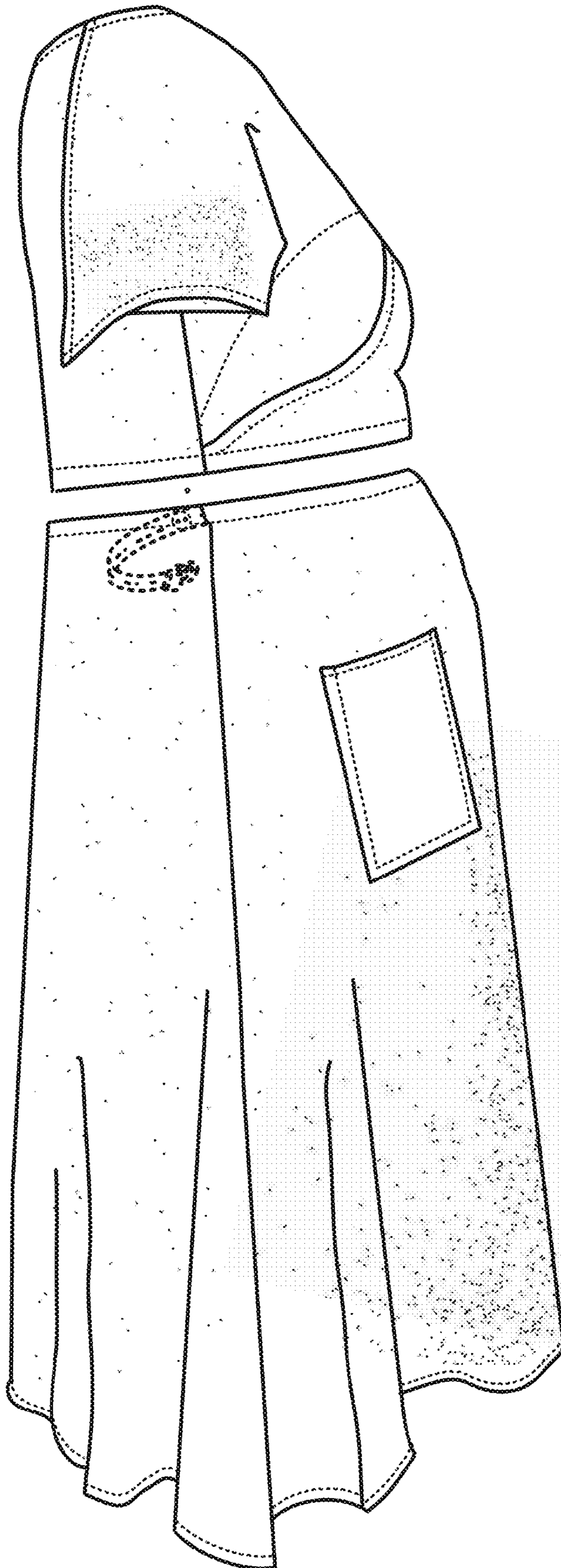

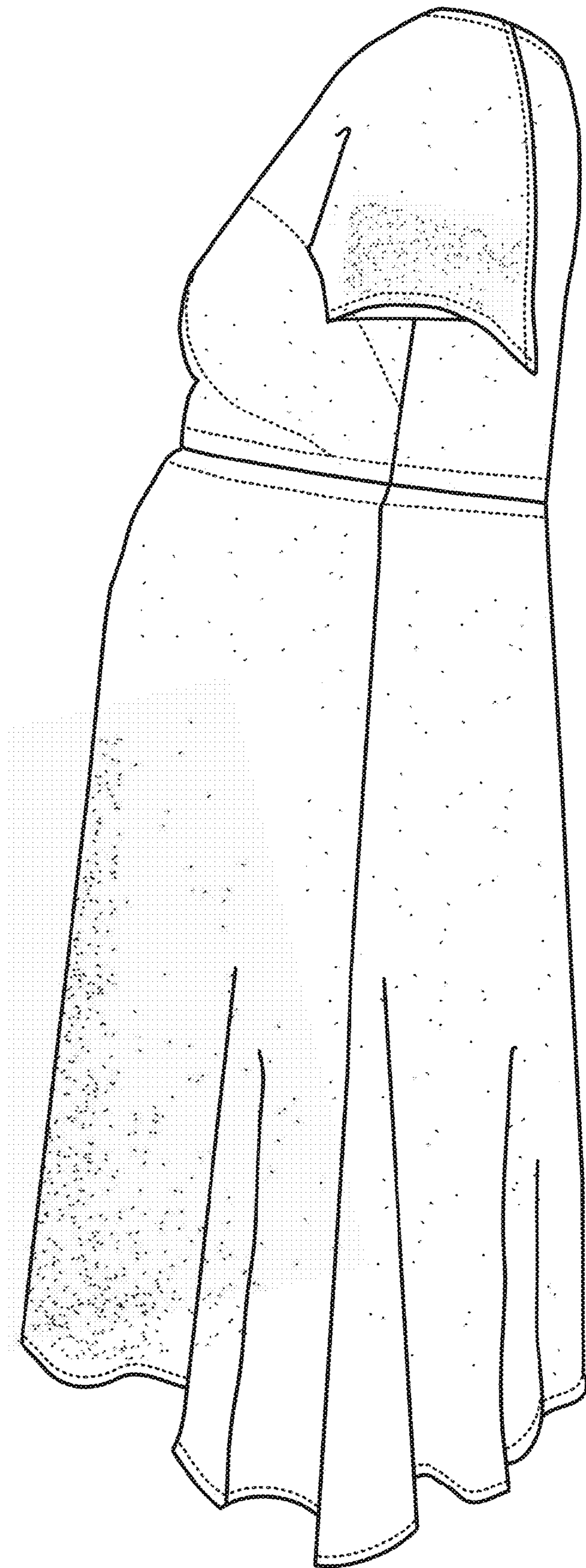

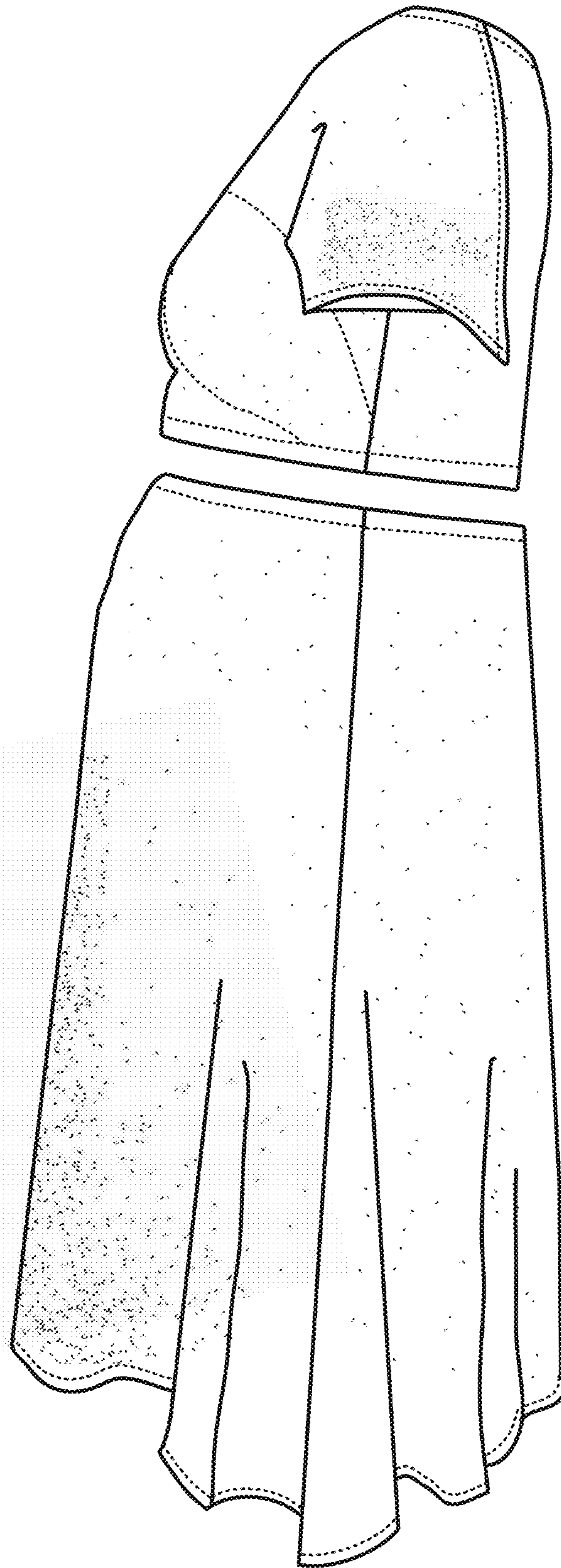

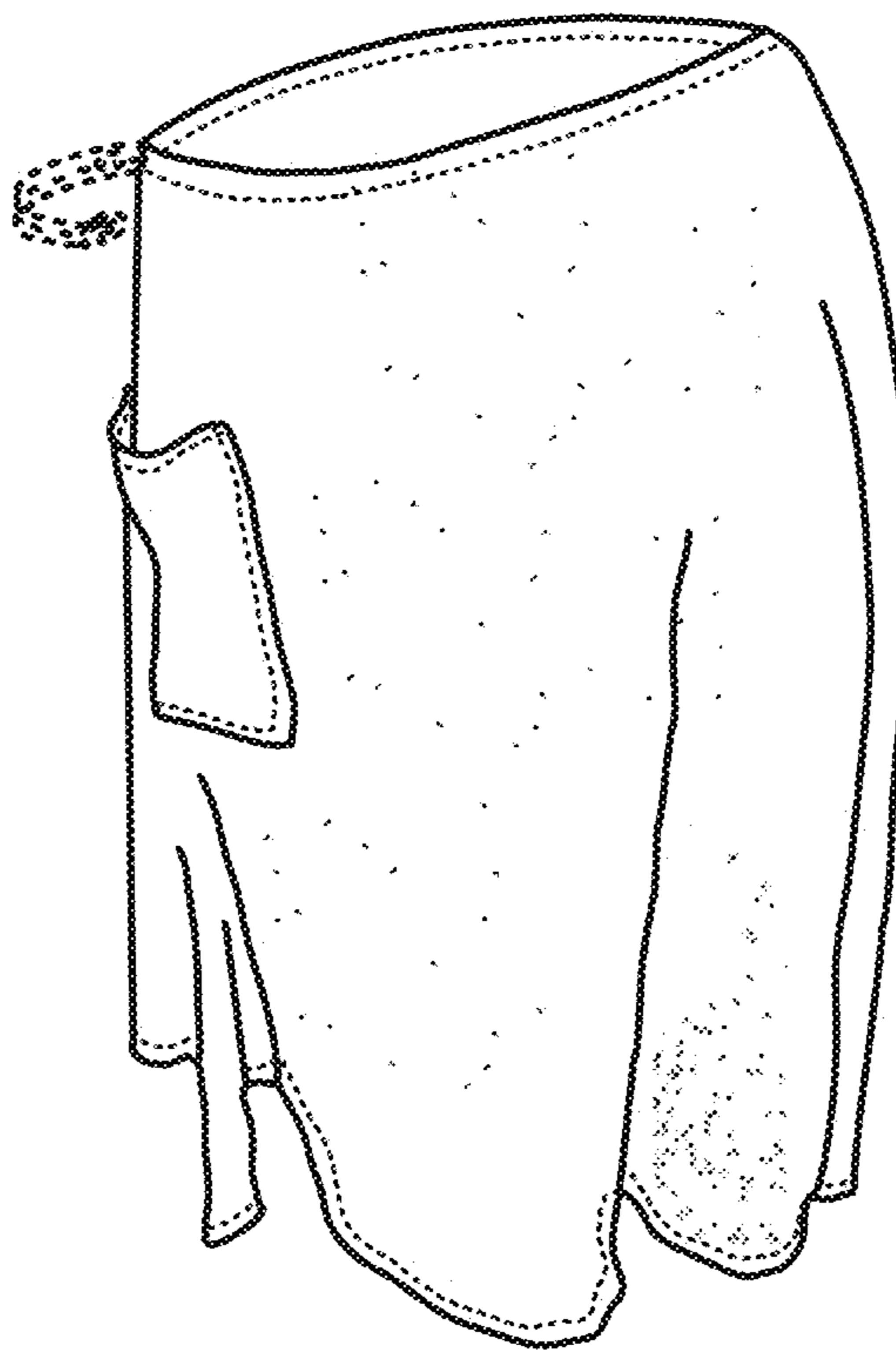
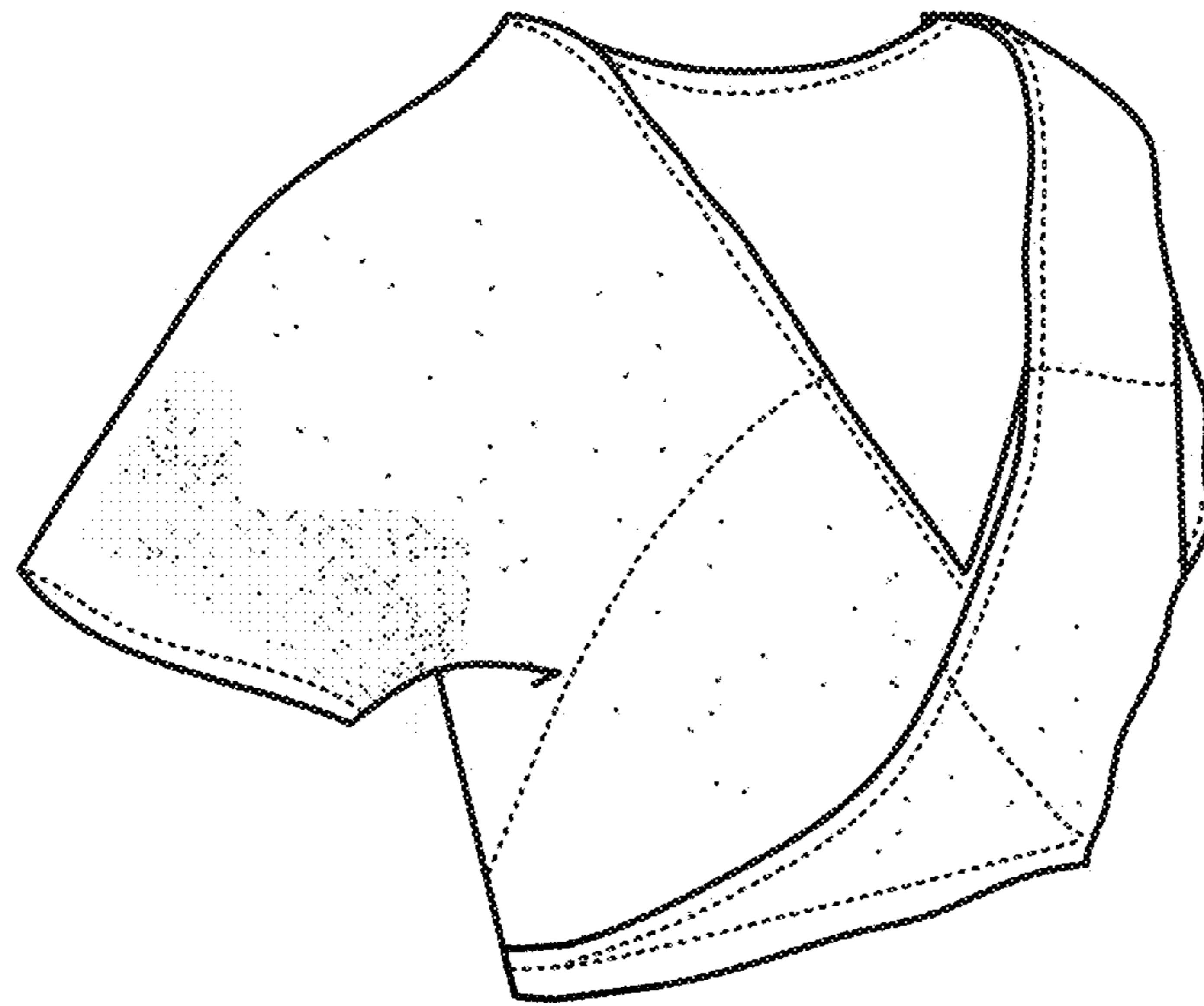

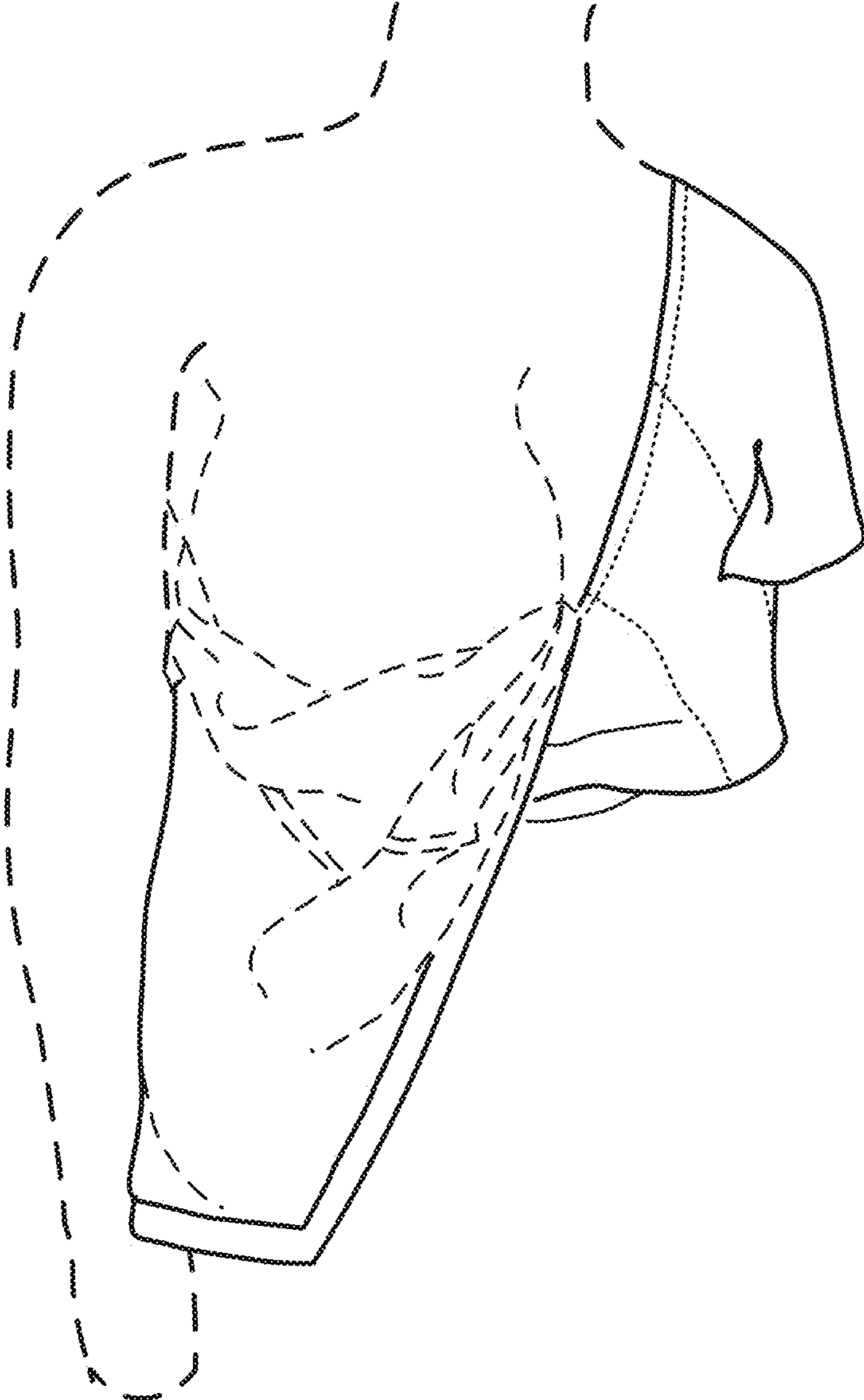
