design;

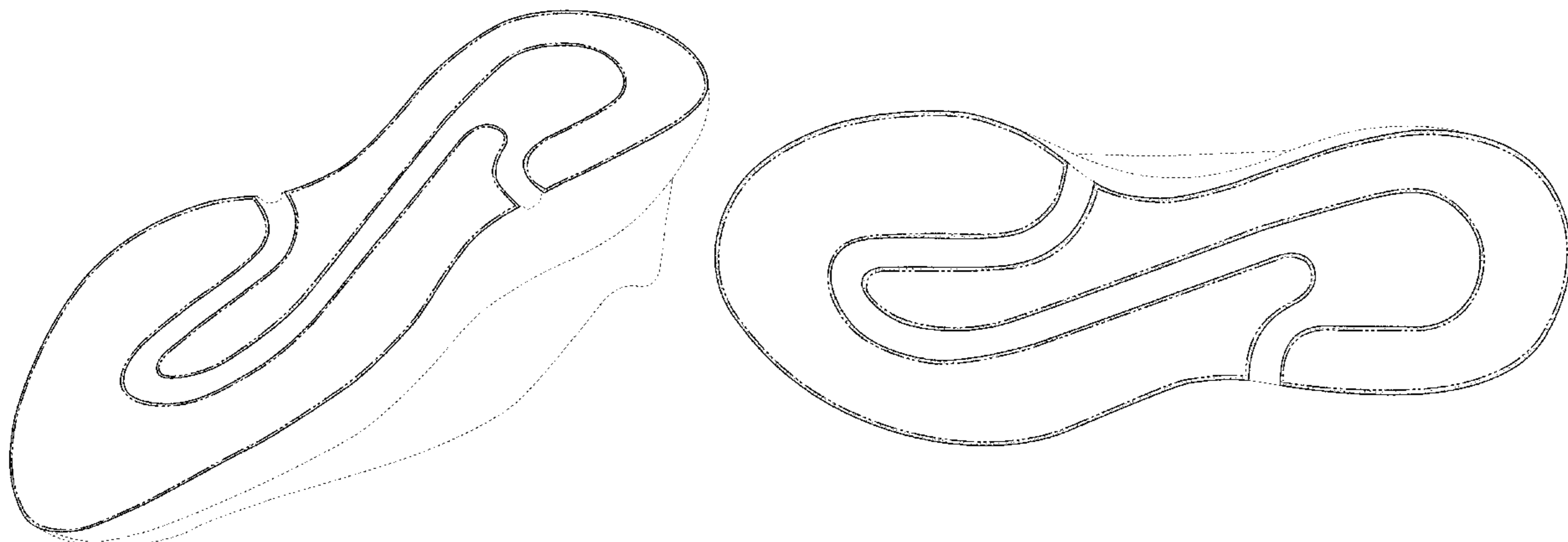
FIG. 2 is a bottom view thereof; and,

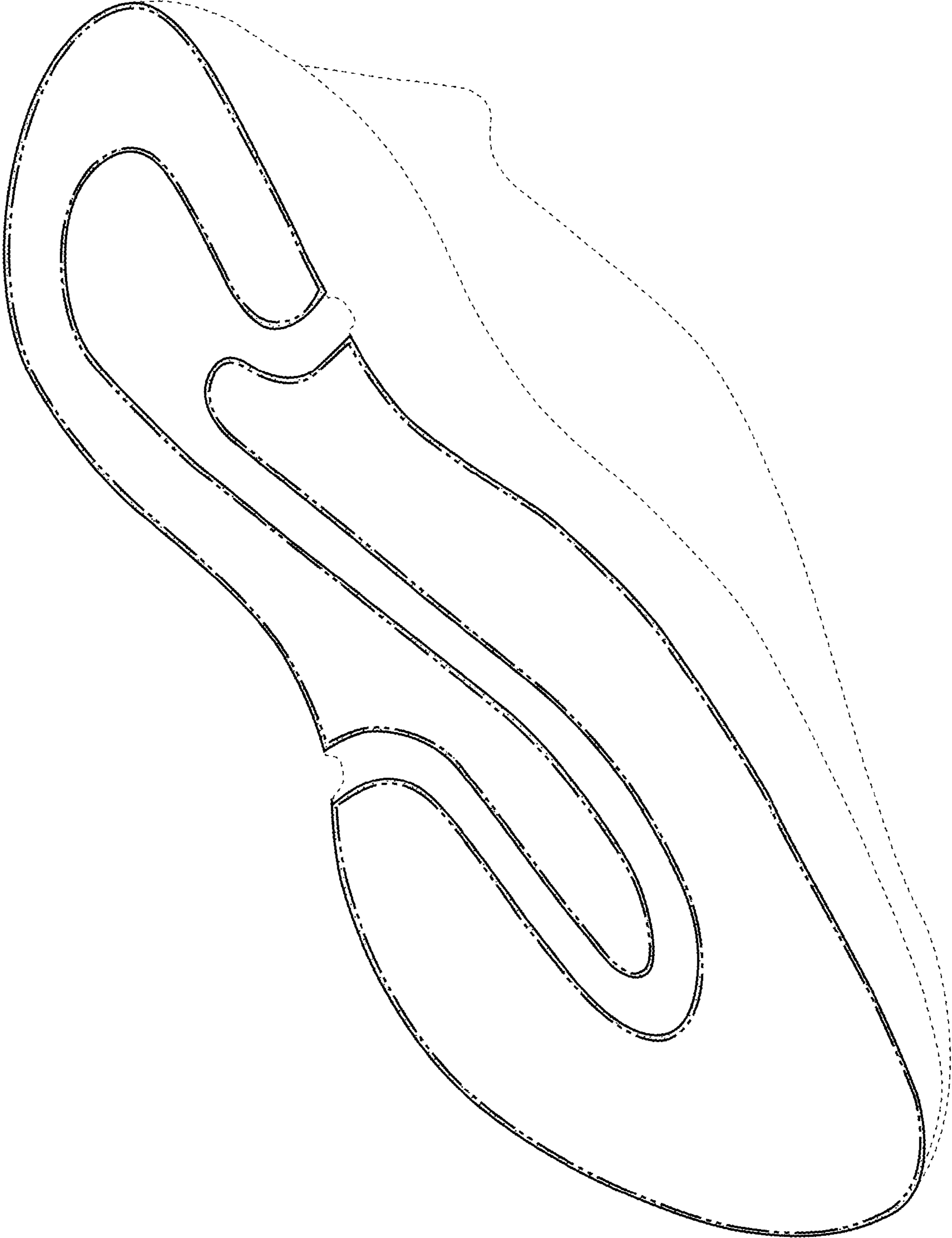

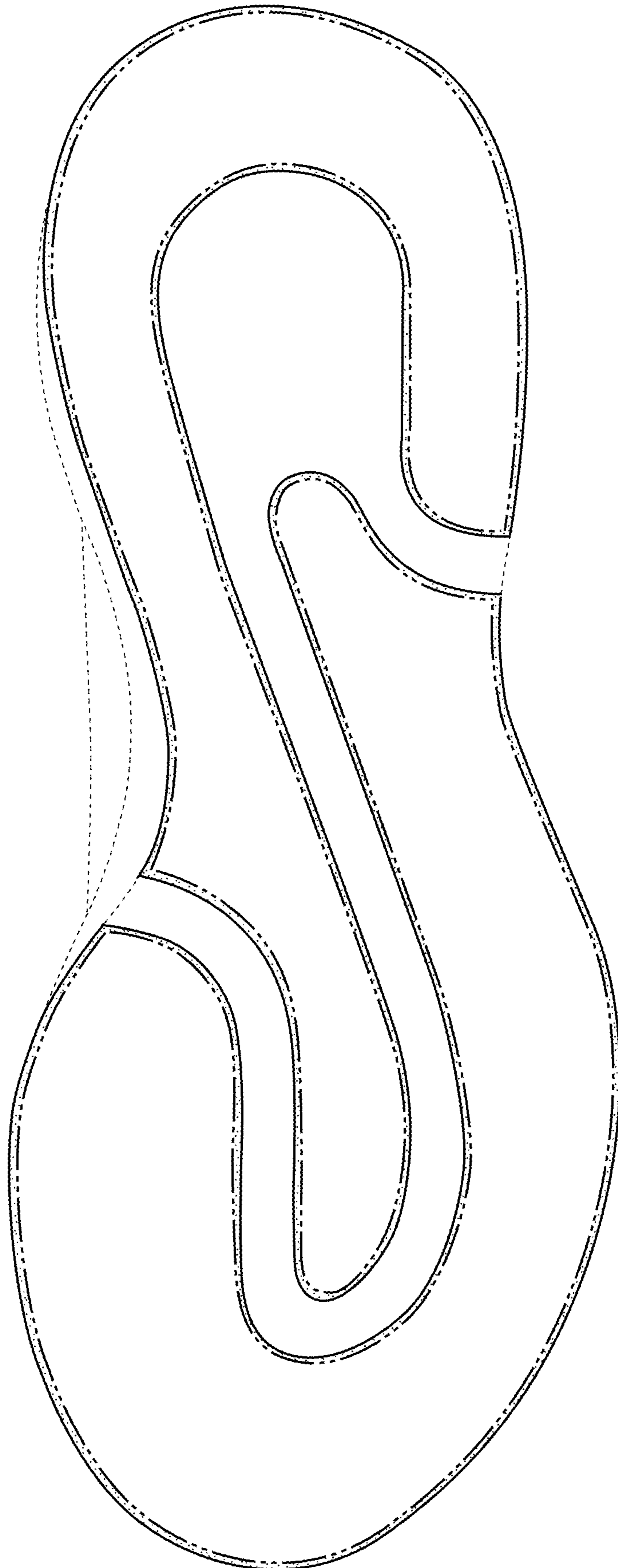

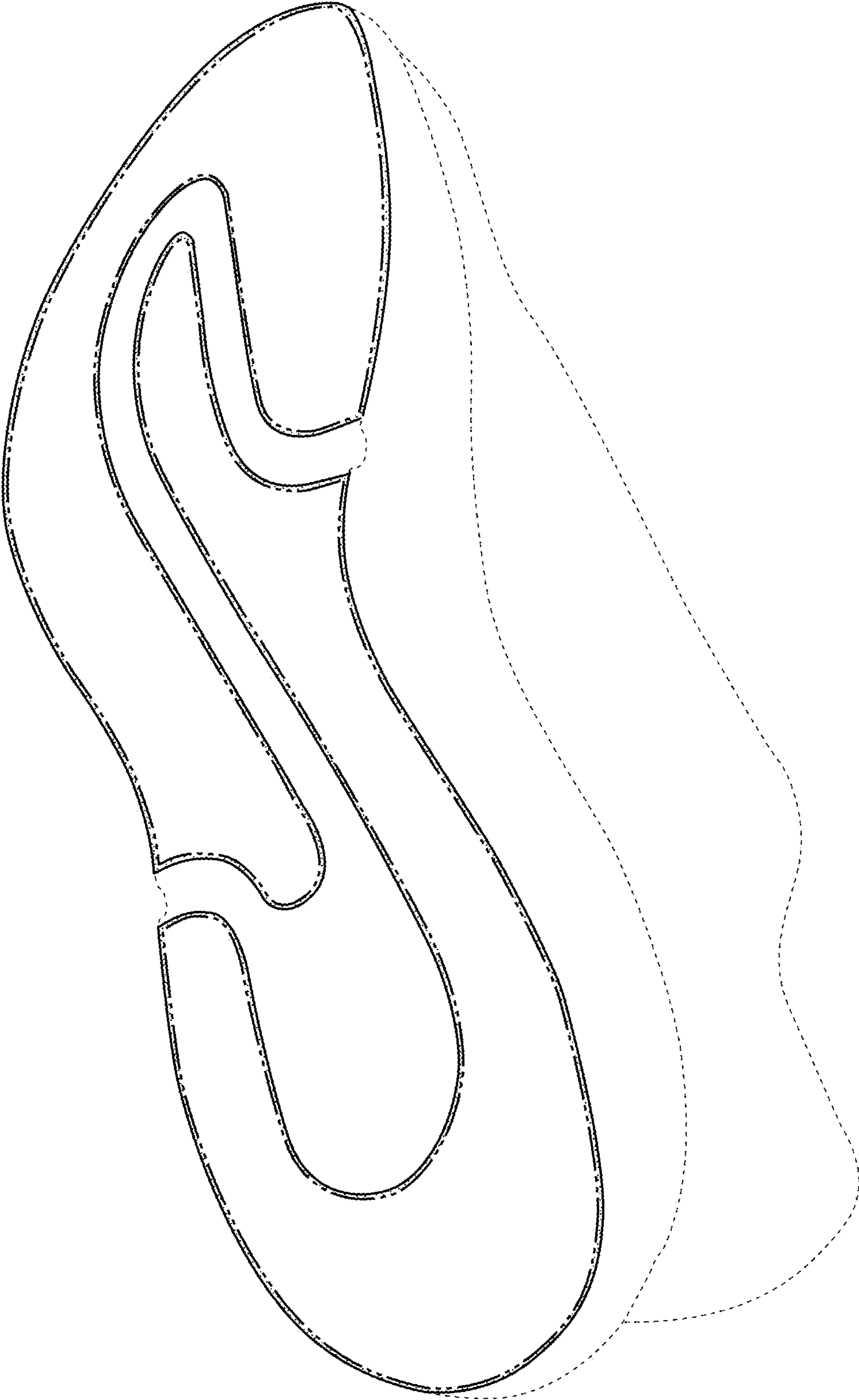
